FIG. 2 is a front view showing my new design shown in FIG. 1;

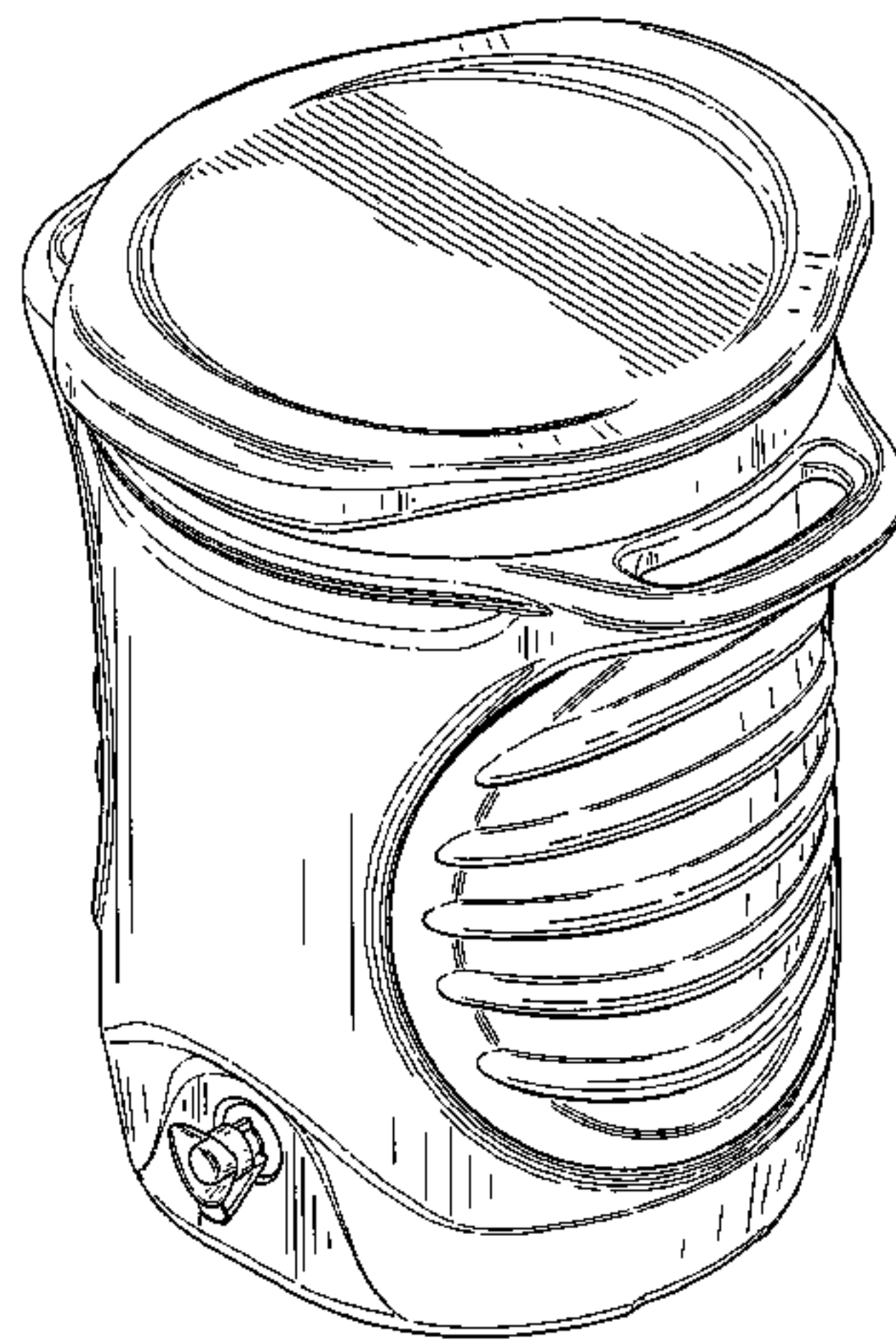
FIG. 3 is a right side view showing my new design shown in FIG. 1, the left side view being identical;

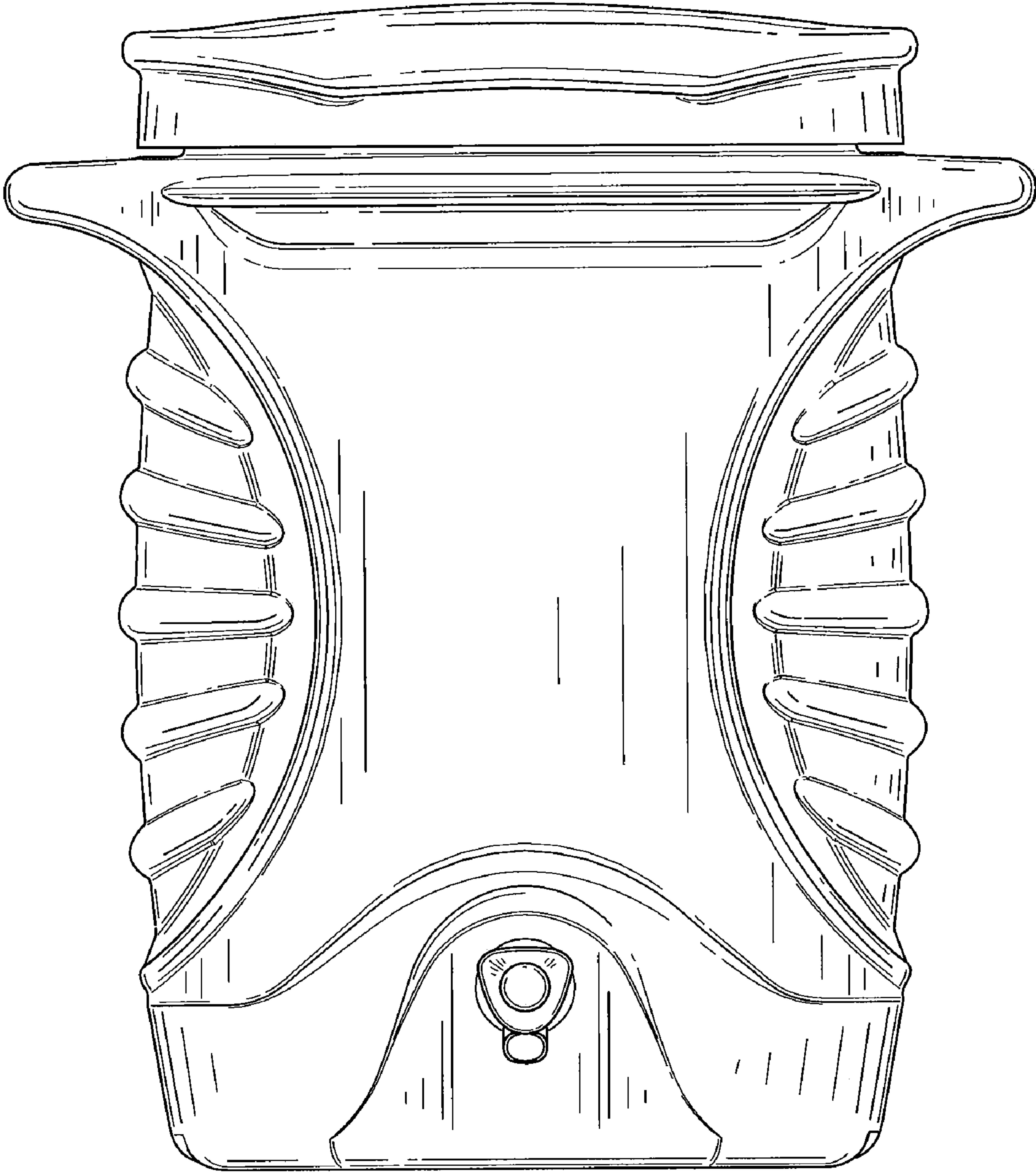
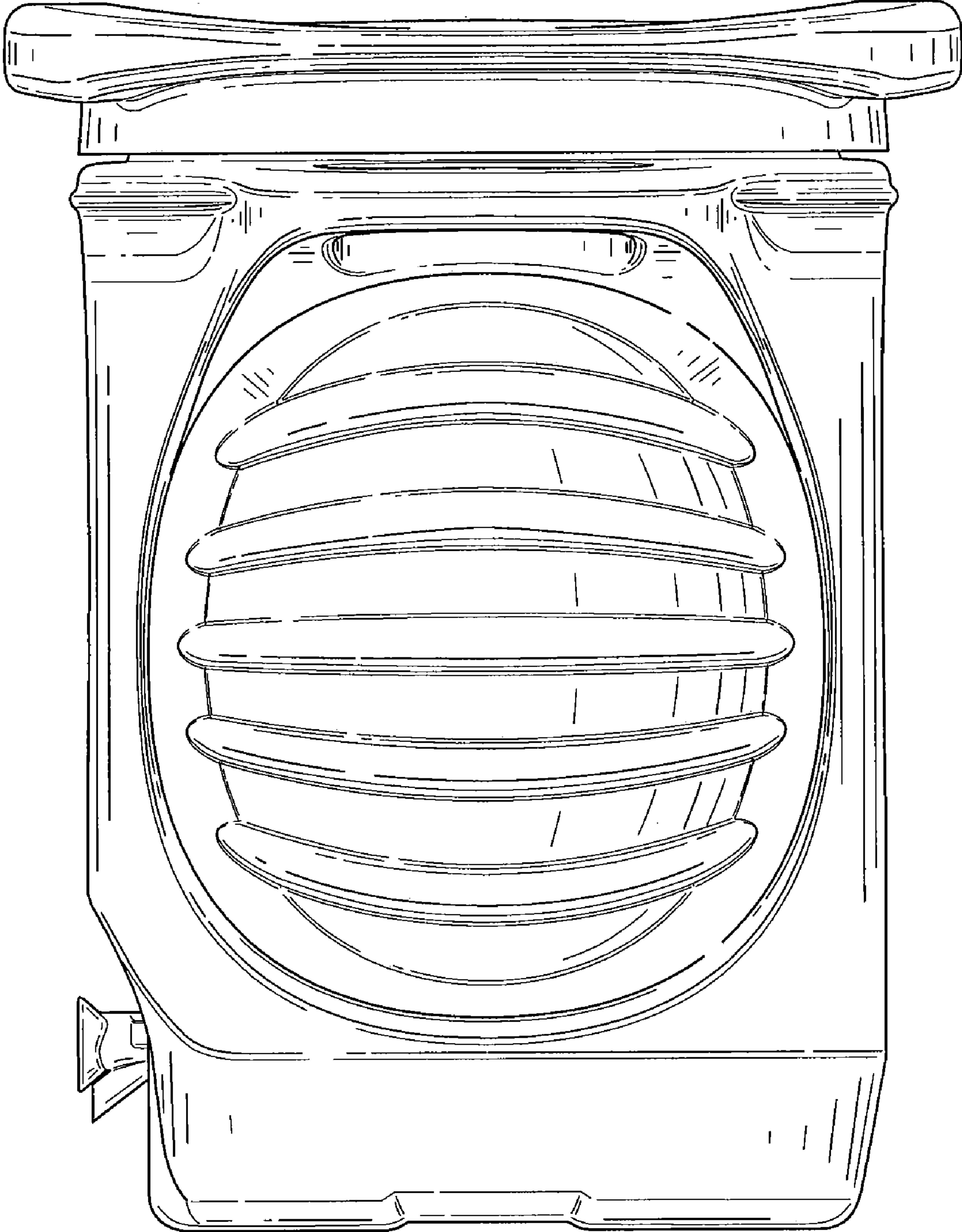

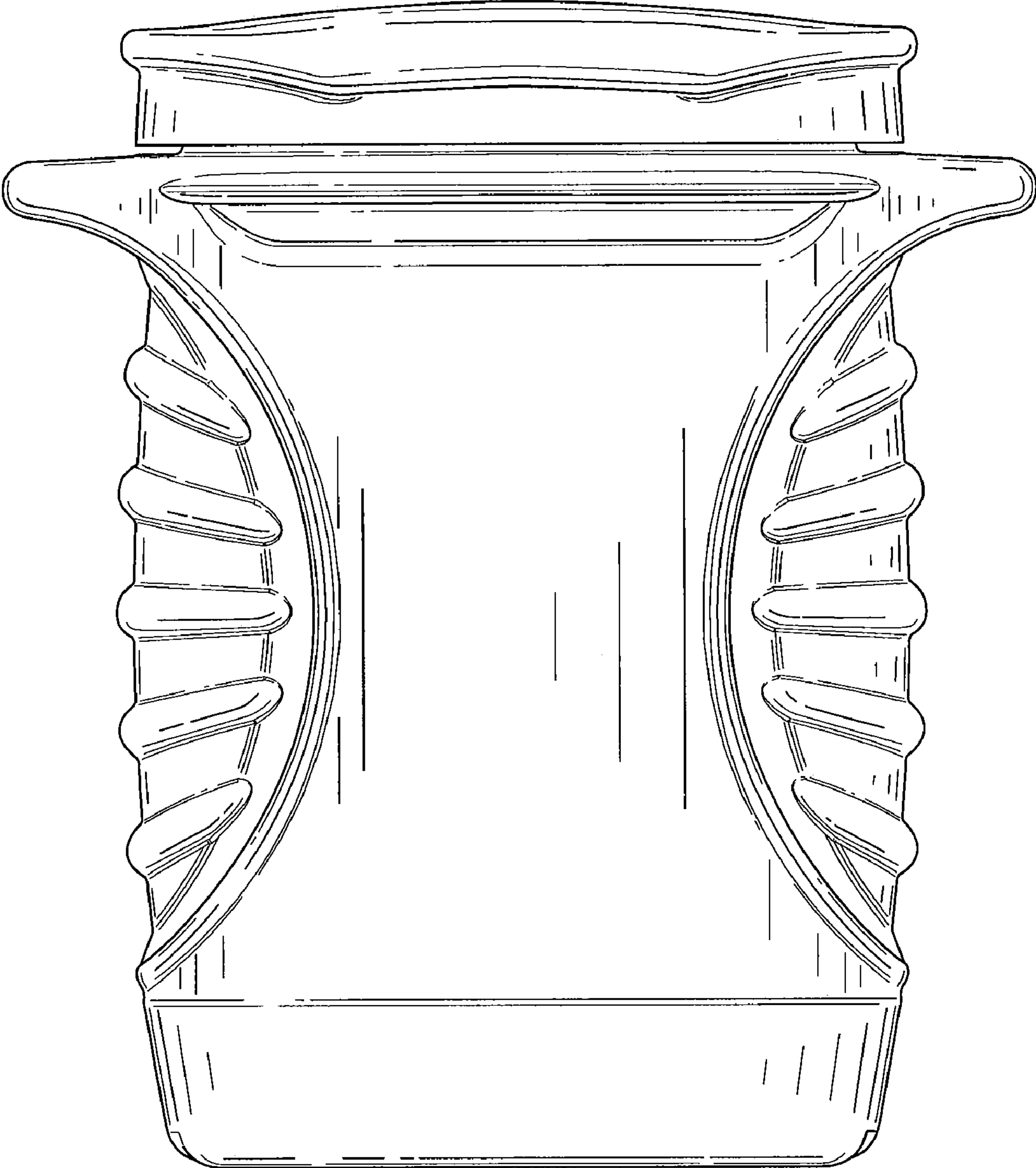
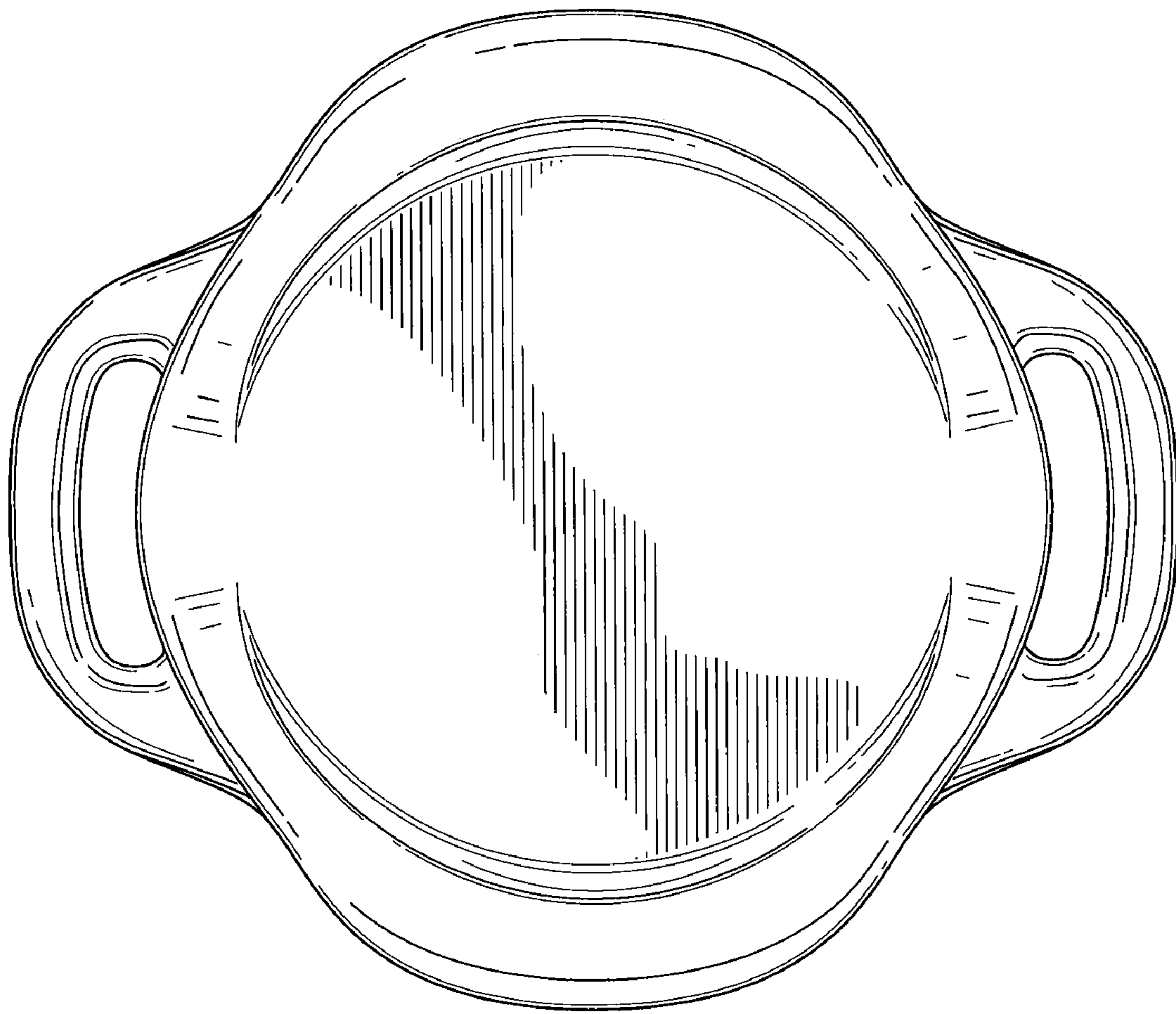

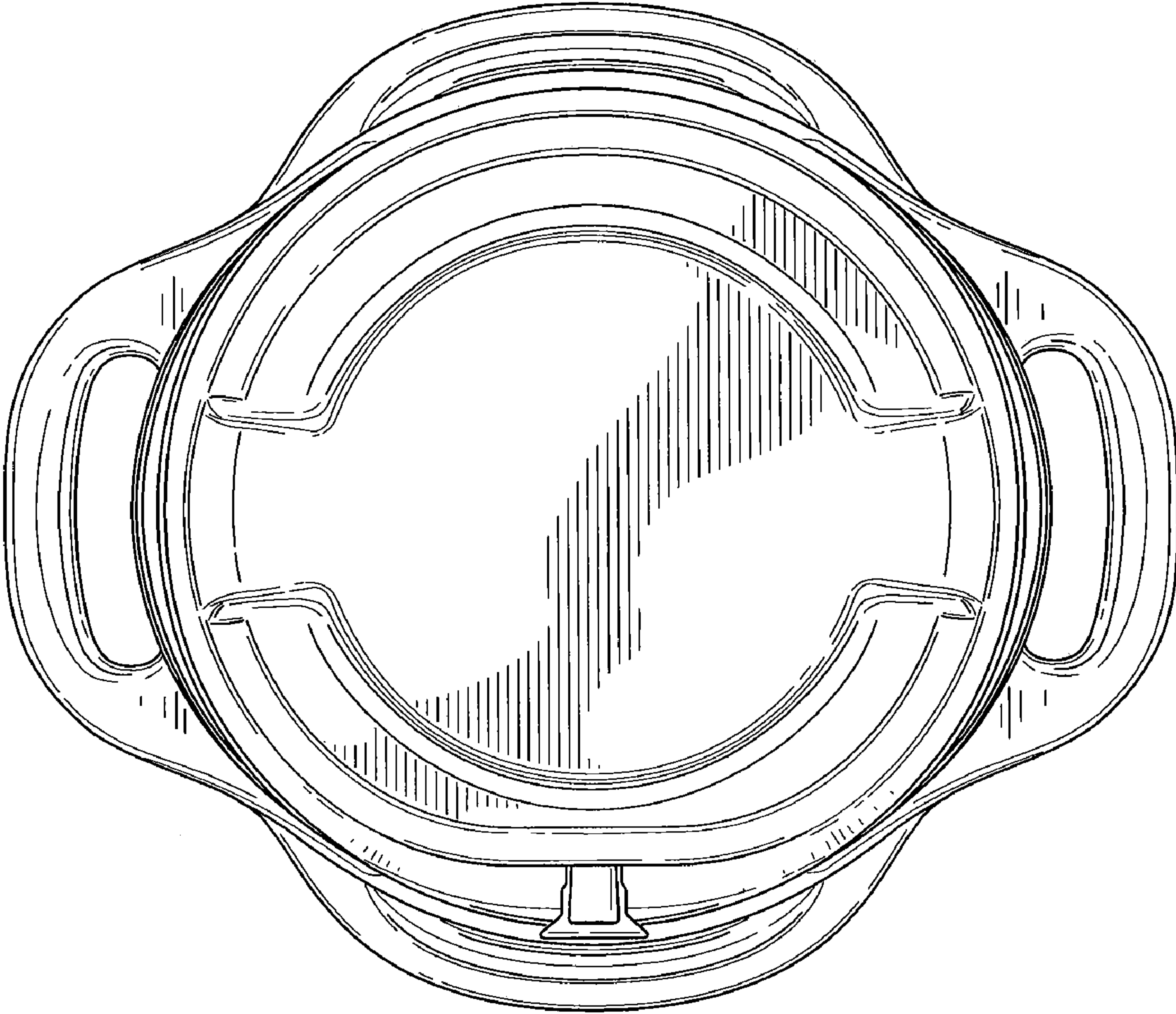
