FIG. 4 is rear elevation view thereof.

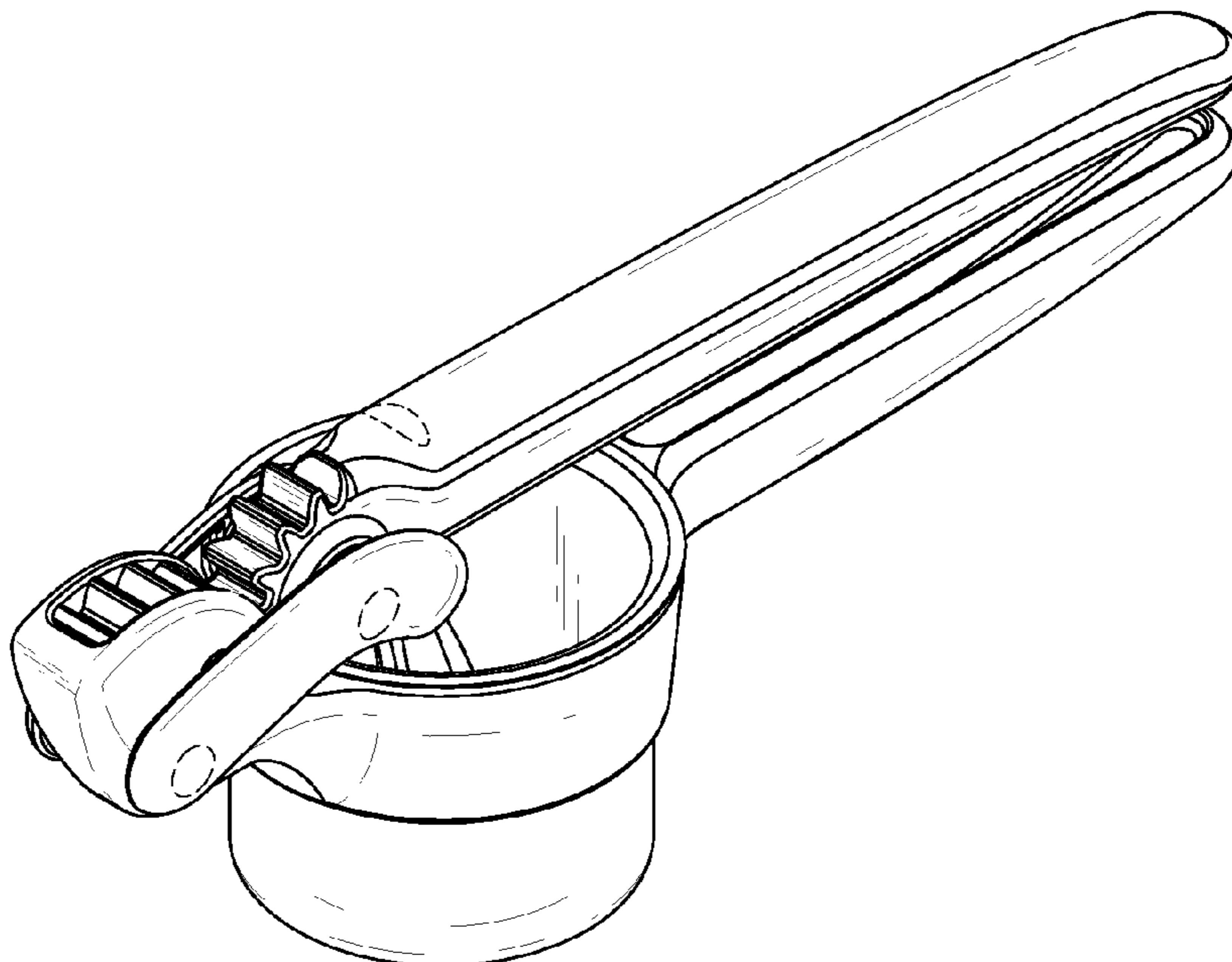
FIG. 5 is a front elevation view thereof.

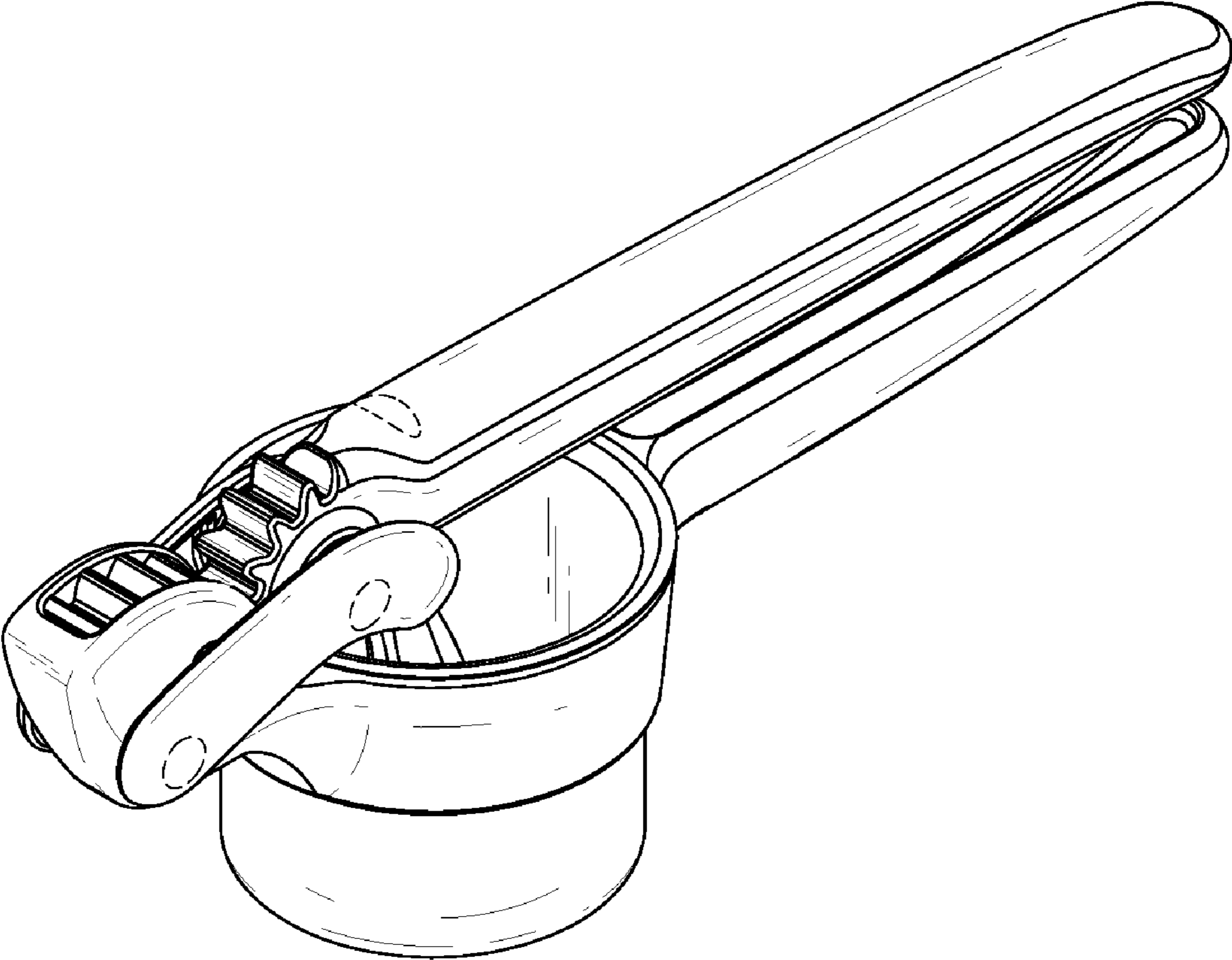

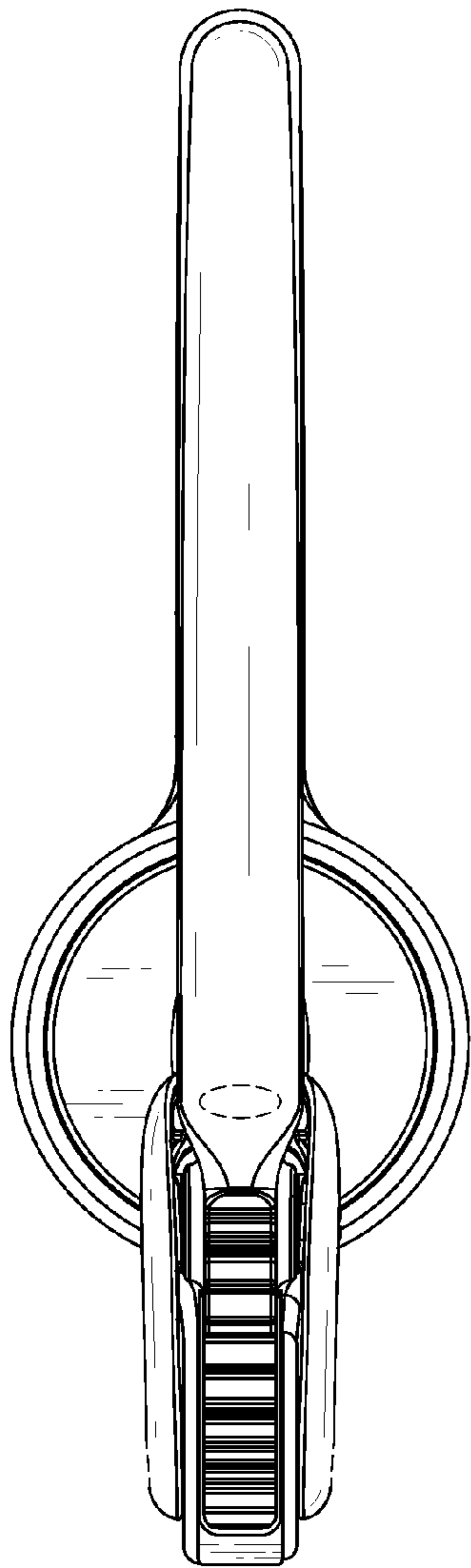

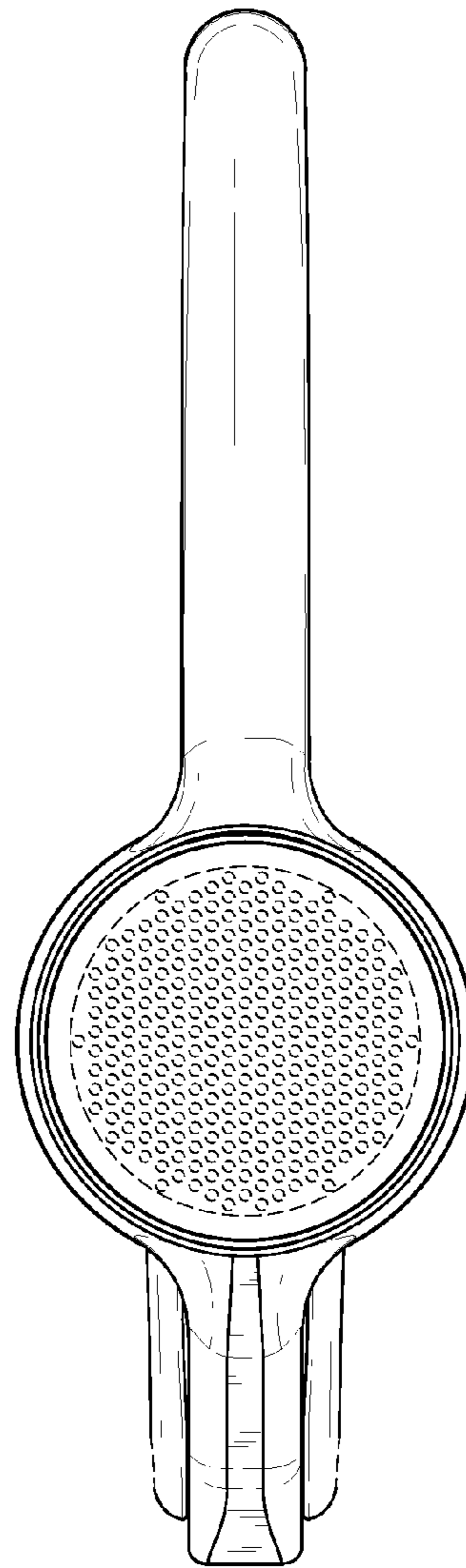

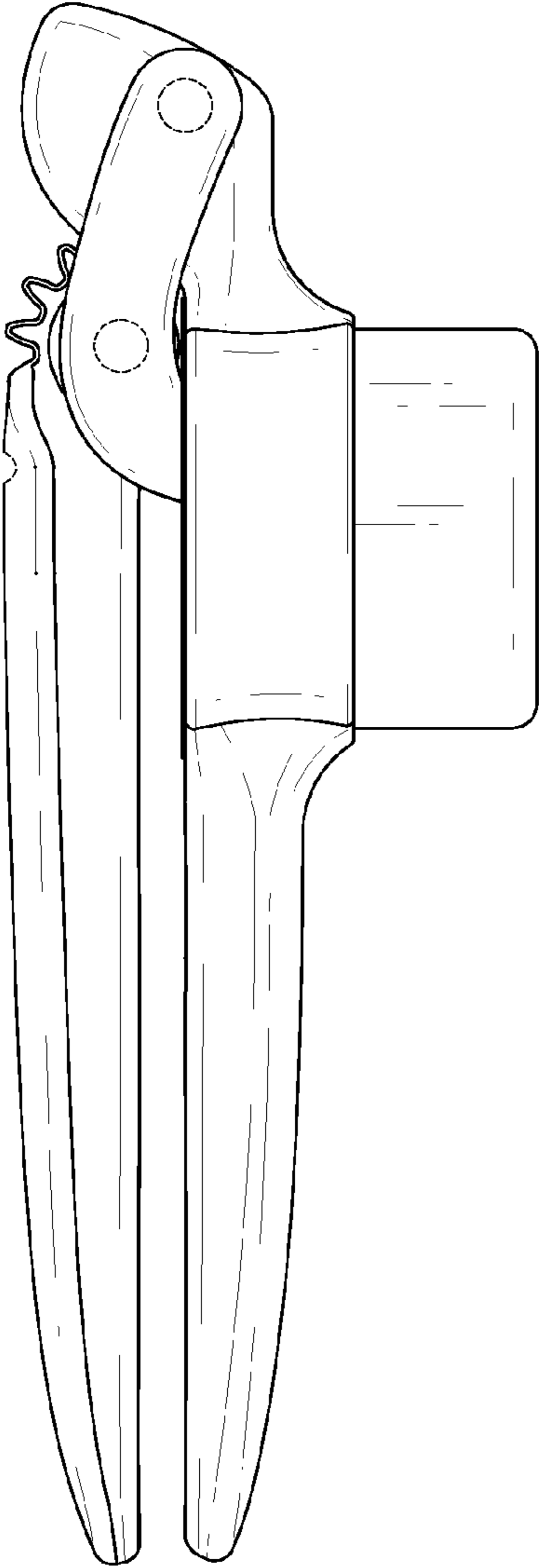

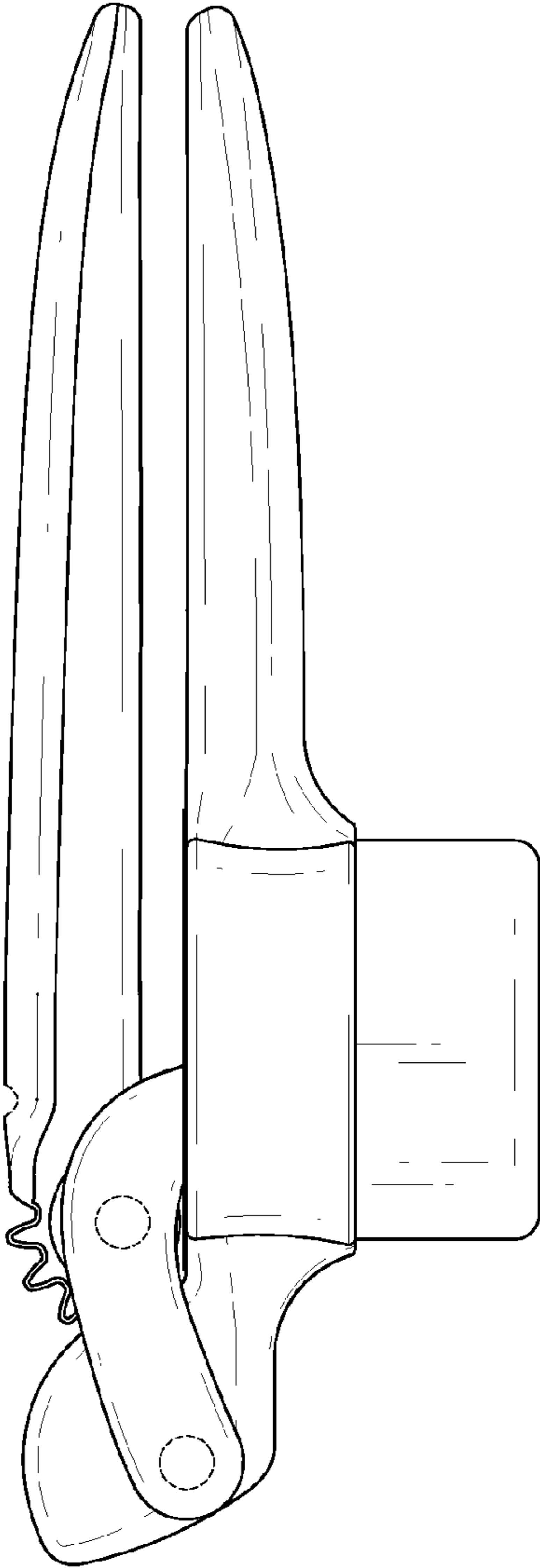

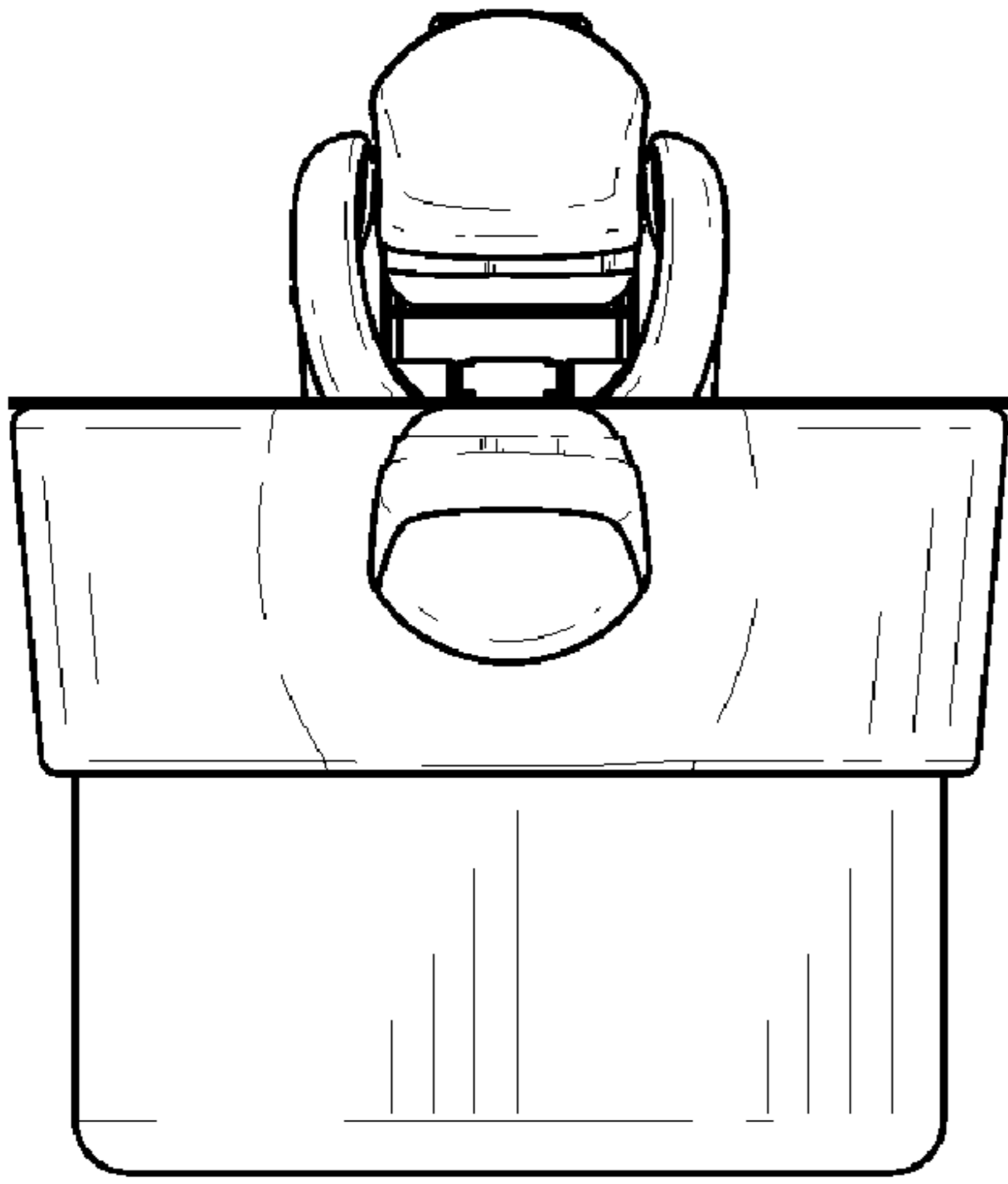

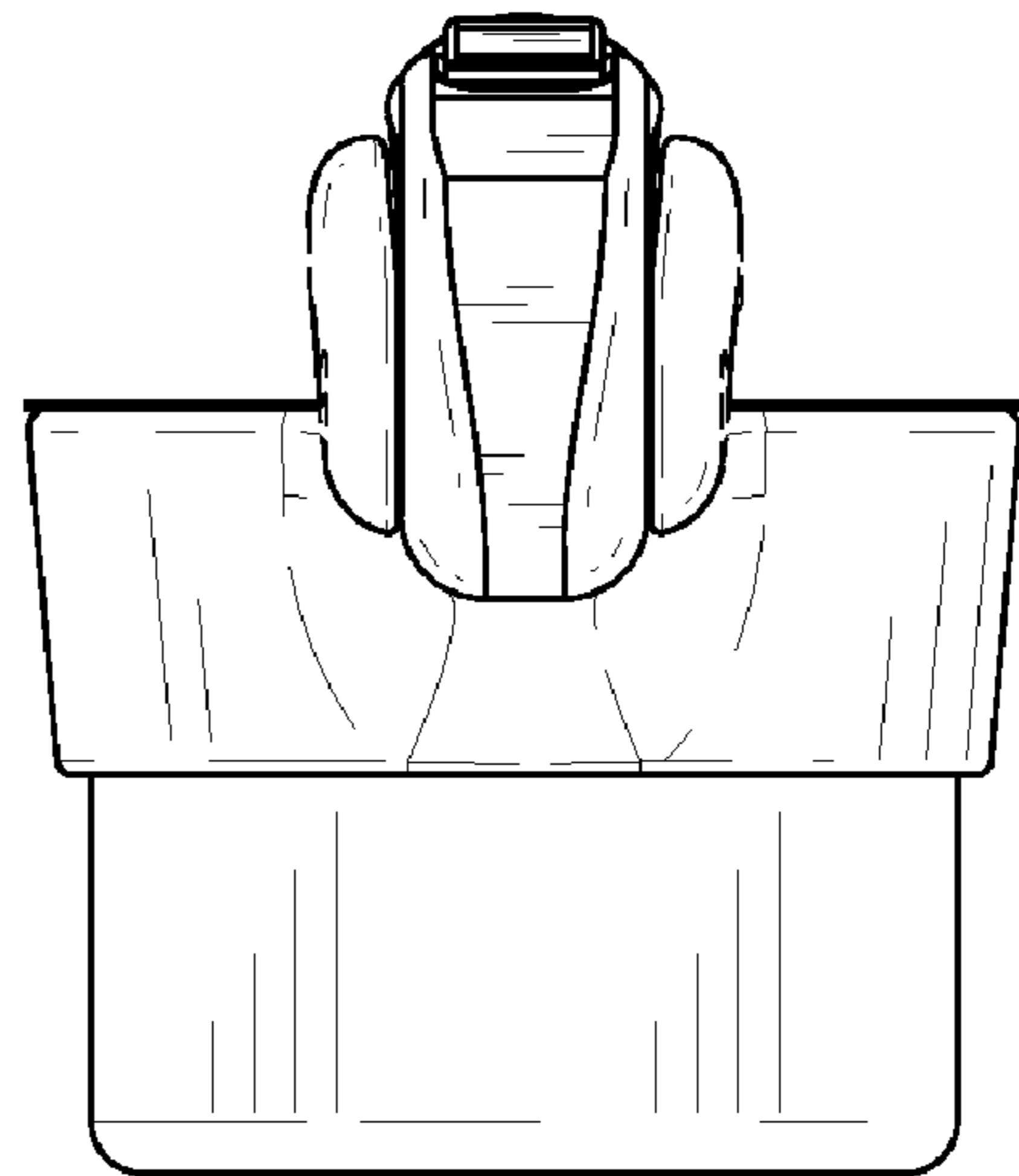
