(57) **CLAIM**

The ornamental design for the shovel handle, as shown and described.

DESCRIPTION

FIG. 1 is a top view of the shovel handle of the claimed design. FIG. 2 is a right side view of the shovel handle of the claimed design; the left side being a mirror image.

FIG. 3 is a bottom view of the shovel handle of the claimed design.

FIG. 4 is a right end view of the shovel handle of the claimed design.

FIG. 5 is a left end view of the shovel handle of the claimed design.

FIG. 6 is a top view of the shovel handle of the claimed design in an alternate environment.

FIG. 7 is a right side view of the shovel handle of the claimed design in an alternate environment; the left side being a mirror image.

FIG. 8 is a bottom view of the shovel handle of the claimed design in an alternate environment.

FIG. 9 is a right end view of the shovel handle of the claimed design in an alternate environment; and,

FIG. 10 is a left end view of the shovel handle of the claimed design in an alternate environment.

The broken lines show the environment of the claimed shovel handle design and forms no part thereof.
