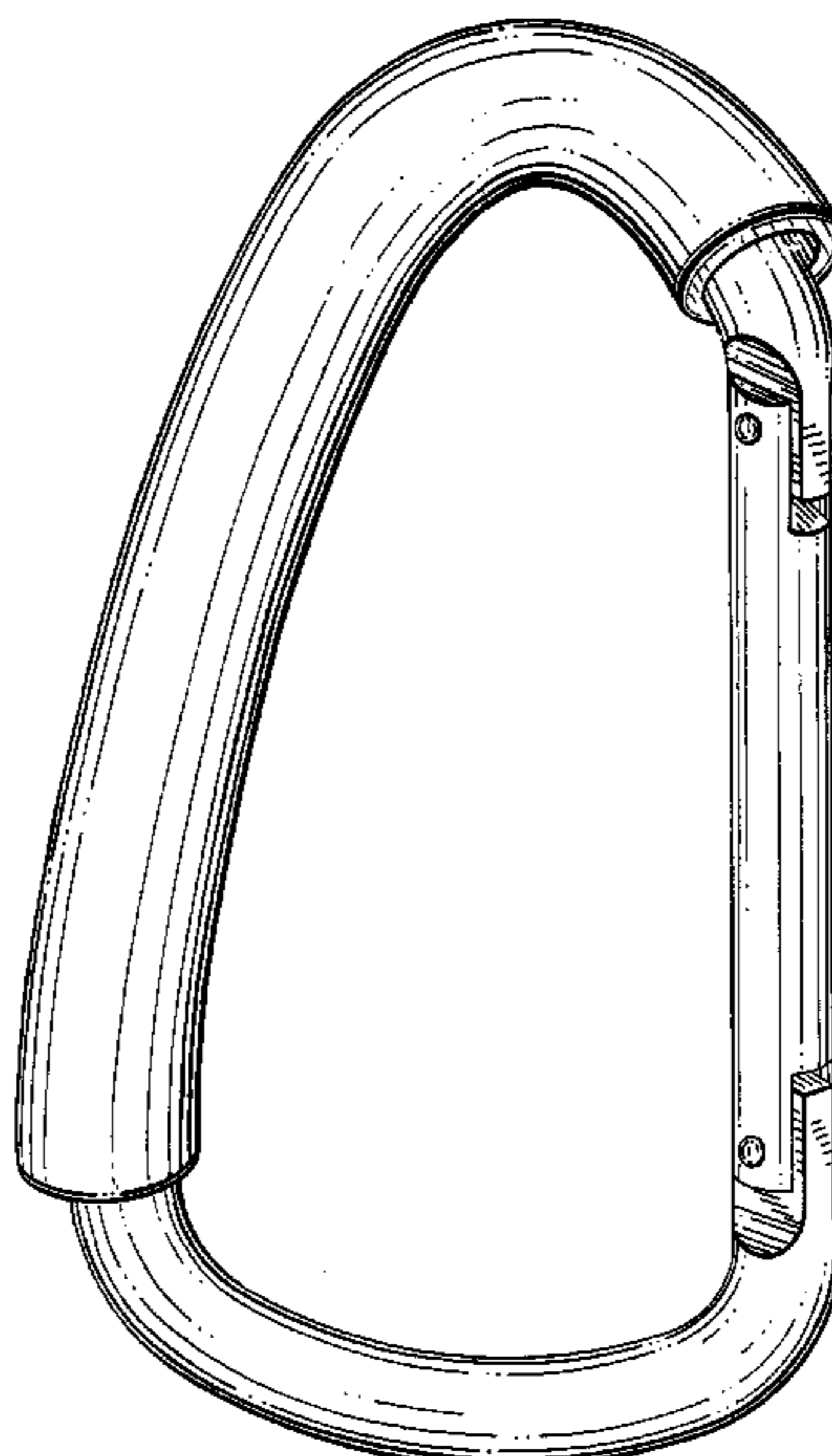

DESCRIPTION

FIG. 1 is a perspective view of the carabiner of the invention. FIG. 2 is a front elevation view of the carabiner of FIG. 1; FIG. 3 is a top plan view of the carabiner of FIGS. 1–2; FIG. 4 is a left side elevation view of the carabiner of FIGS. 1–3; FIG. 5 is a right side elevation view of the carabiner of FIGS. 1–4; and, FIG. 6 is a bottom plan view of the carabiner of FIGS. 1–5.

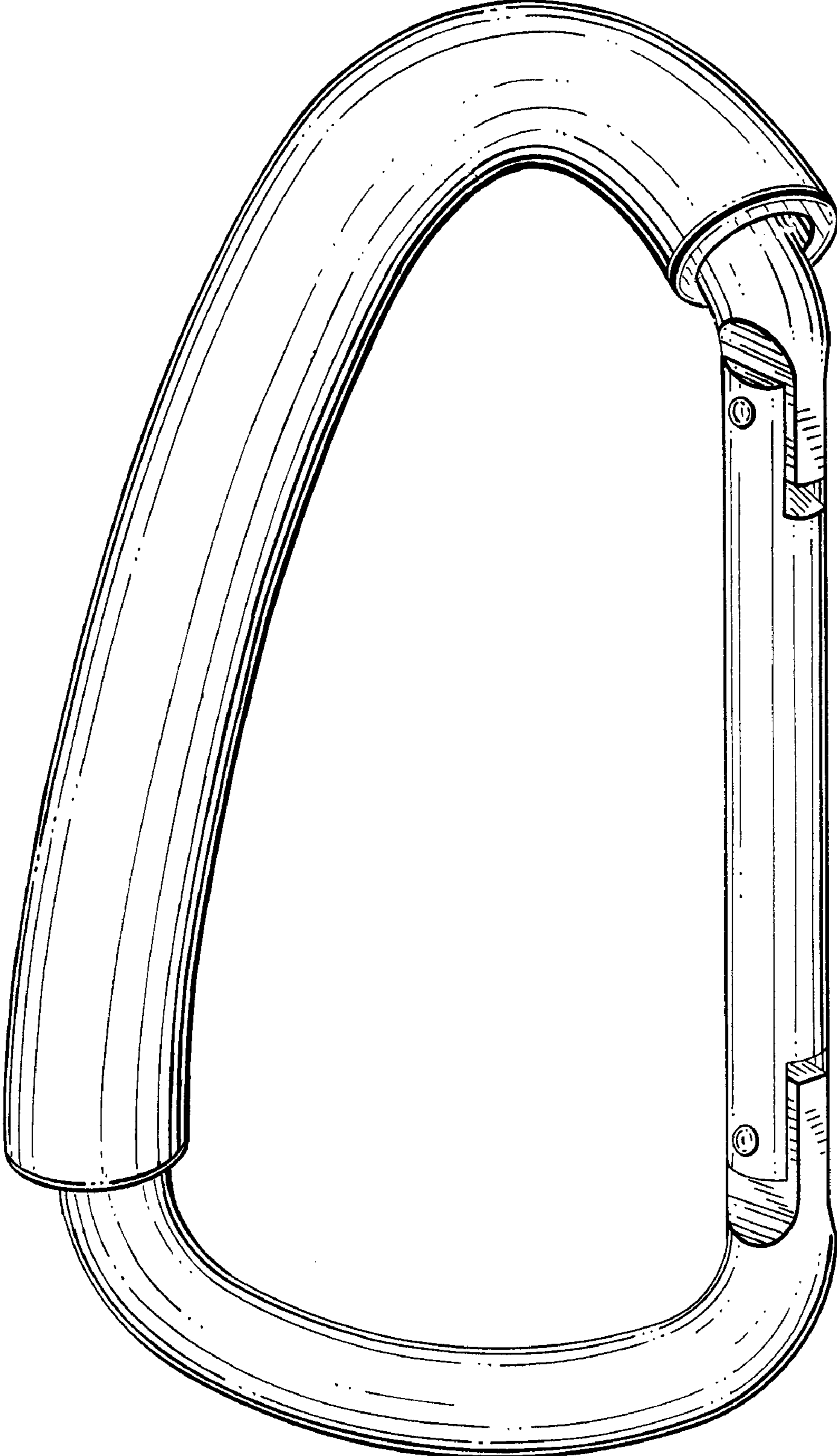

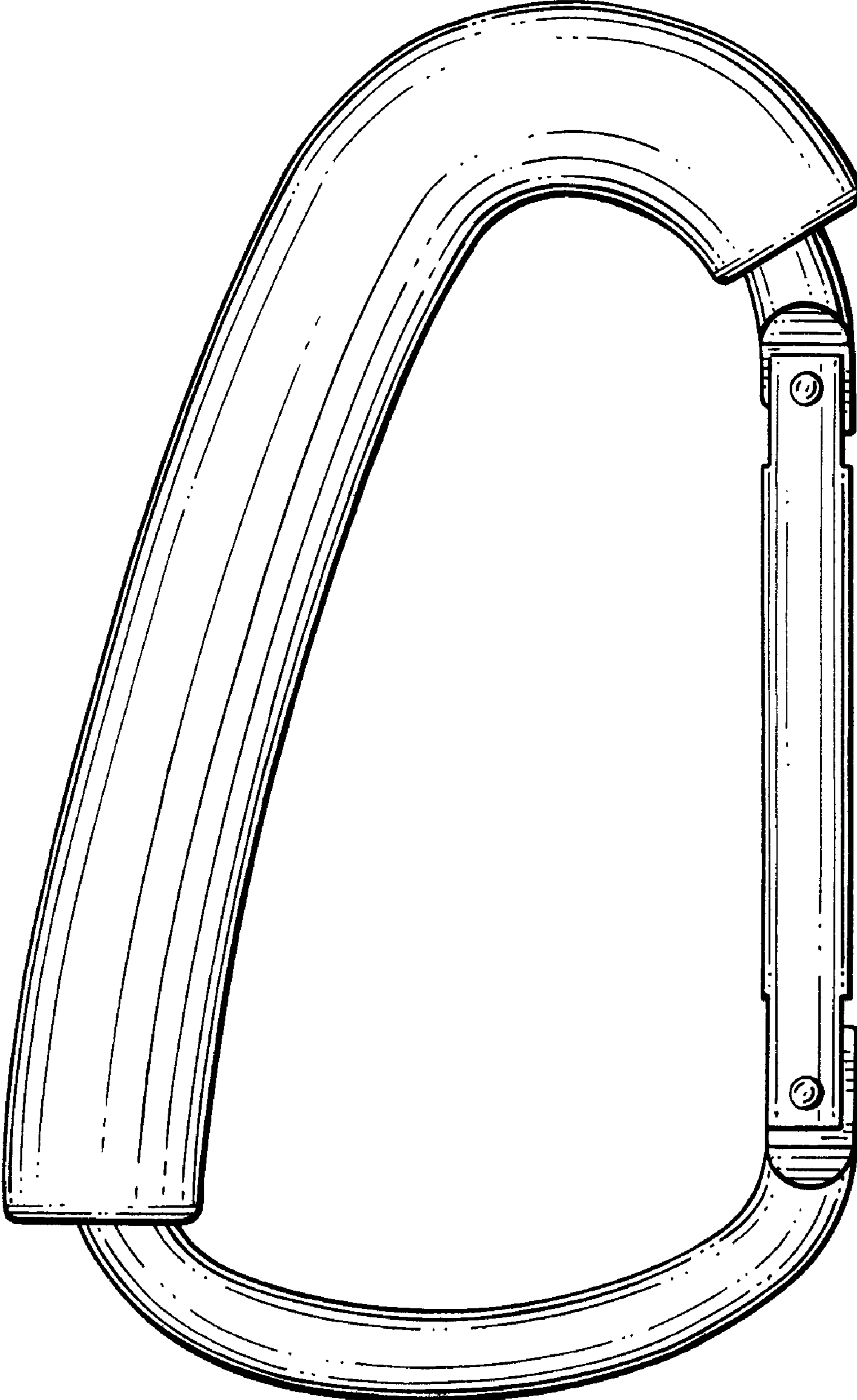

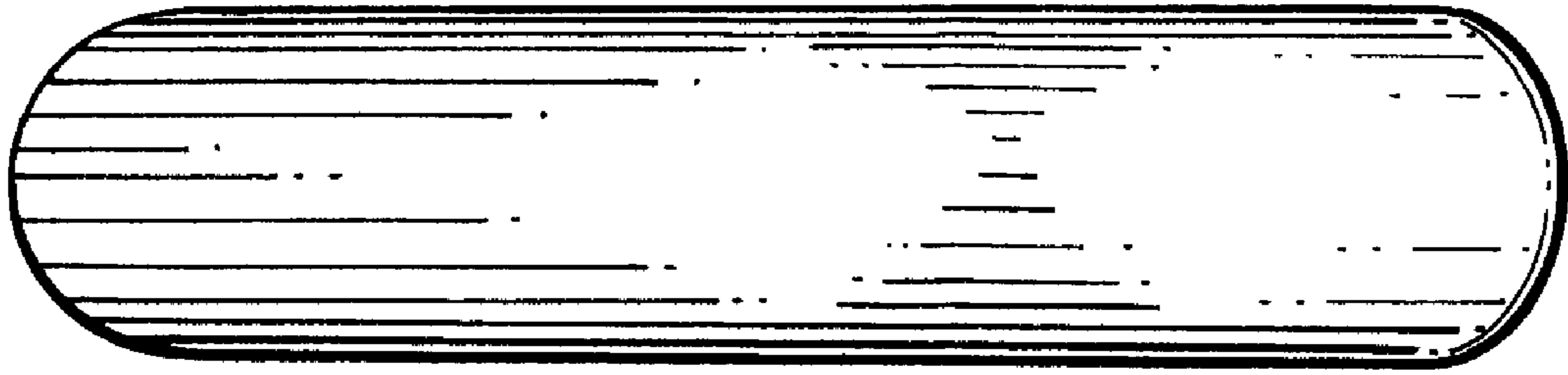

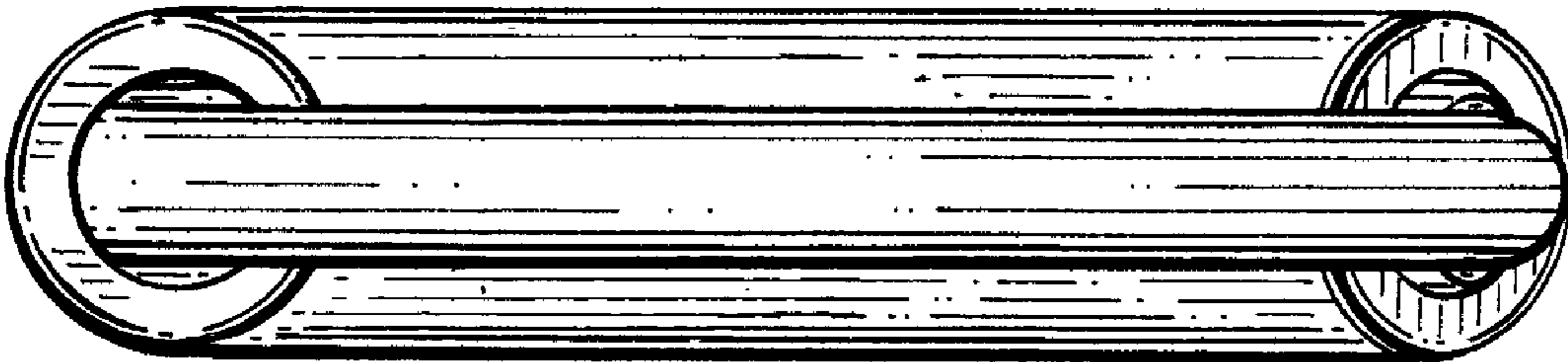

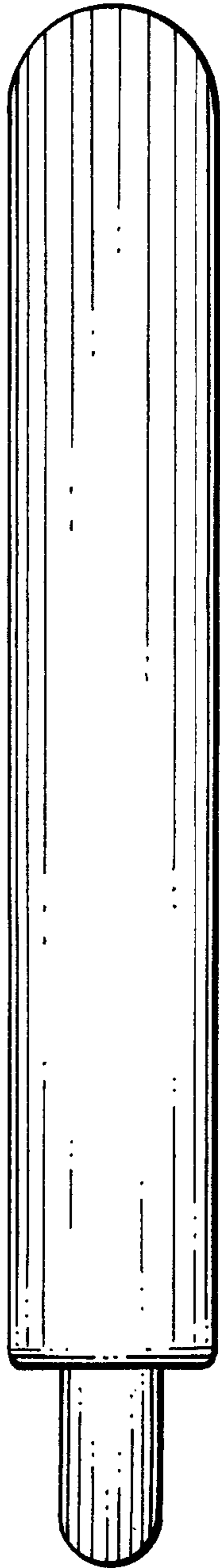

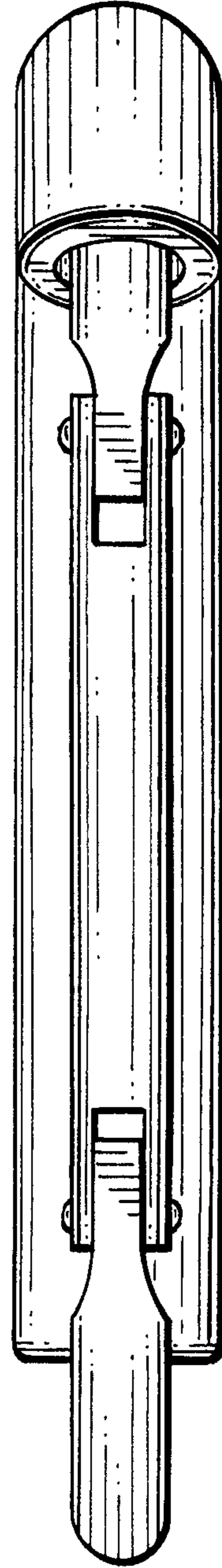
