(57) **CLAIM**

The ornamental design for a flexible container for pills or capsules, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a flexible container.

FIG. 2 is a front elevational view of the flexible container of FIG. 1.

FIG. 3 is a top plan view of the flexible container of FIG. 1.

FIG. 4 is a side elevational view of the flexible container of FIG. 1.

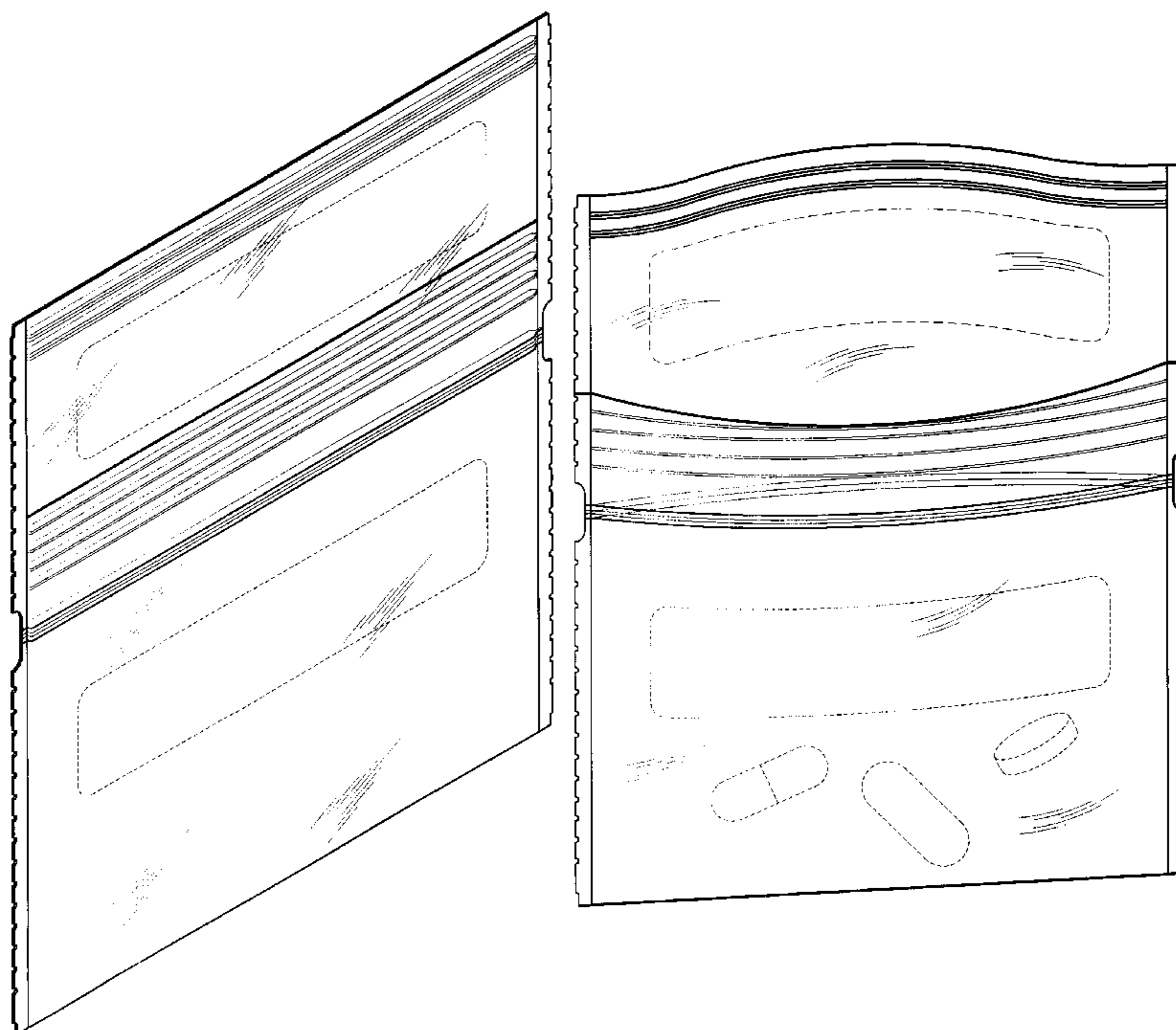
FIG. 5 is a bottom plan view of the flexible container of FIG. 1.

FIG. 6 is a rear elevational view of the flexible container of FIG. 1; and,

FIG. 7 is a front elevational view of the flexible container of FIG. 1 in an opened state and containing several pills and capsules.

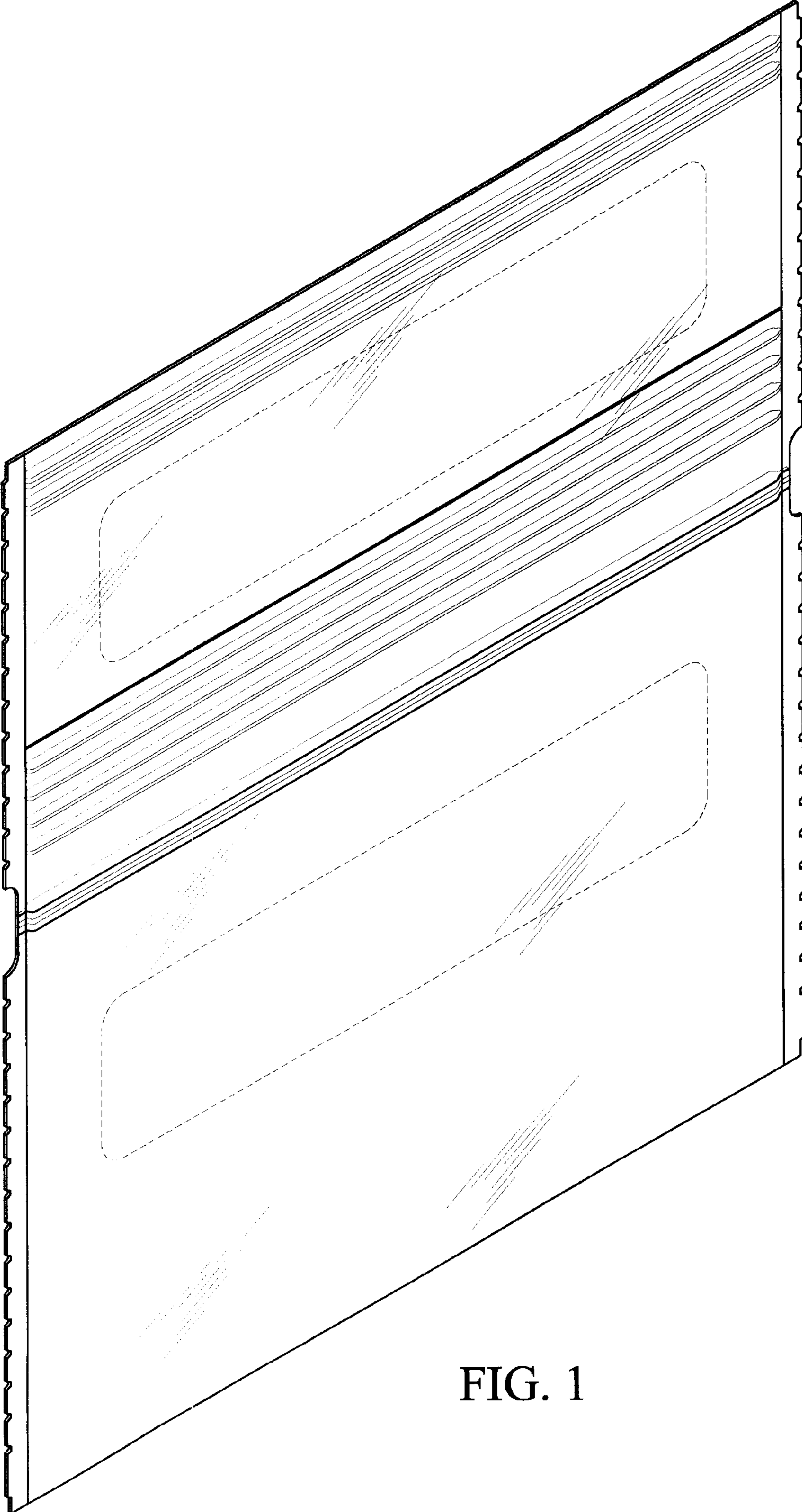

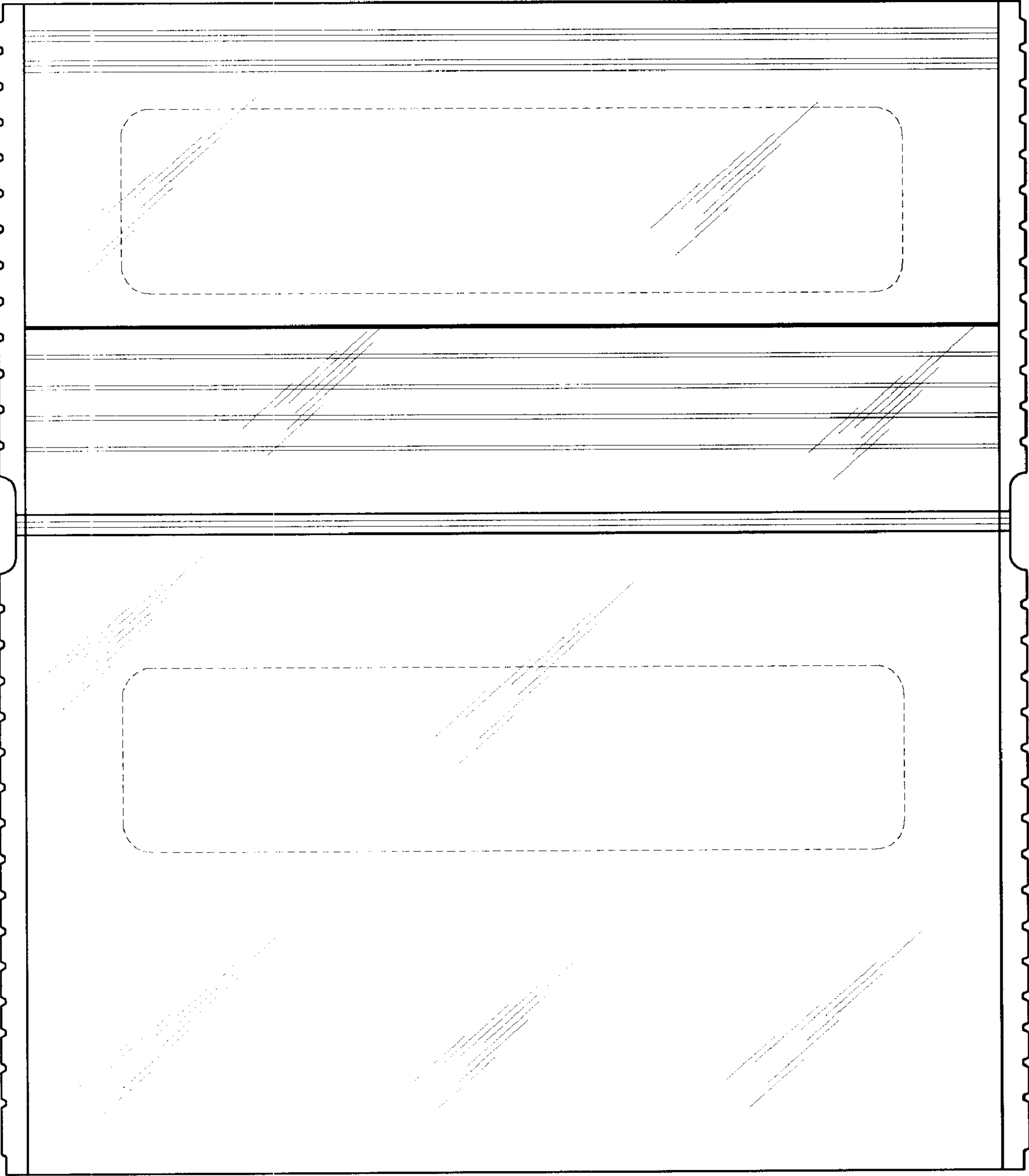

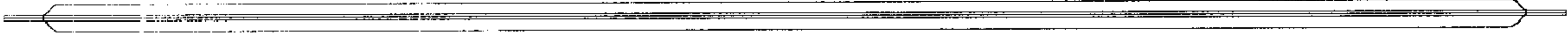

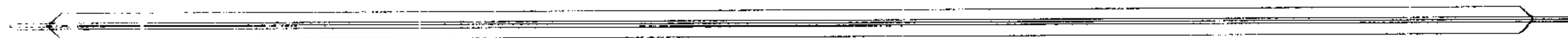

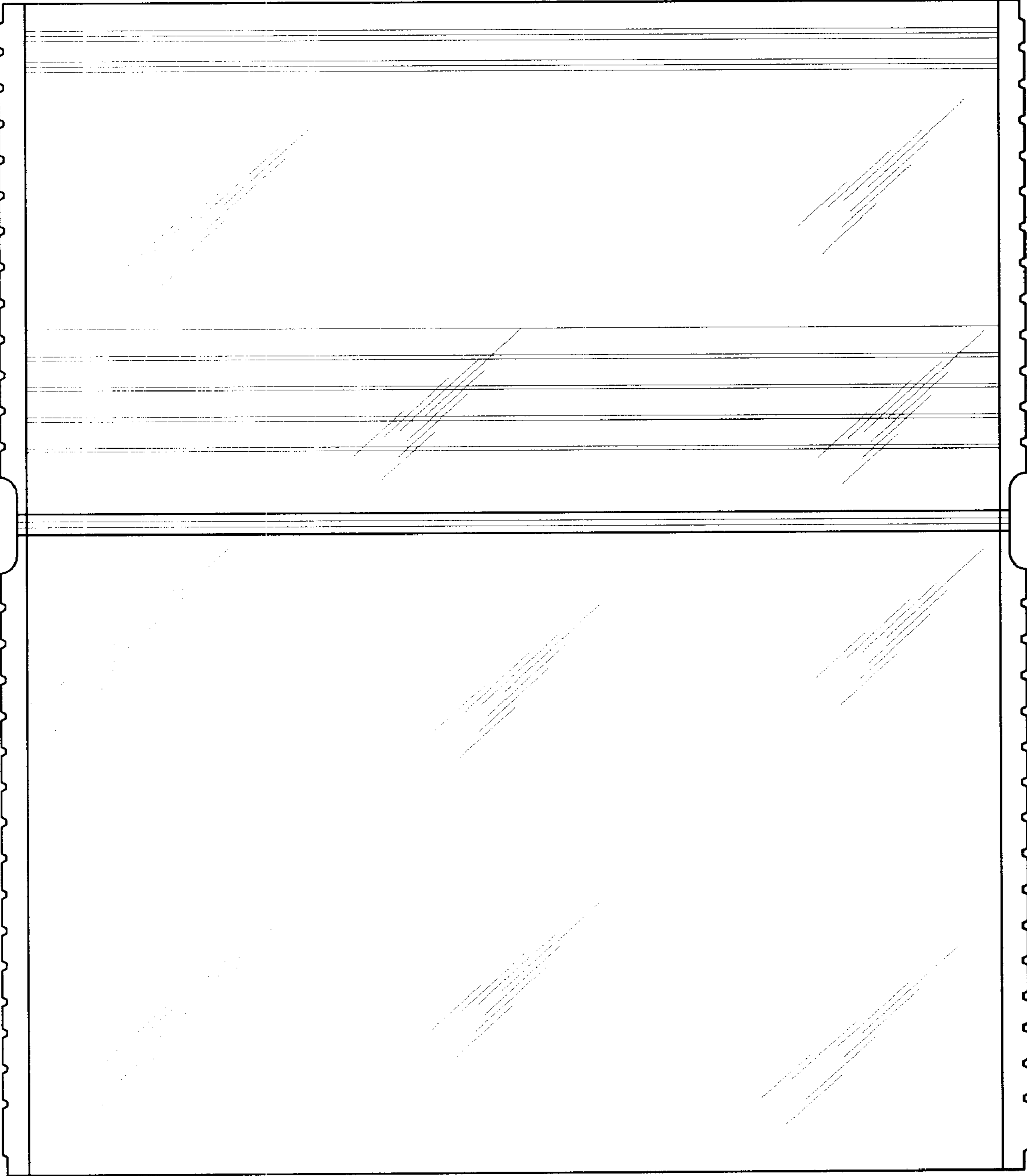

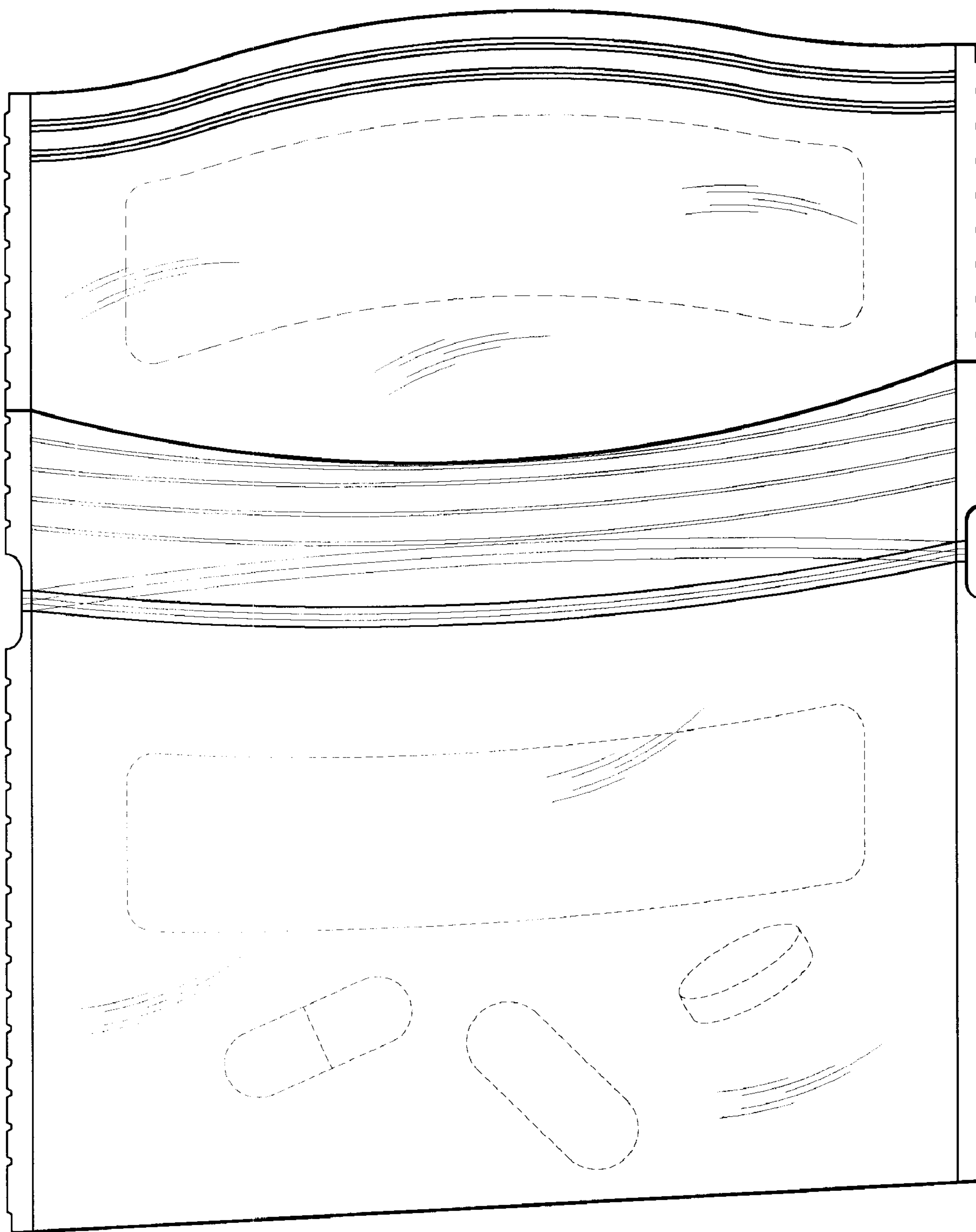
