FIG. 3 is a left side elevation thereof;

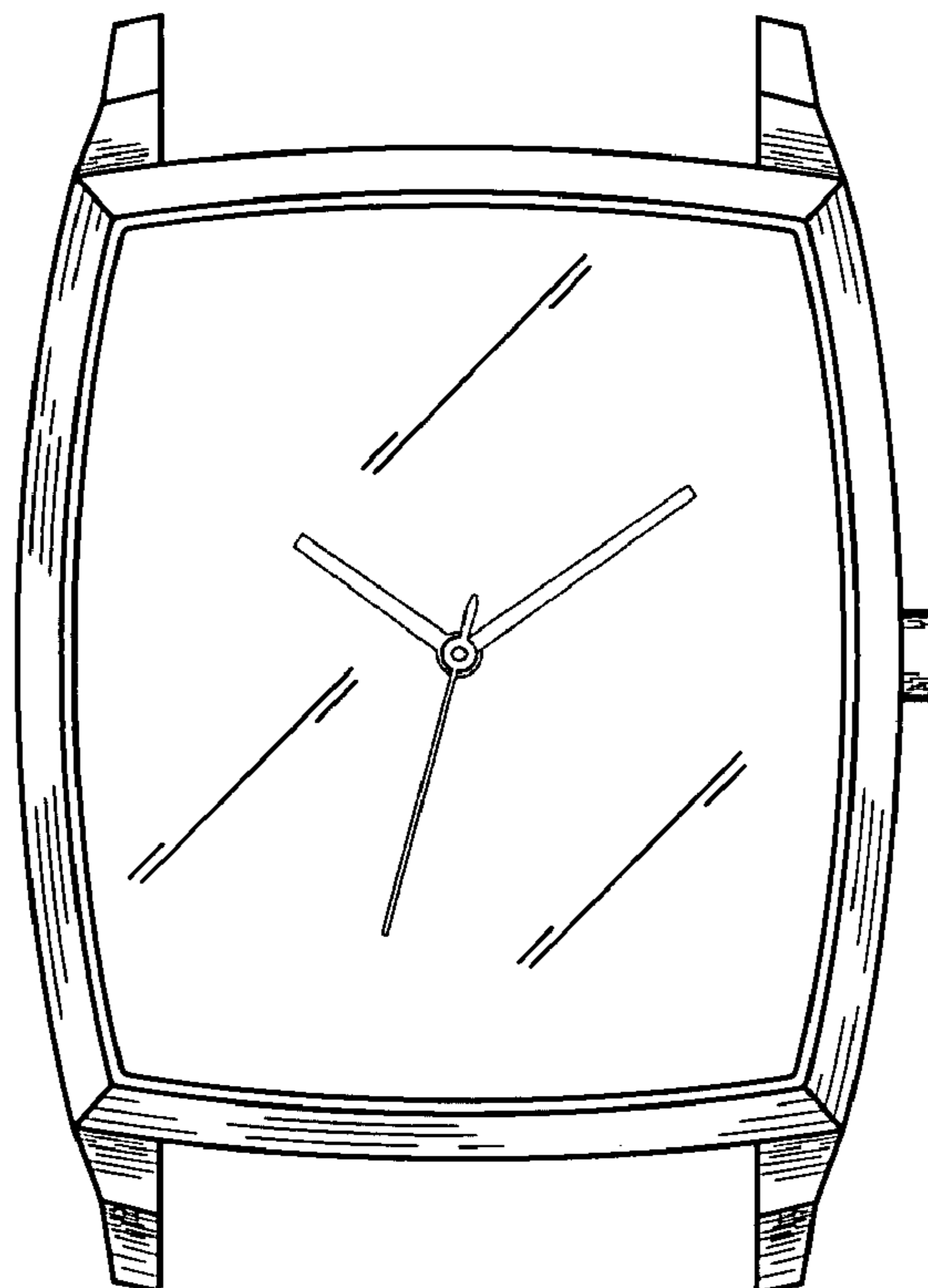
FIG. 4 is a rear elevation thereof;

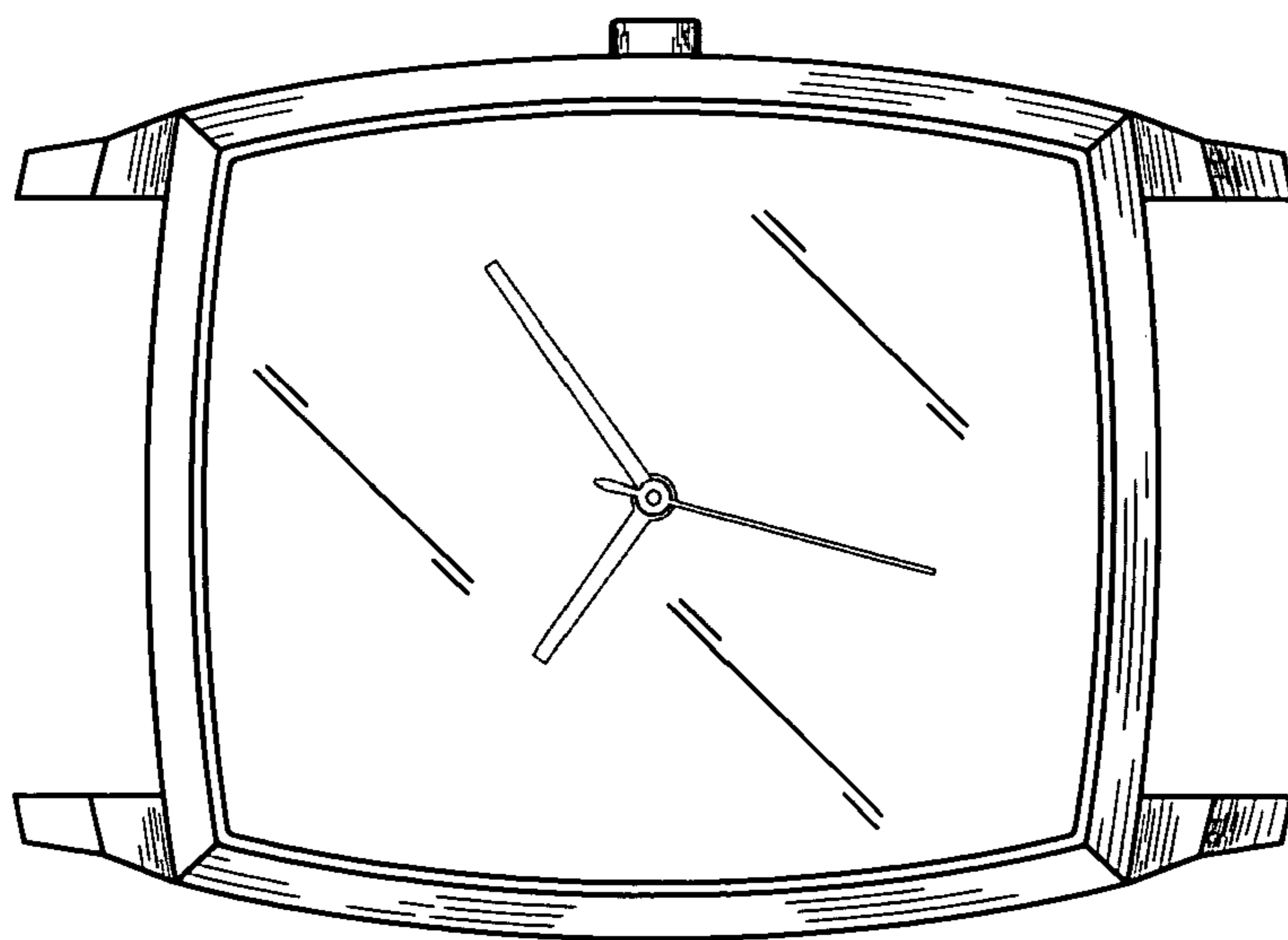

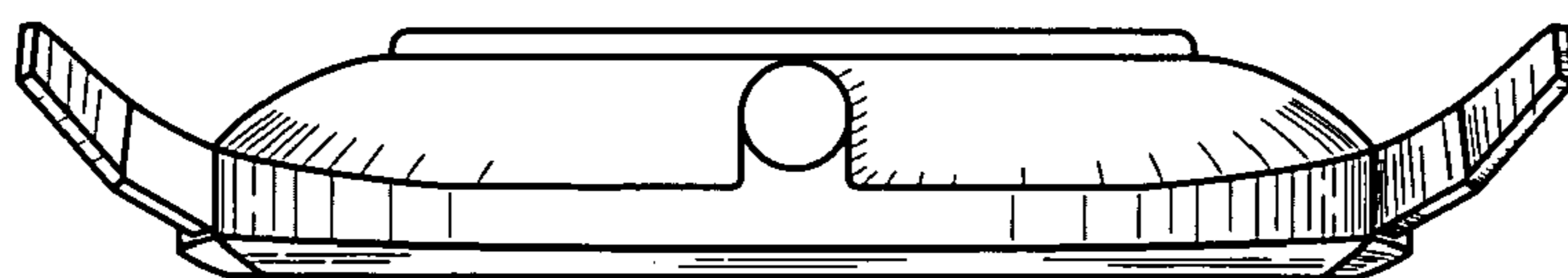

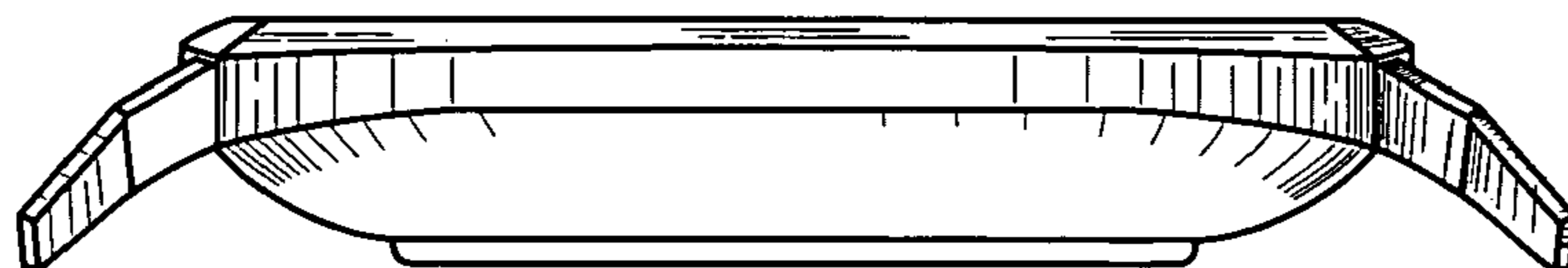

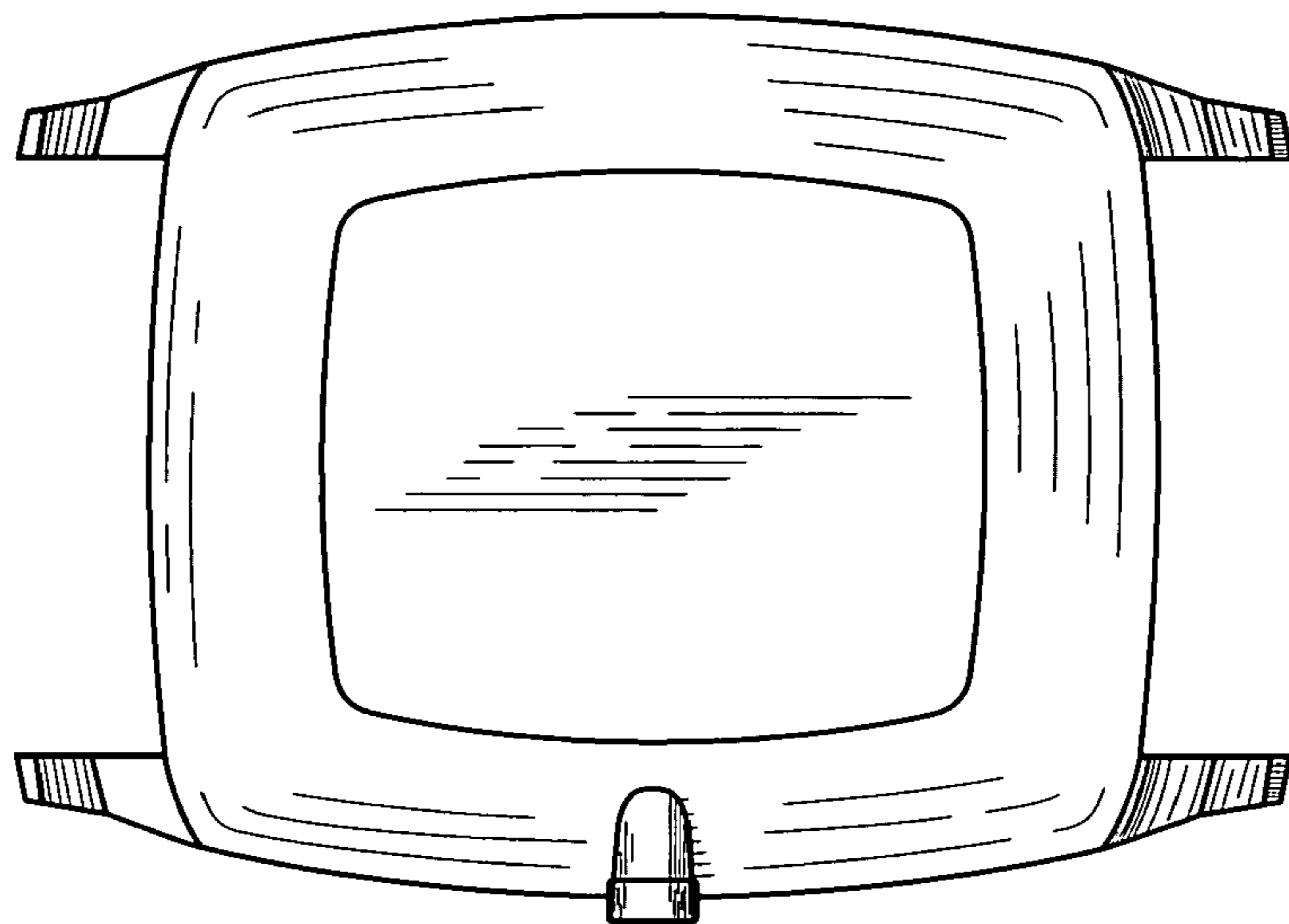

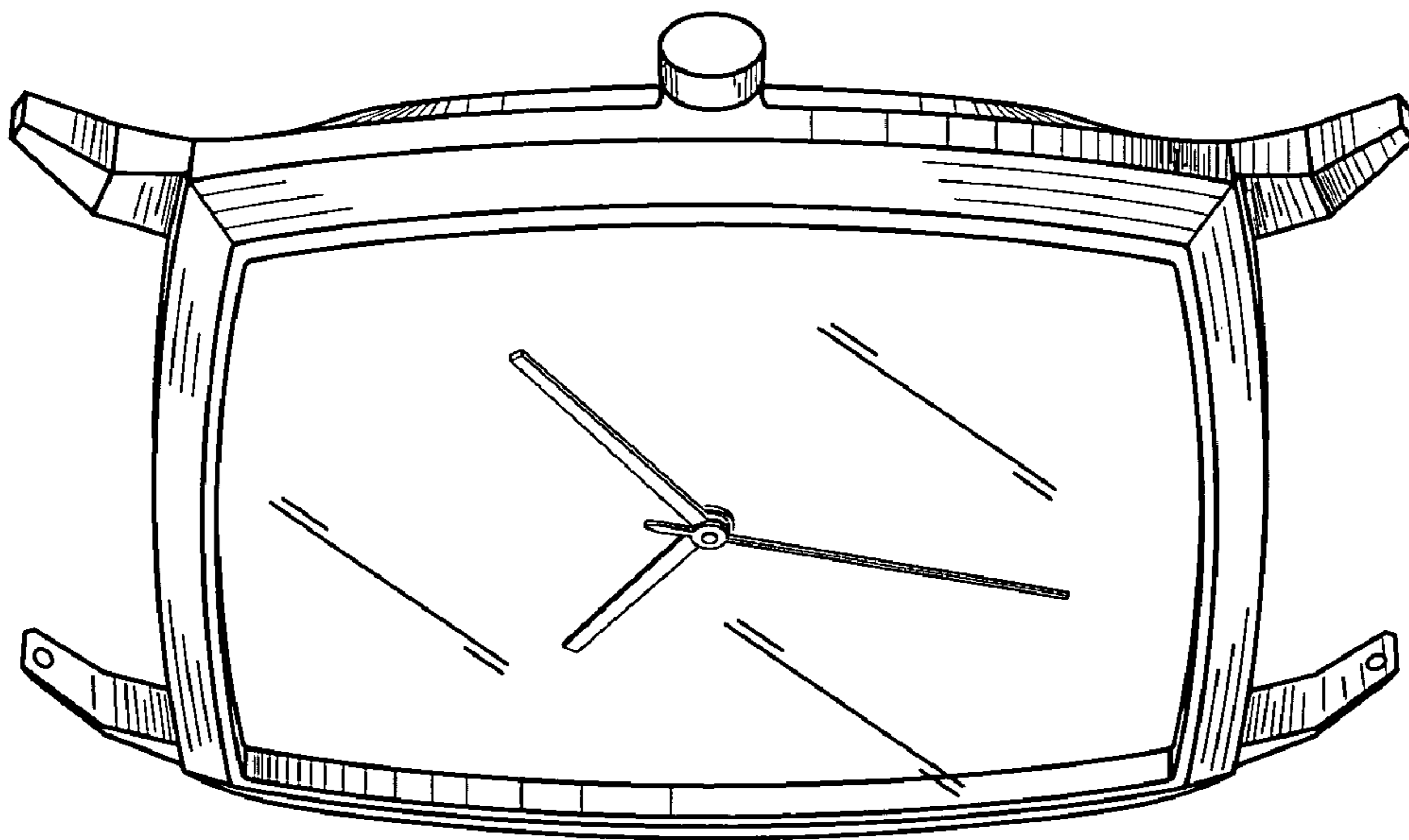

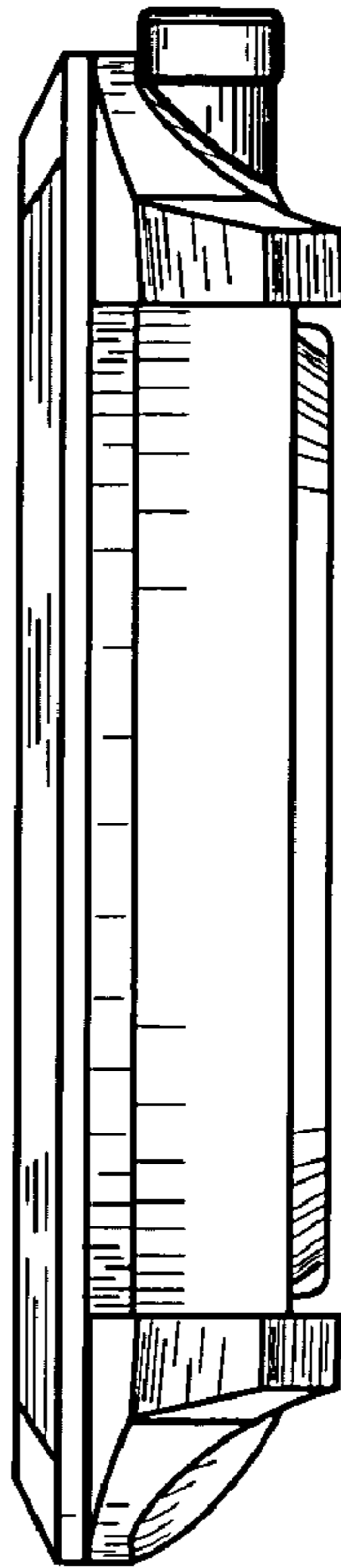
