FIG. 3 is a rear view of the watch.

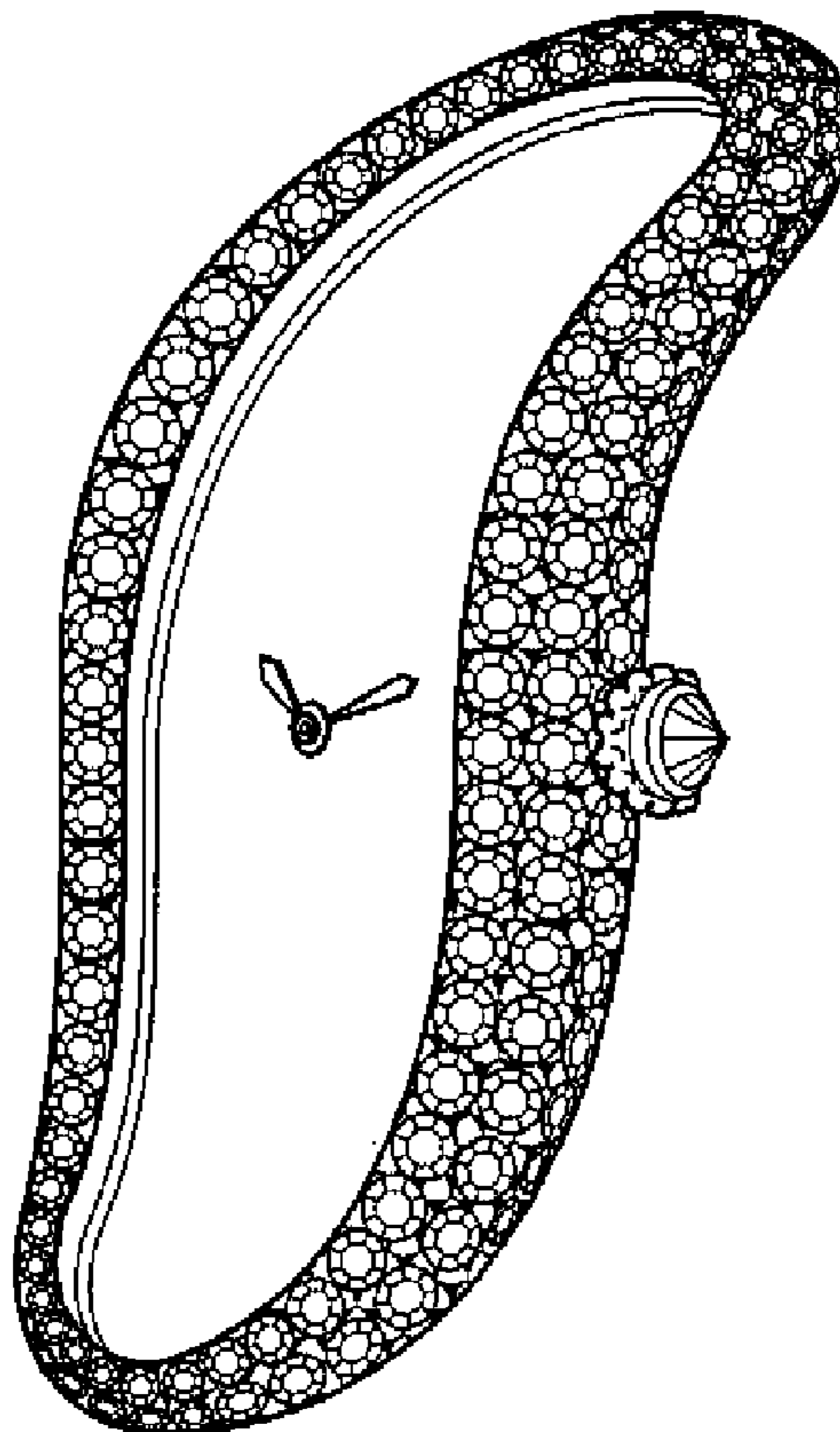
FIG. 4 is a left side view of the watch.

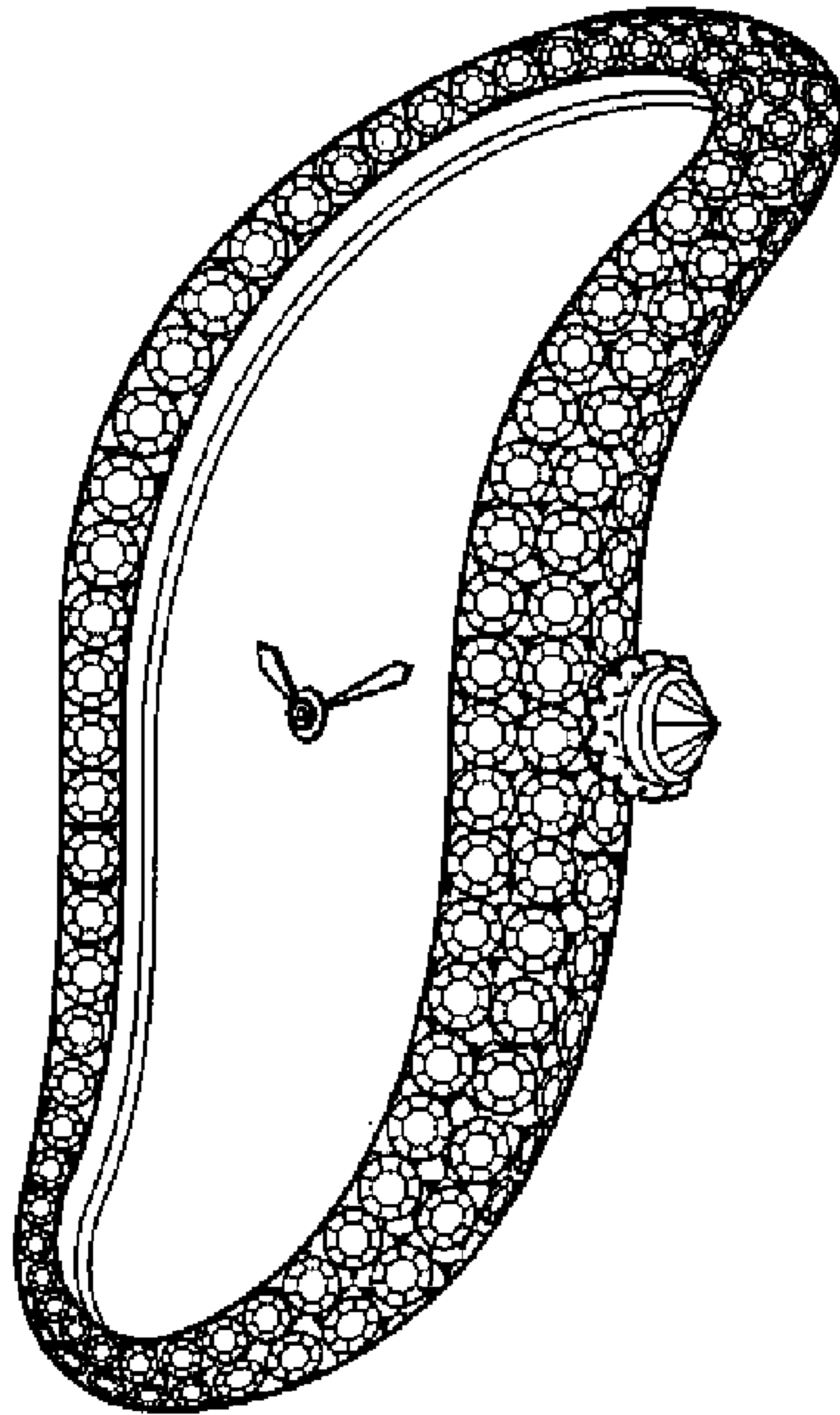

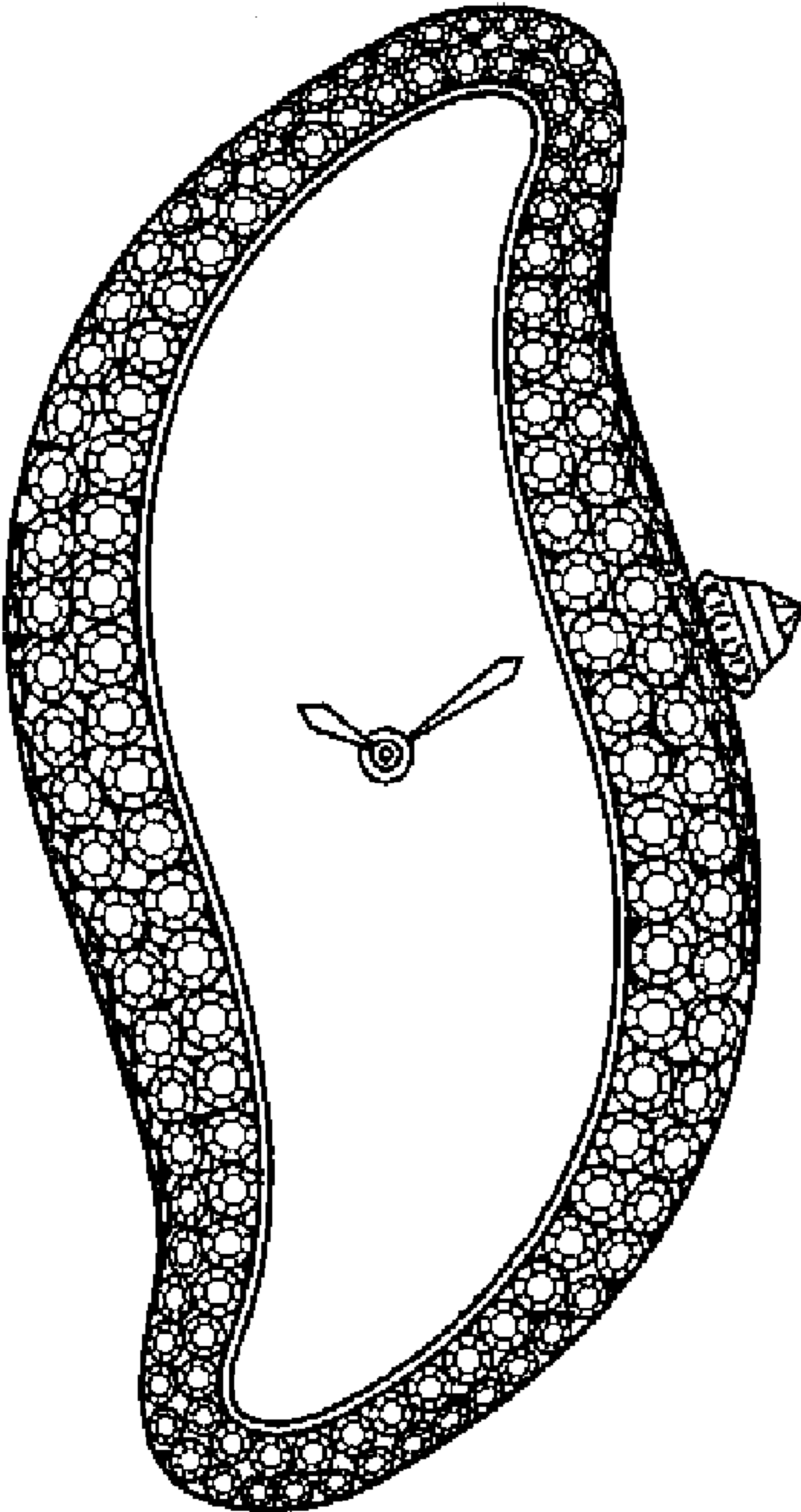

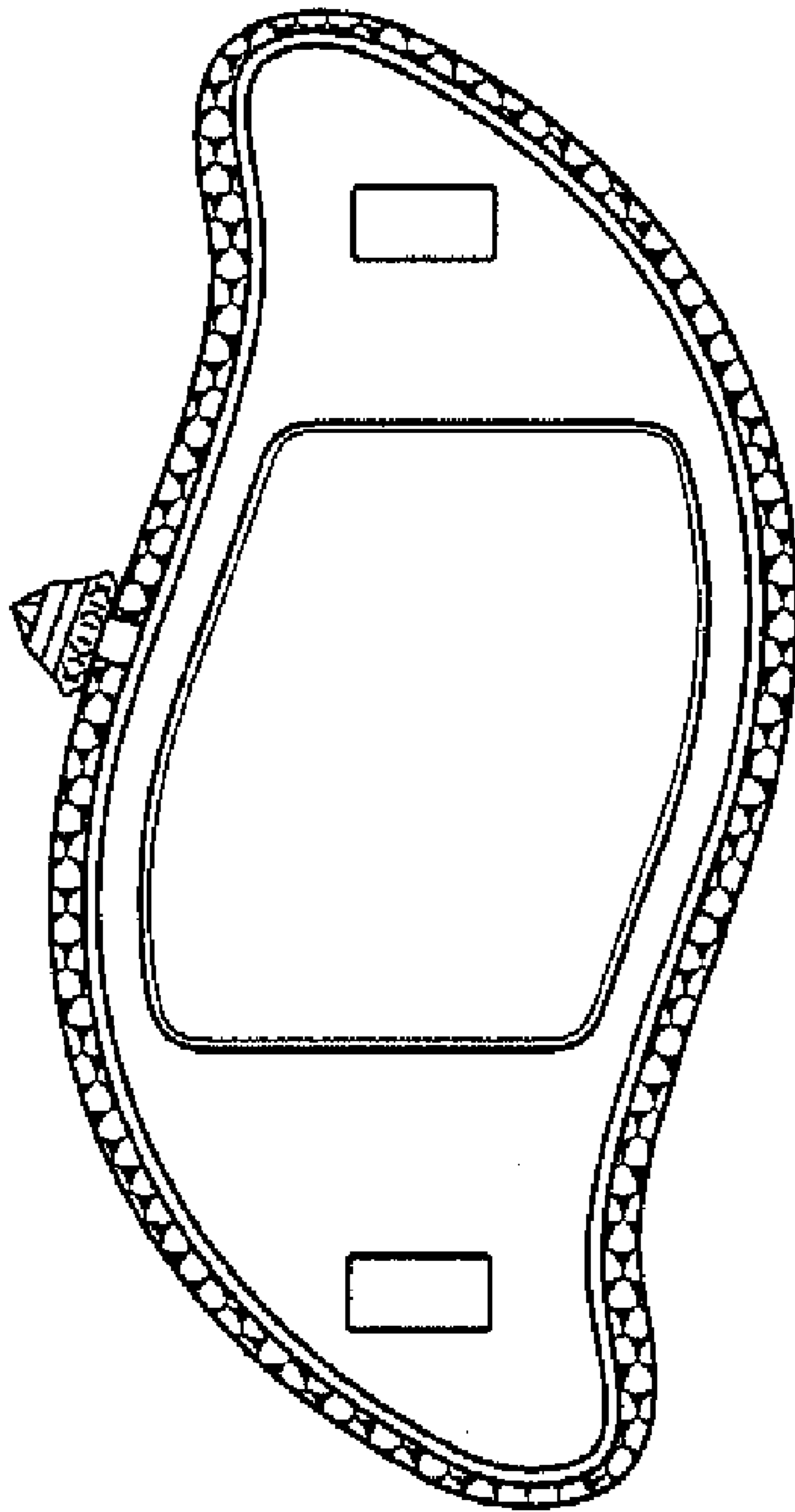

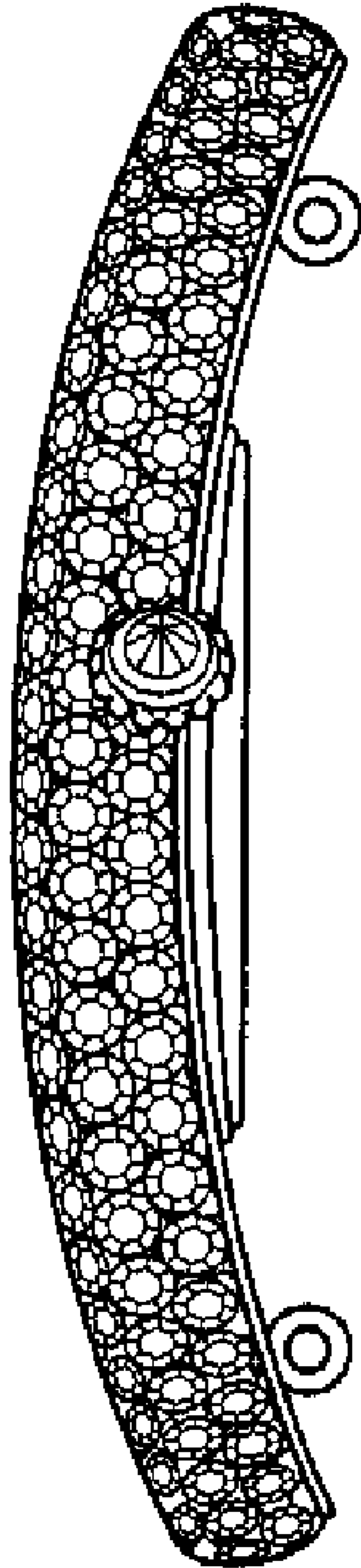

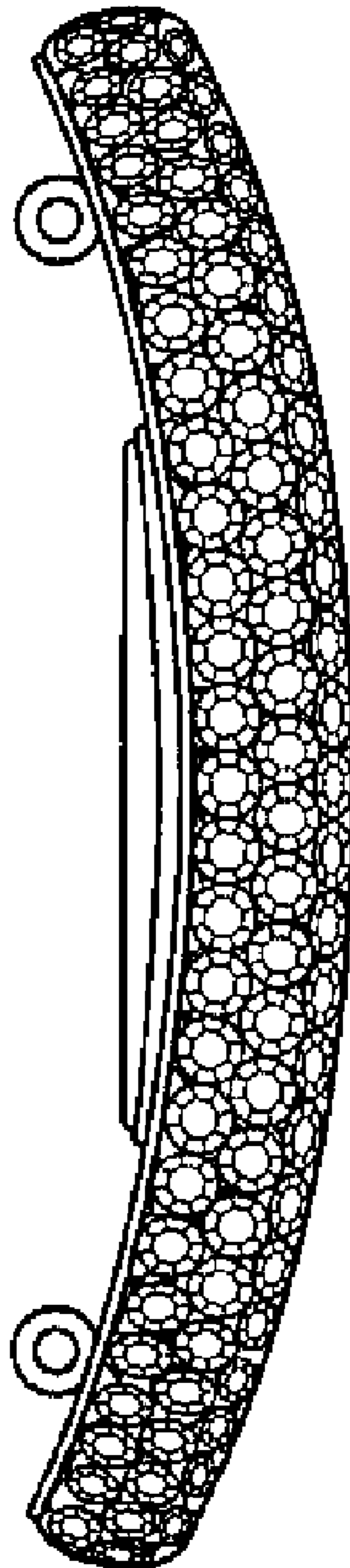

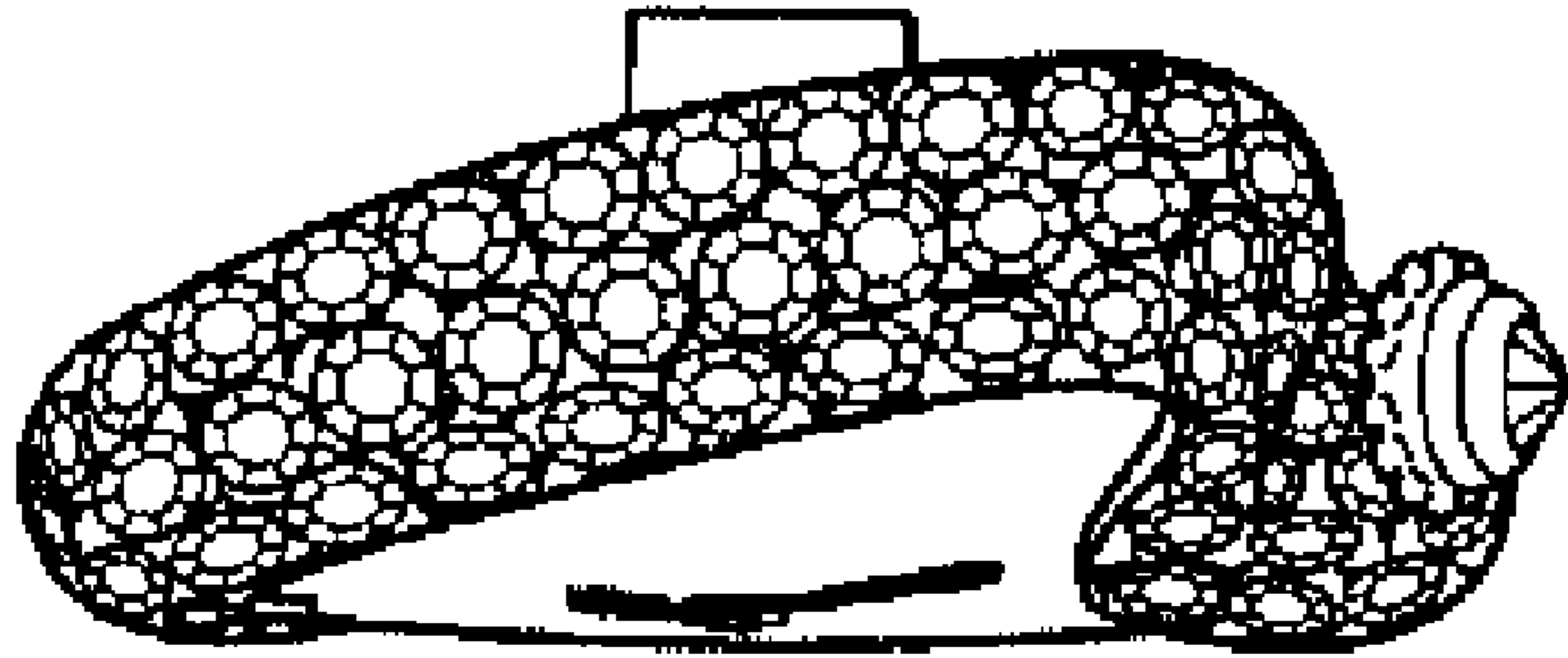

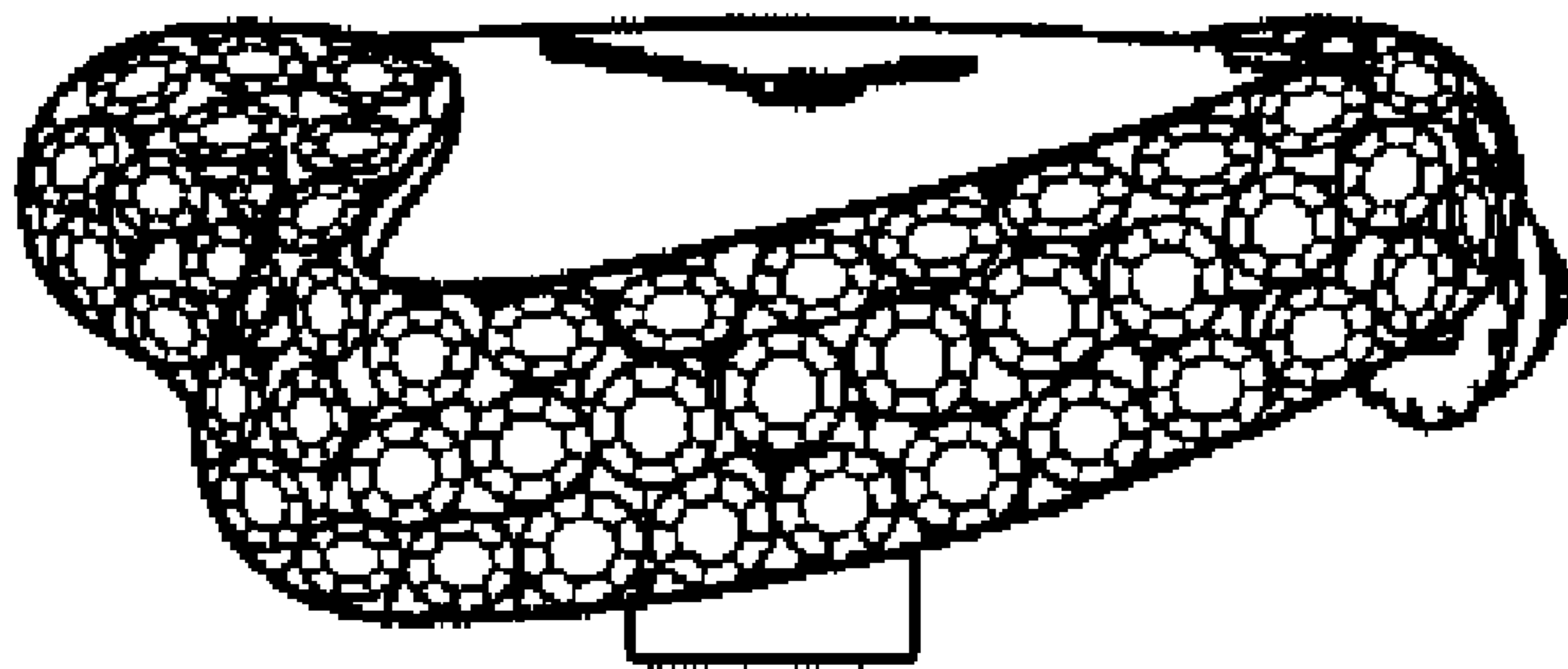
