shaver being placed in the charger with washing apparatus.

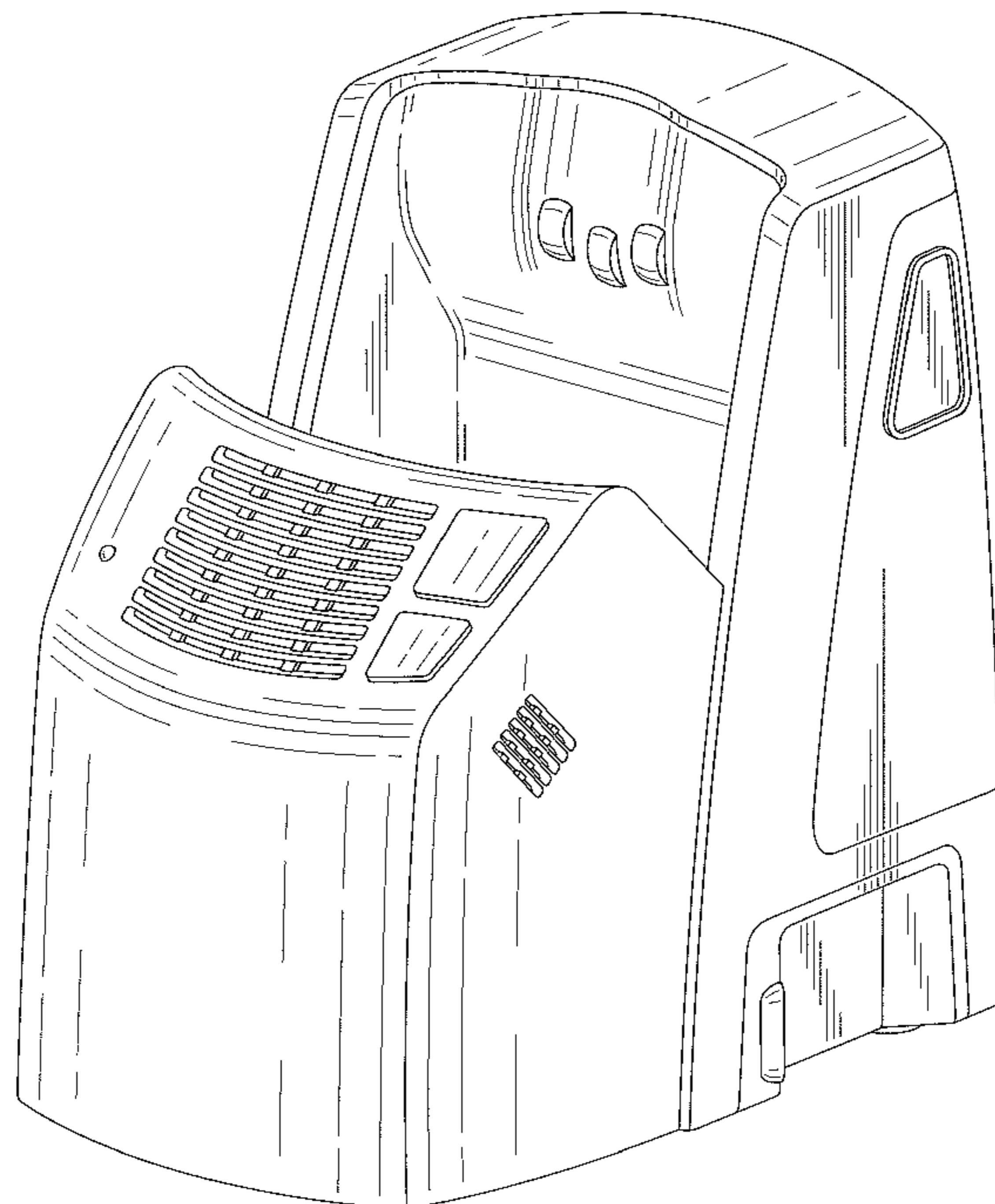

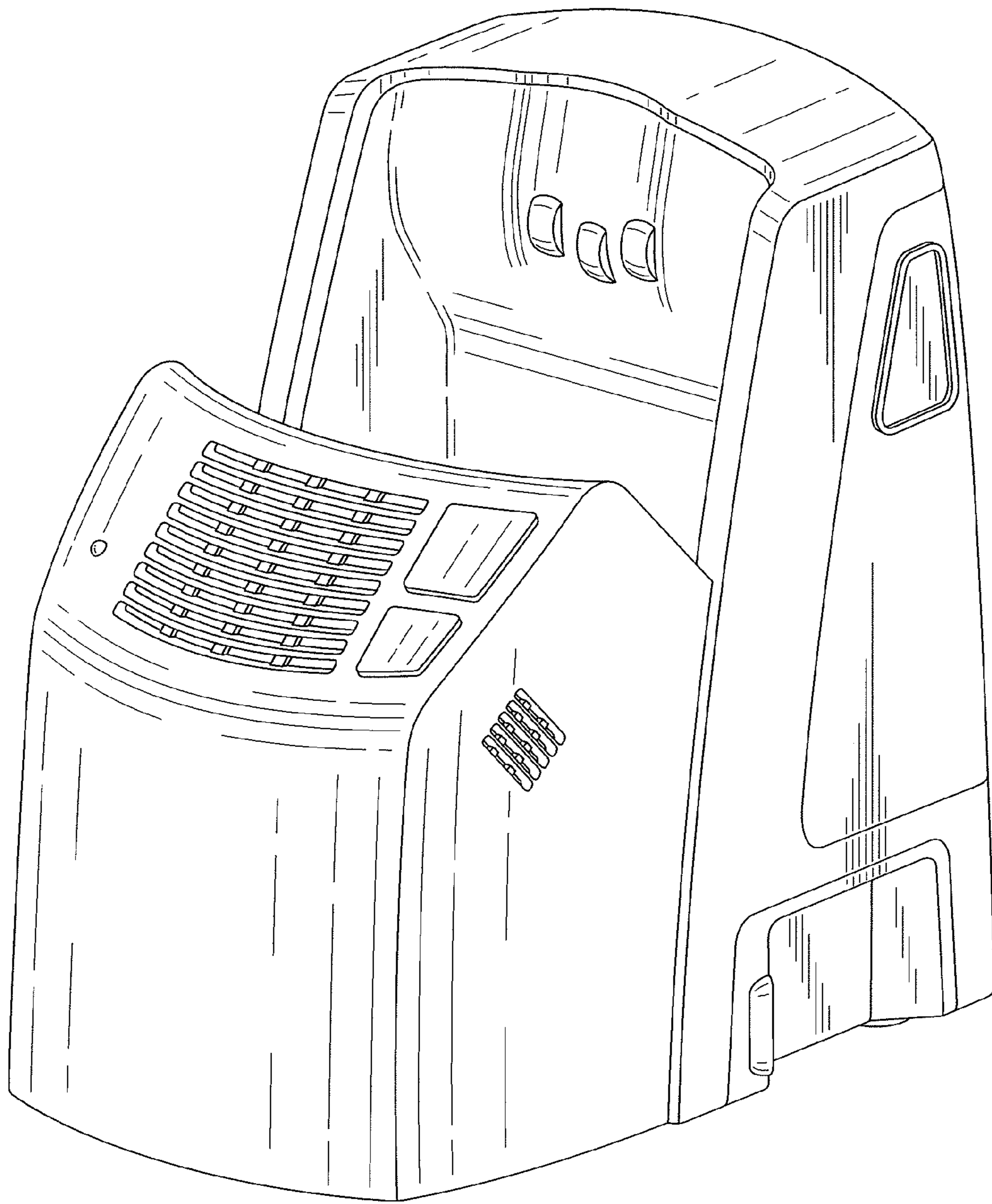

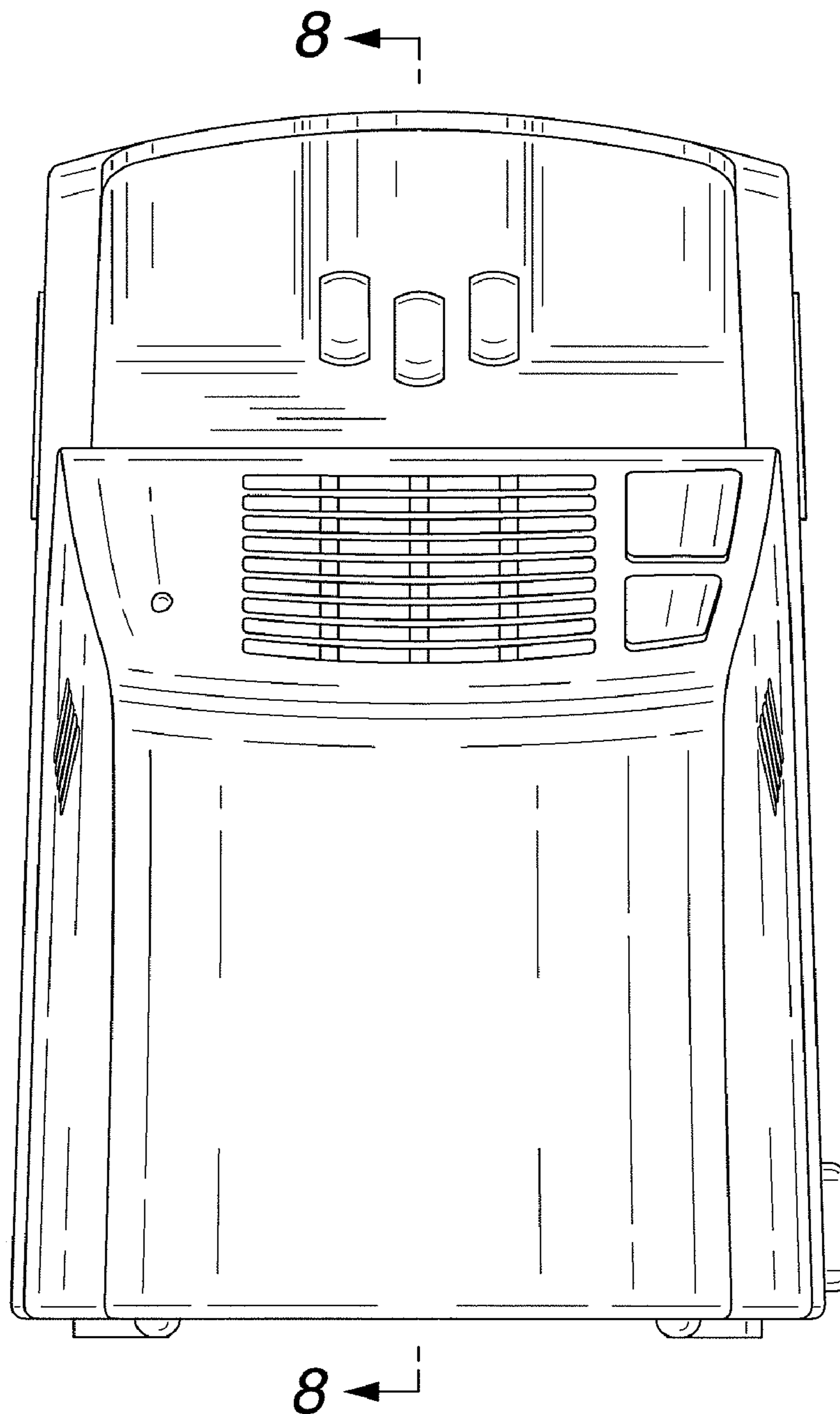

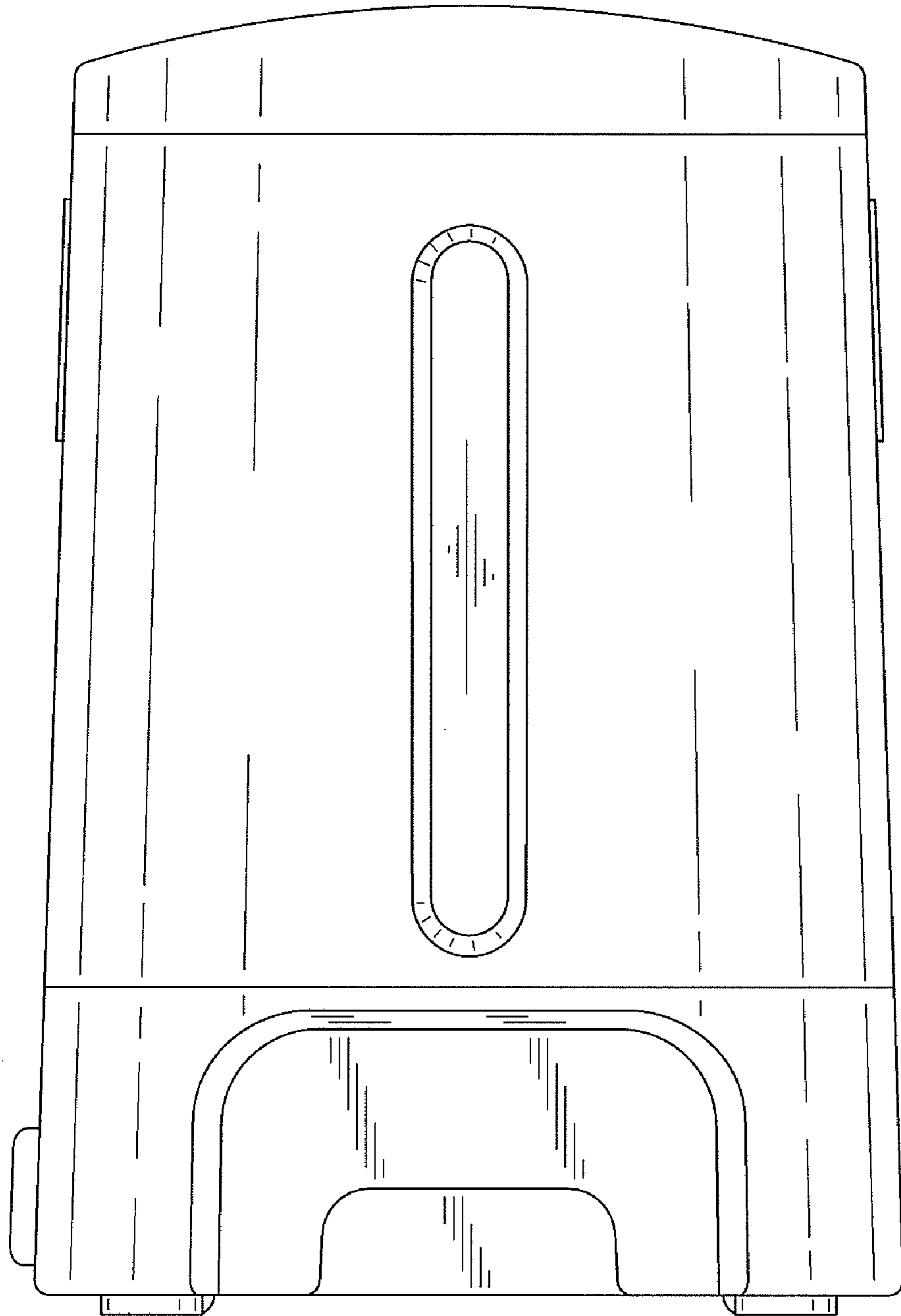

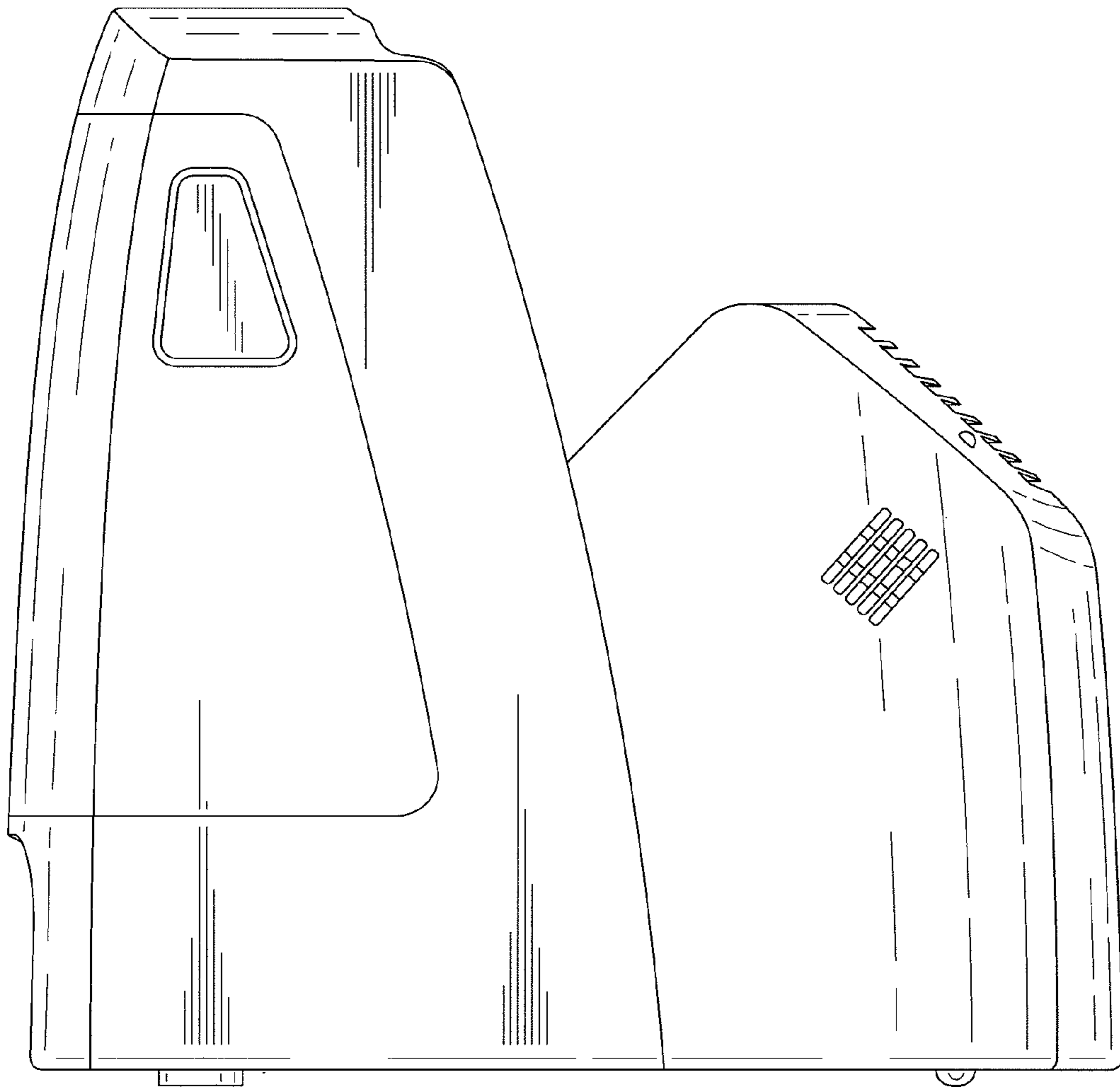

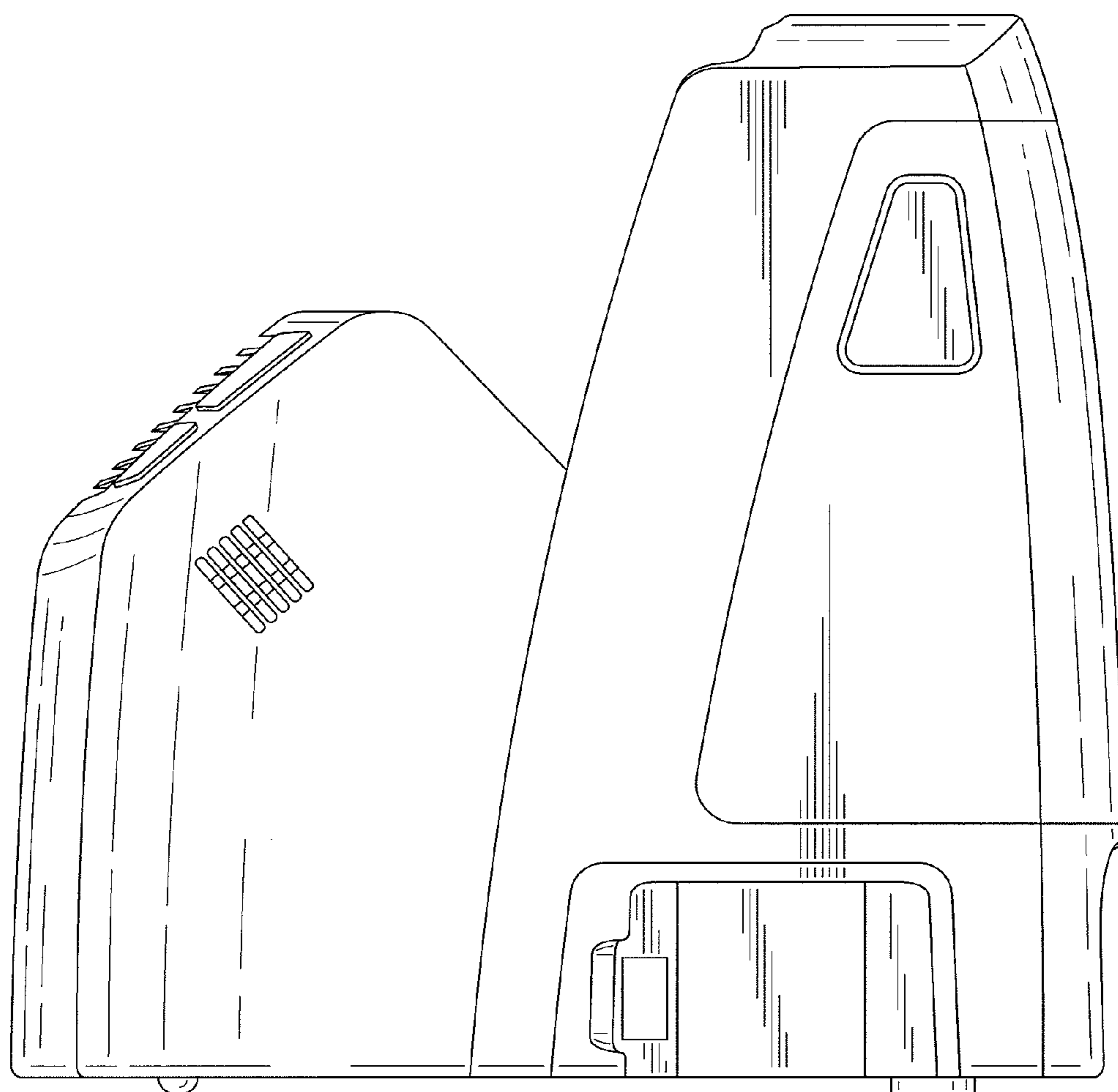

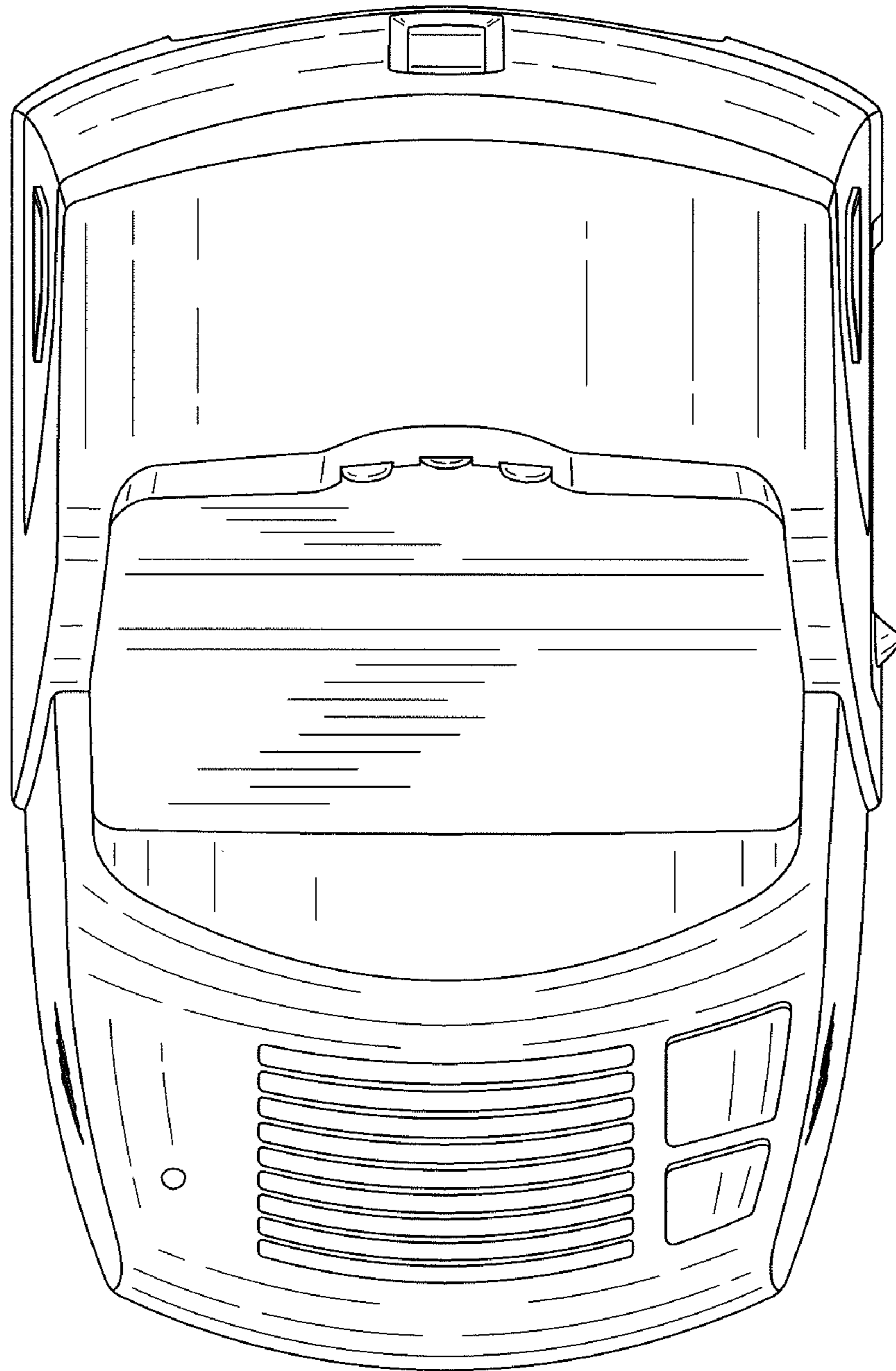

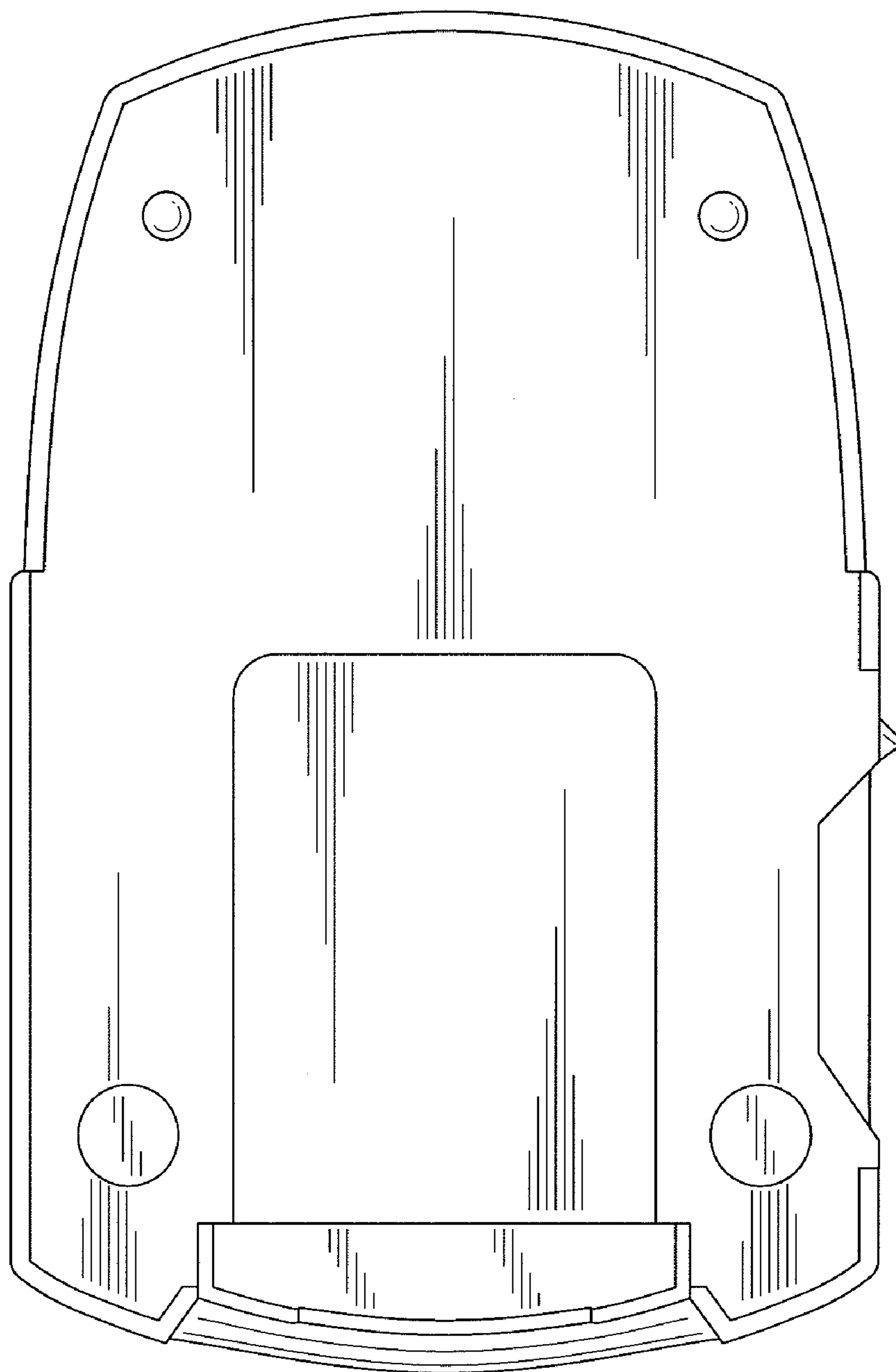

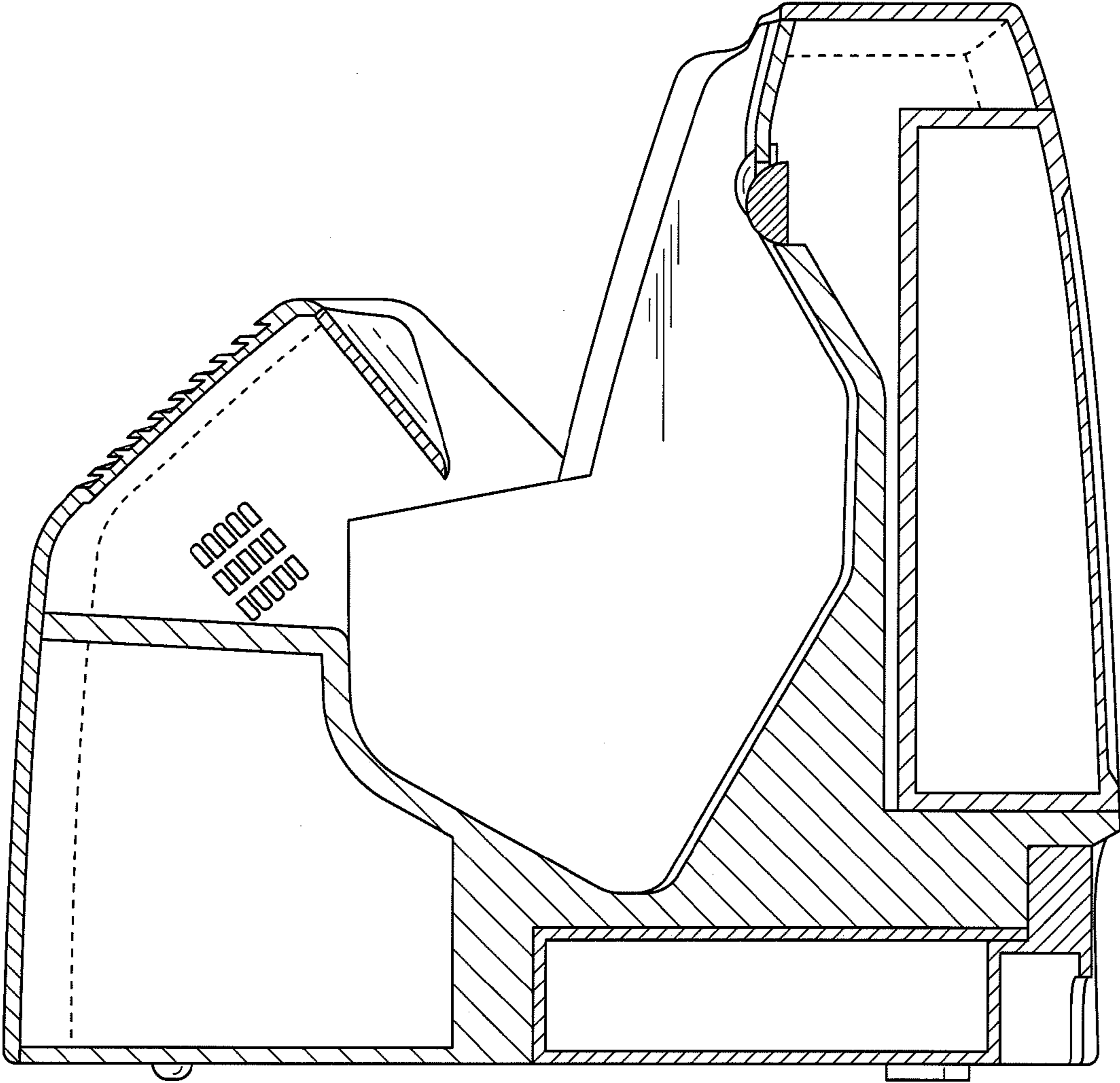

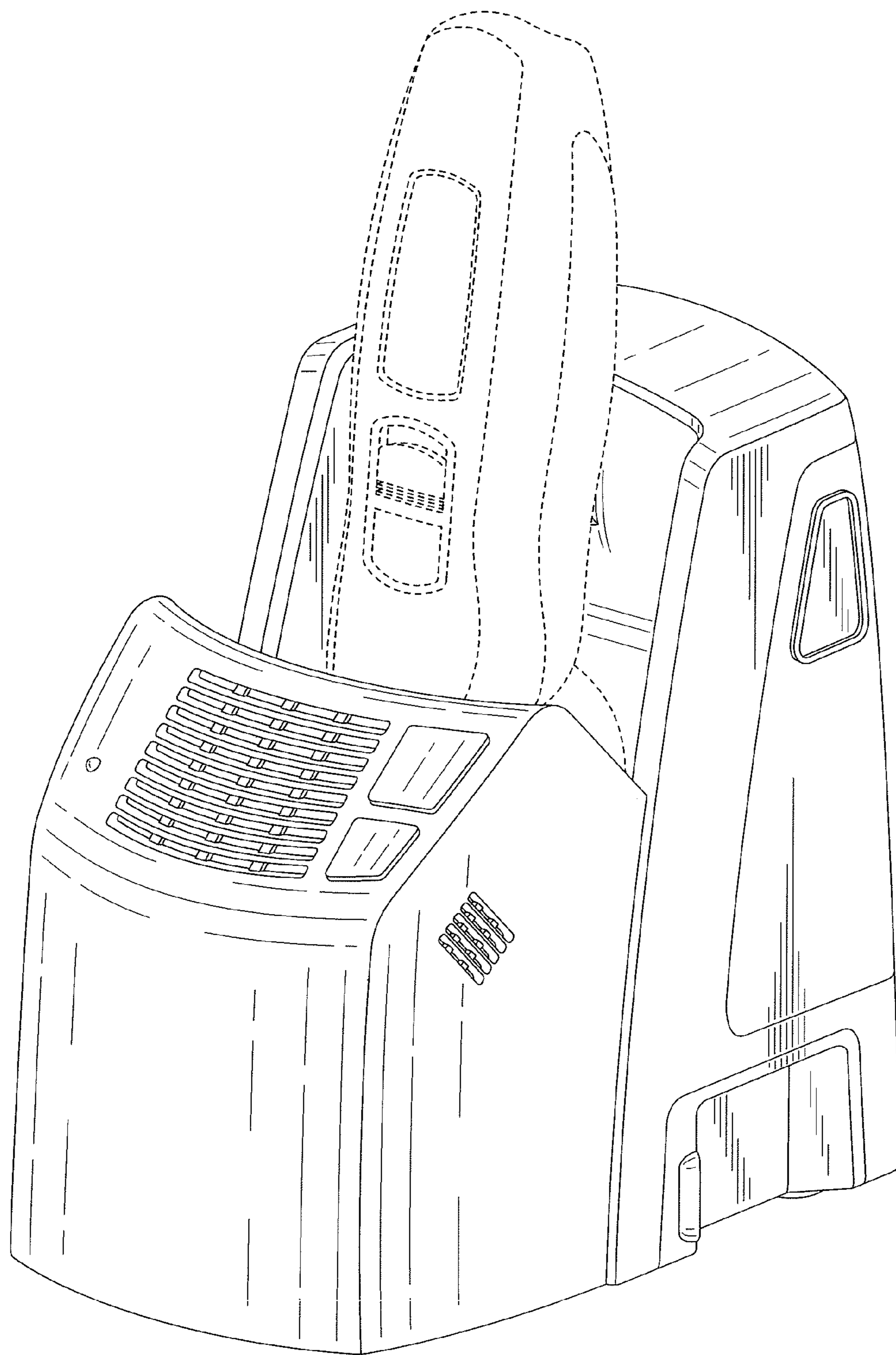
