DESCRIPTION

FIG. 1 is a front isometric view of a media player showing our new design;

FIG. 4 is a left side elevational view thereof;

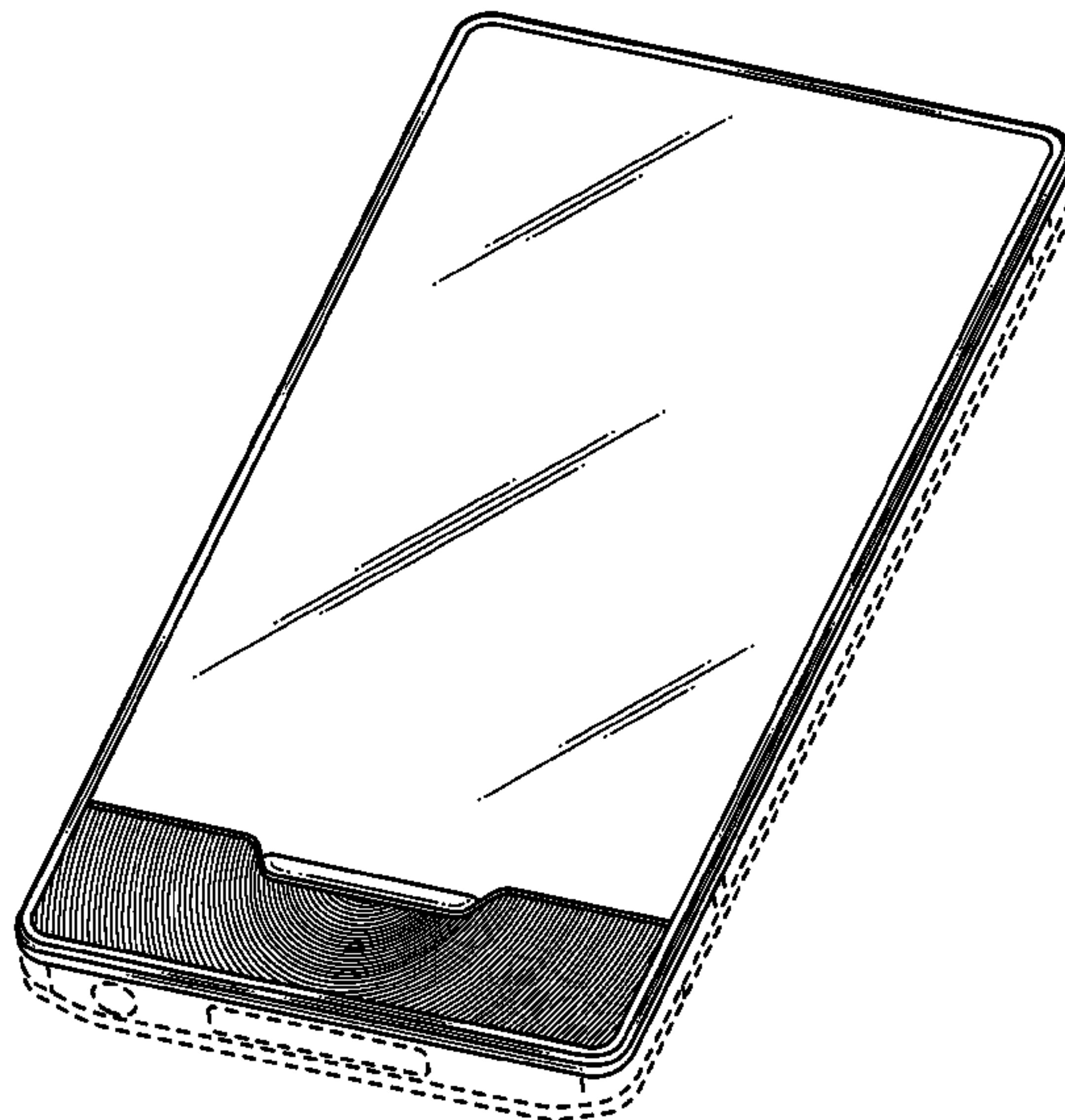
FIG. 5 is a top plan view thereof;

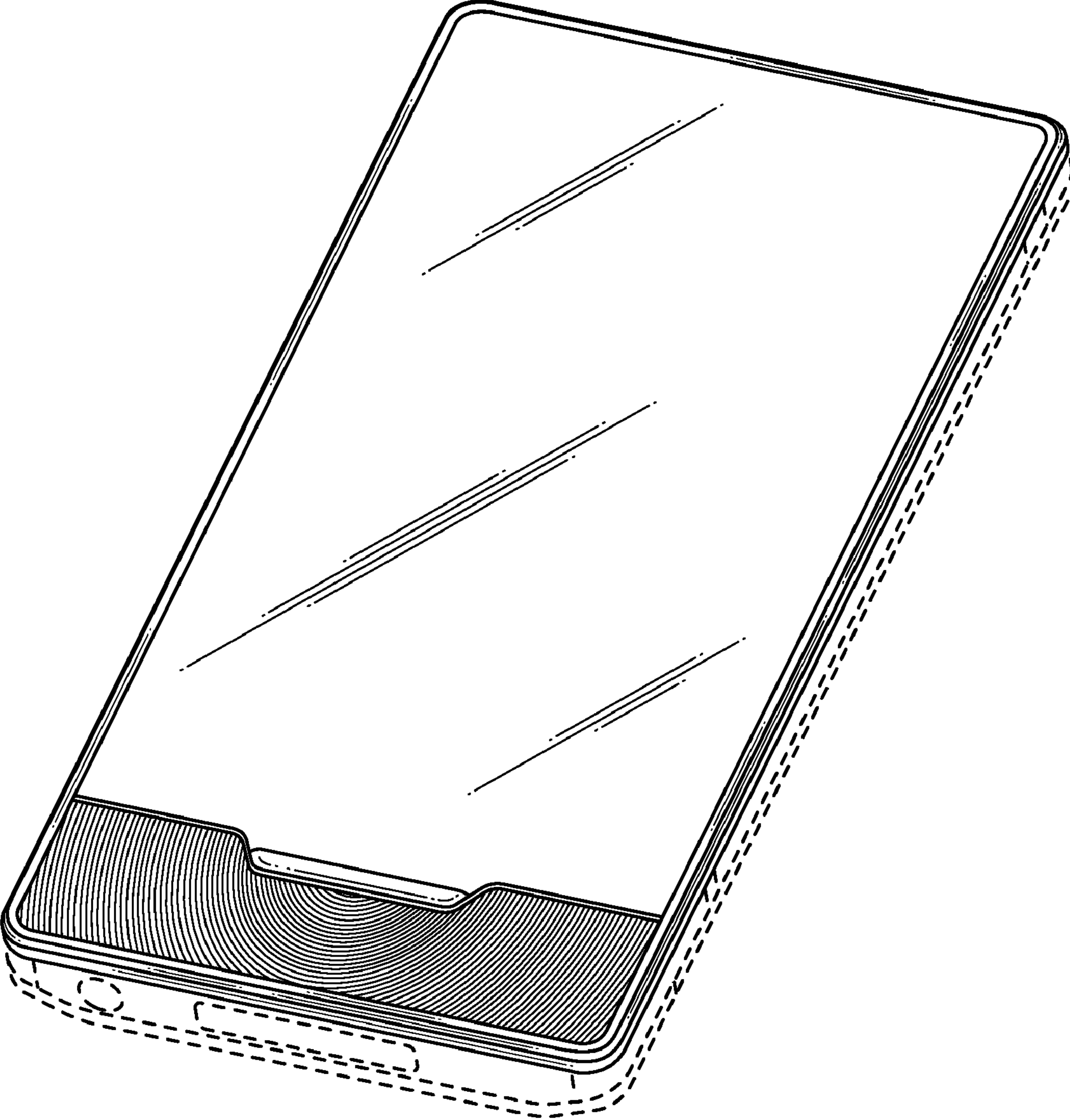

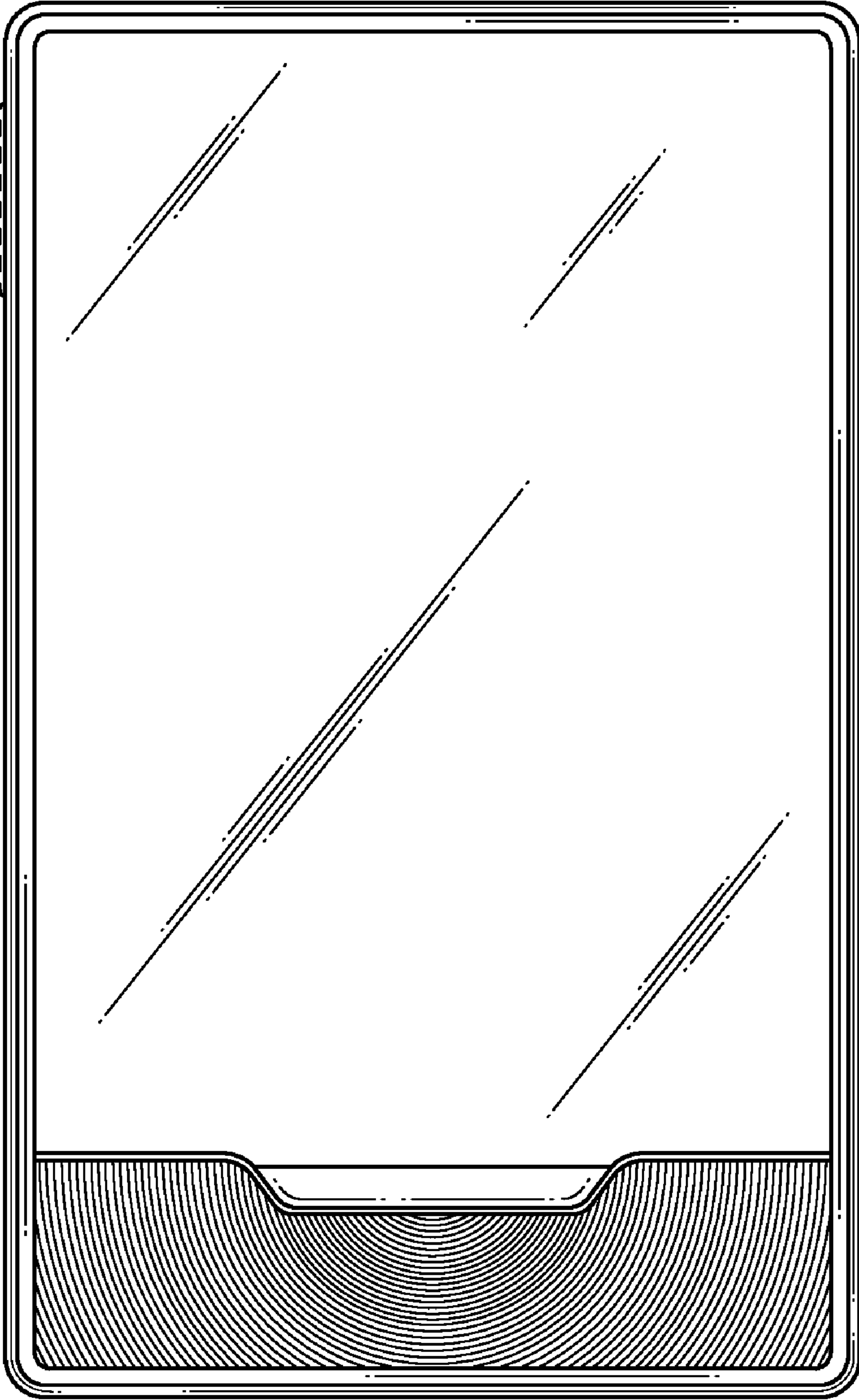

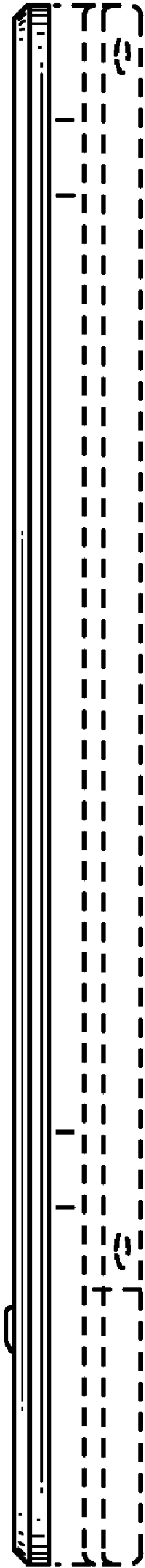

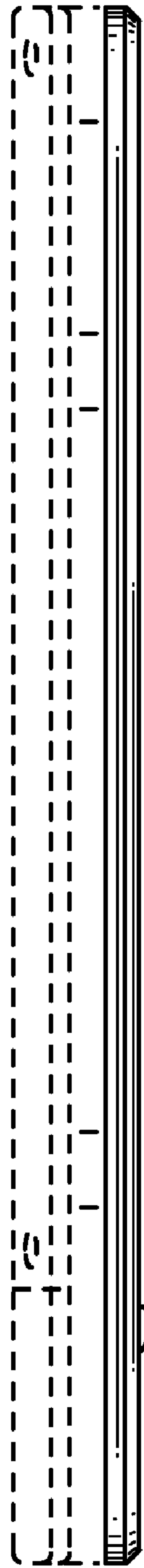

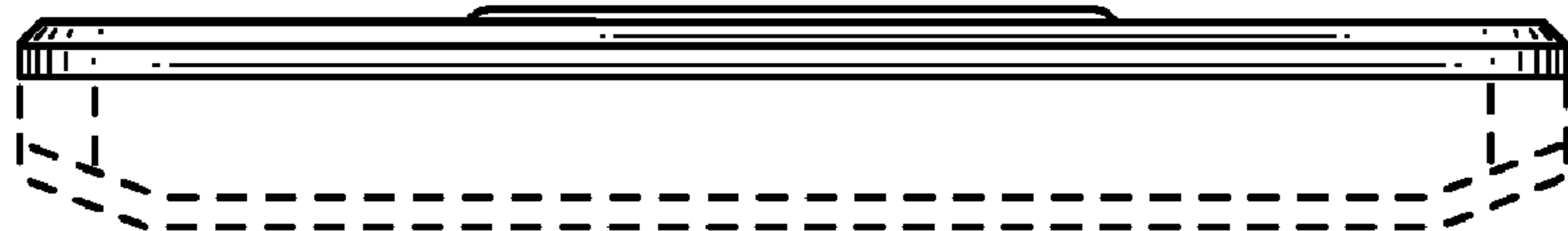

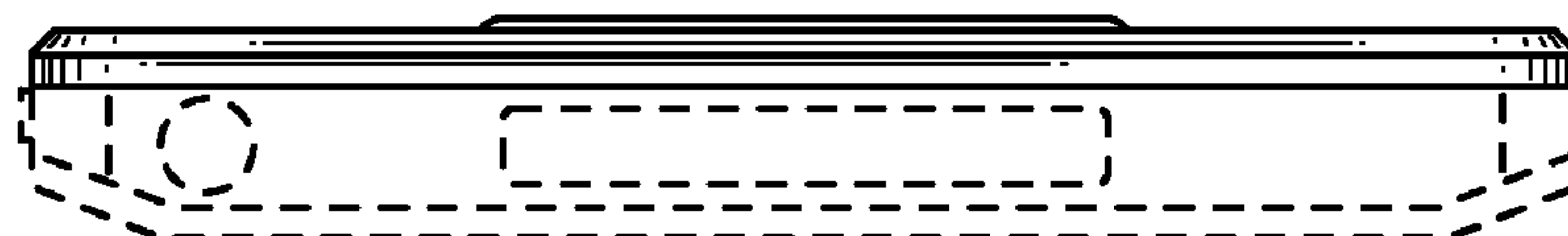

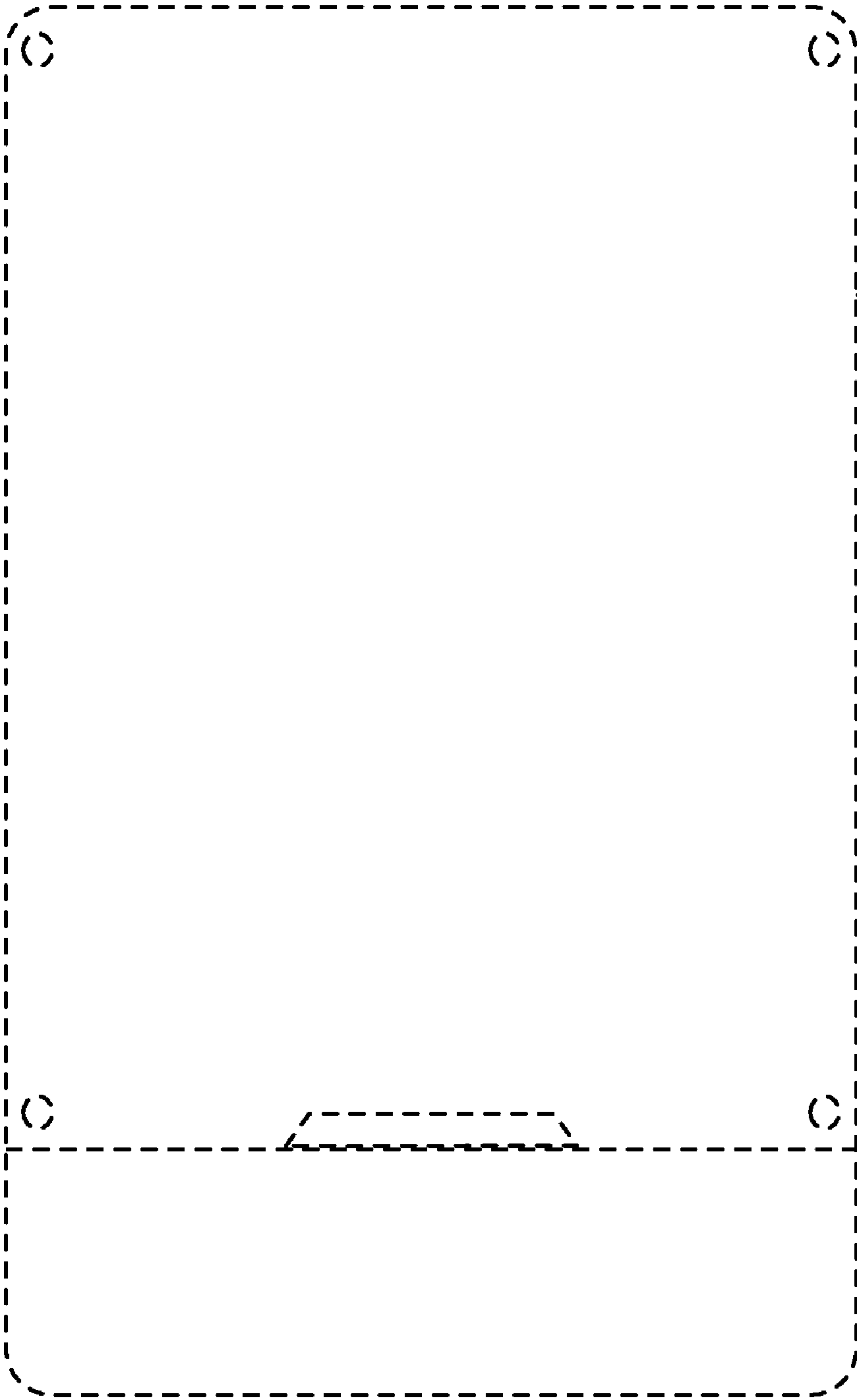
