FIG. 14 is a bottom view of an aromatic nebulizing diffuser embodying the design shown in FIG. 8.

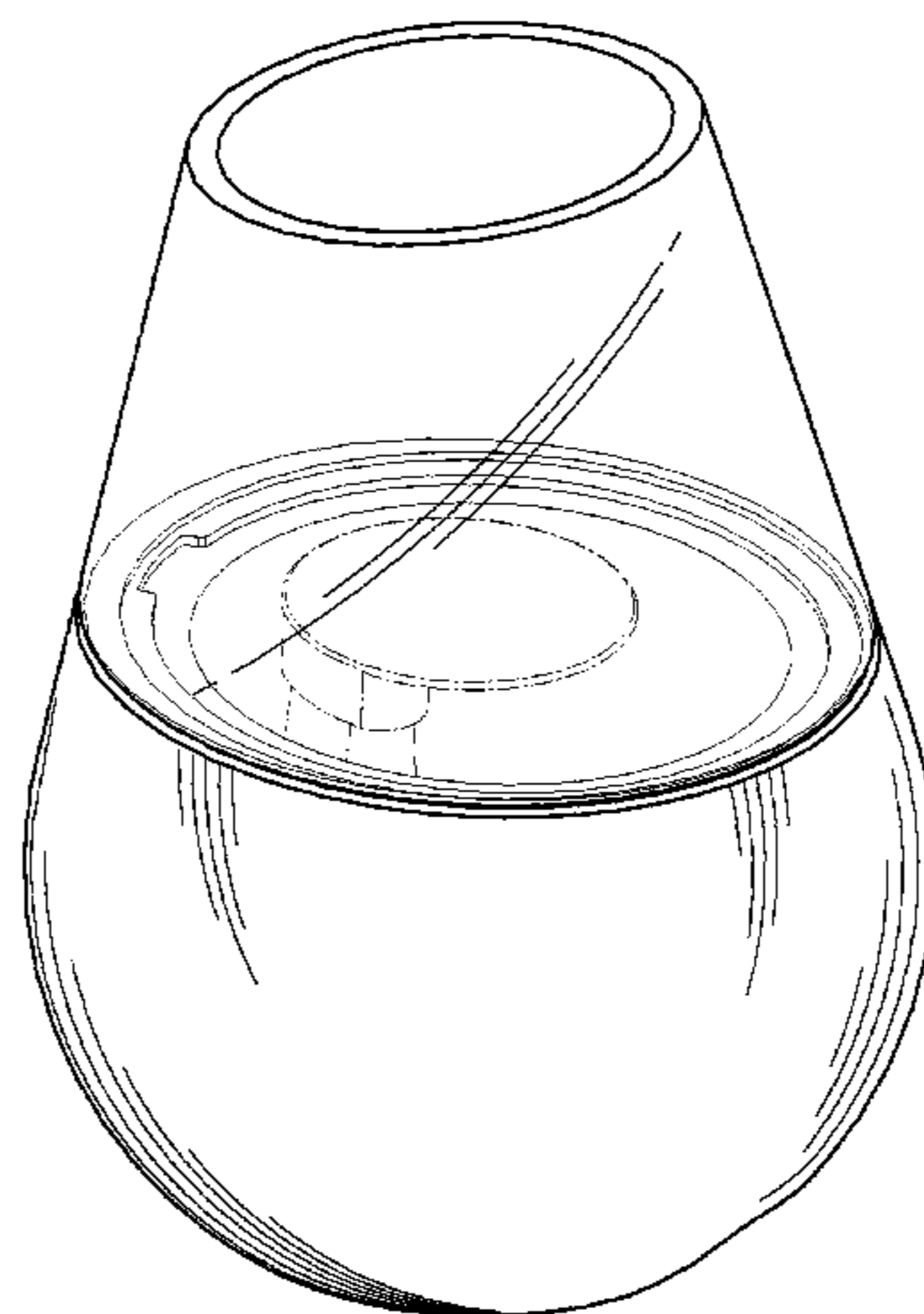

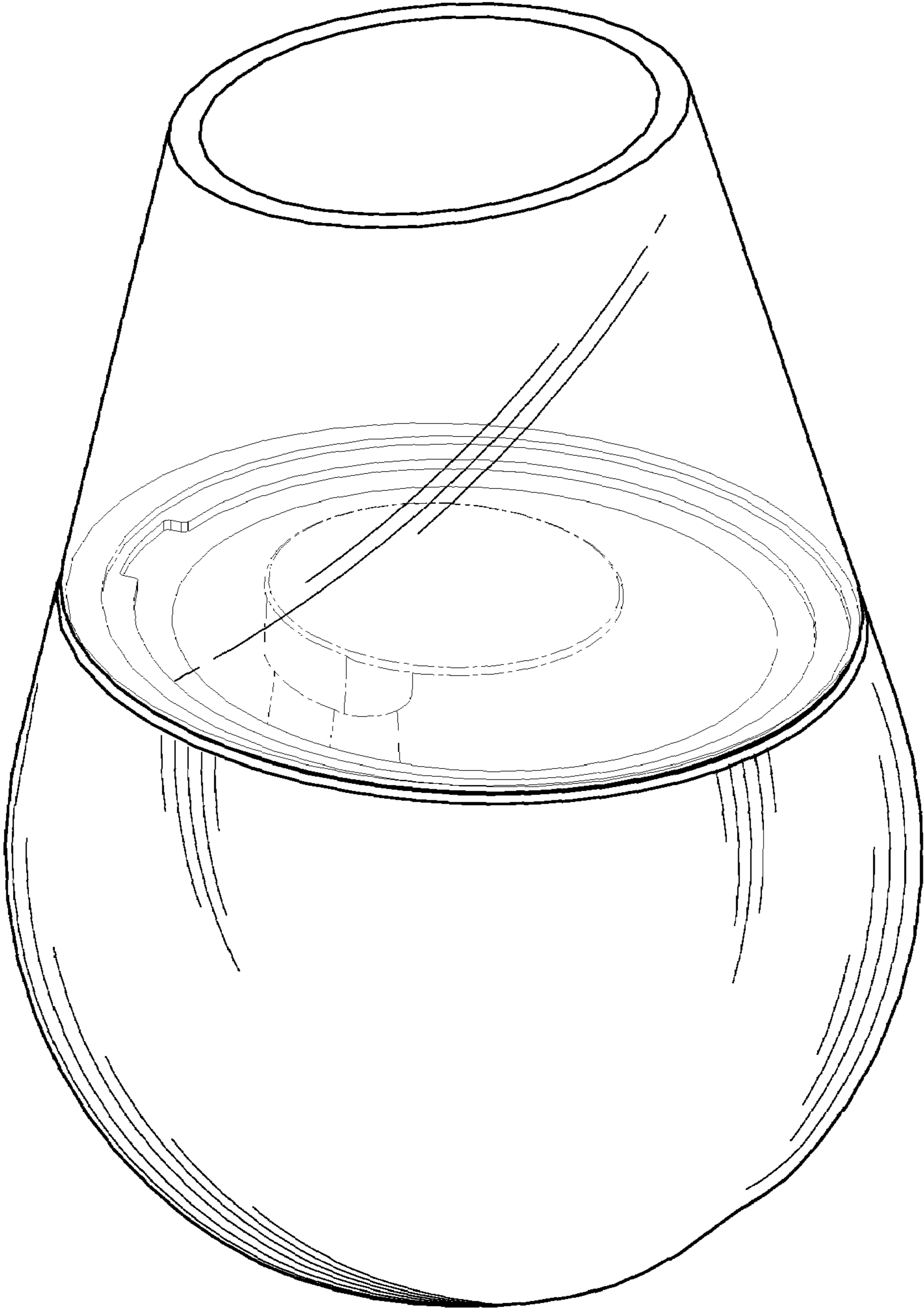

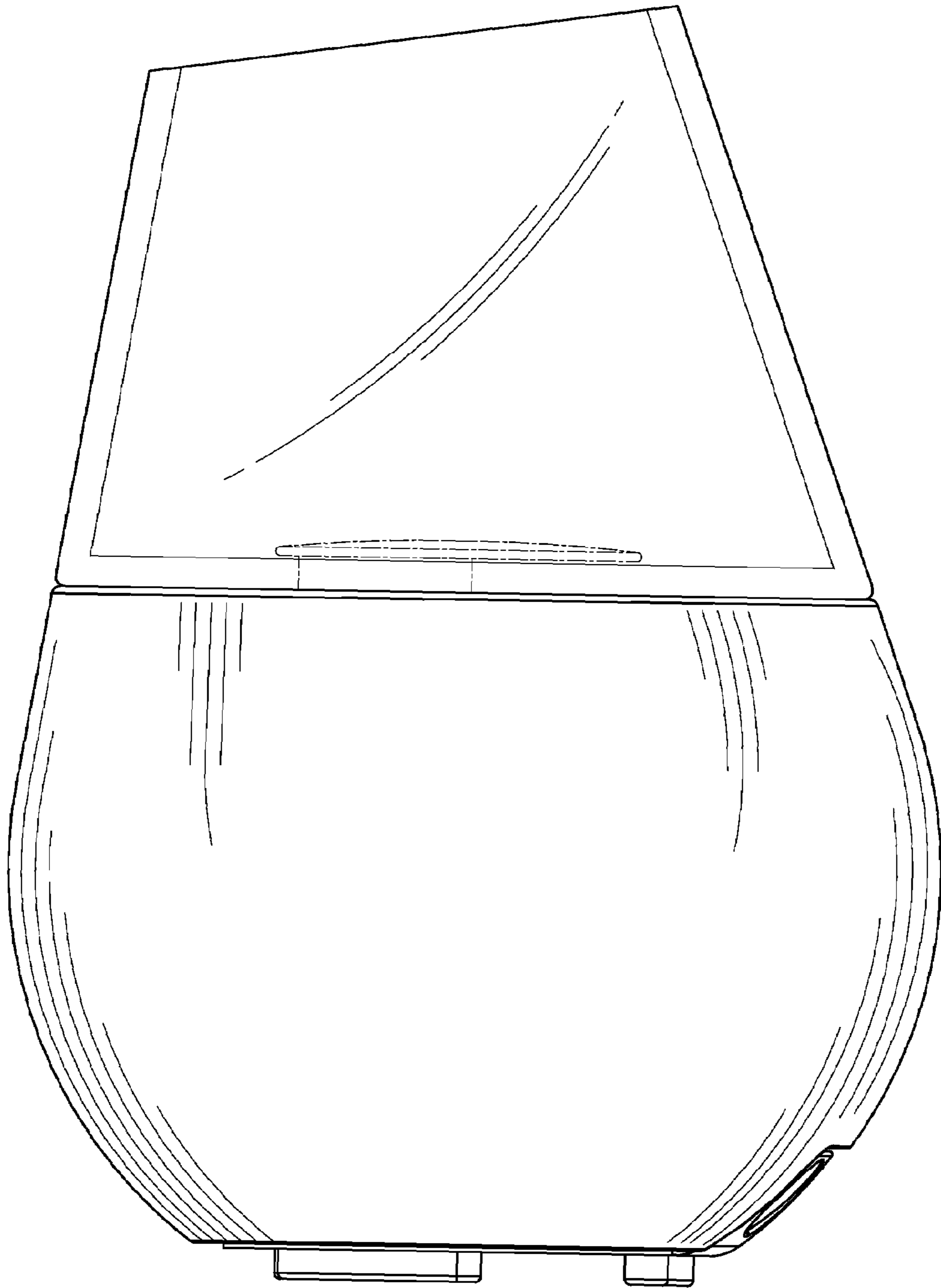

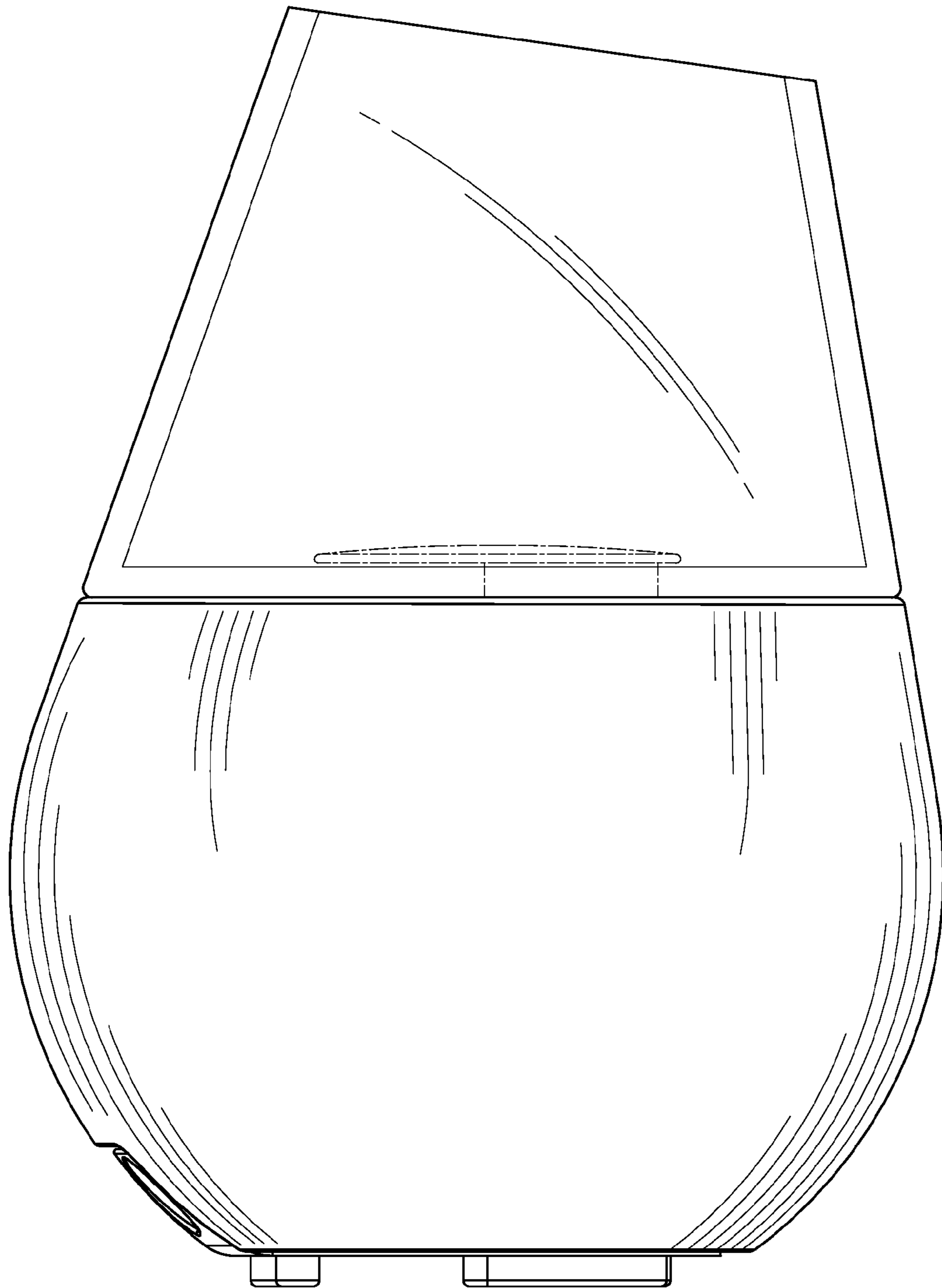

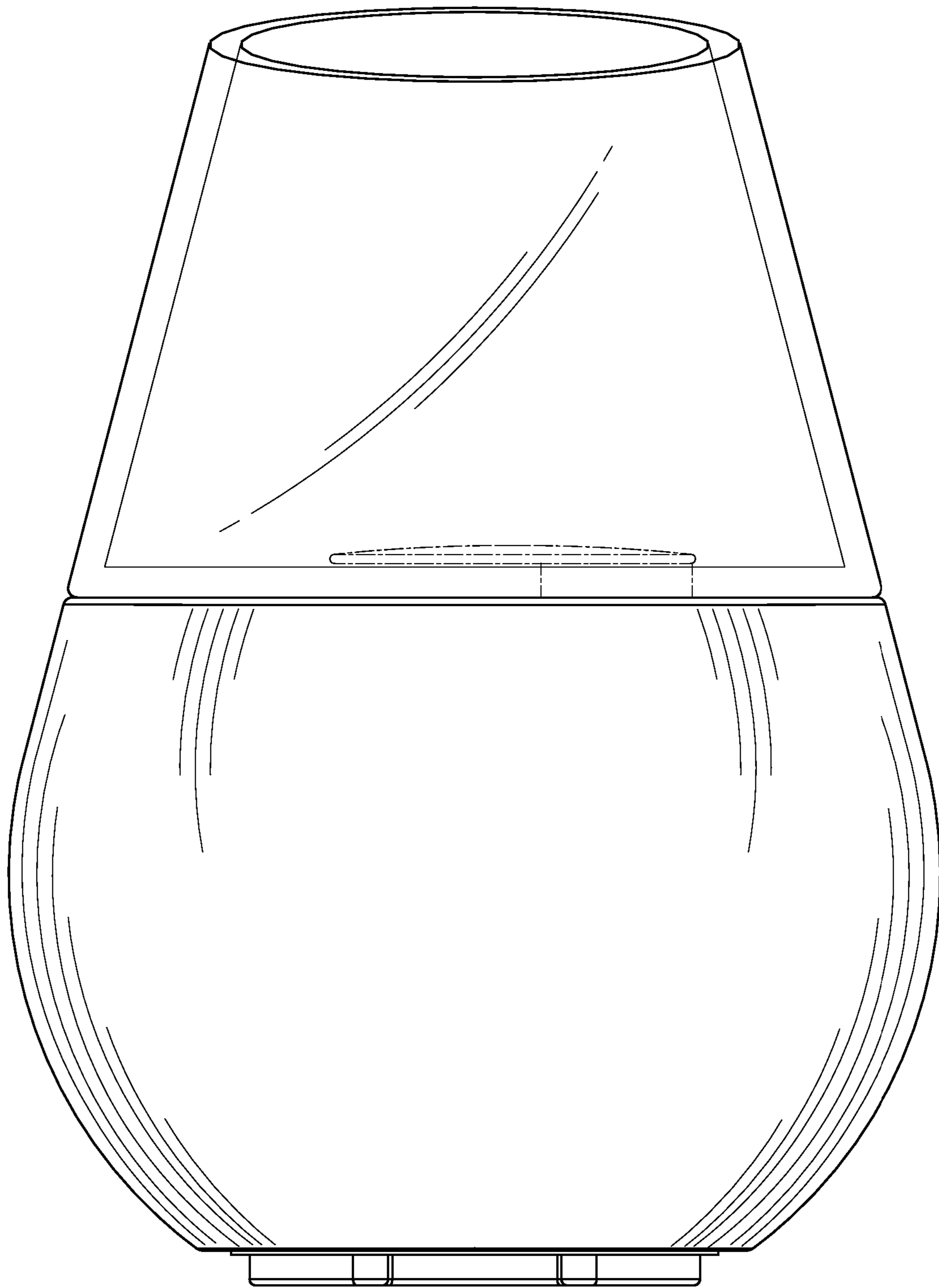

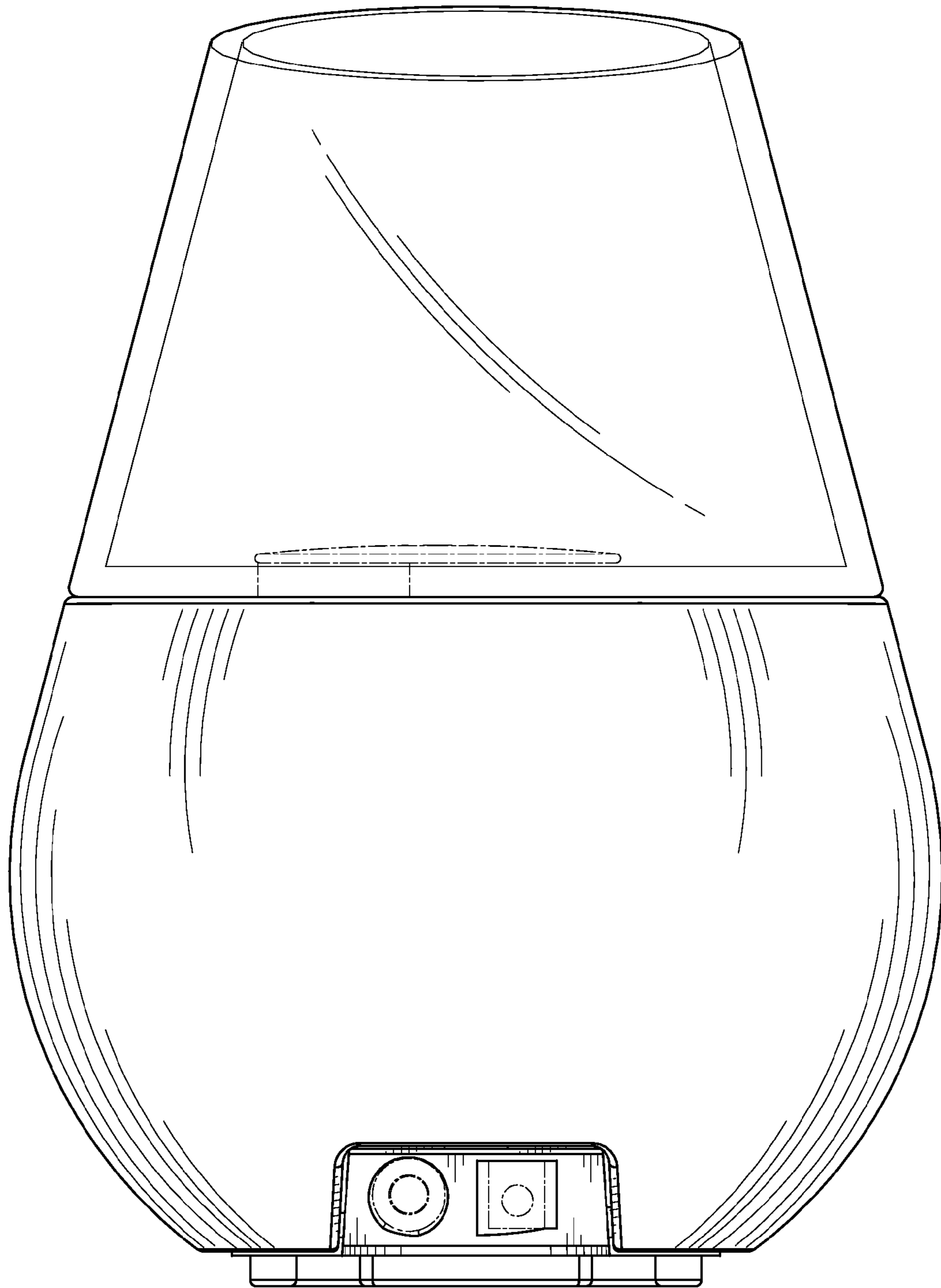

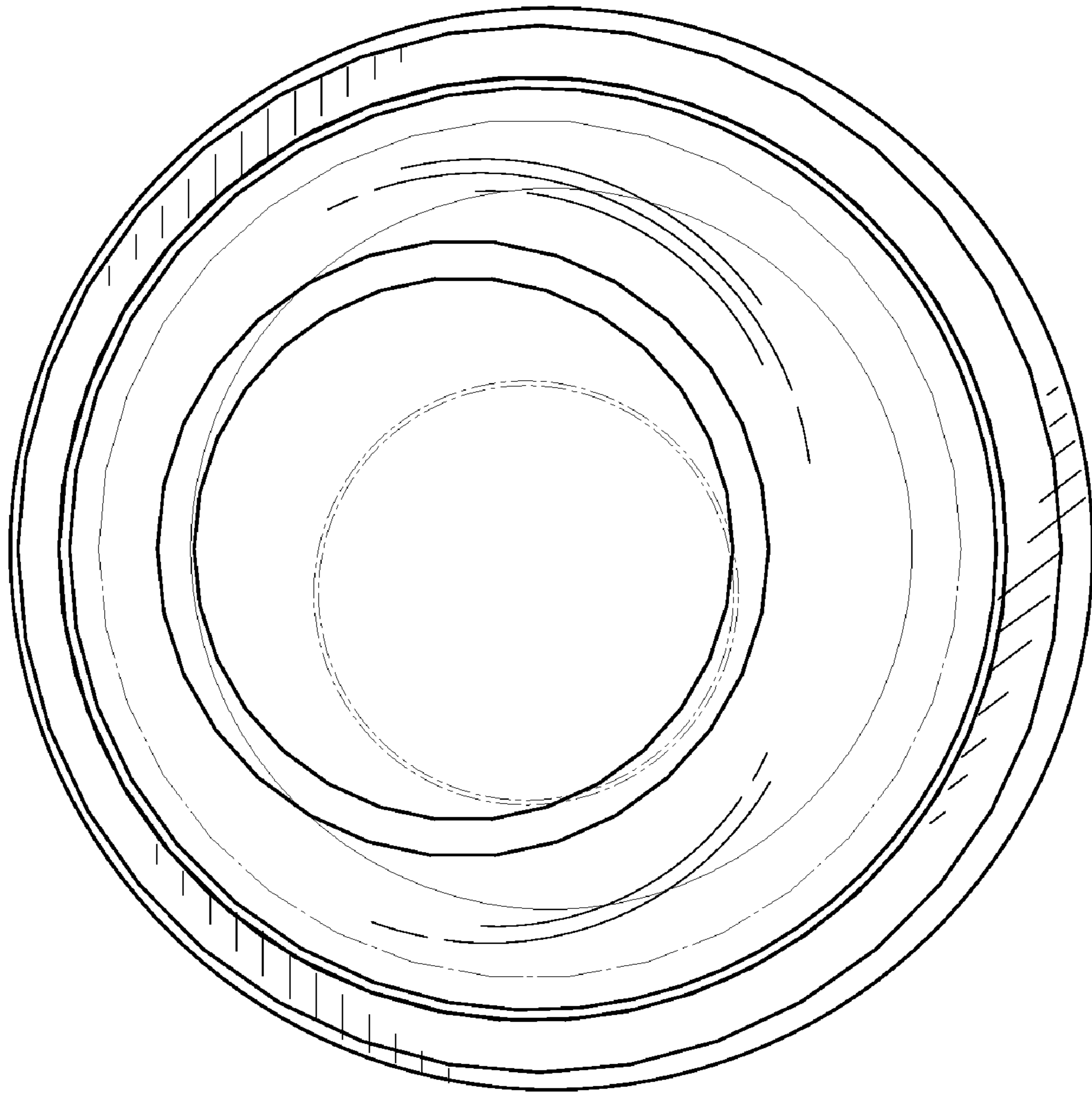

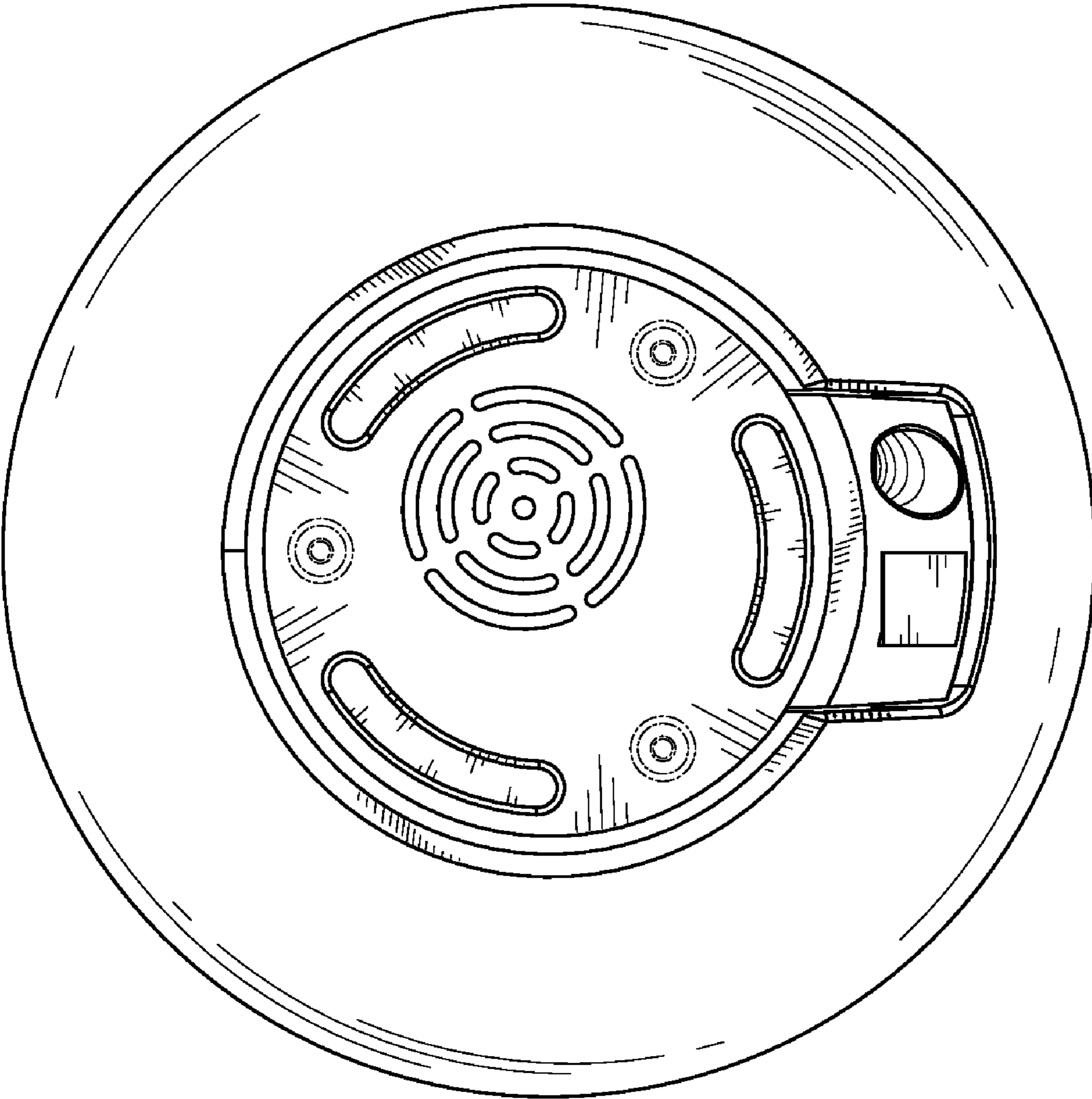

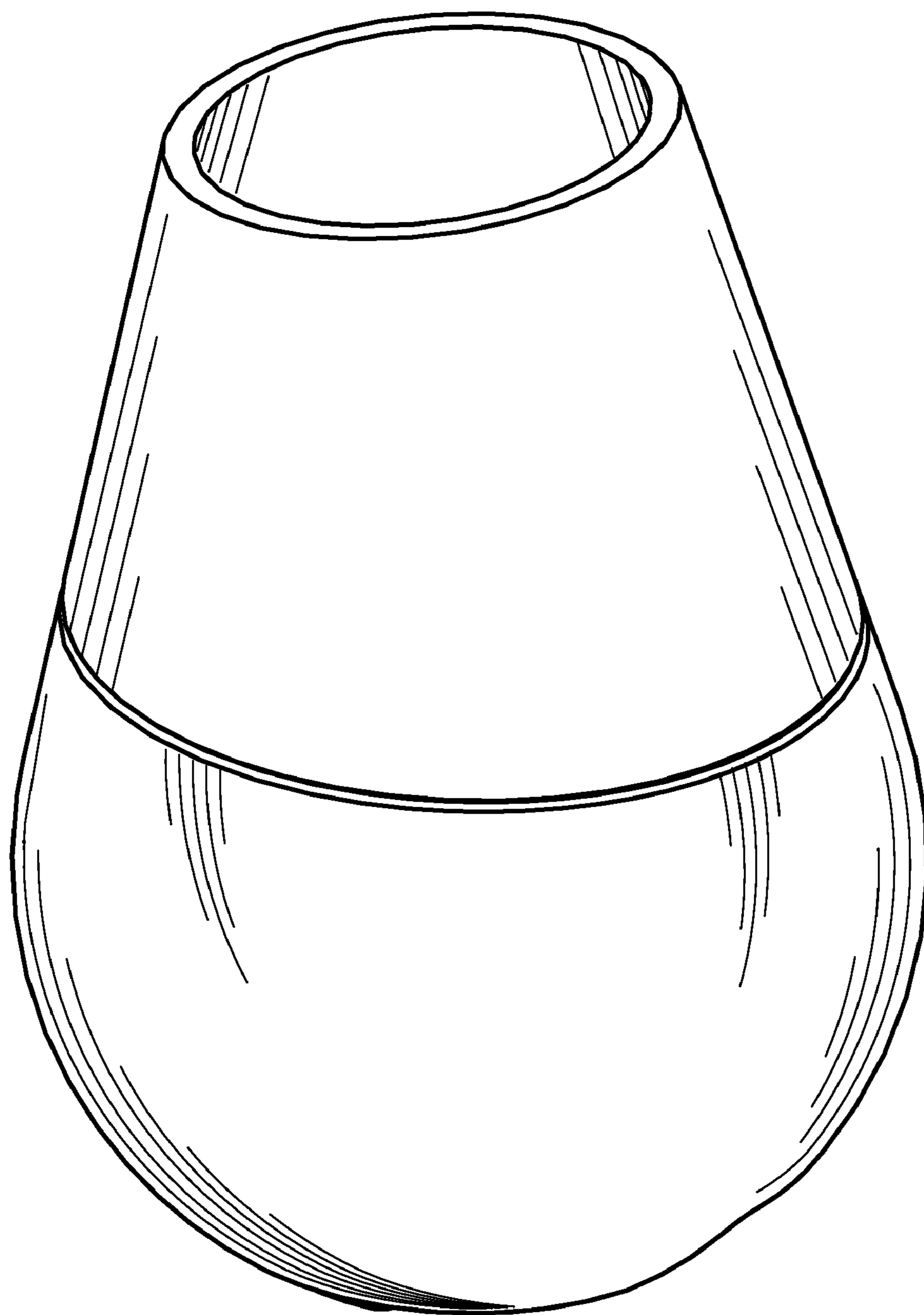

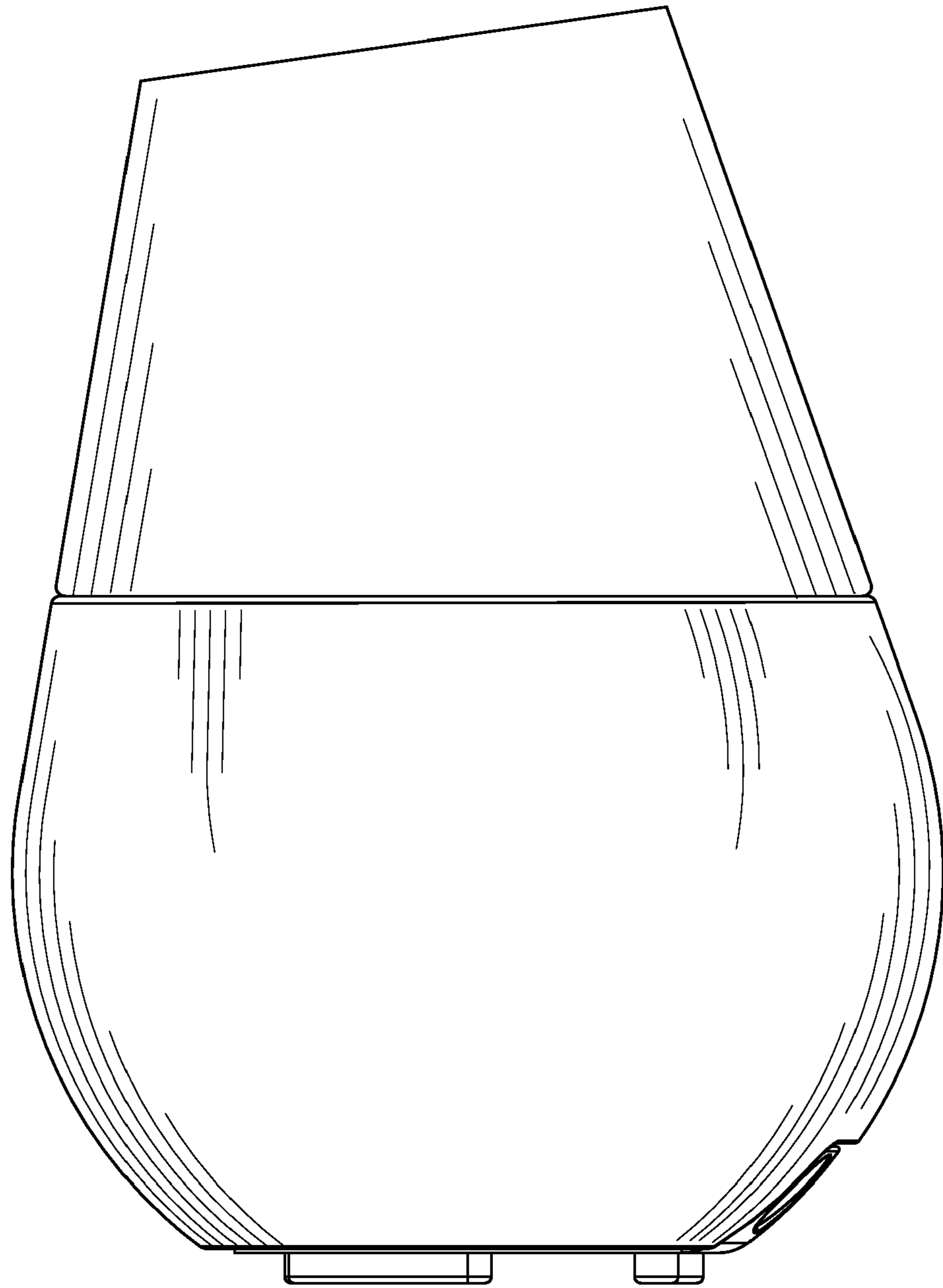

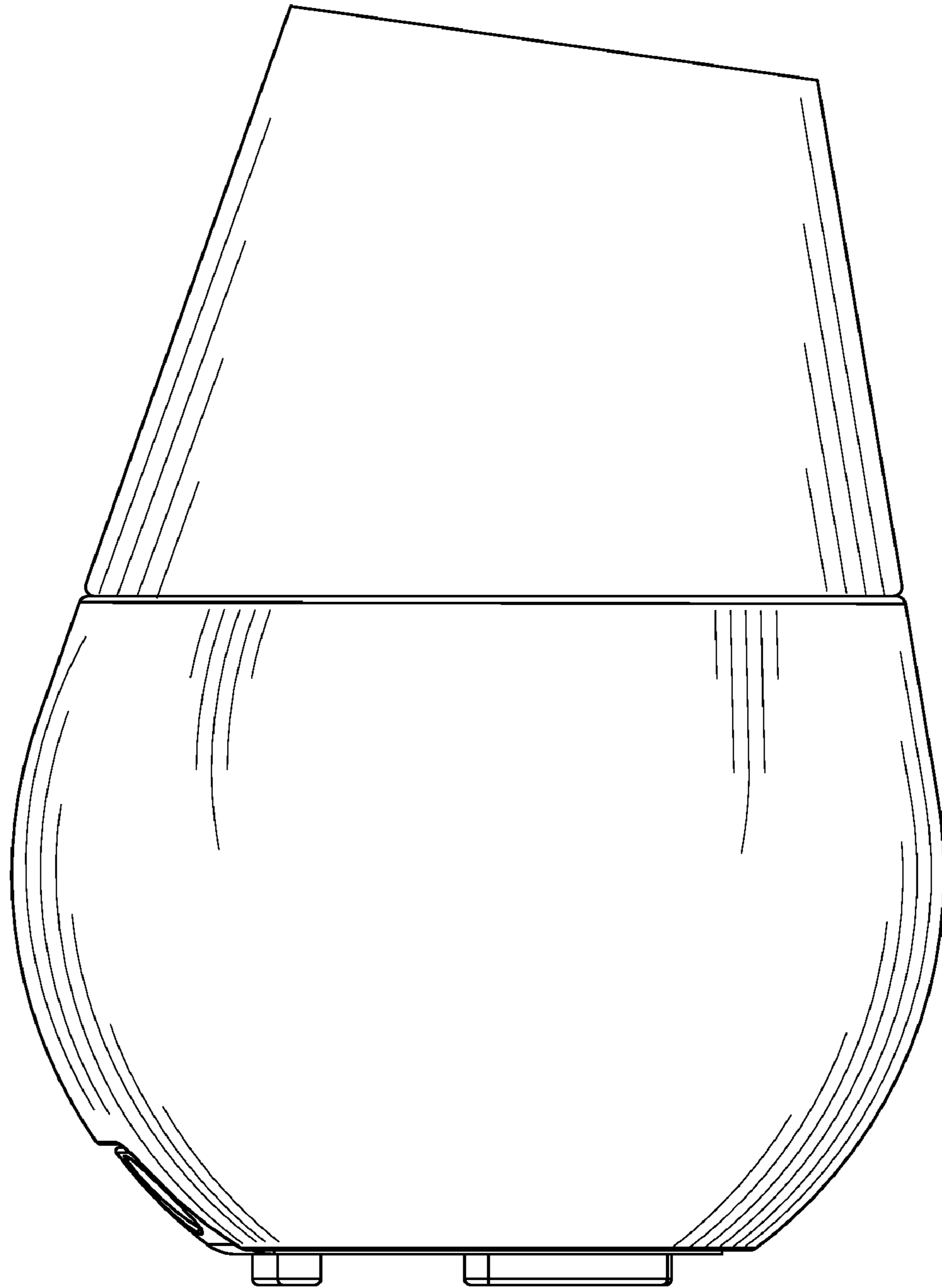

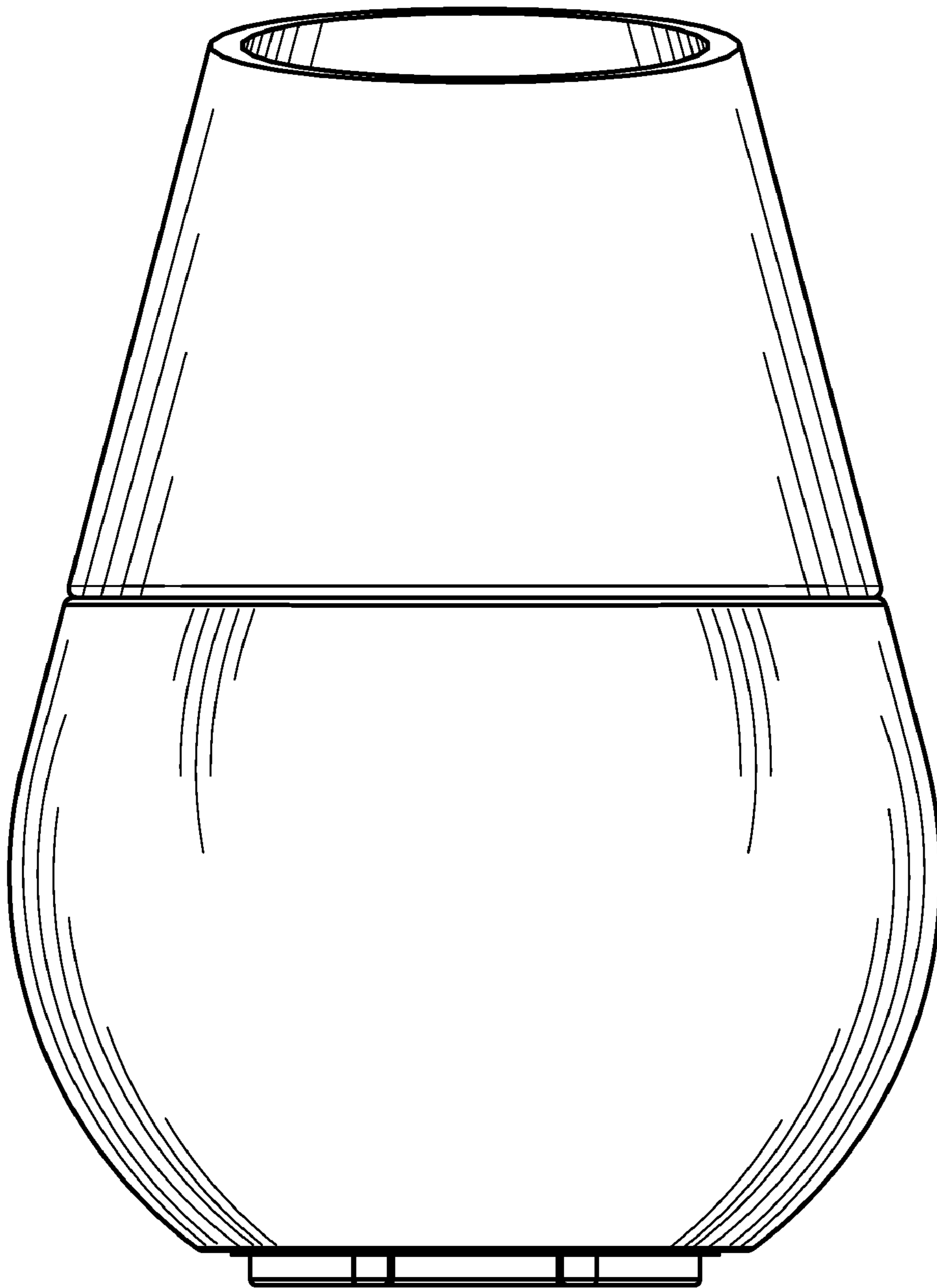

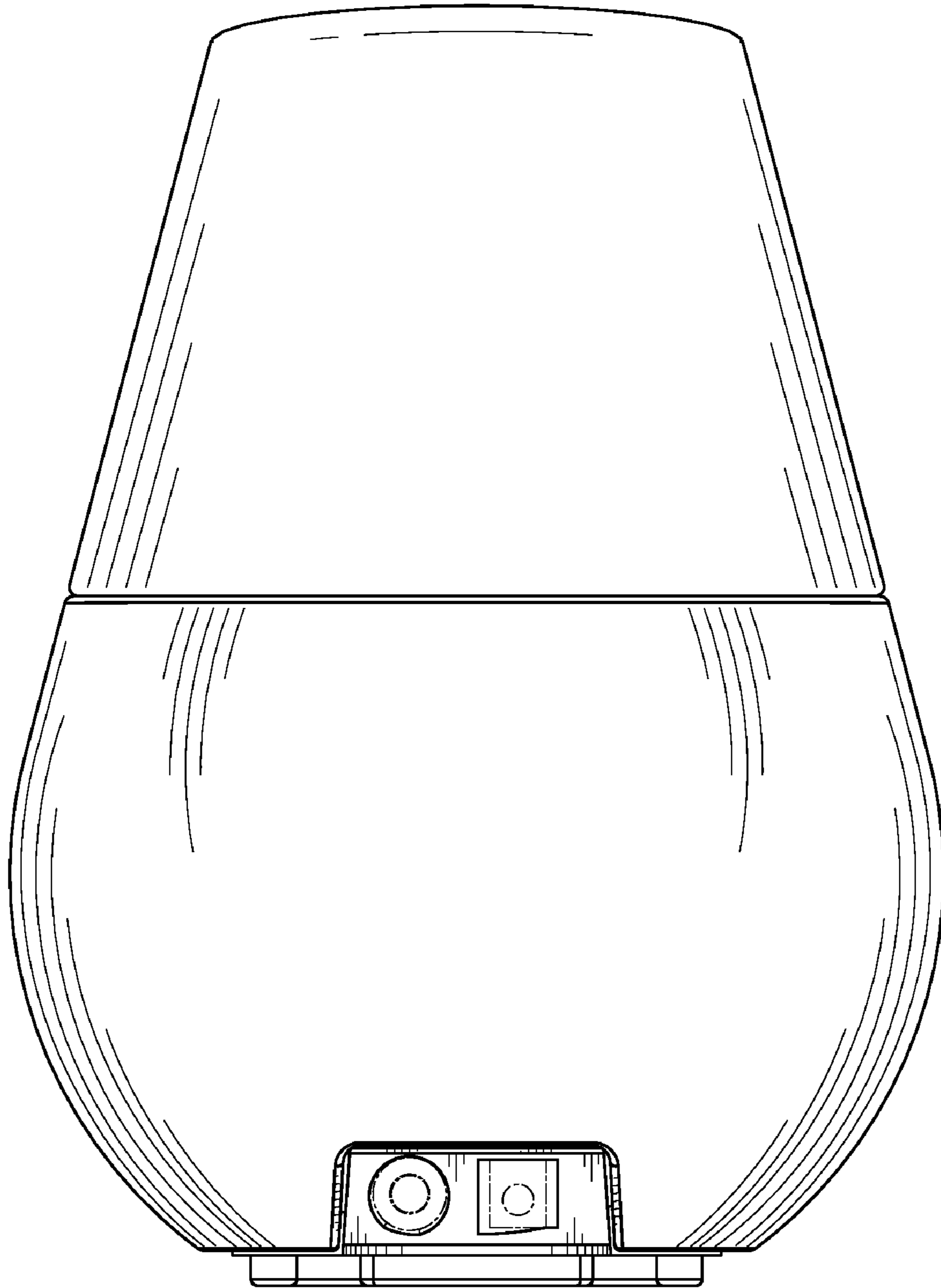

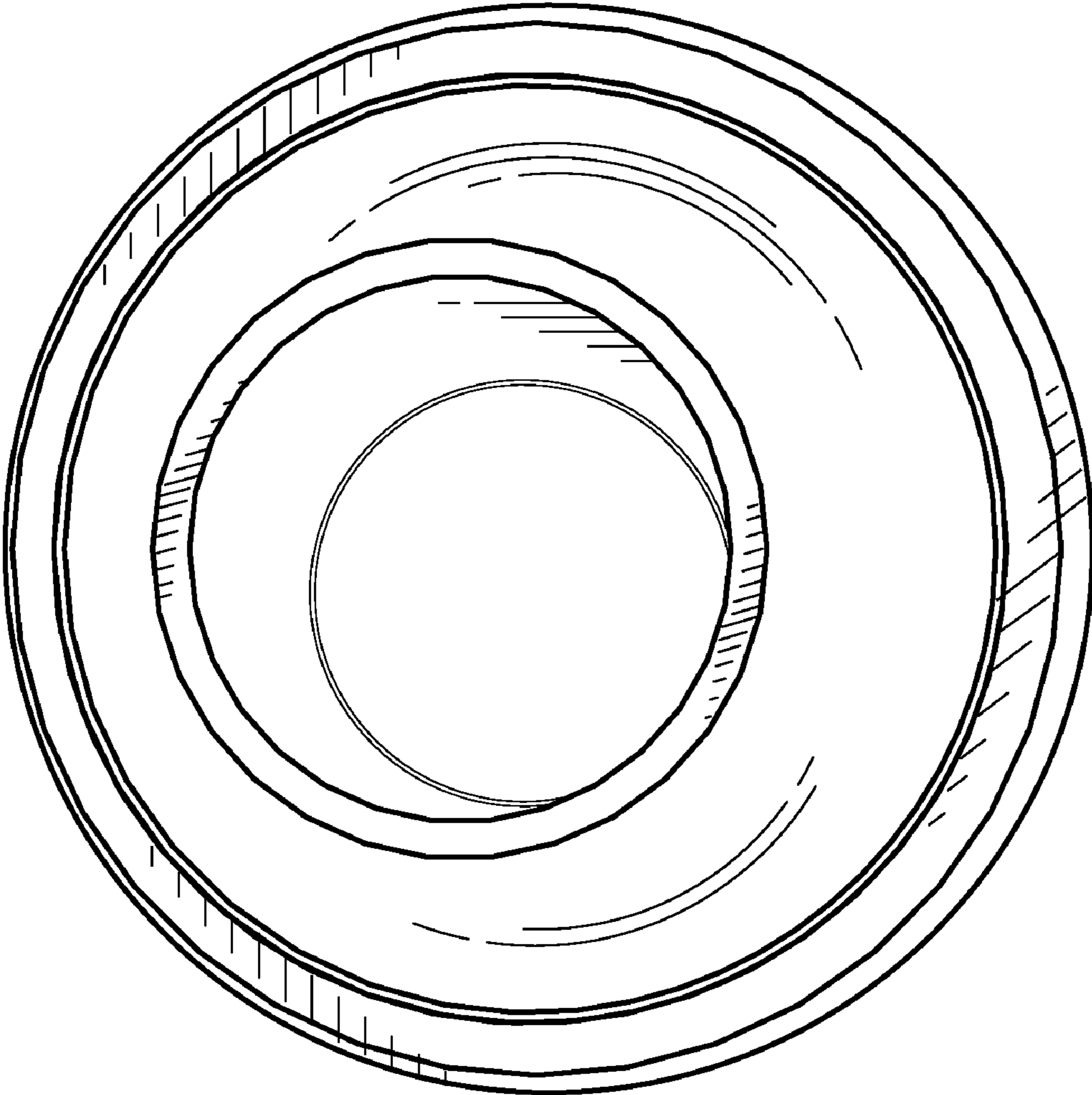

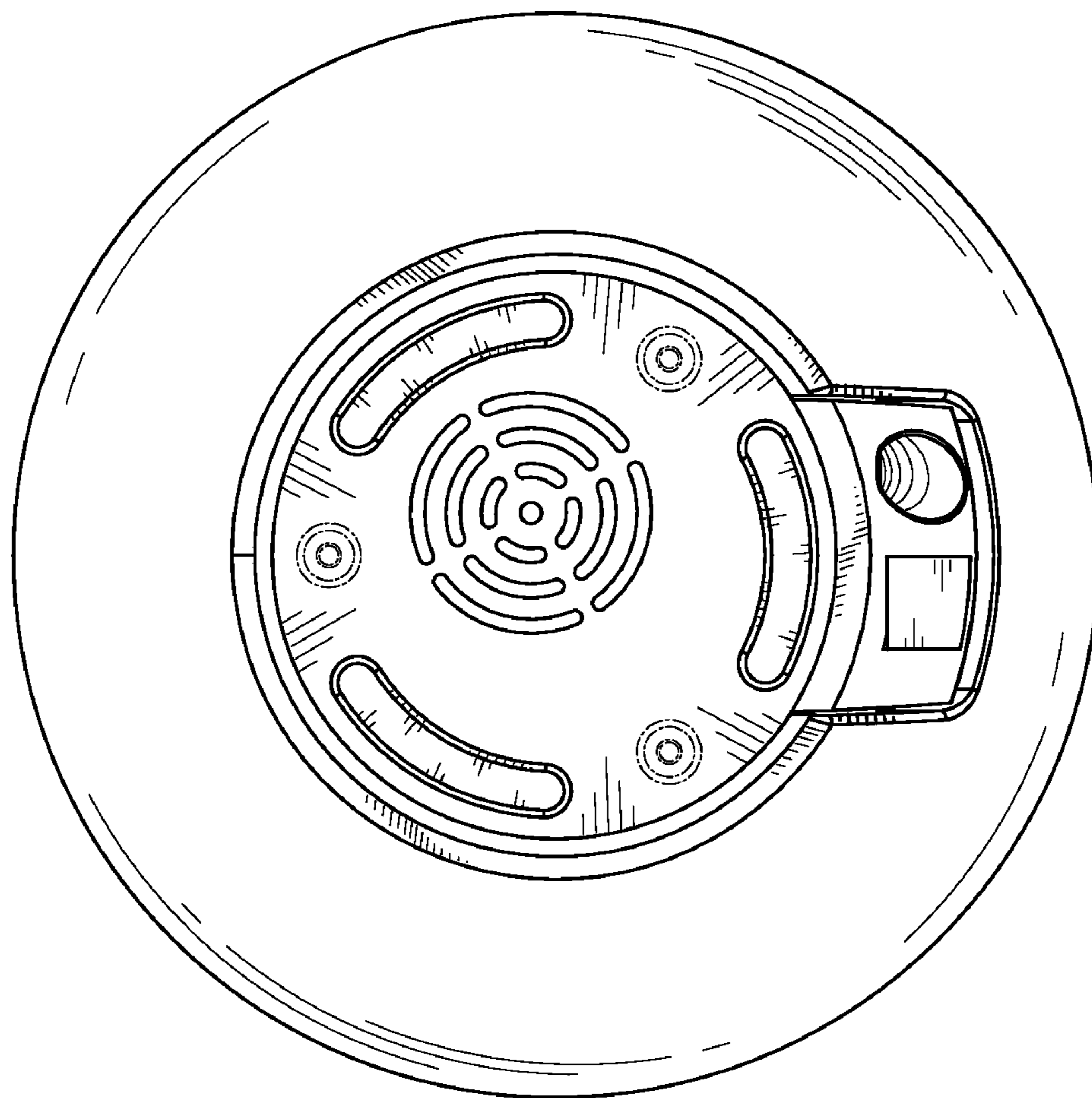
