(57) **CLAIM**

The ornamental design for a heat wrap for thighs, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a heat wrap for thighs, with portions shown in an alternate position;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a top view thereof;

FIG. 5 is a bottom view thereof;

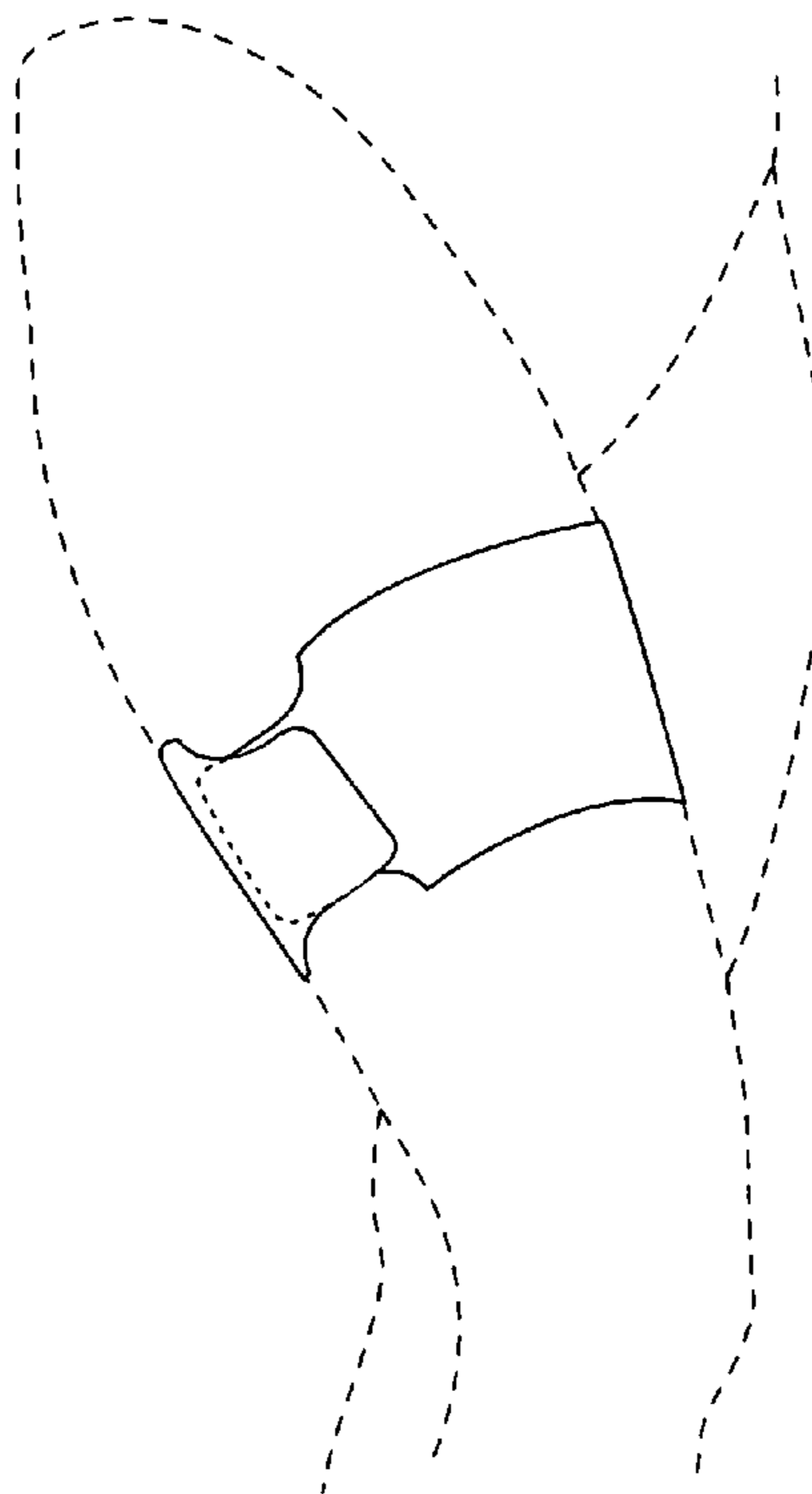
FIG. 6 is a left-hand side view thereof;

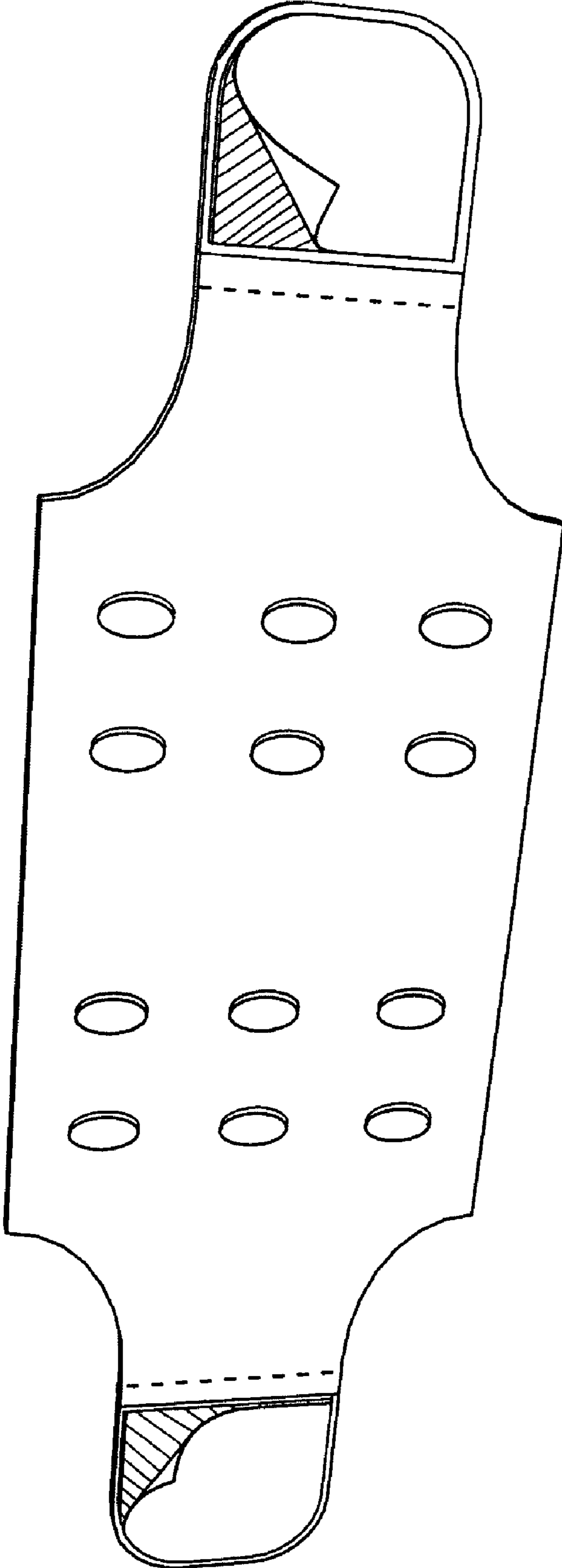

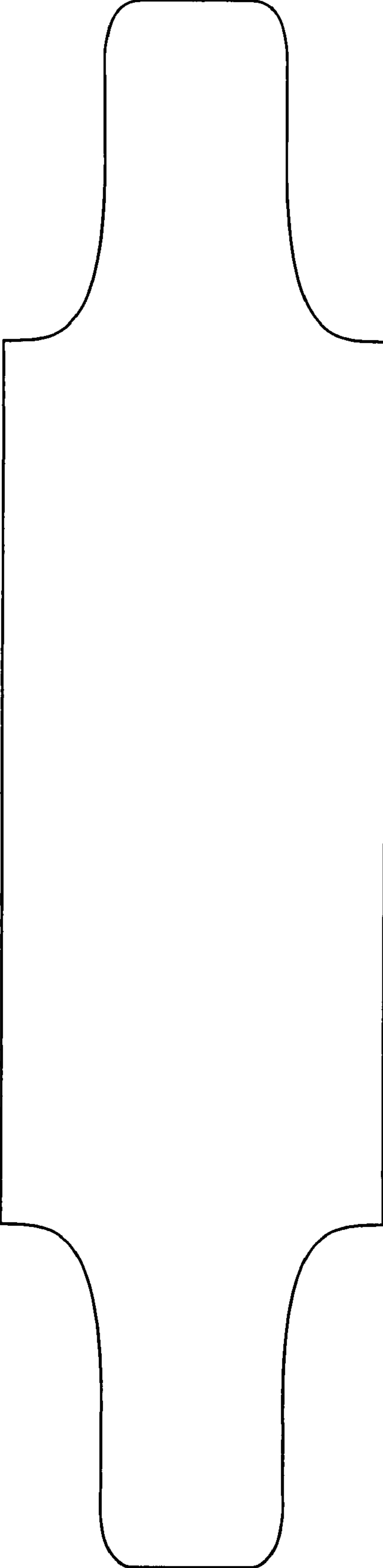

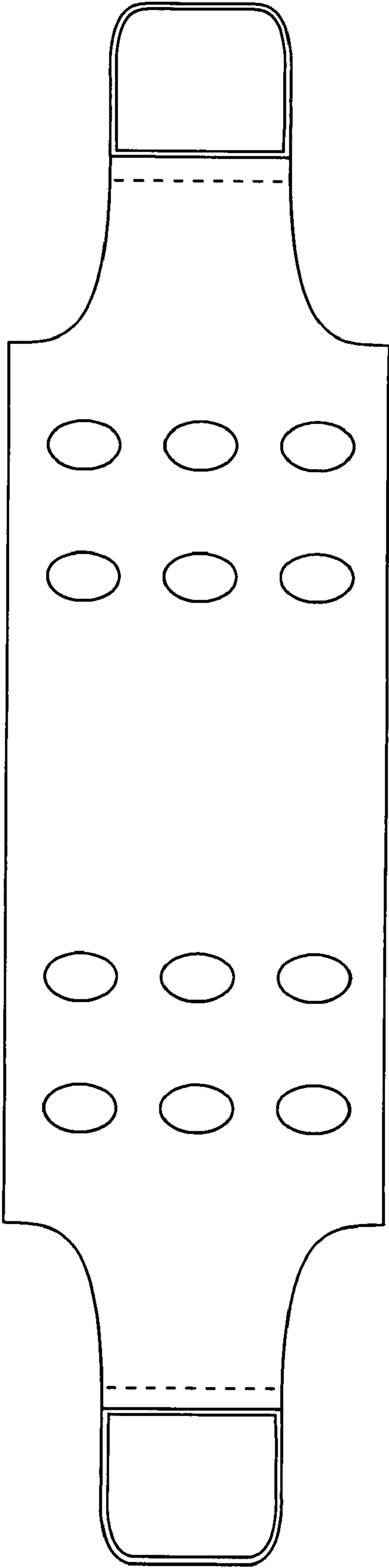

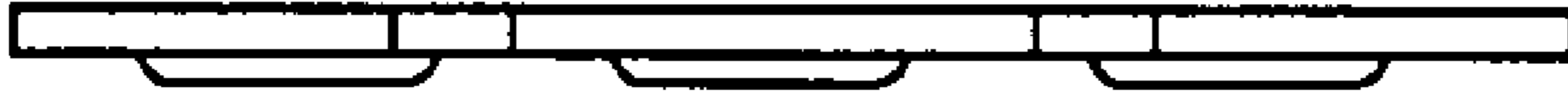

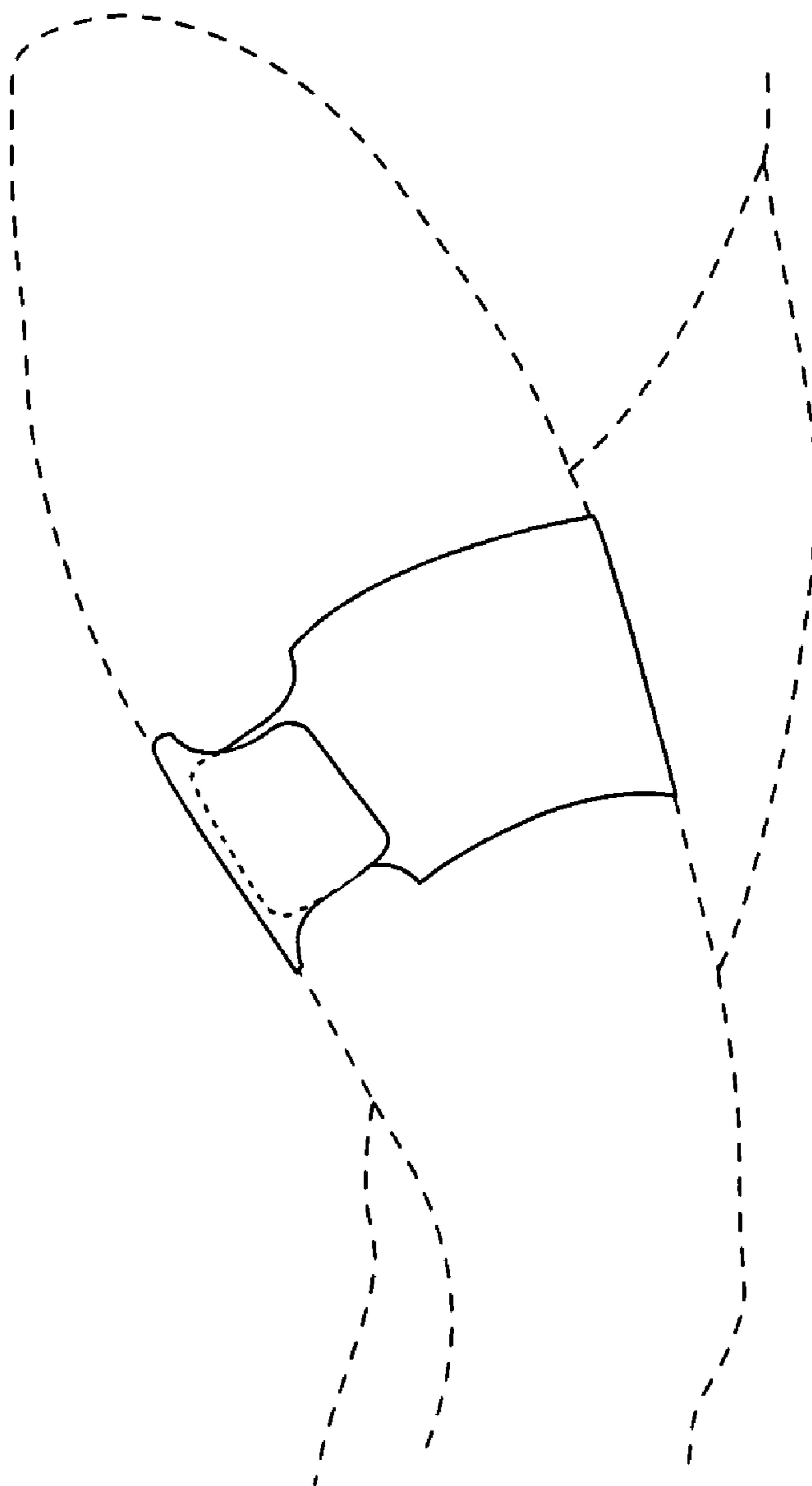
