(57) **CLAIM**

The ornamental design for a martial arts toe protector, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a martial arts toe protector of the claimed design, shown in use with the right foot;

FIG. 2 is a bottom perspective view of FIG. 1;

FIG. 3 is a top view of the martial arts toe protector of the claimed design for use with the right foot;

FIG. 4 is a side view thereof;

FIG. 5 is a side view thereof;

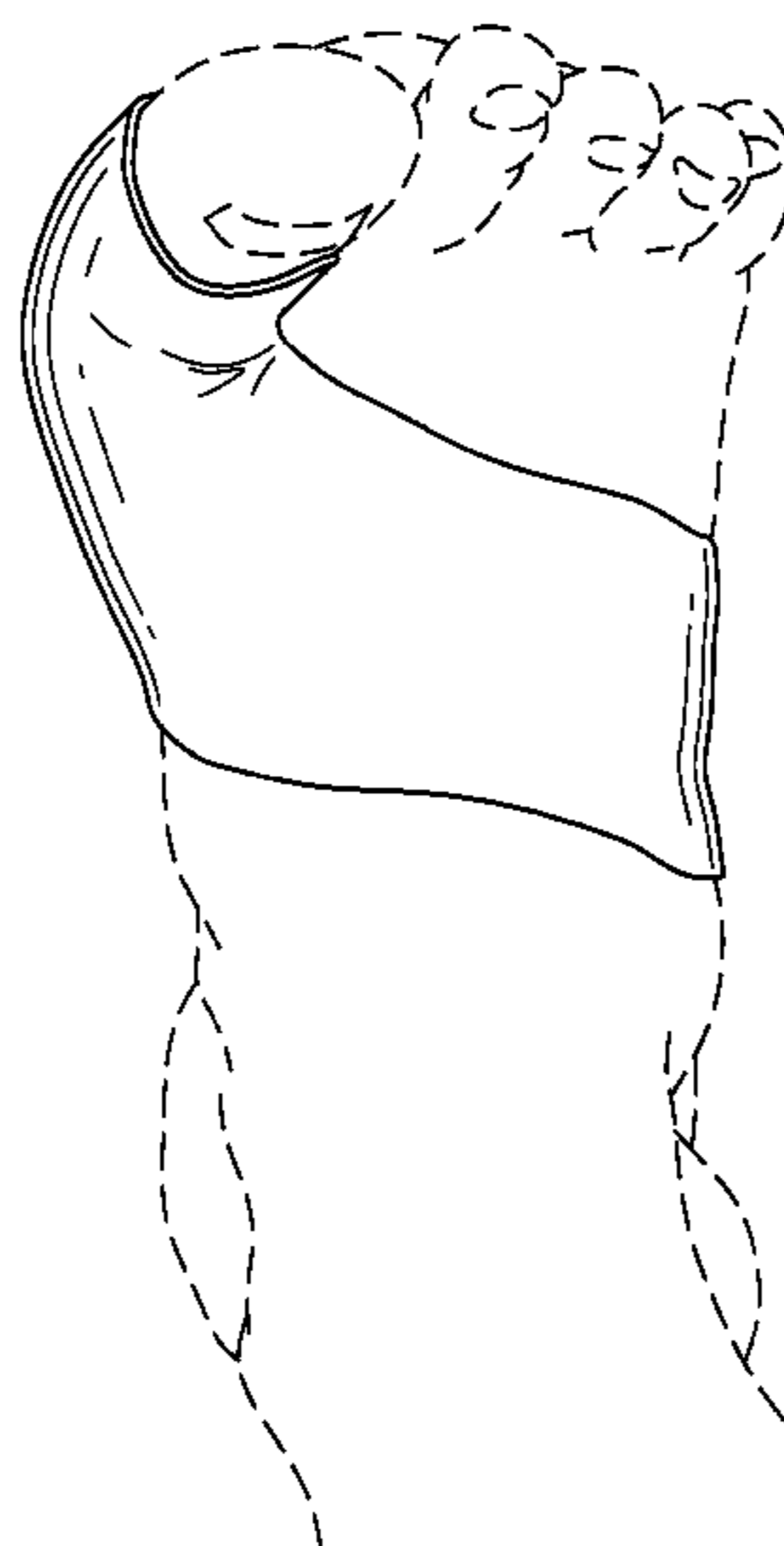
FIG. 6 is a front view thereof;

FIG. 7 is a rear view thereof; and,

FIG. 8 is a bottom view thereof.

The elements shown by dashed lines are for illustrative purposes only and form no part of the claimed design. The martial arts toe protector shown in FIGS. 1 through 8 is a right foot martial arts toe protector. The left foot martial arts toe protector is a mirror image of the right foot martial arts toe protector.

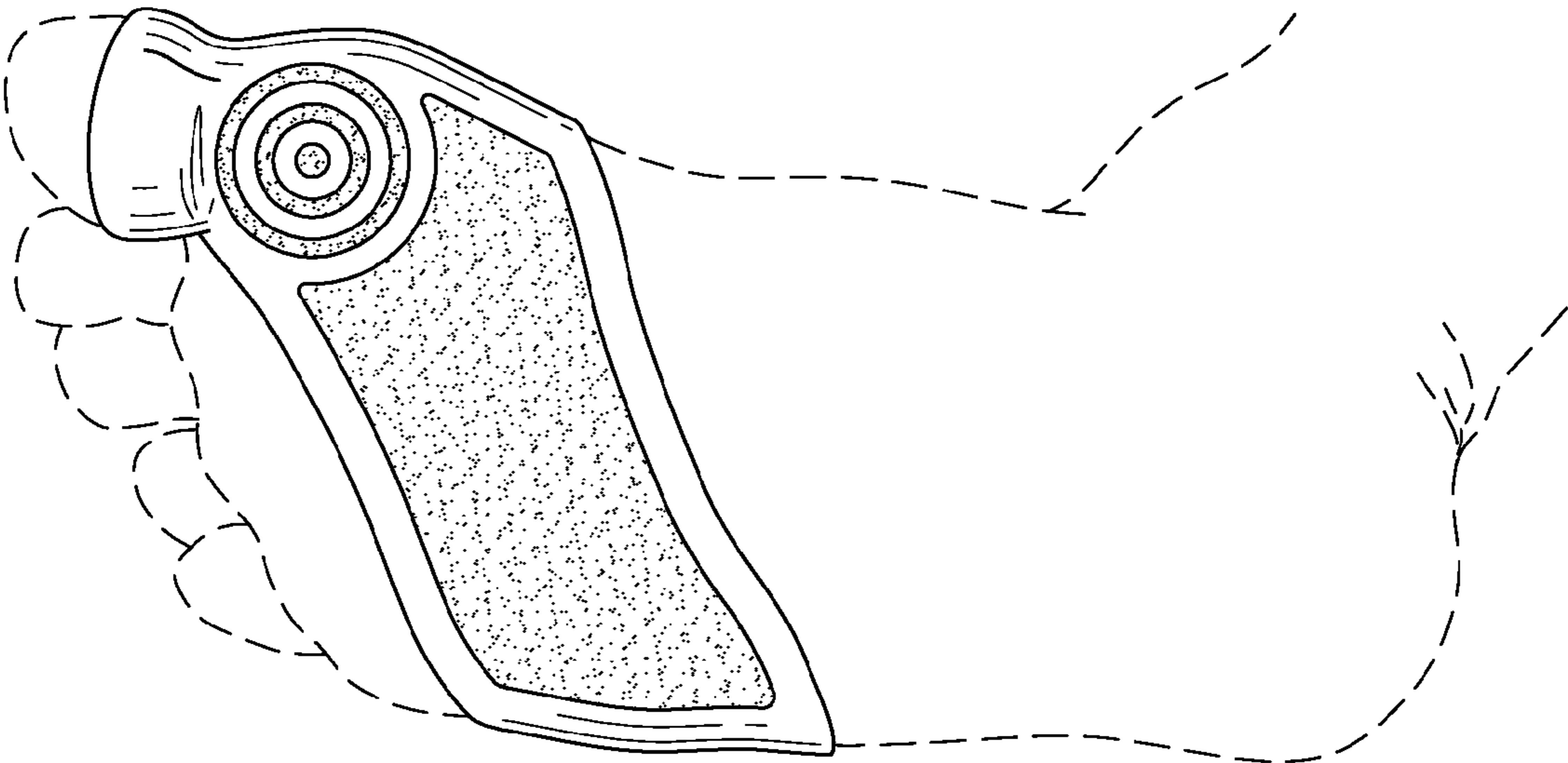

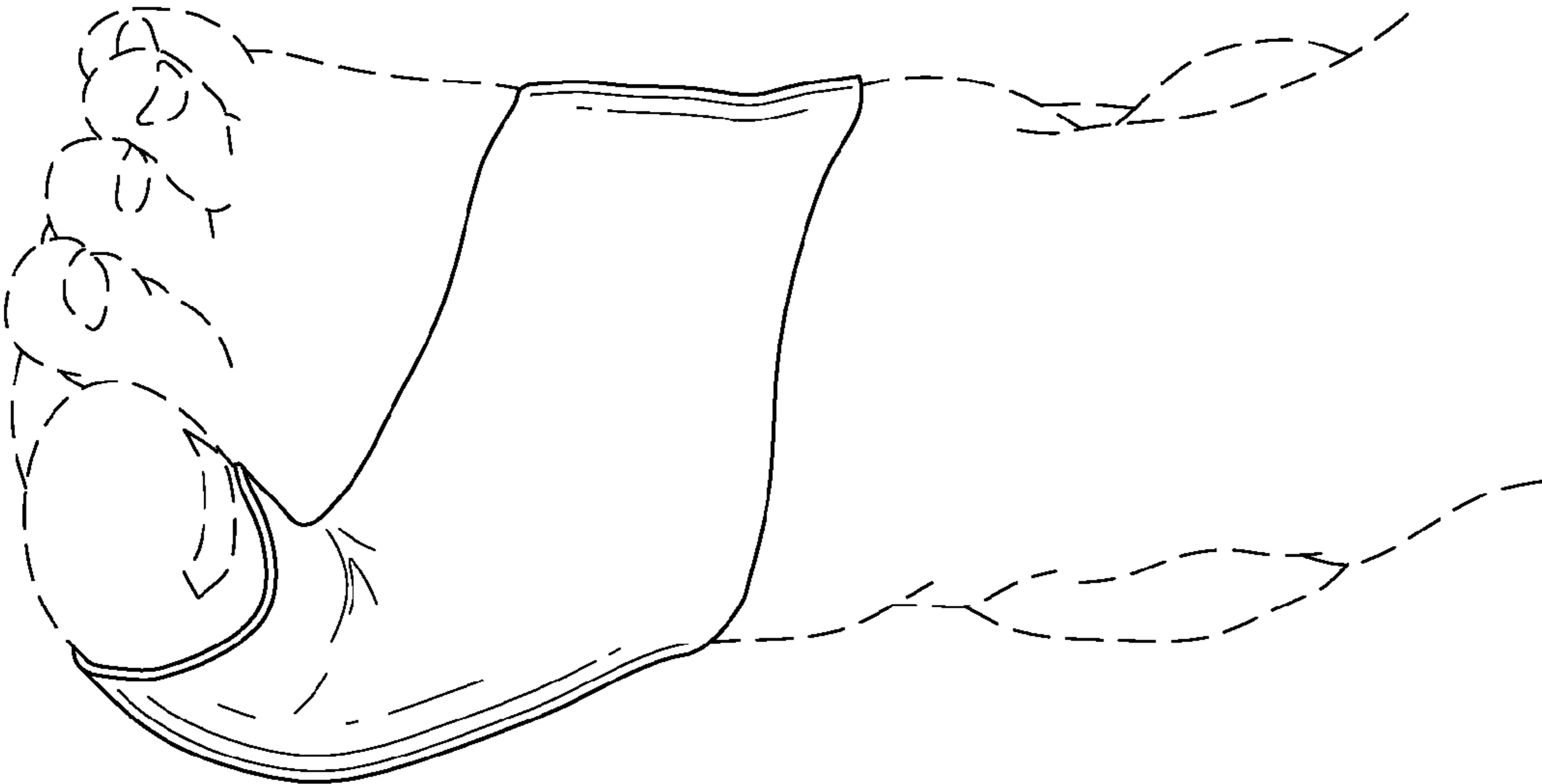

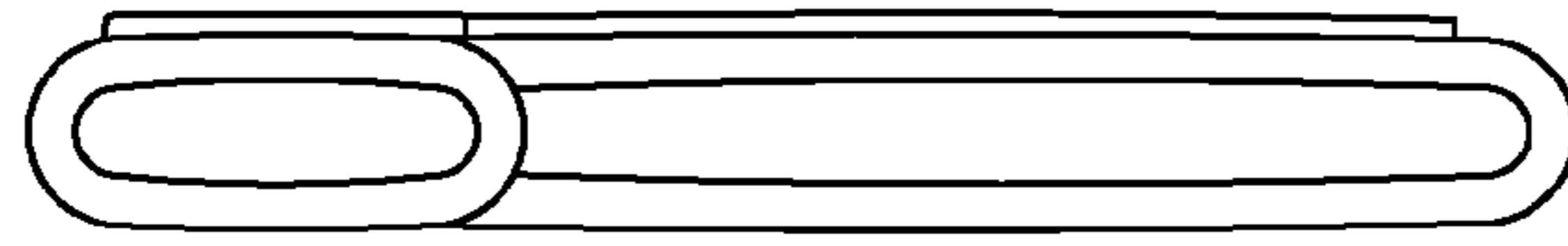

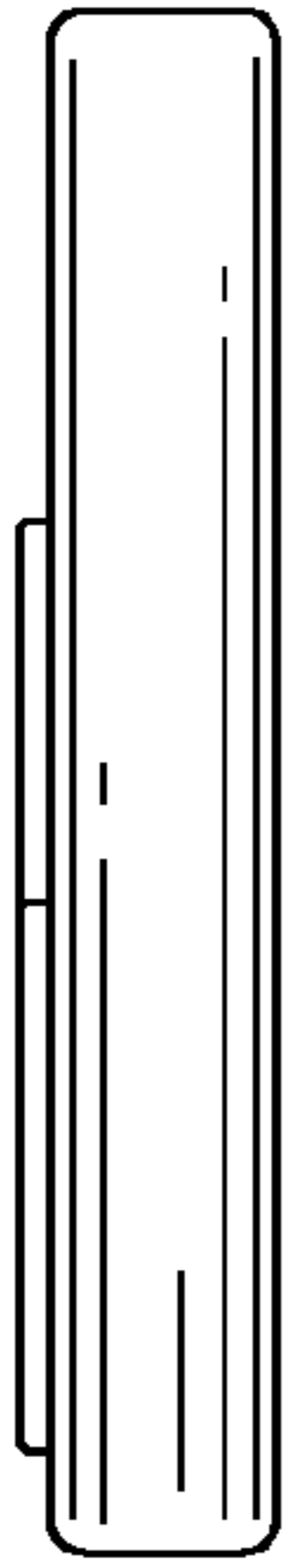

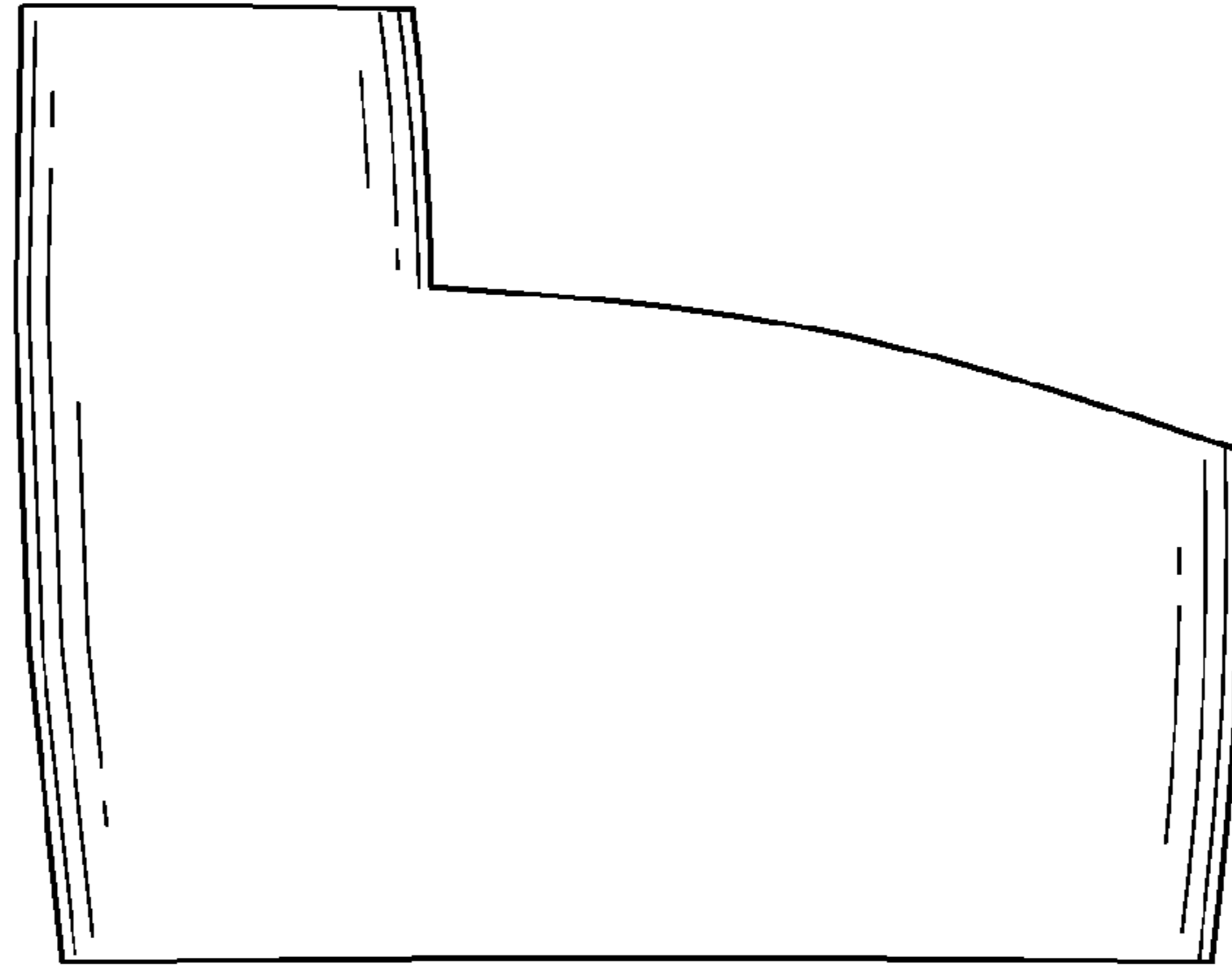

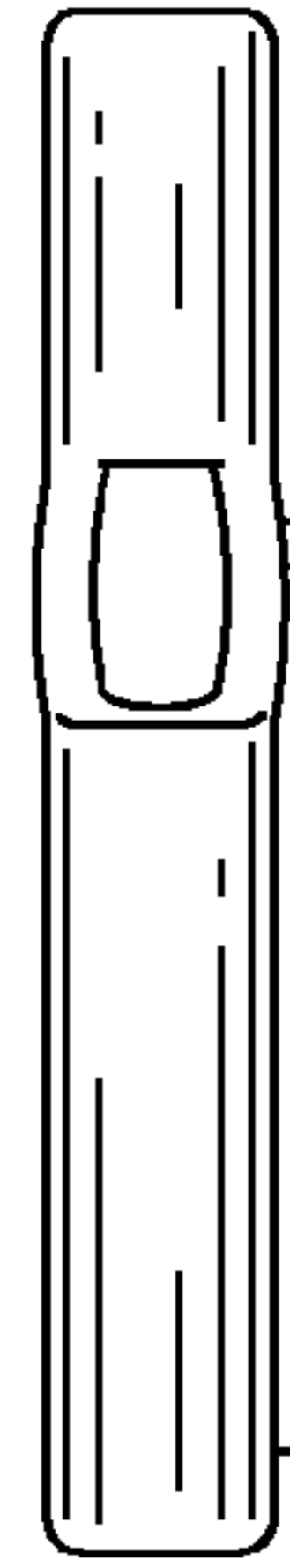

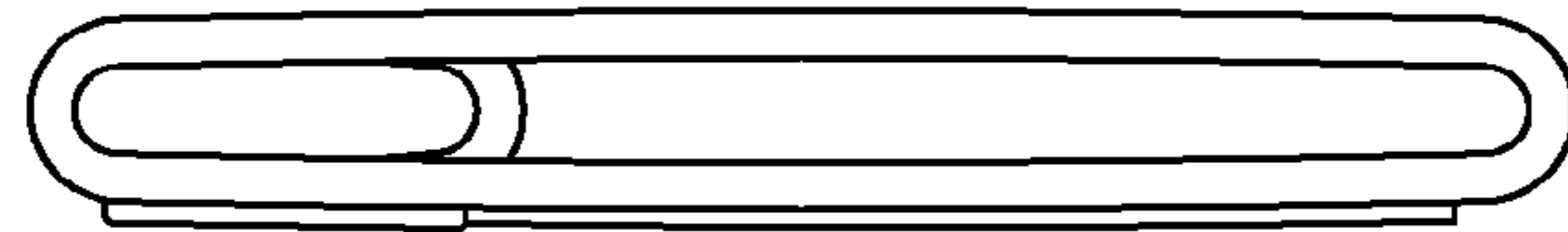

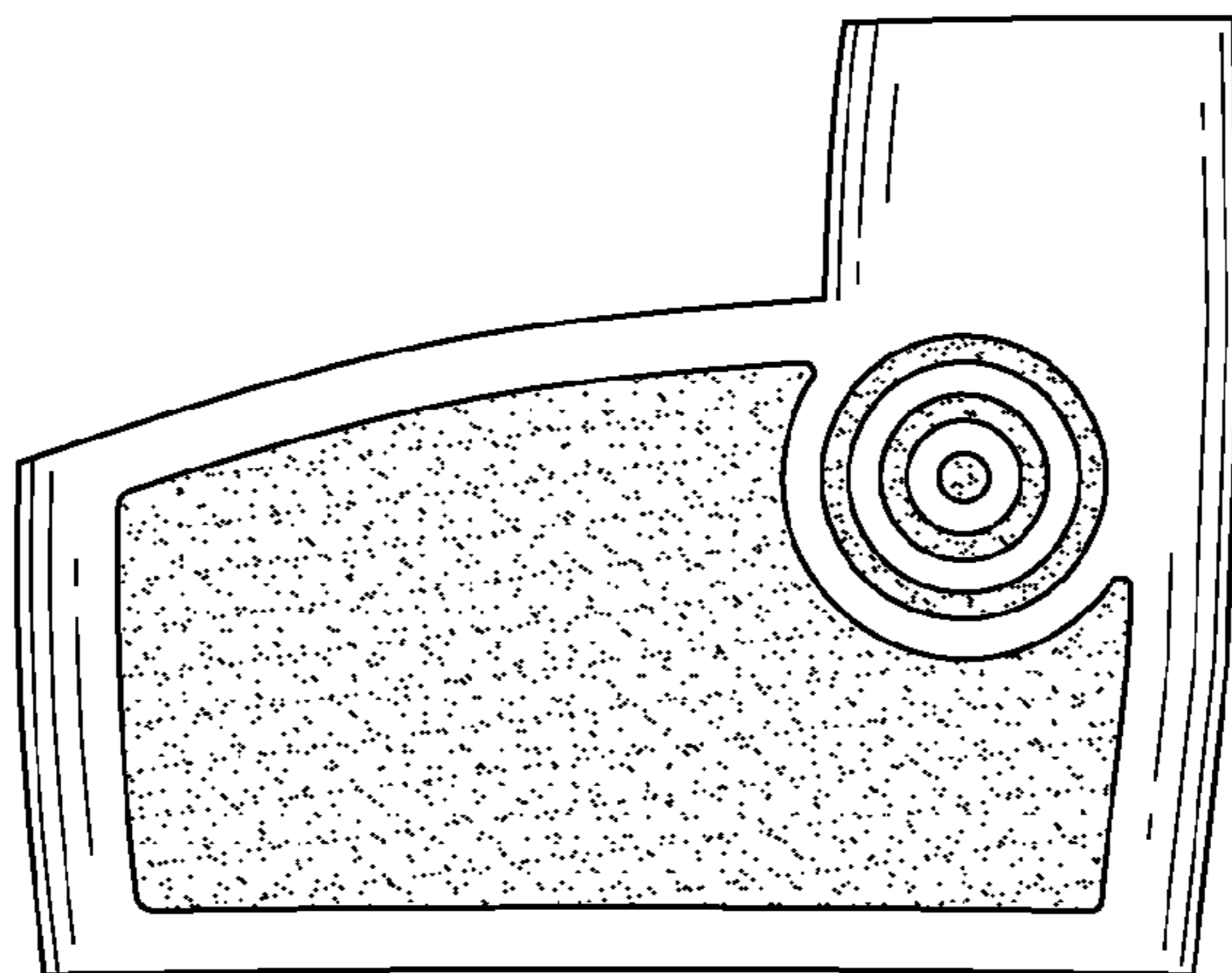
