FIG. 7 is a back view thereof;

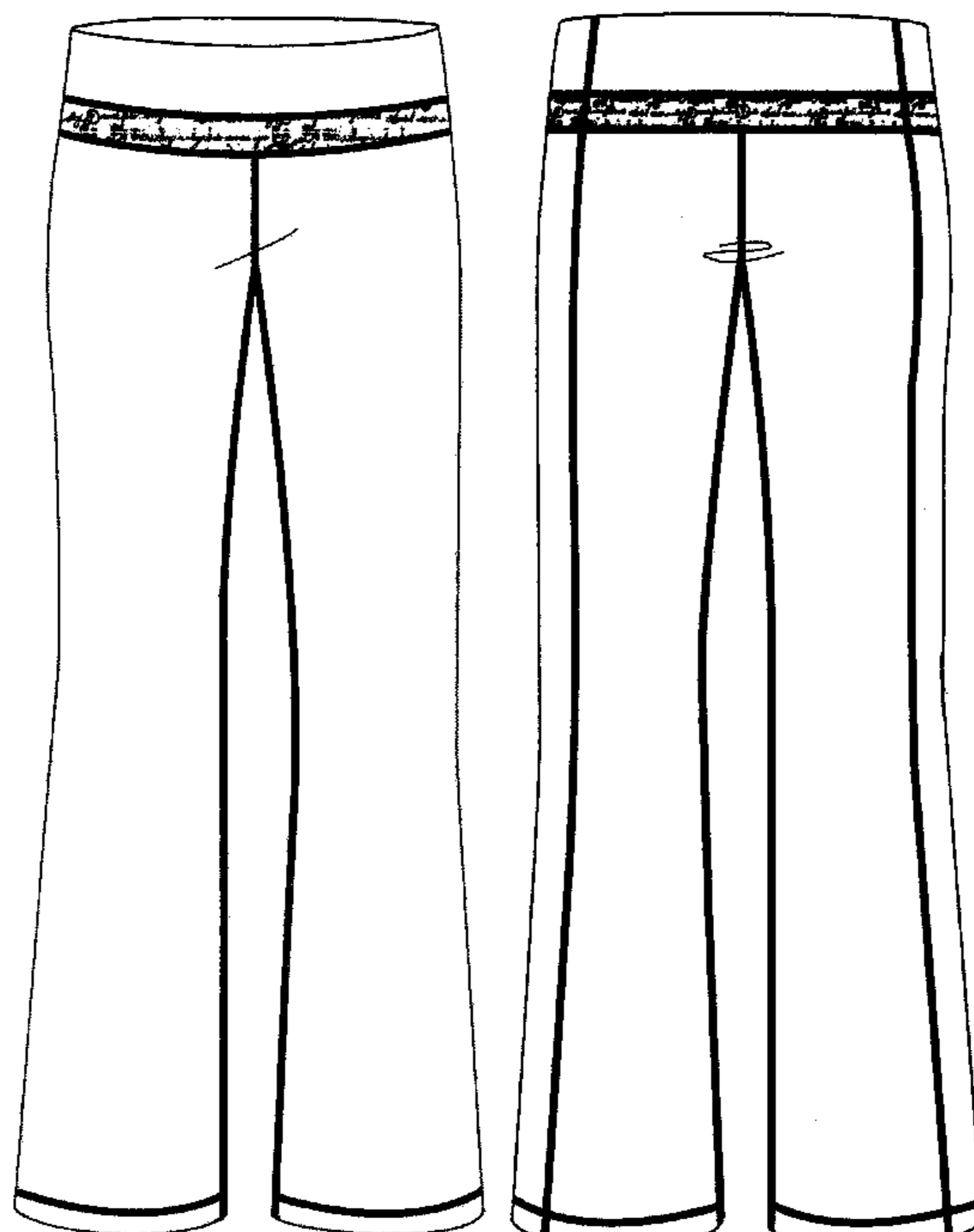
FIG. 8 is a right side view thereof;

FIG. 9 is a left side view thereof; and,

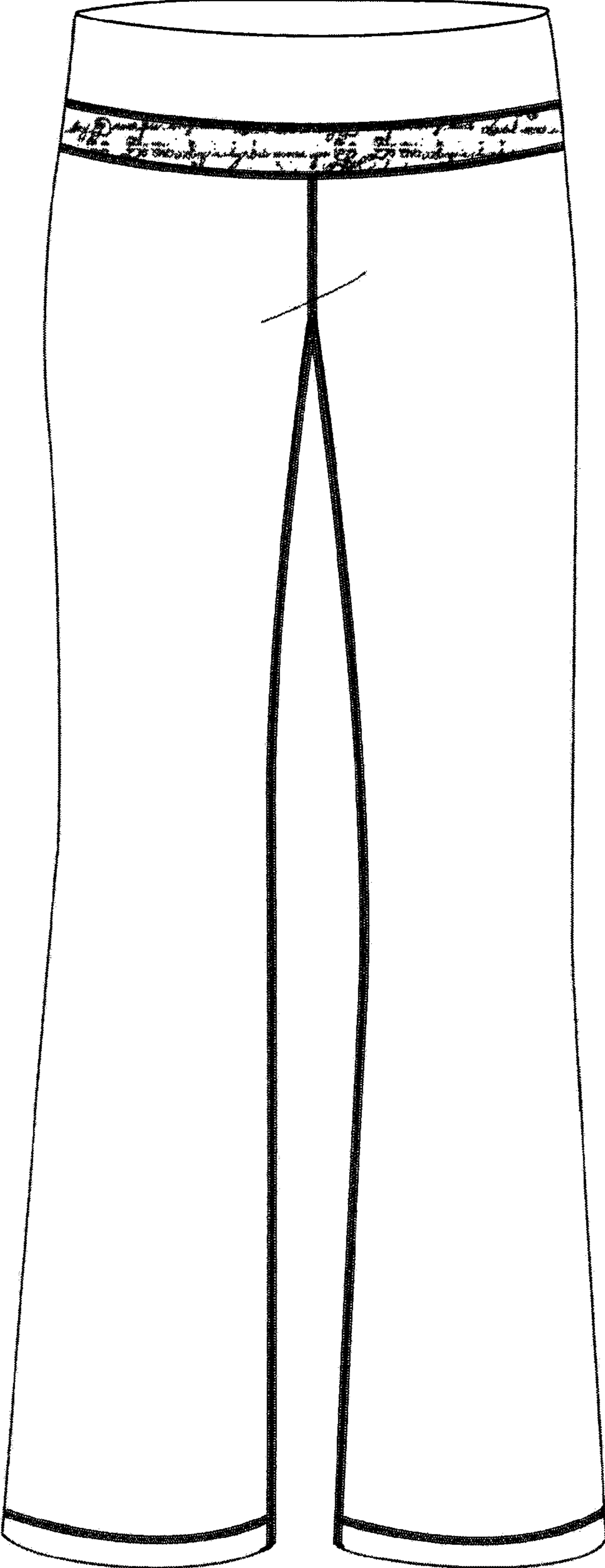
FIG. 10 is a front view thereof shown in use.

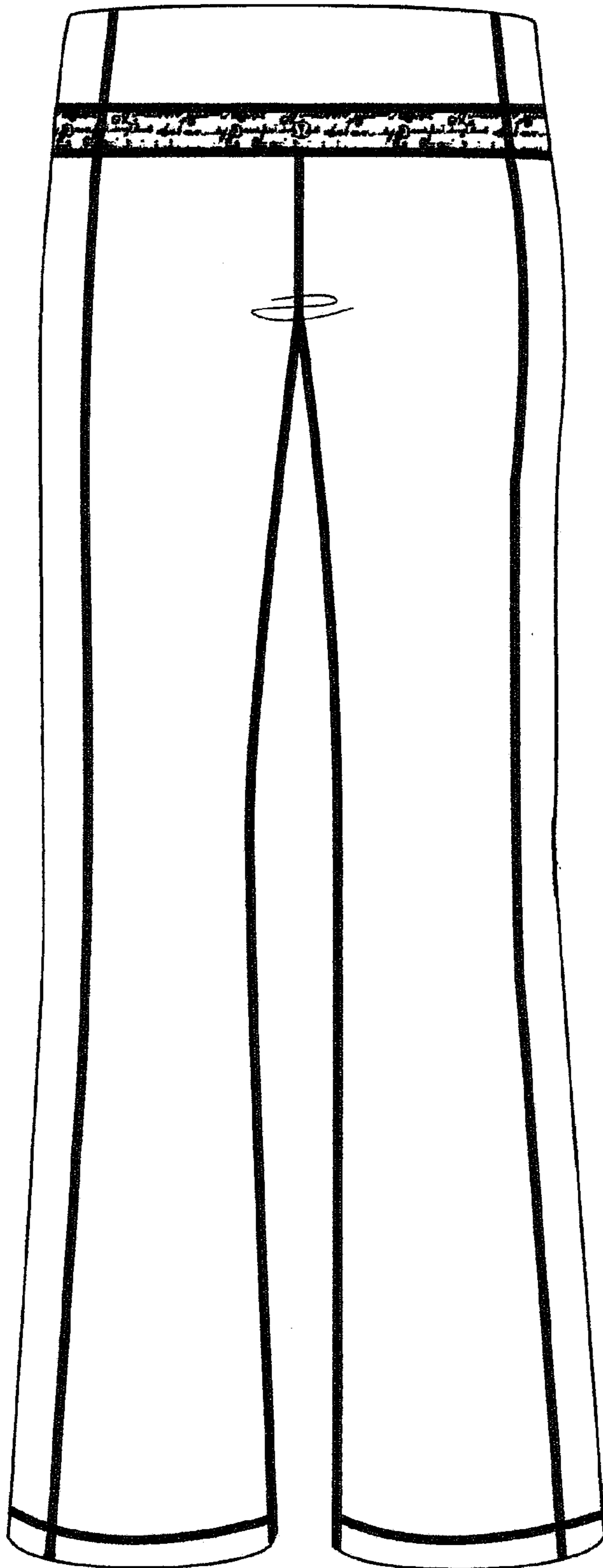

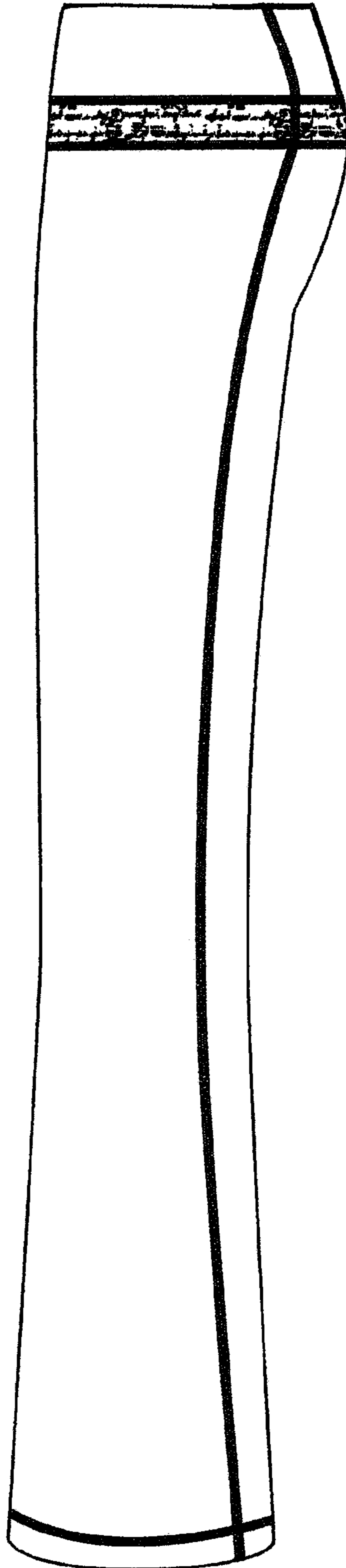

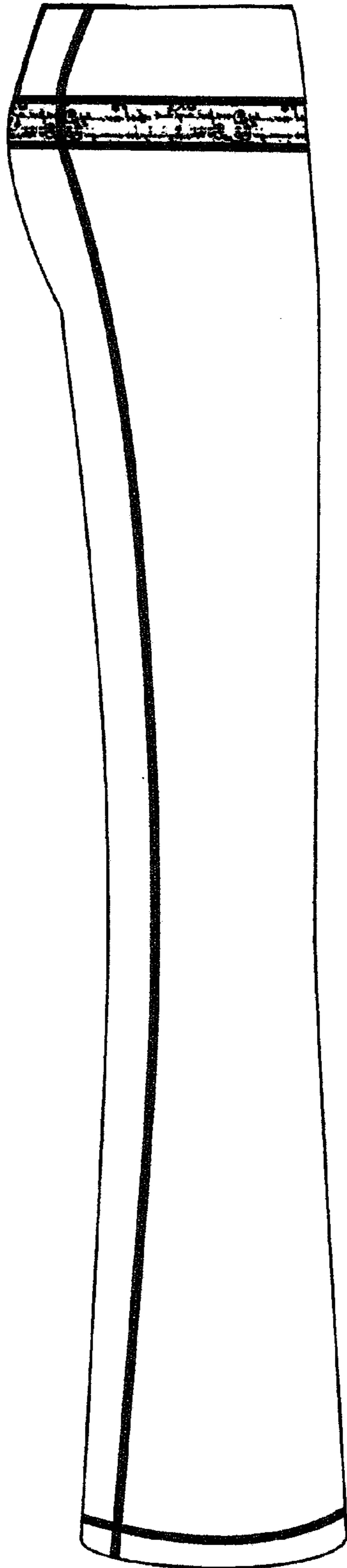

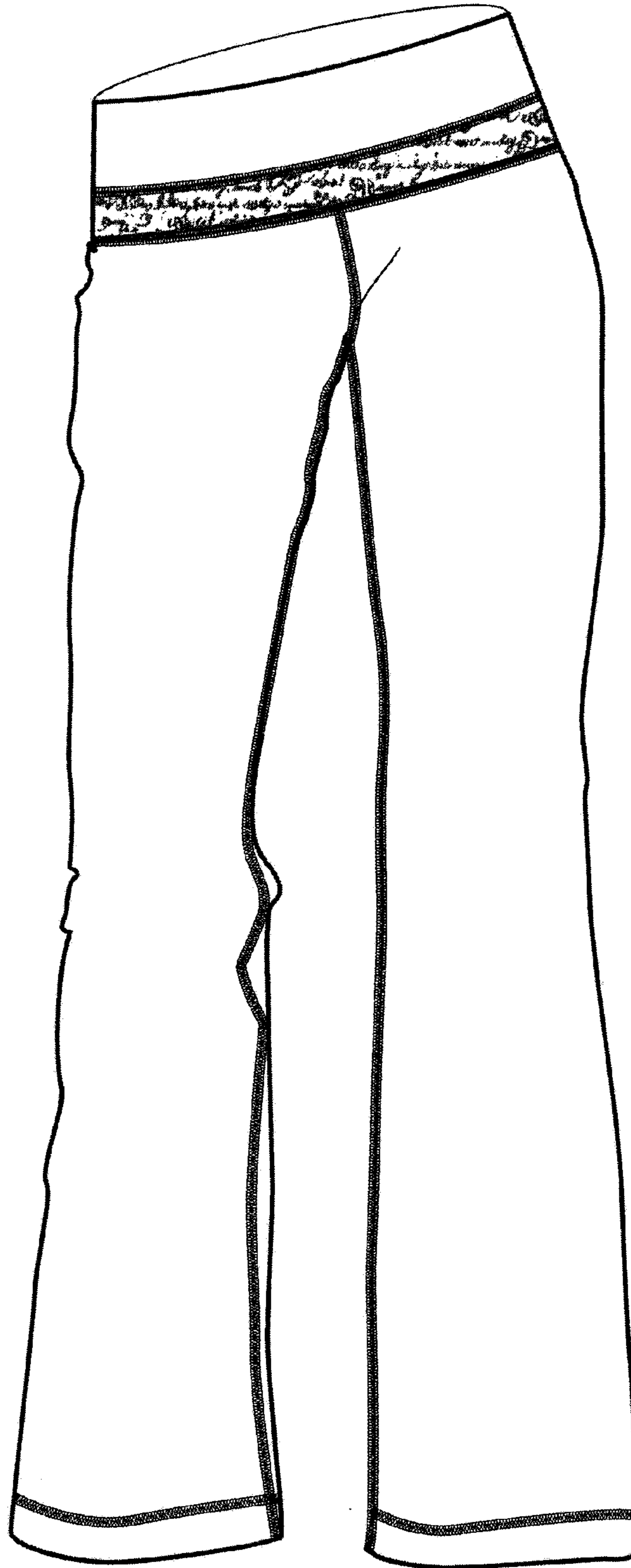

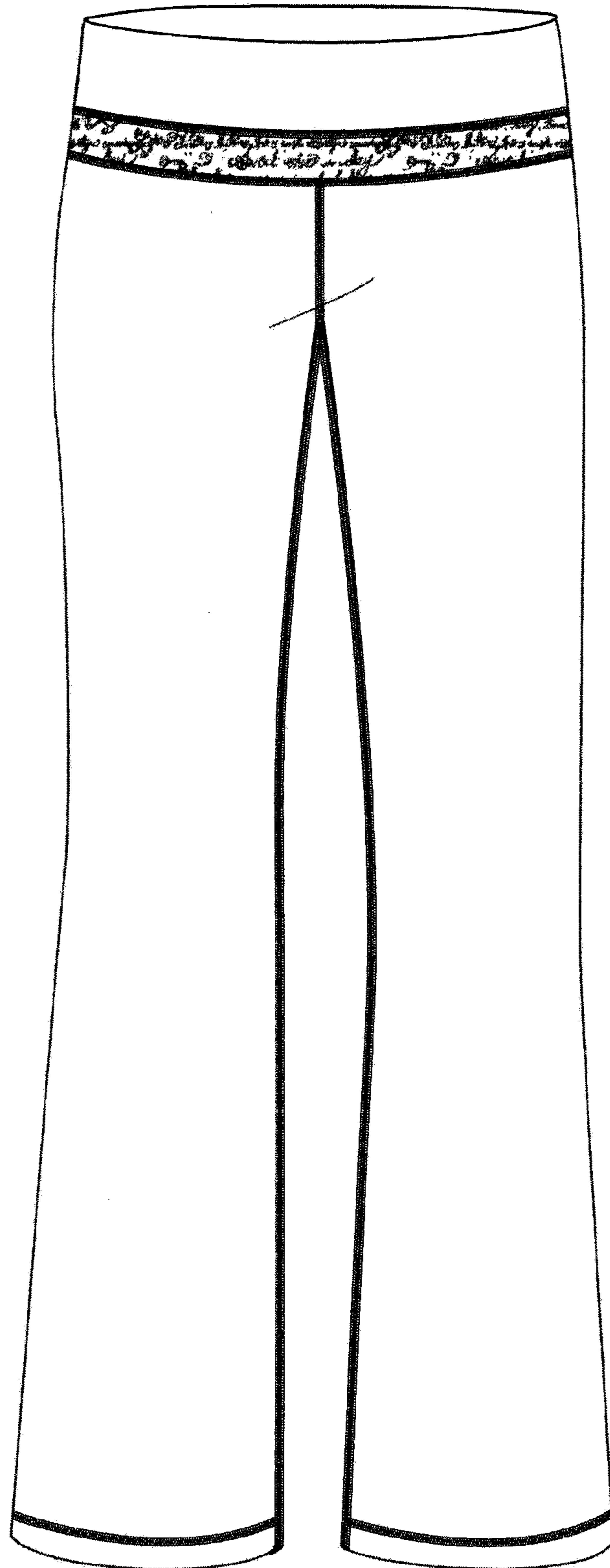

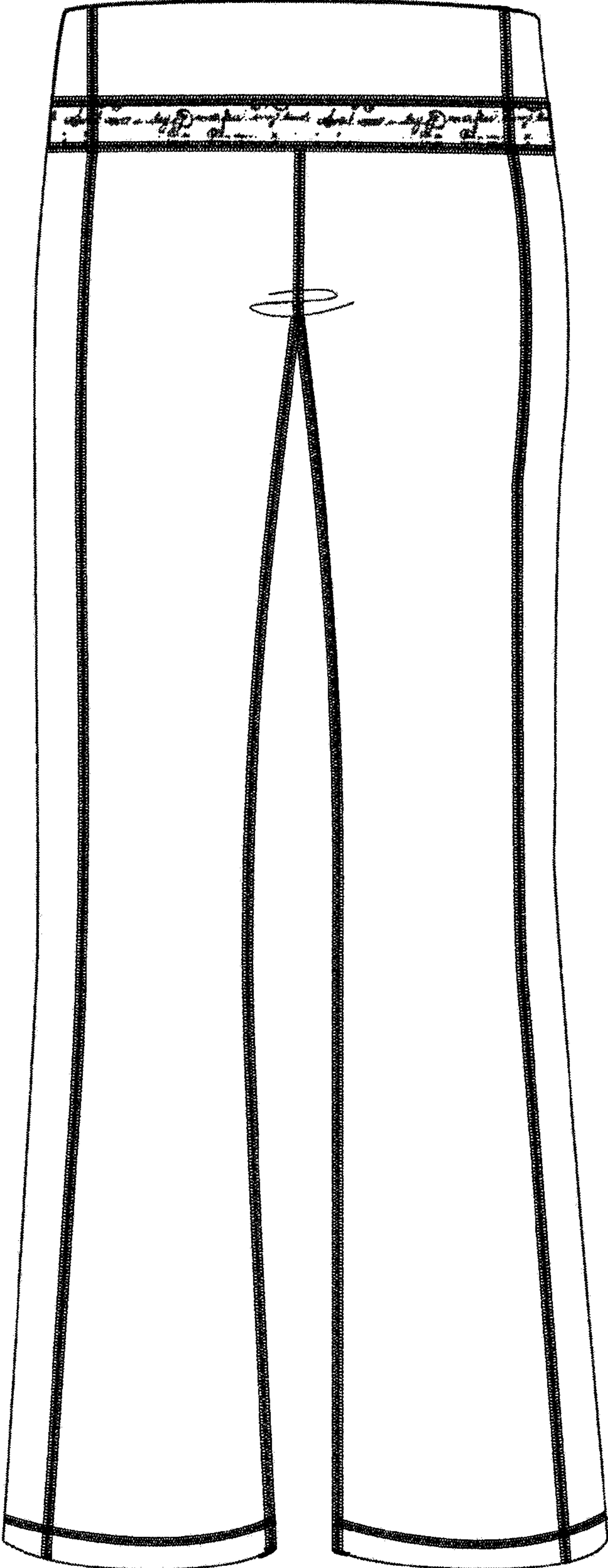

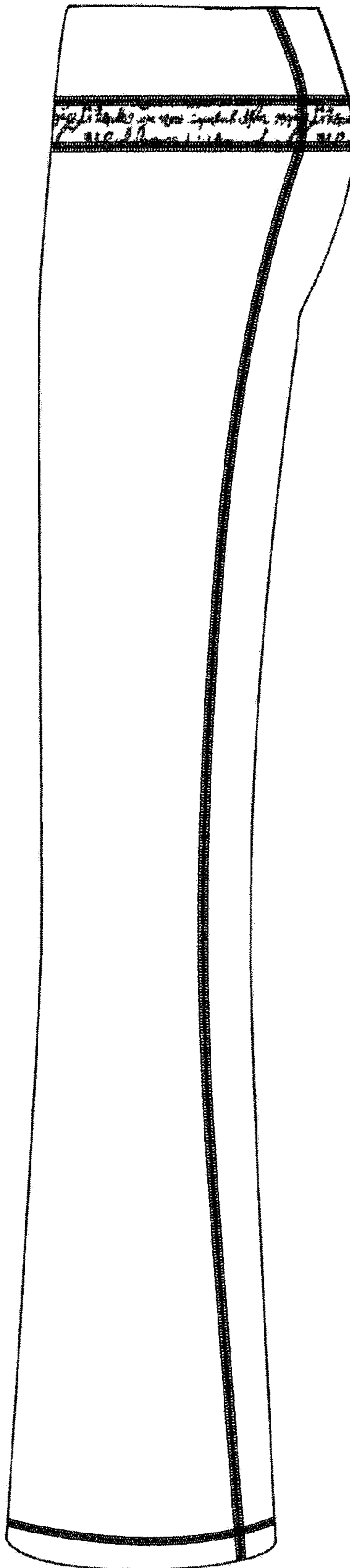

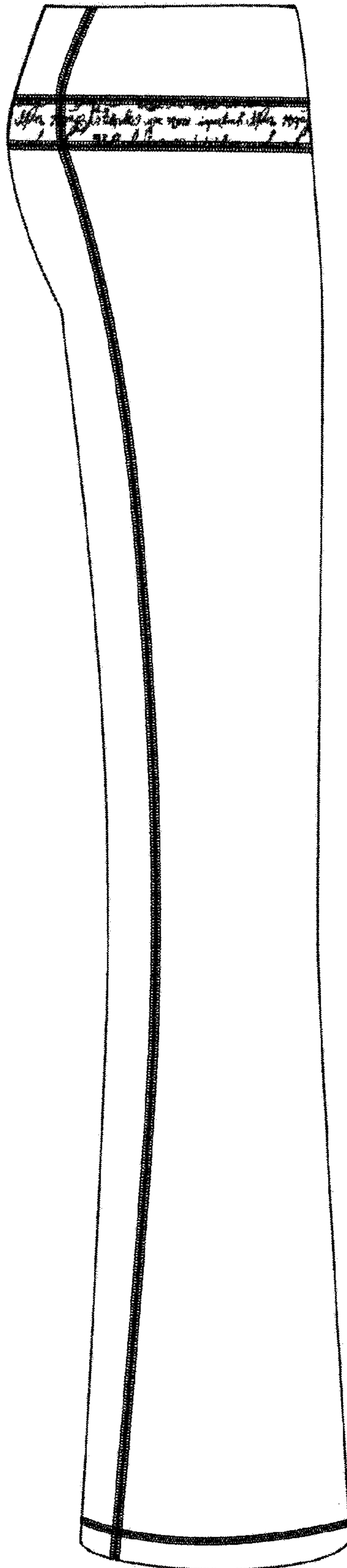
