FIG. 3 is a front perspective view with the top drawer open;

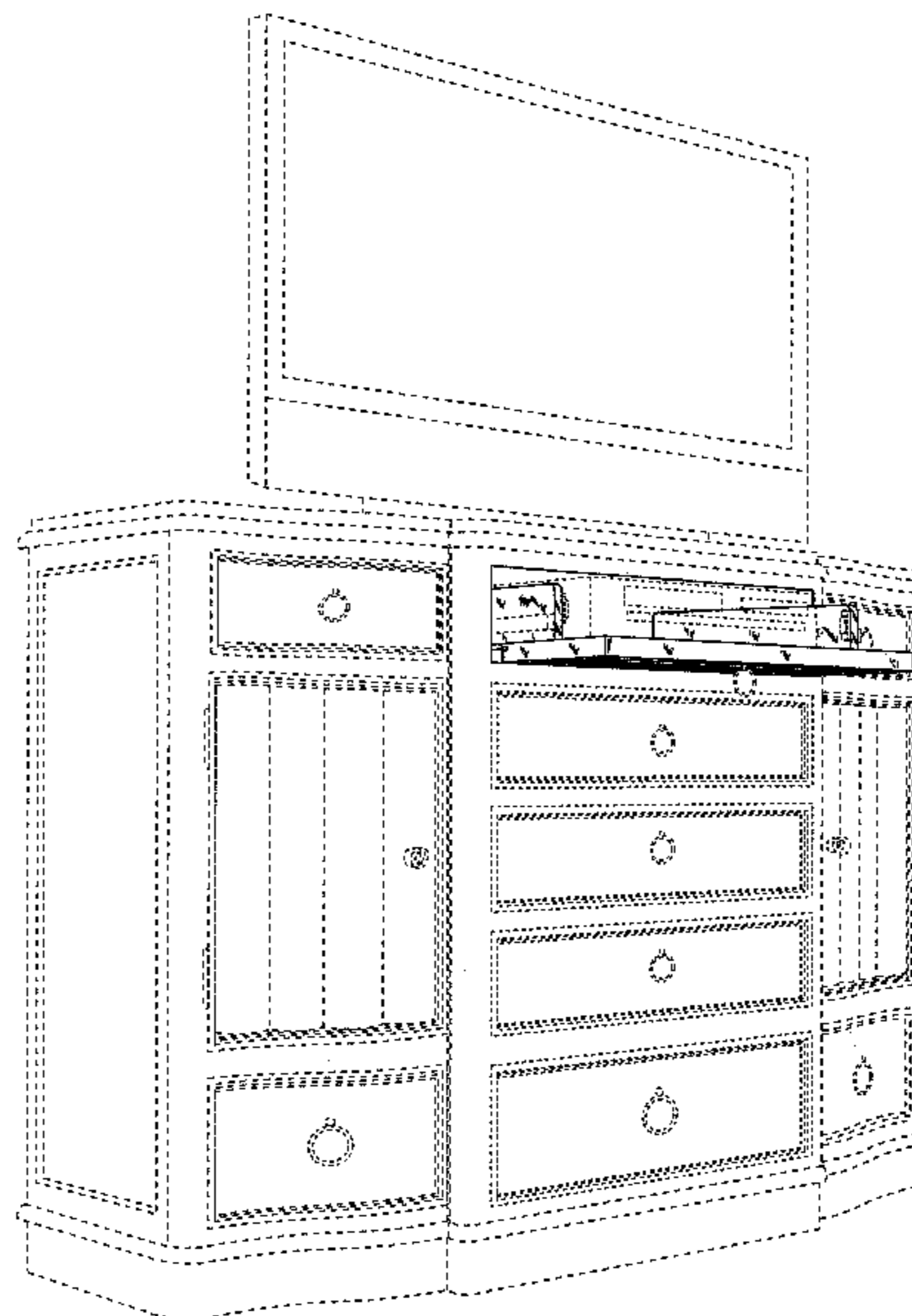
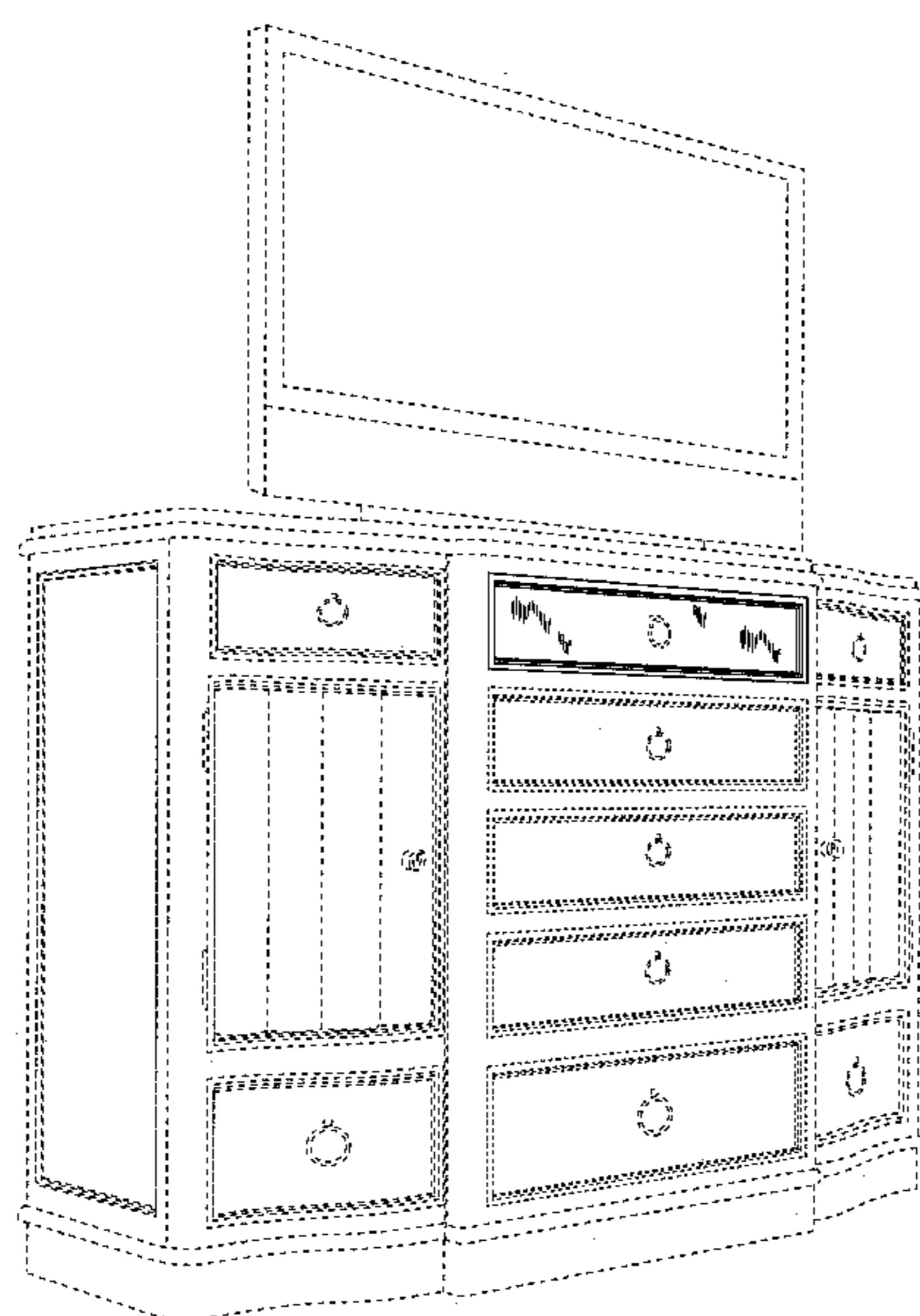
FIG. 4 is a front view with the top drawer closed;

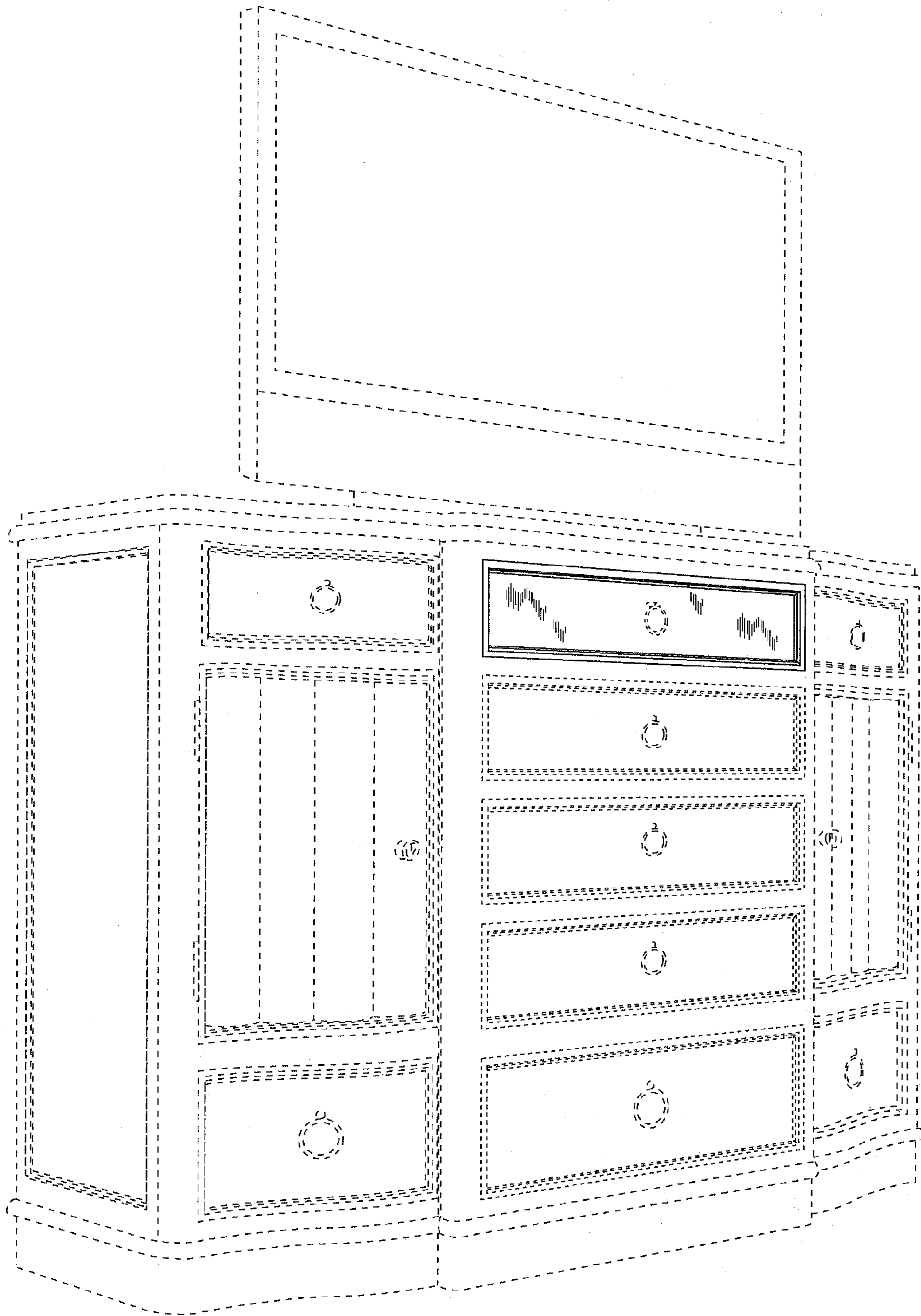

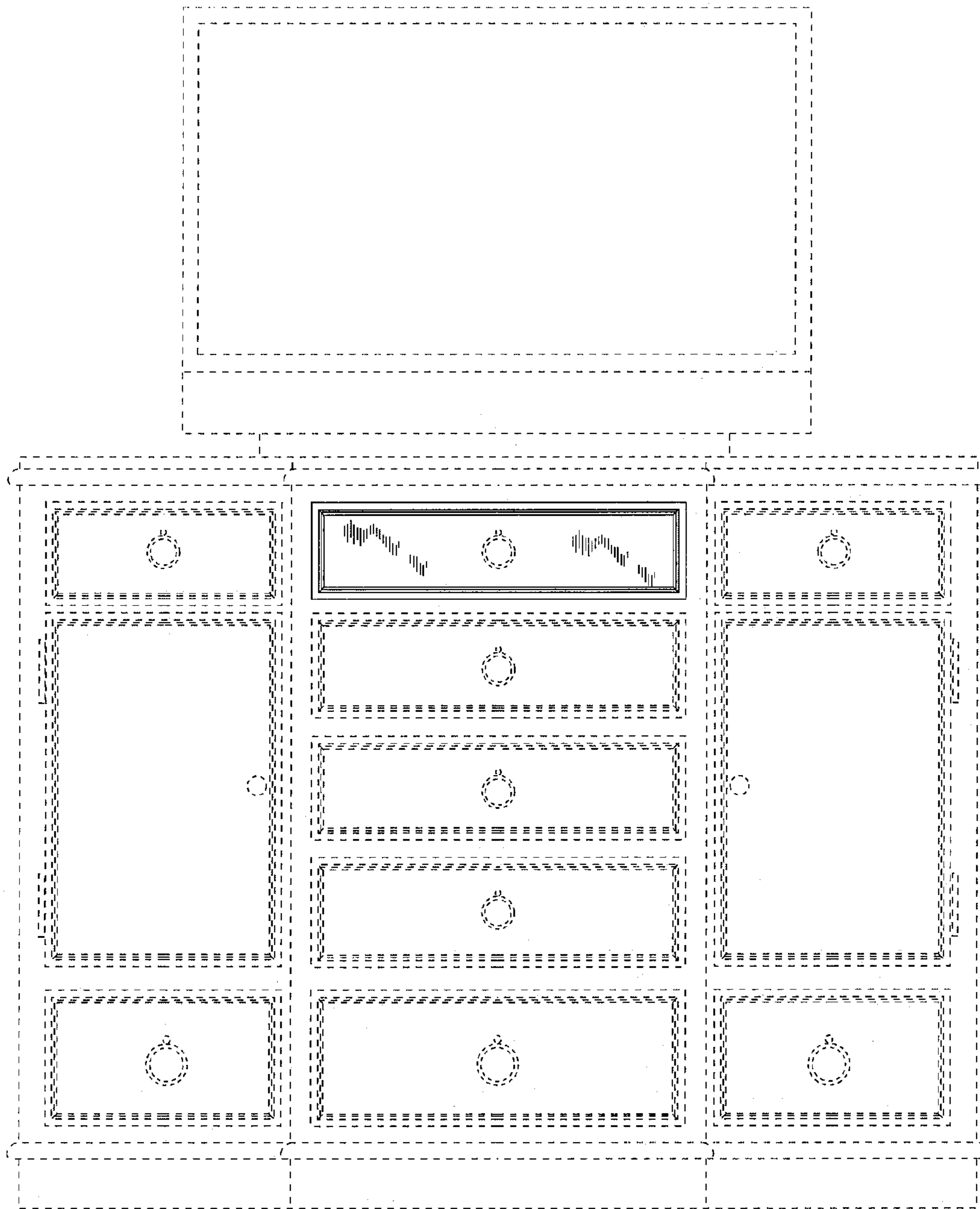

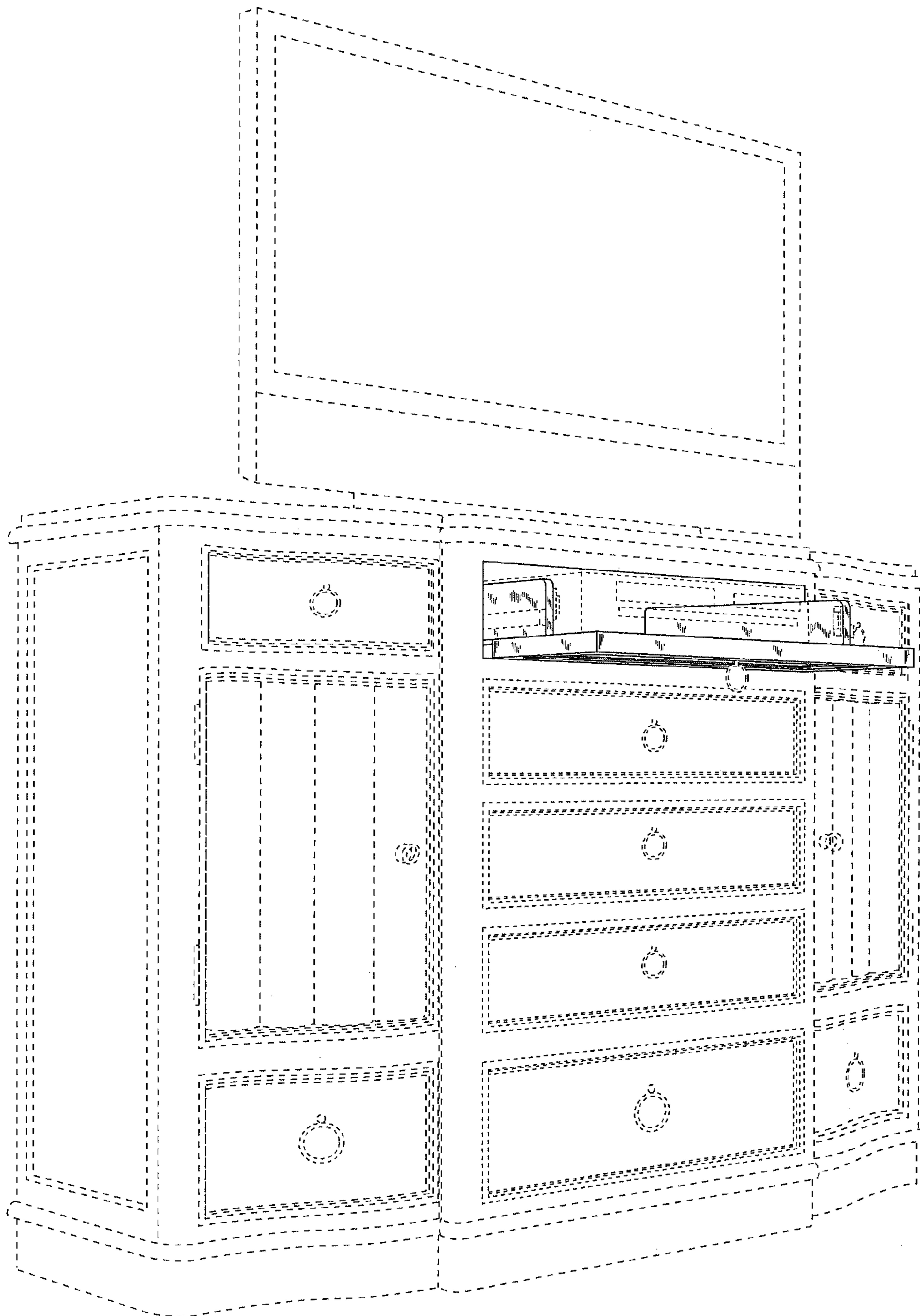

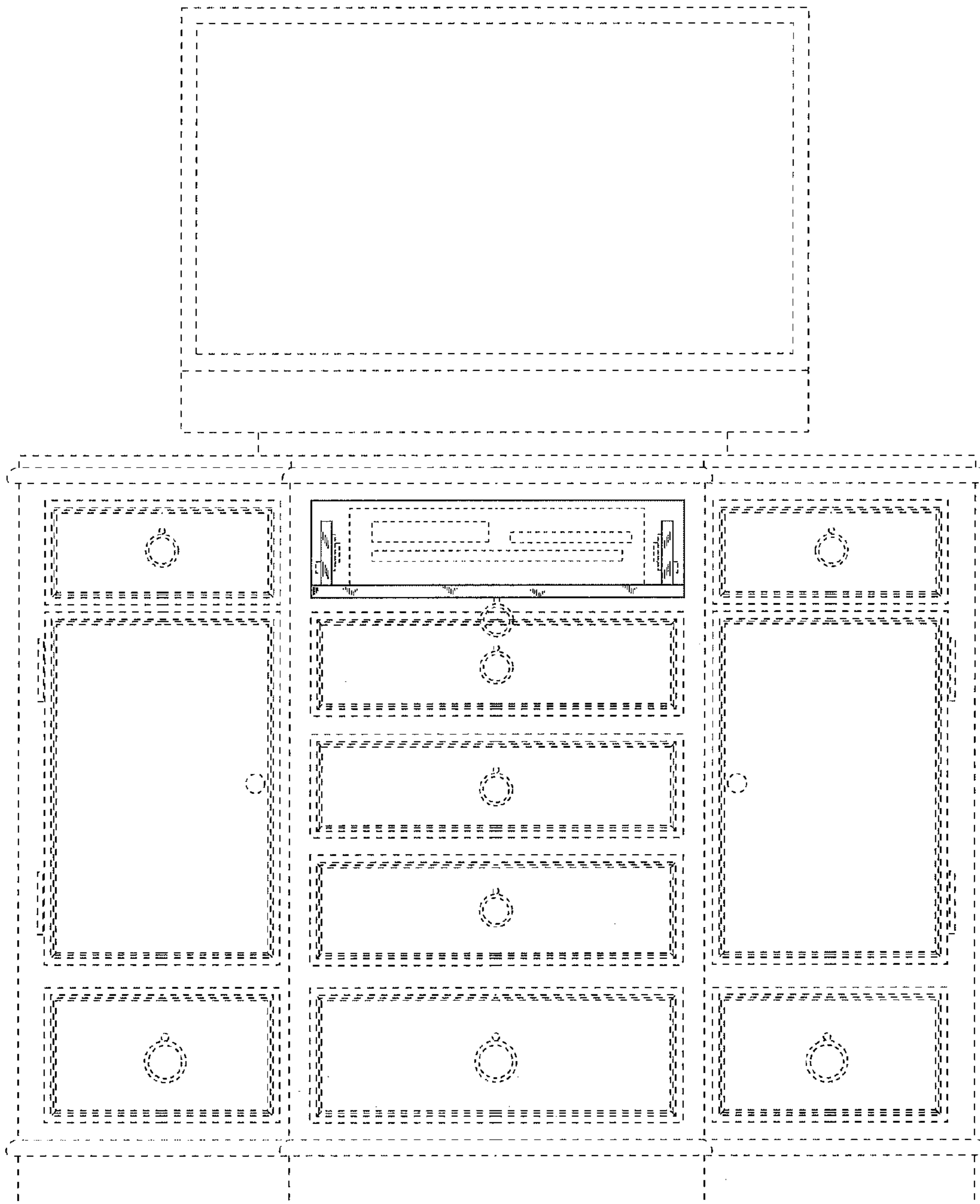

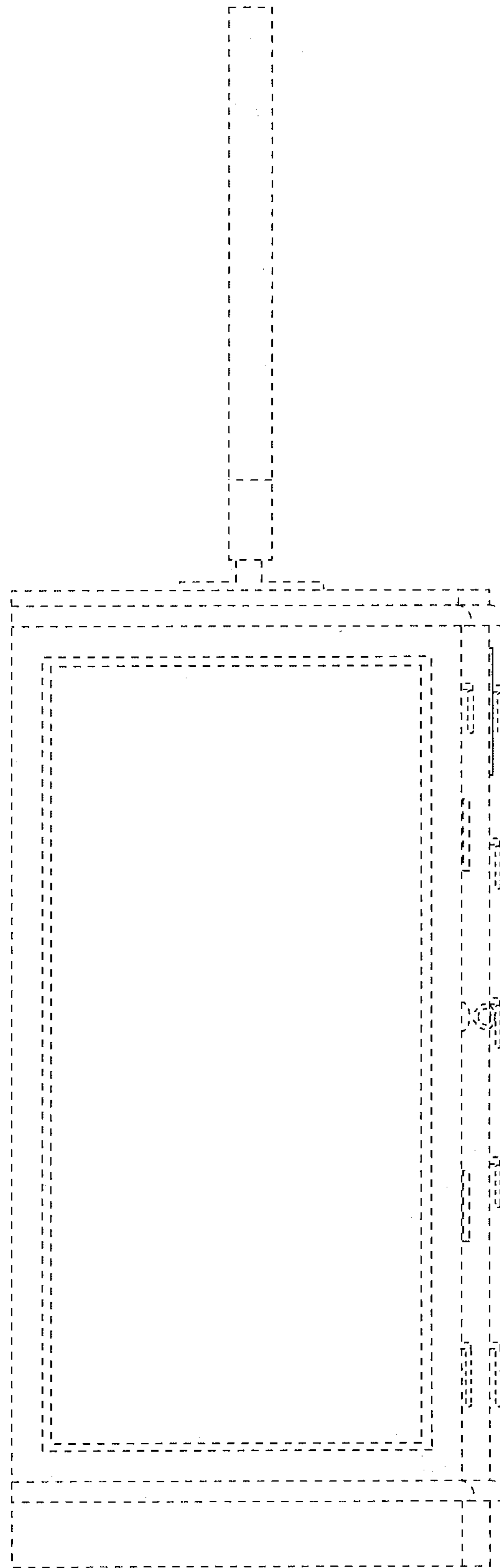

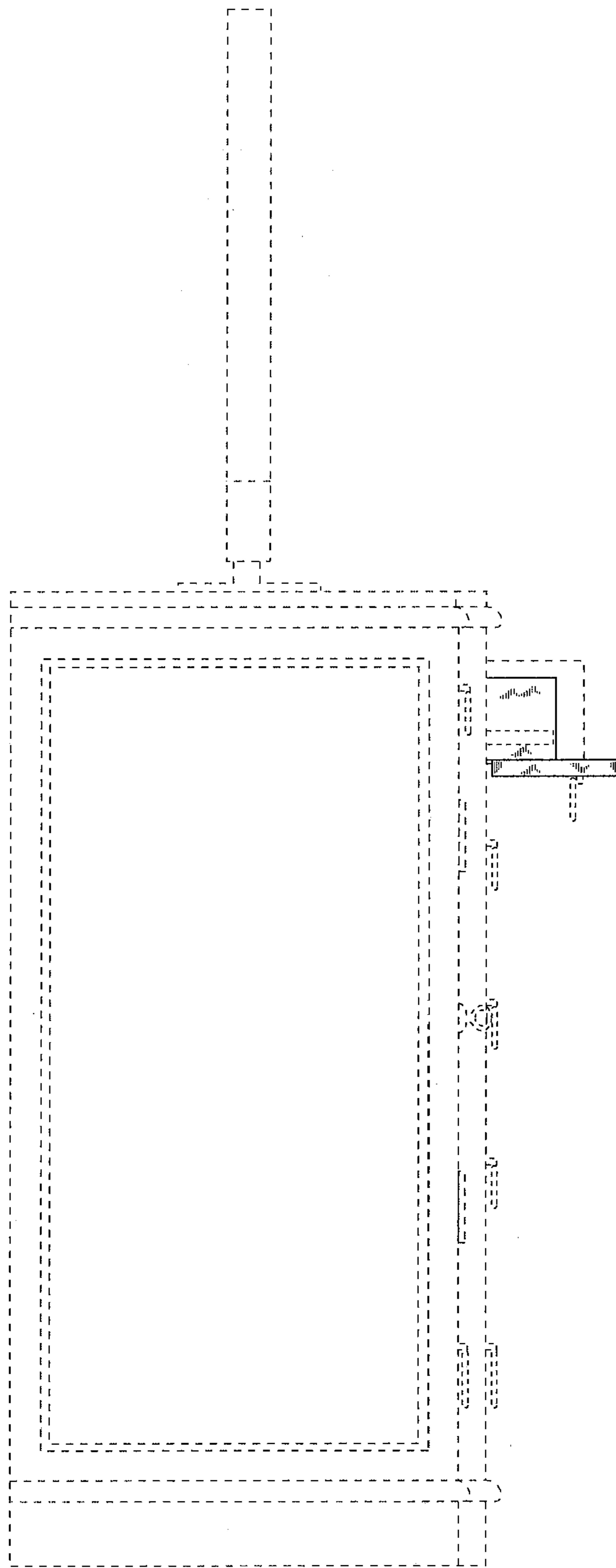
