The ornamental design for a hamburger basket, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a hamburger basket showing my new design, with the lid in the open position;

FIG. 2 is a bottom plan view thereof;

FIG. 3 is a front elevation view thereof, in the closed position;

FIG. 4 is a rear elevation view thereof;

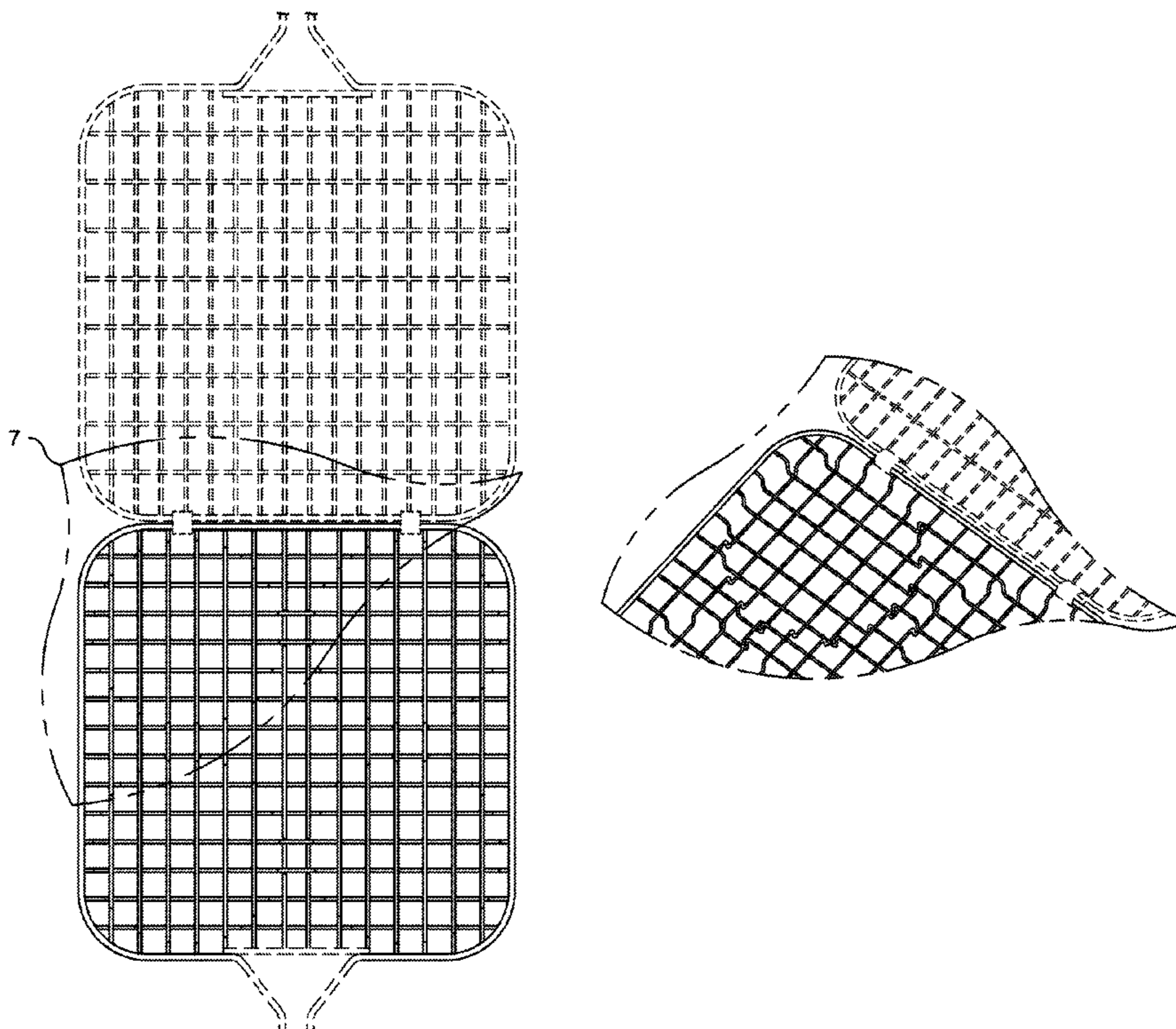
FIG. 5 is a left side elevation view thereof;

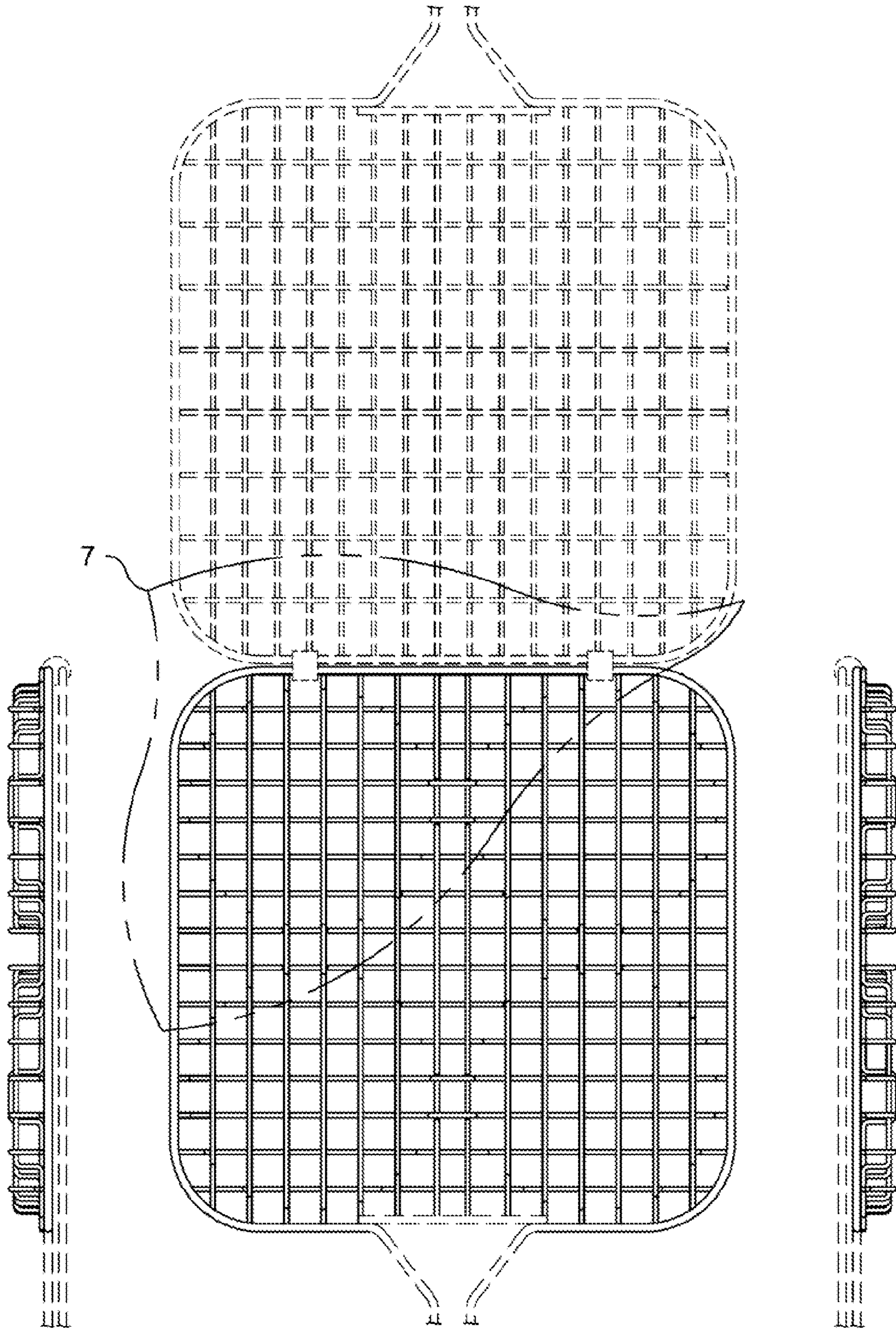

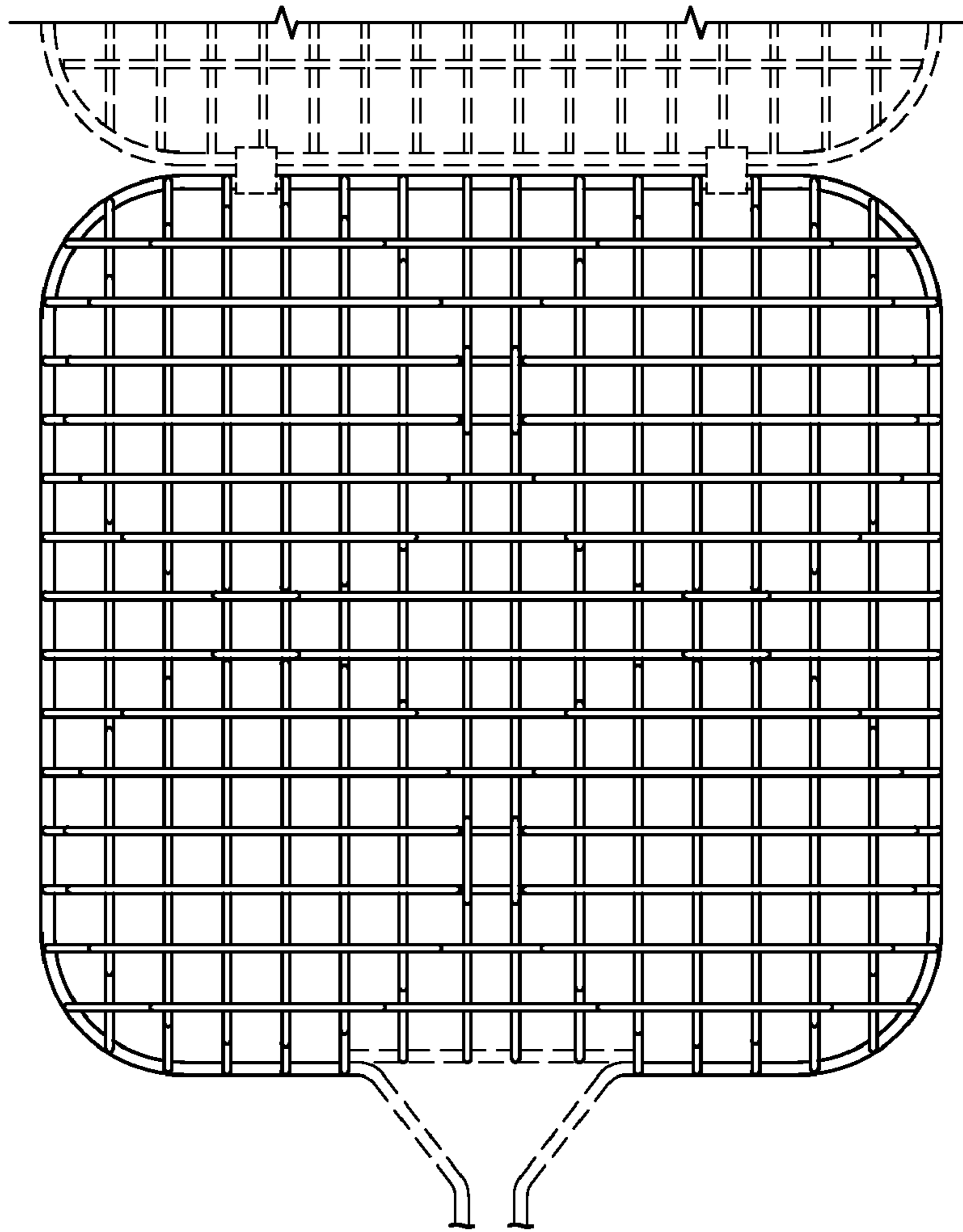

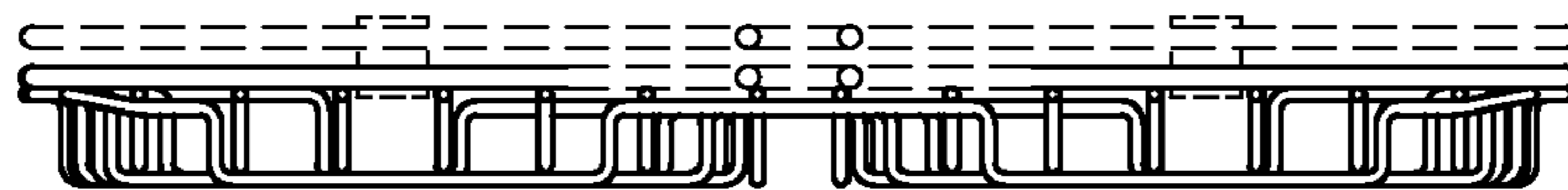

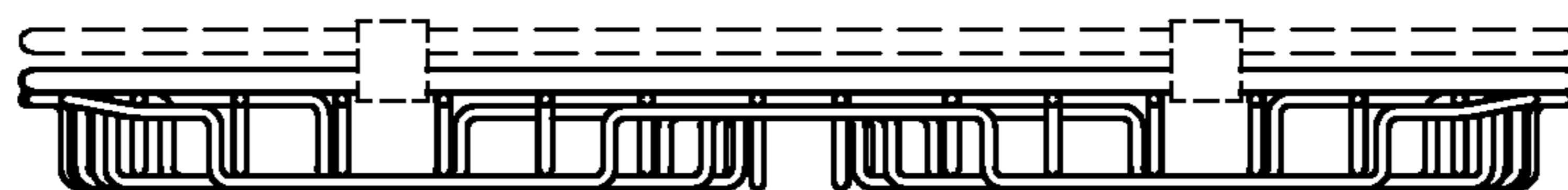

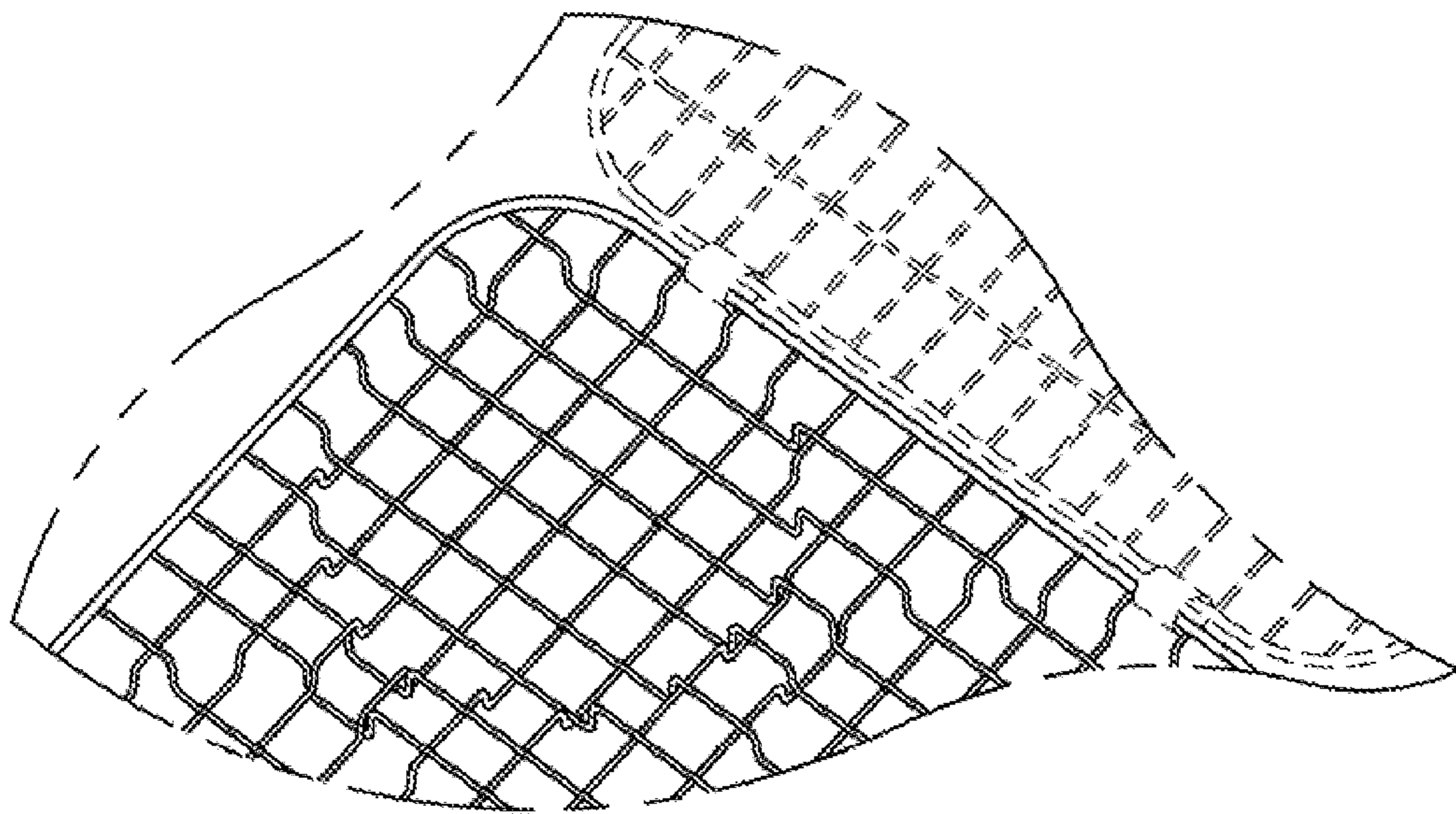
