The ornamental design for a torque wrench and adaptor for an ultrasonic instrument, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a torque wrench and adaptor for an ultrasonic instrument as seen from the top, back, right and left sides;

FIG. 2 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

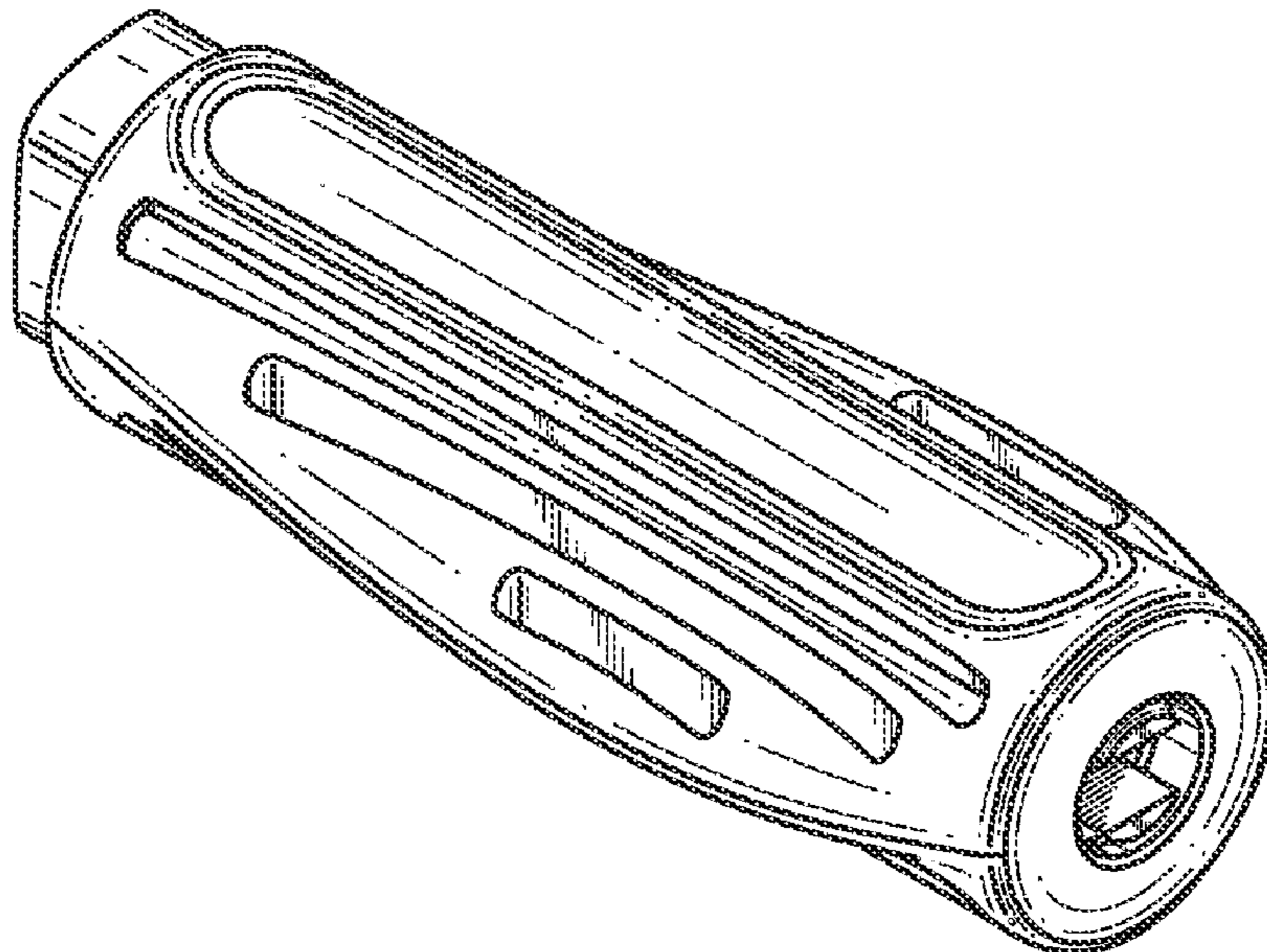
FIG. 5 is an alternate side elevation view thereof;

FIG. 6 is an end view thereof; and,

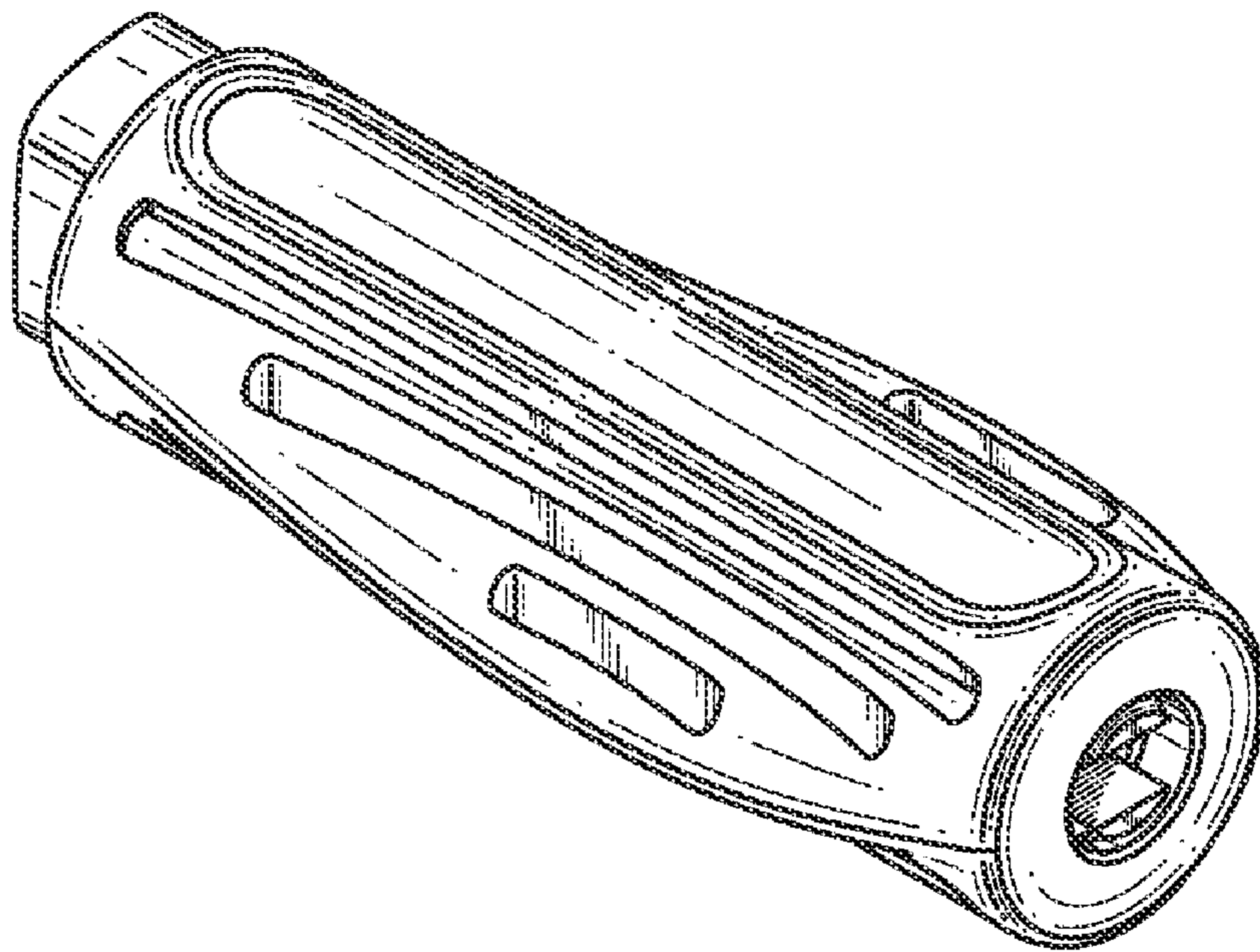
FIG. 7 is a front view thereof.

The portions of the torque wrench and adaptor for an ultrasonic instrument shown in broken lines form no part of the claimed design.

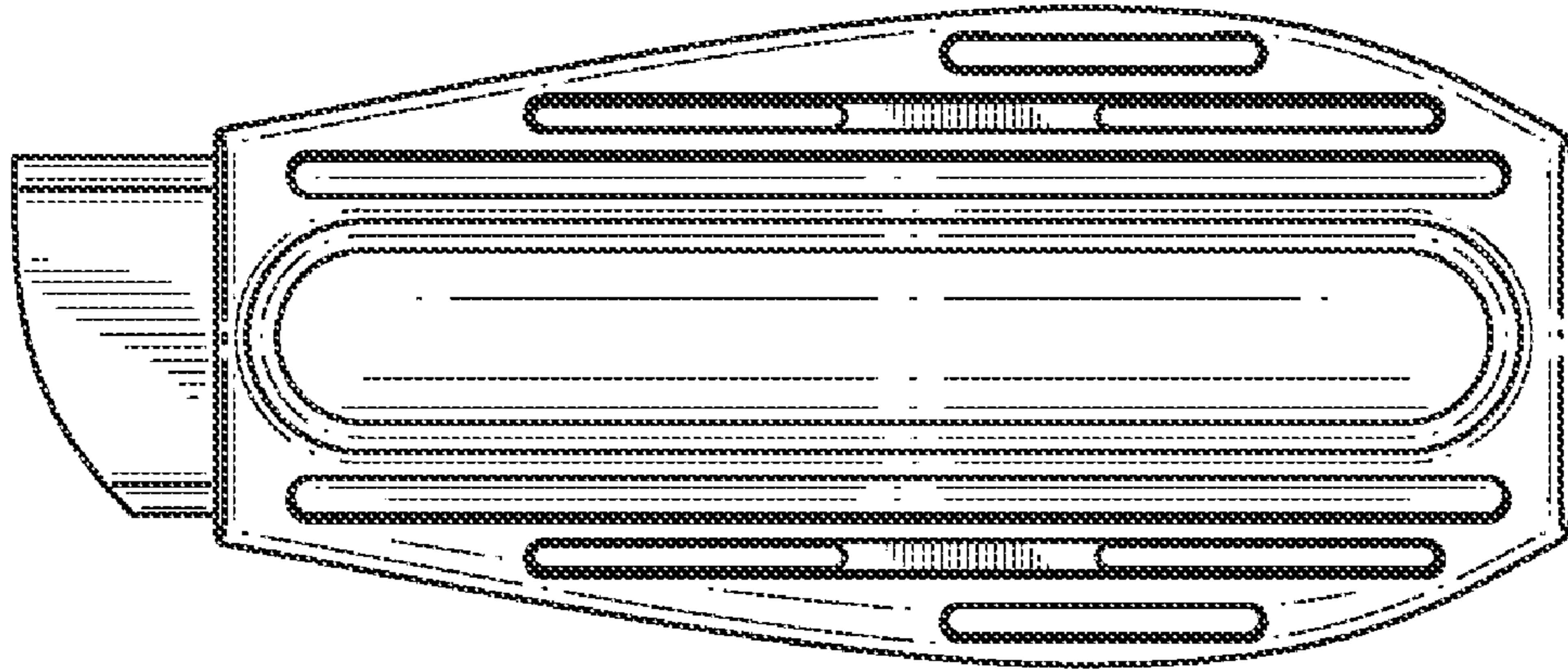

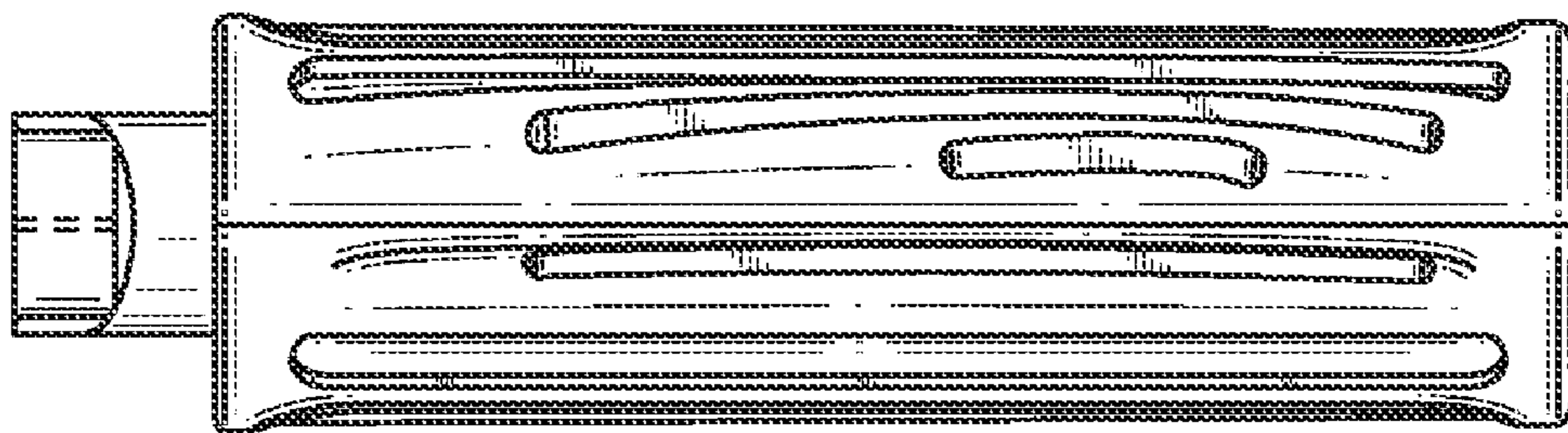

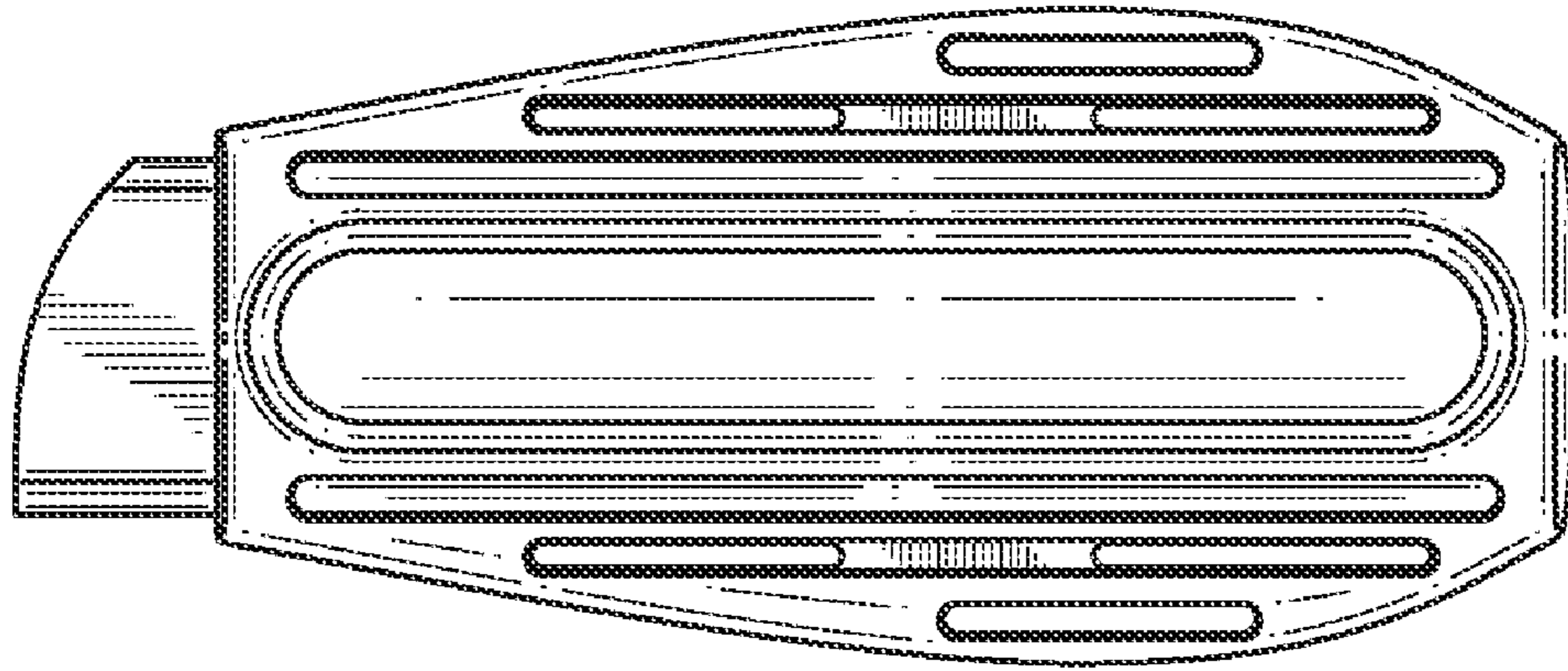

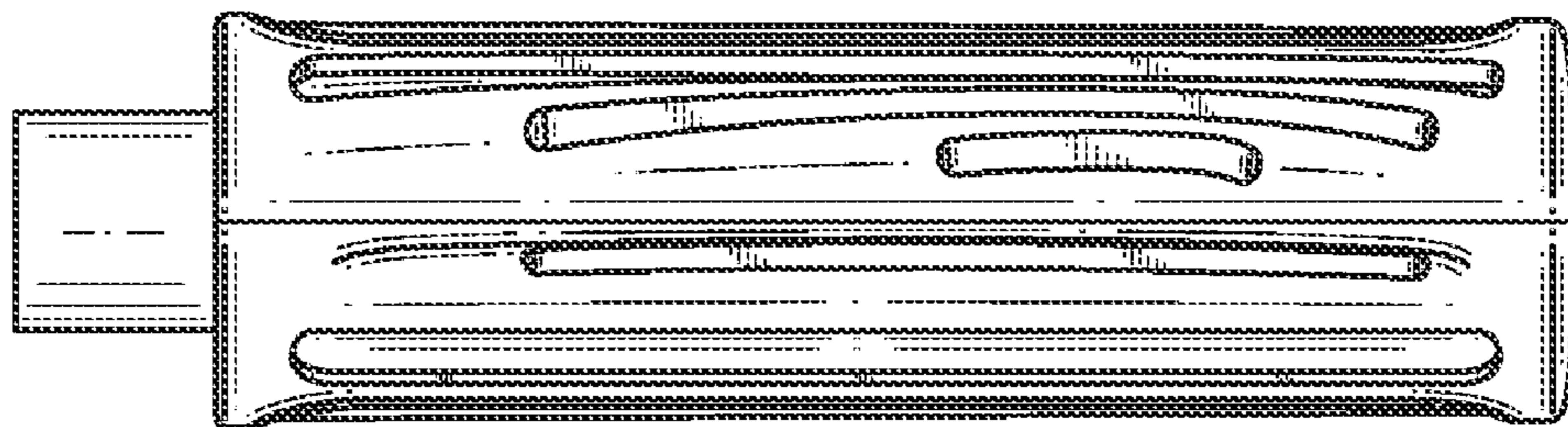

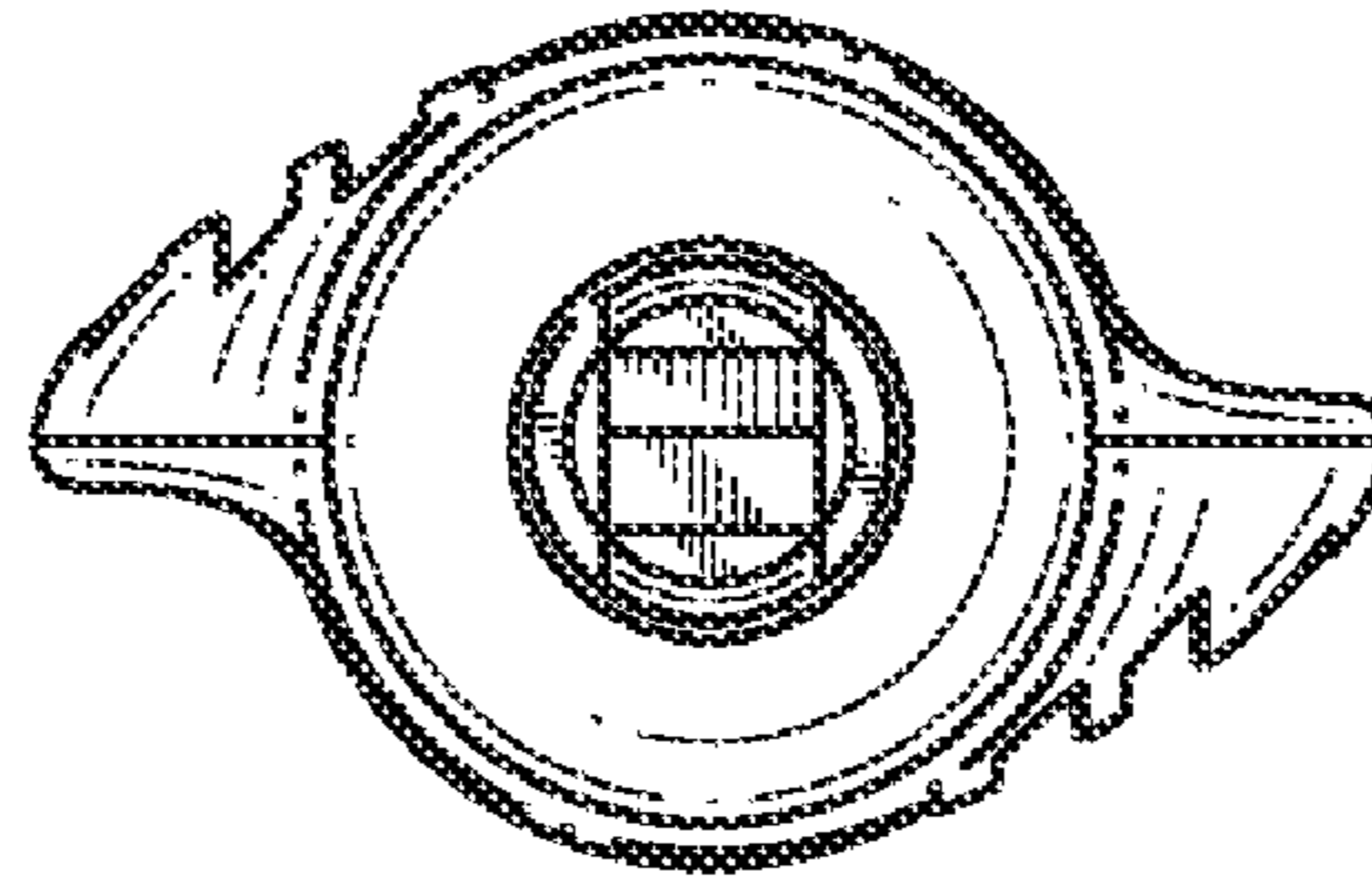
