FIG. 2 is an alternative embodiment of FIG. 1 which is lined for color;

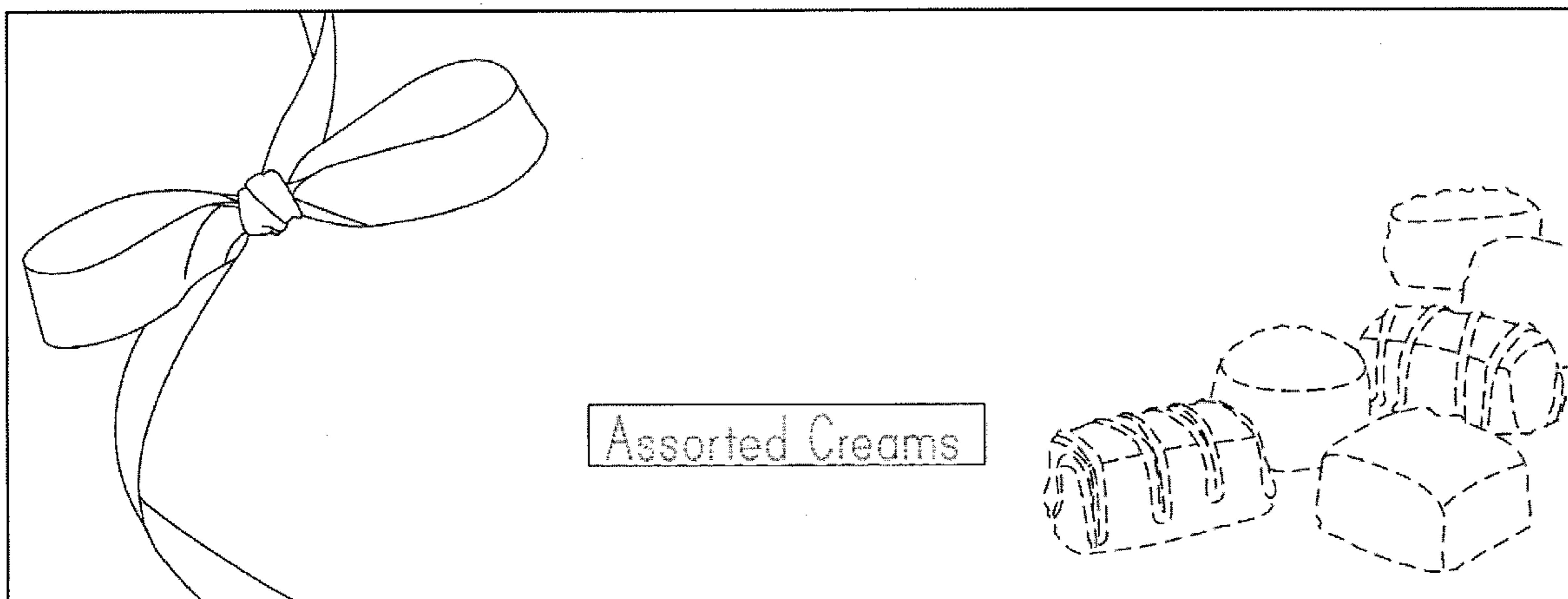
FIG. 3 is an alternative embodiment of FIG. 1 which is lined for color;

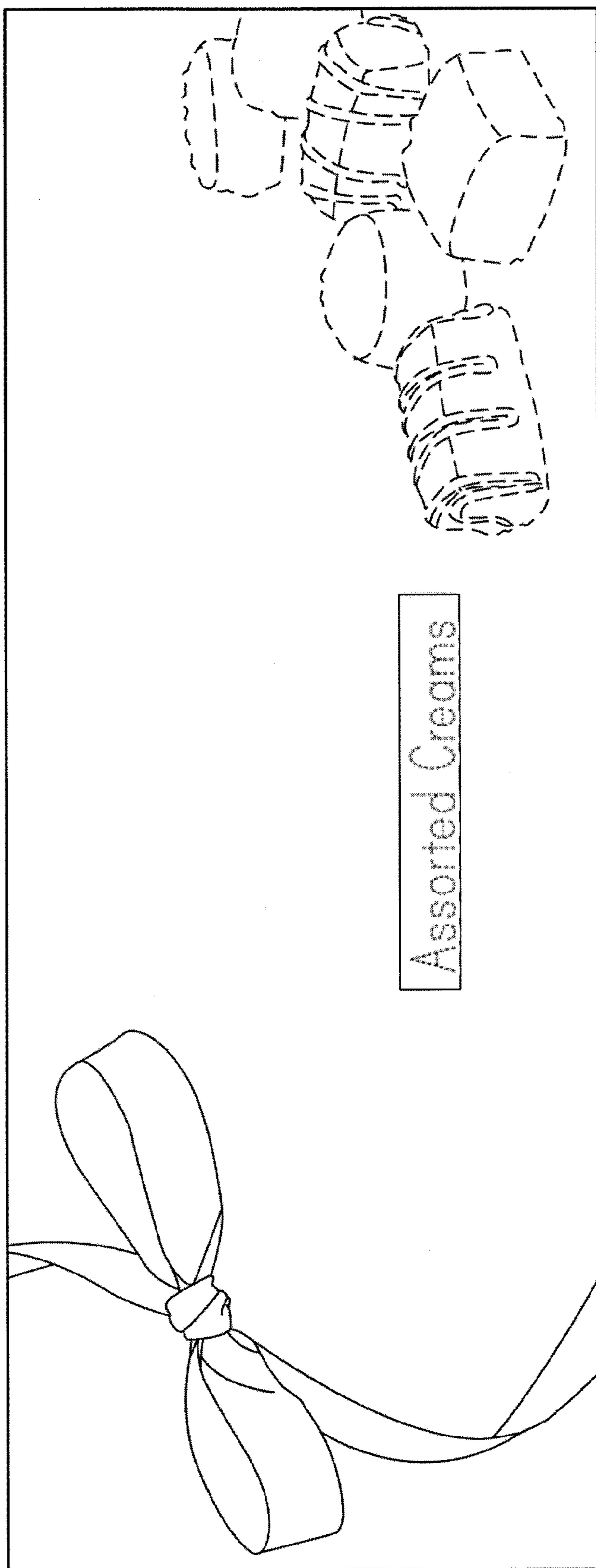

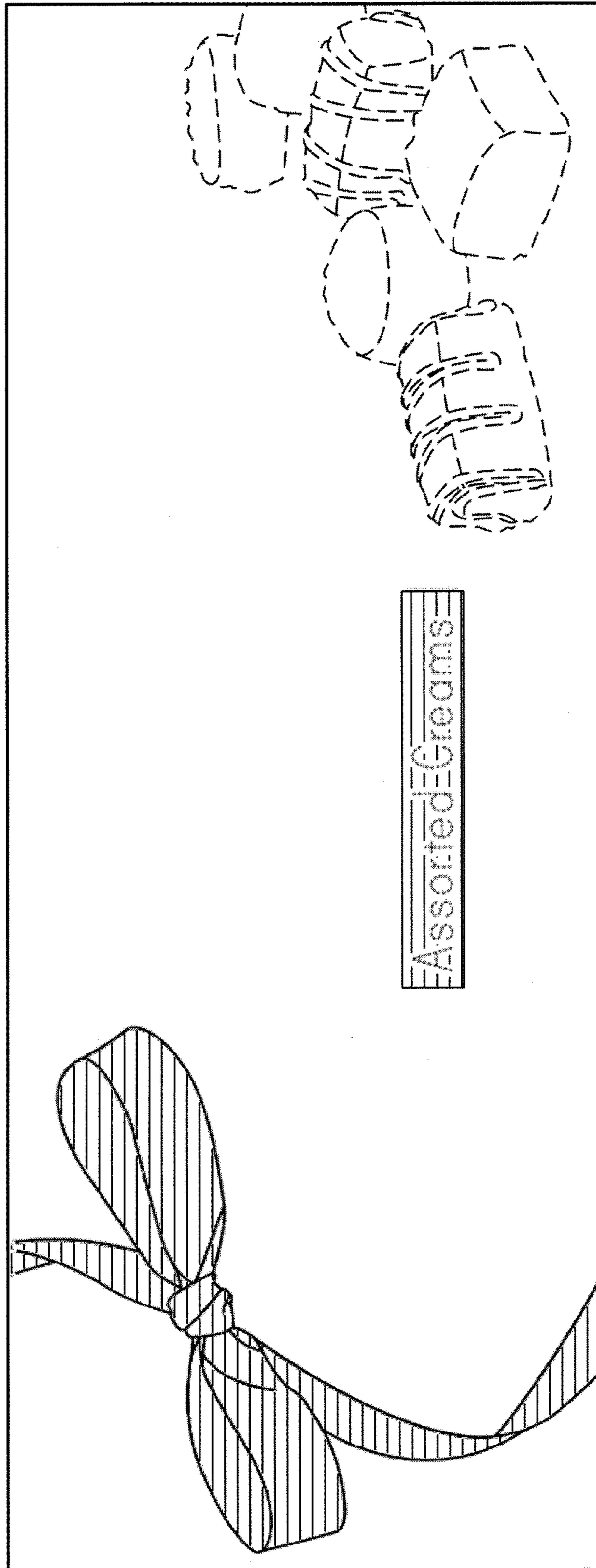

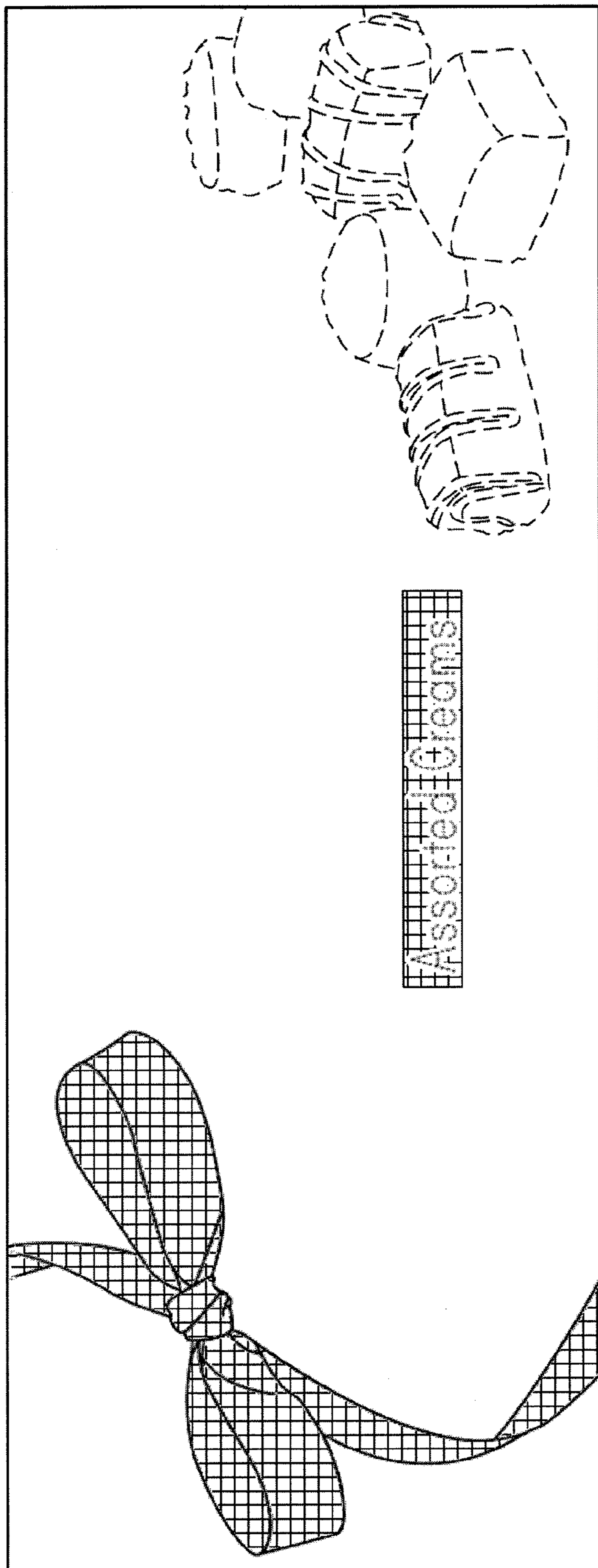

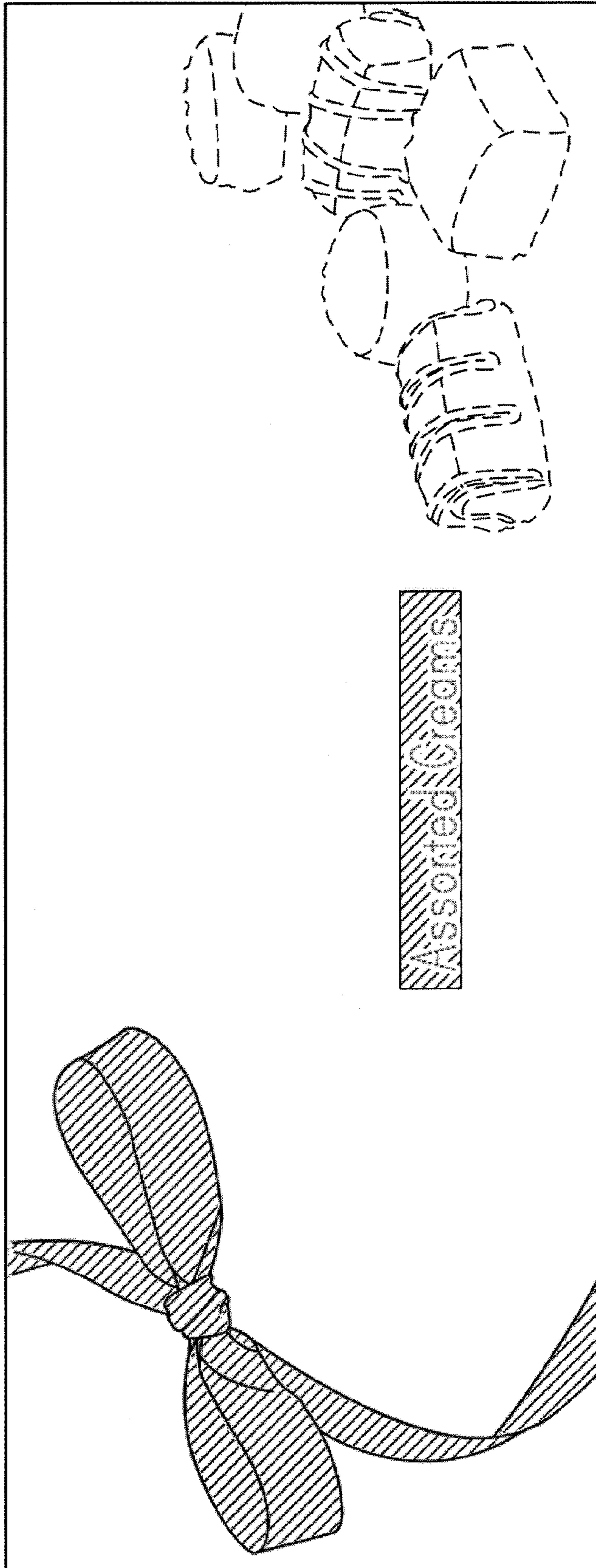

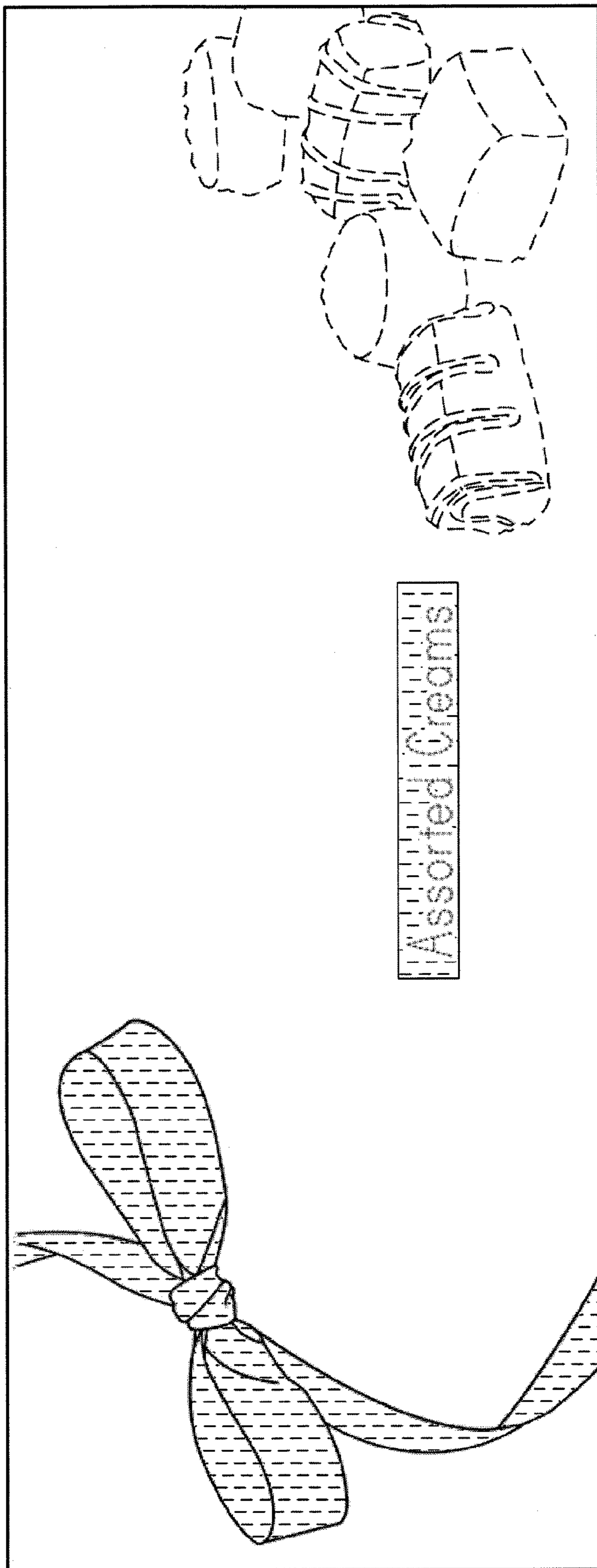
