FIG. 5 is a front view of the dome;

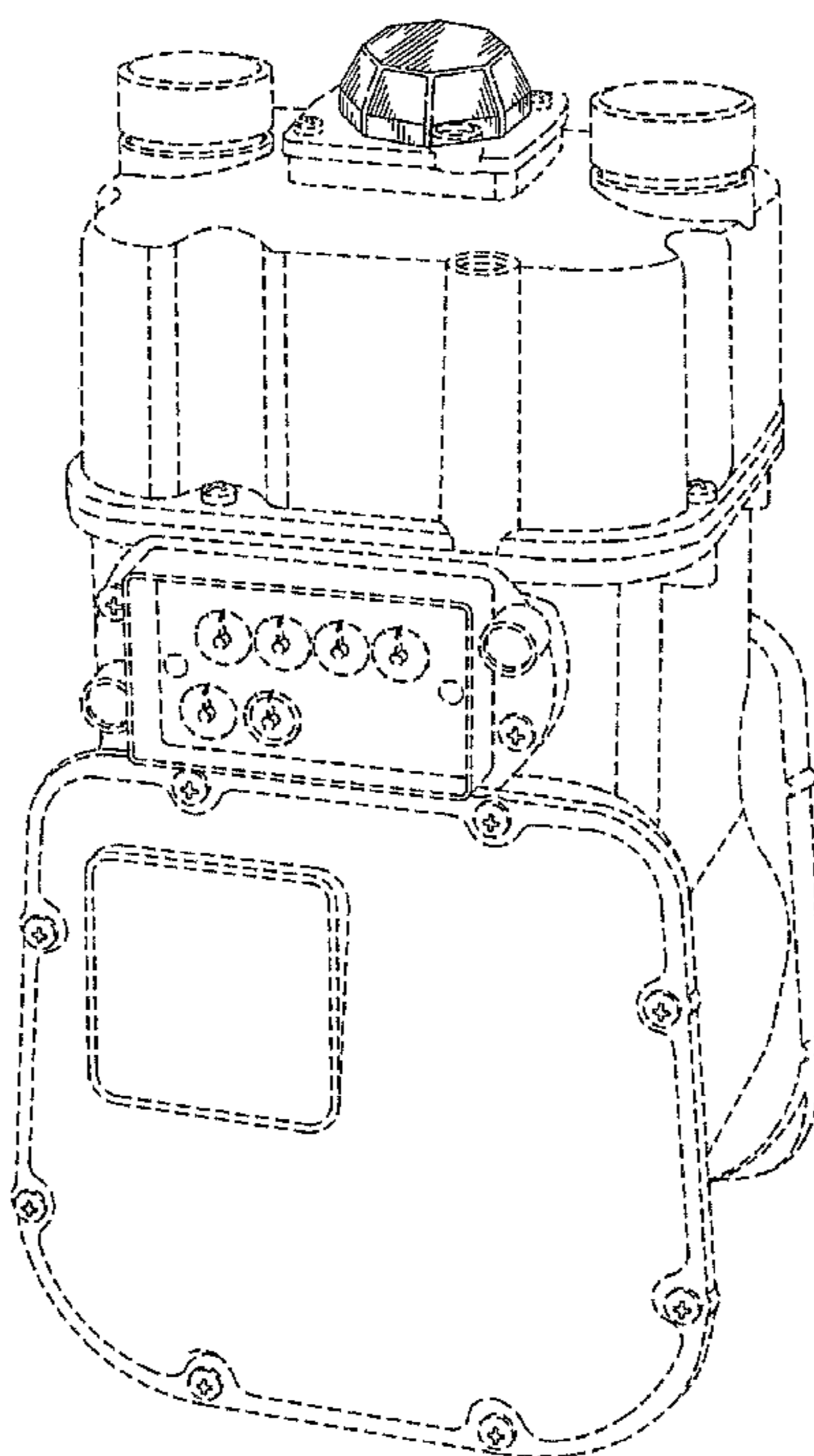
FIG. 6 is a rear view of the dome;

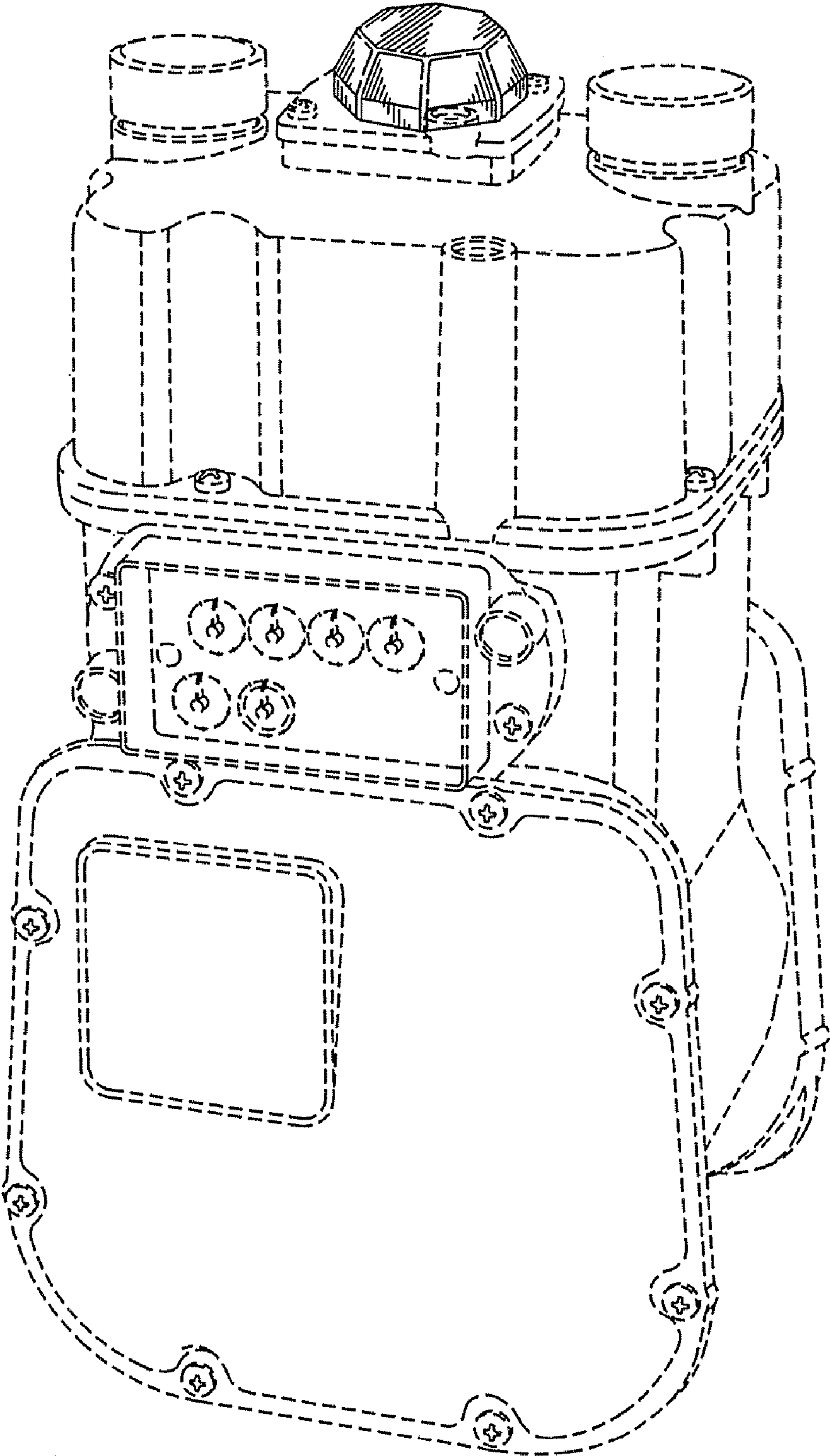

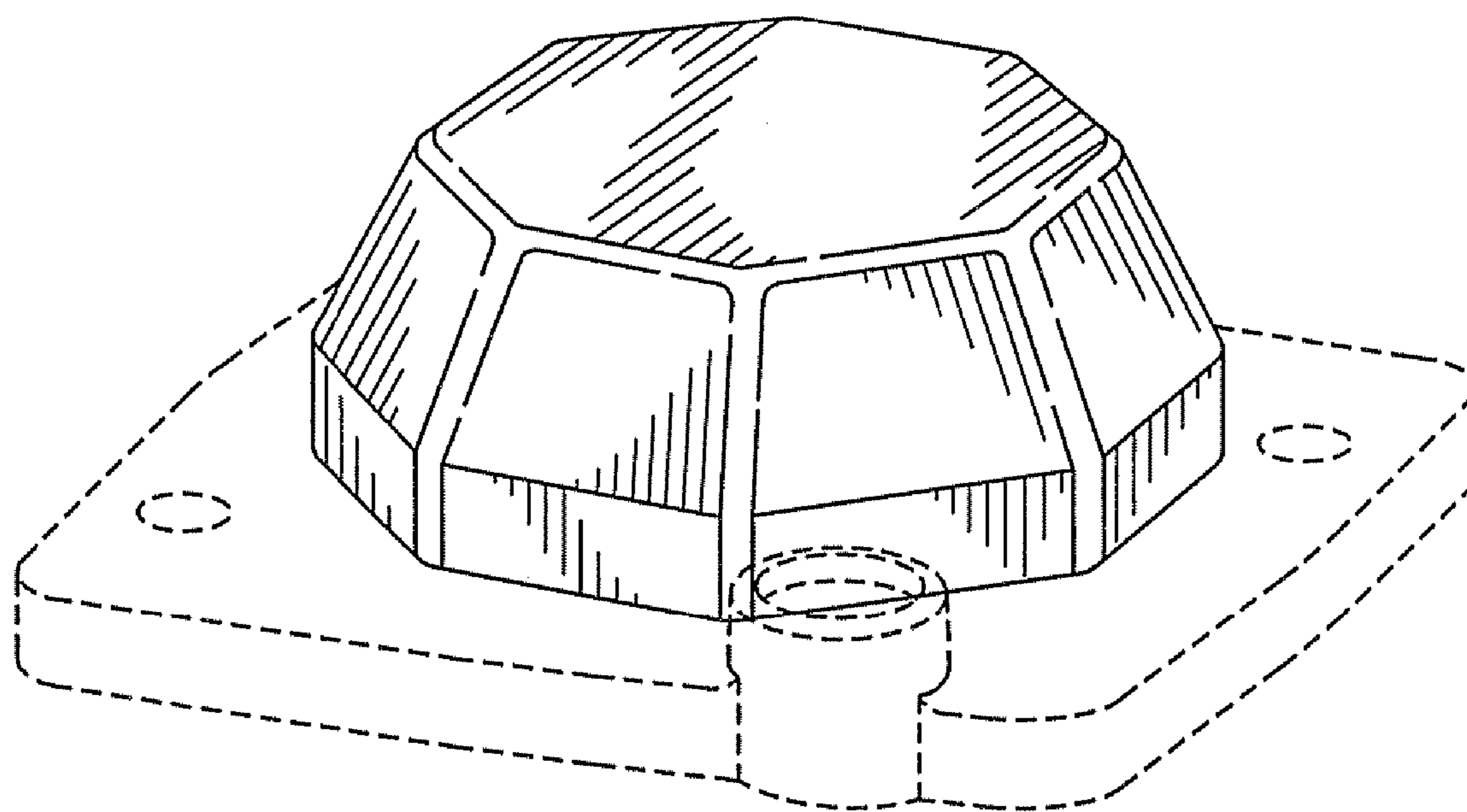

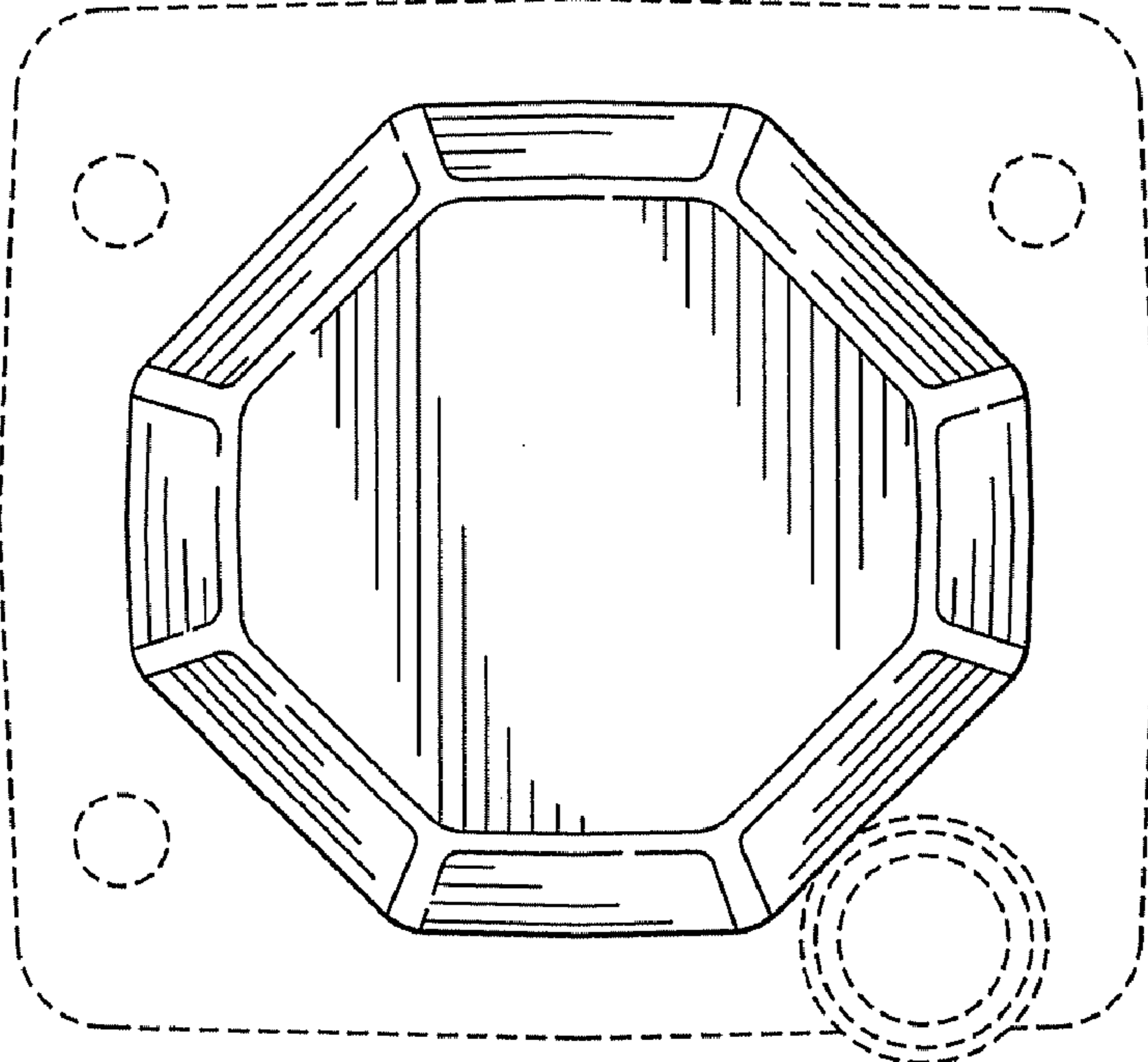

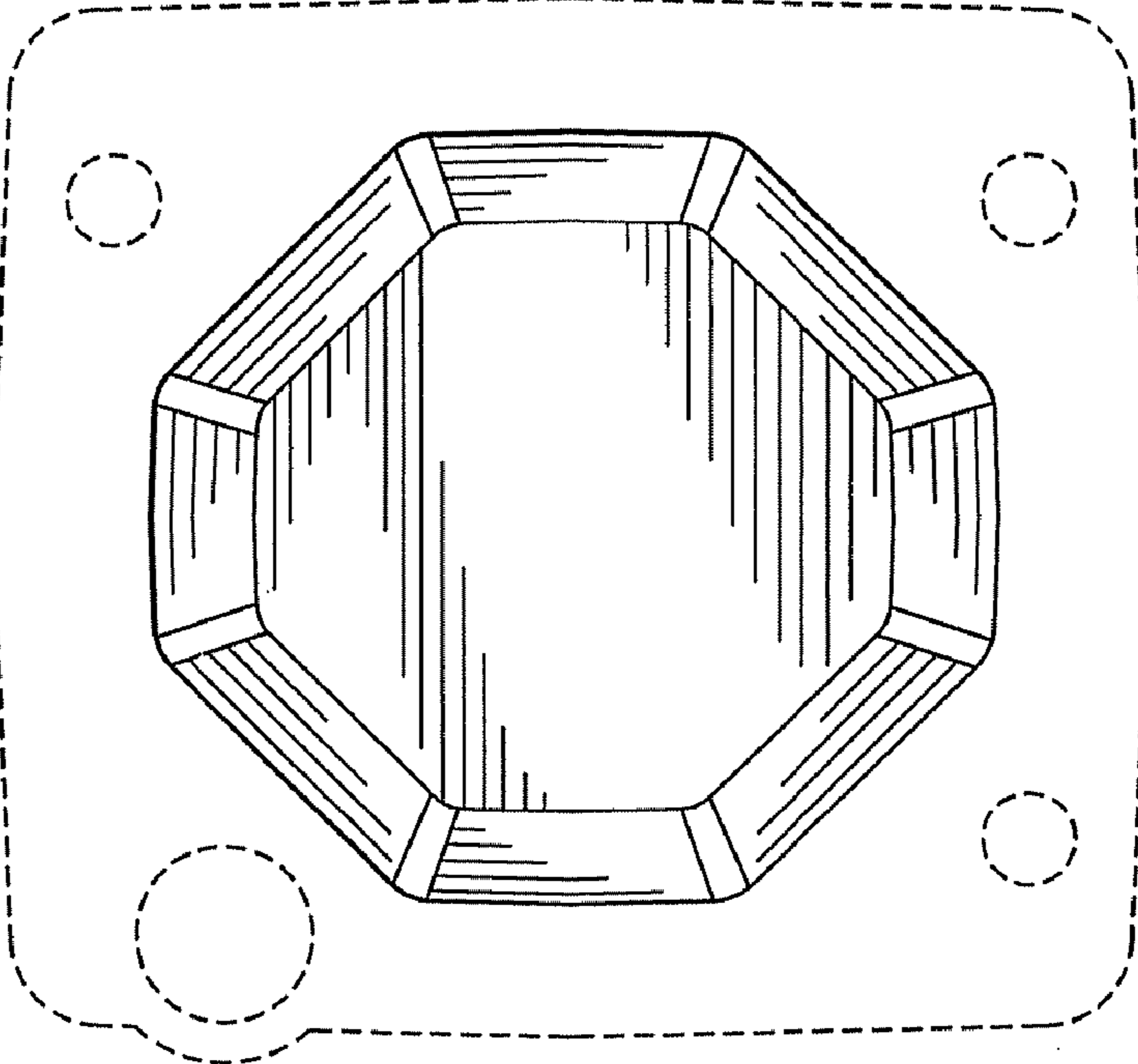

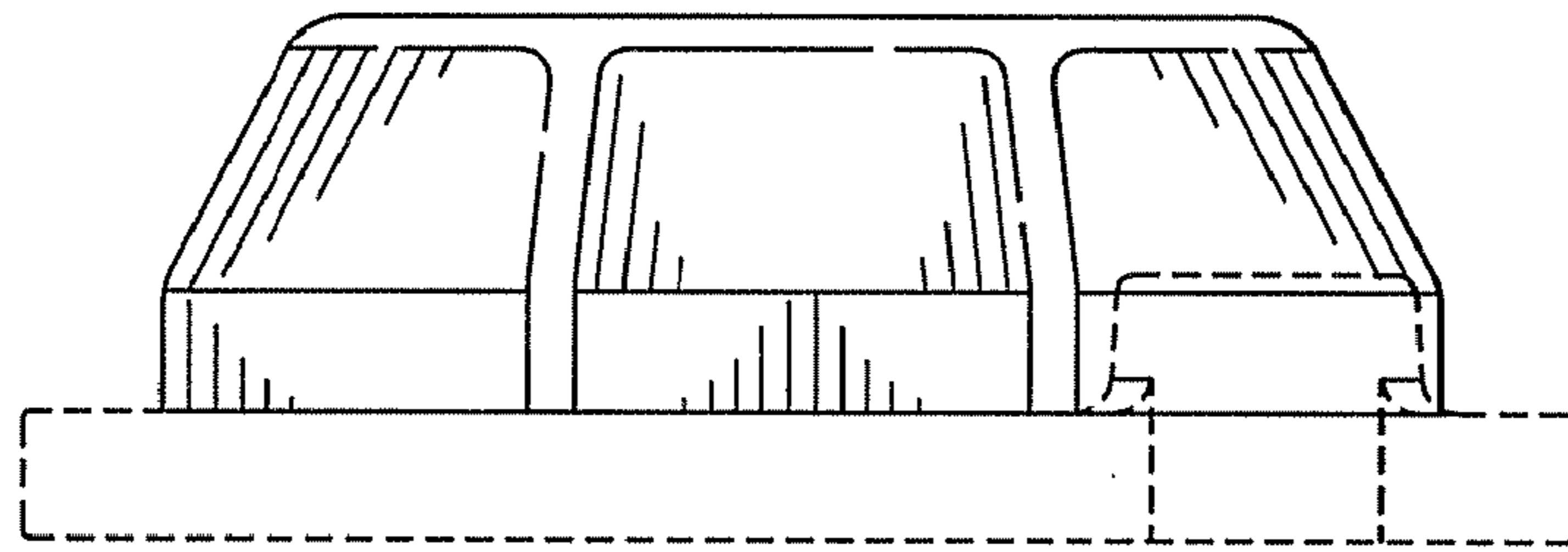

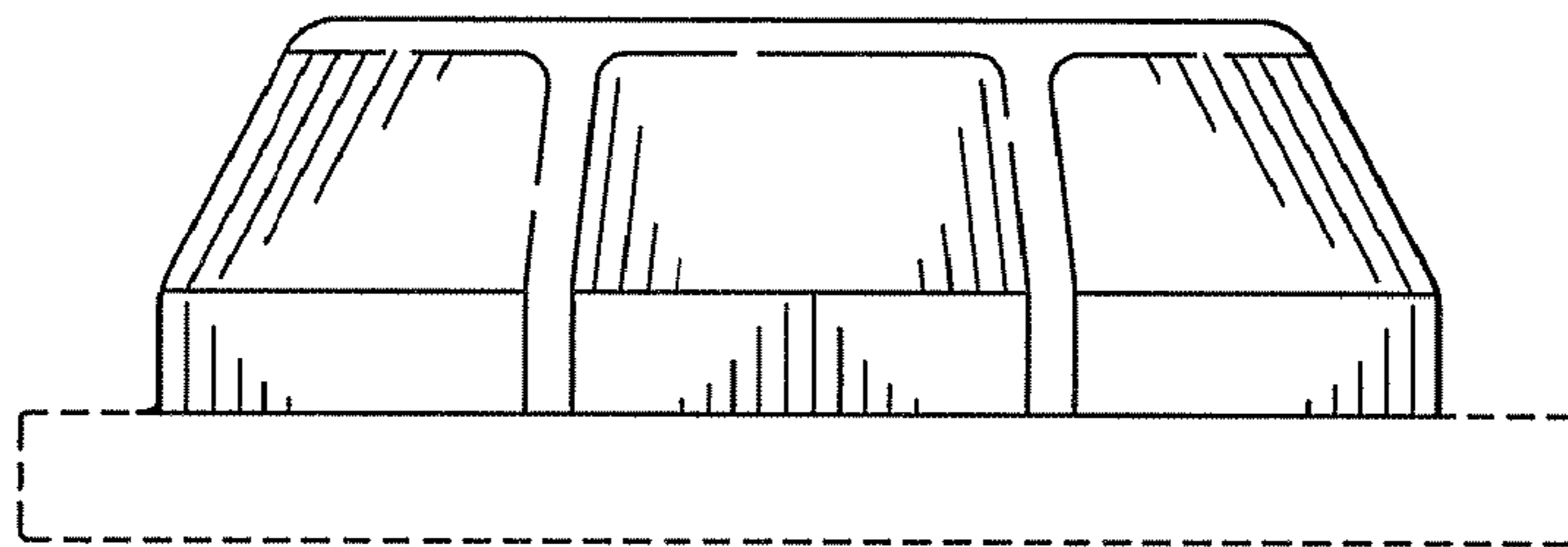

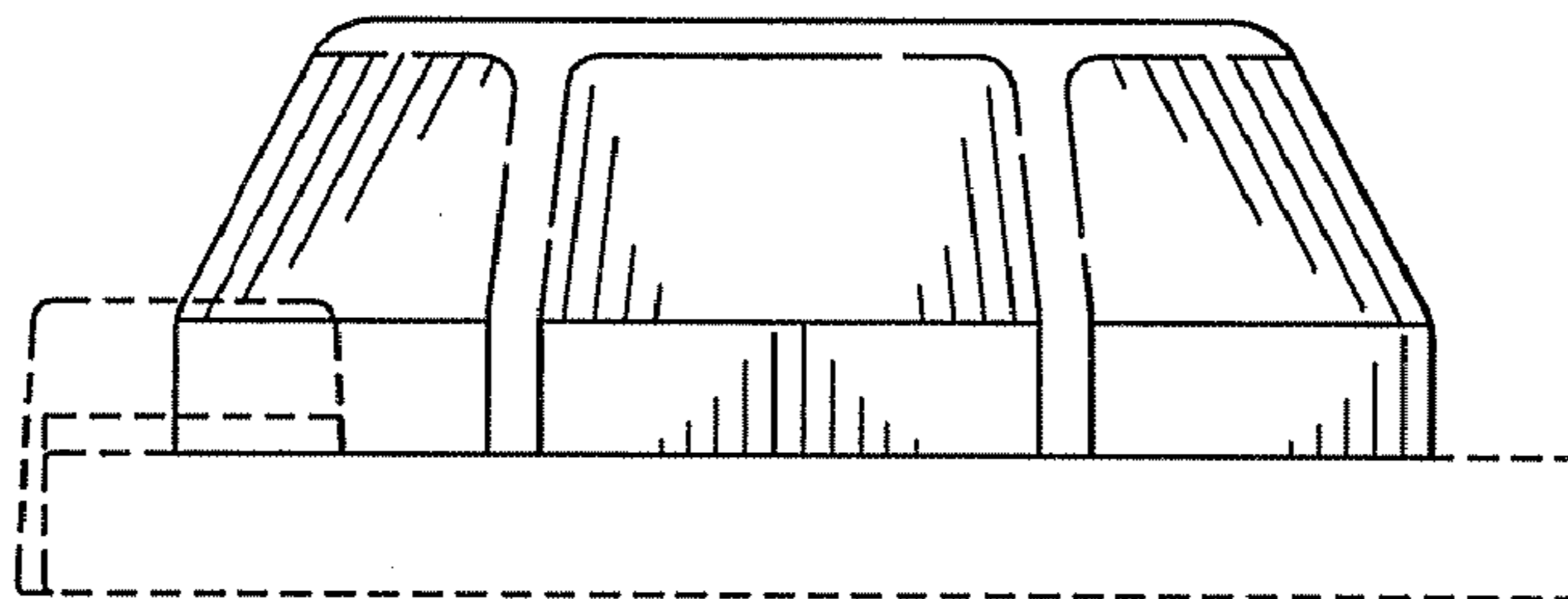

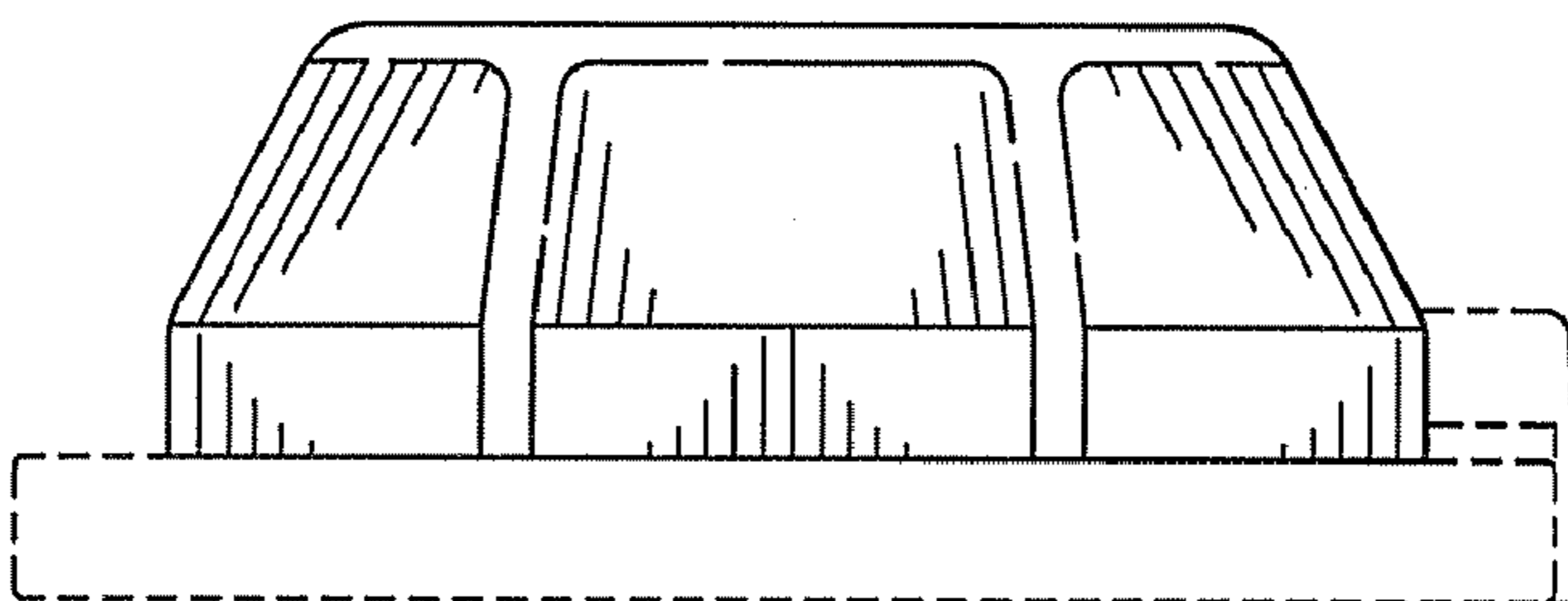
