(57) **CLAIM**

An ornamental design for a vehicle front bumper cover outer panel, as shown and described.

DESCRIPTION

FIG. 1 is a left side elevational view of a left vehicle front bumper cover outer panel (the right vehicle front bumper cover outer panel being a mirror image and is not shown);

FIG. 2 is a right side elevational view of the vehicle front bumper cover outer panel;

FIG. 3 is a front elevational view of the vehicle front bumper cover outer panel;

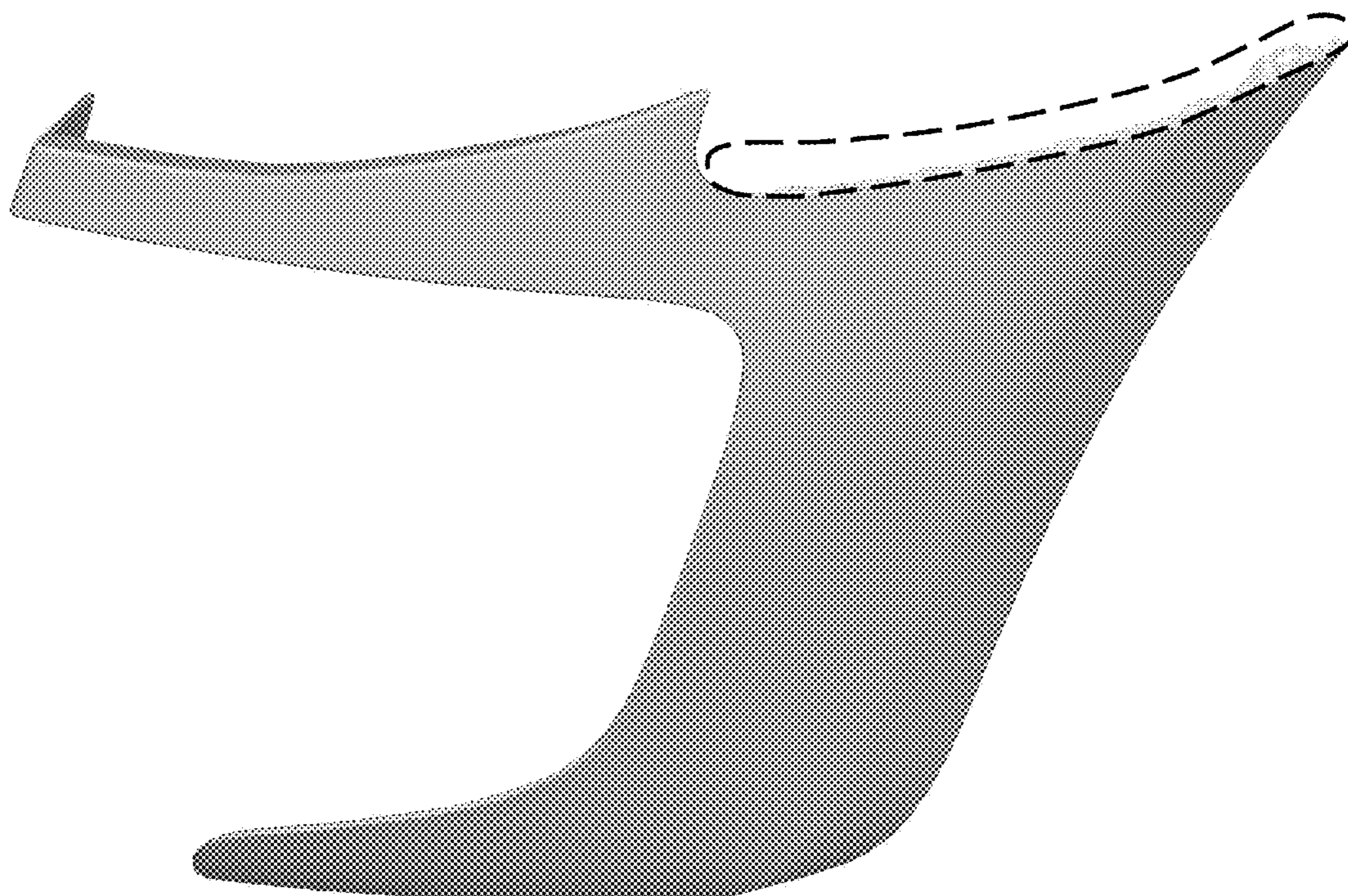
FIG. 4 is a top plan view of the vehicle front bumper cover outer panel;

FIG. 5 is a bottom plan view of the vehicle front bumper cover outer panel; and,

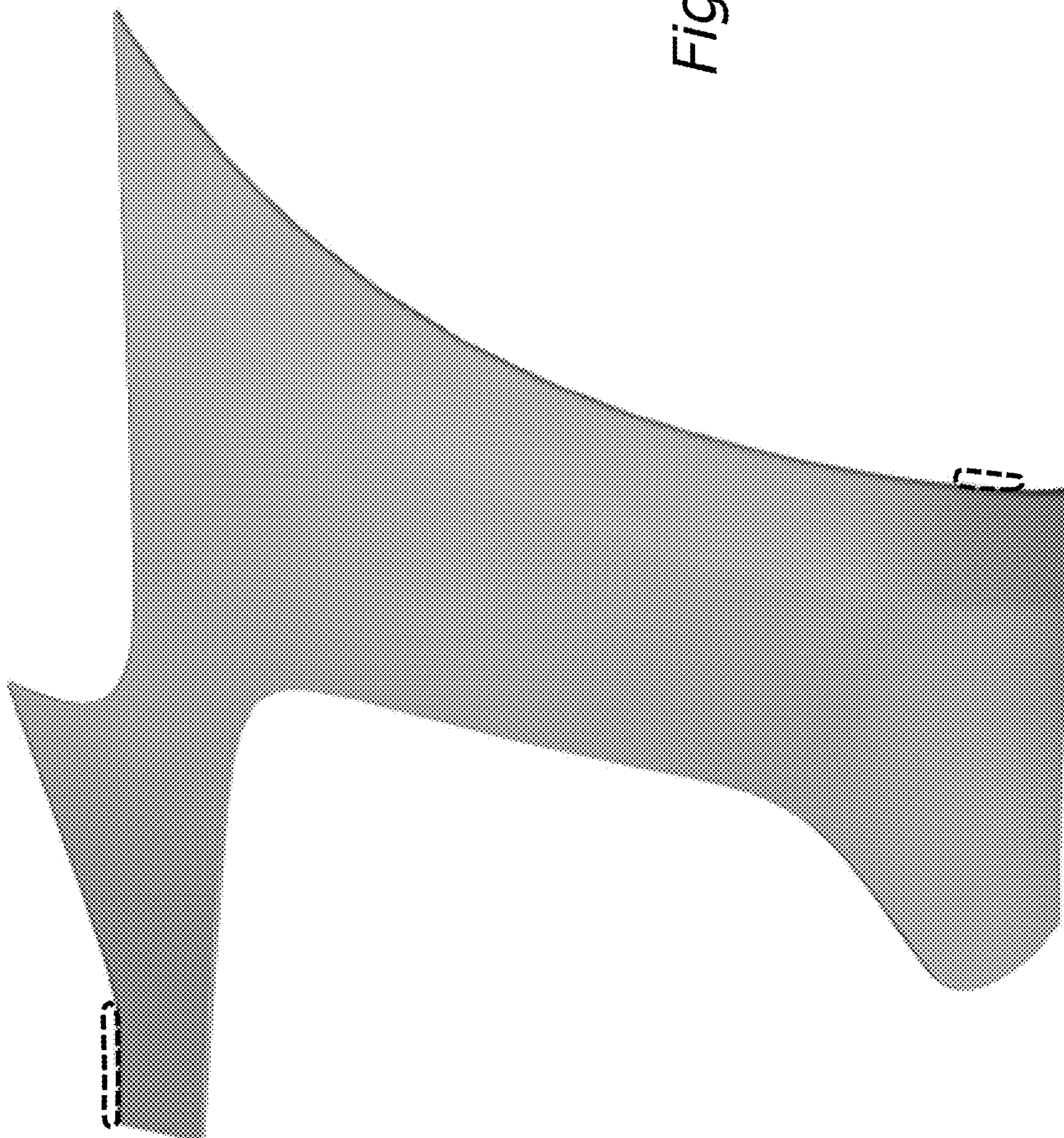

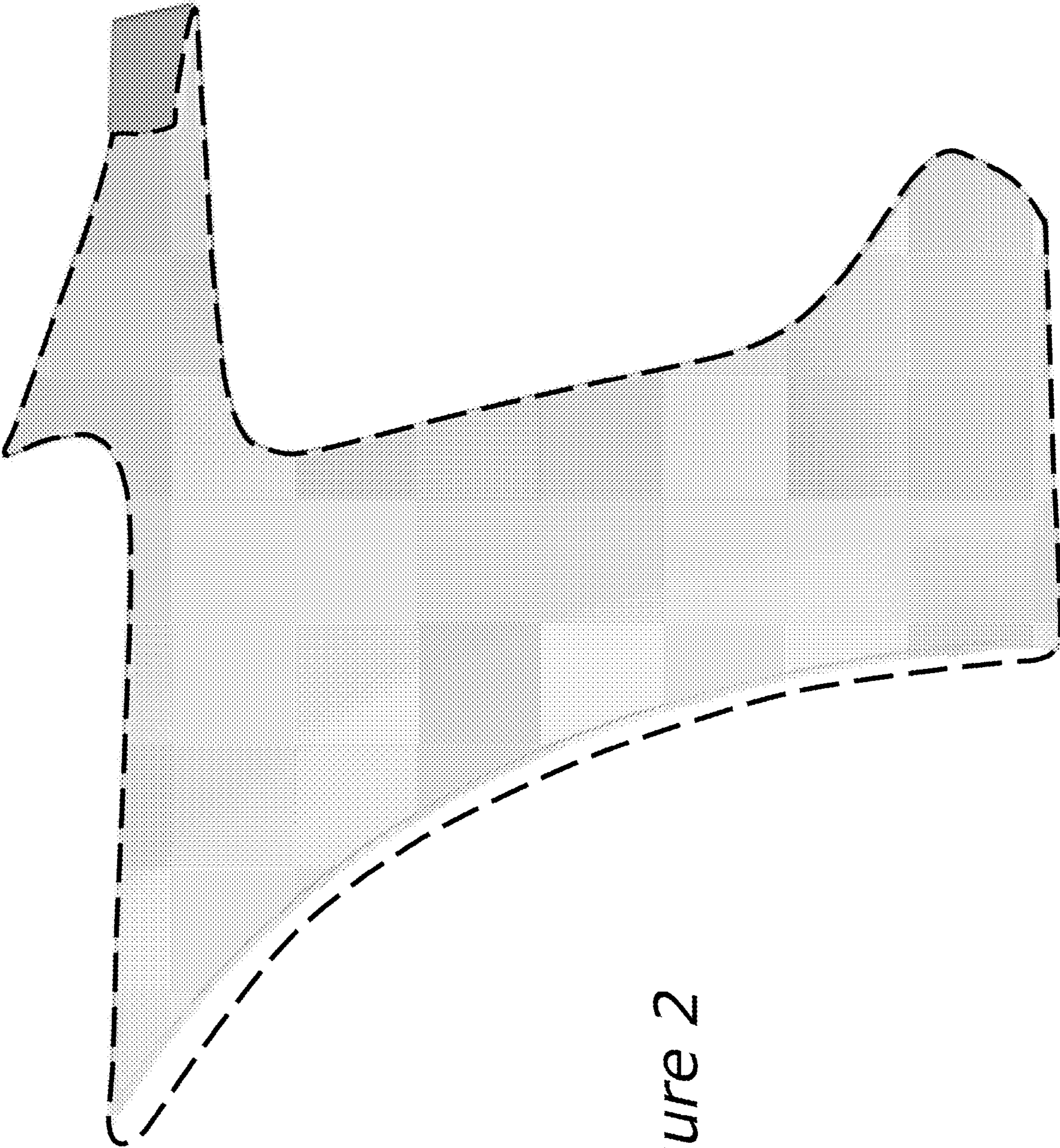

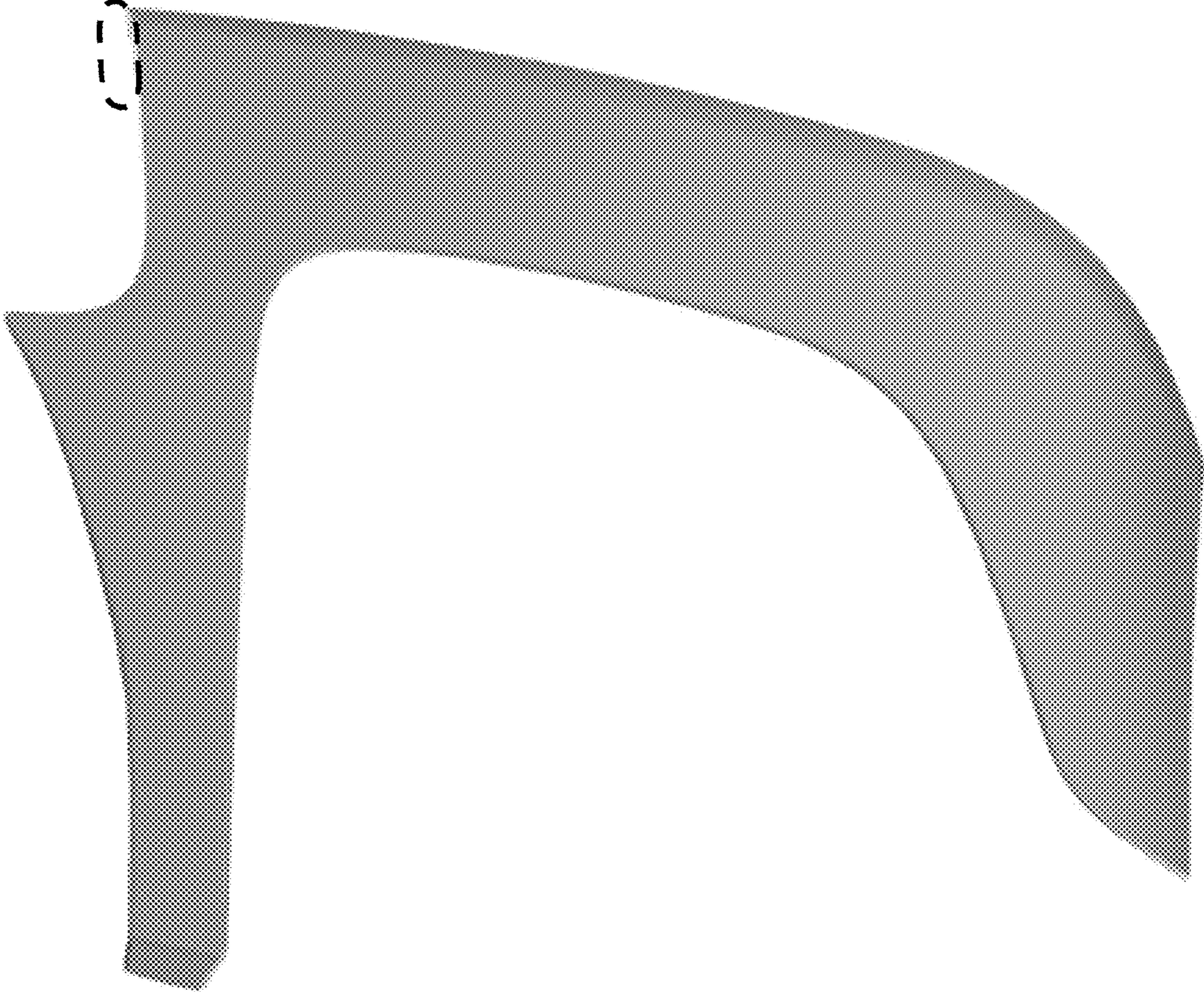

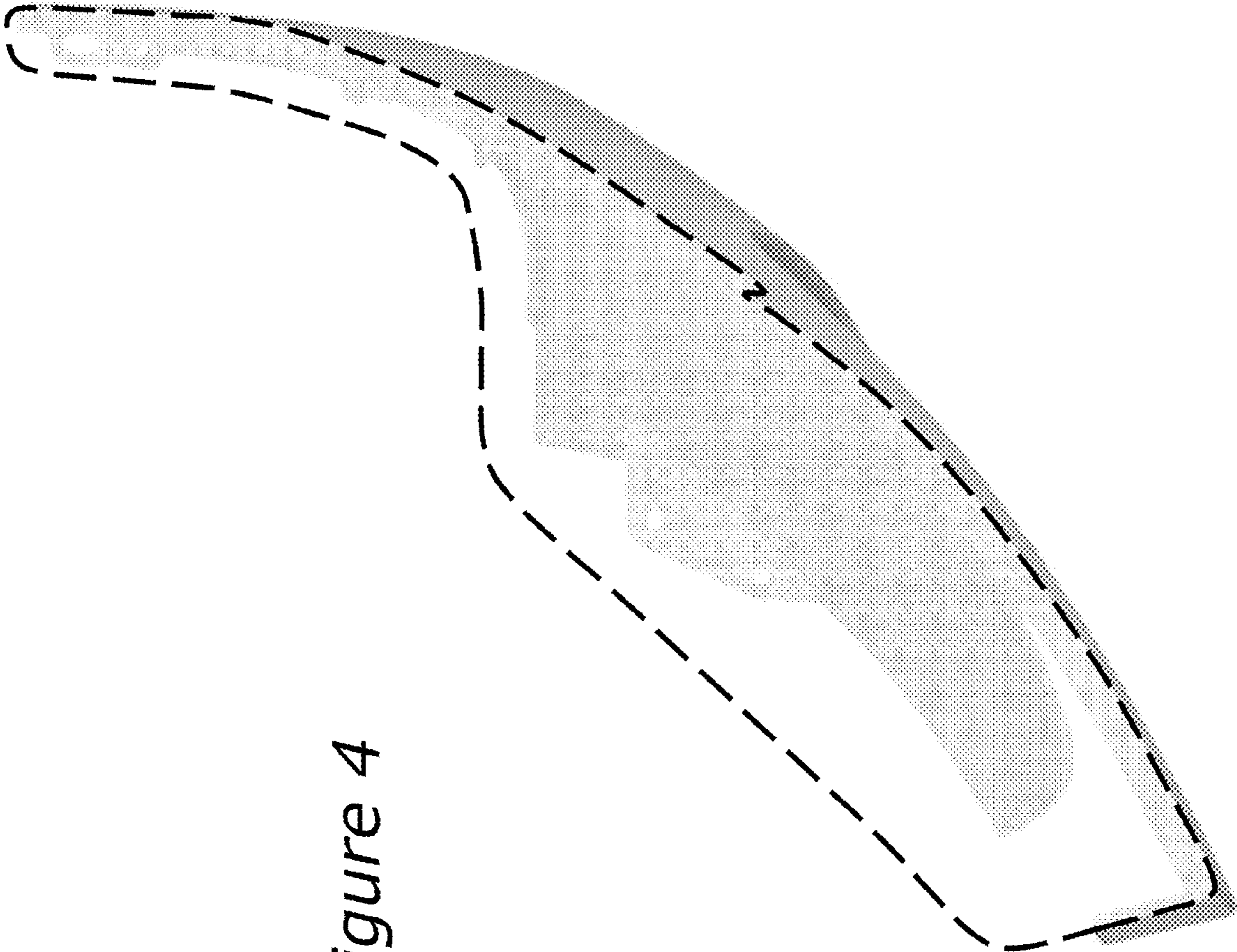
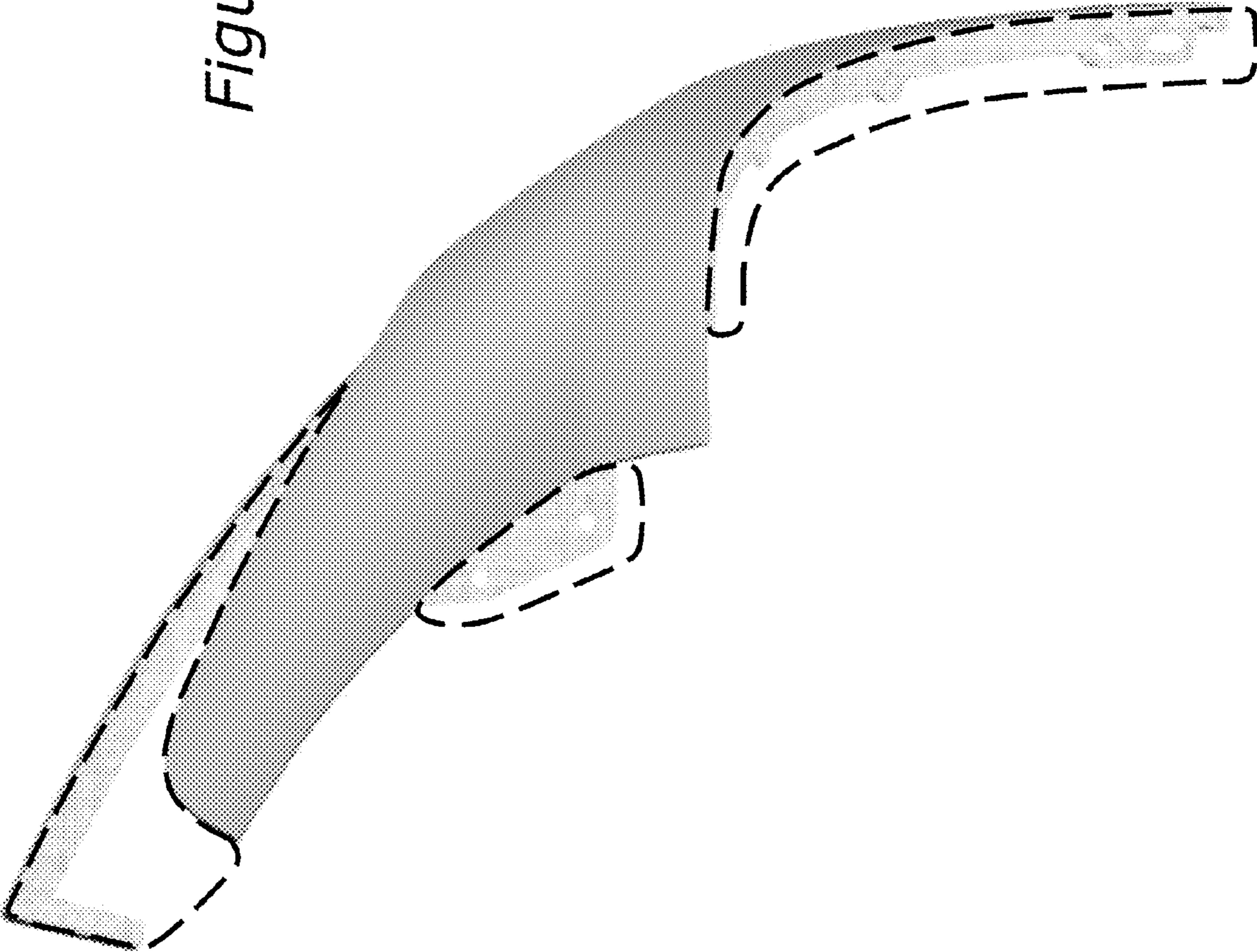

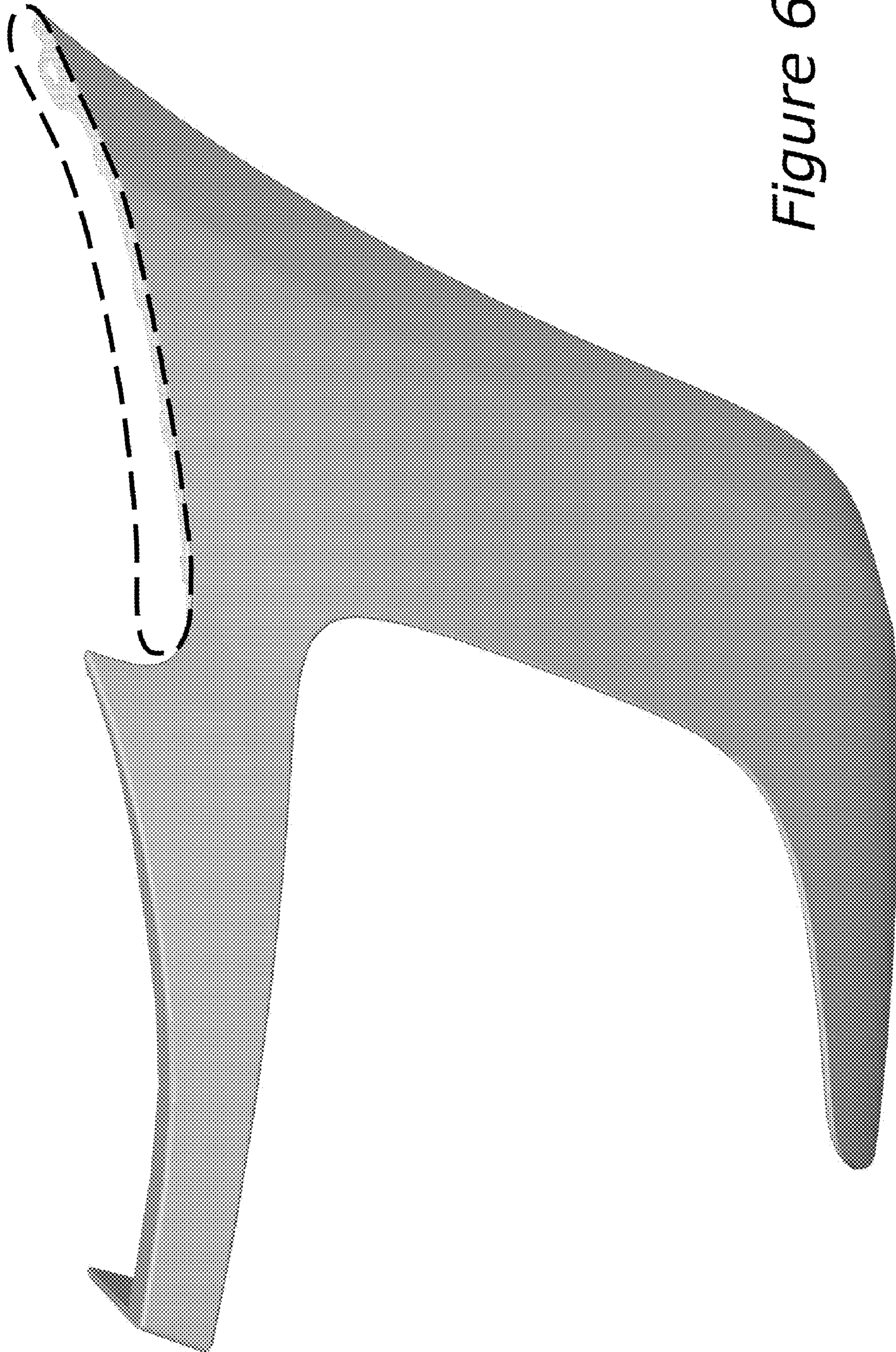
