(57) **CLAIM**

The ornamental design for tire, as shown and described.

DESCRIPTION

FIG. 1 is left side elevational view of the tire and tread (the right side being a mirror image thereof);

FIG. 2 is an enlarged portion of the left side elevational view of FIG. 1 taken along portion 2—2;

FIG. 3 is a top plan view; and,

FIG. 4 is an enlarged portion of the top plan view of FIG. 3 taken along portion 4—4 (it being understood that the tread pattern repeats uniformly throughout the circumference of the tread).

The broken lines in FIGS. 1-2 are for the purpose of illustrating indicia located on the tire and form no part of the claimed design.

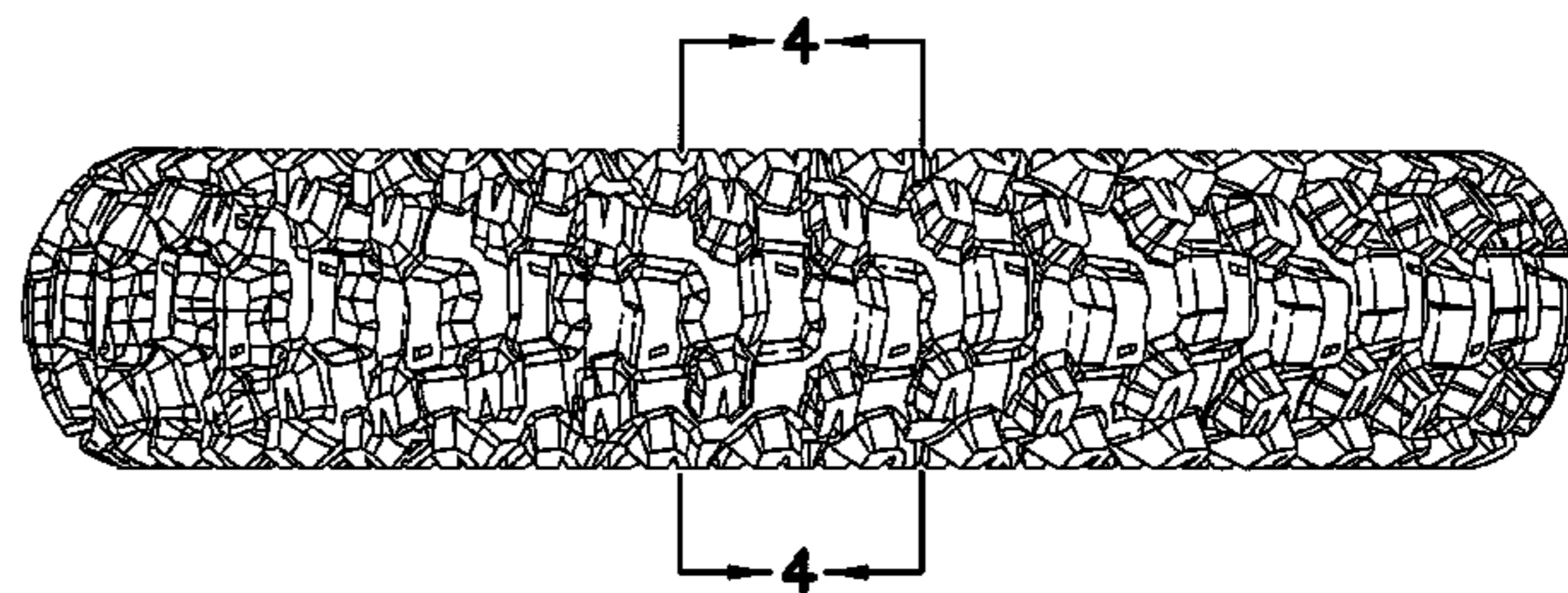
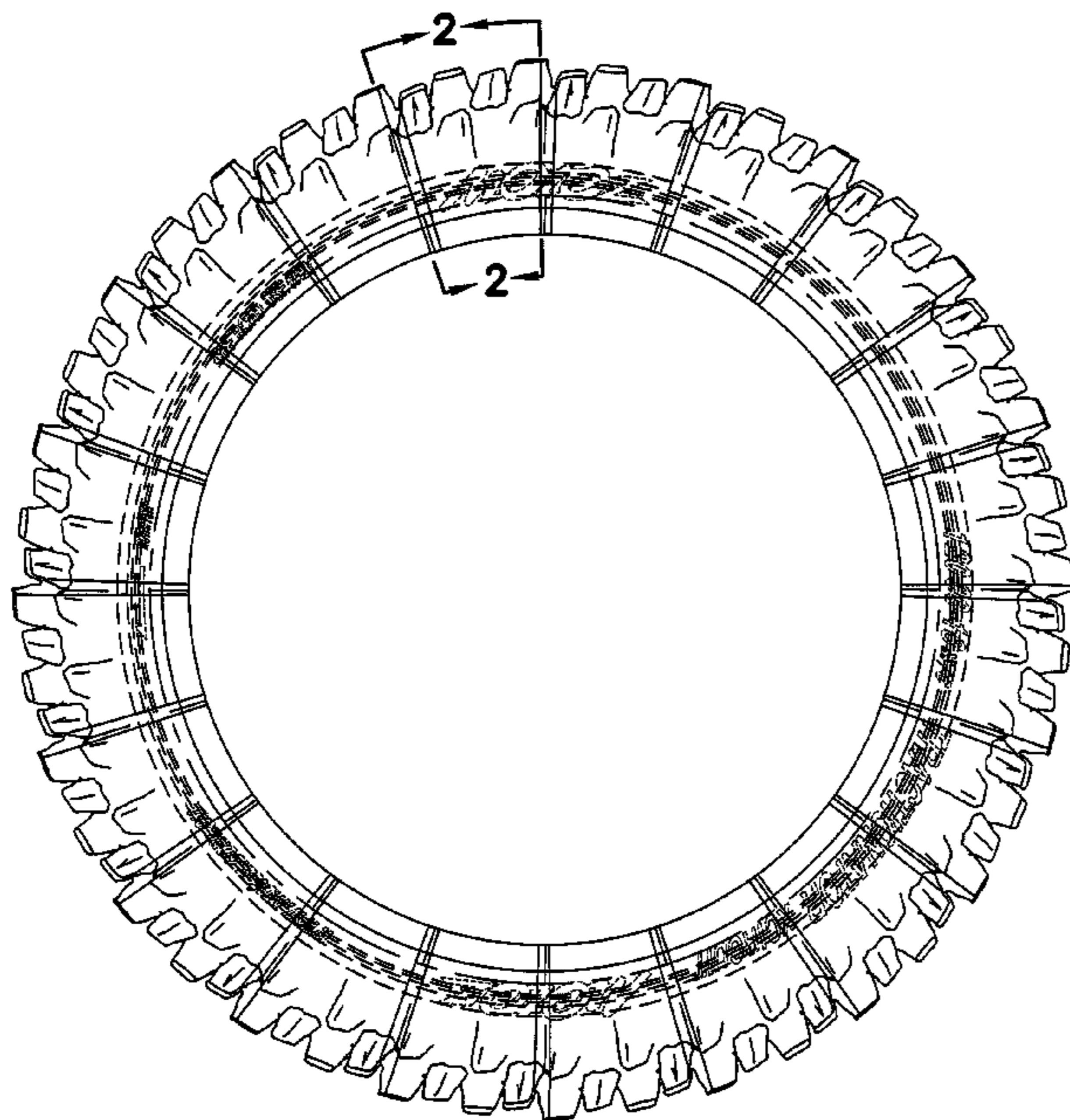

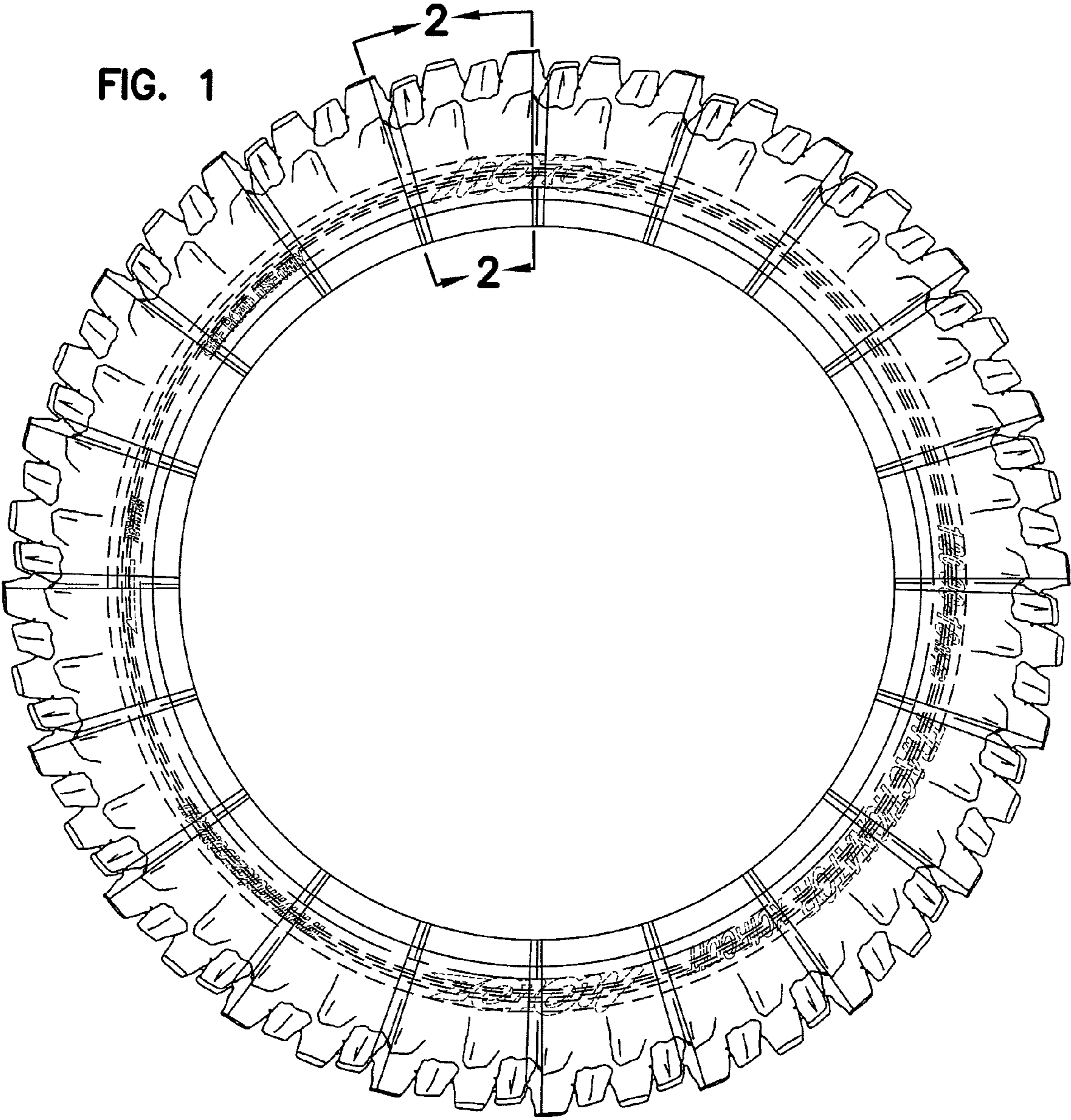

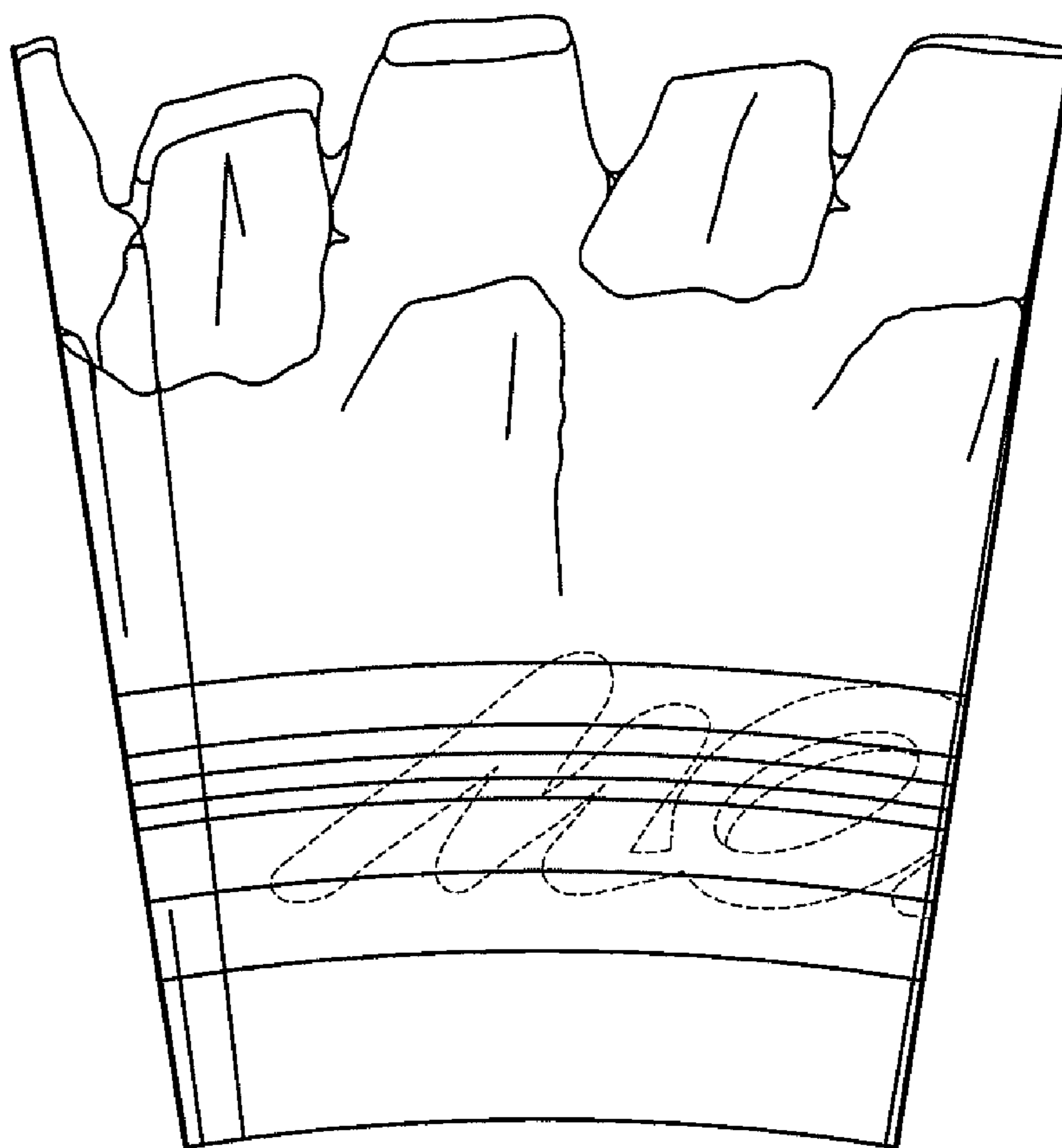

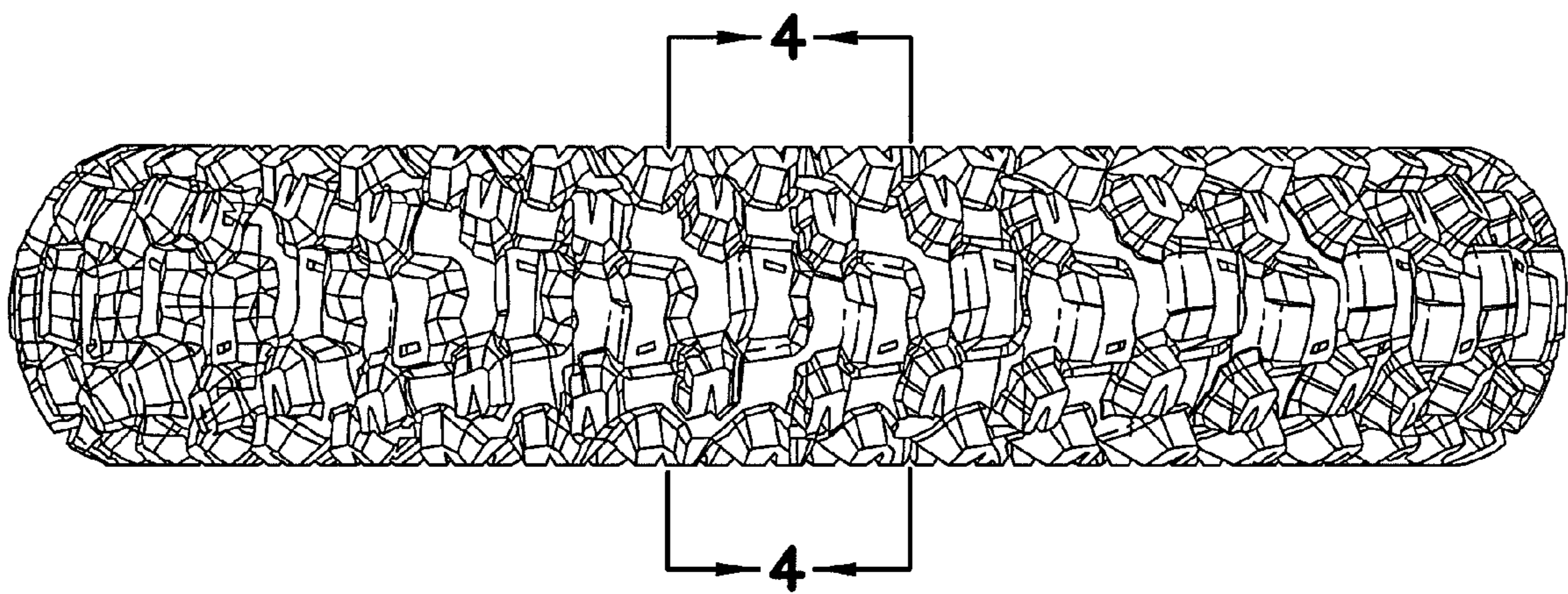
