The ornamental design for an embossing for a sanitary article with embossing, as shown and described.

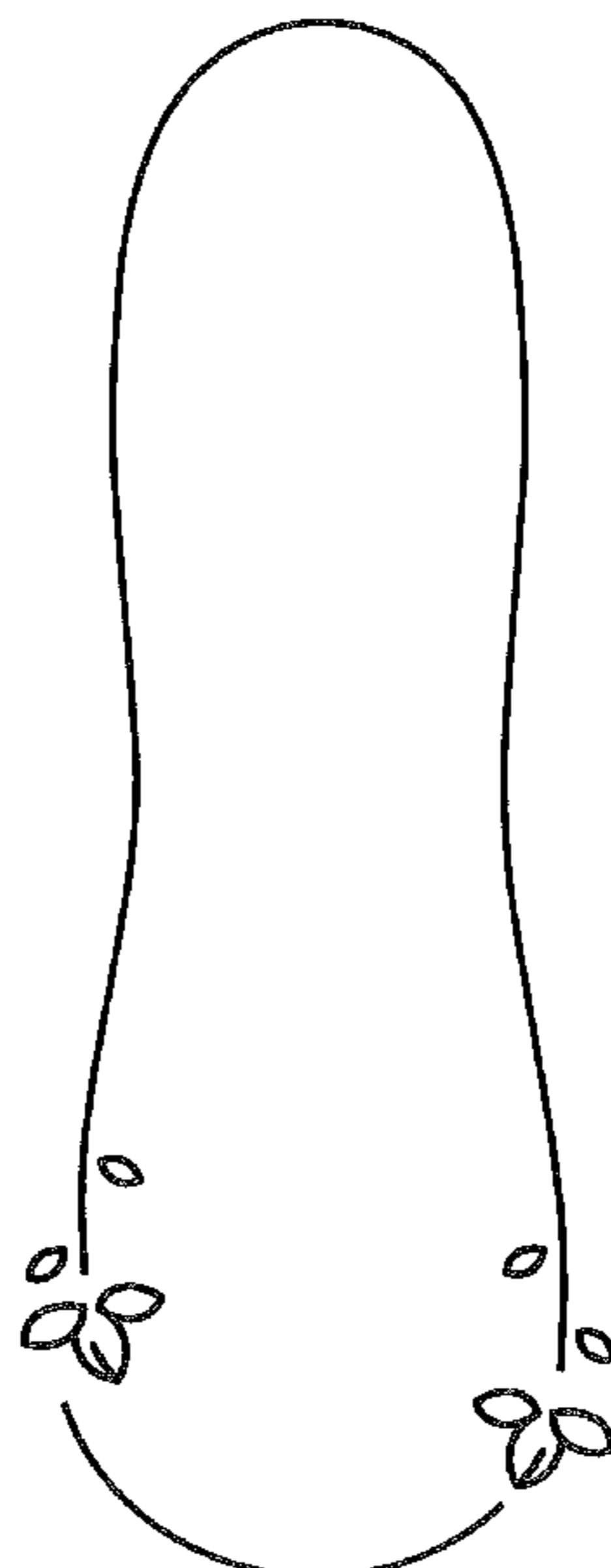
**DESCRIPTION**

FIG. 1 is a top plan view of an embossing for a sanitary article with embossing showing our new design according to a first embodiment; and,

FIG. 2 is a top plan view of an embossing for a sanitary article with embossing showing our new design according to a second embodiment.

The broken lines showing dots in FIG. 2 are for environmental purposes only and do not form any part of the claimed design.

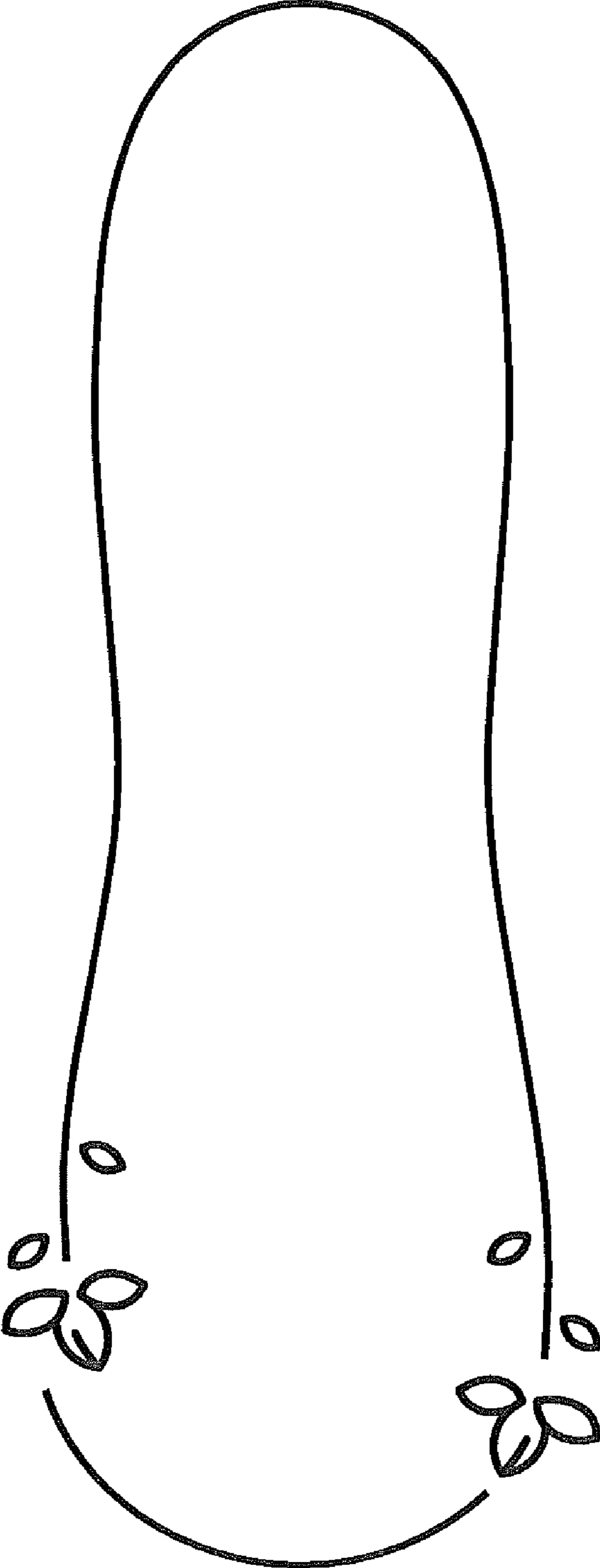

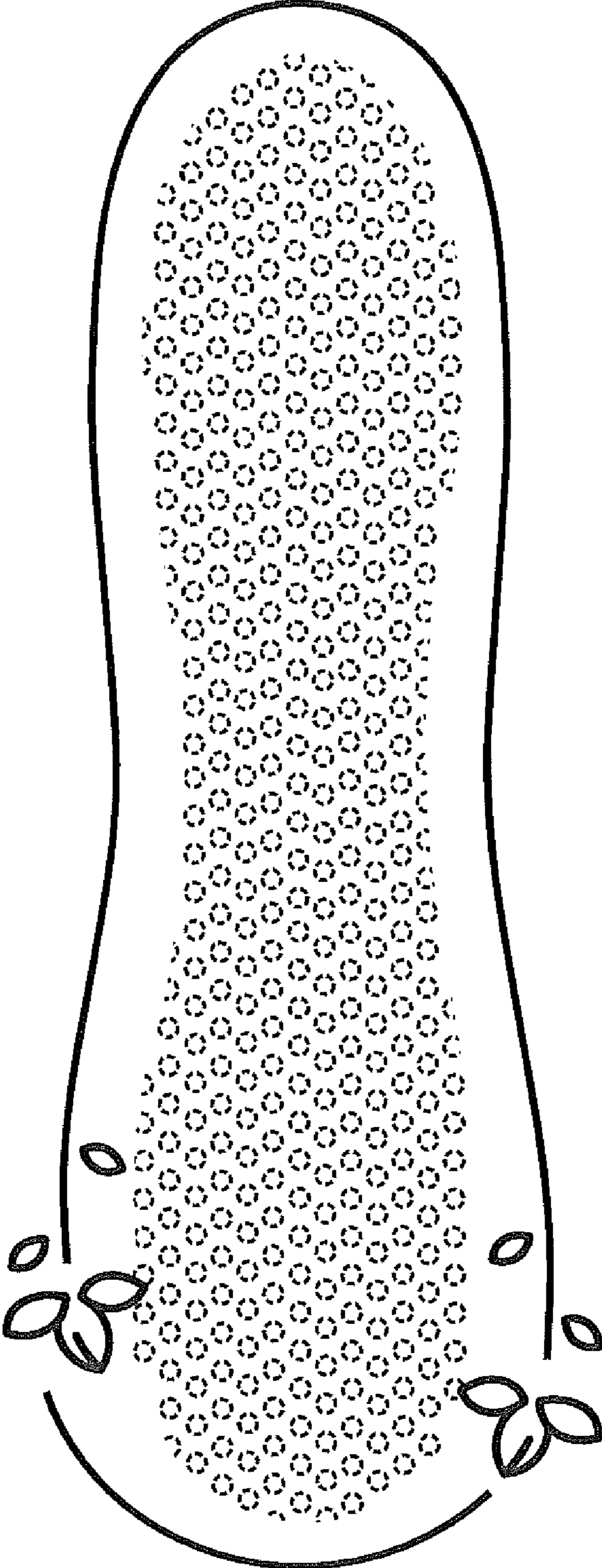
