FIG. 3 is a front elevational view thereof;

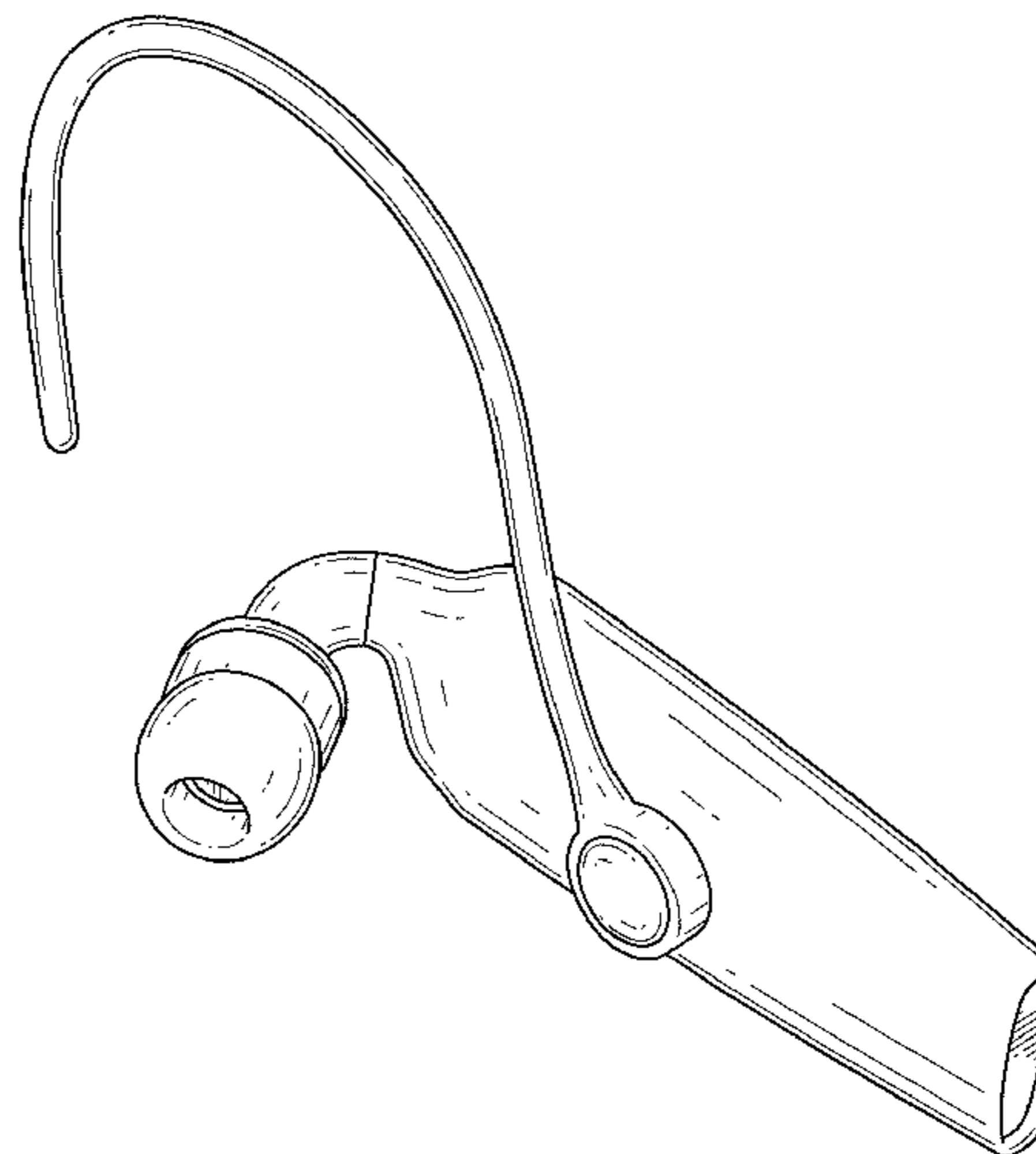
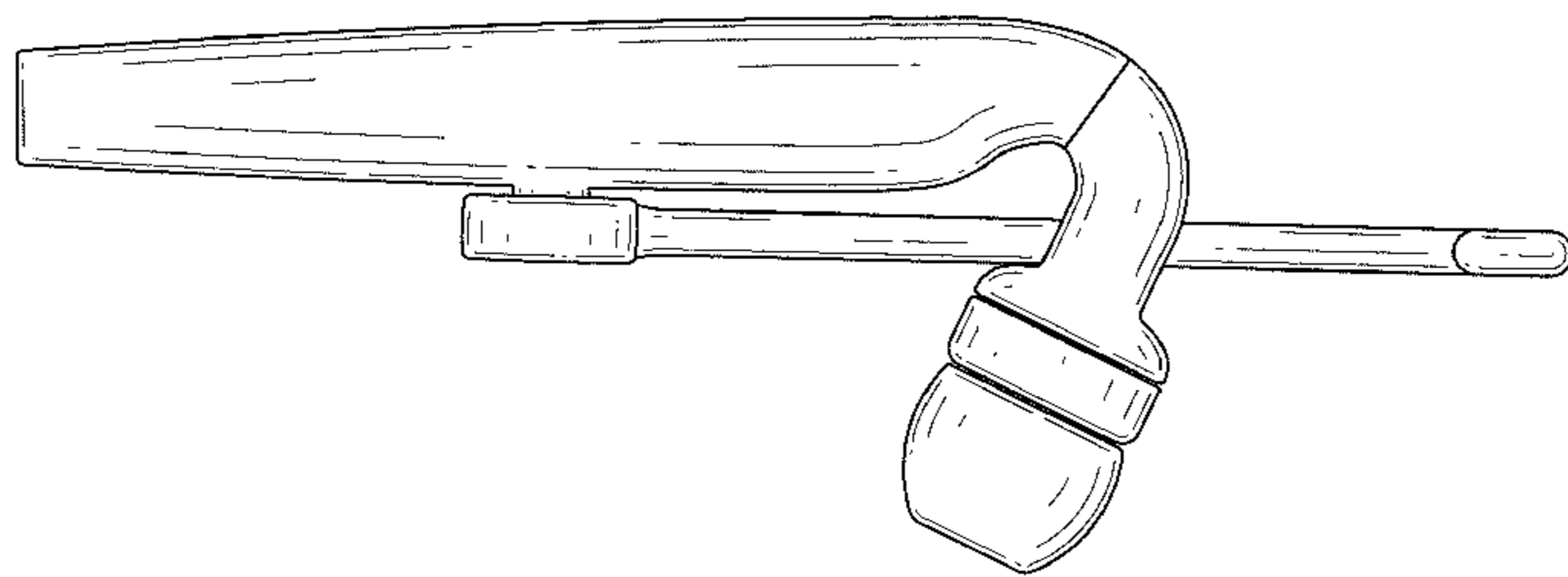
FIG. 4 is an elevated front, right perspective view thereof;

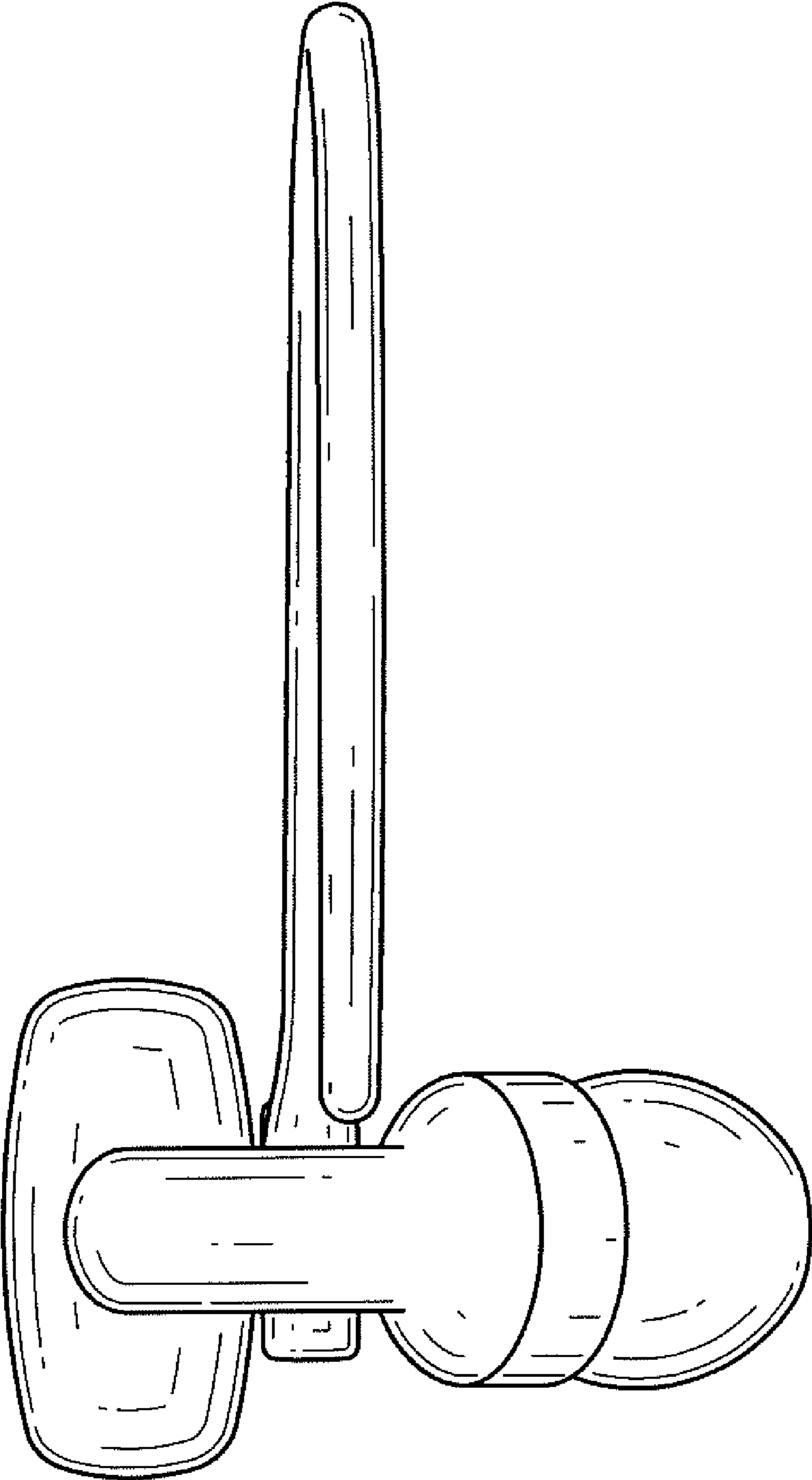

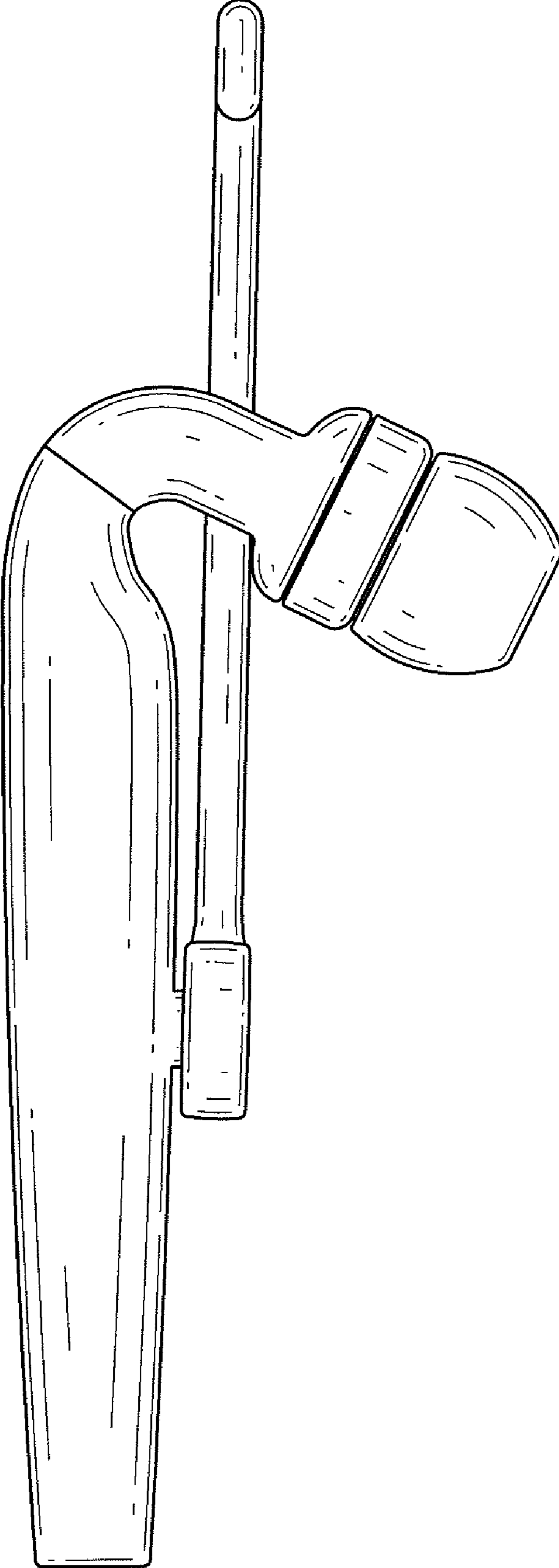

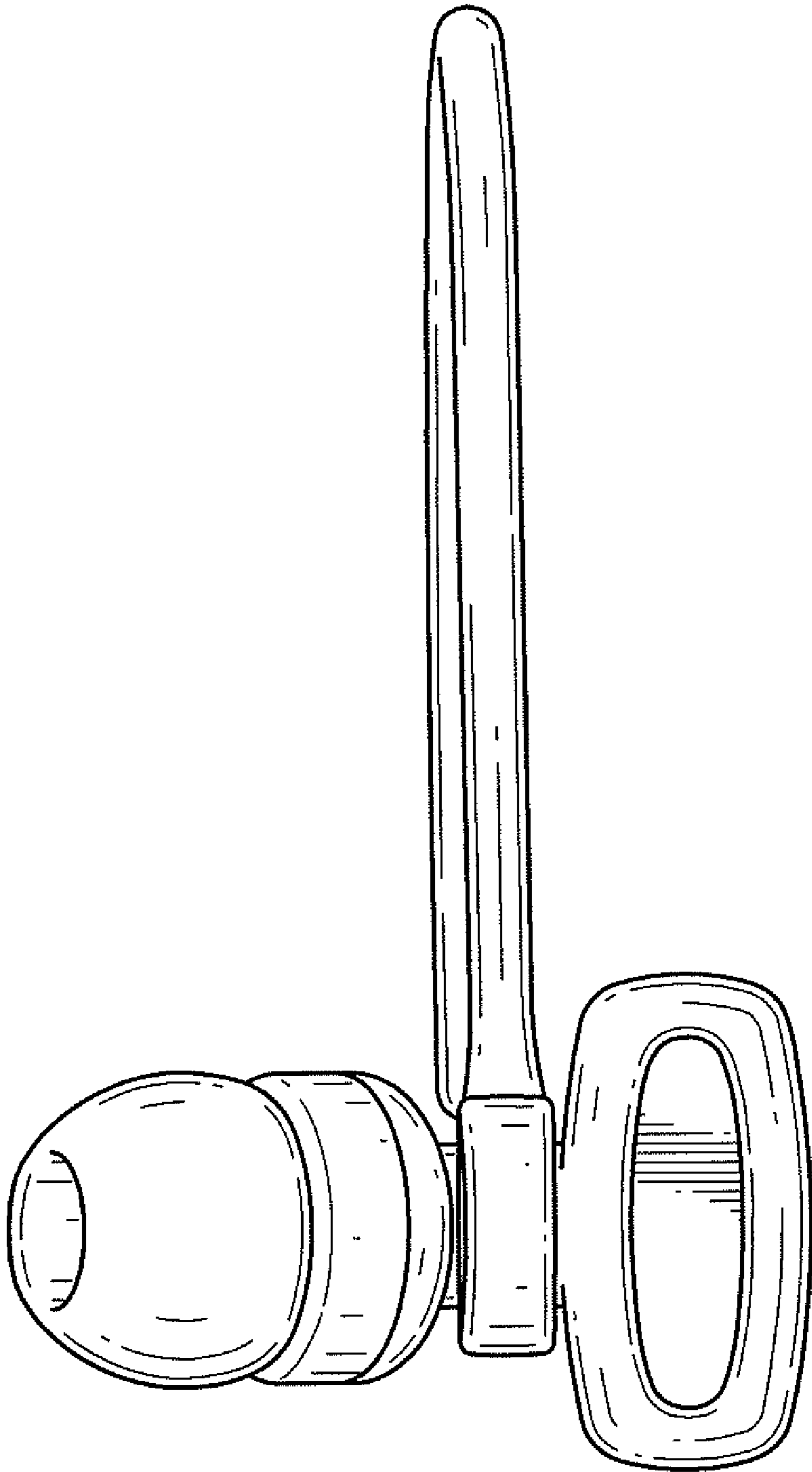

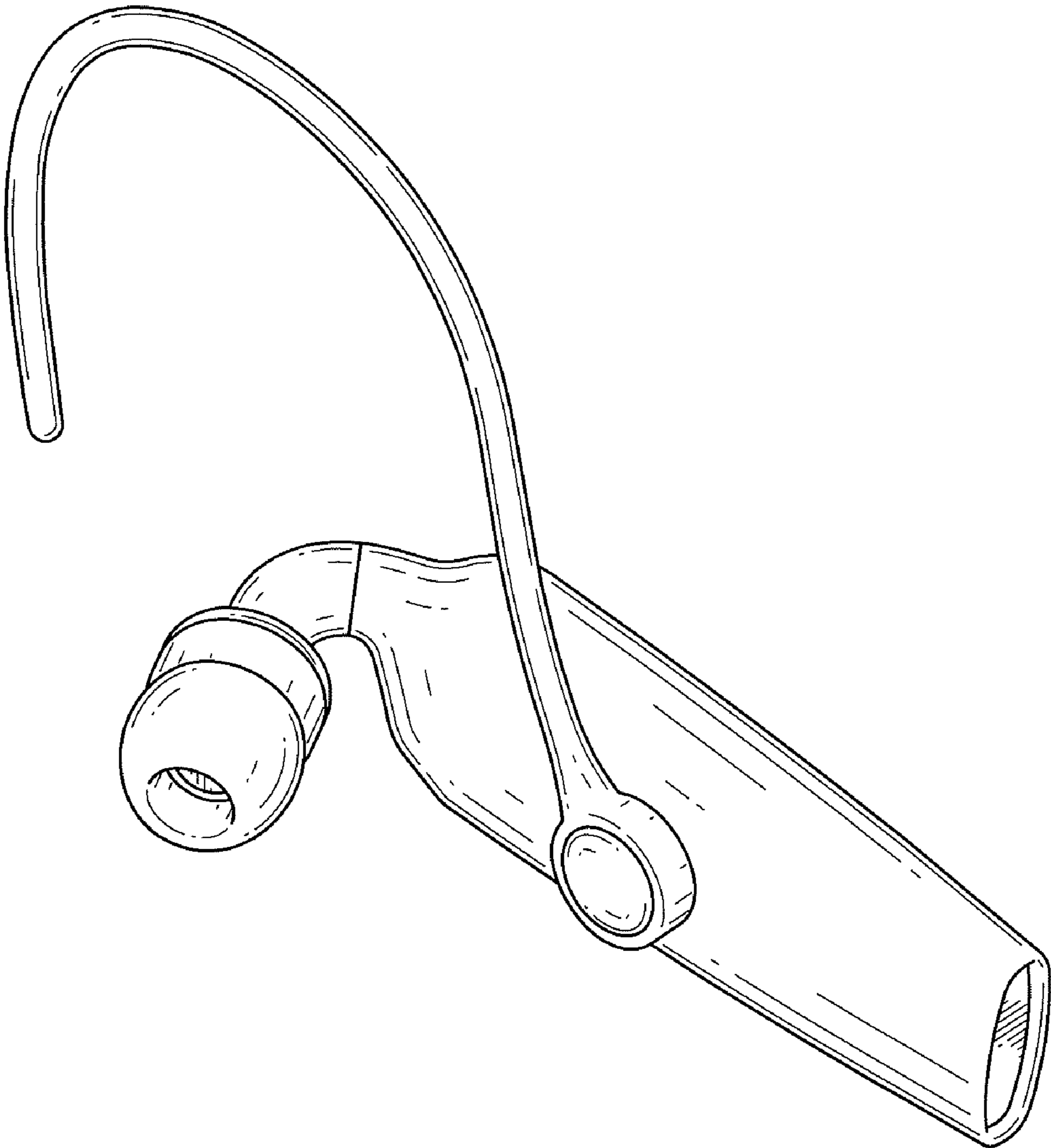

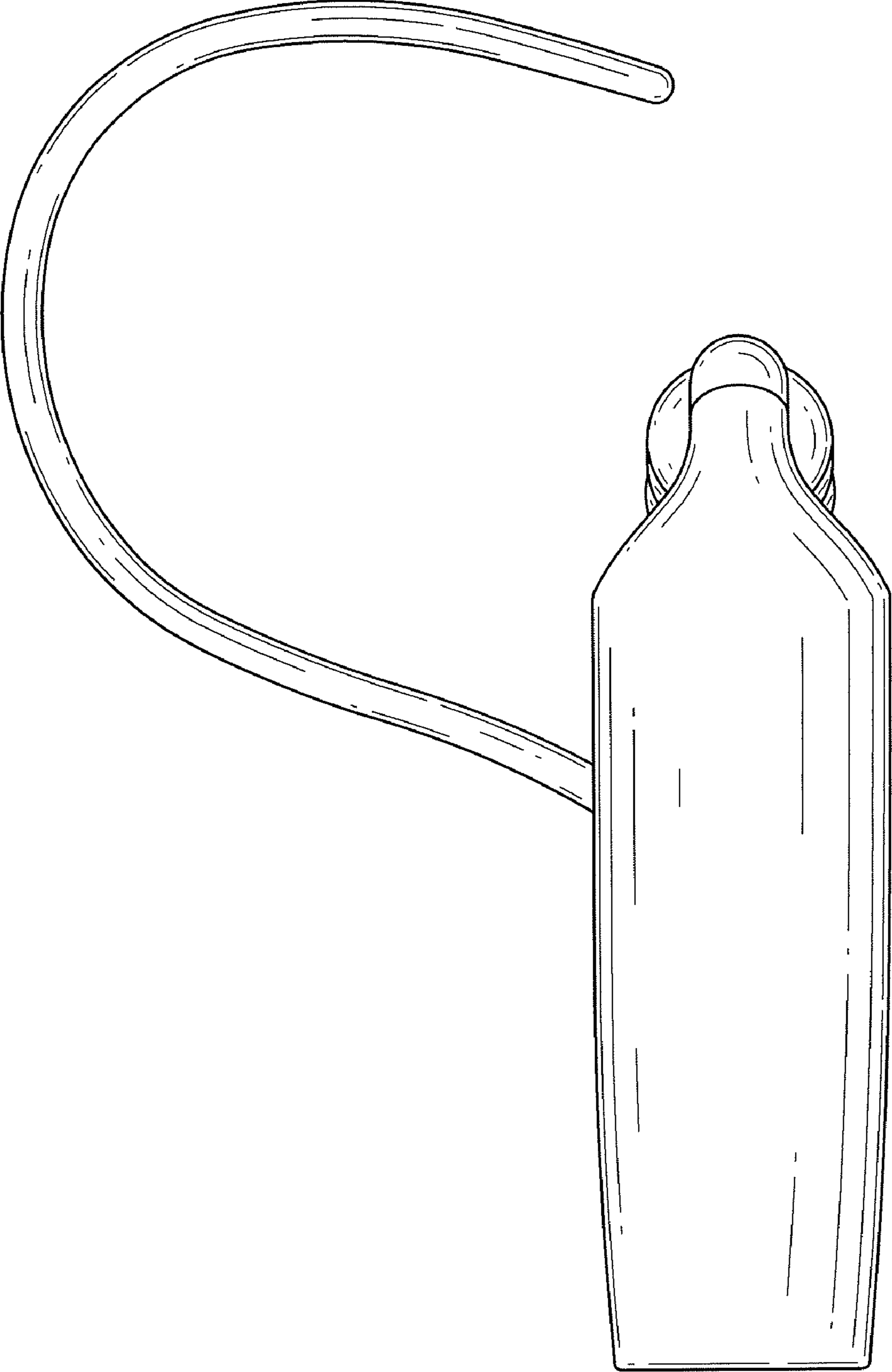

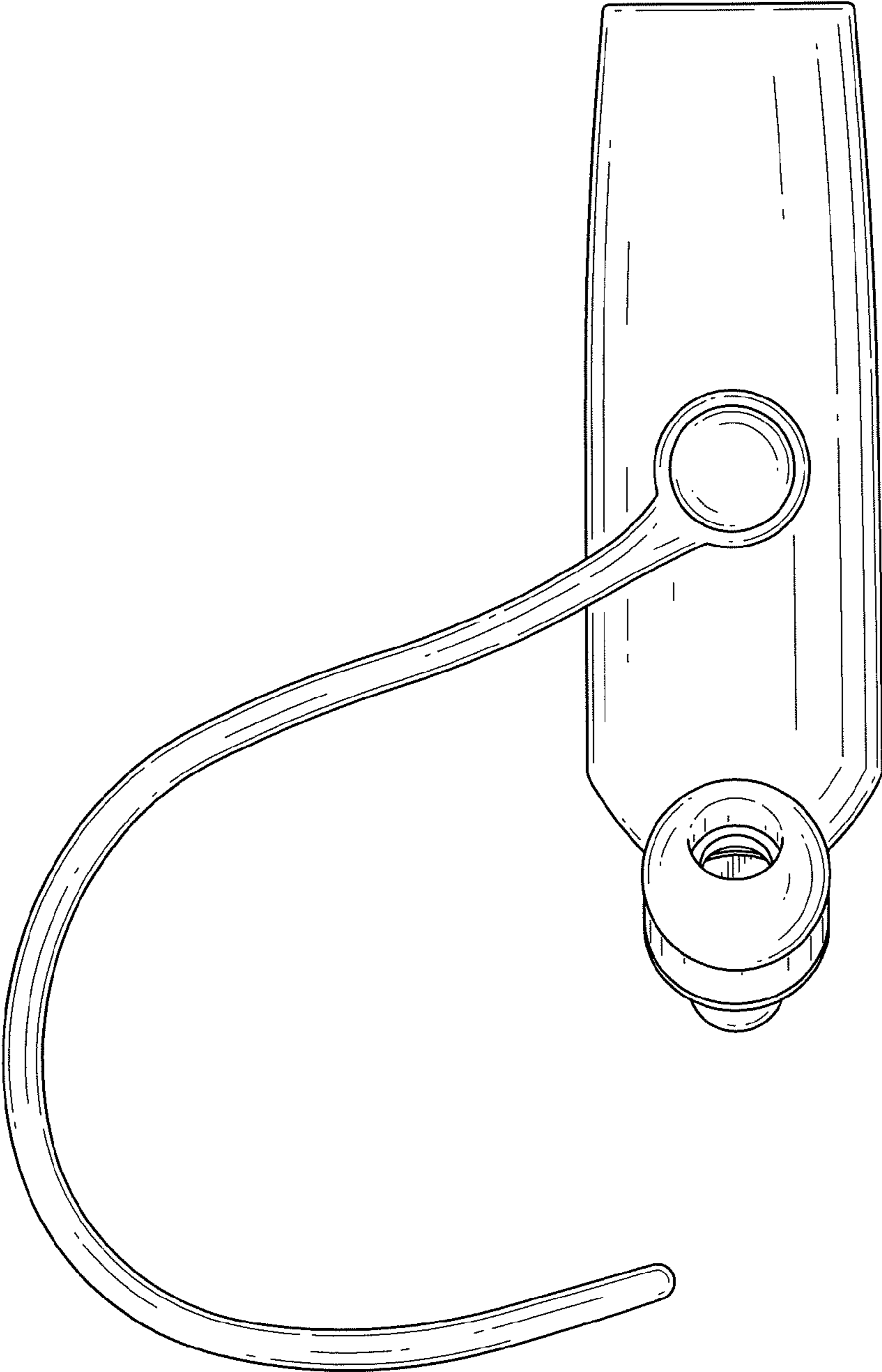

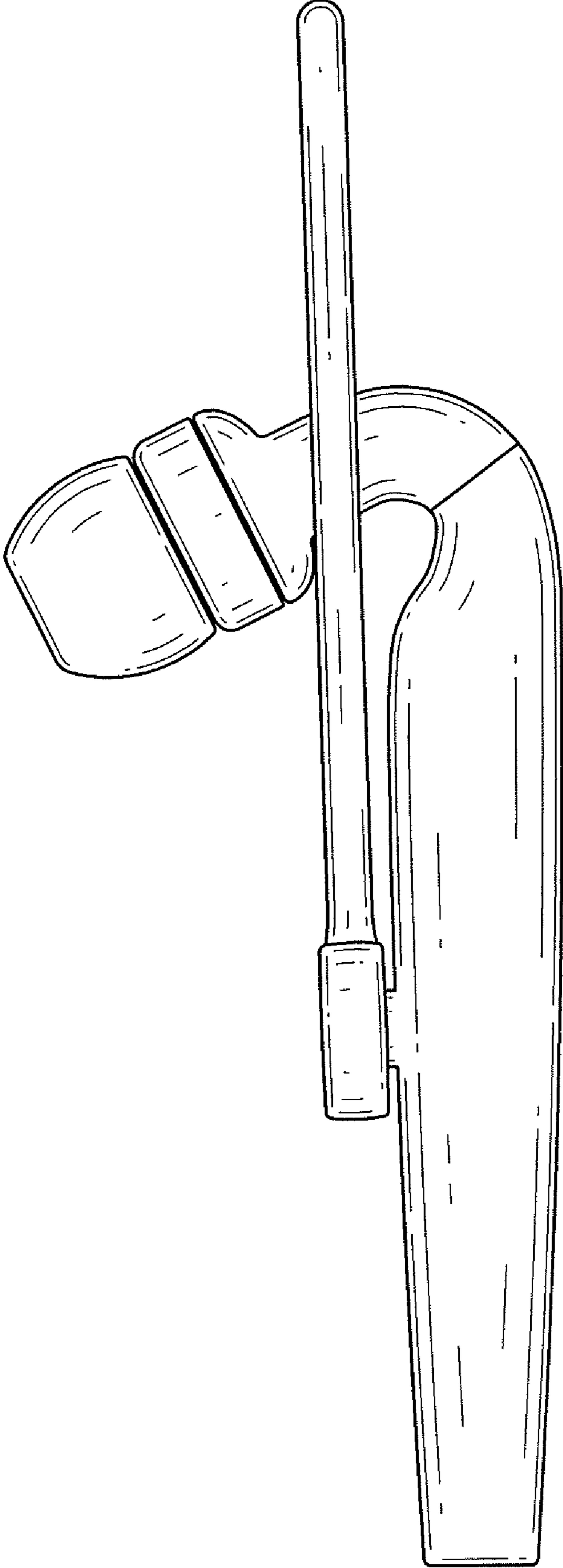
