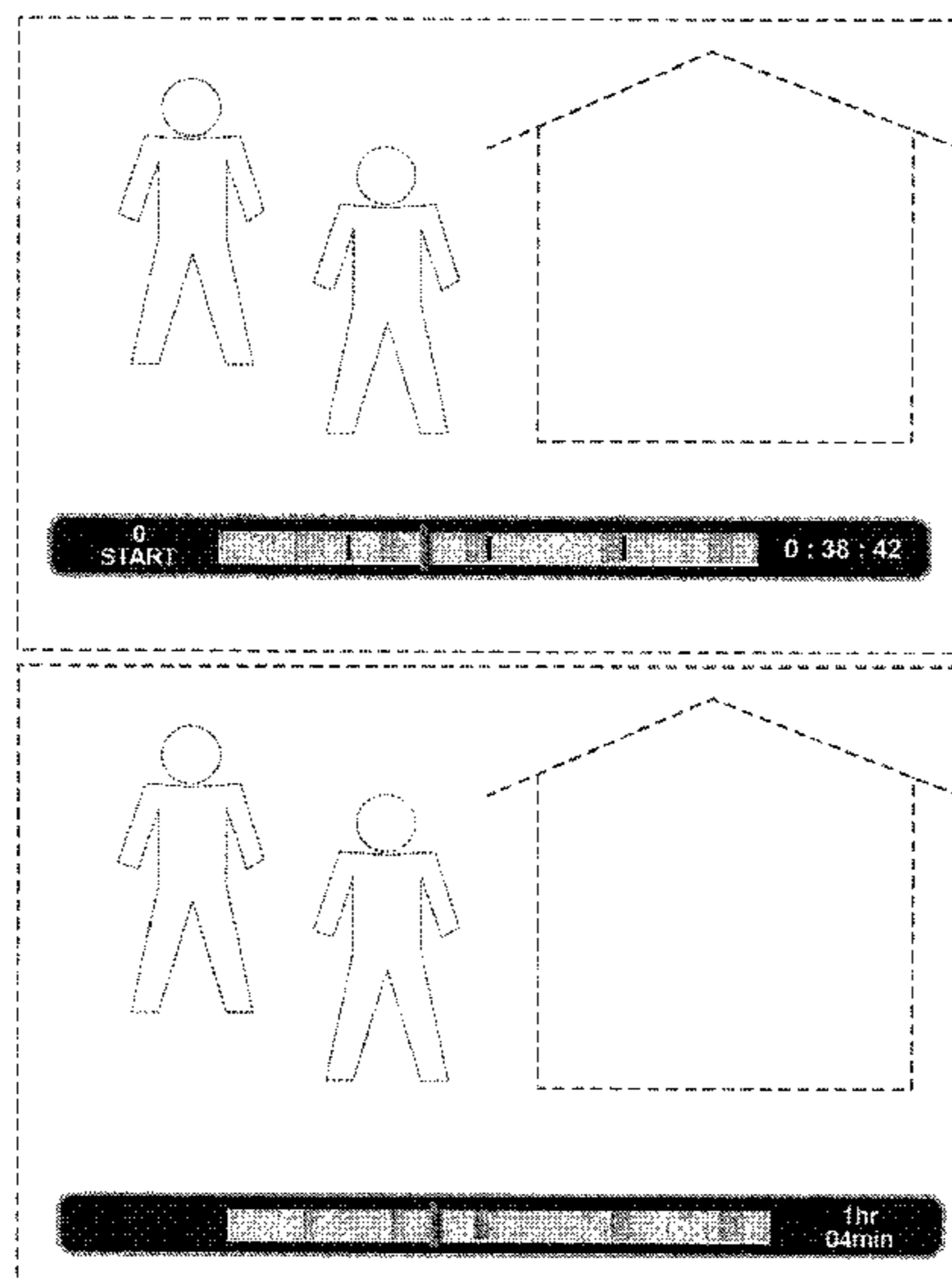
FIG. 5 is a front view of another embodiment of a display screen with progress bar for recorded video showing my new design;

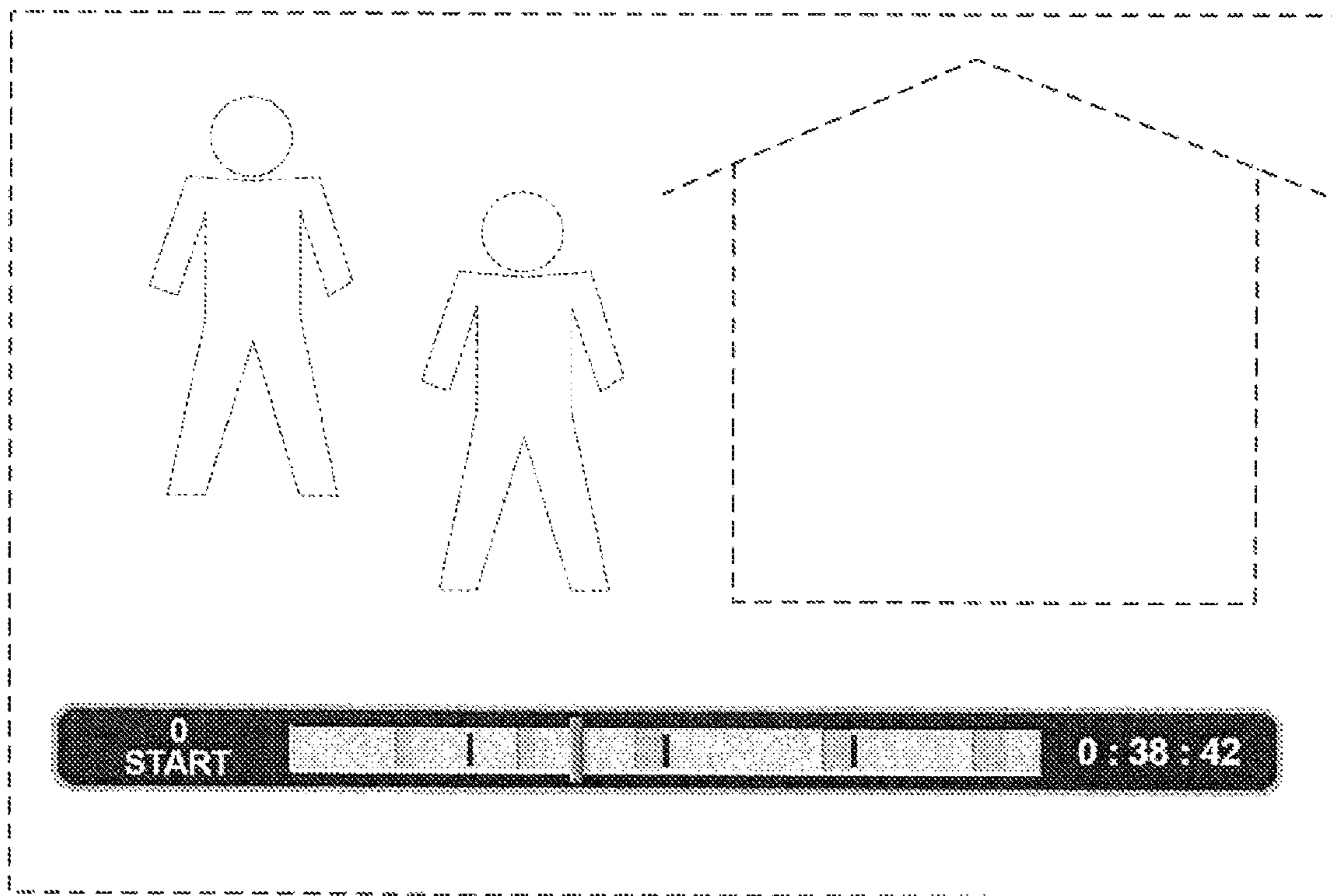

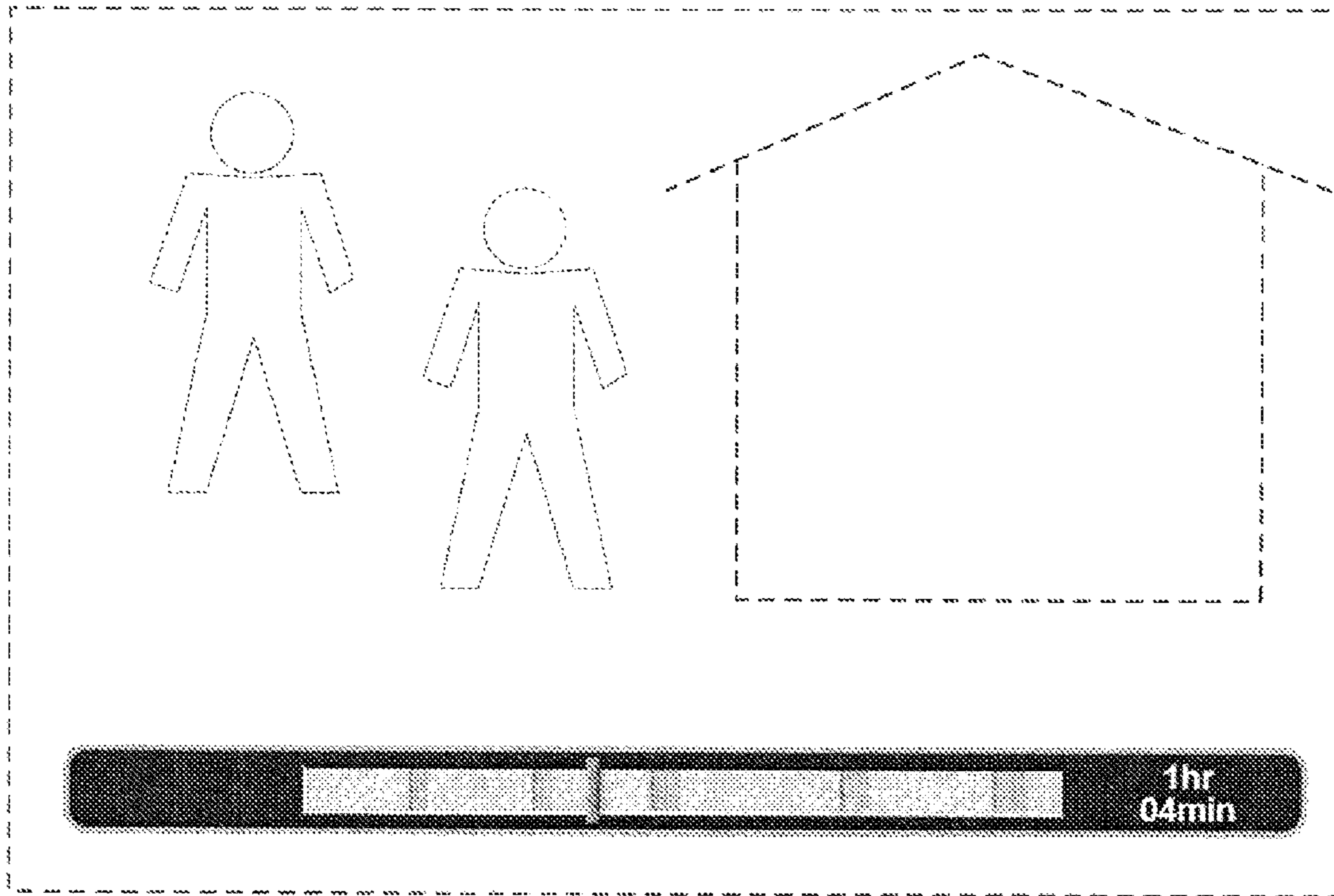

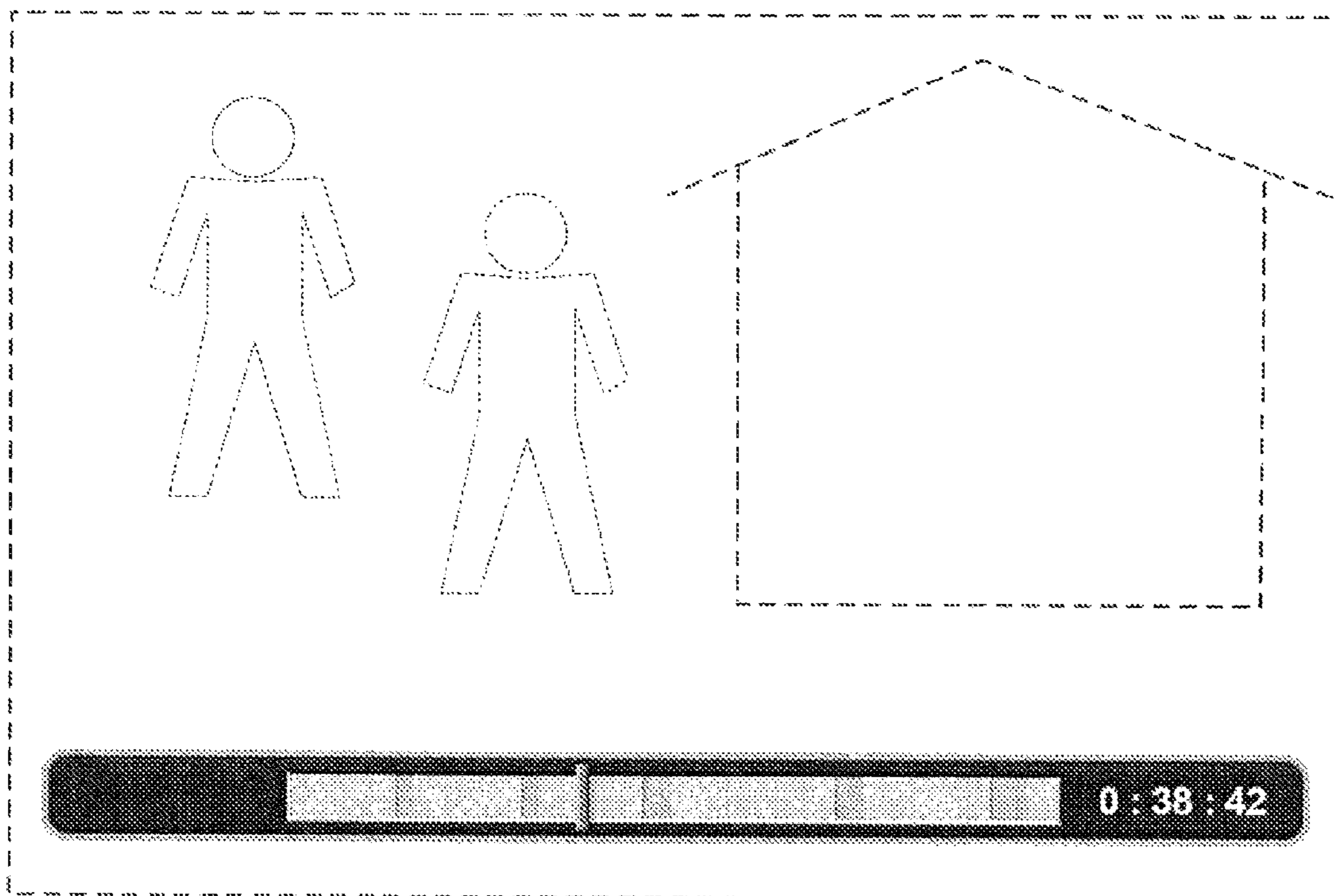

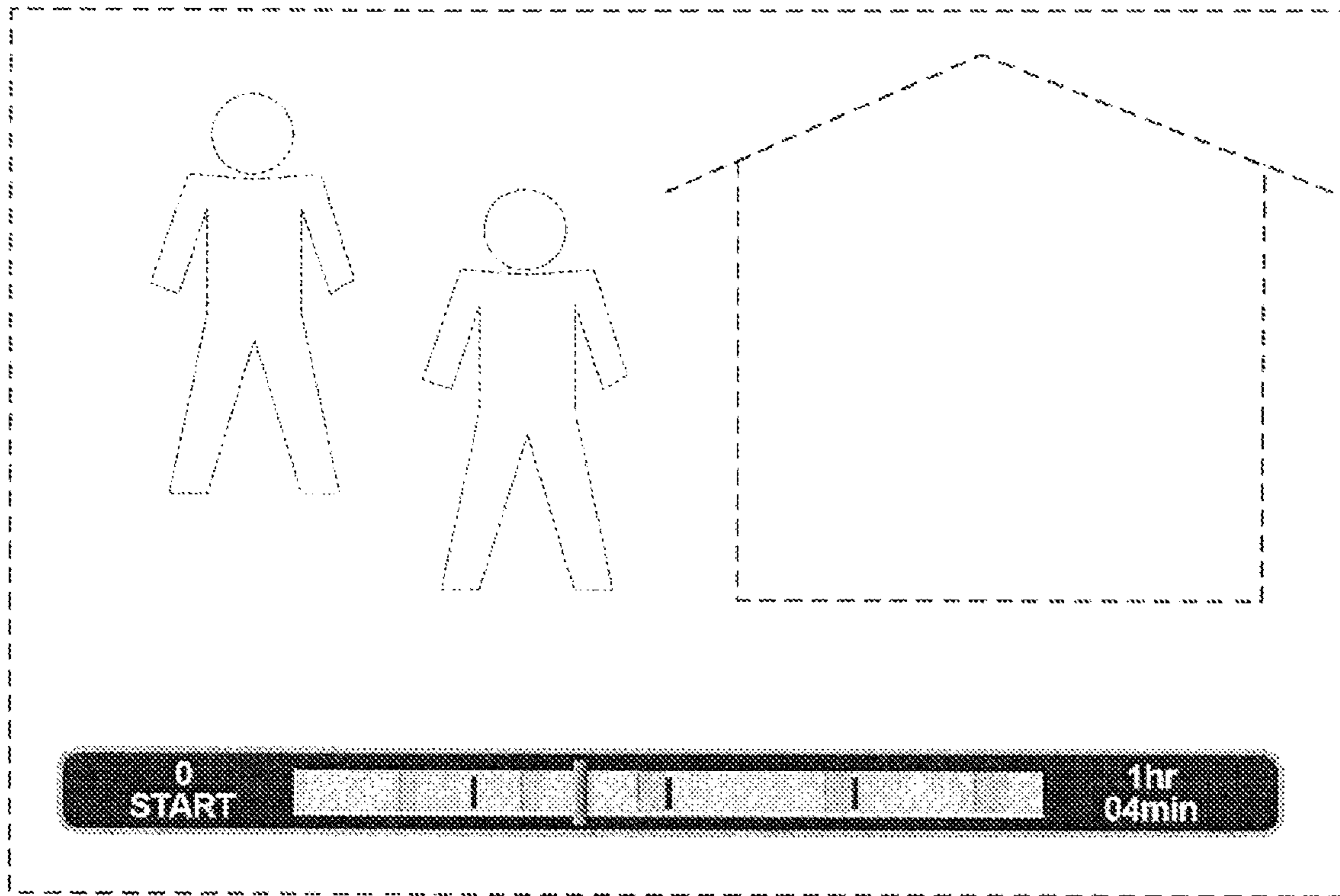

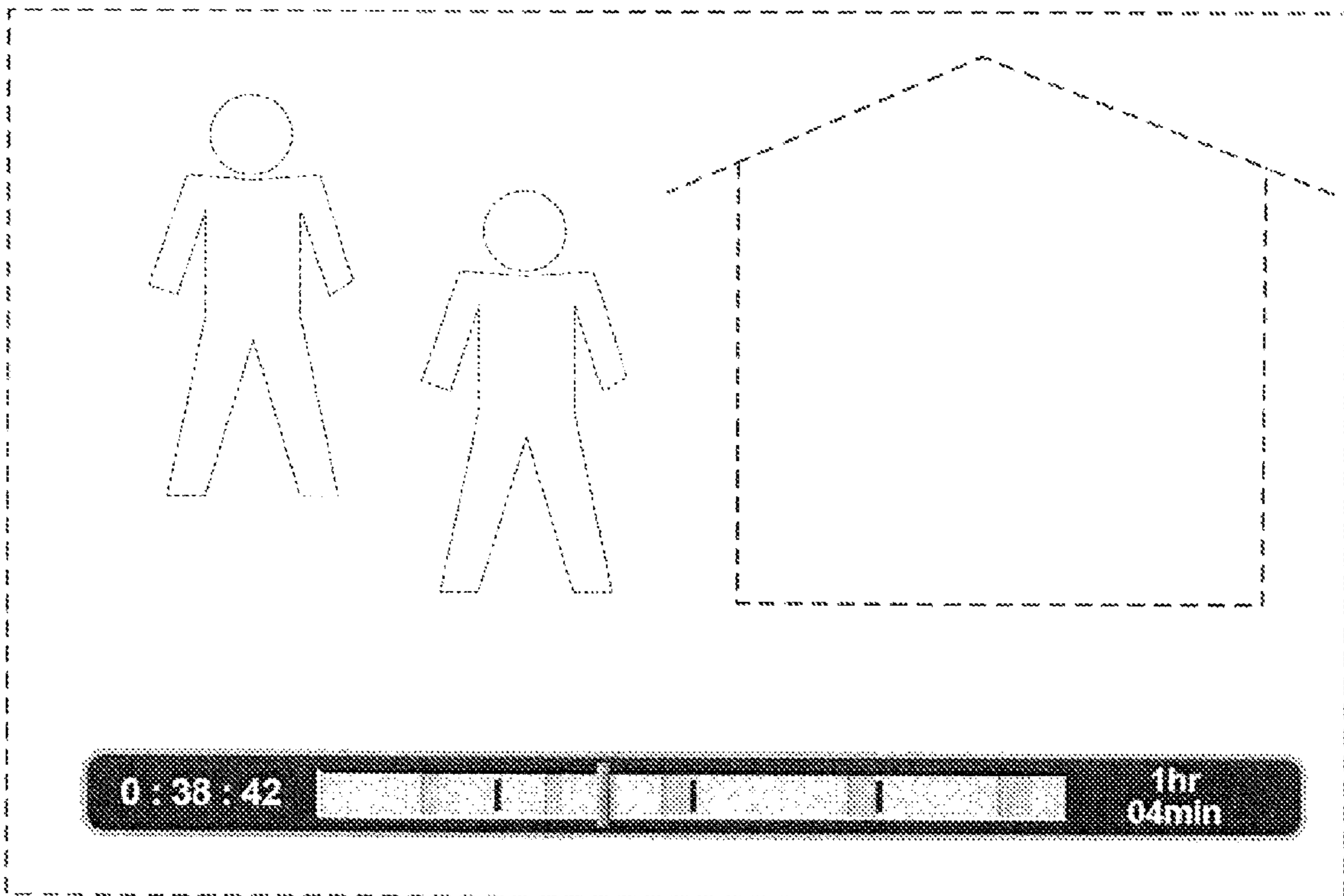

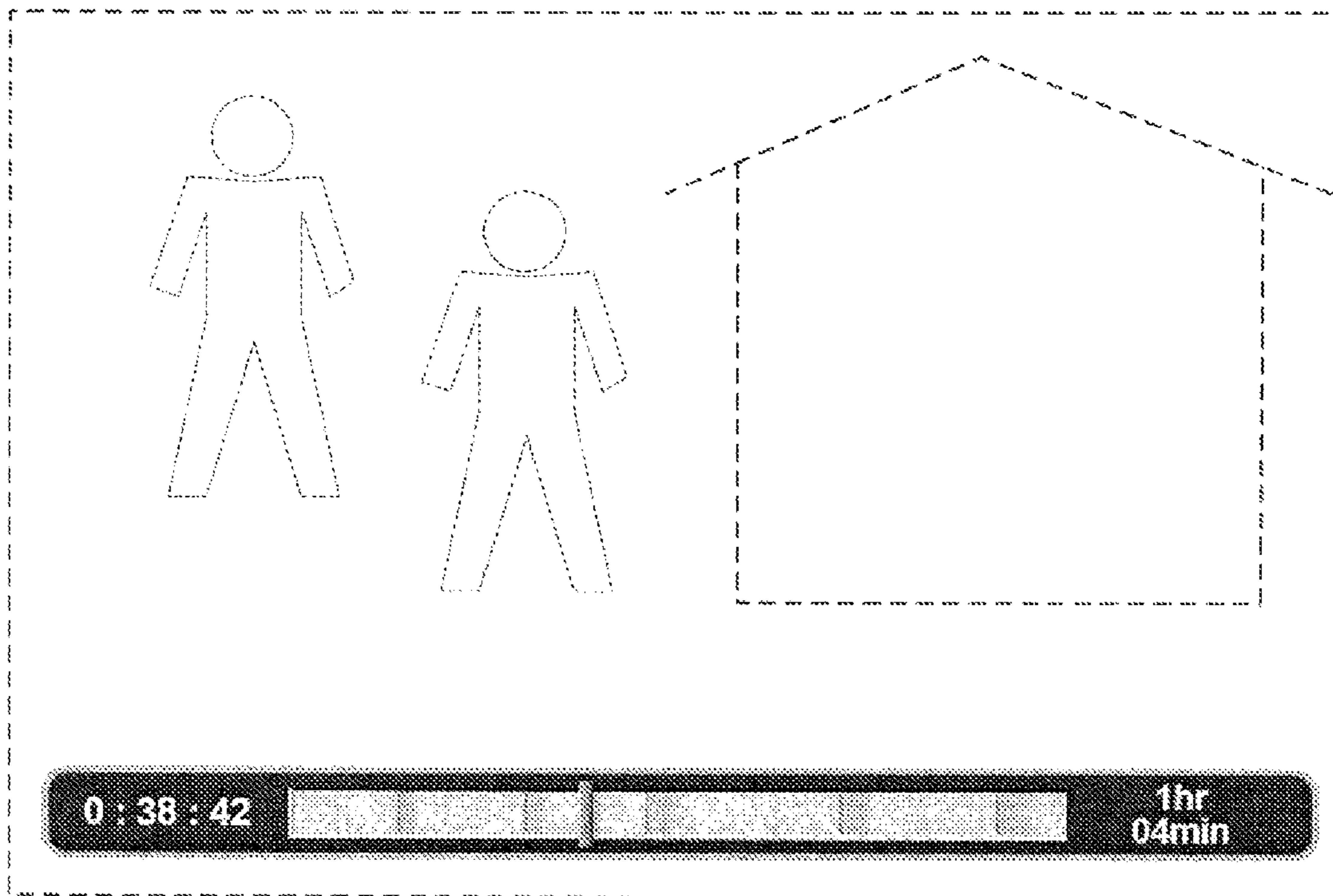

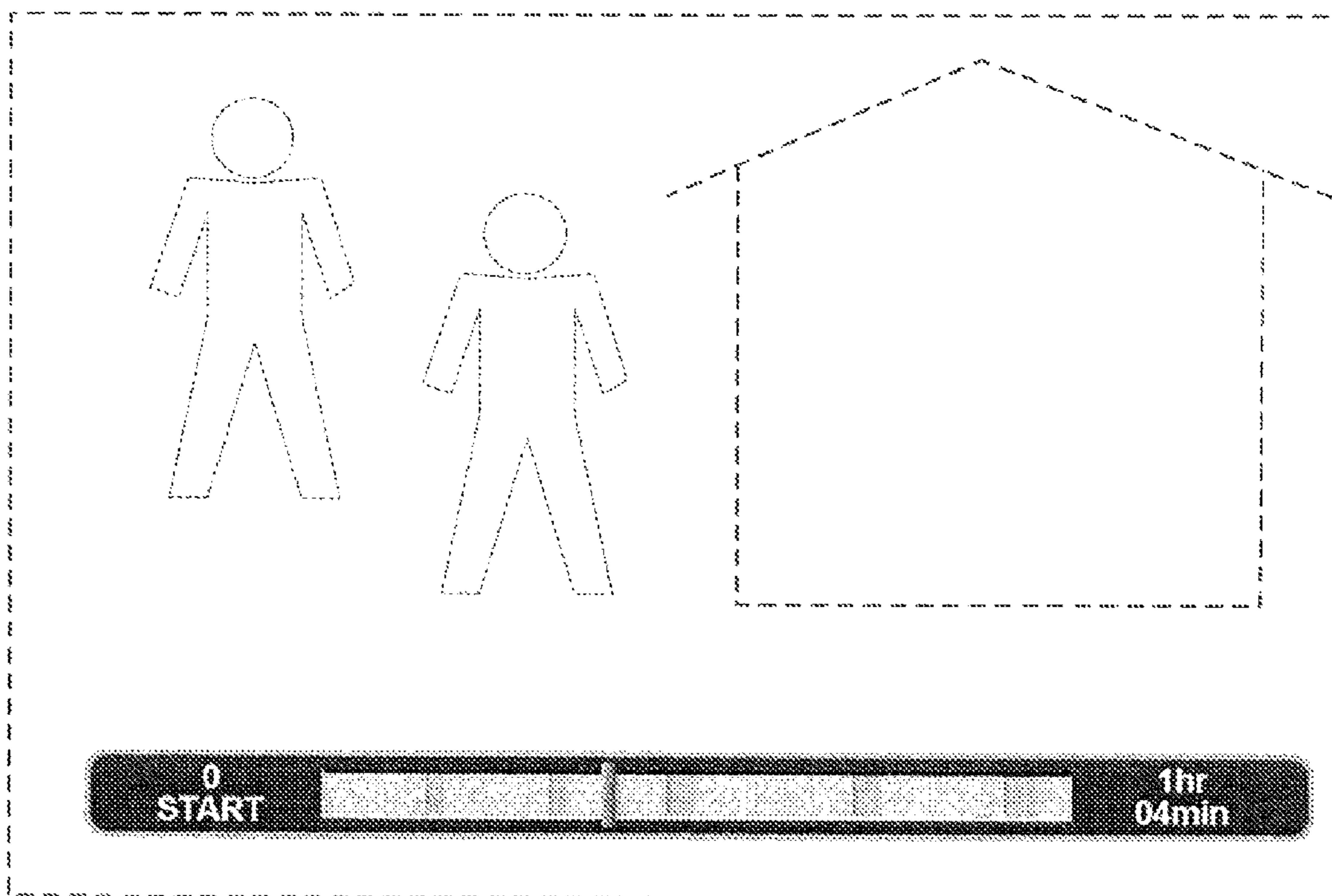
