**DESCRIPTION**

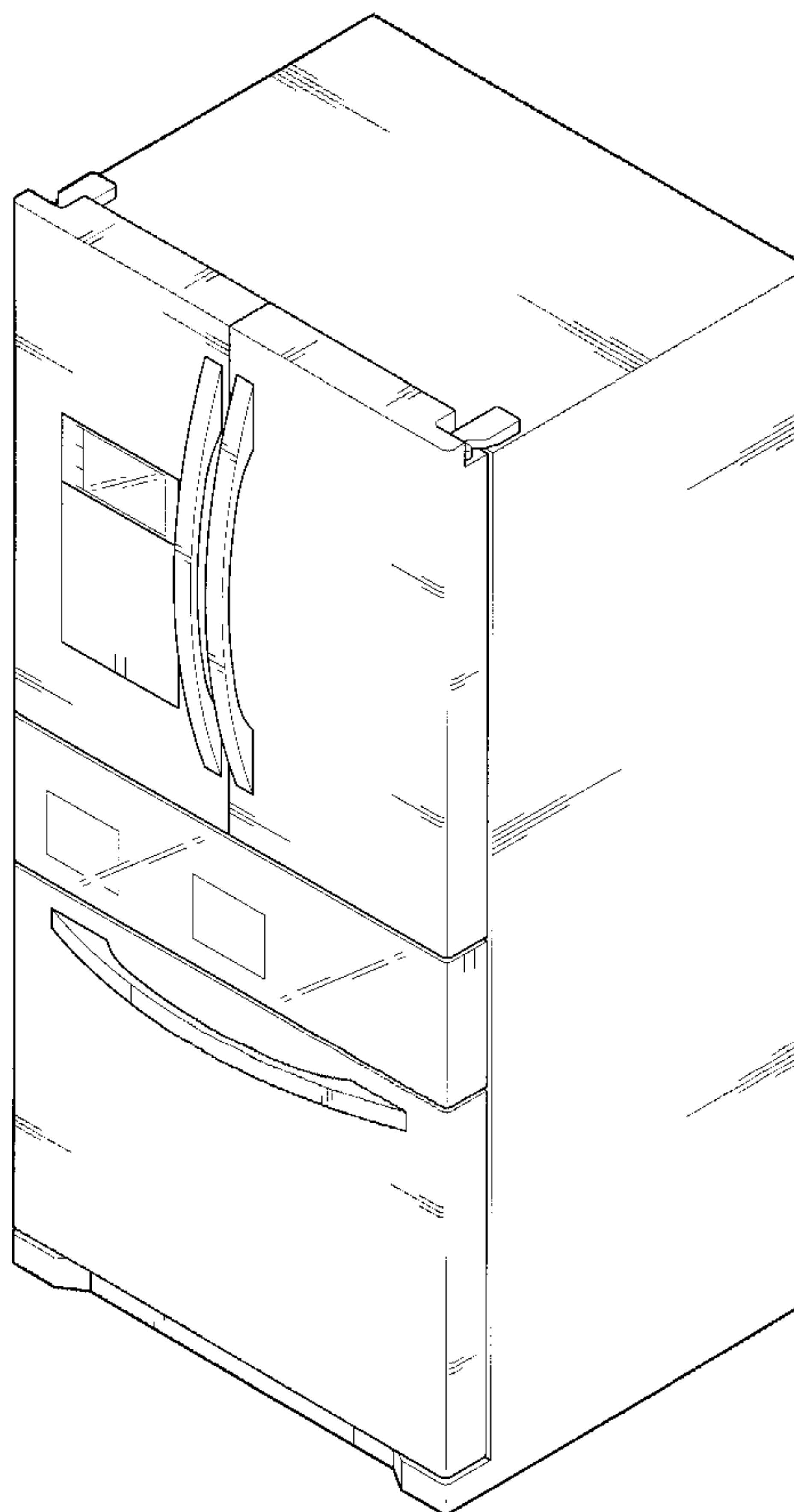

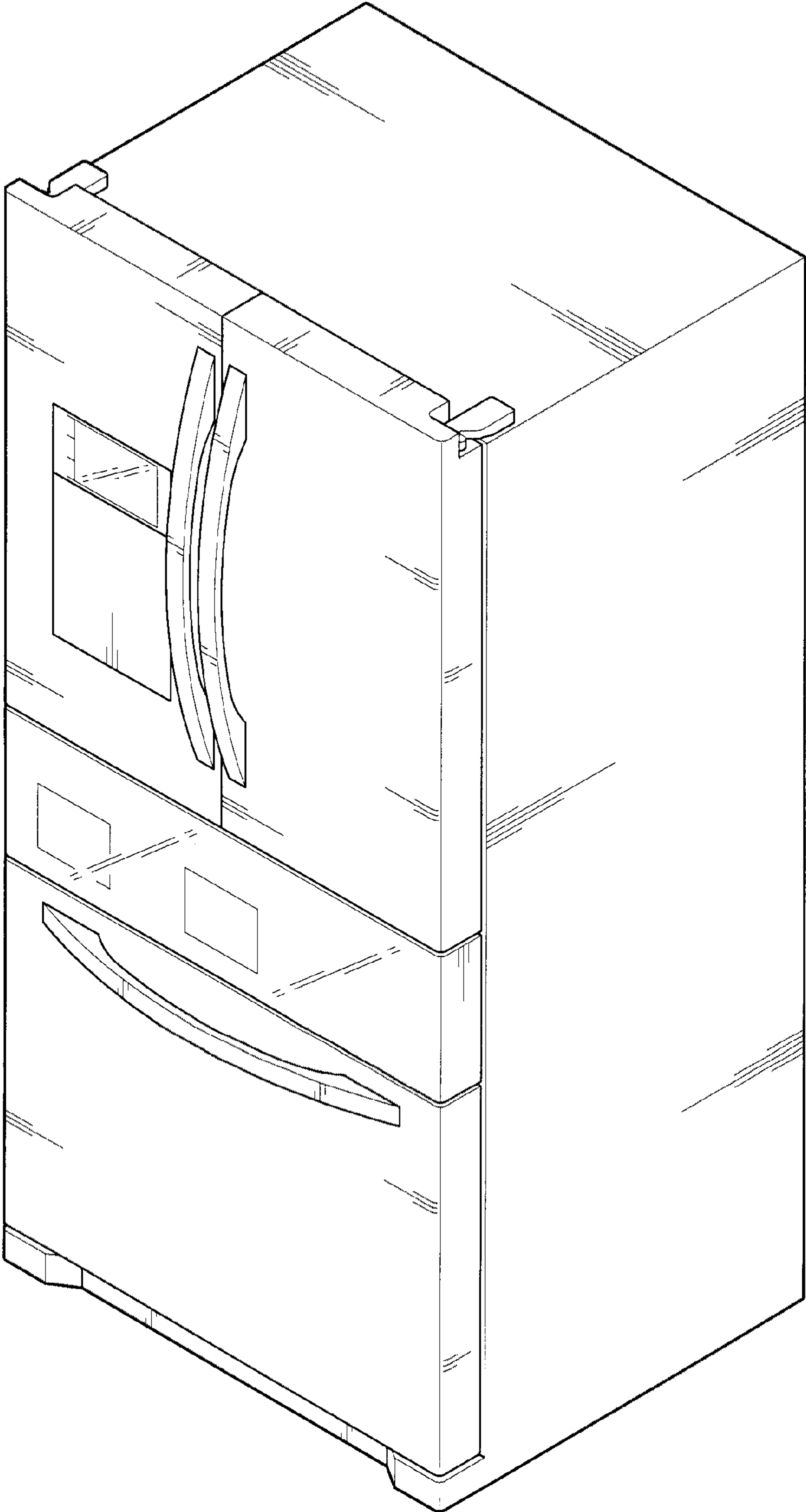

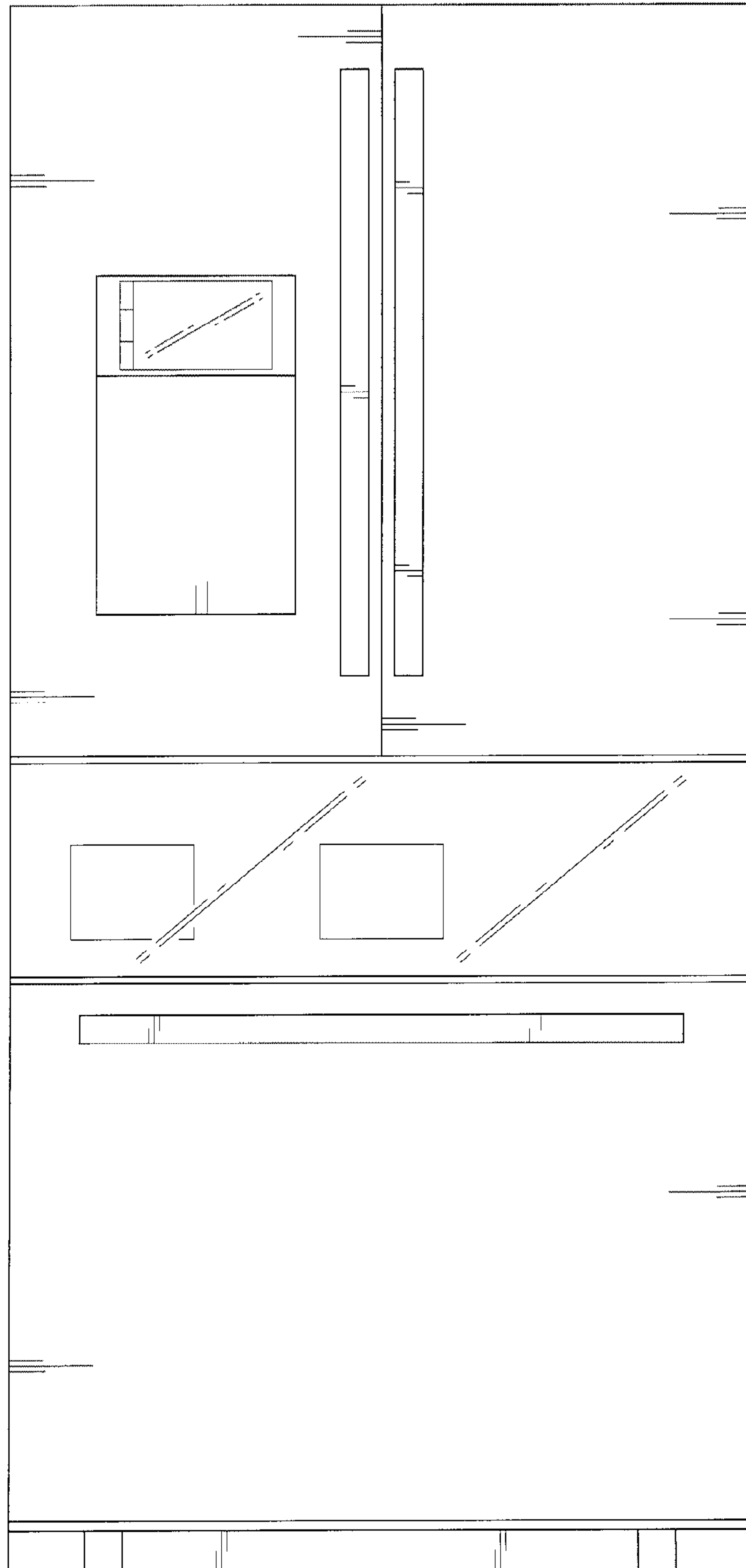

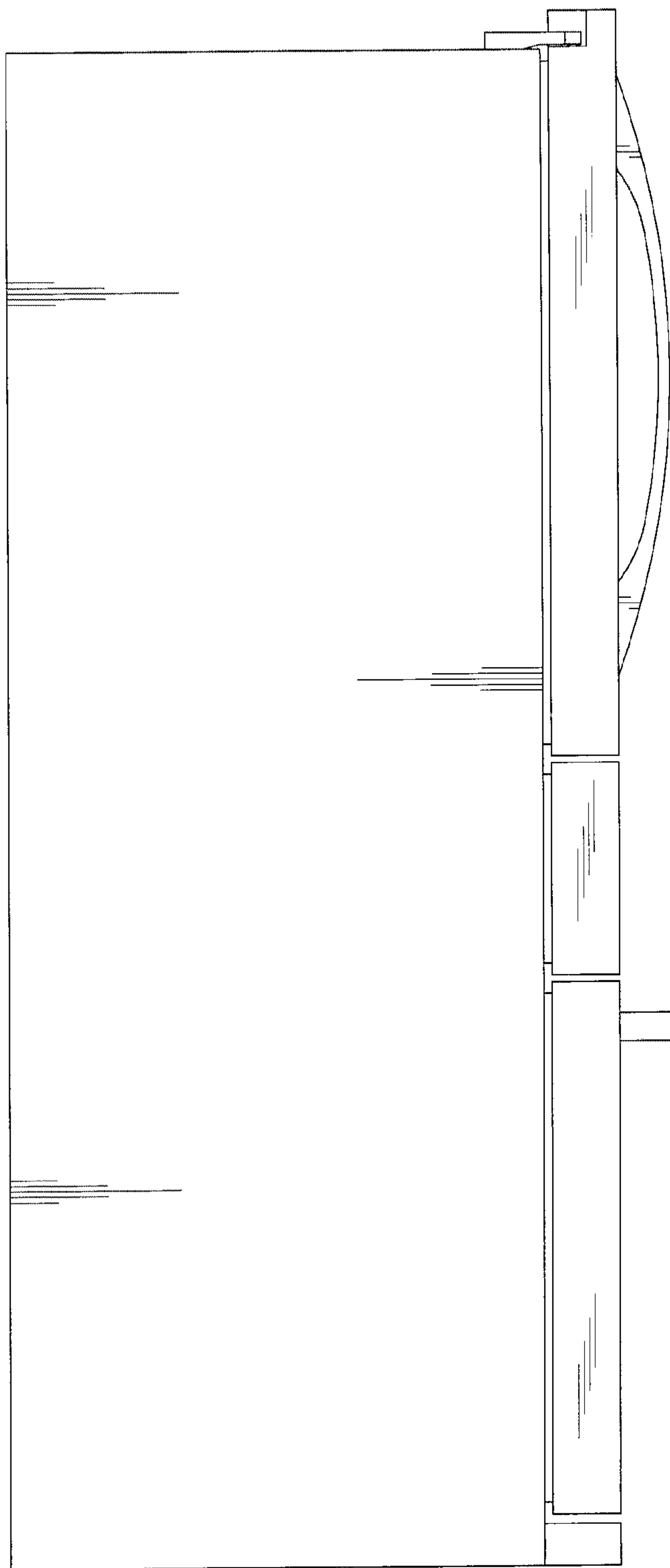

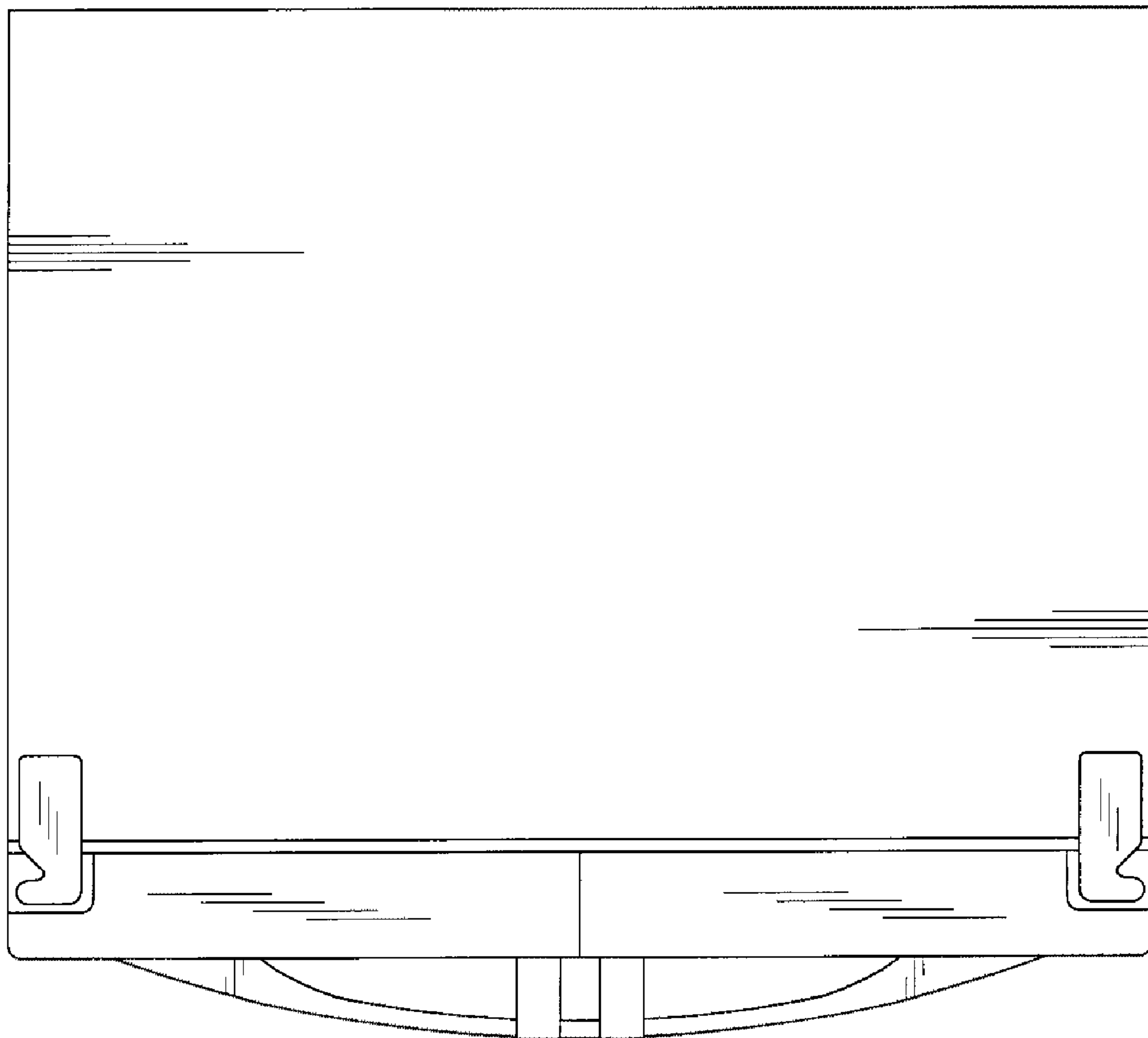
