FIG. 3 is a rear view of the design;

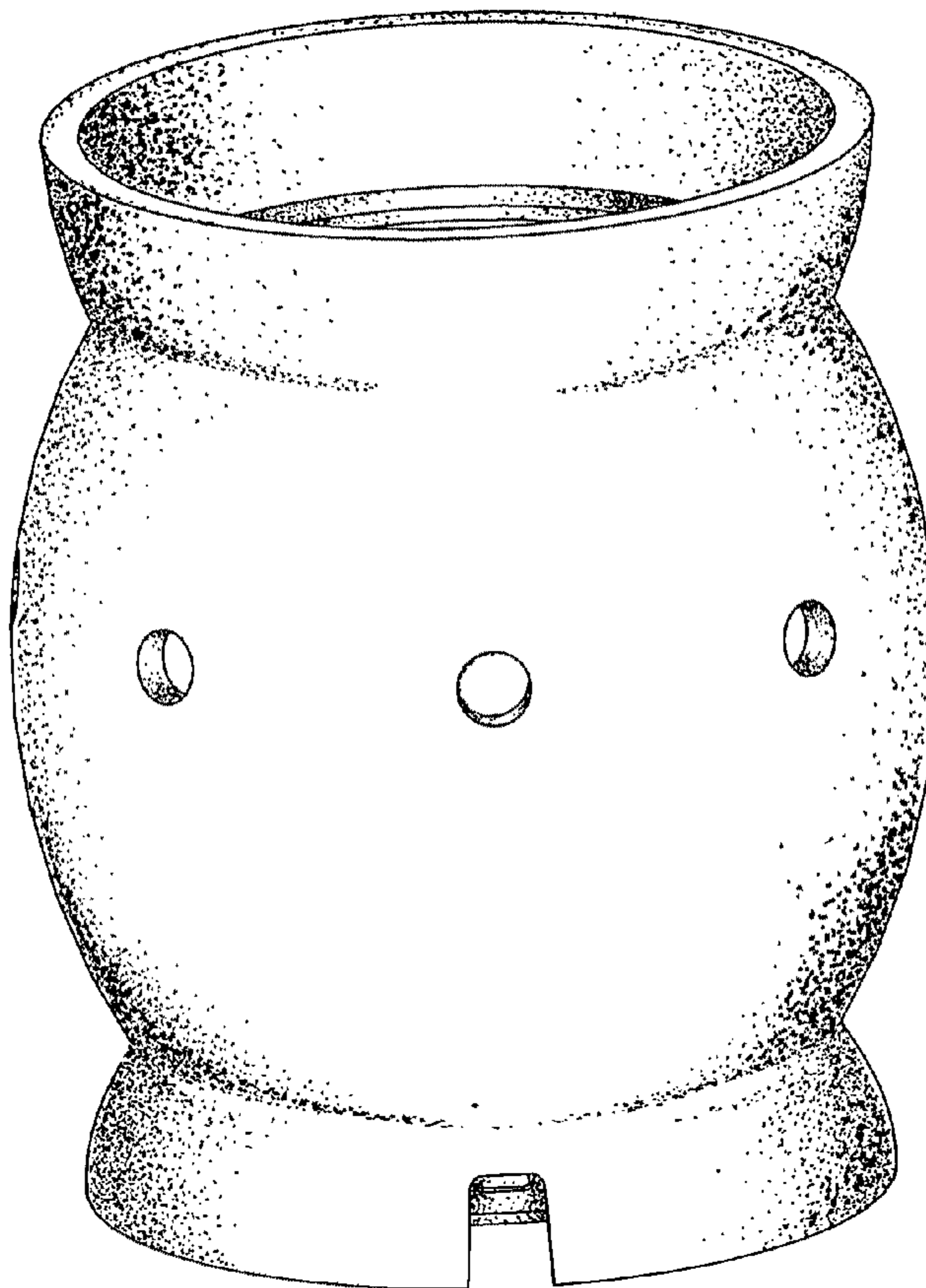
FIG. 4 is a right side view of the design;

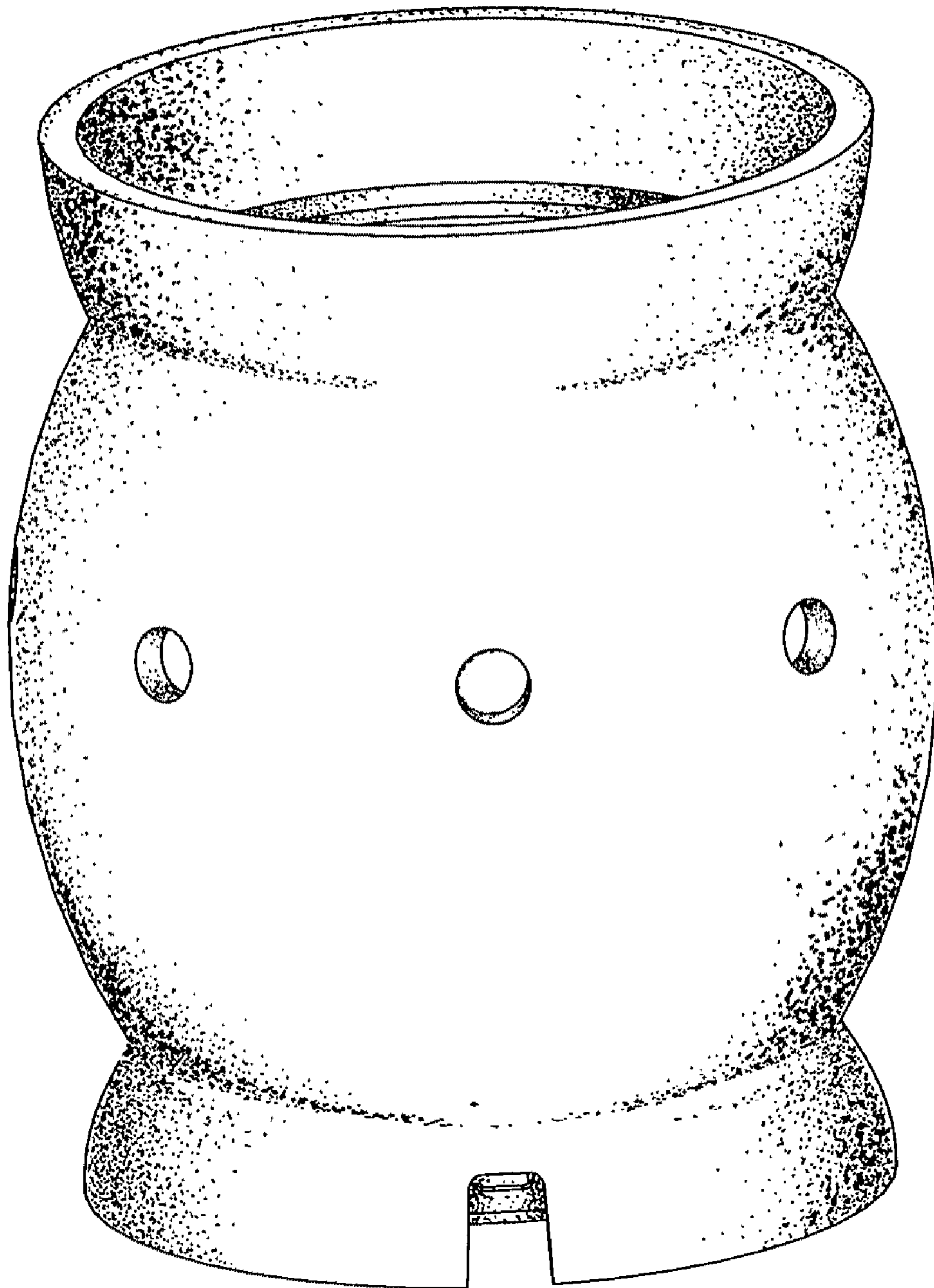

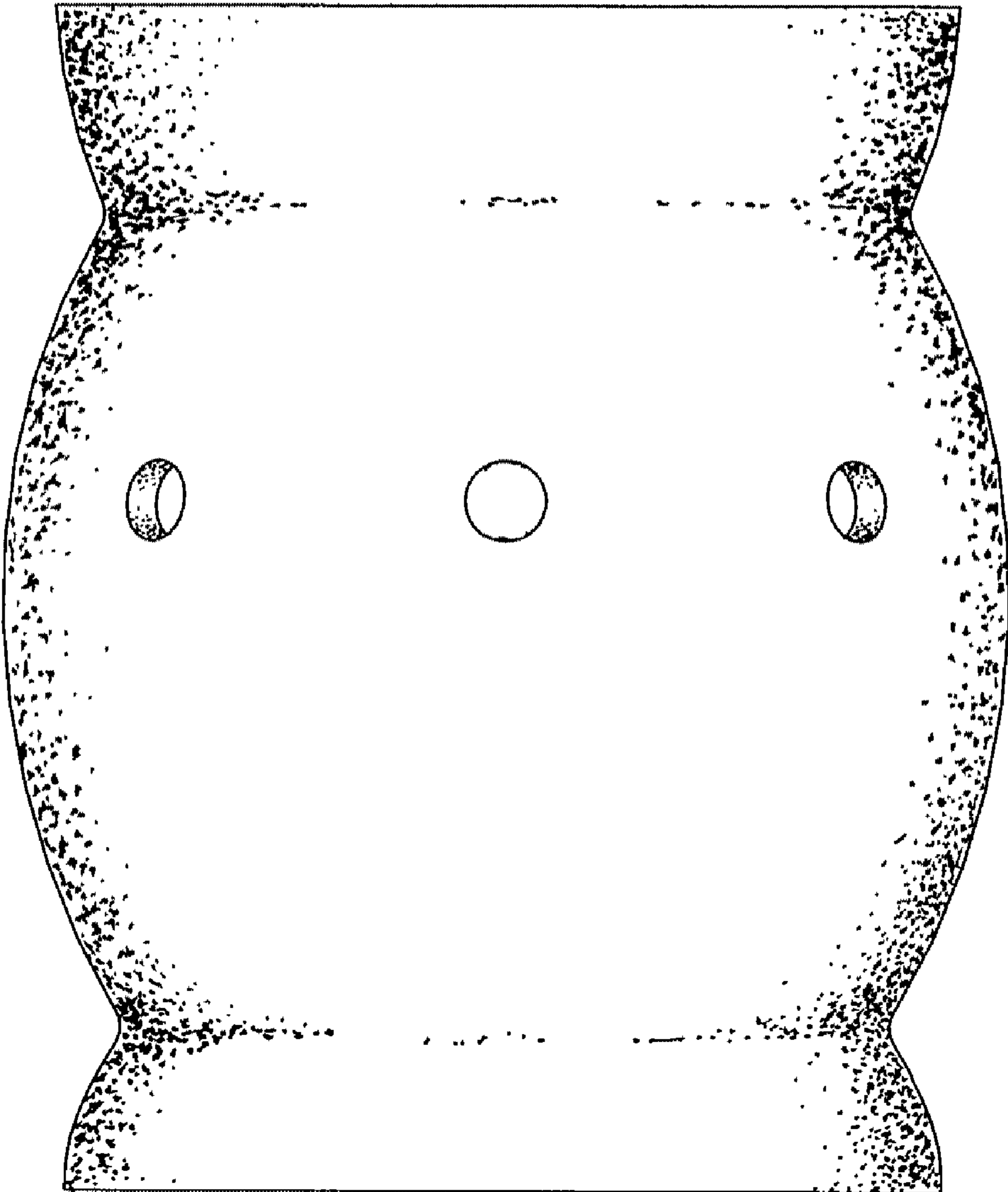

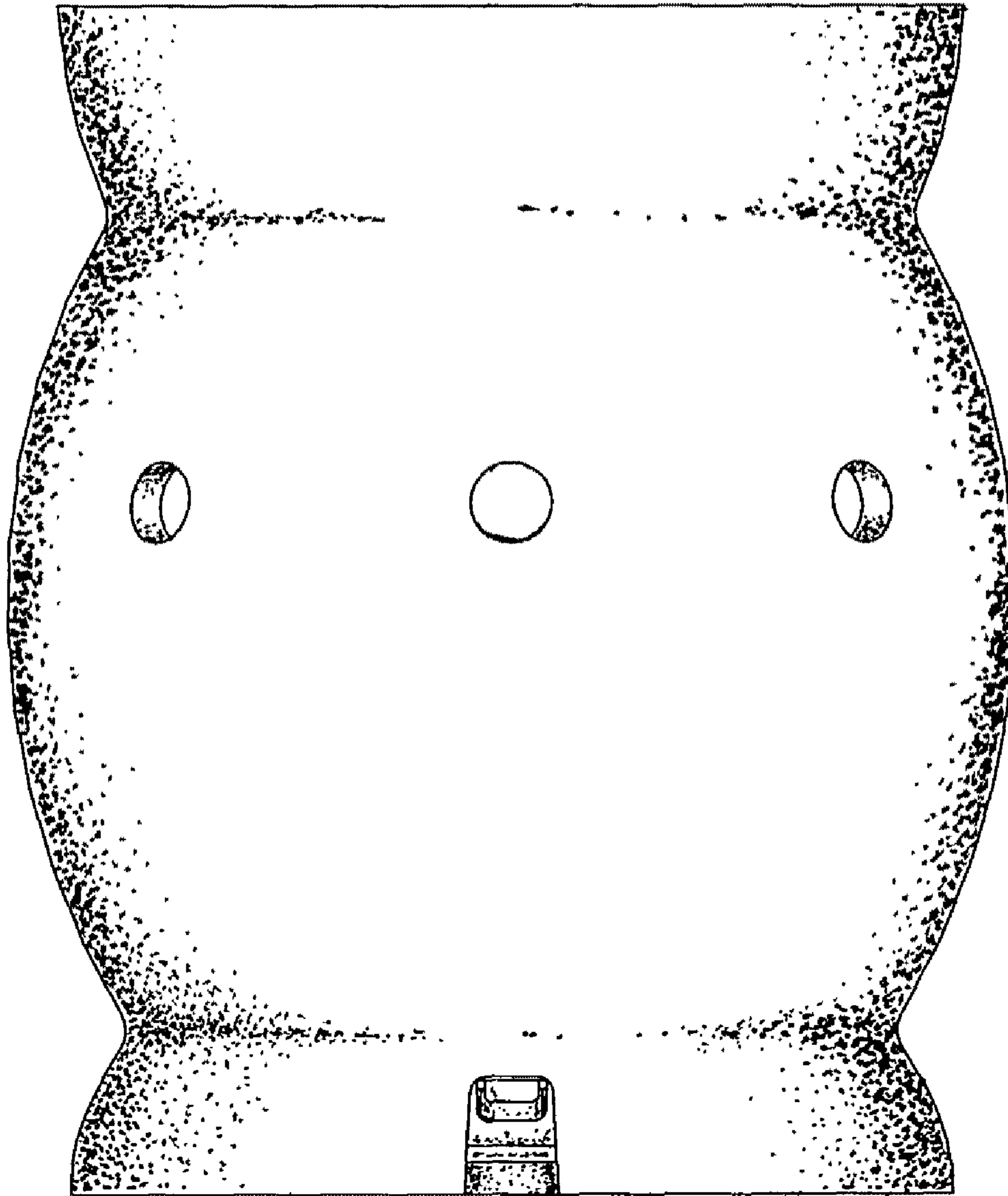

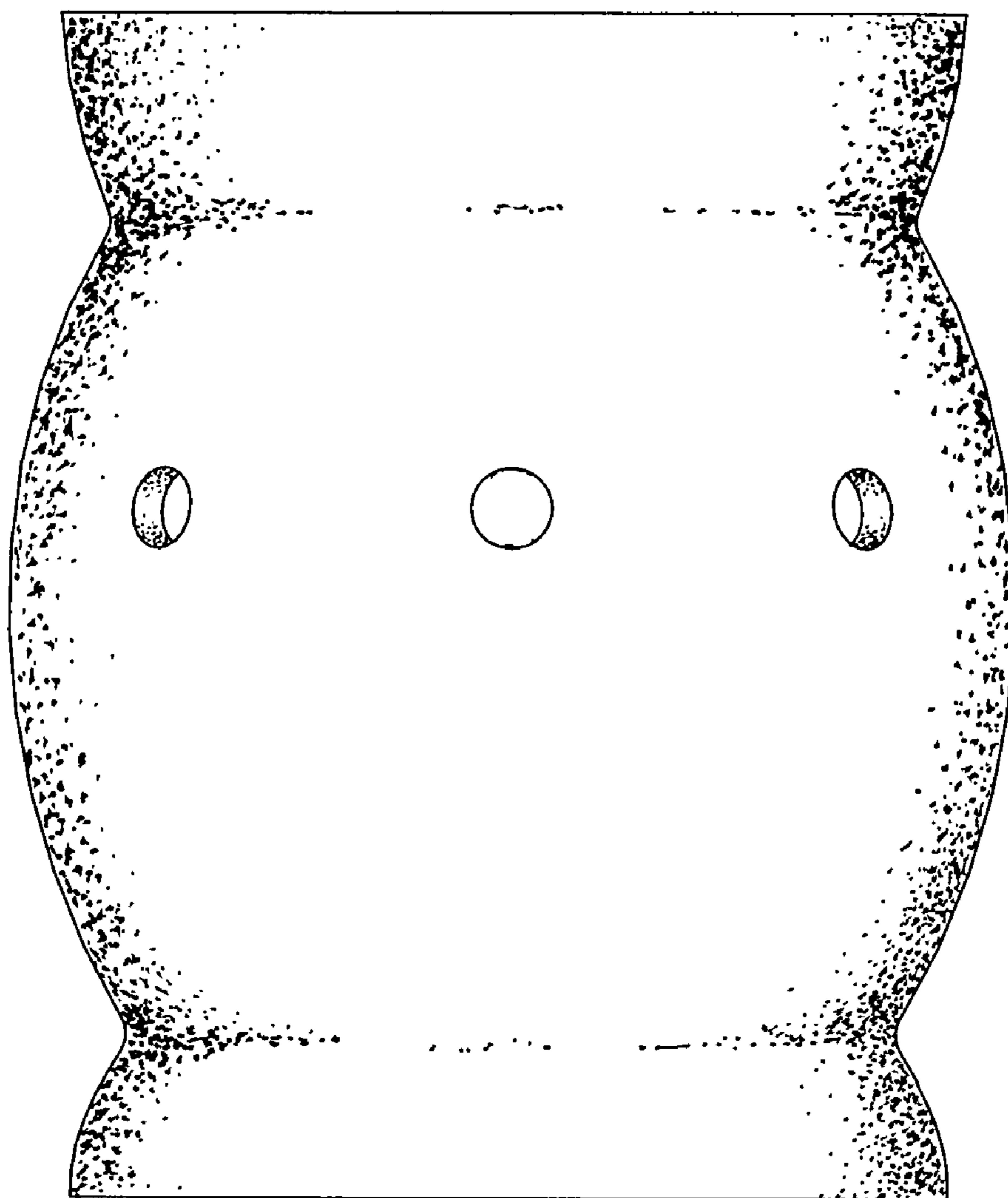

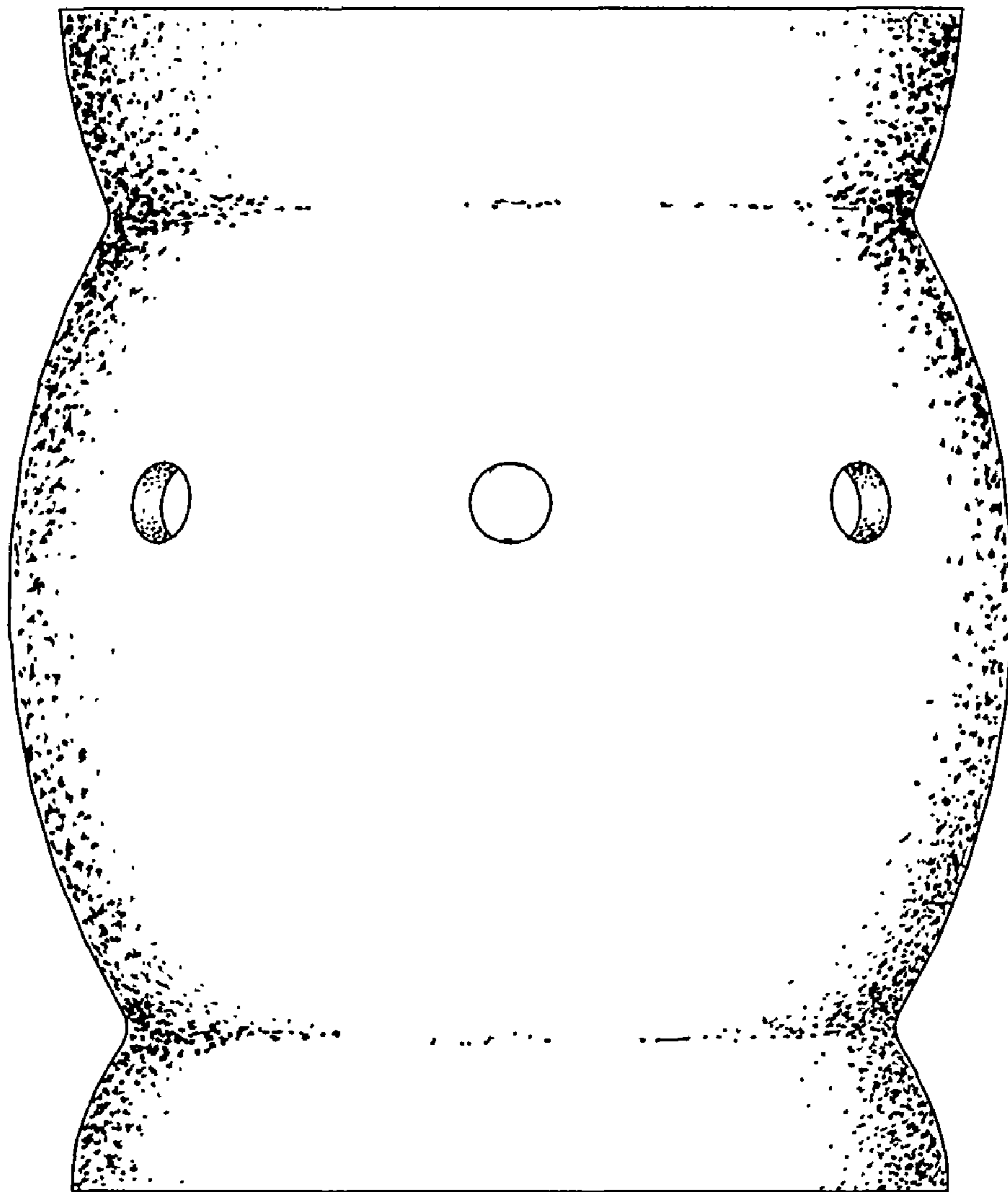

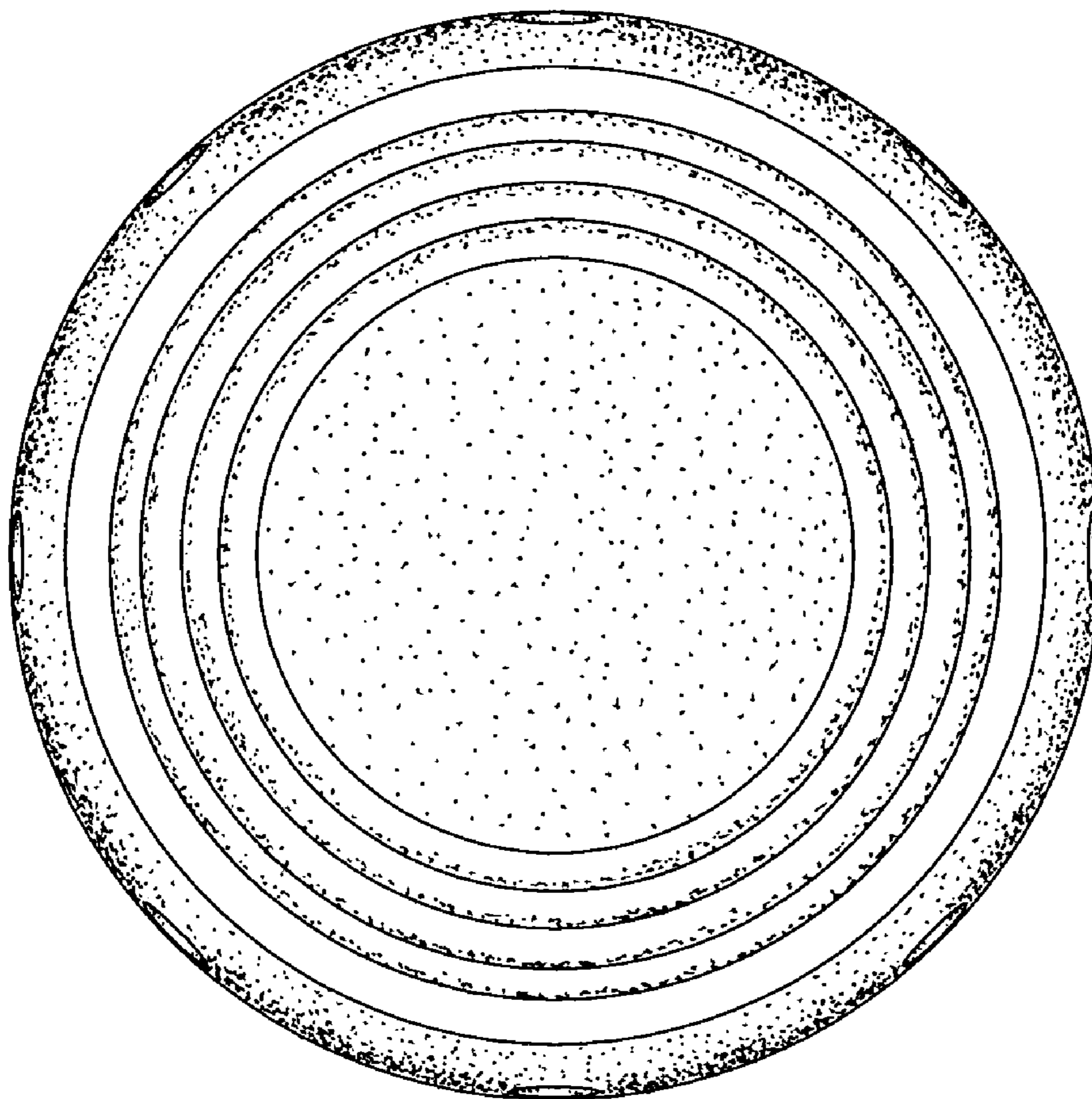

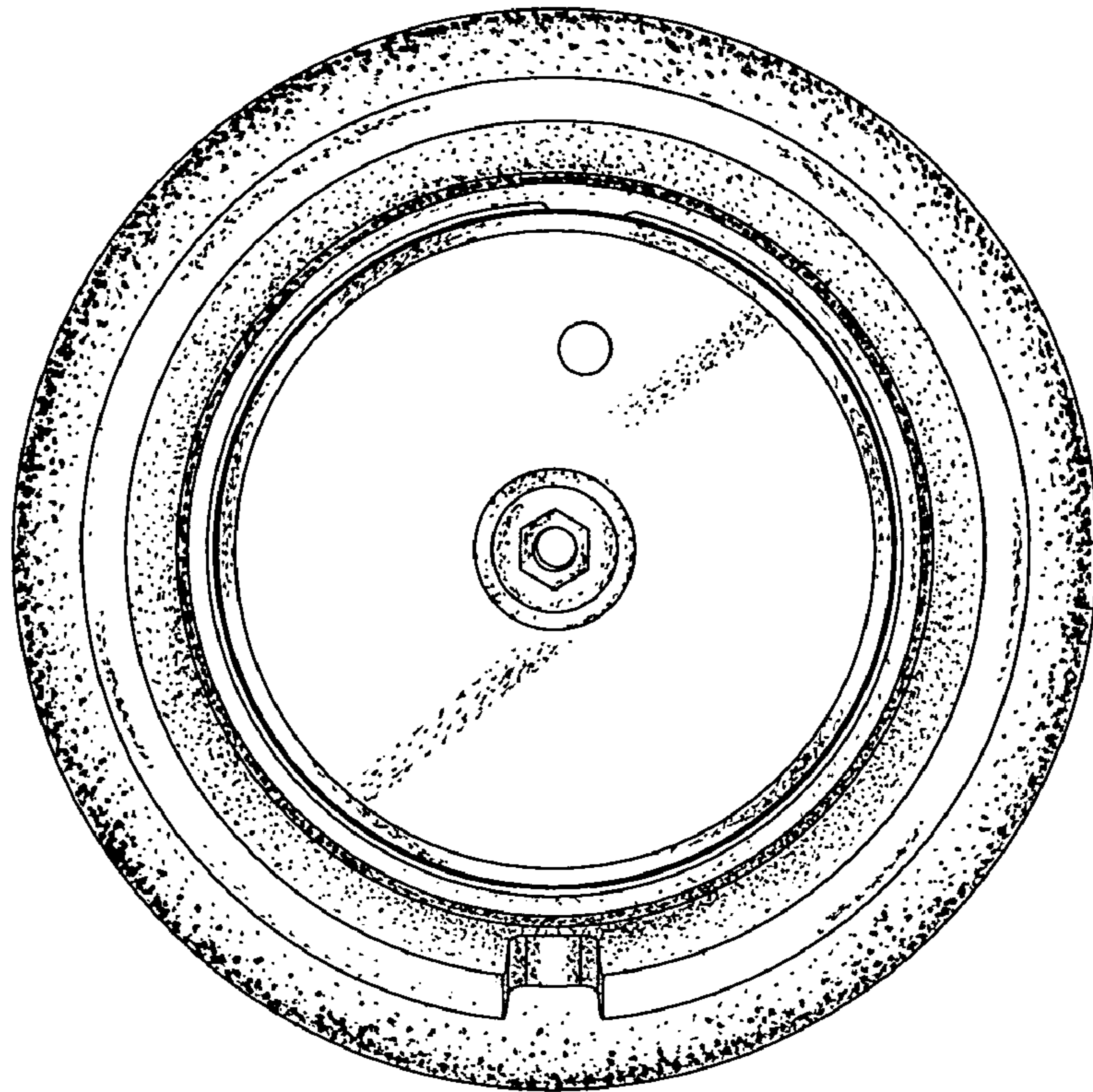
