(57) **CLAIM**

The ornamental design for pants with zippers, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the pants with zippers of our invention showing the location of the zippers;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a left side view thereof;

FIG. 5 is a right side view thereof;

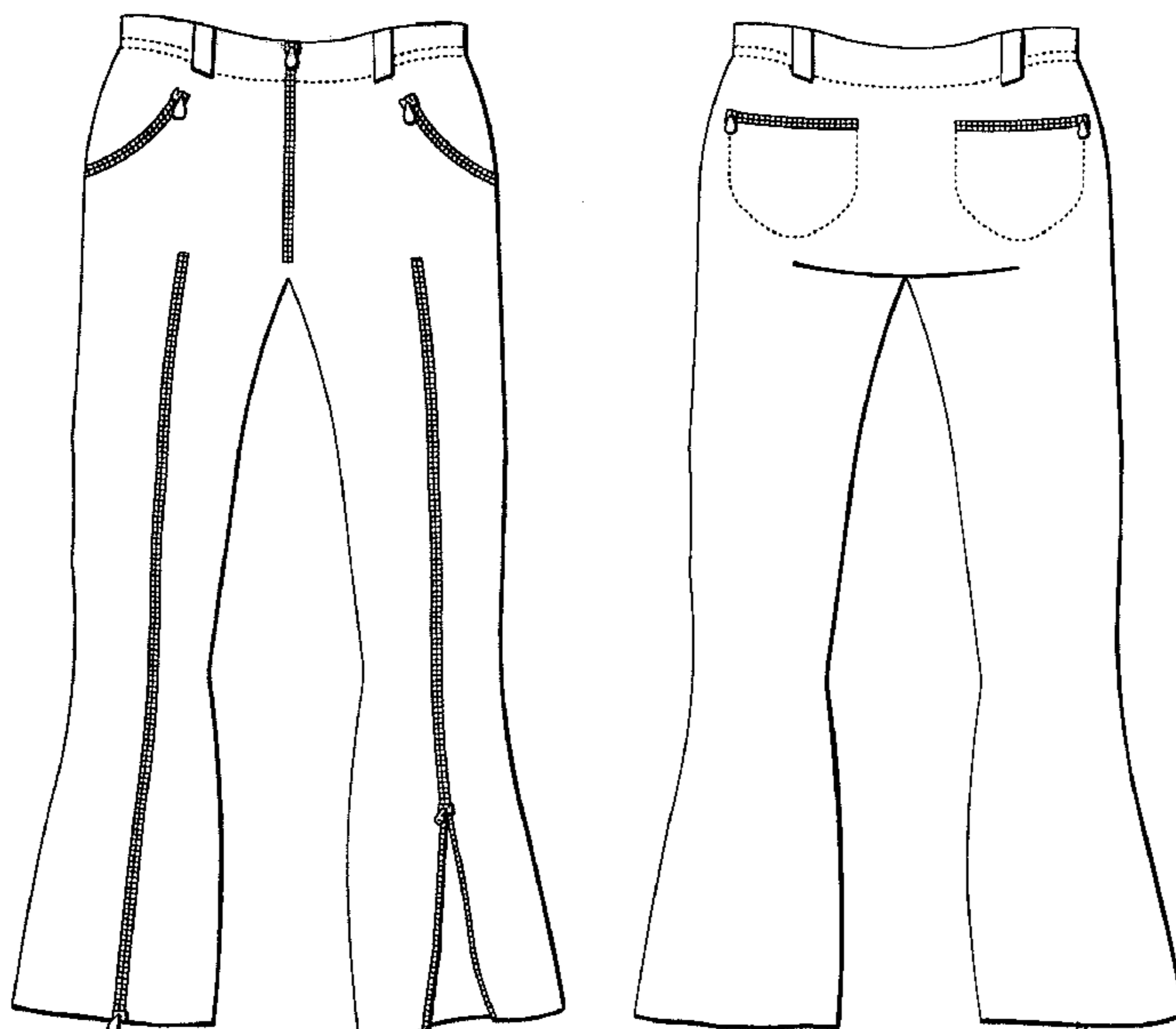
FIG. 6 is a top view thereof;

FIG. 7 is a bottom view thereof; and,

FIG. 8. is a front perspective view of a second embodiment of the design of FIG. 1, the only difference being the style of the zippers.

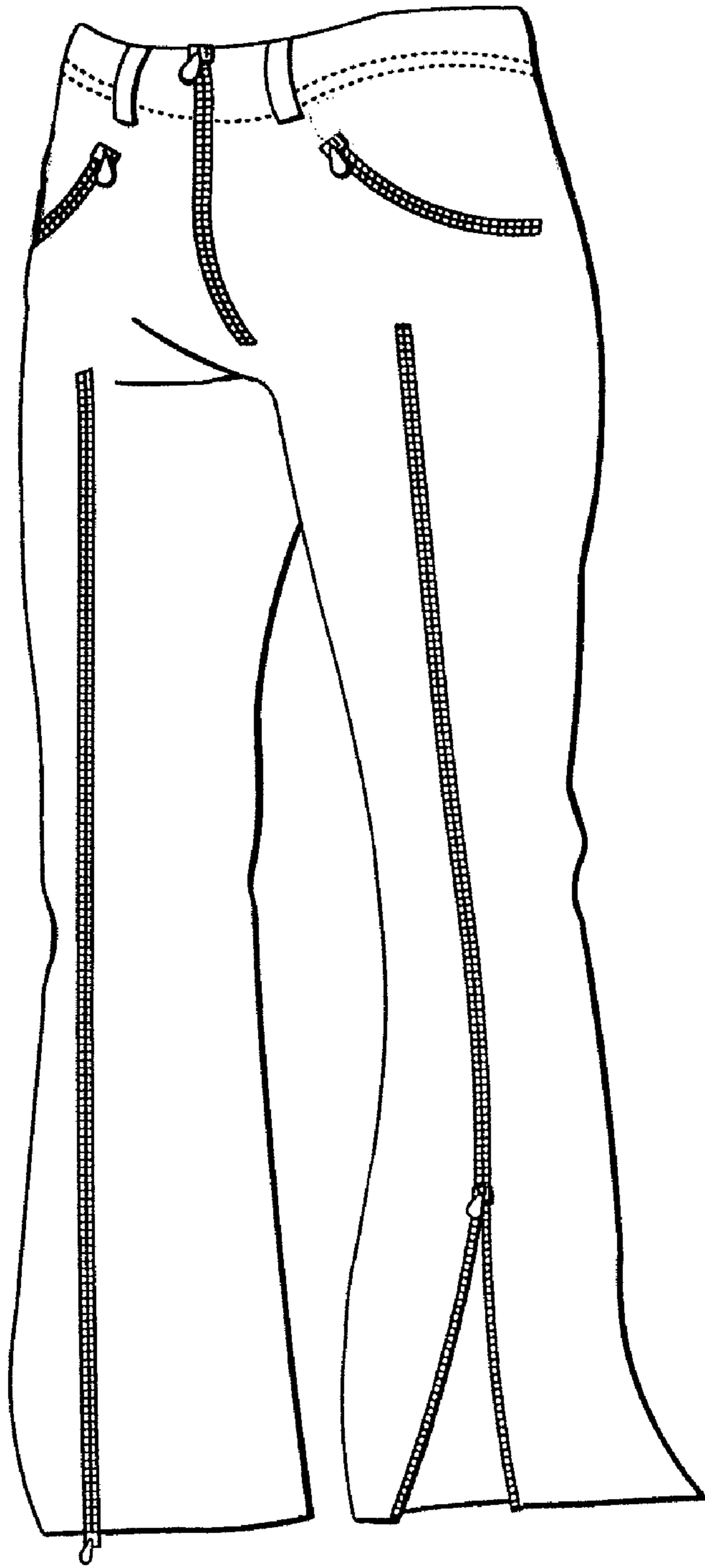

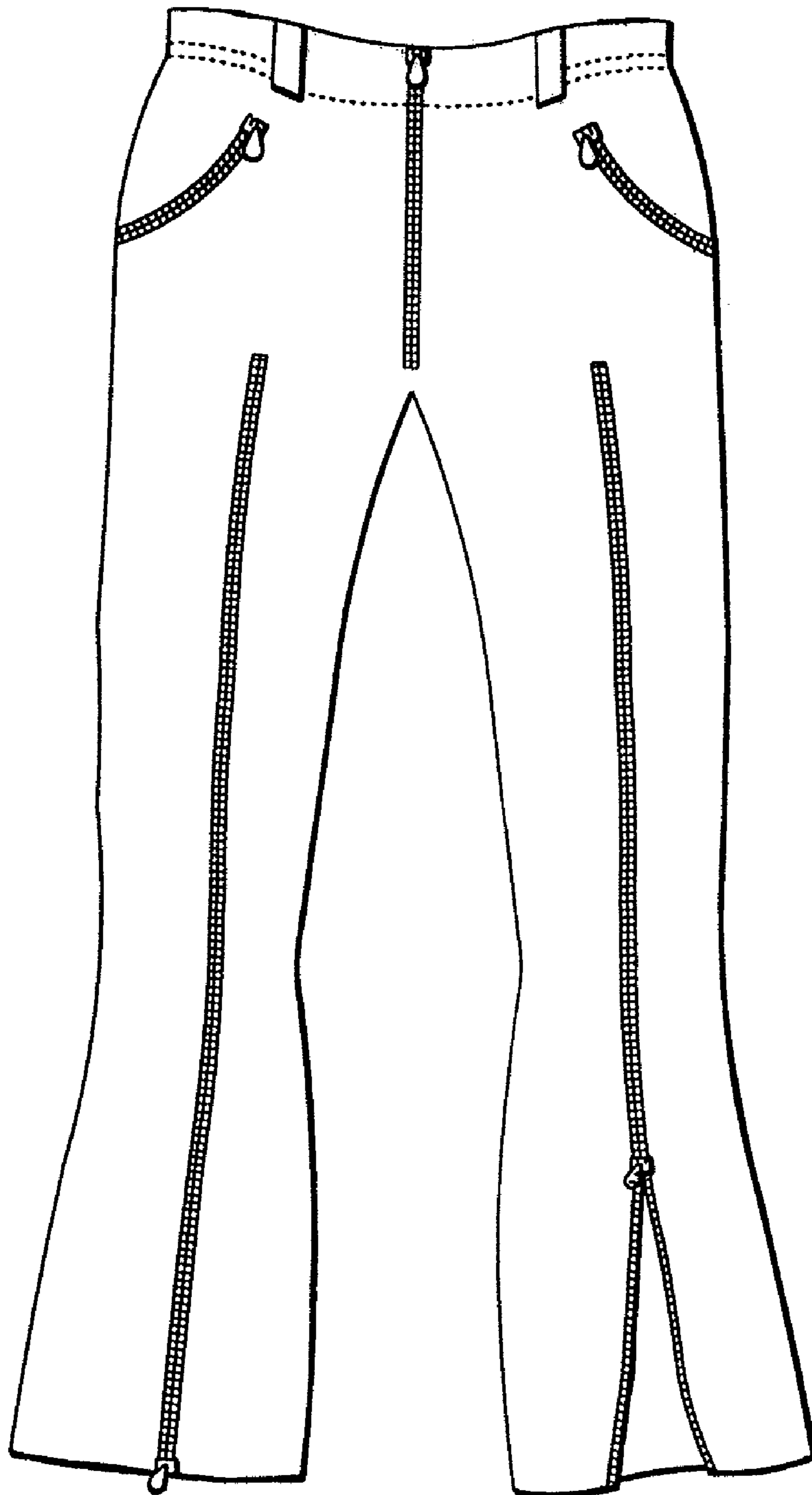

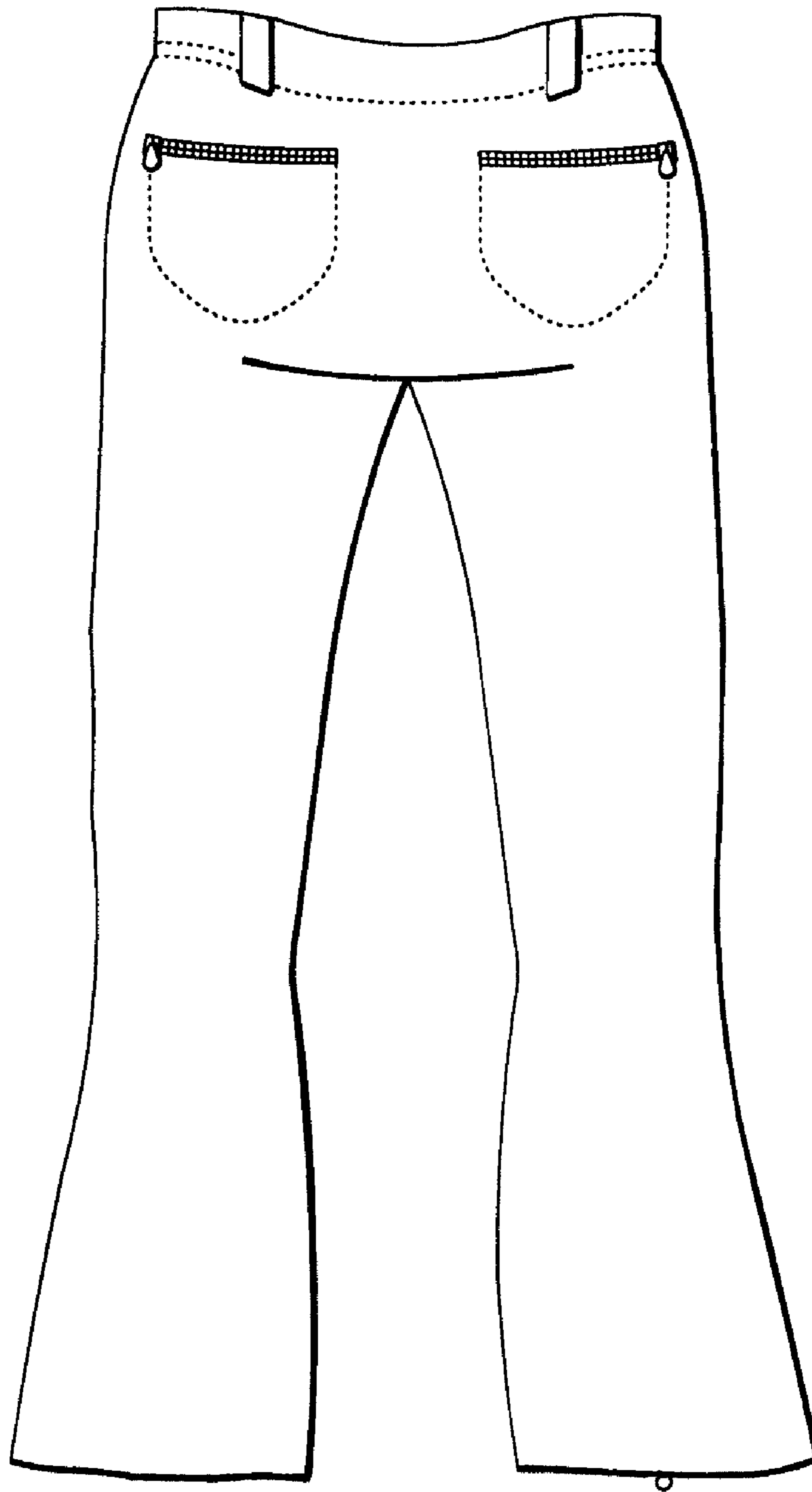
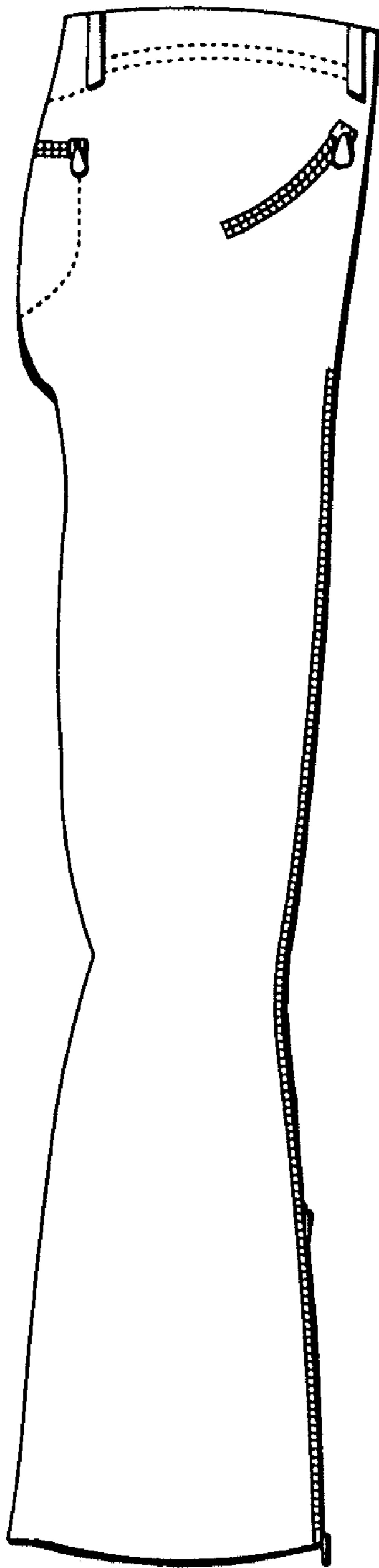
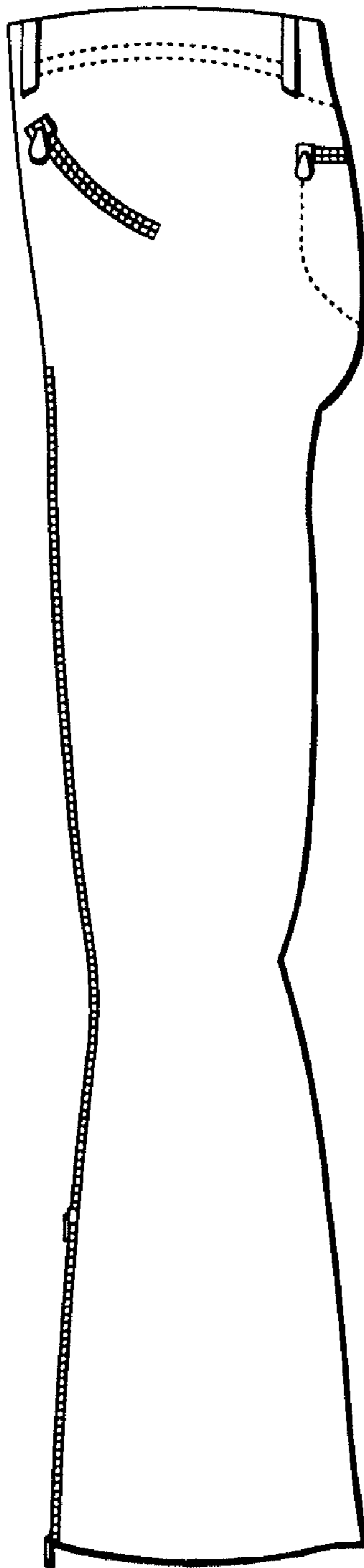


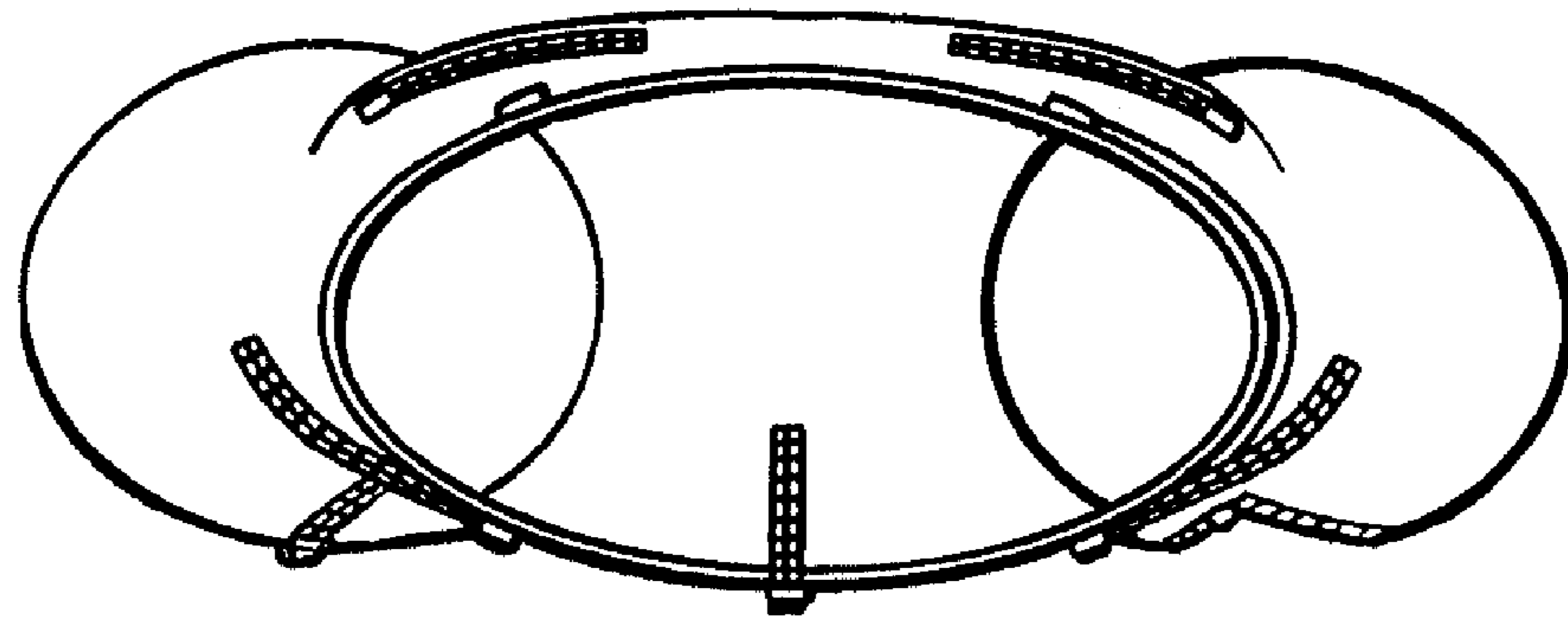

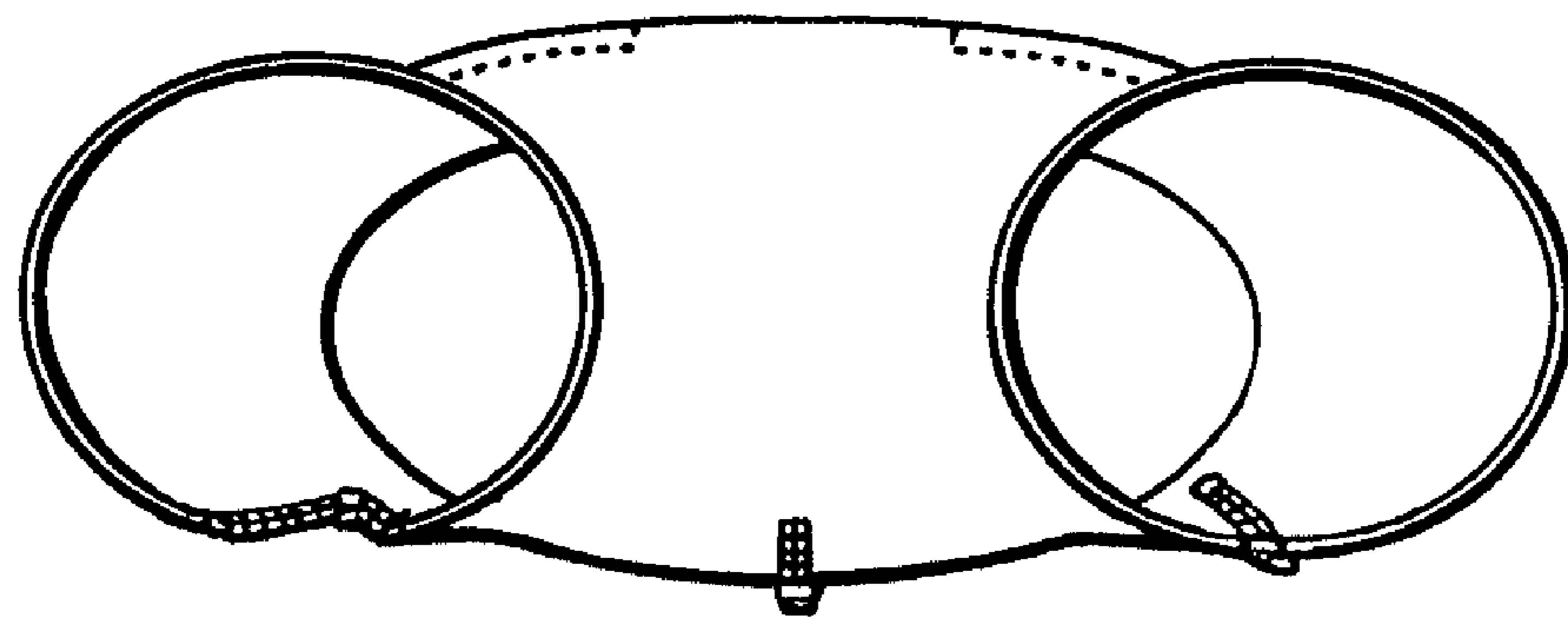

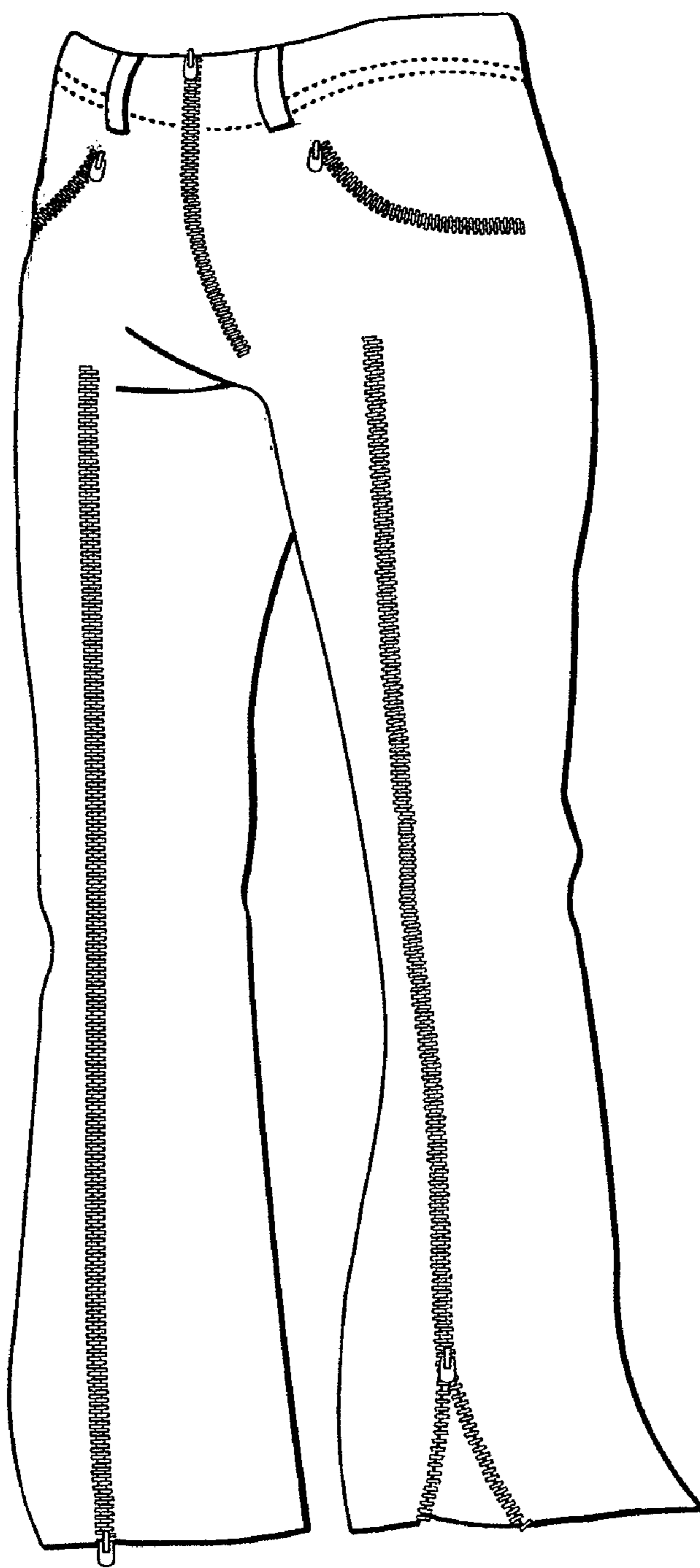
