FIG. 4 is a right view of the backpack for a laptop;

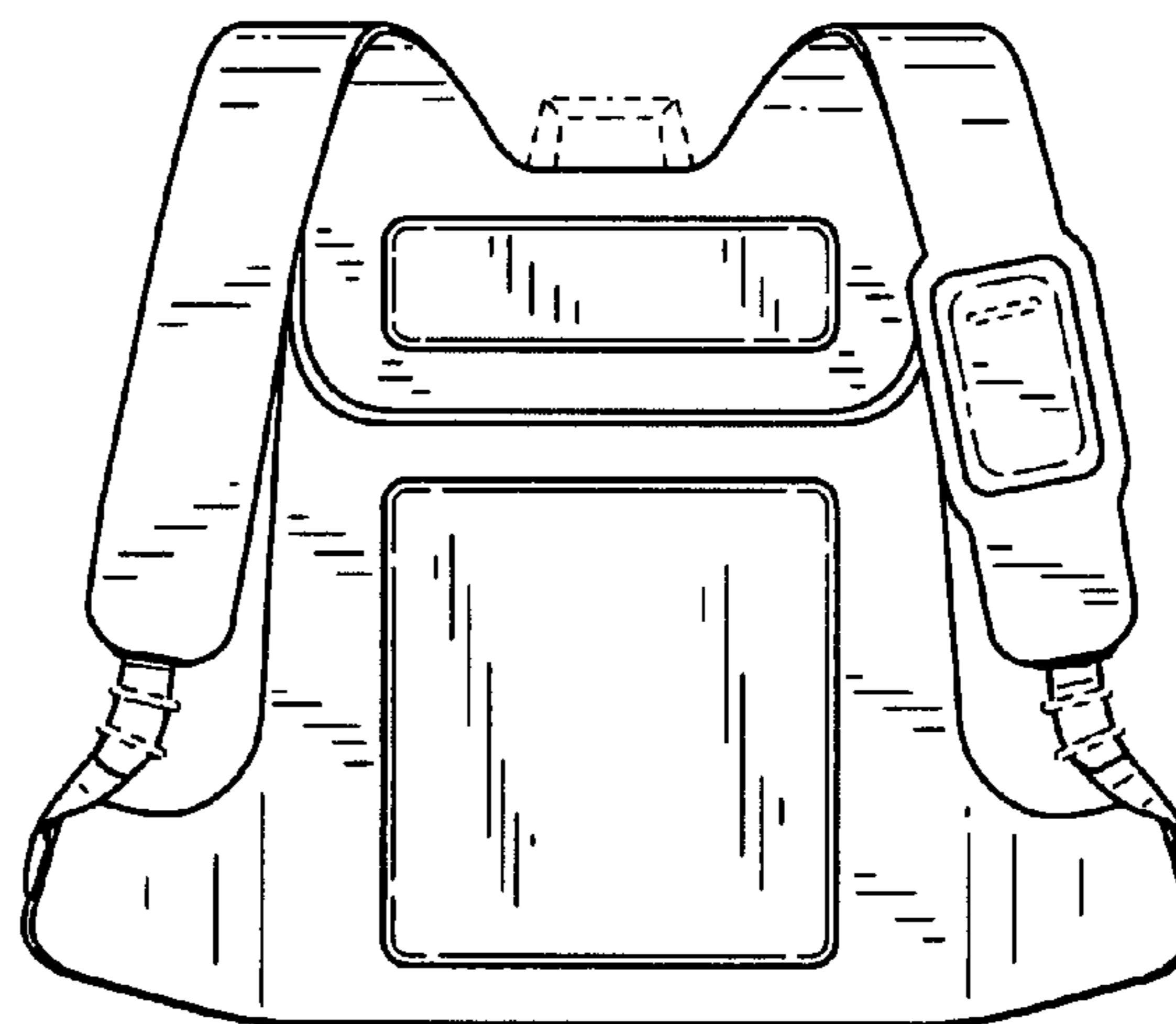
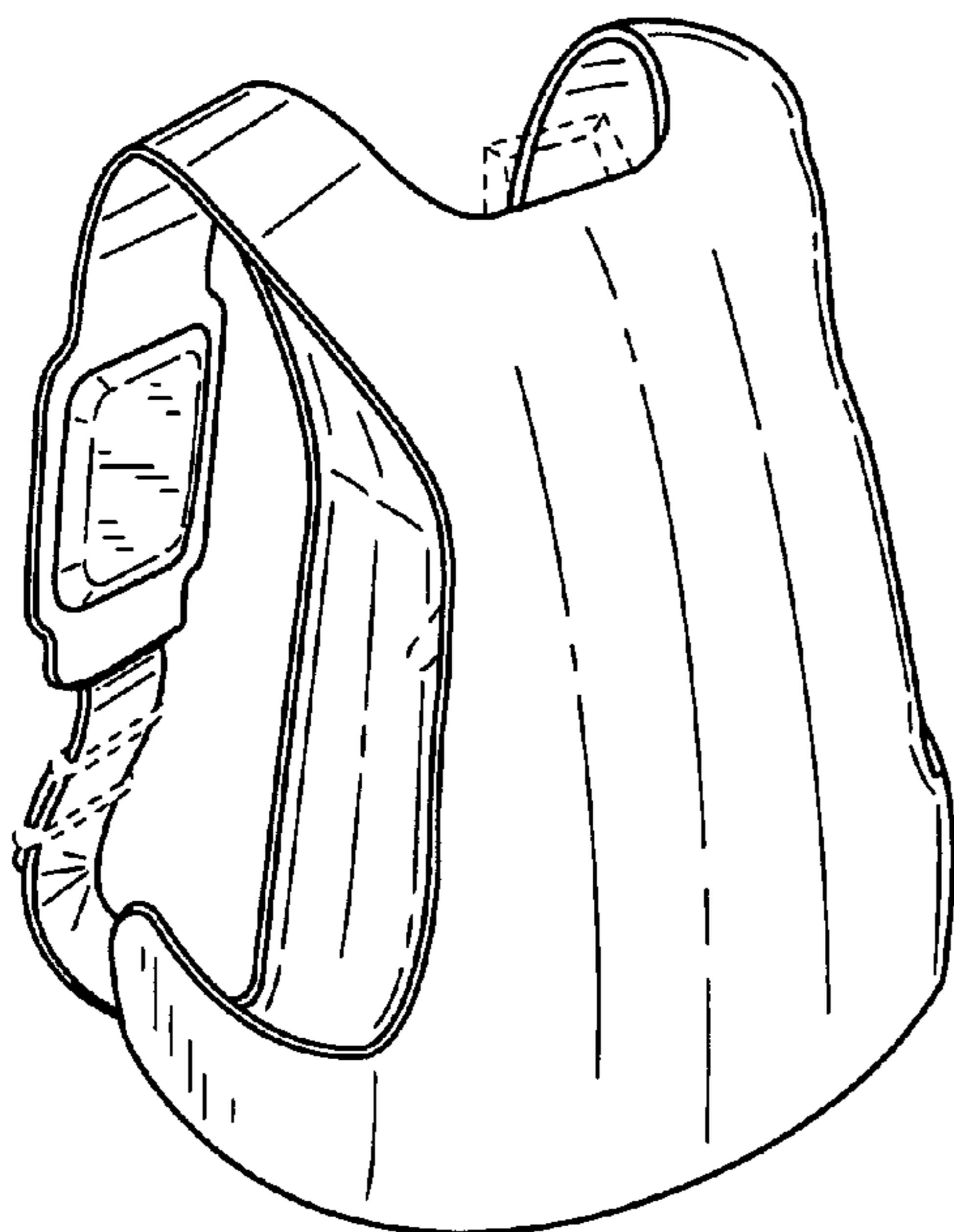
FIG. 5 is a left view of the backpack for a laptop;

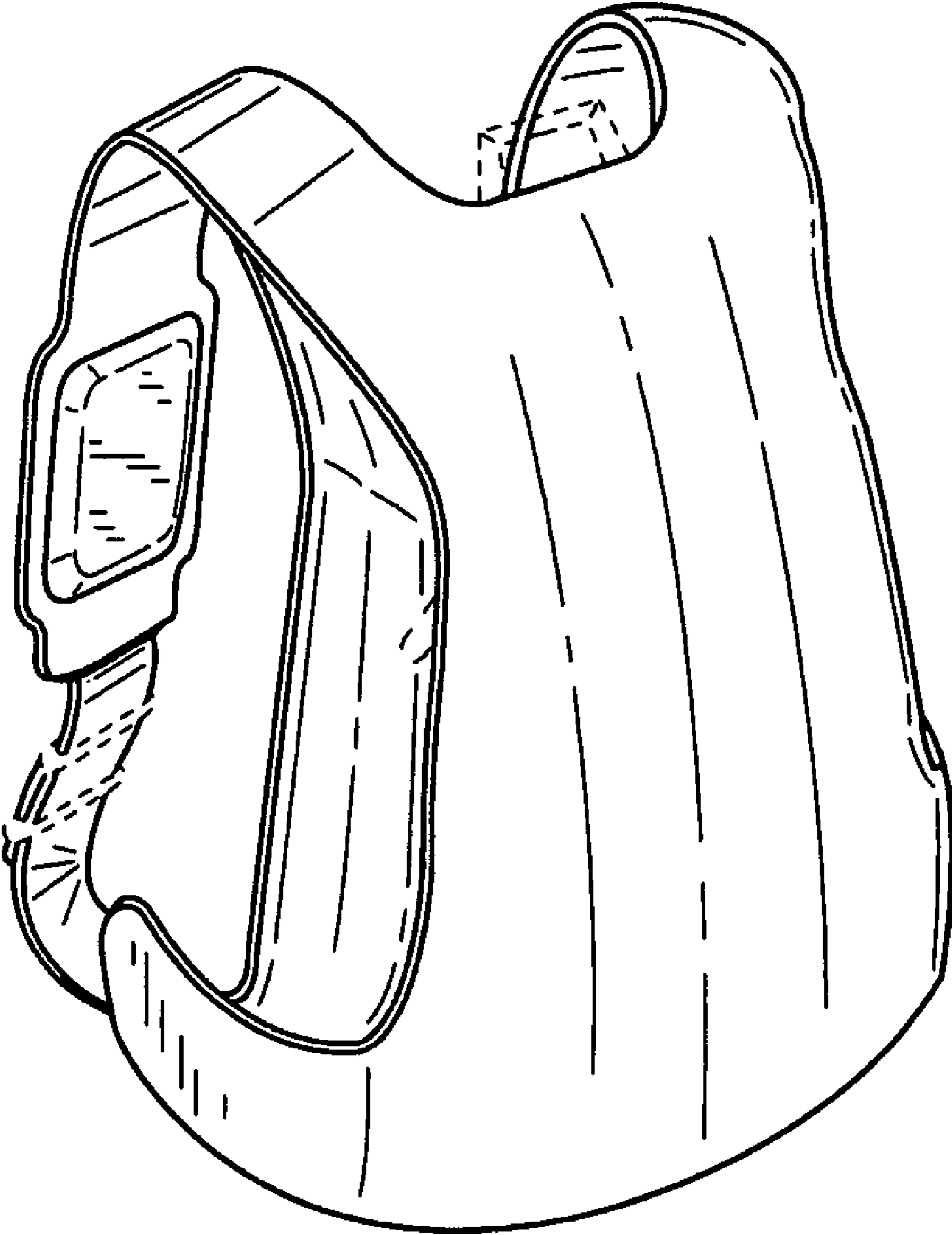

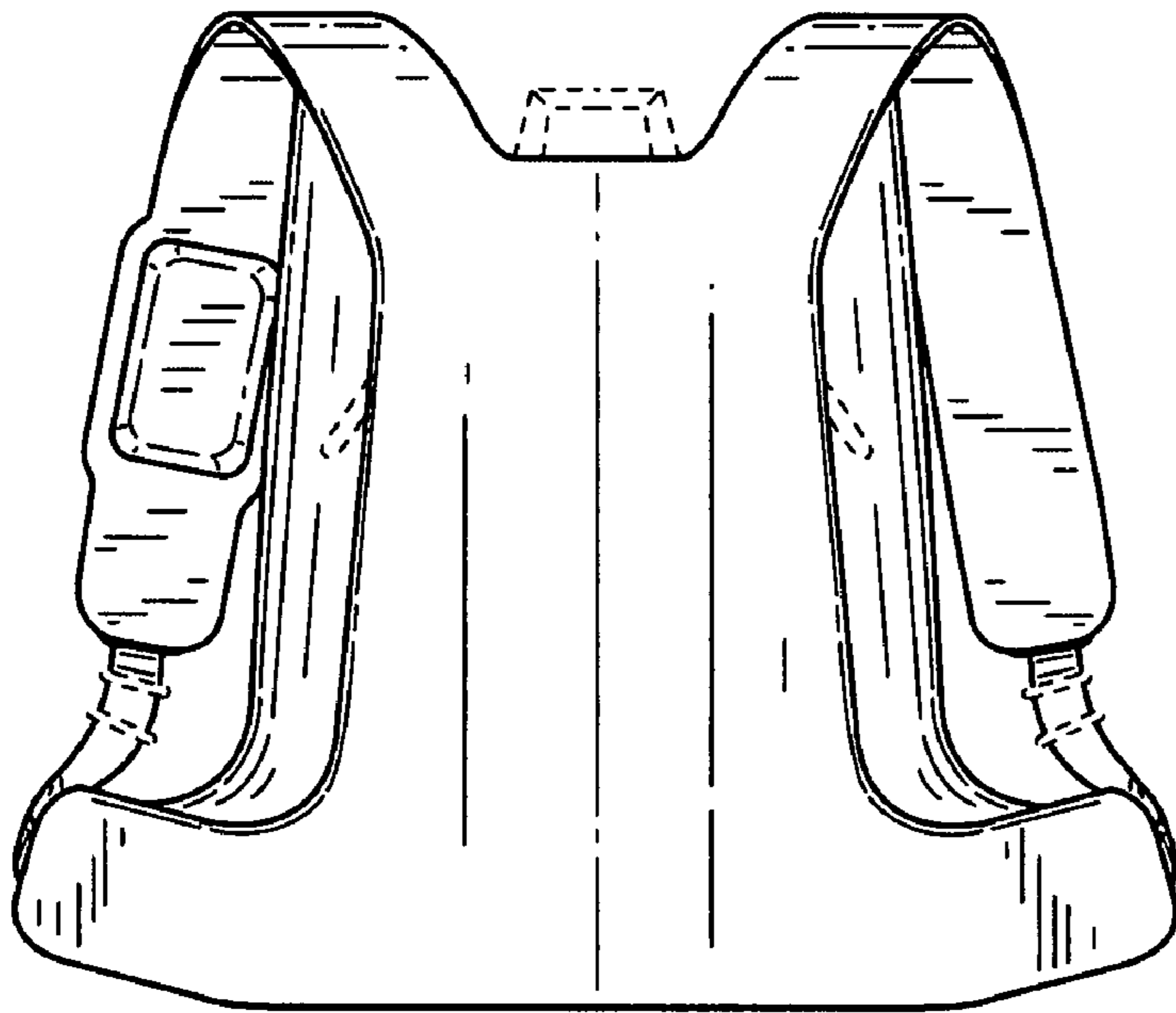

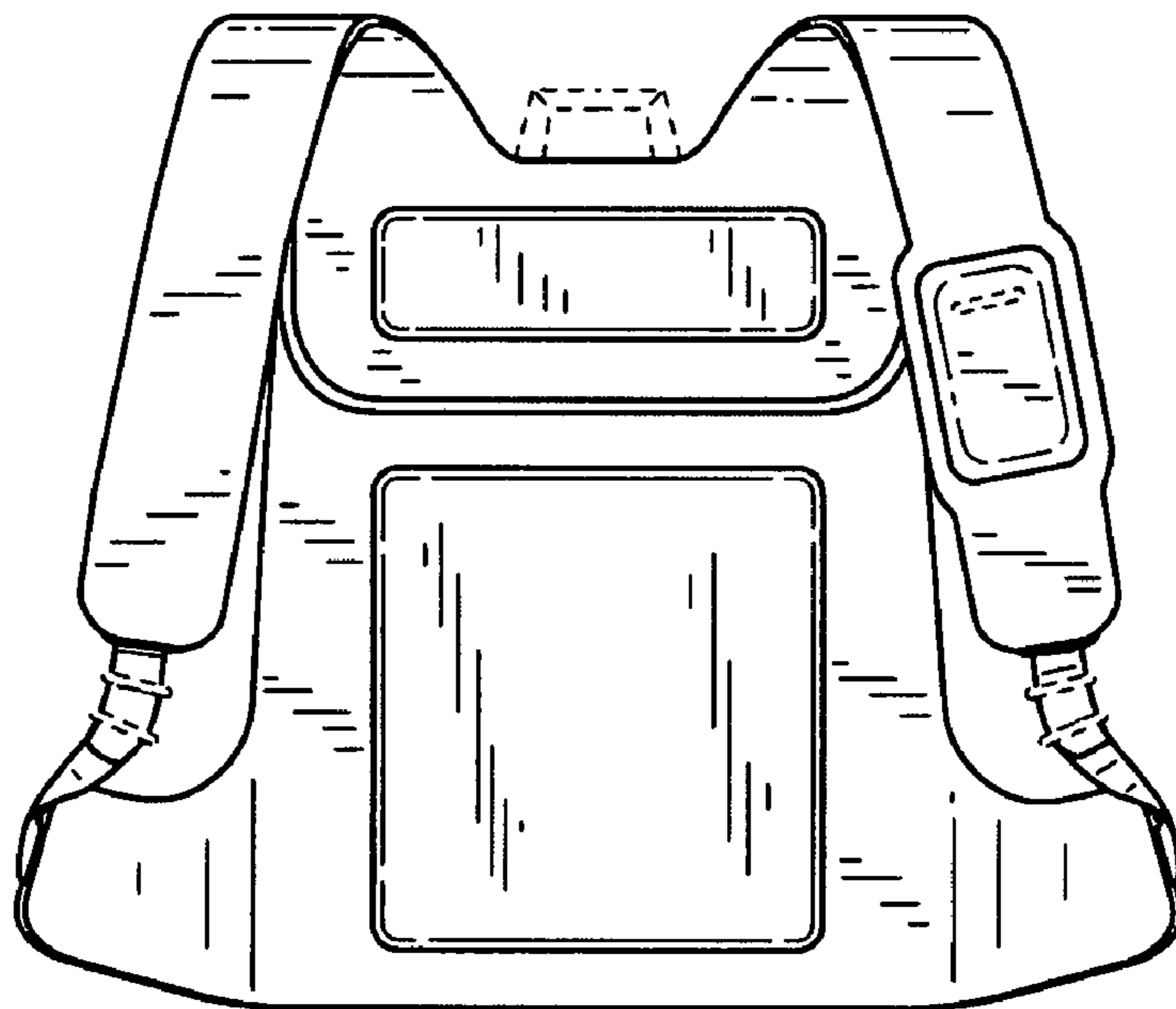

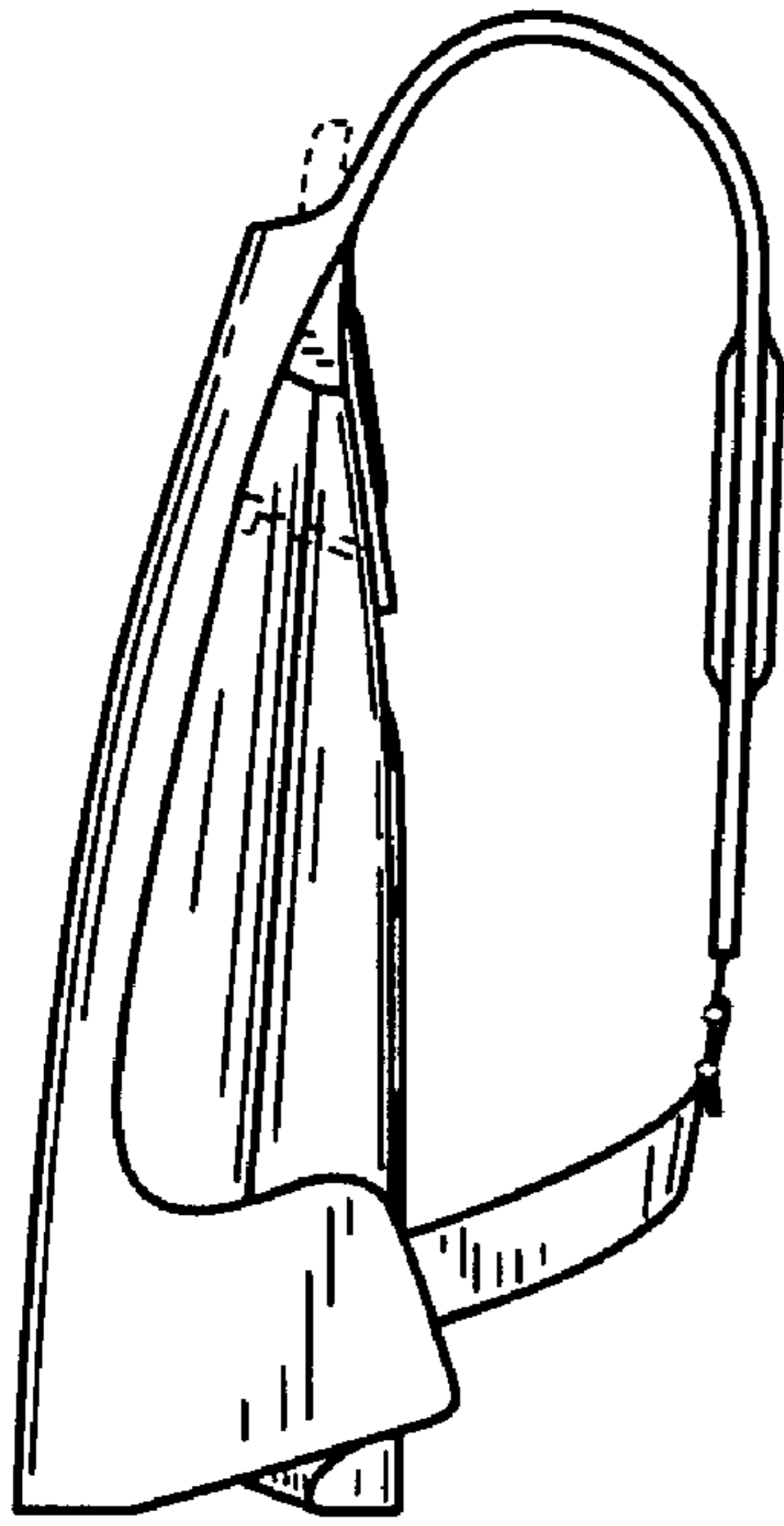

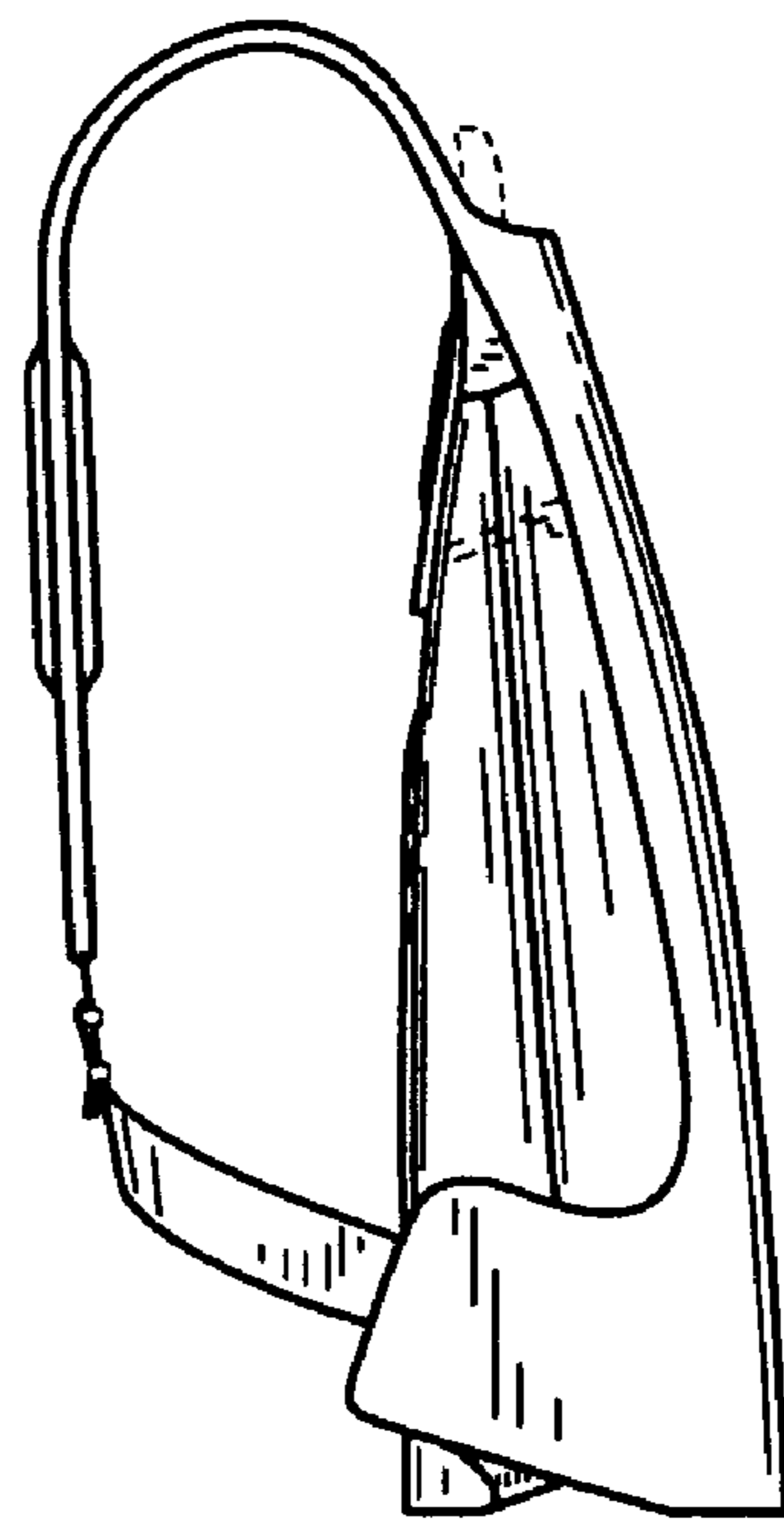

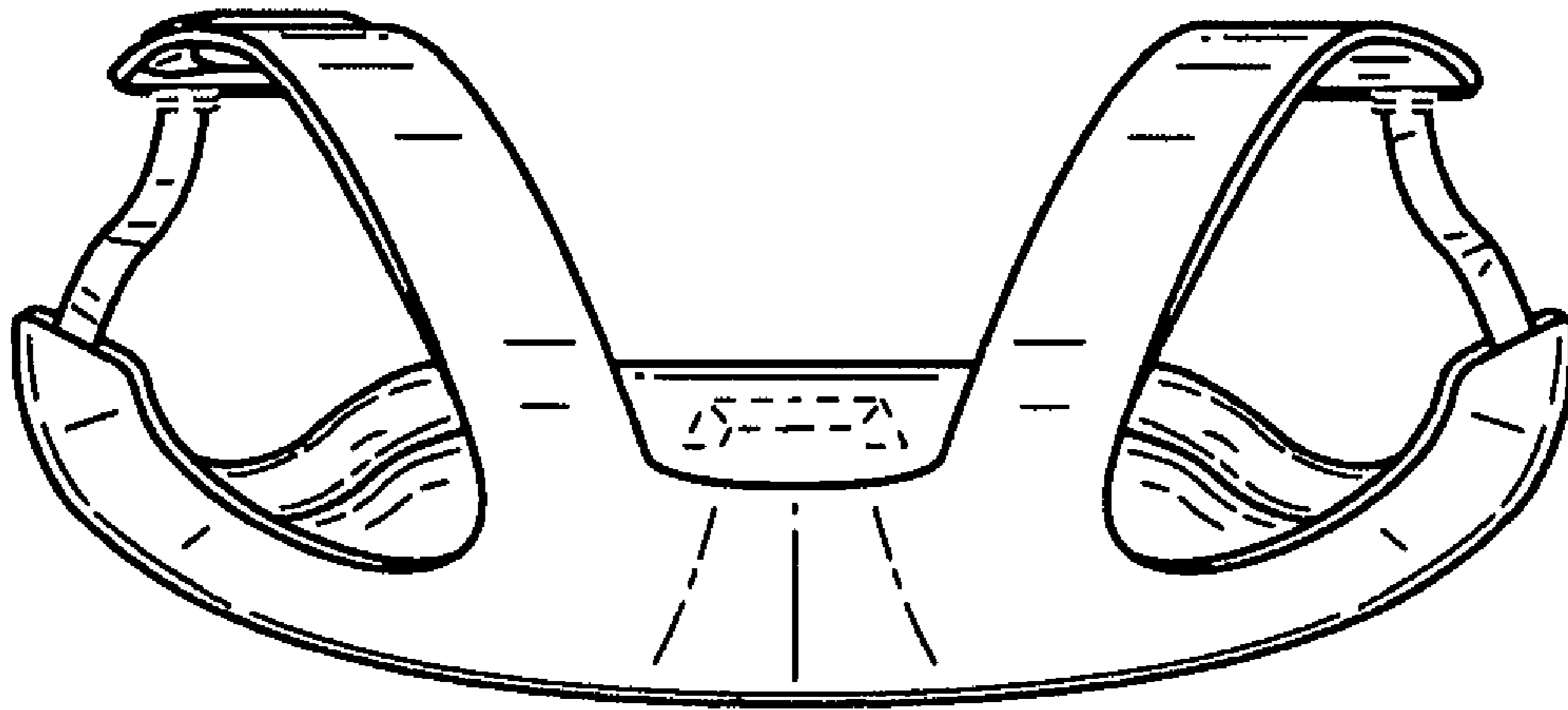

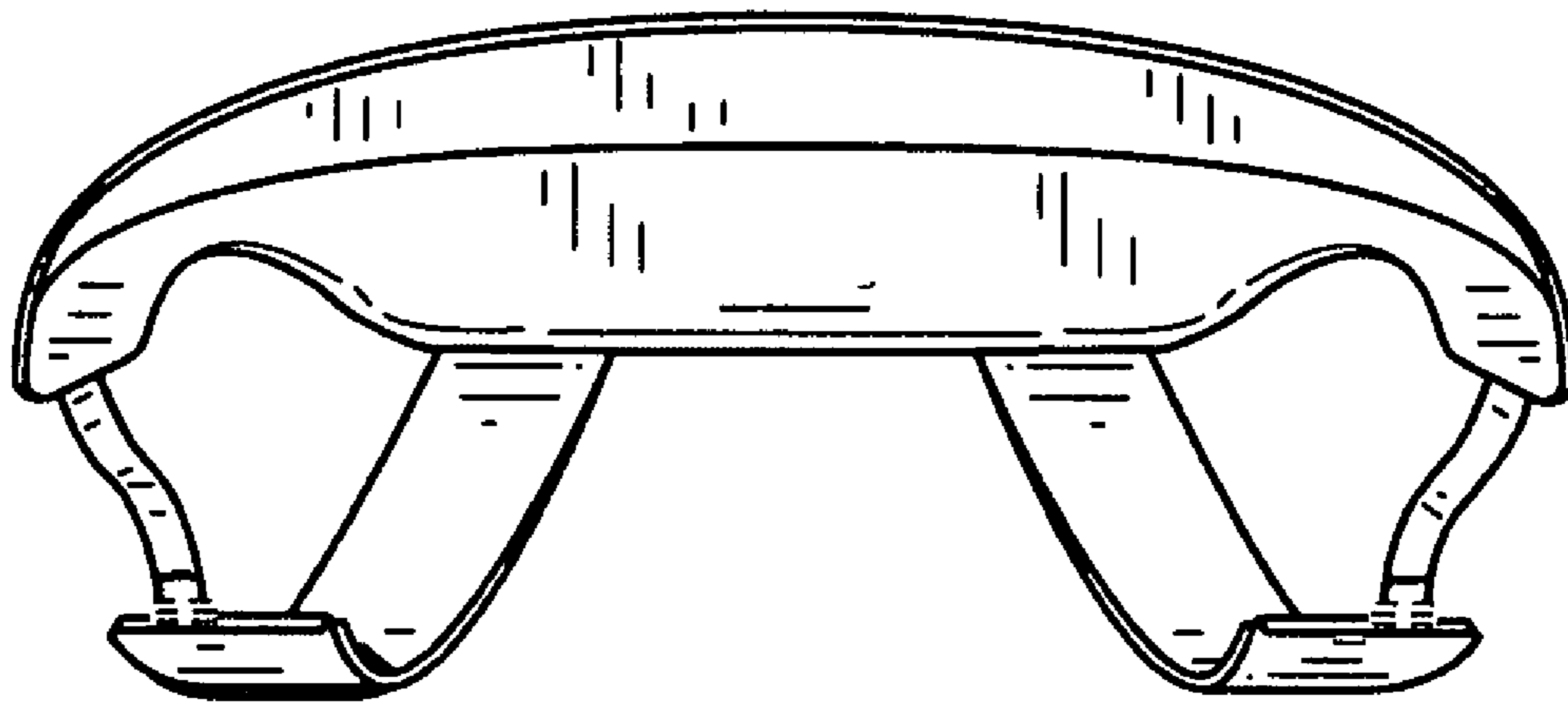
