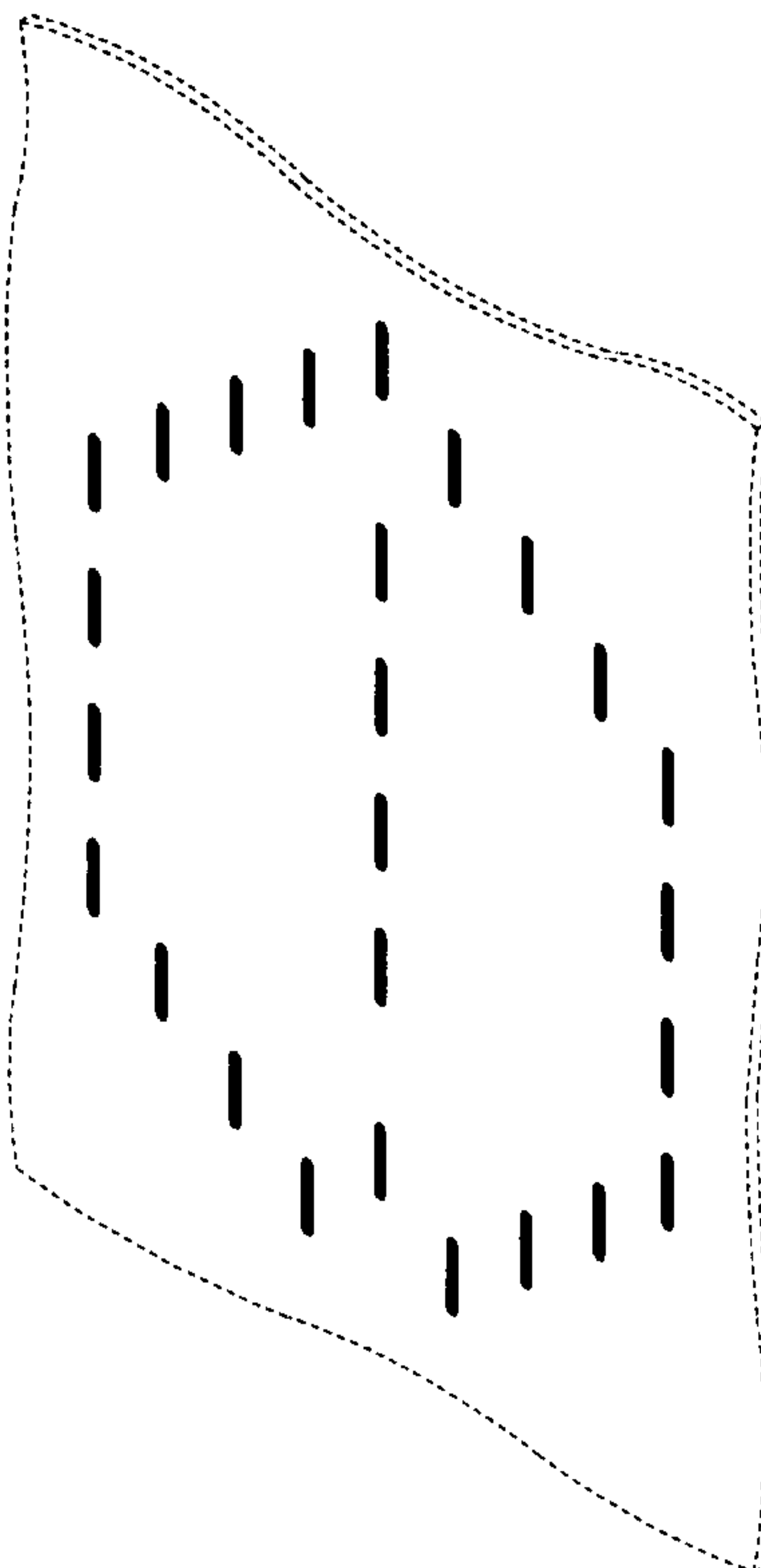
The ornamental design for a pattern for a sheet, as shown and described.

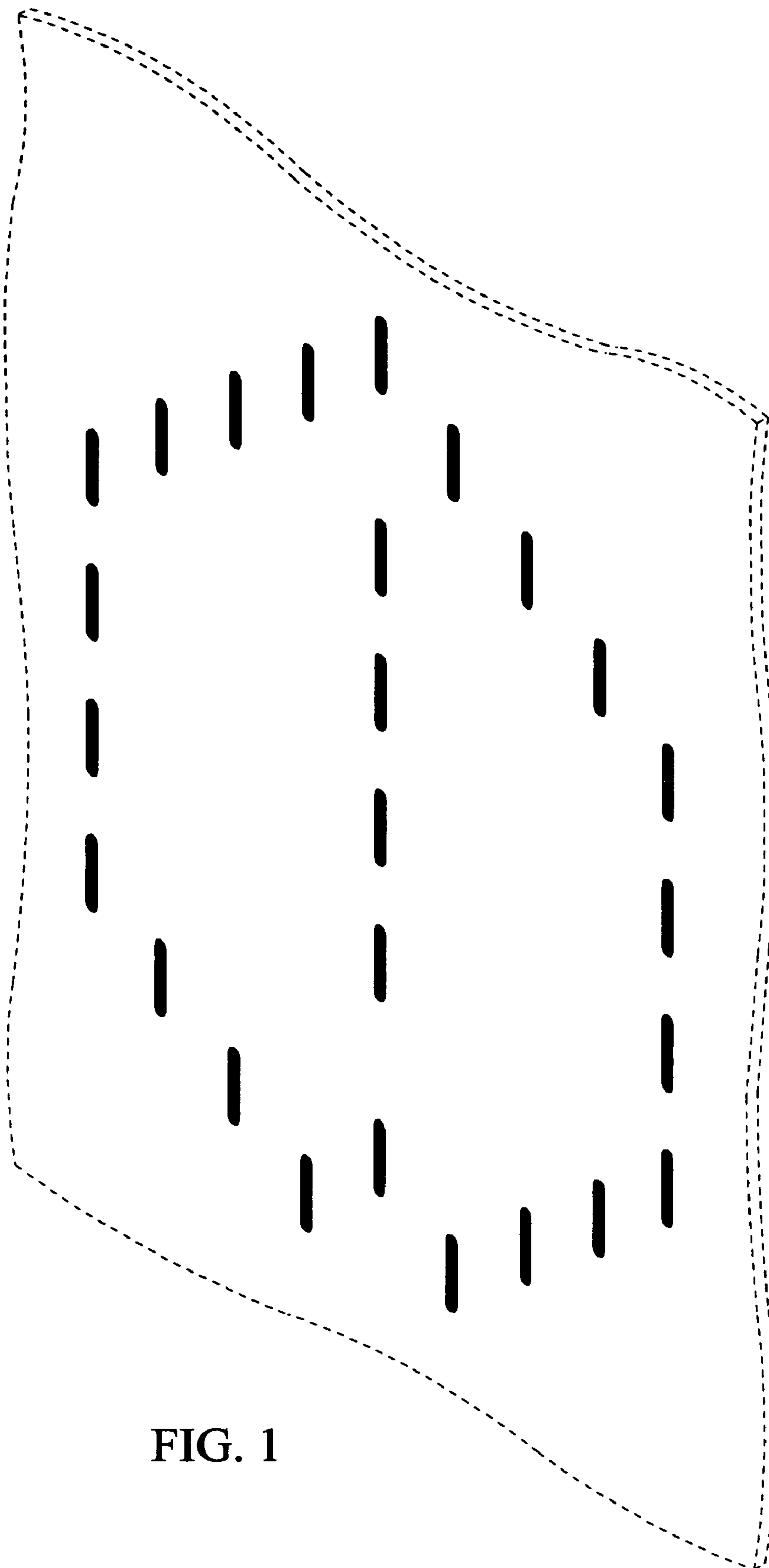

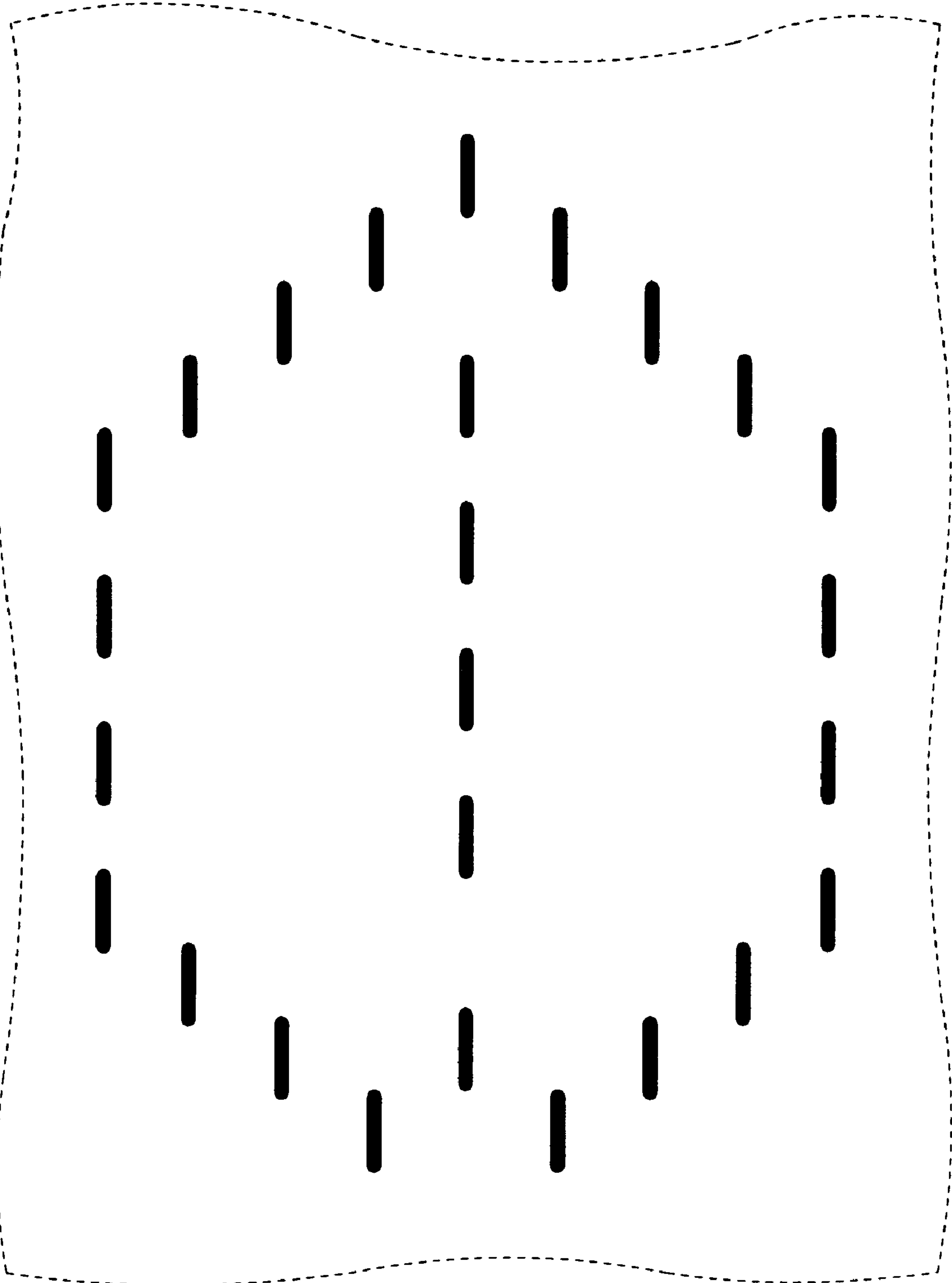

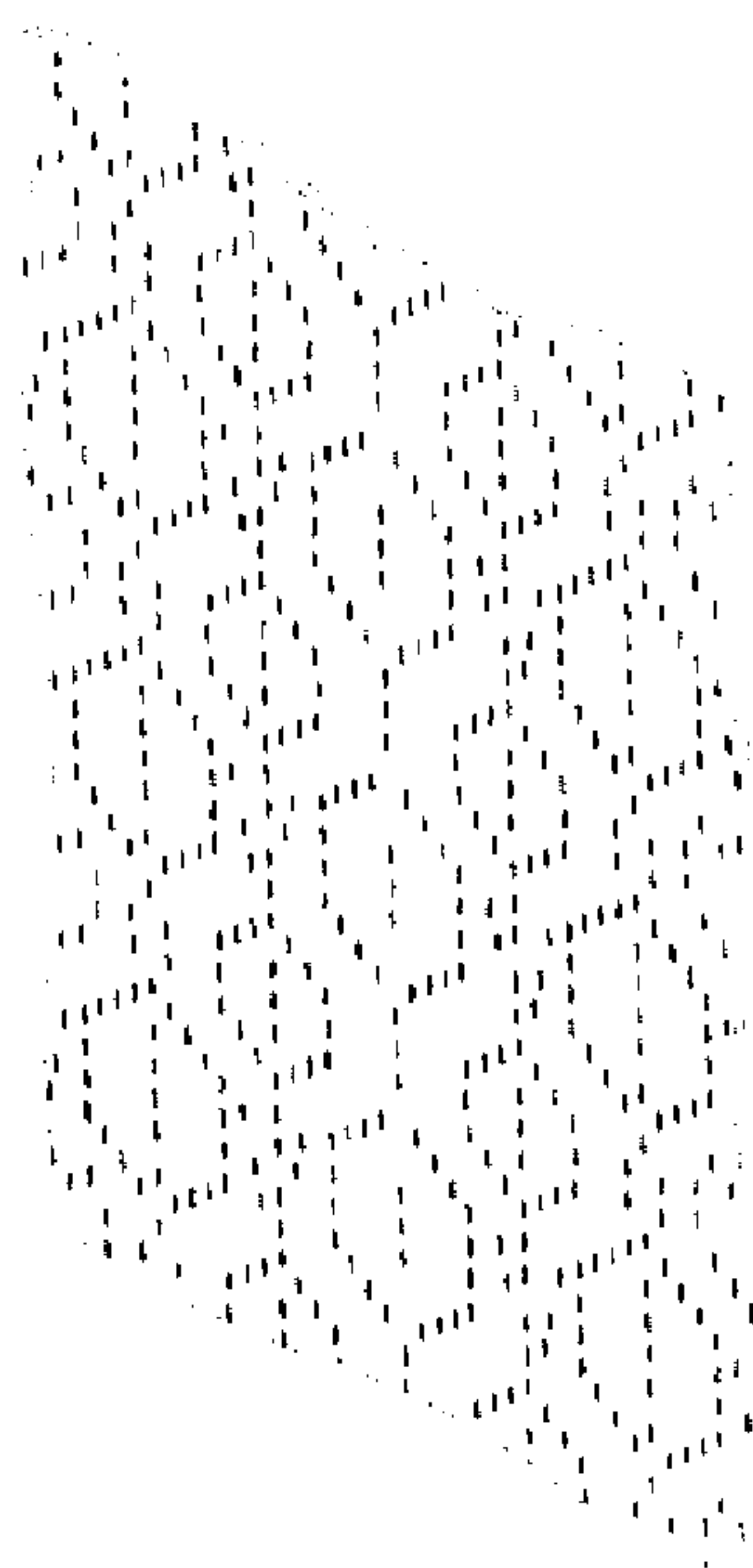

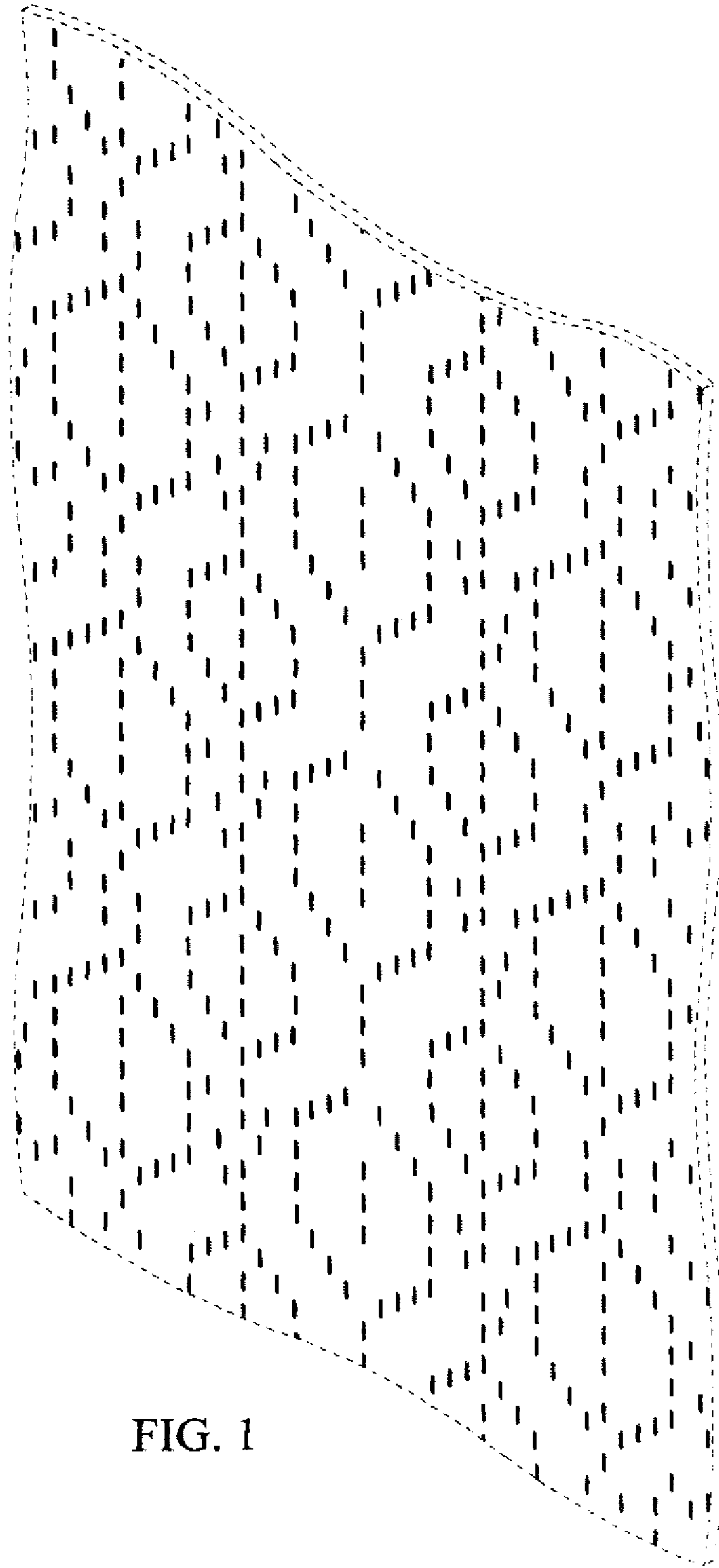

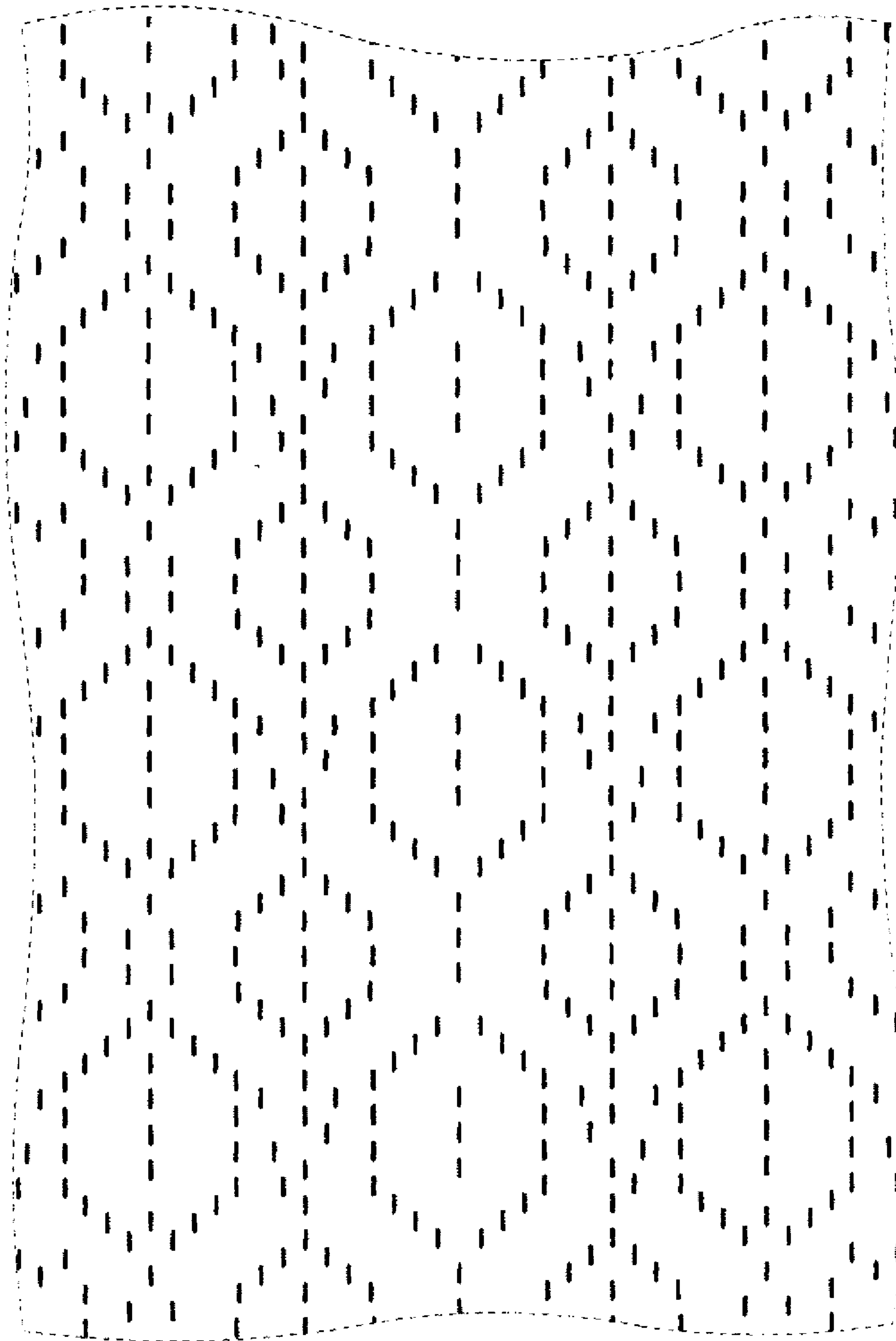
