**DESCRIPTION**

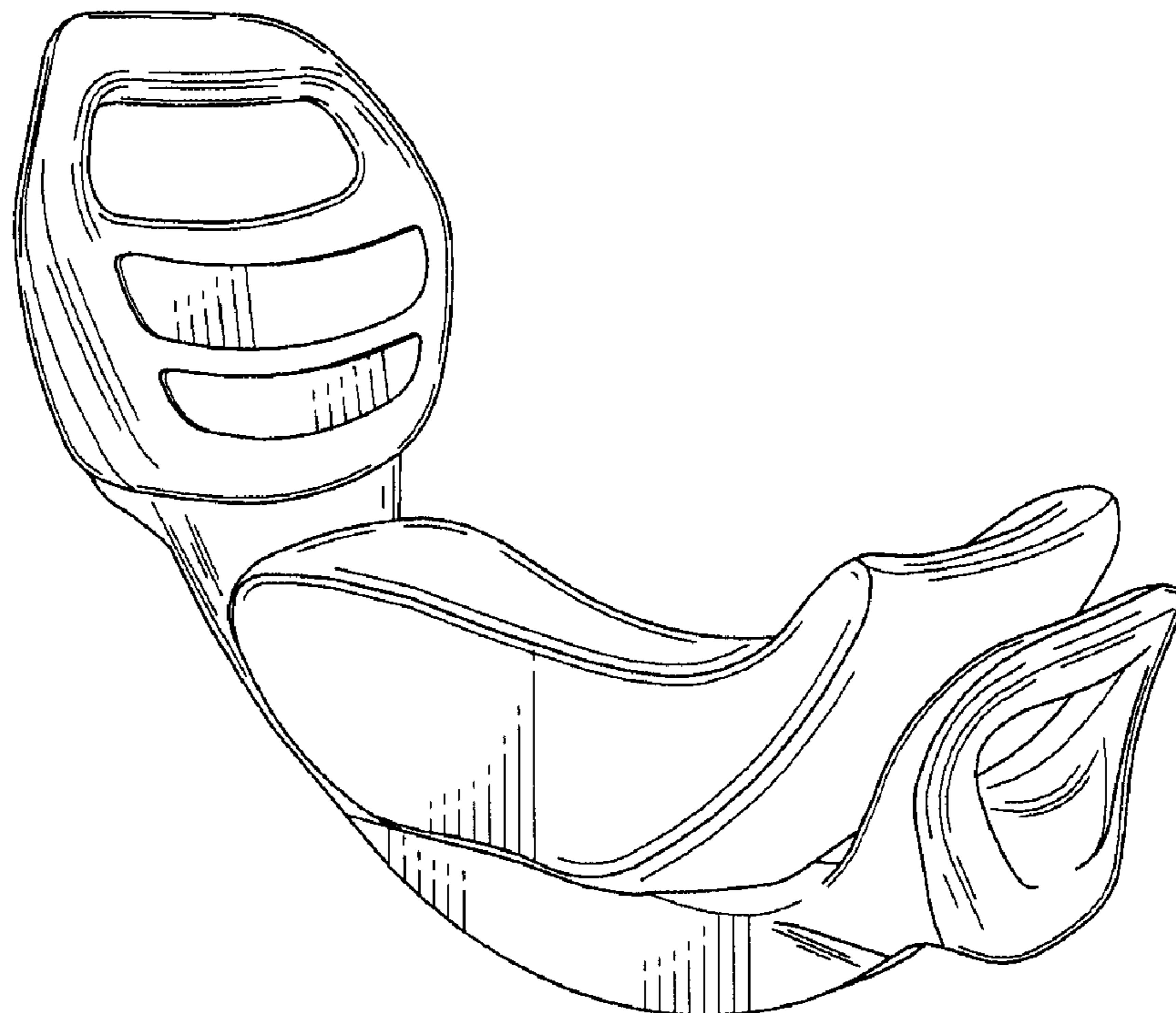

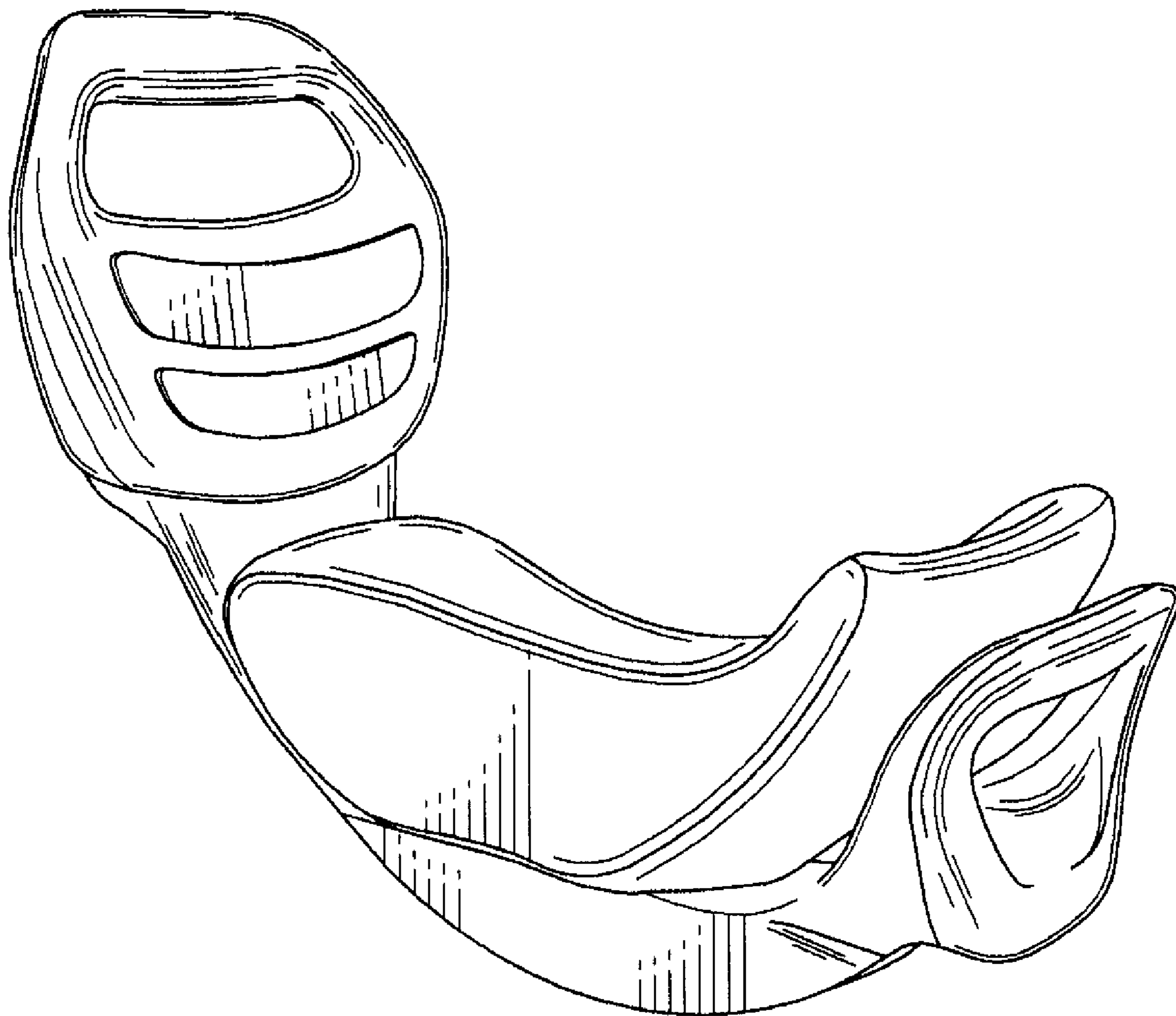
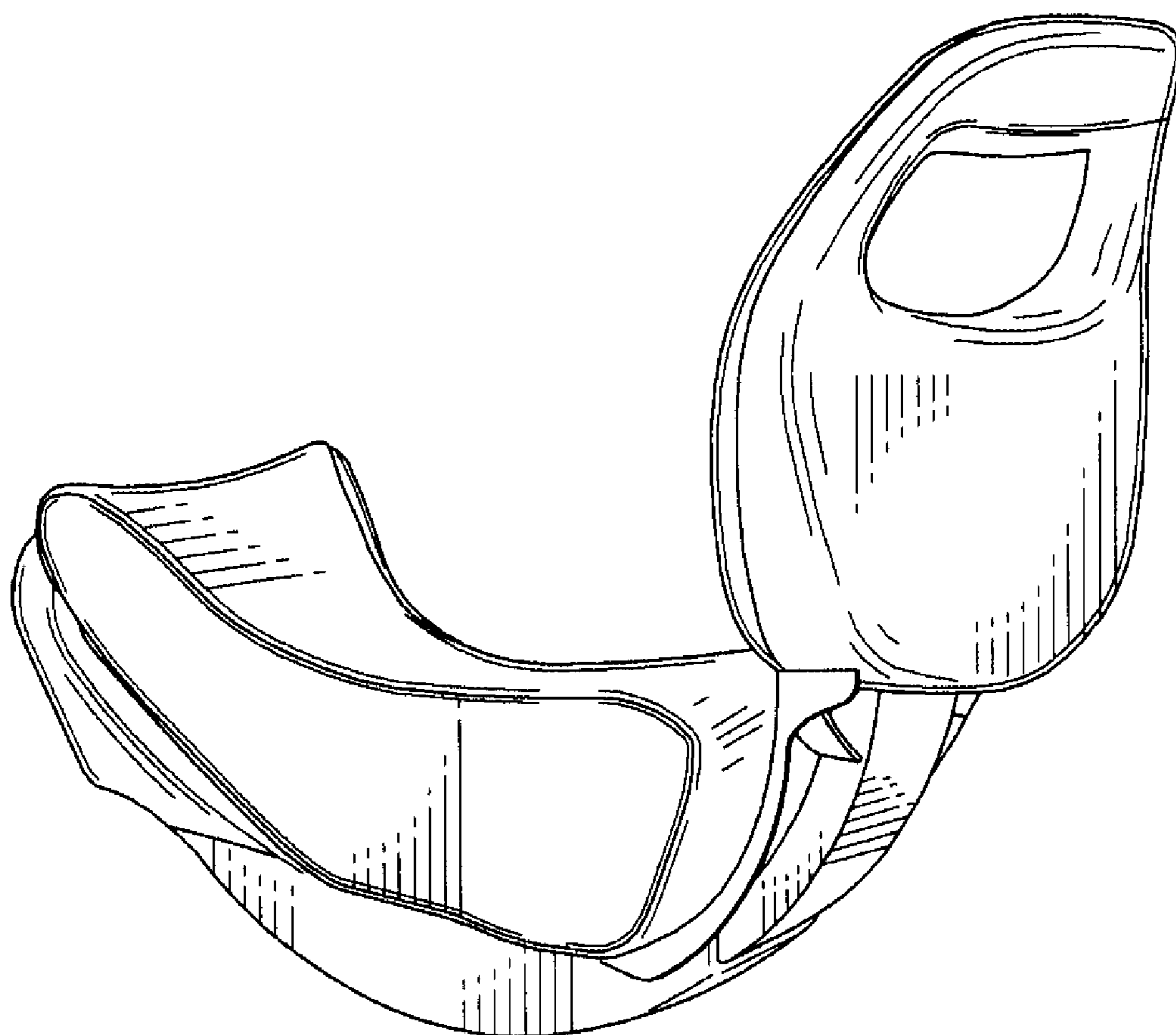
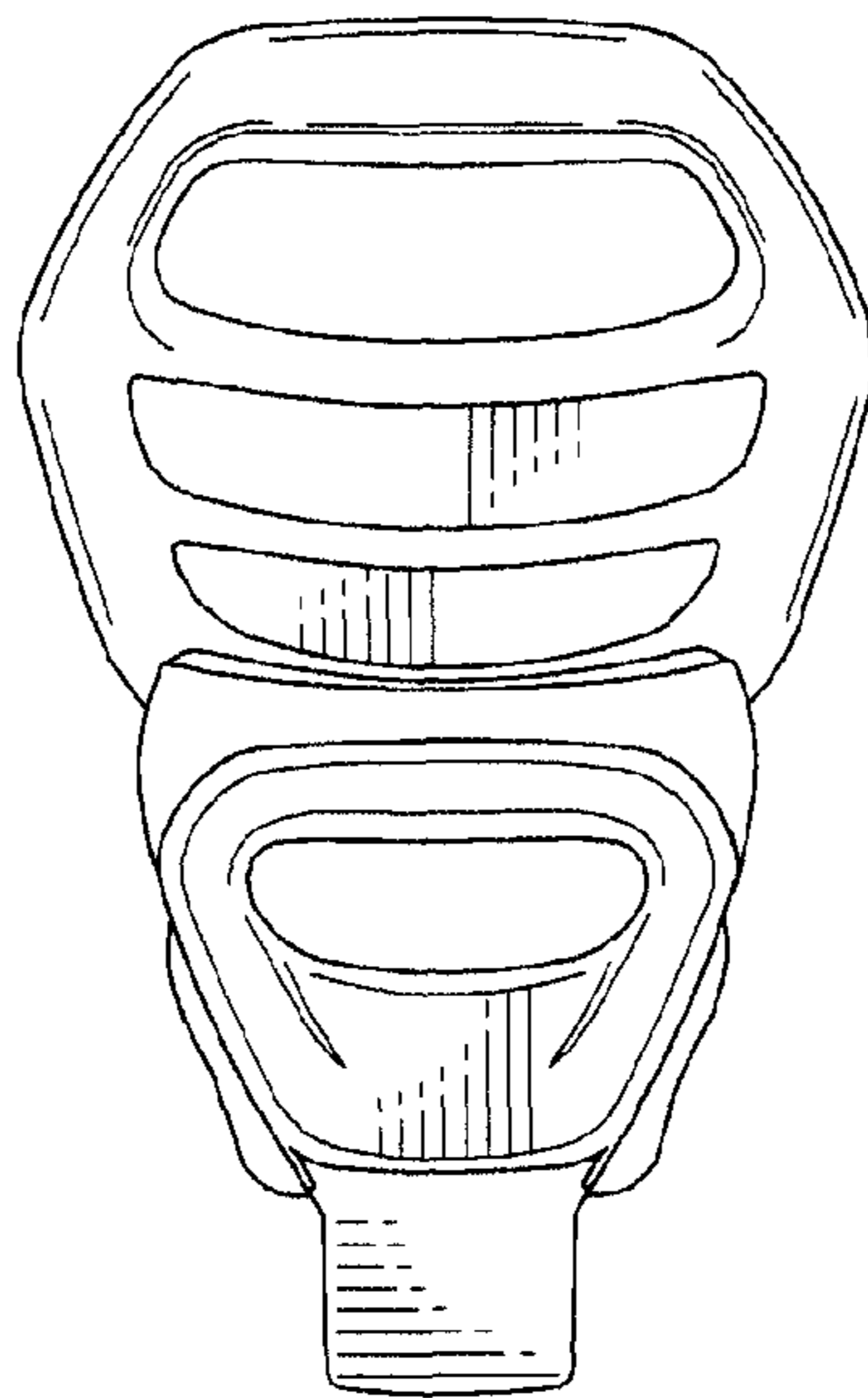

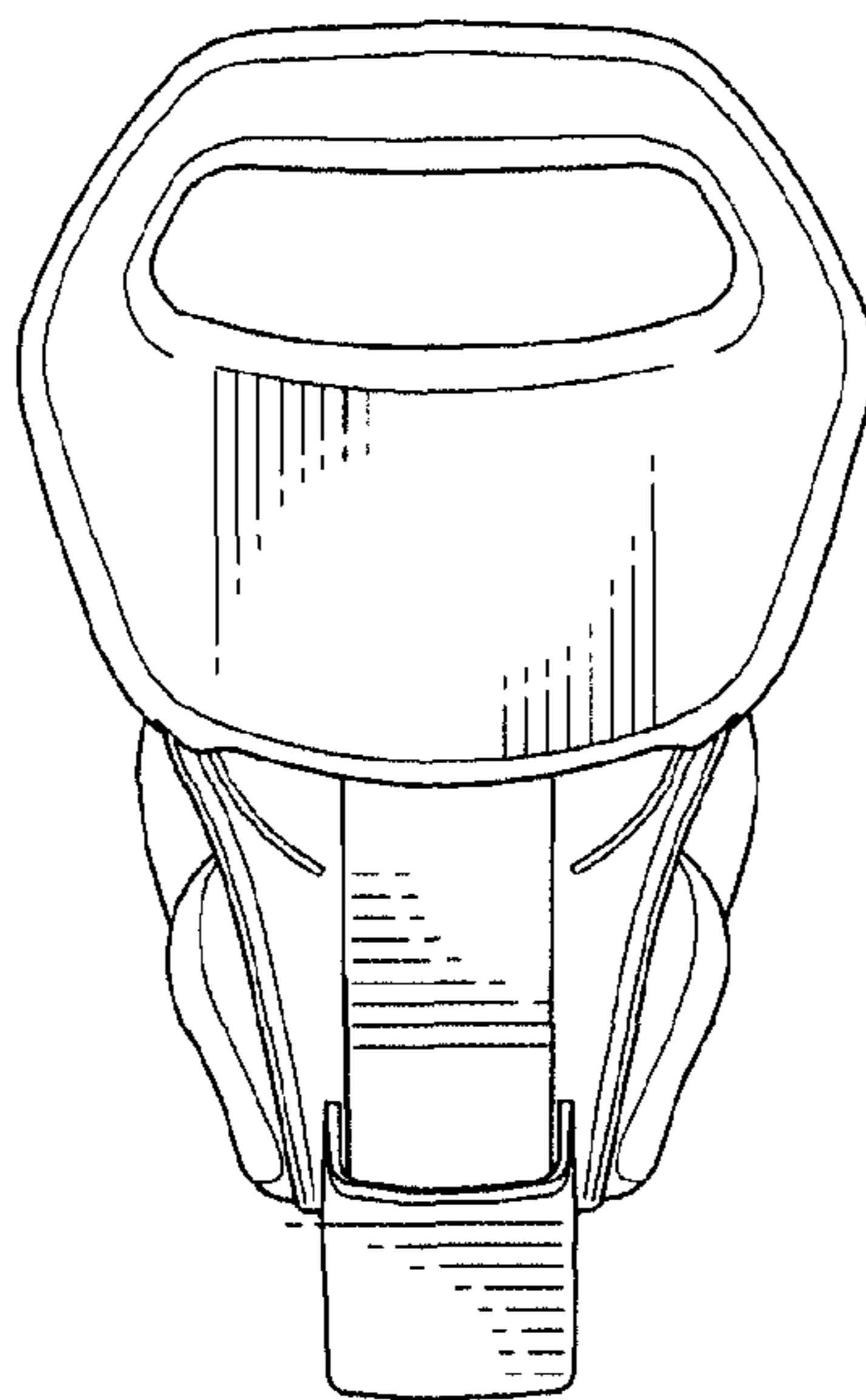
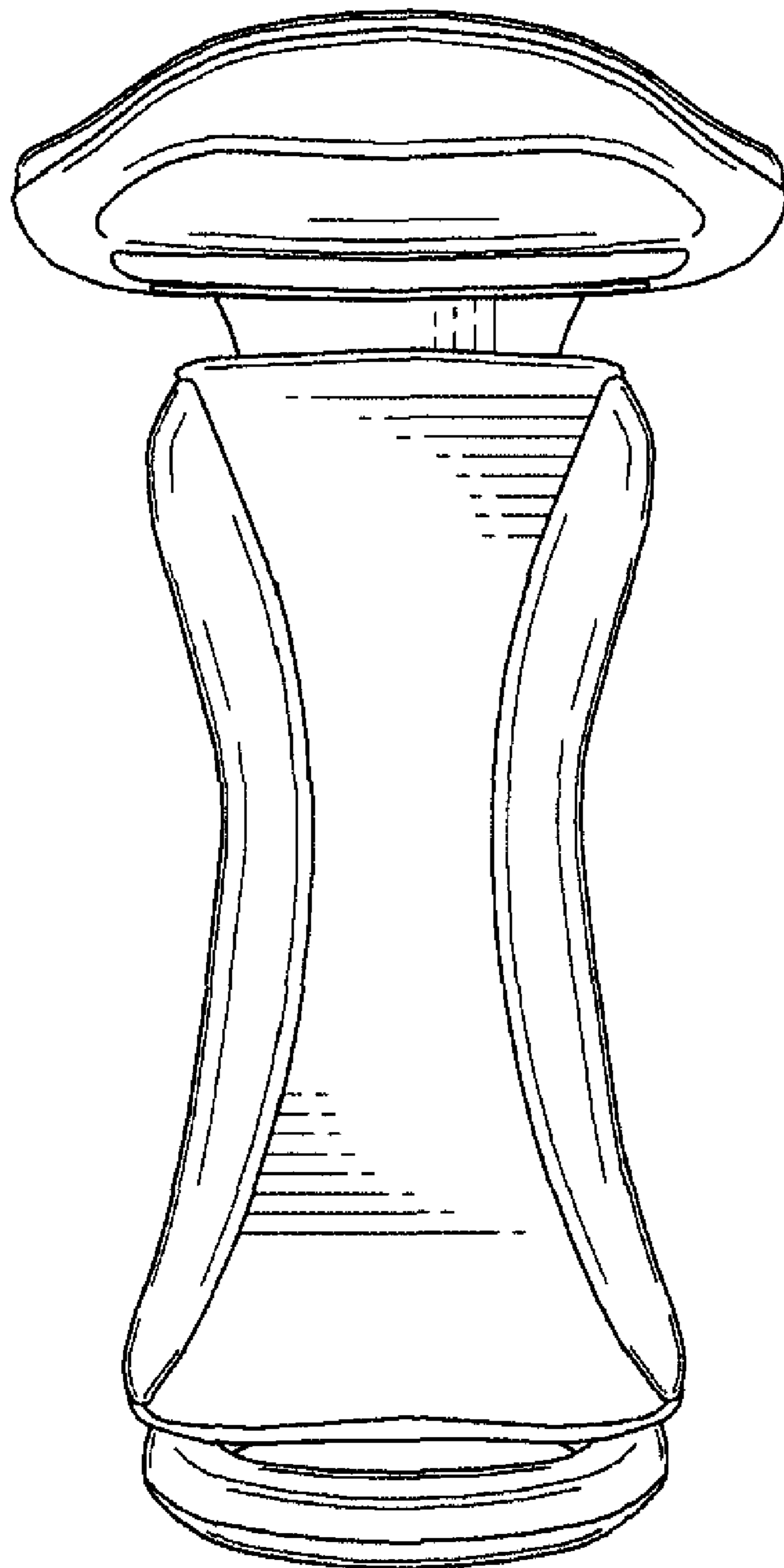
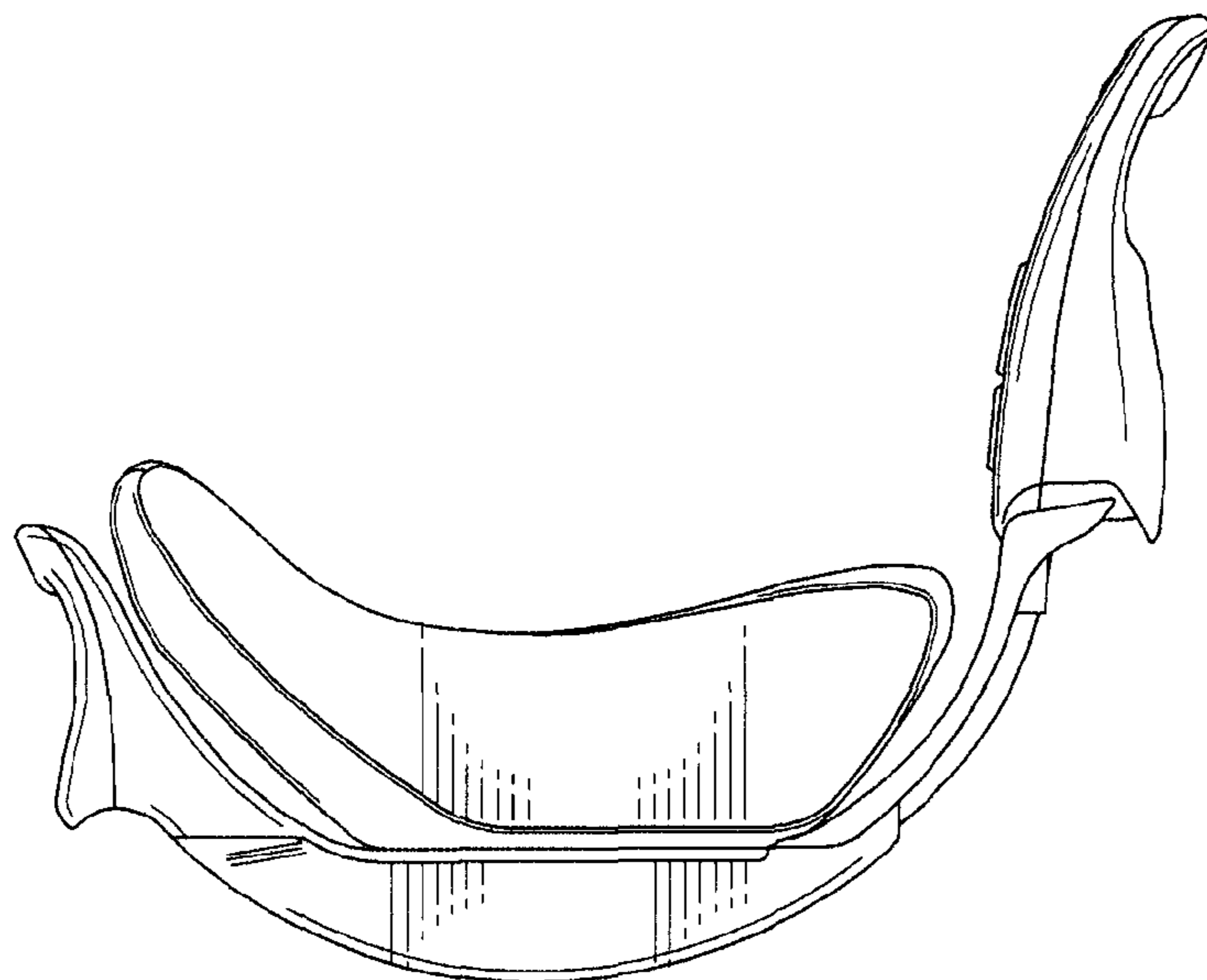
