FIG. 2 is a left-side elevation view of the passenger seating arrangement according to the invention;

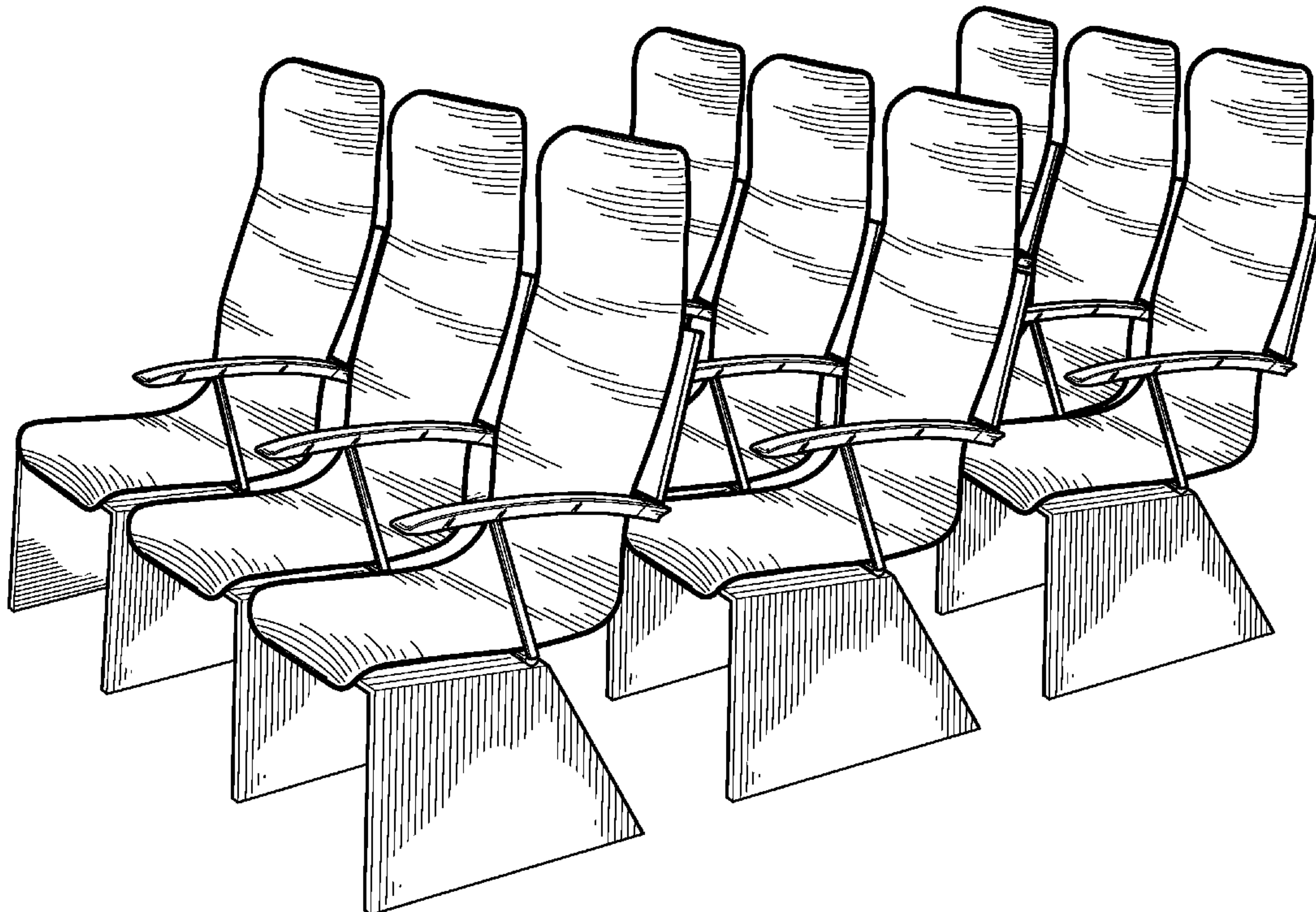
FIG. 3 is a right-side elevation view of the passenger seating arrangement according to the invention

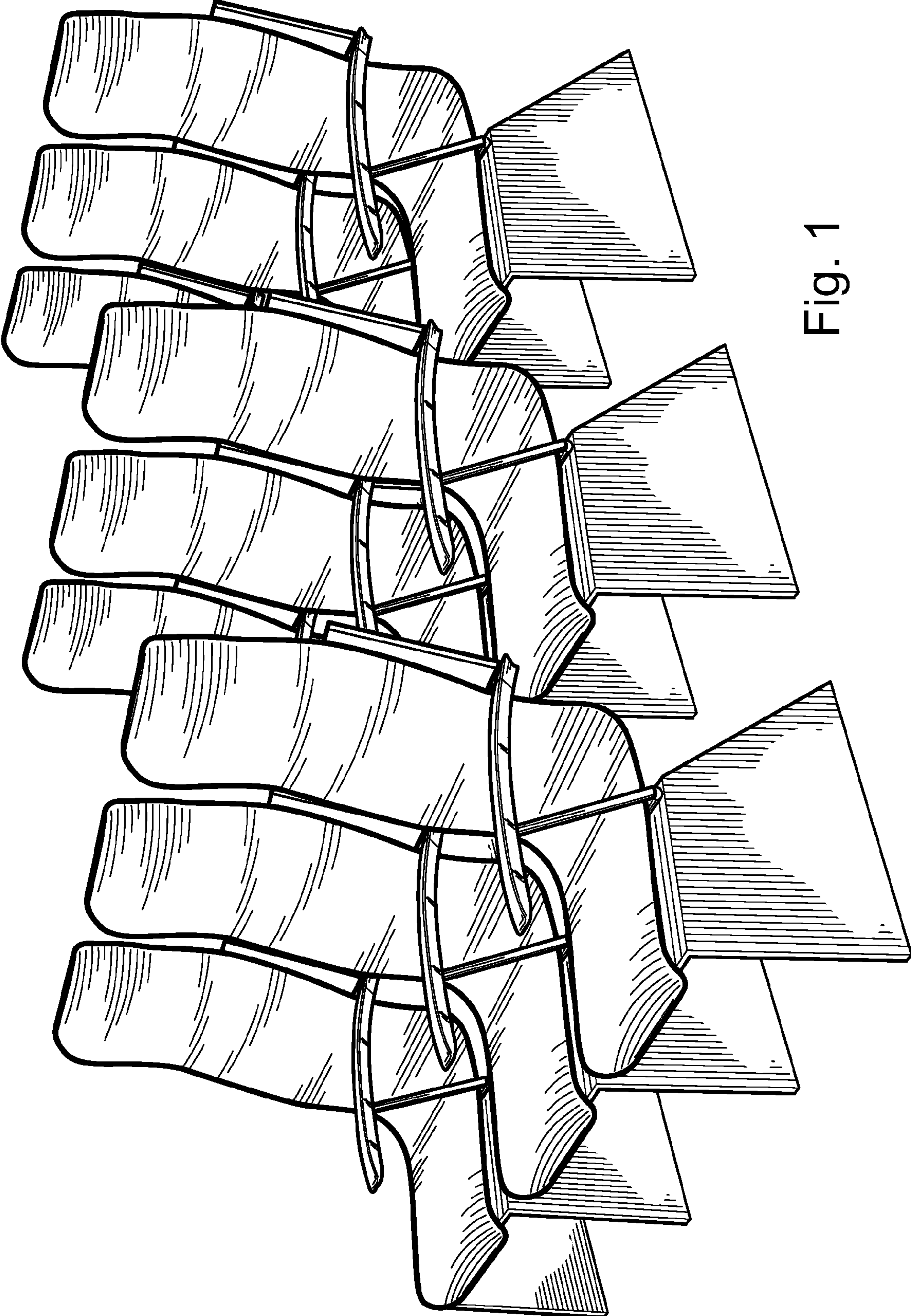

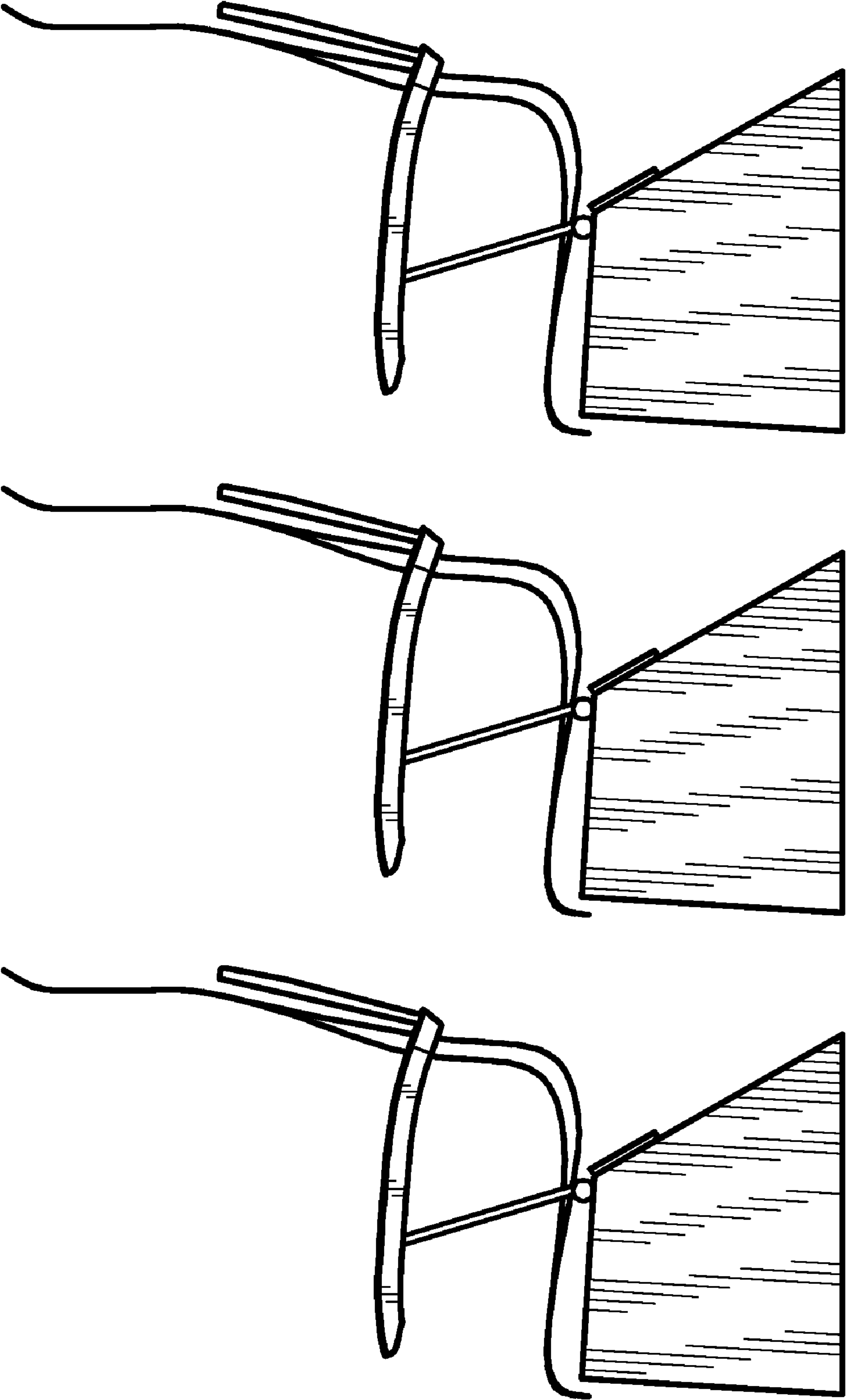

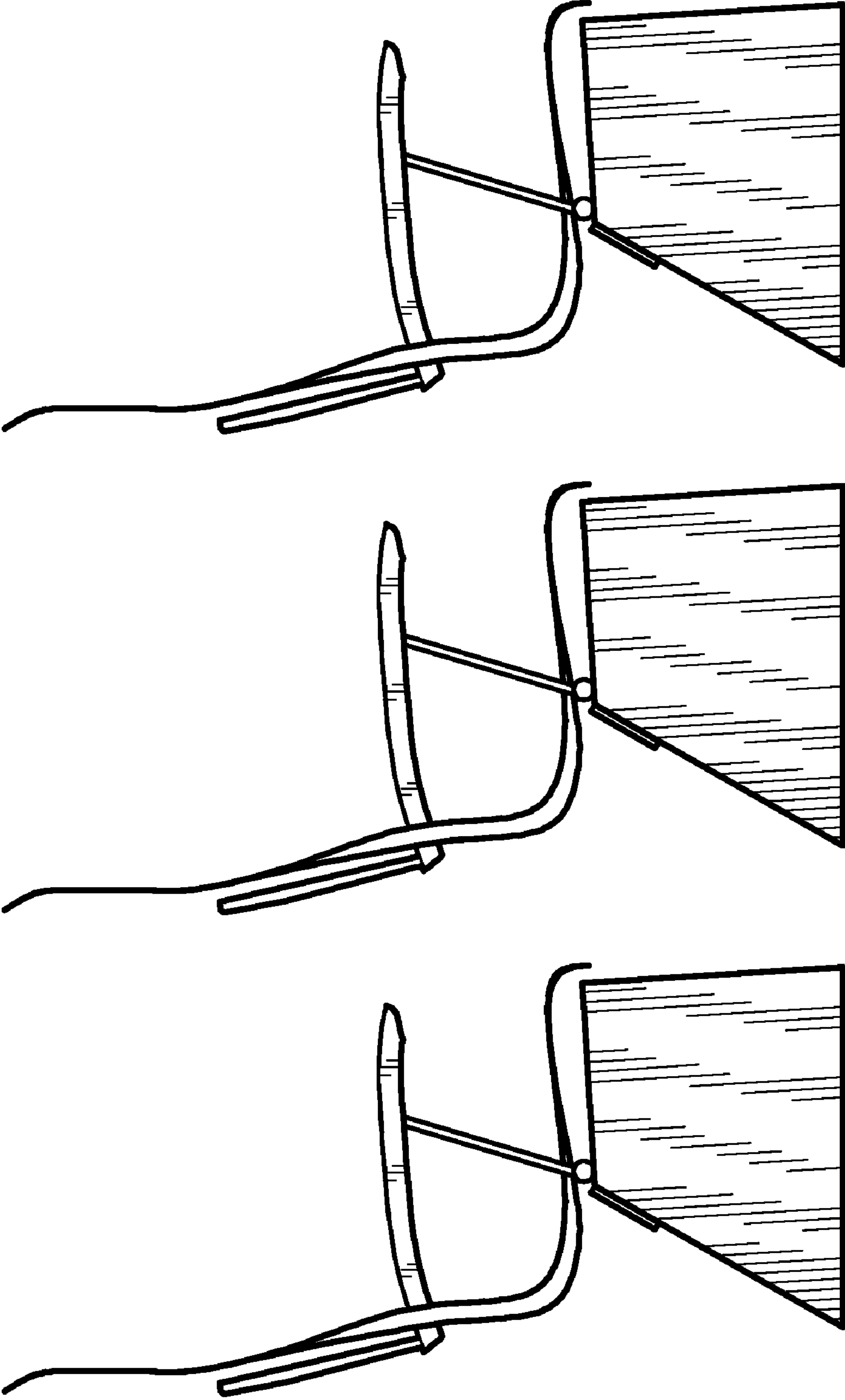

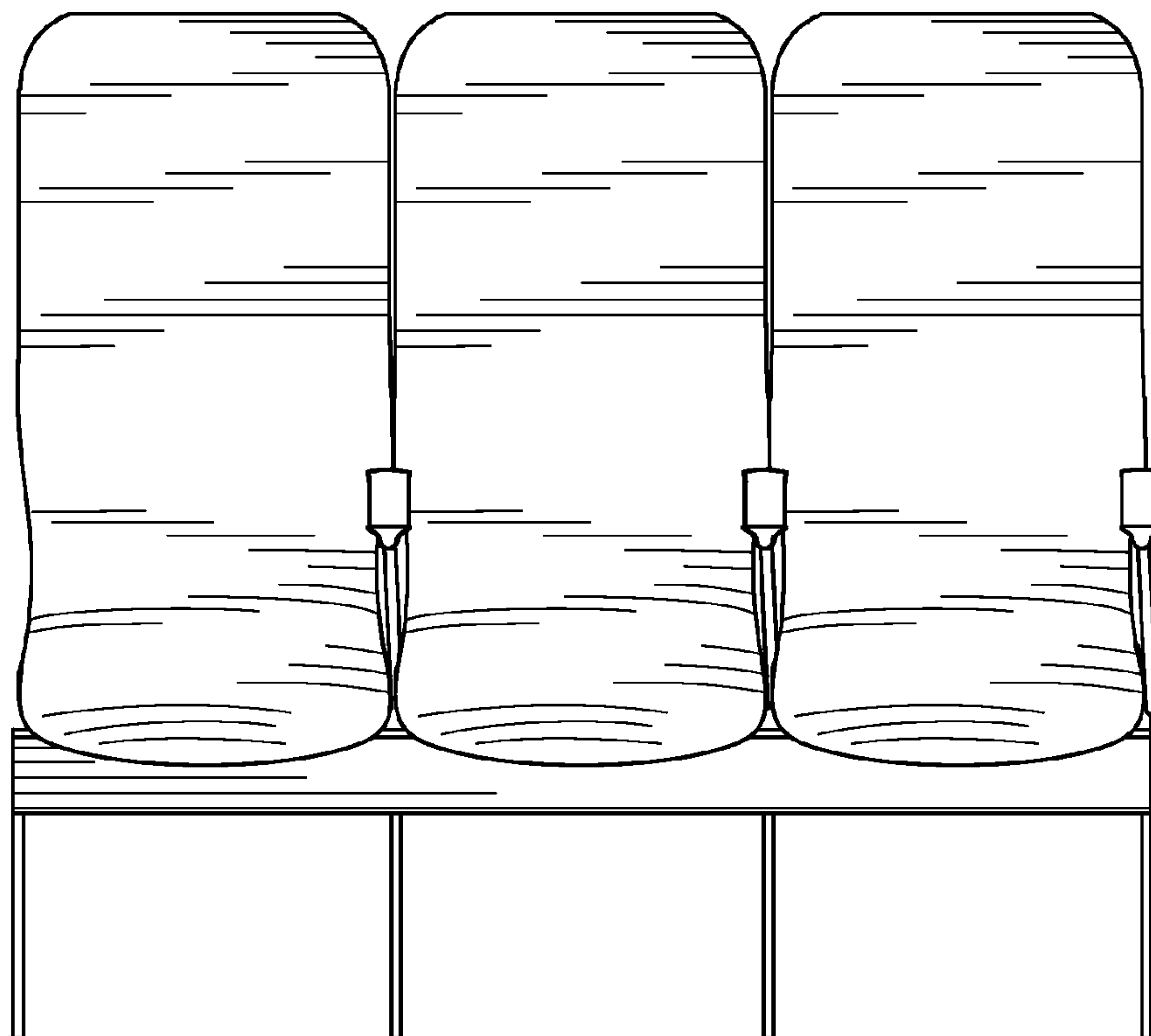

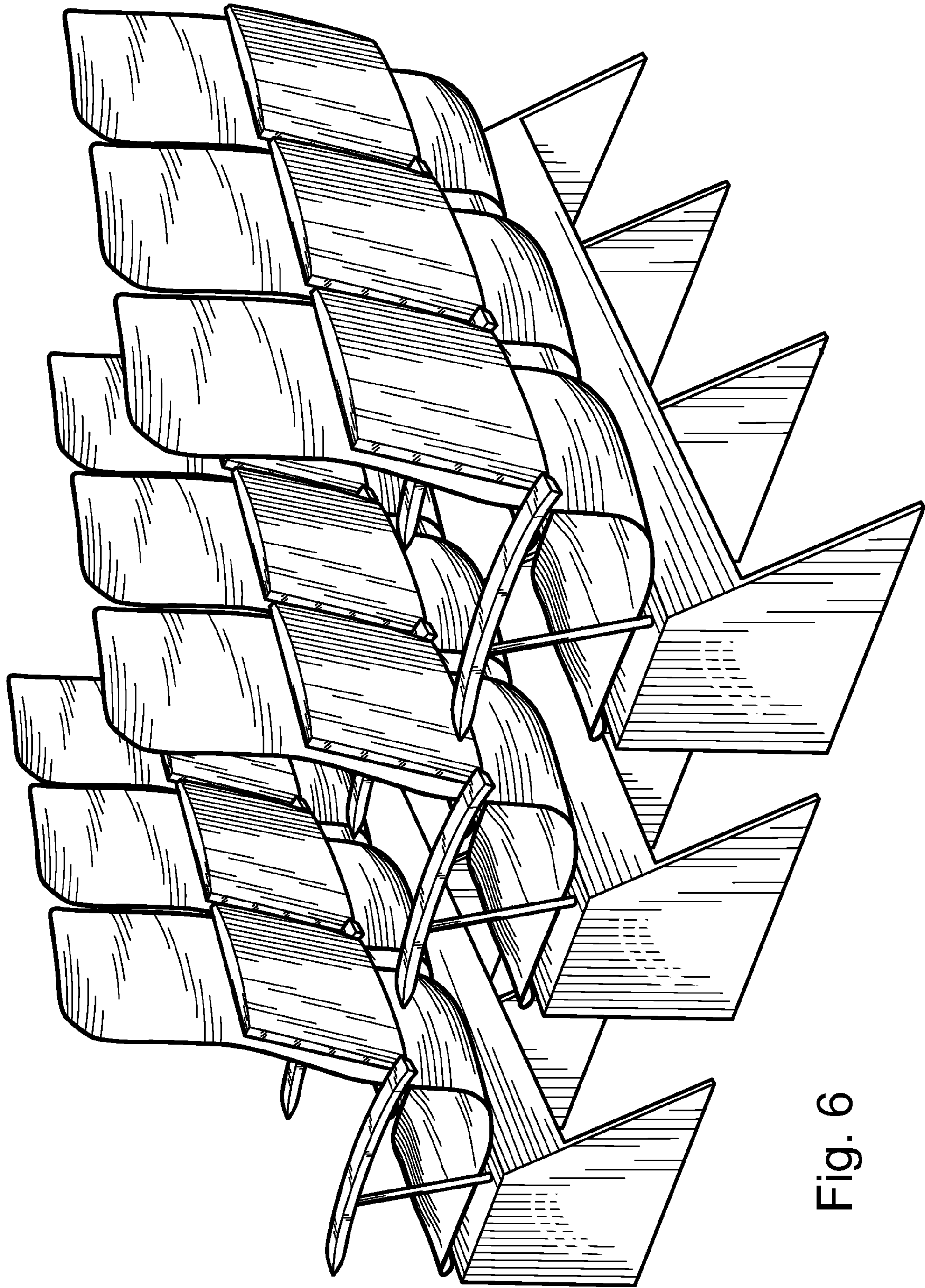
