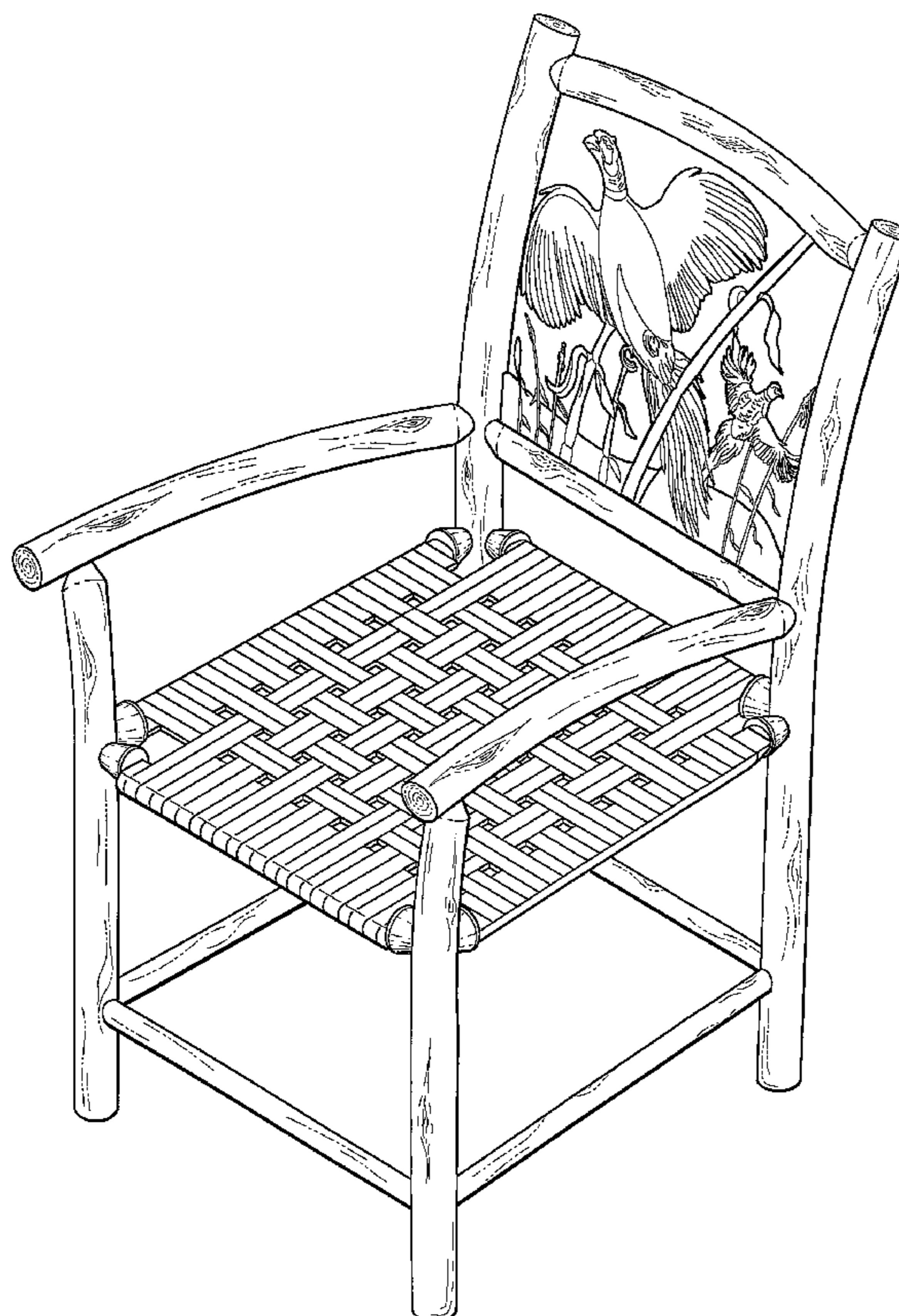

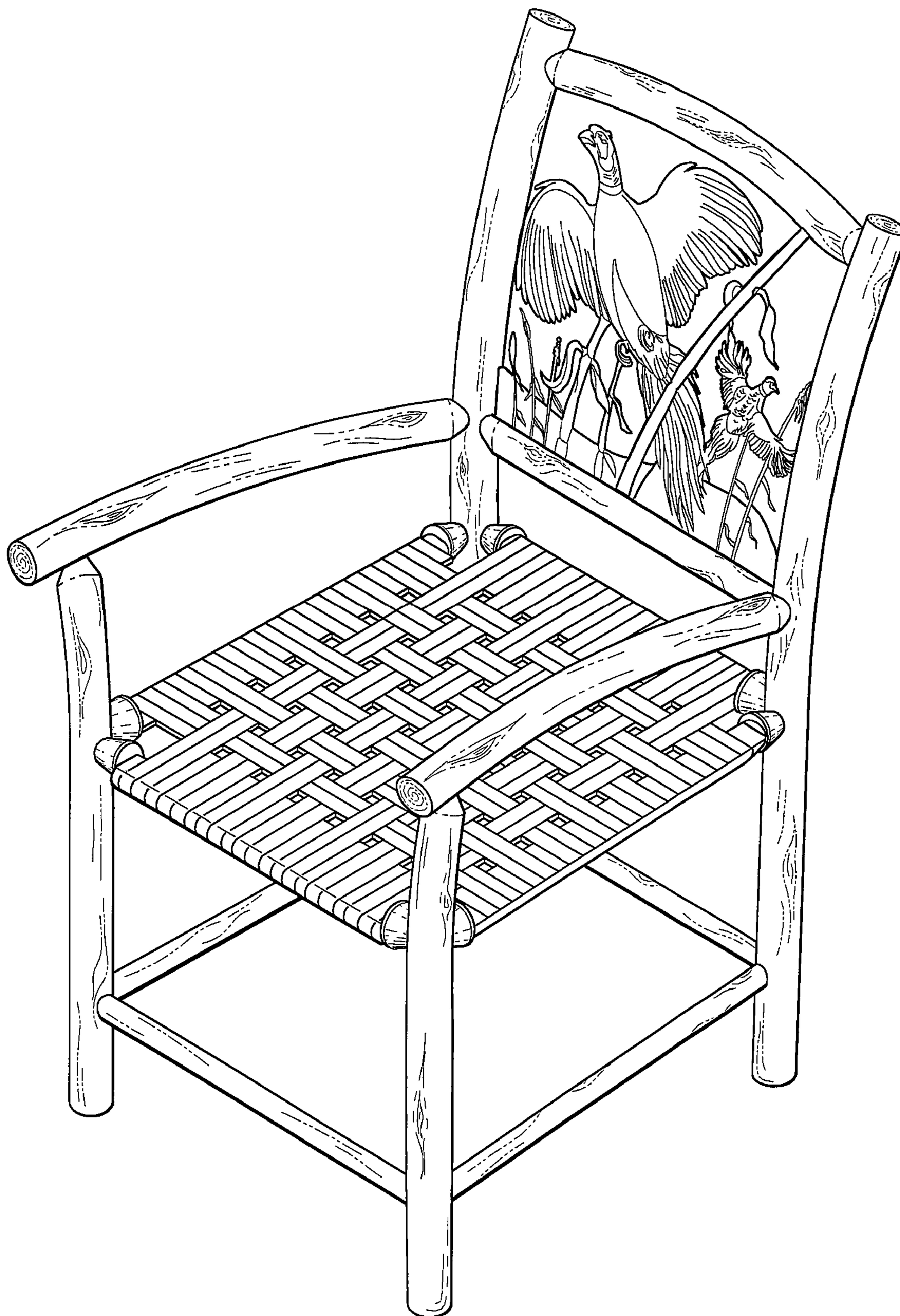
The ornamental design for a chair with animal design back, as shown and described.

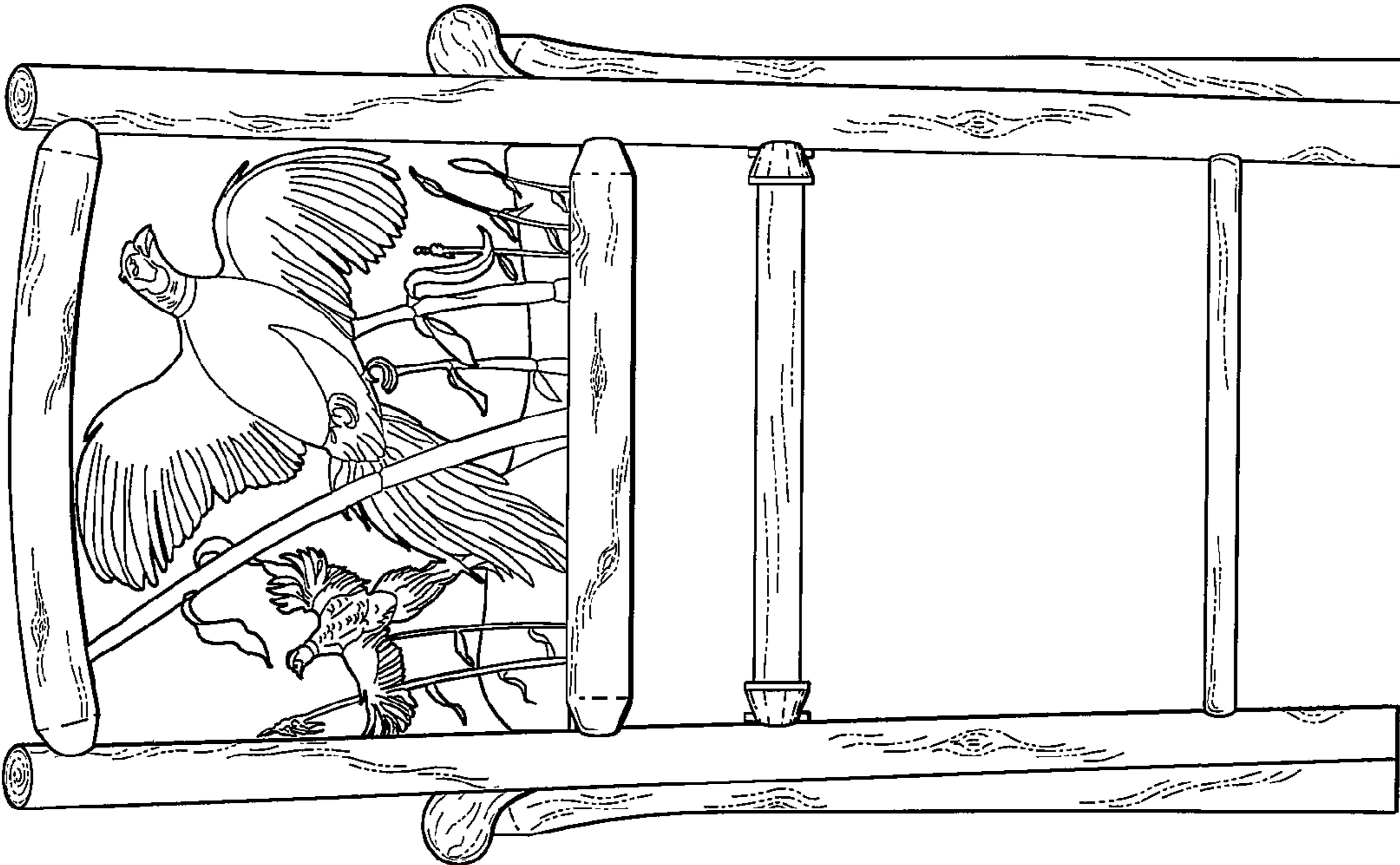

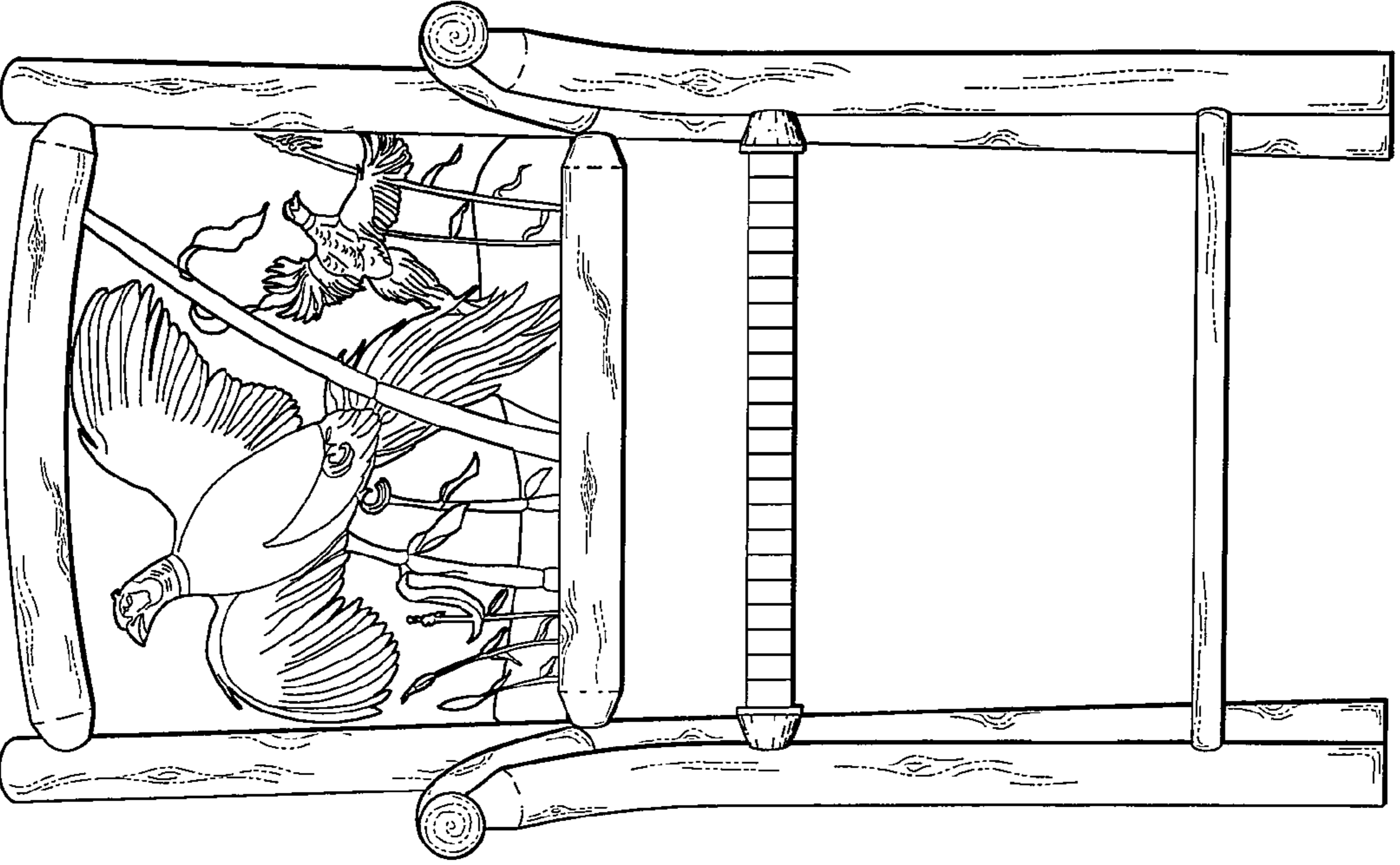

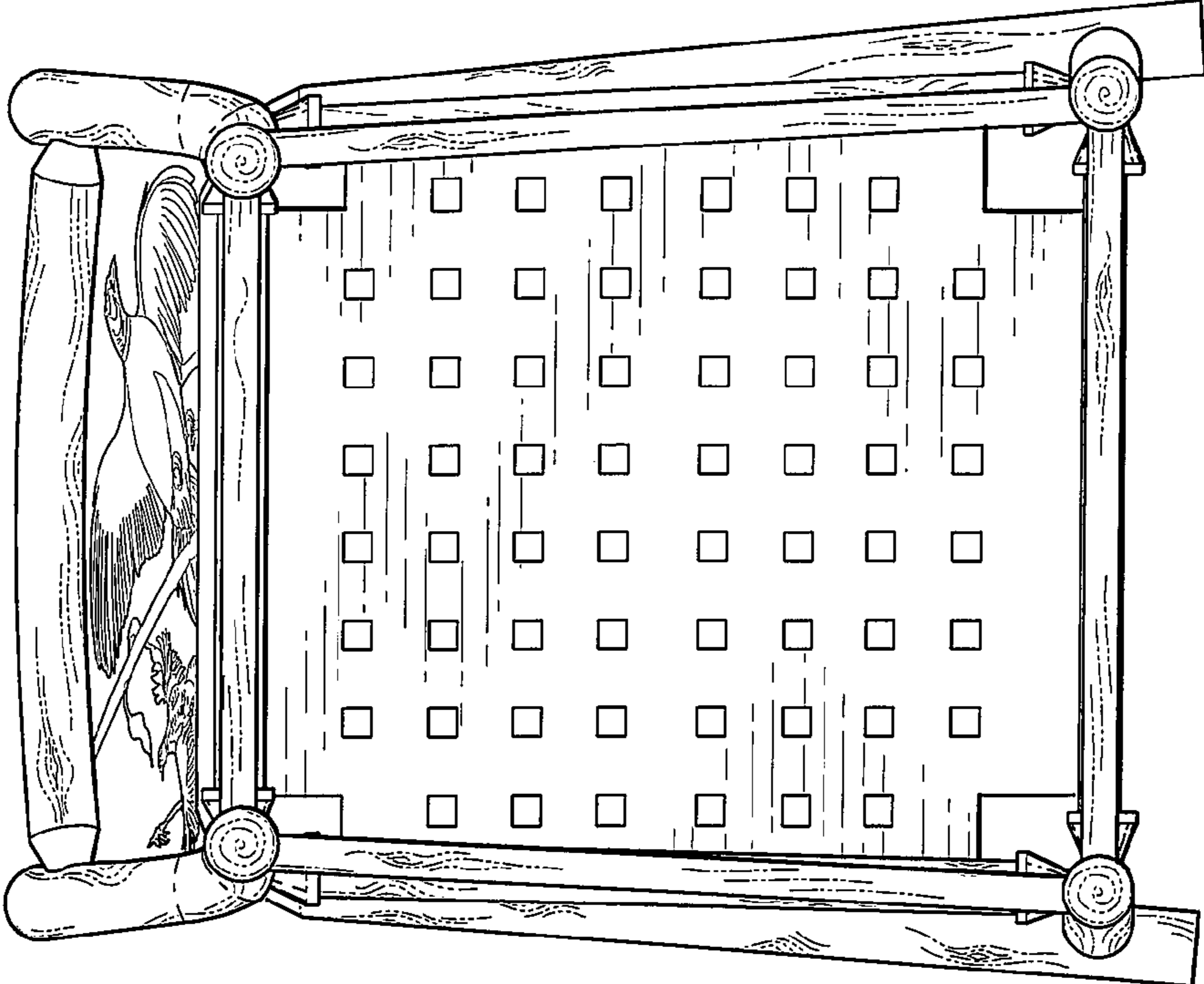

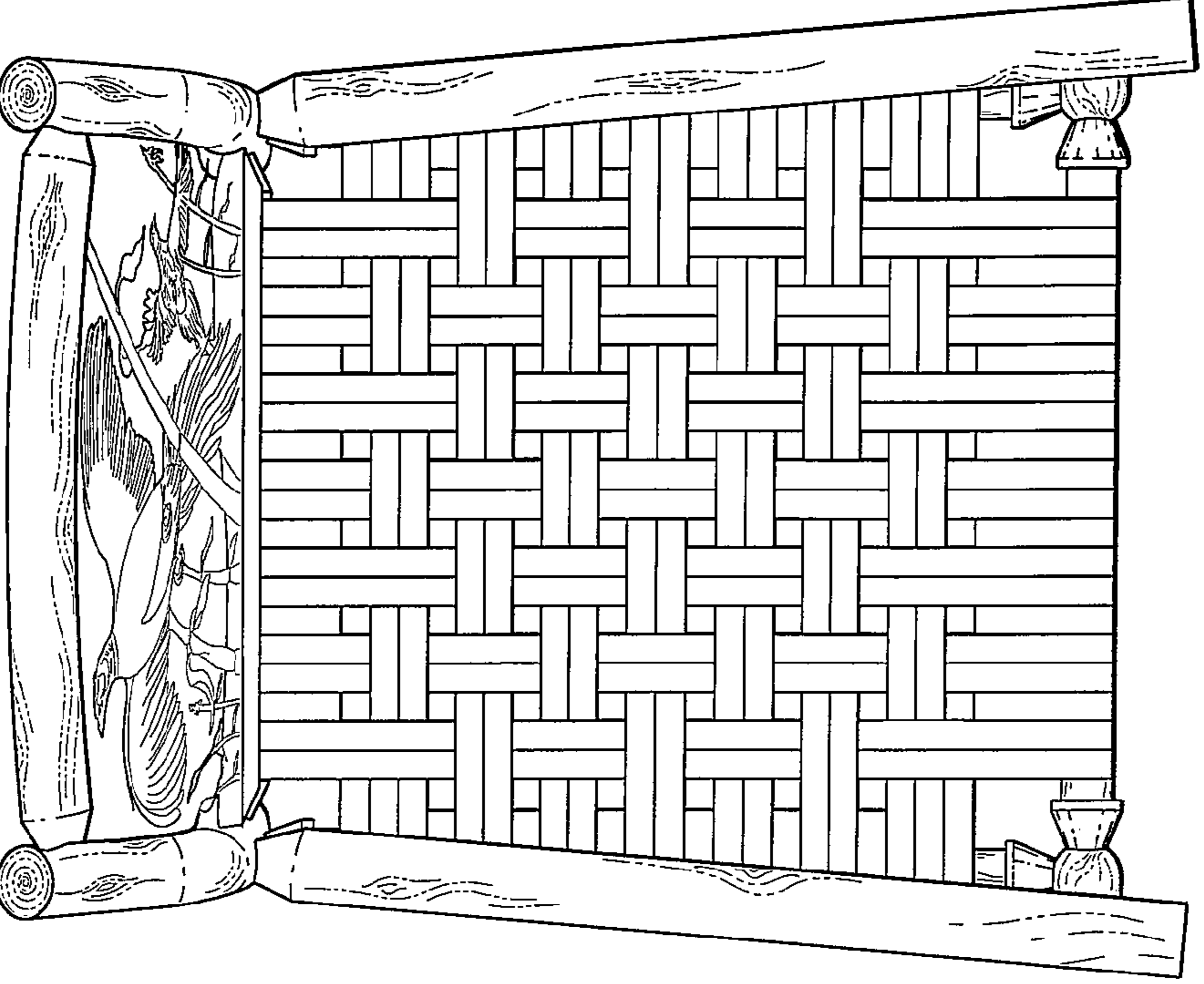
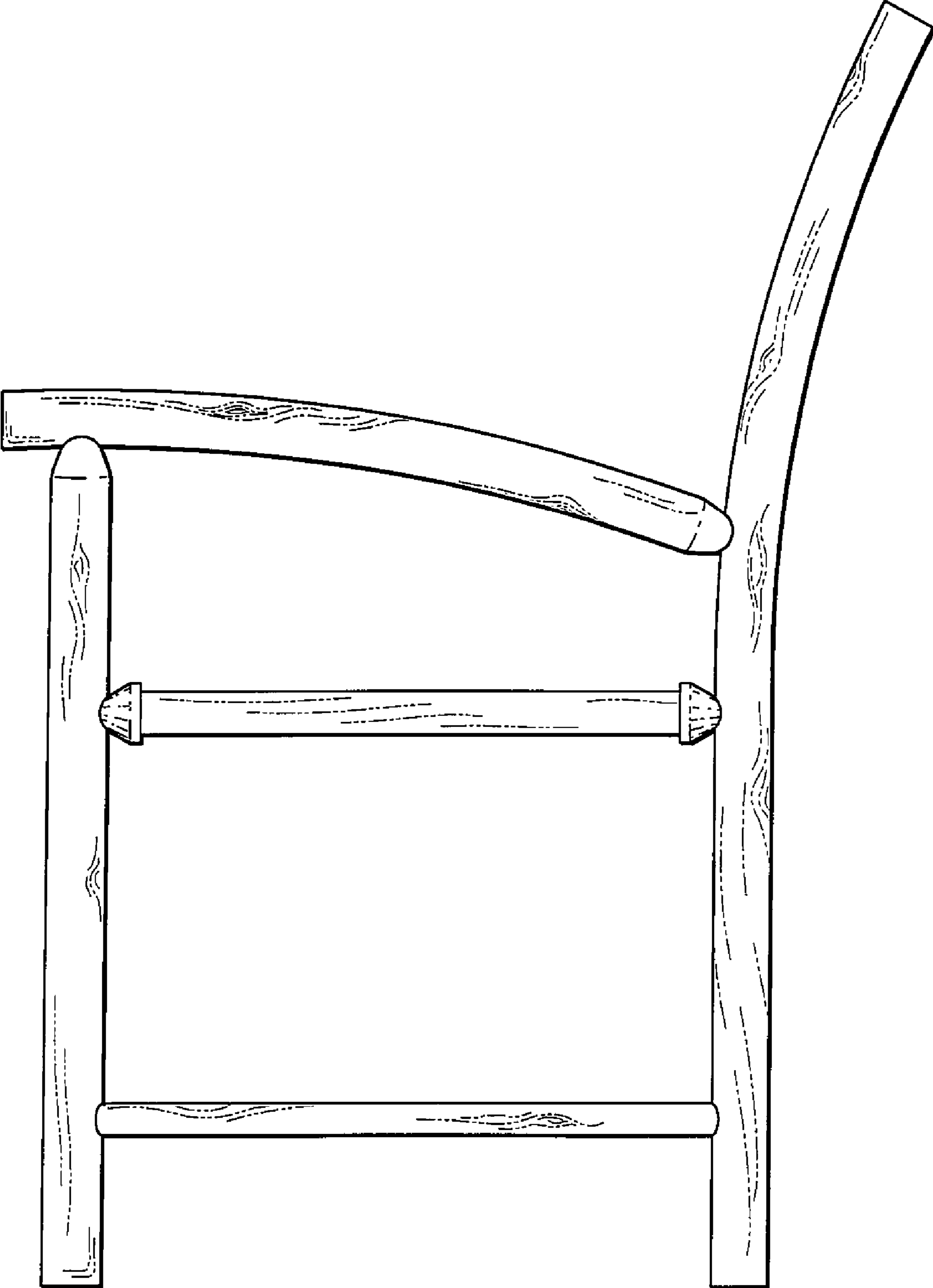
