(57) **CLAIM**

I claim the ornamental design for a pillow, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pillow, according to my new design.

FIG. 2 is a bottom plan view of the pillow of FIG. 1.

FIG. 3 is a top plan view of the pillow of FIG. 1.

FIG. 4 is a left side view of the pillow of FIG. 1.

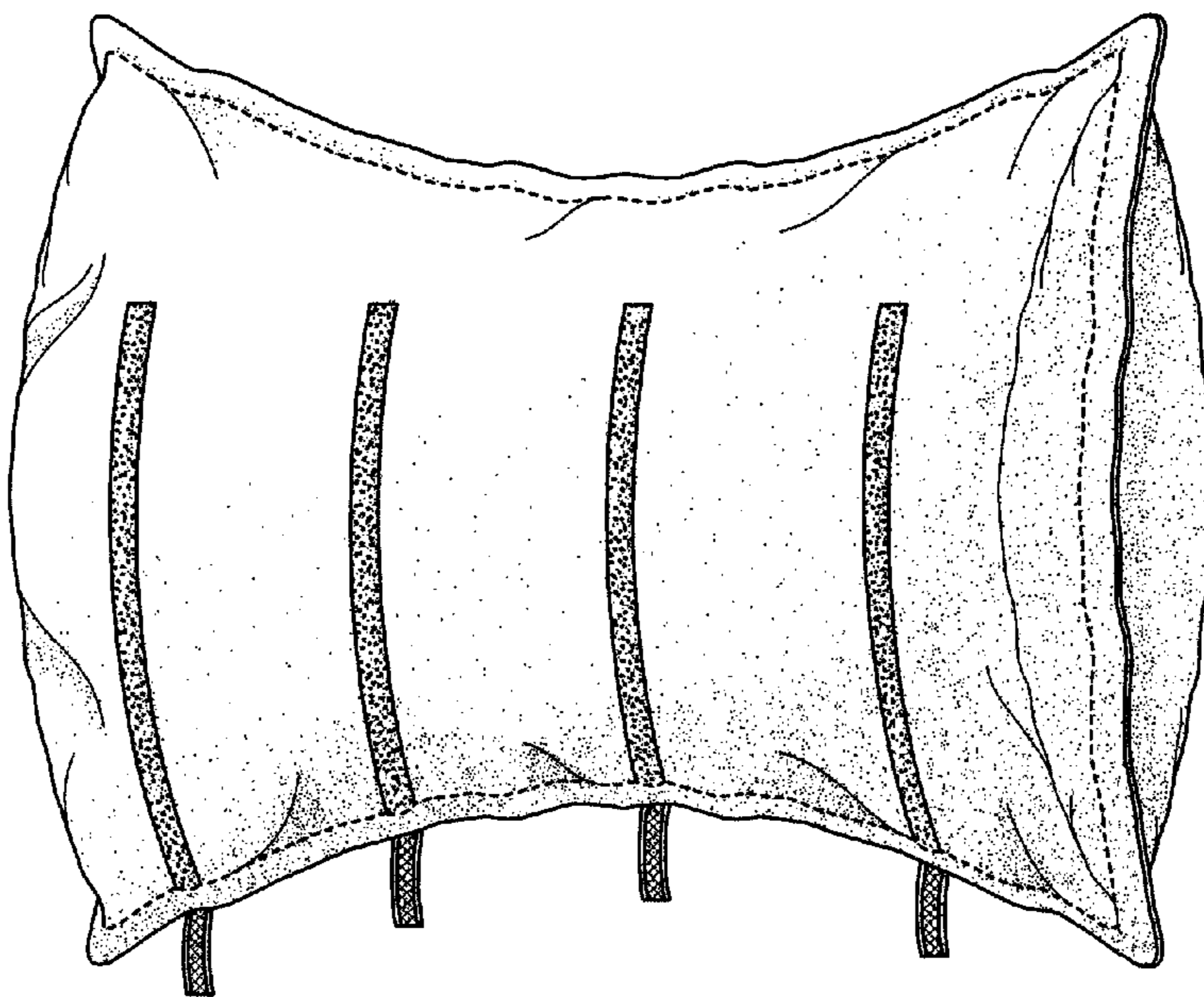
FIG. 5 is a right side view of the pillow of FIG. 1.

FIG. 6 is rear view of the pillow of FIG. 1; and,

FIG. 7 is a front view of the pillow of FIG. 1.

The broken lines in the drawings represent stitch lines. The heavy stippling and the checkerboard line pattern represent strips of loop and hook fasteners, respectively.

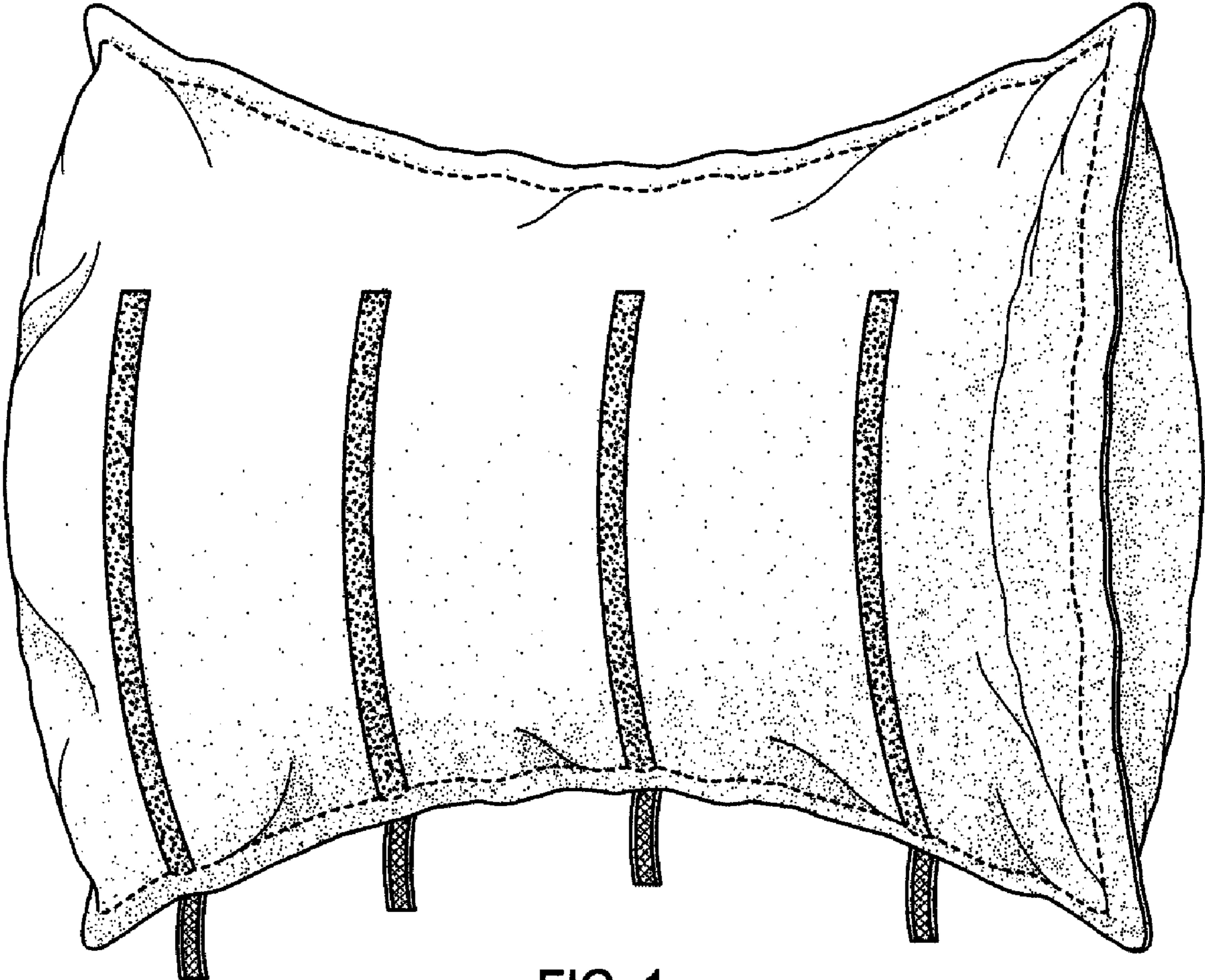

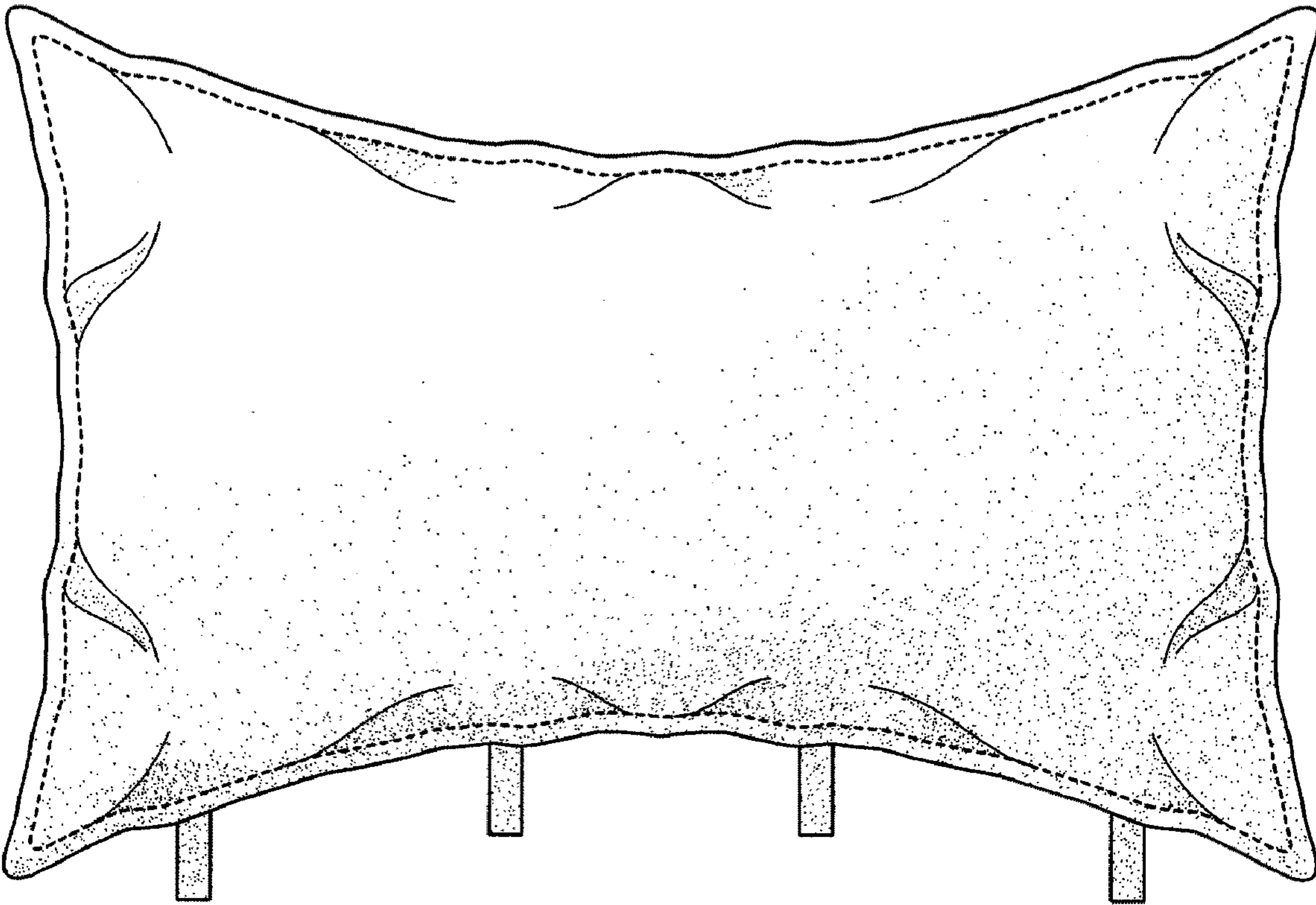

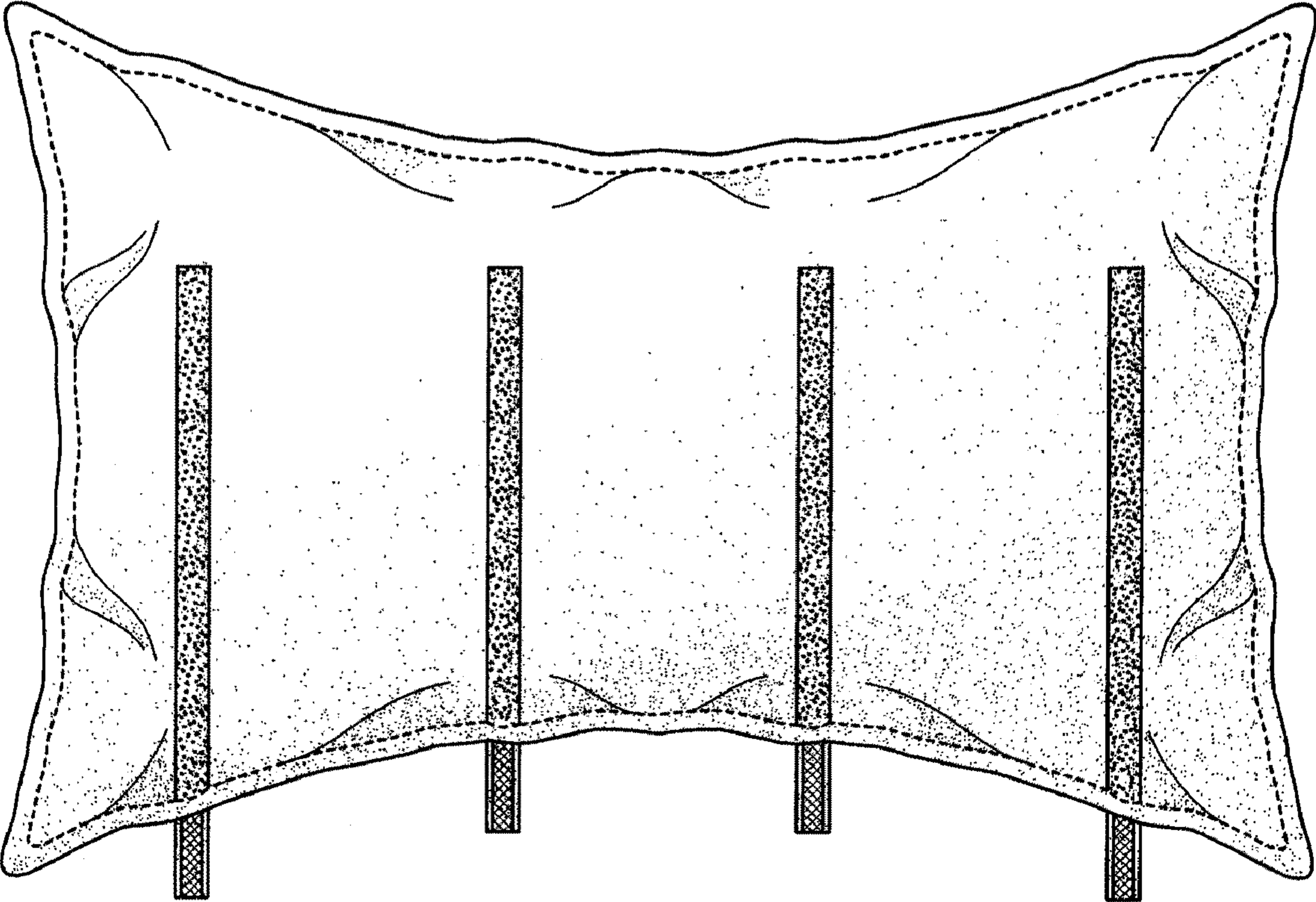

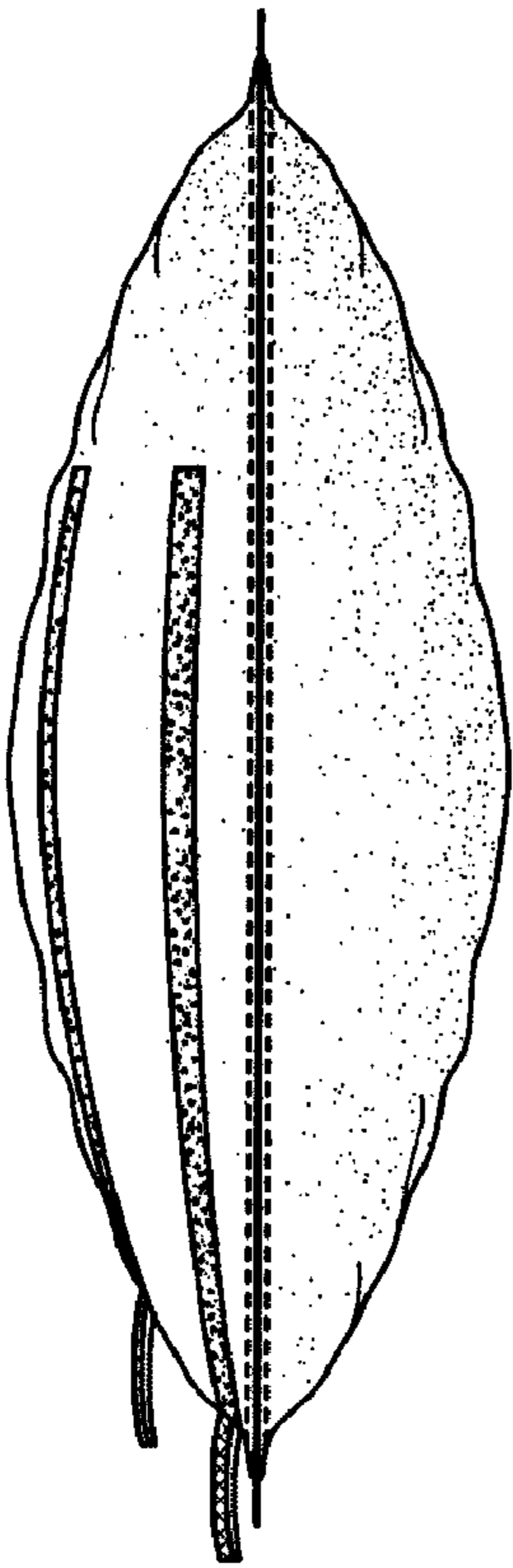

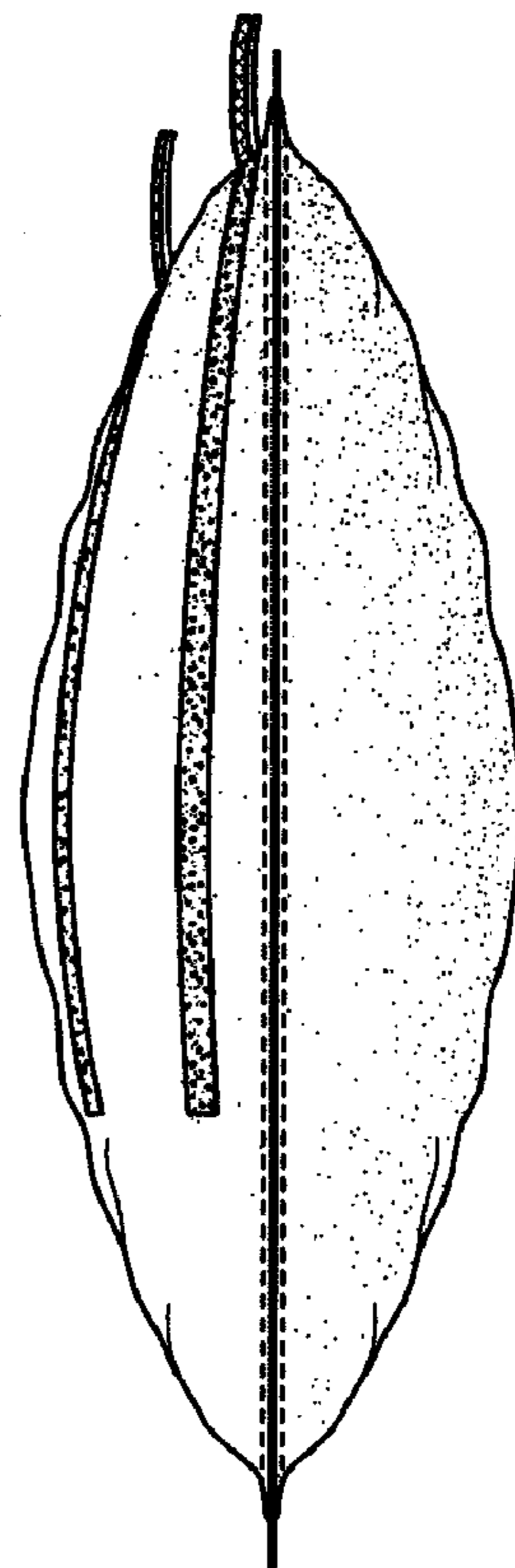

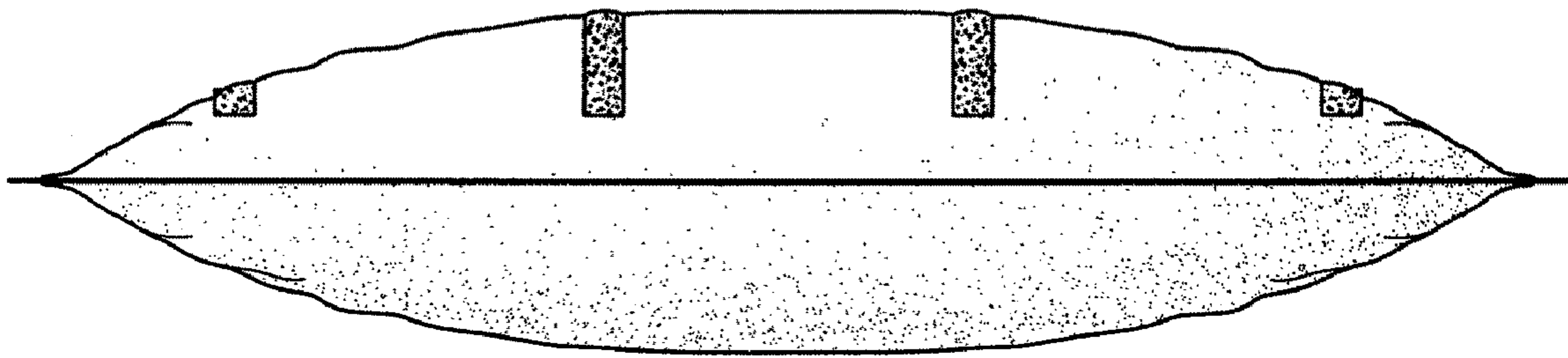

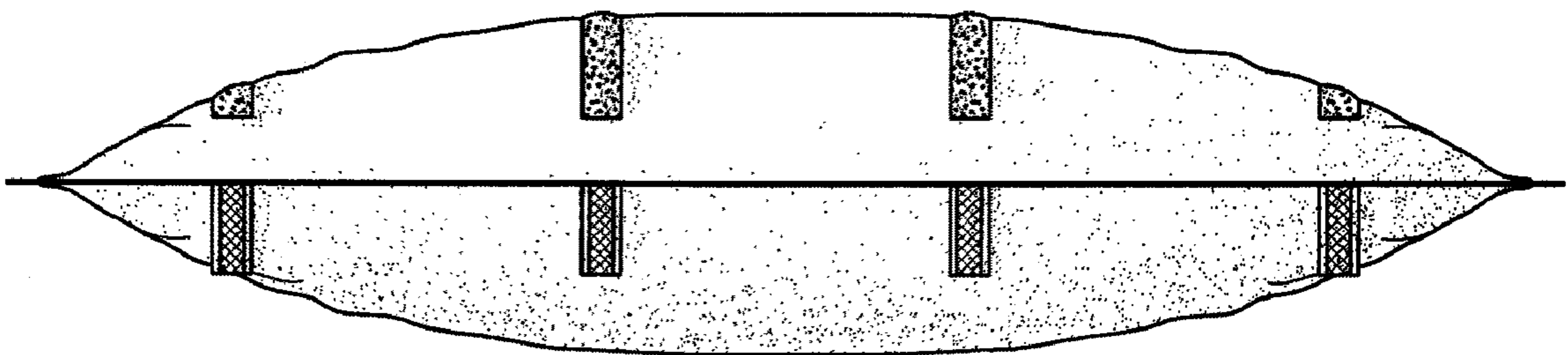
