**DESCRIPTION**

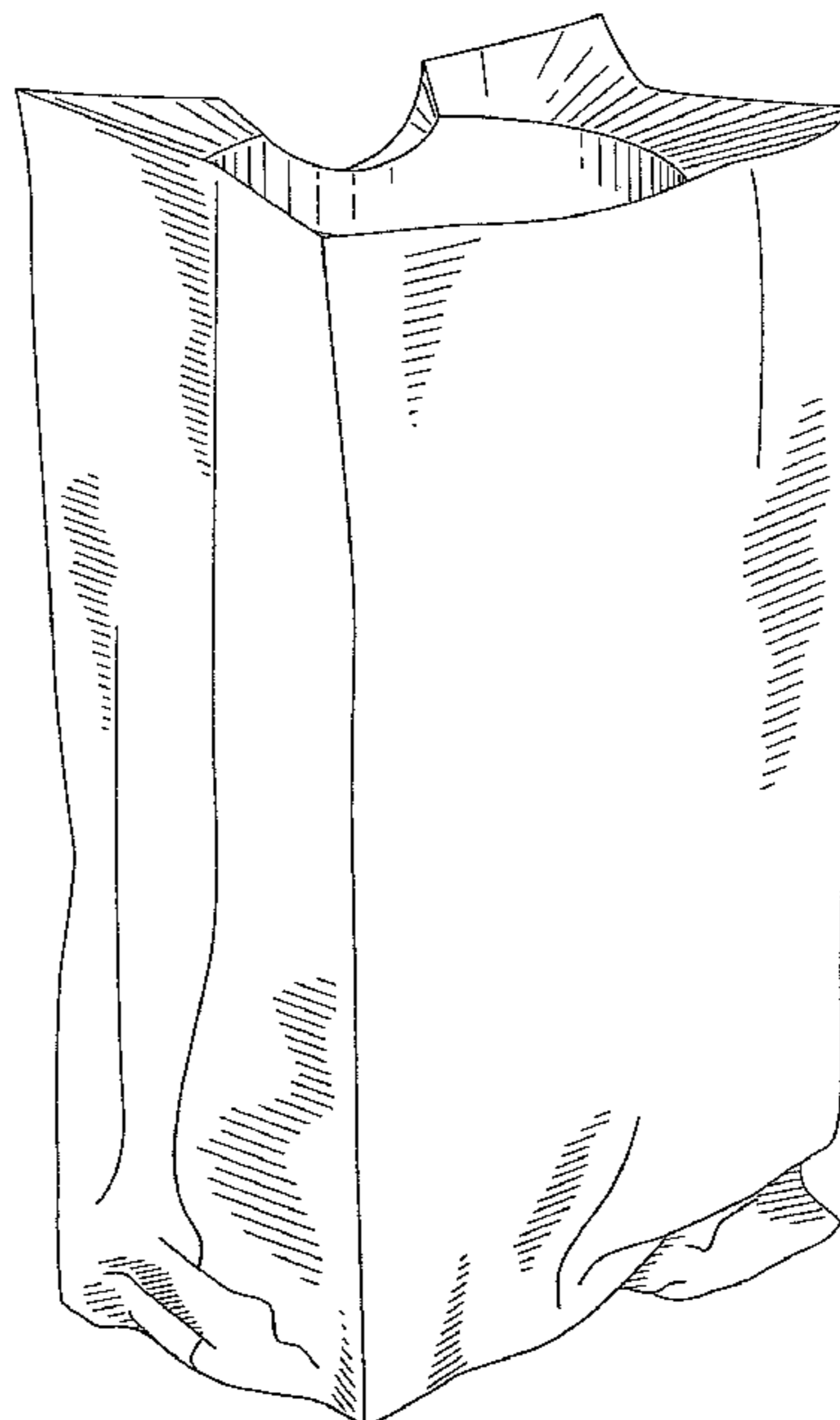
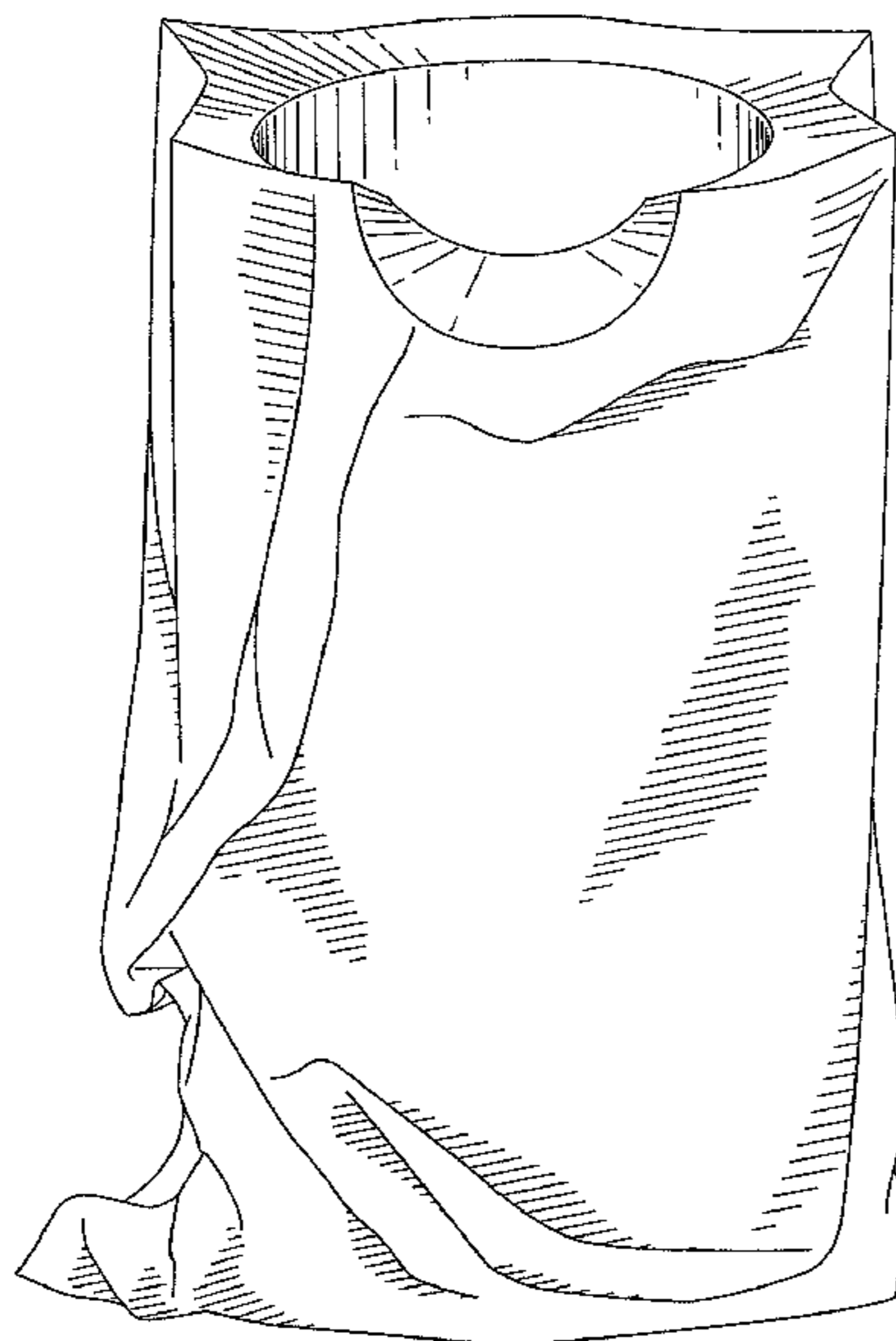
FIG. 1 is a first side perspective view of a beverage insulator

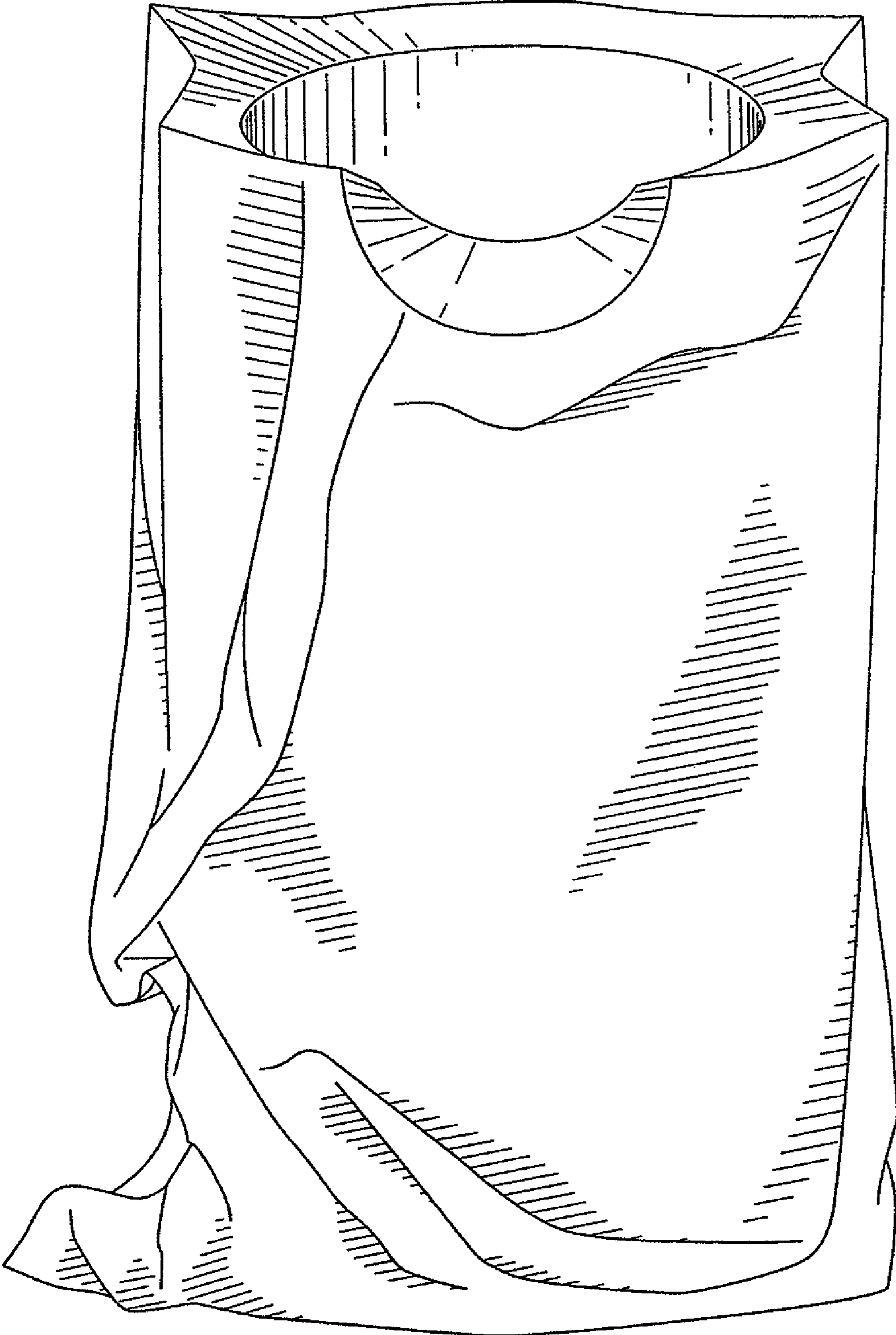

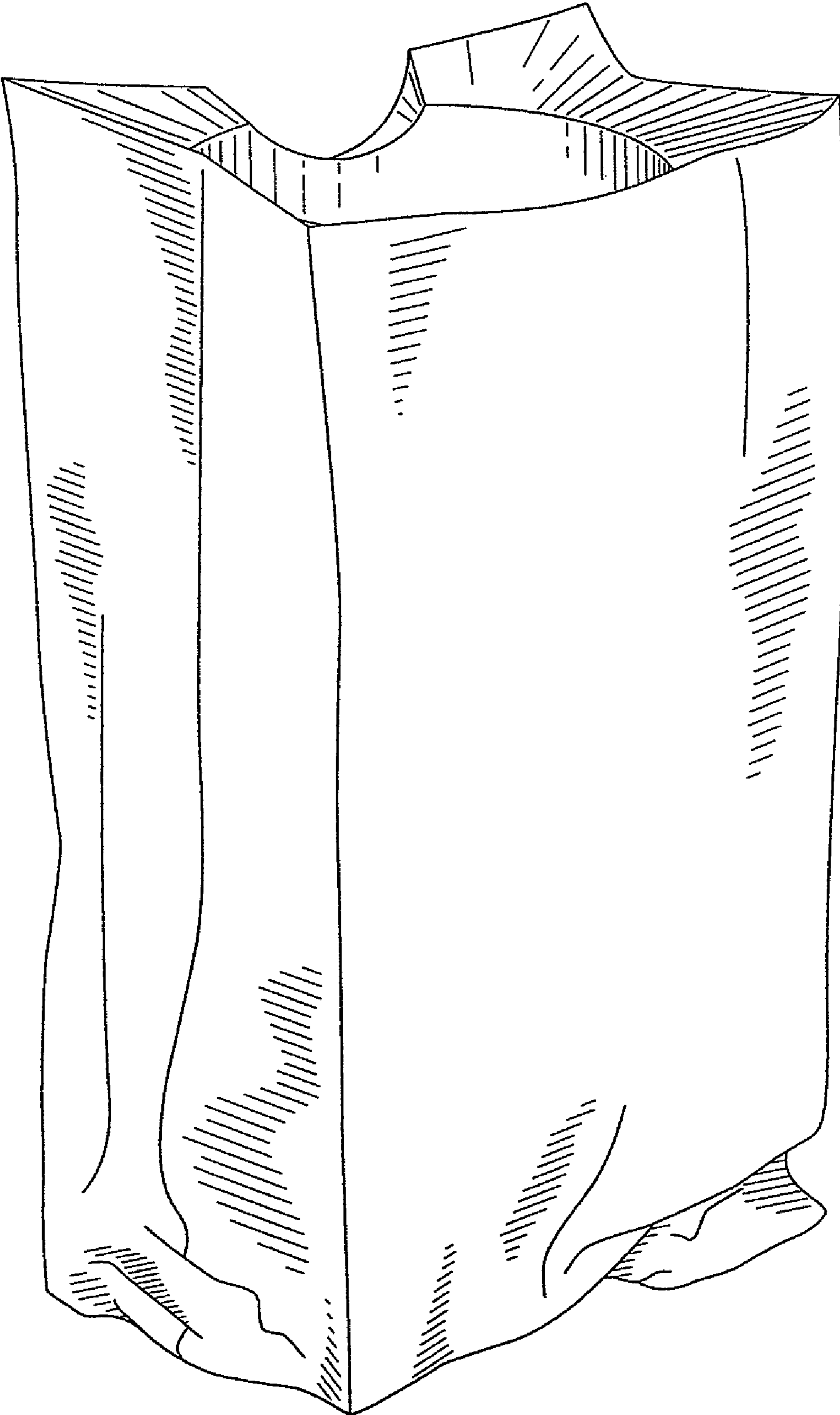

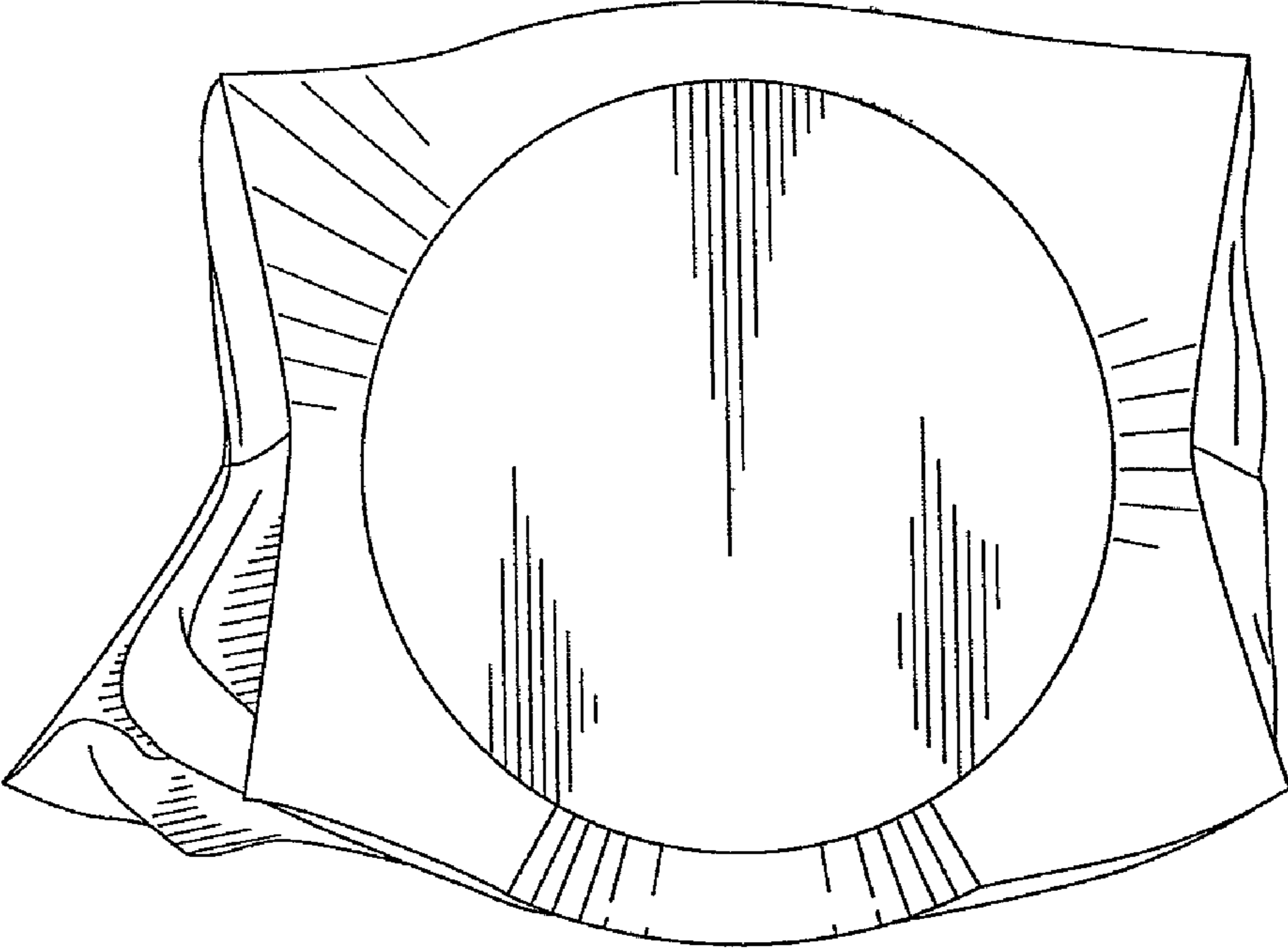

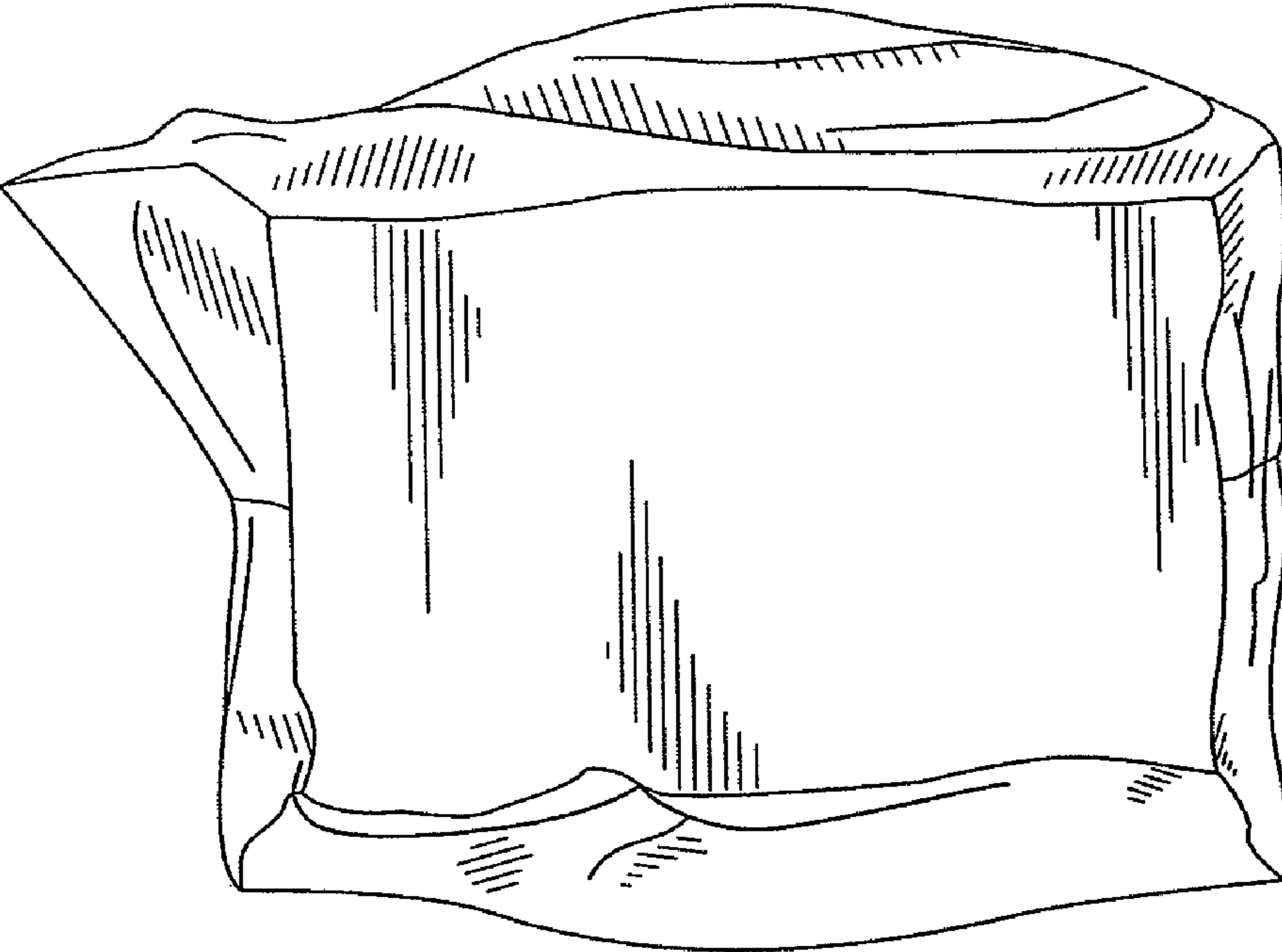
