FIG. 2 is a front view of the collapsible food carrier;

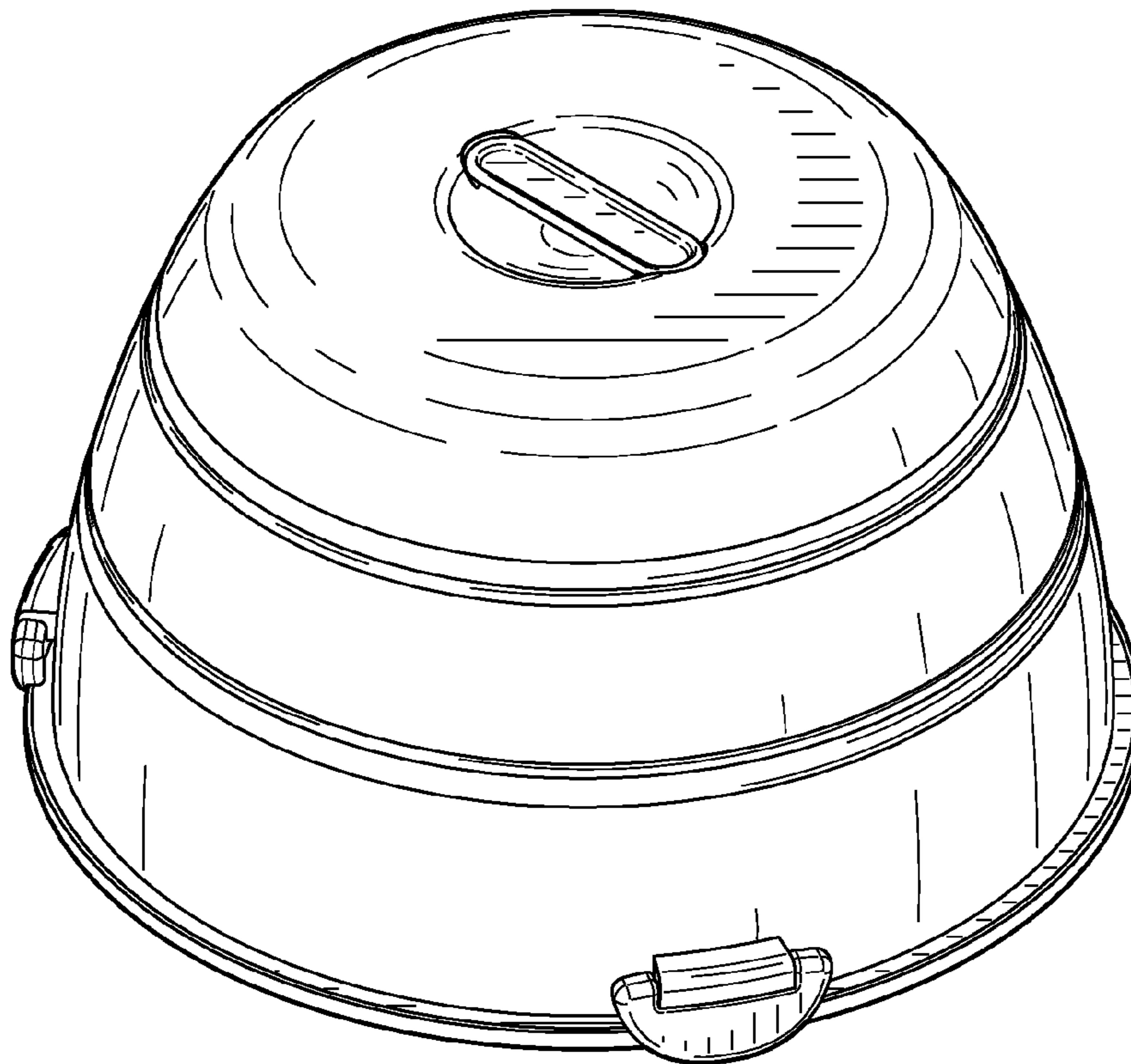
FIG. 3 is a top view of the collapsible food carrier;

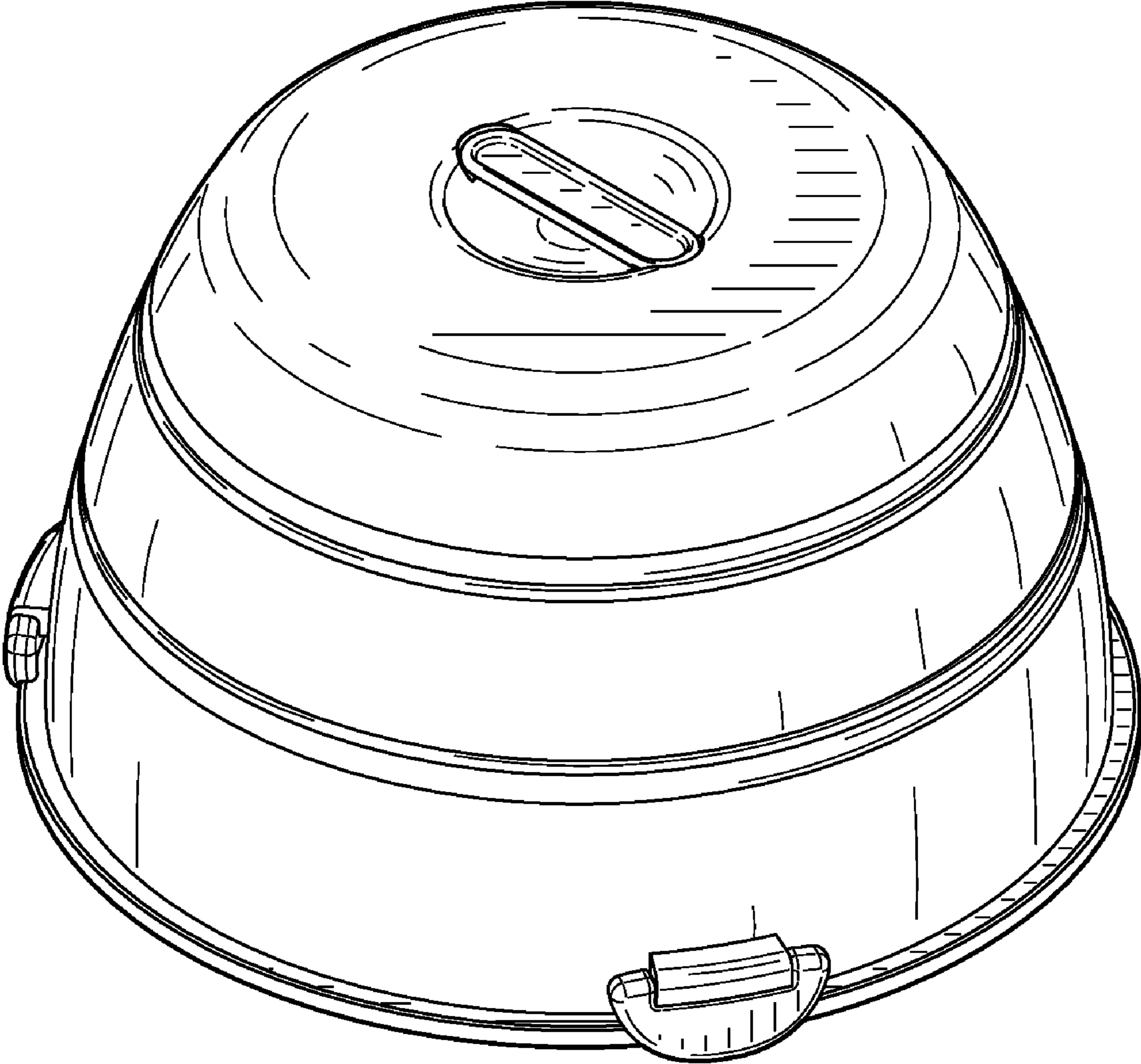

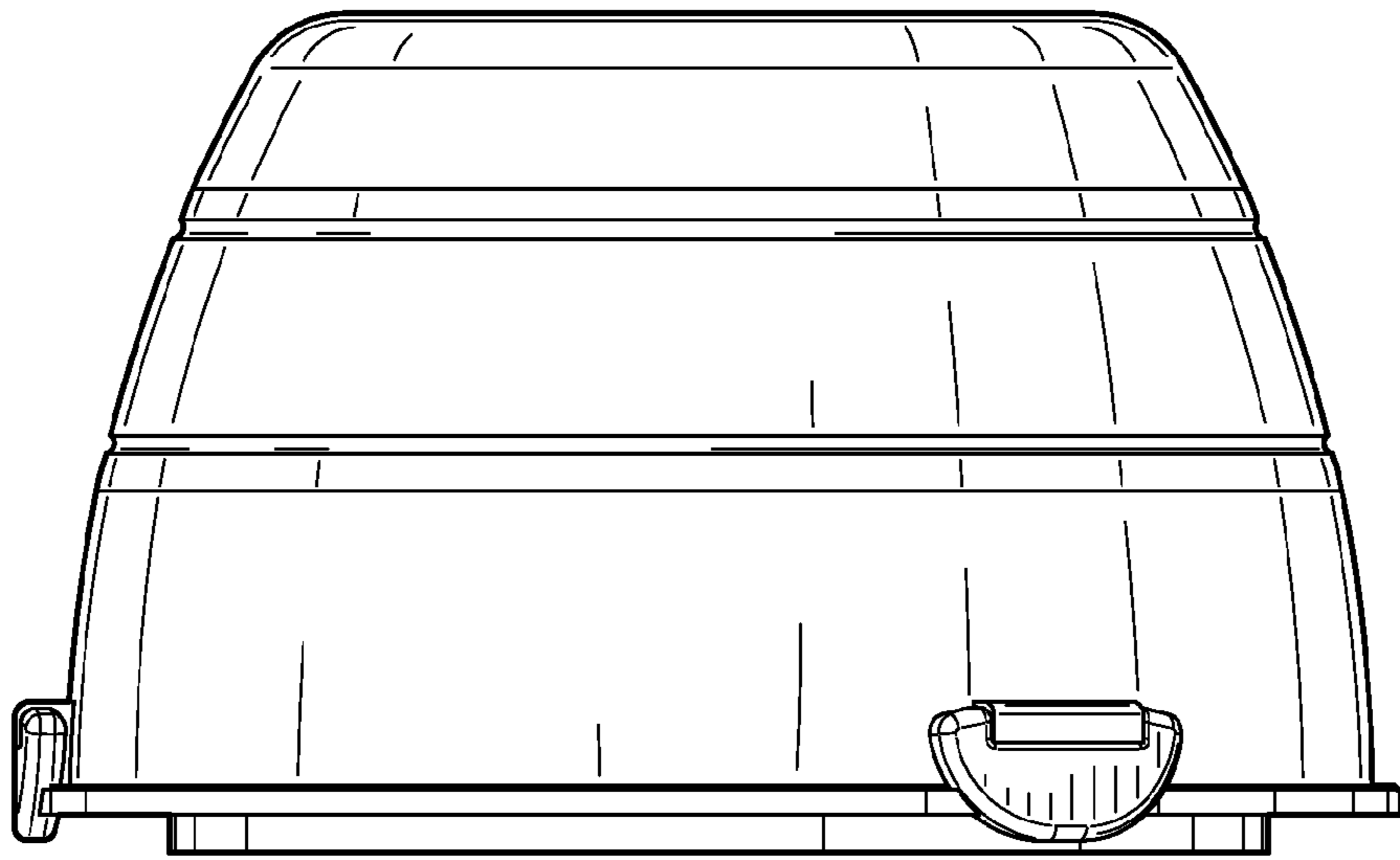

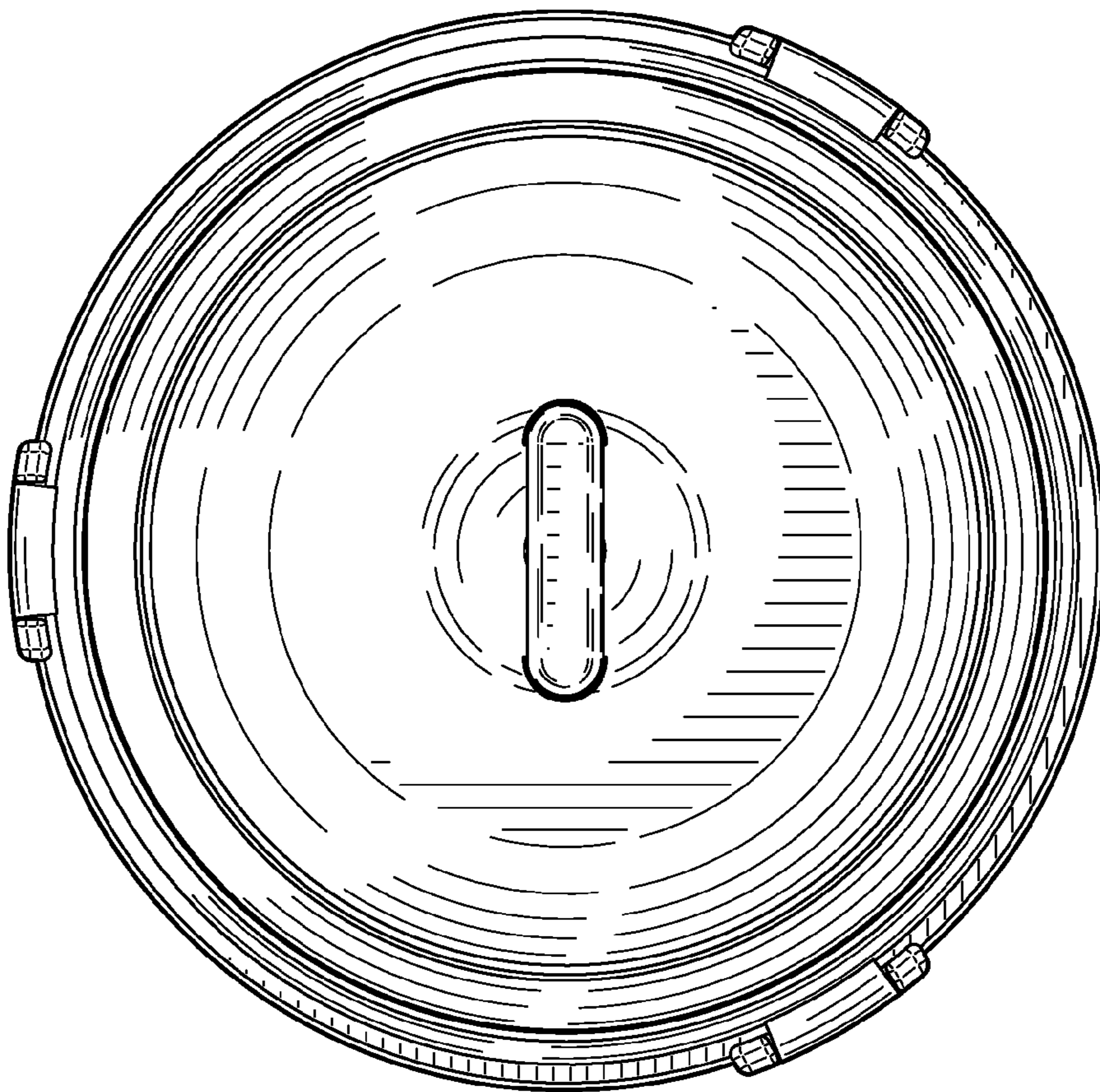

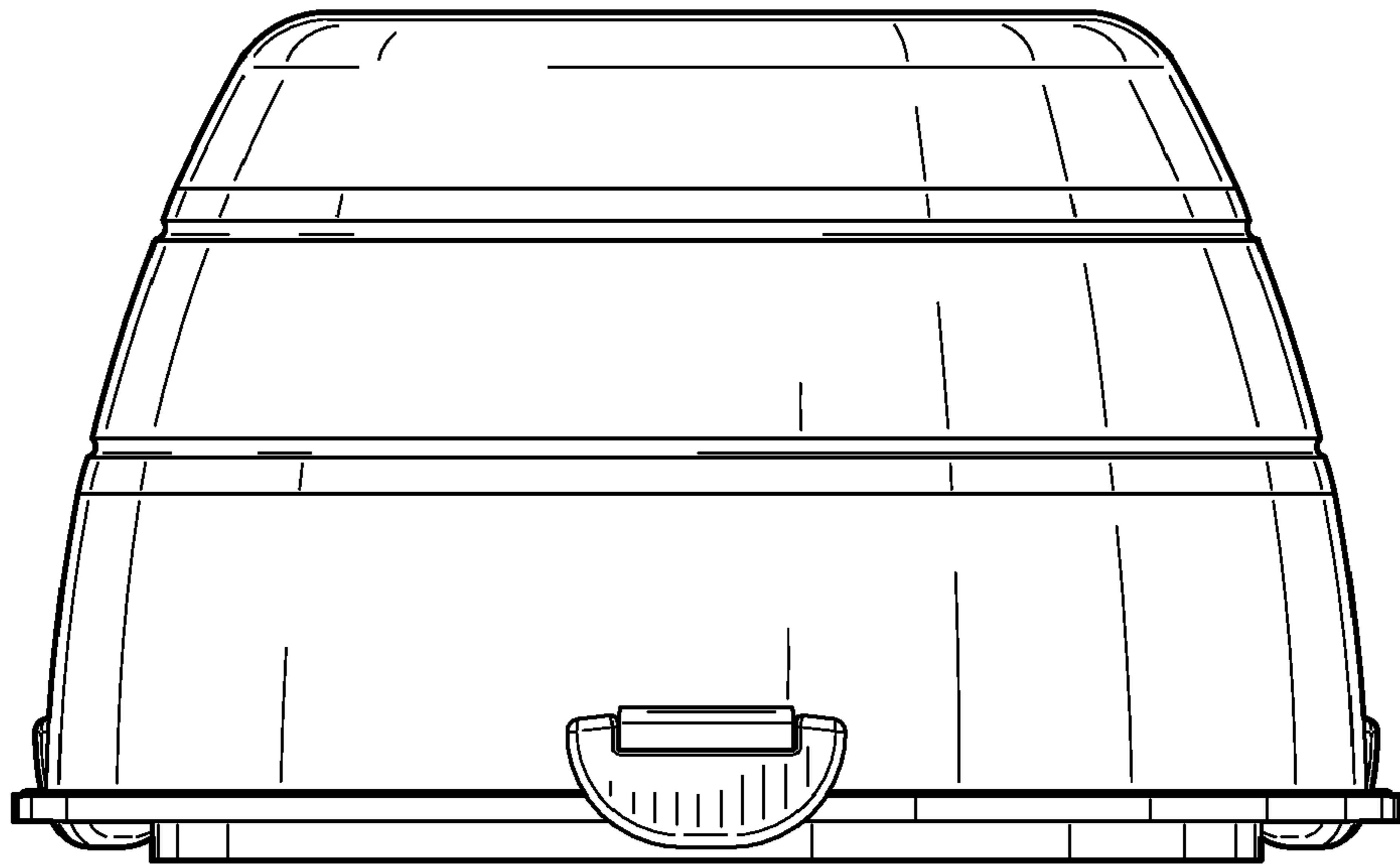

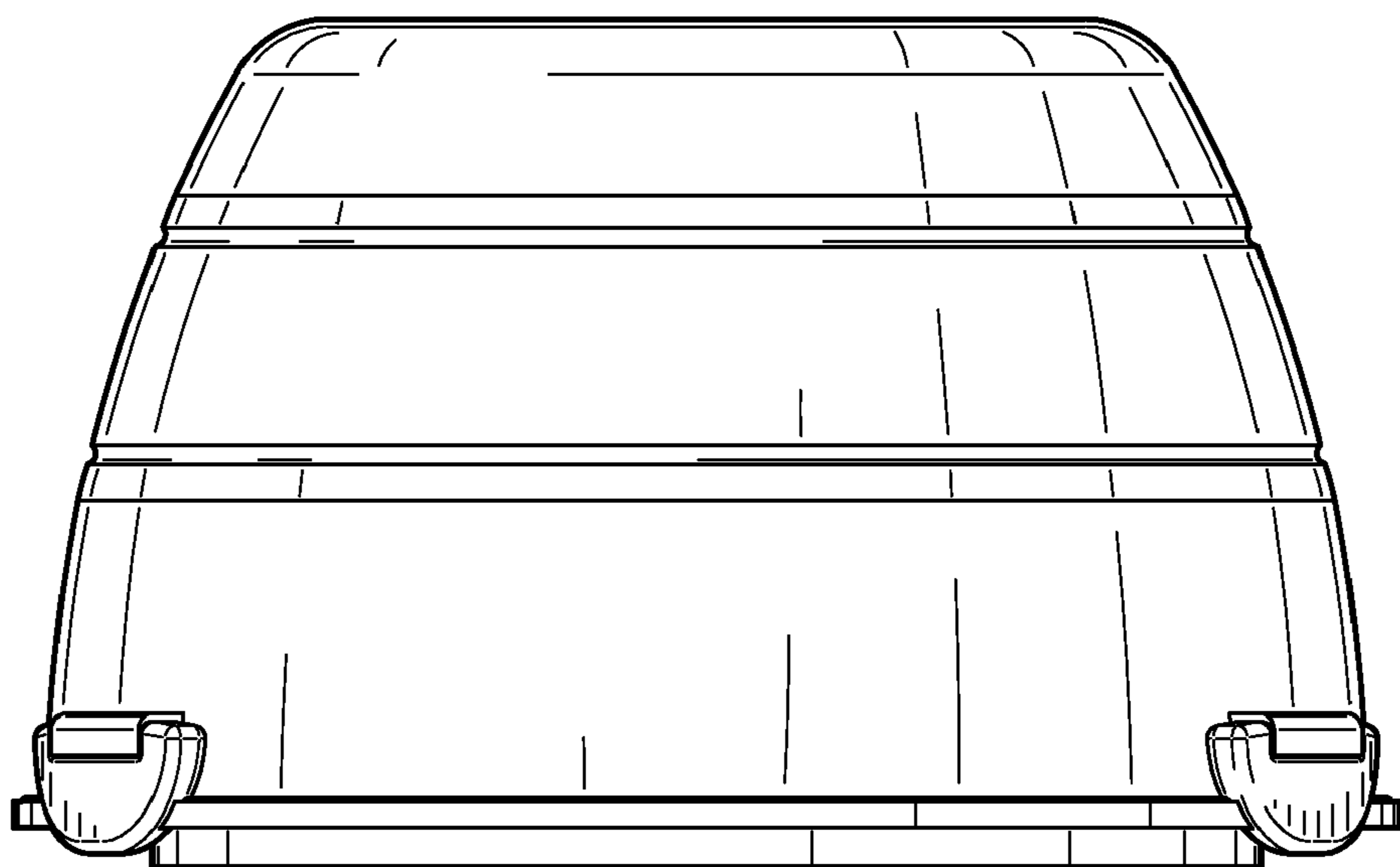

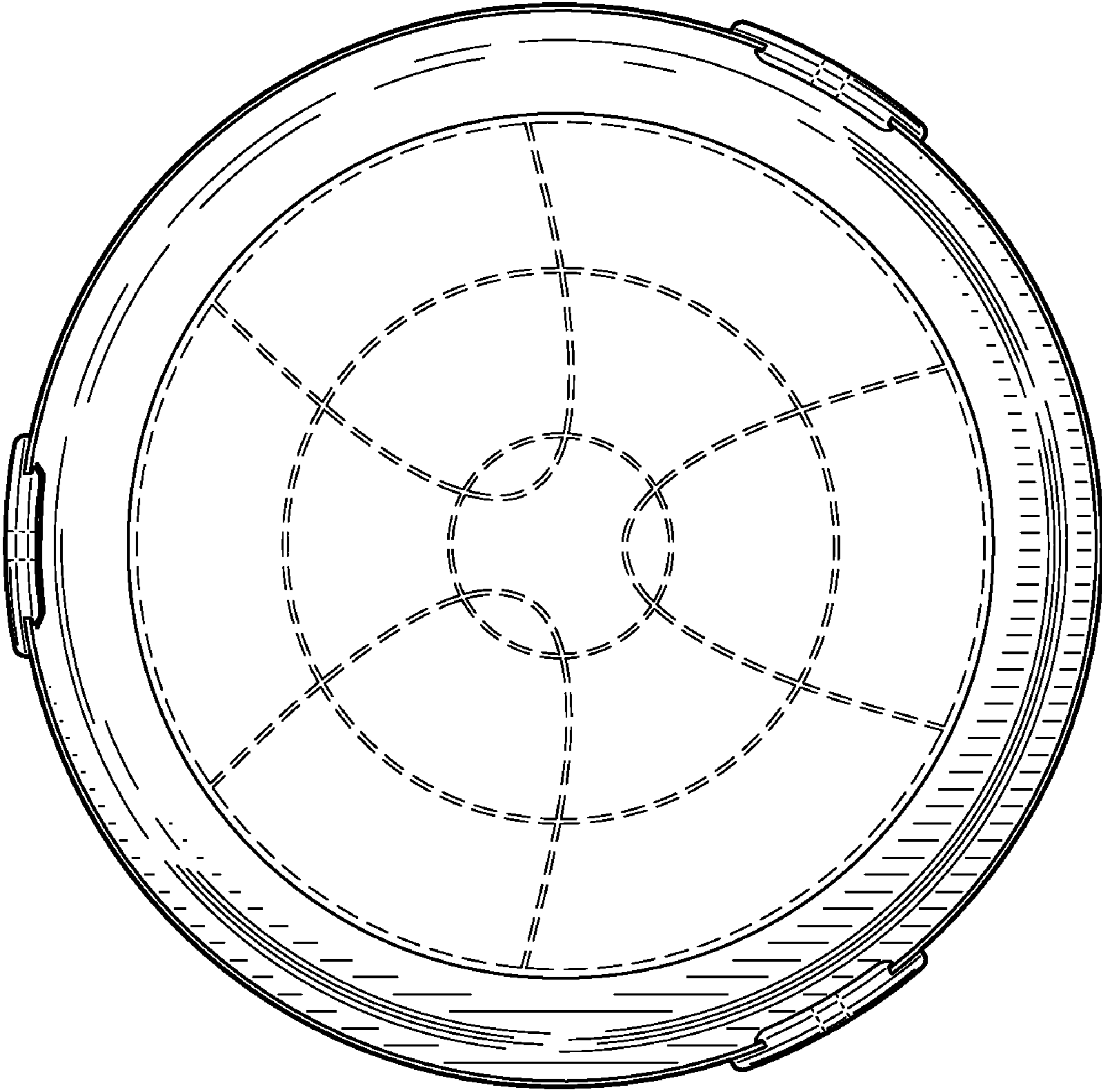
