FIG. 1 is a perspective view of the framework connector, as viewed from the front, top, and left side thereof.

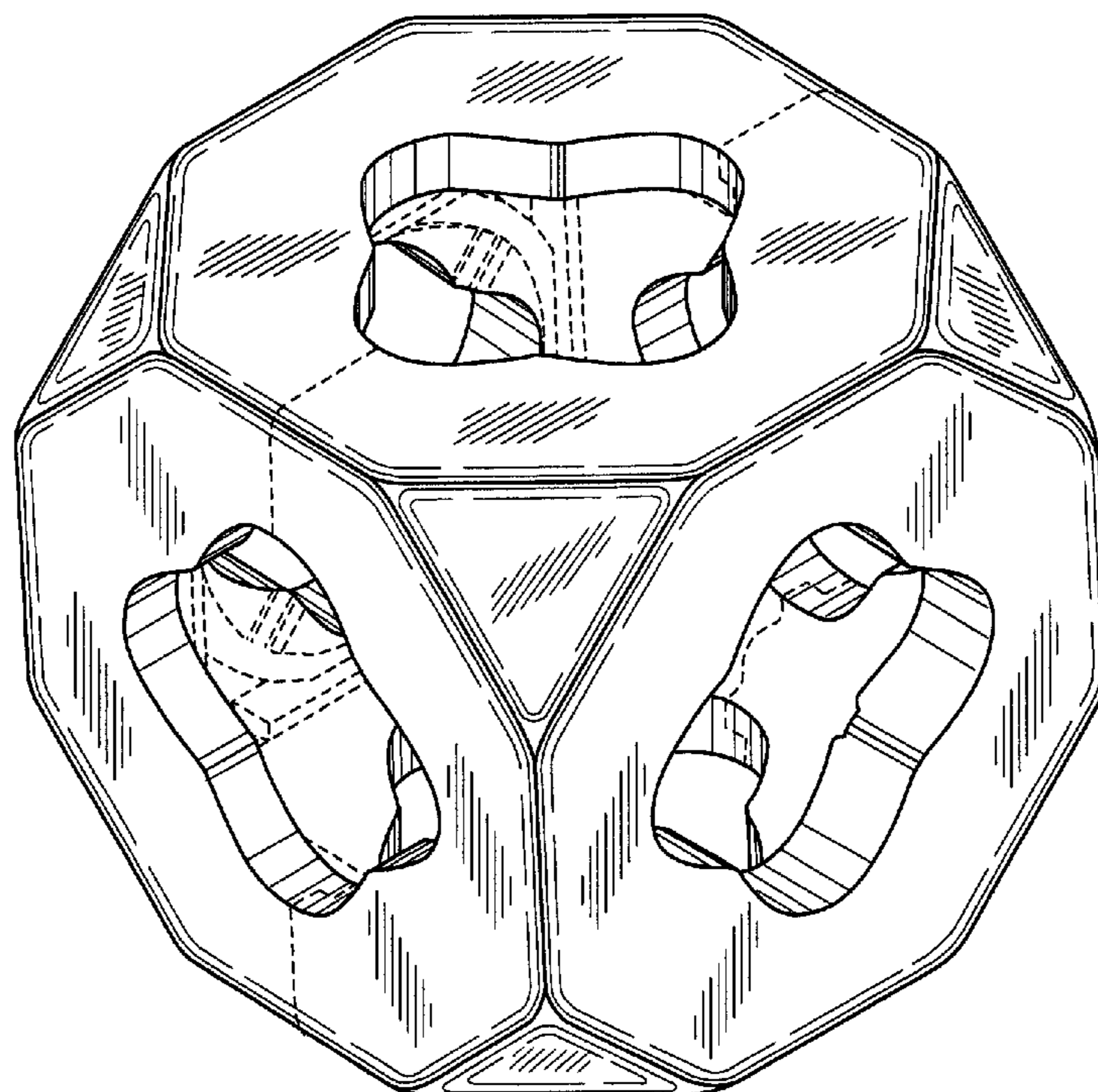

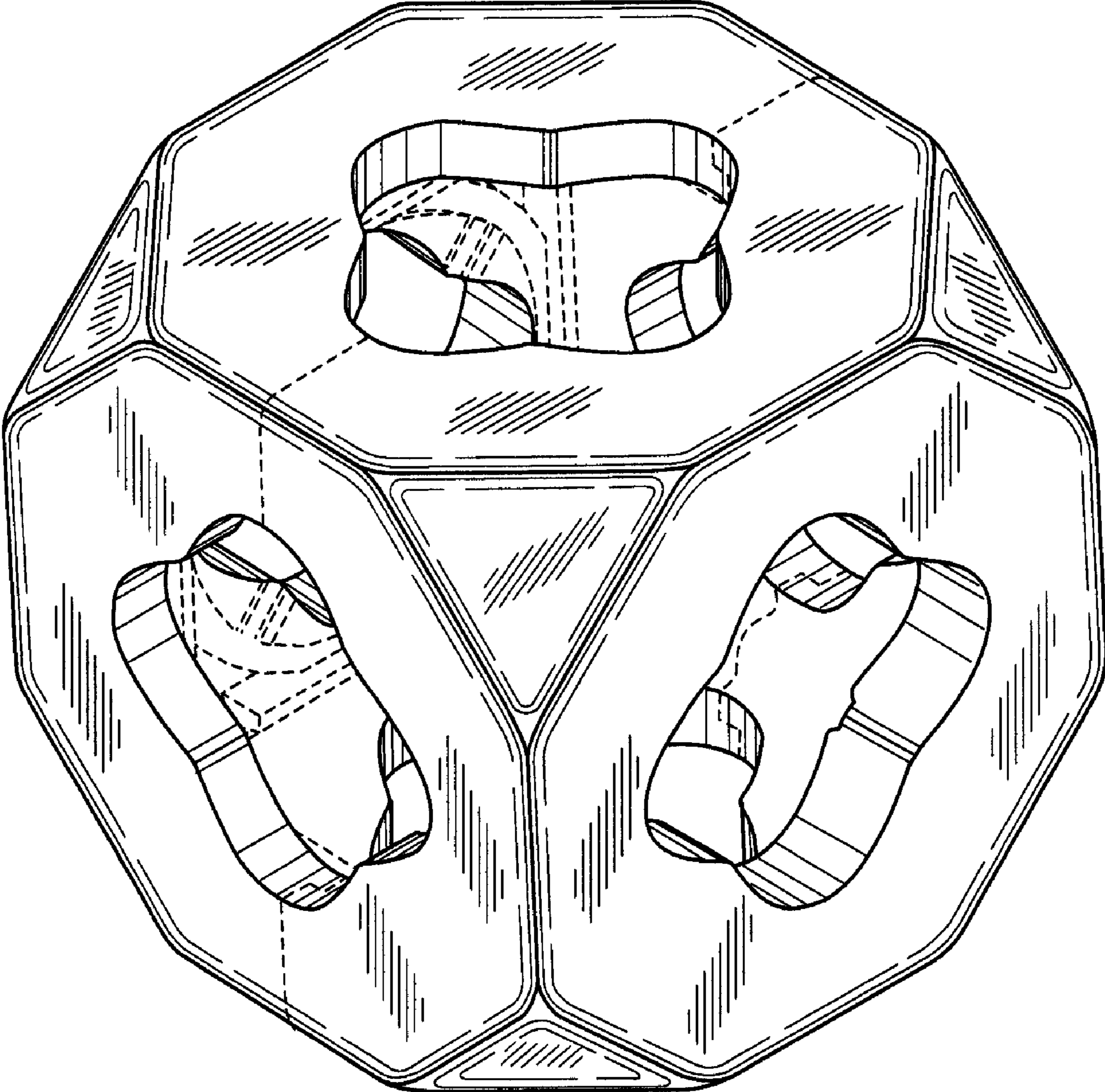

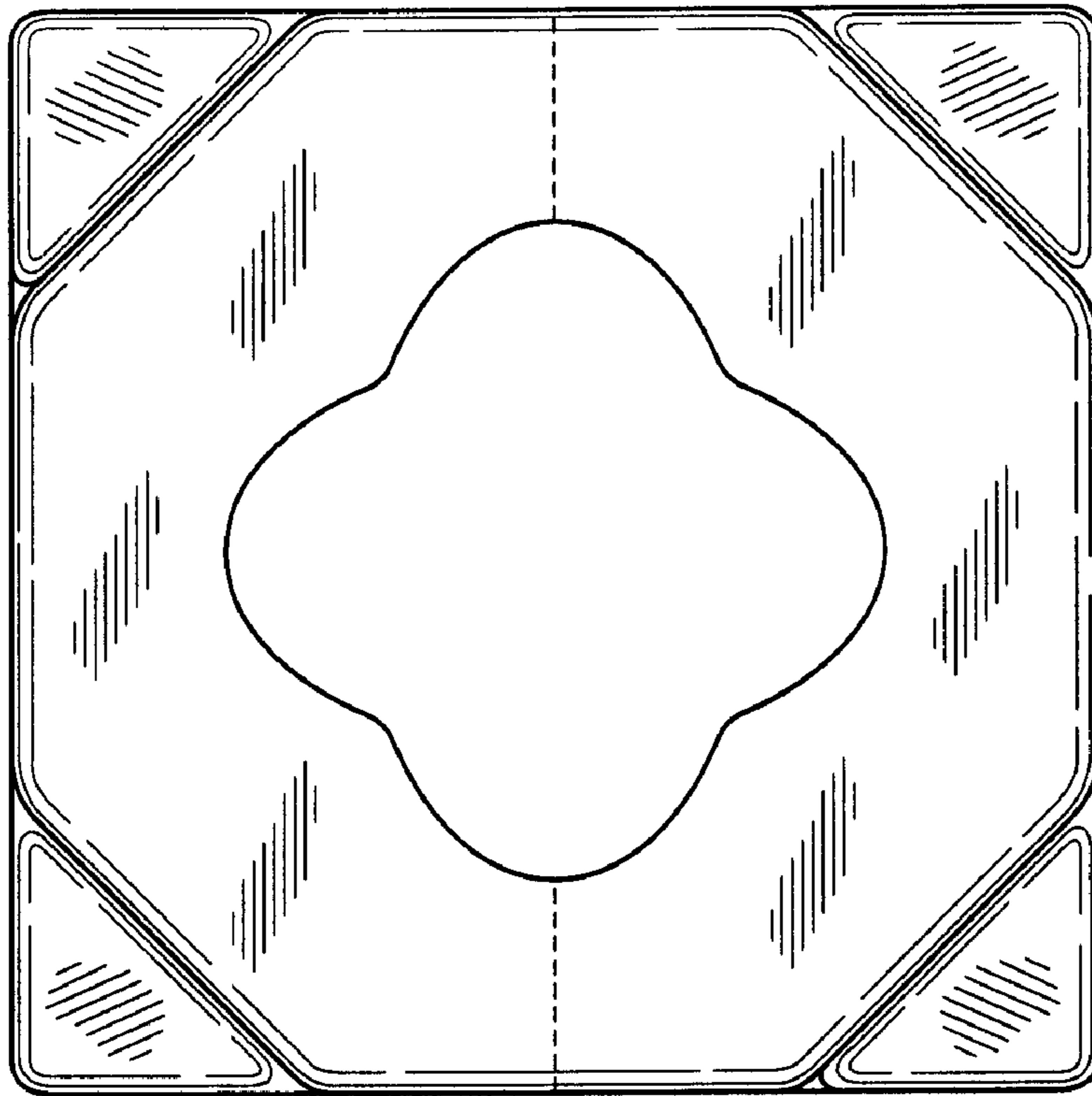

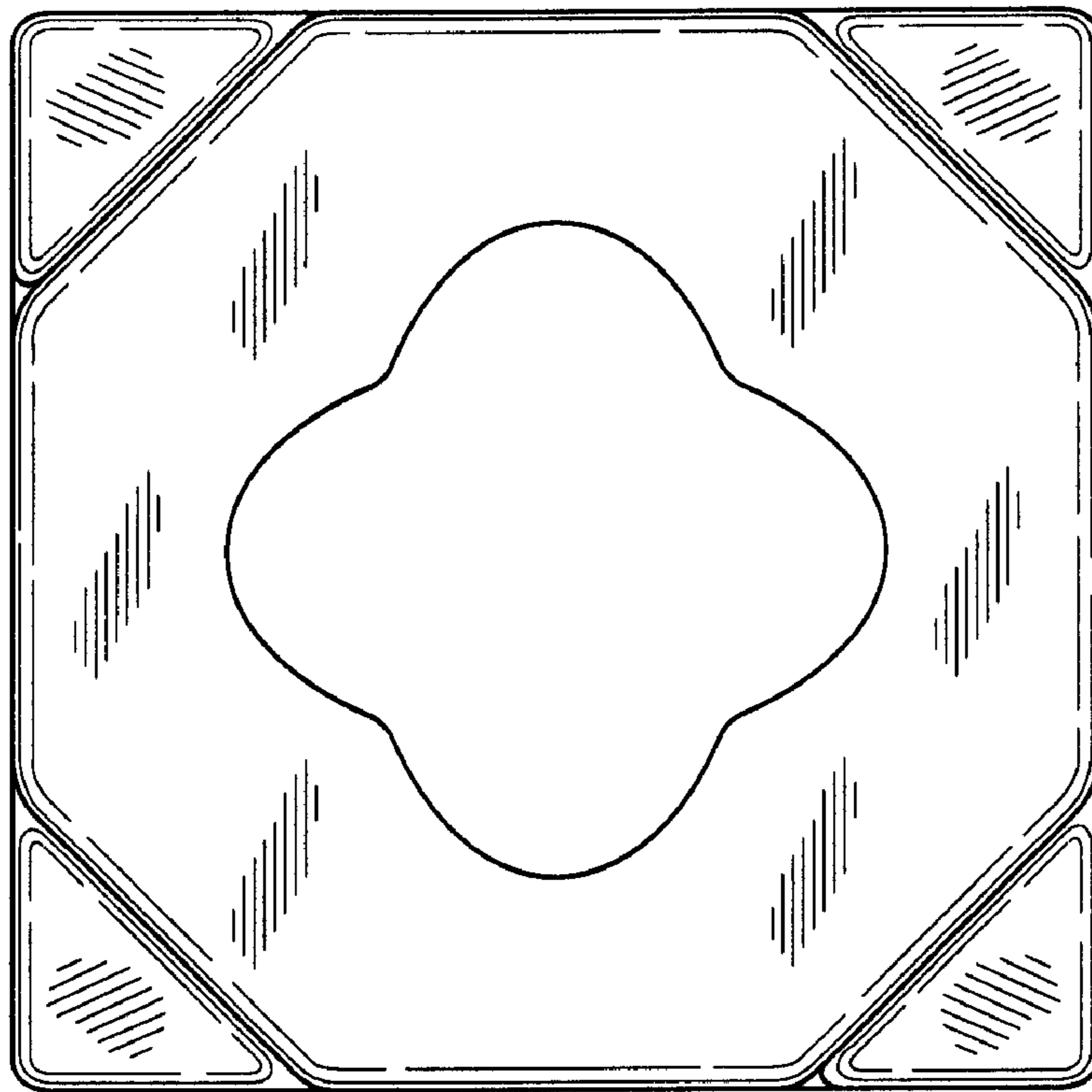
