(57) **CLAIM**

The ornamental design for a container with surface ornamentation, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of the container with surface ornamentation of the present invention;

FIG. 2 is an additional front elevational view thereof, shown in an alternate unclaimed environment;

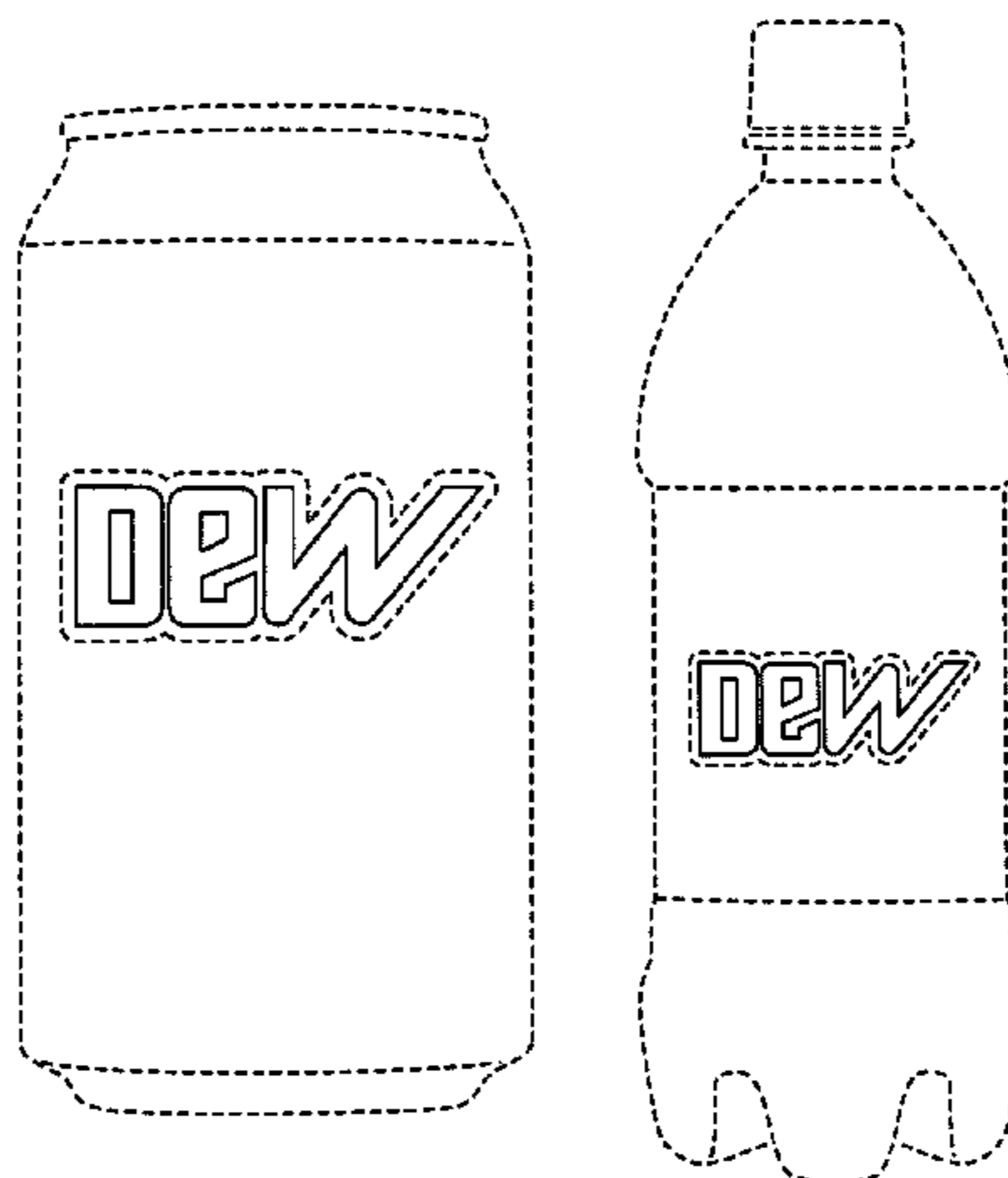
FIG. 3 is an additional front elevational view thereof, shown in an alternate unclaimed environment; and,

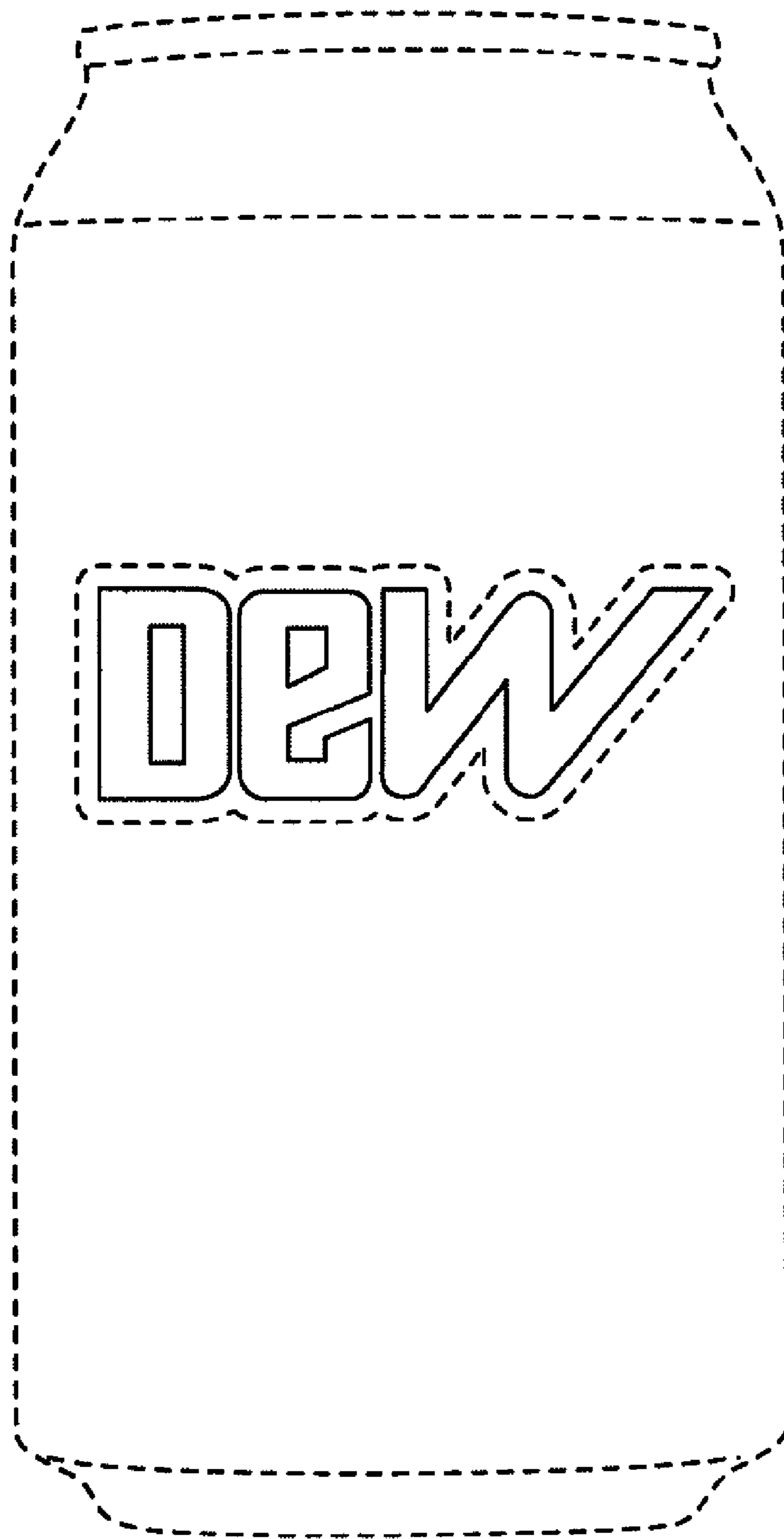

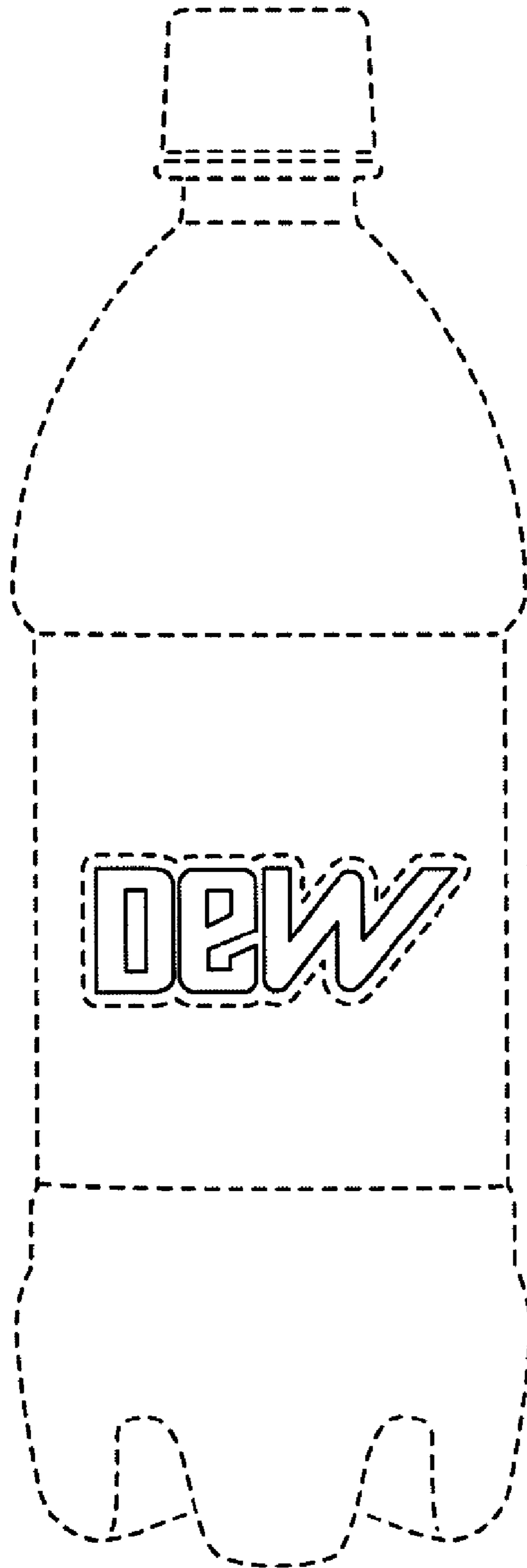

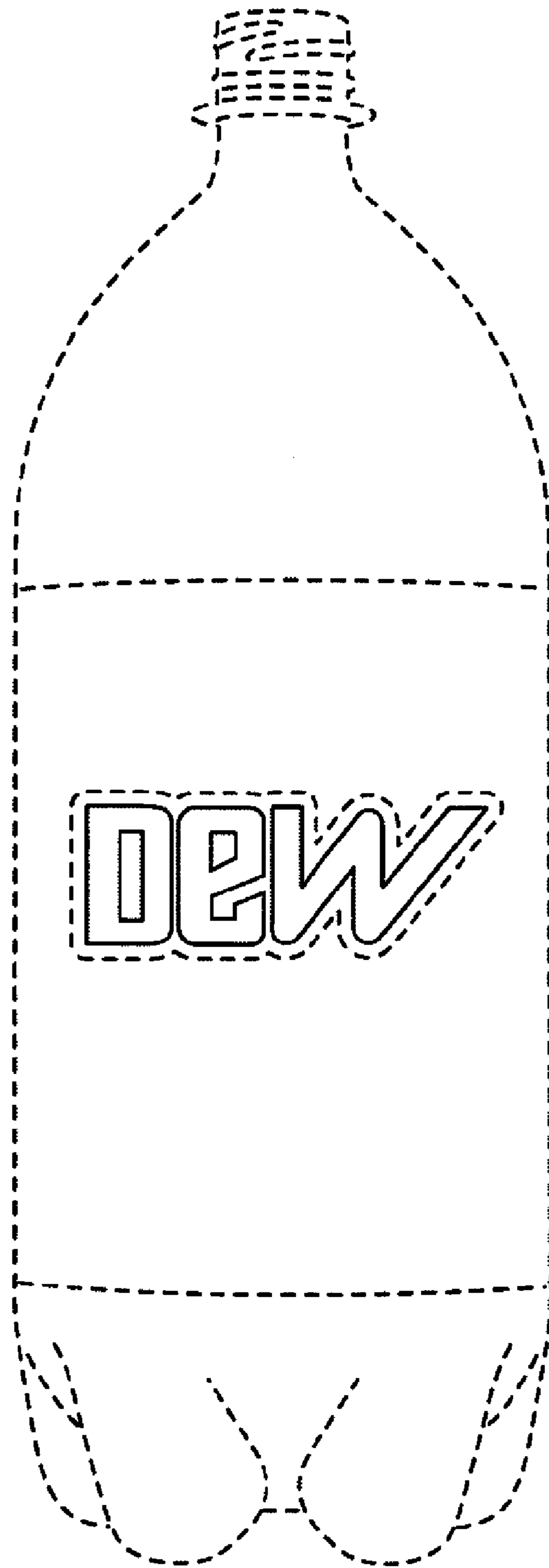

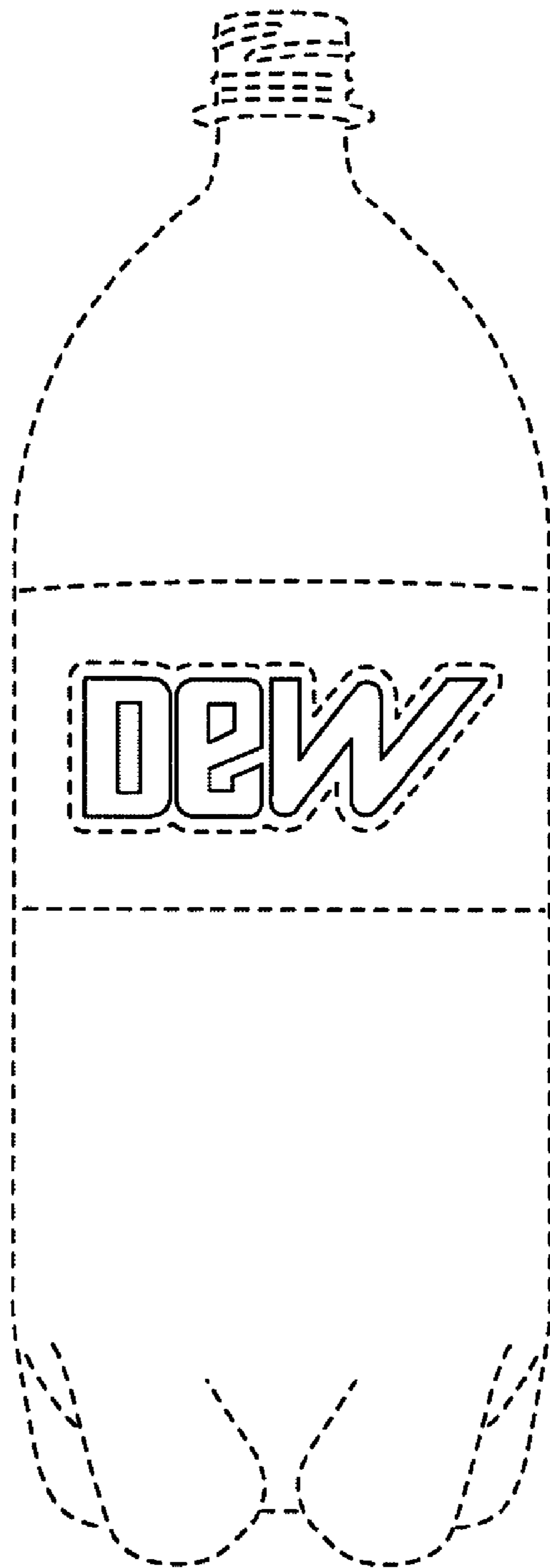
