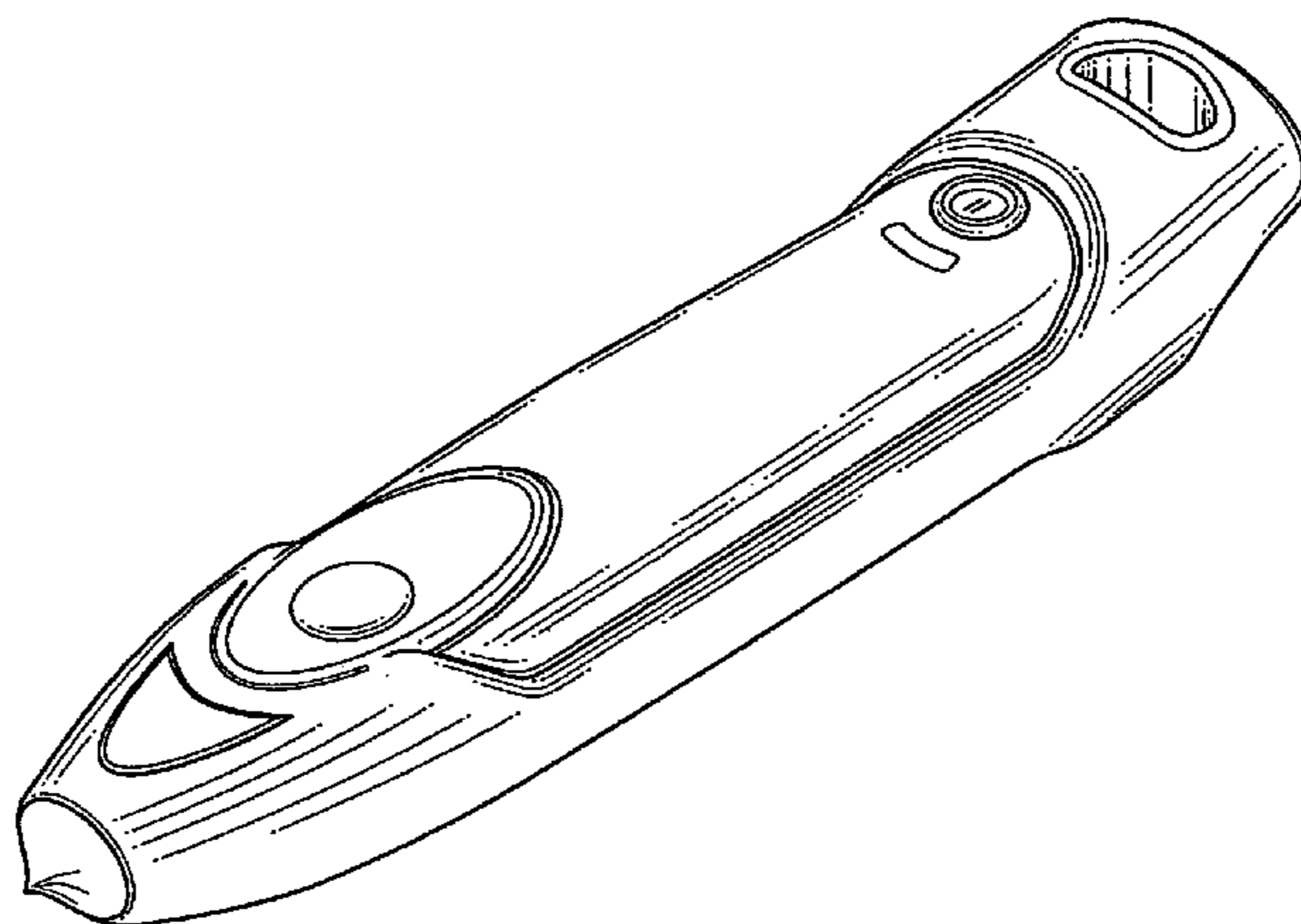
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is an isometric view of an RFID reader in accordance with the design;  
FIG. 2 is a top view of the RFID reader of FIG. 1;  
FIG. 3 is a bottom view of the RFID reader of FIG. 1;  
FIG. 4 is a left side view of the RFID reader of FIG. 1, the right side view being a mirror image thereof;  
FIG. 5 is a front view of the RFID reader of FIG. 1; and,  
FIG. 6 is a rear view of the RFID reader of FIG. 1.

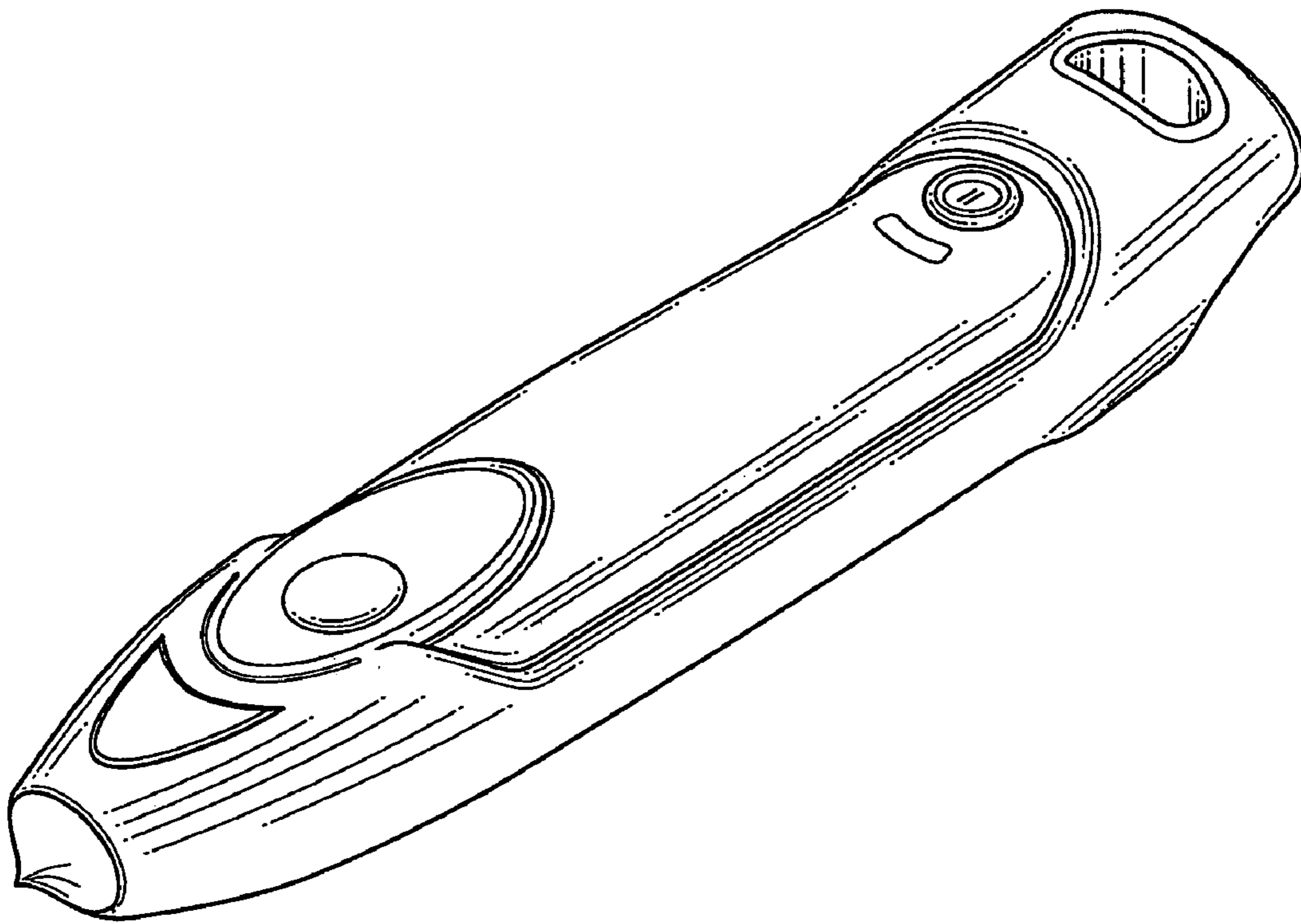

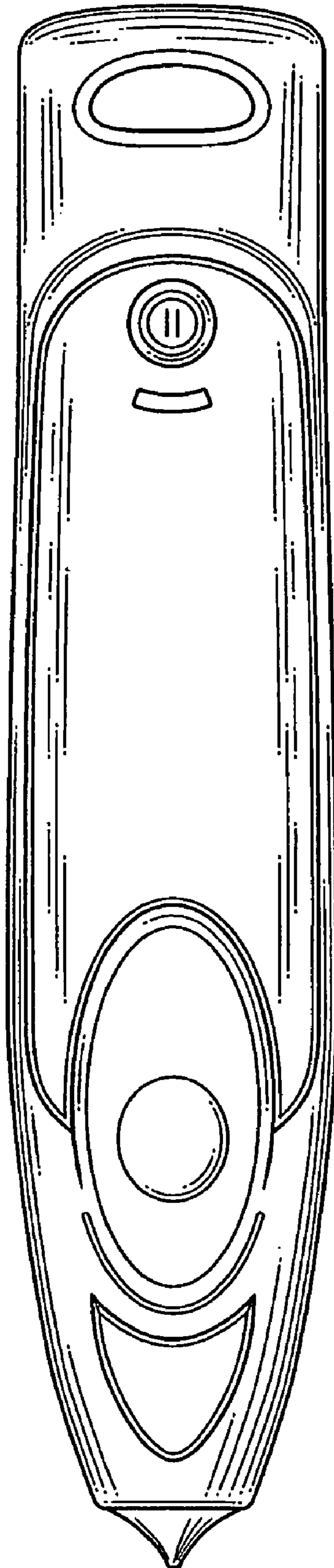

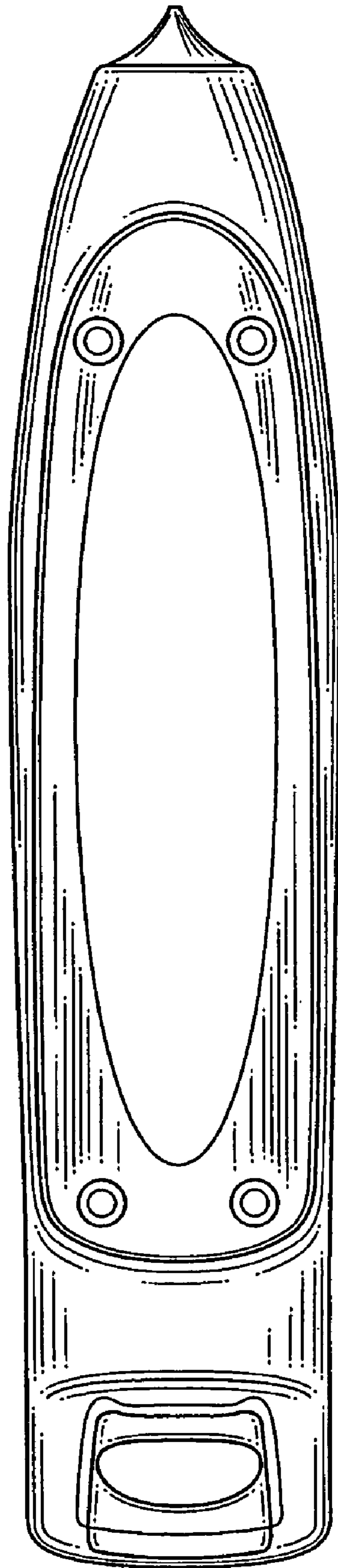

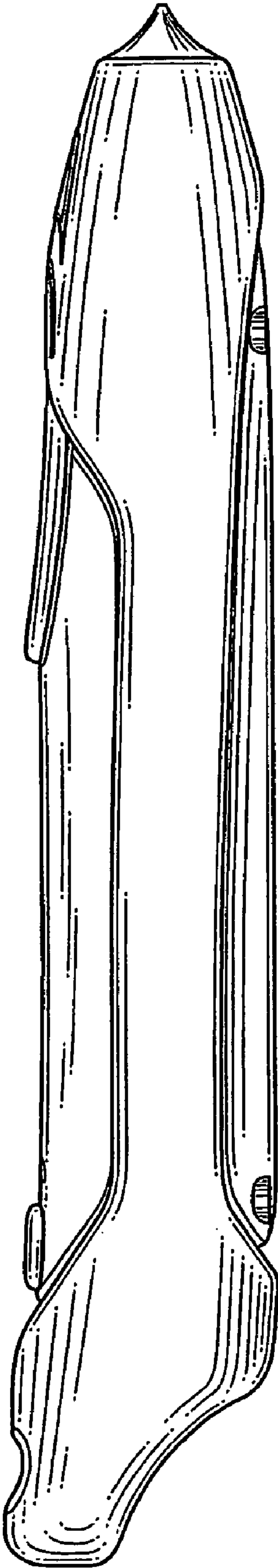
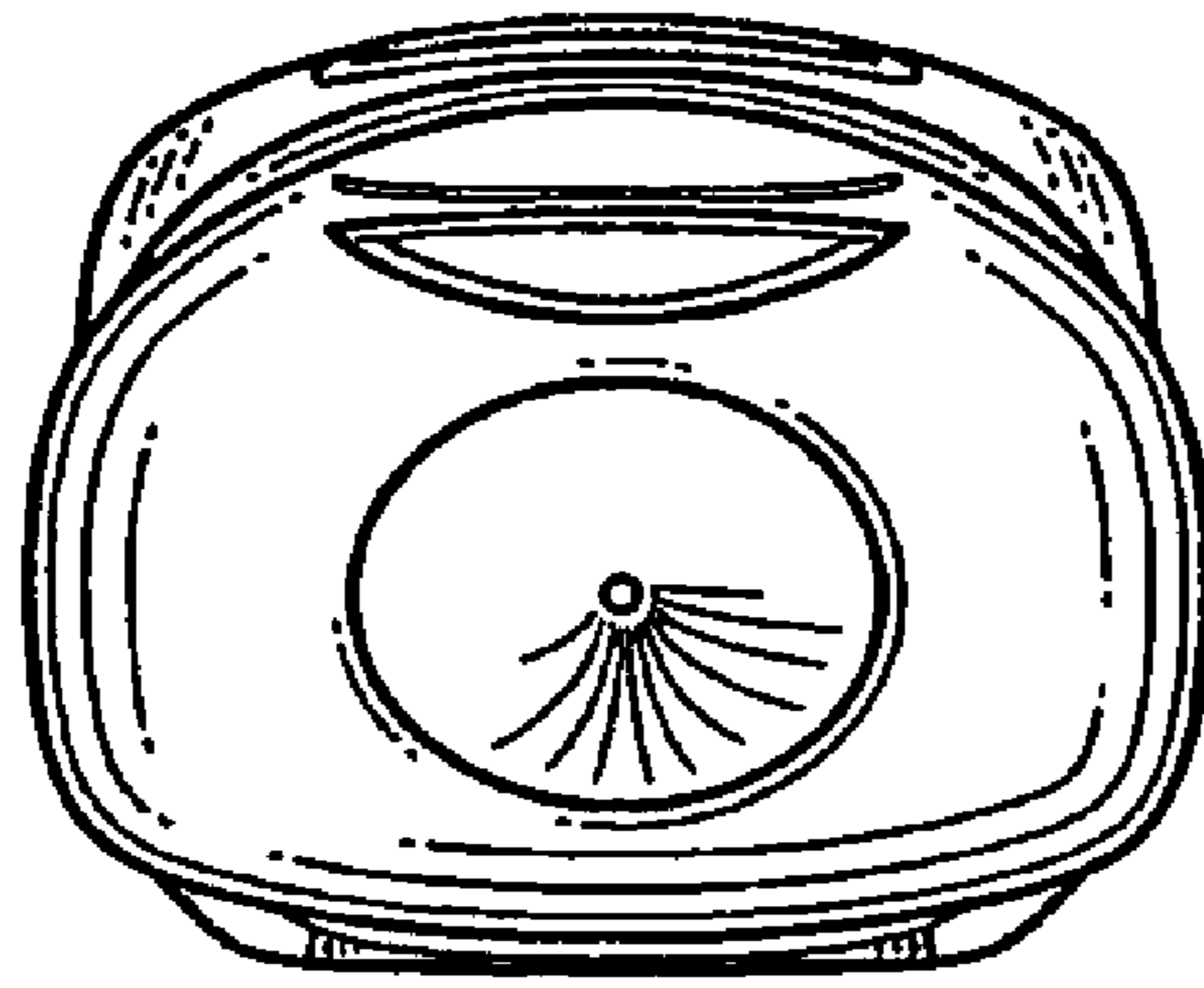
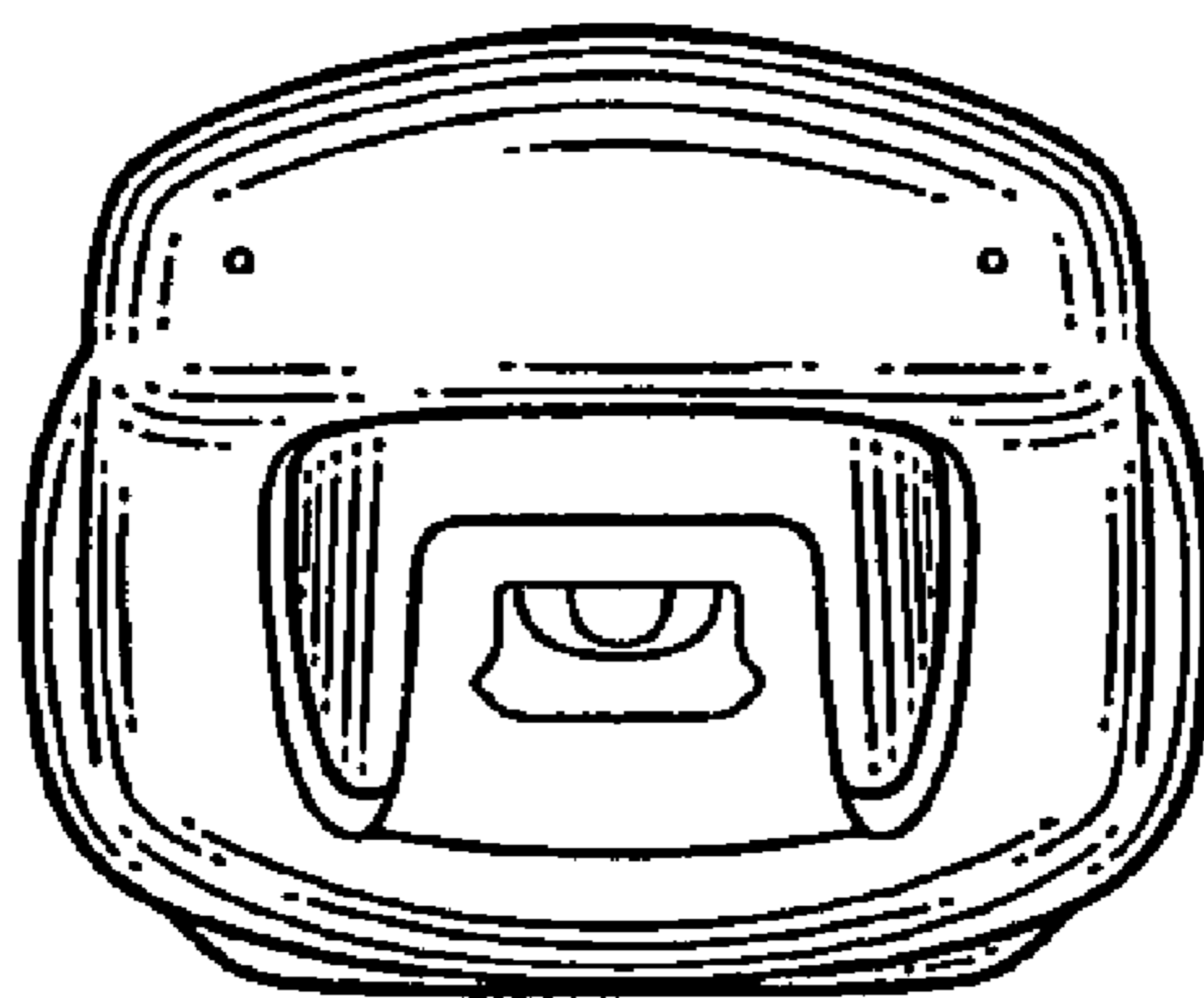
