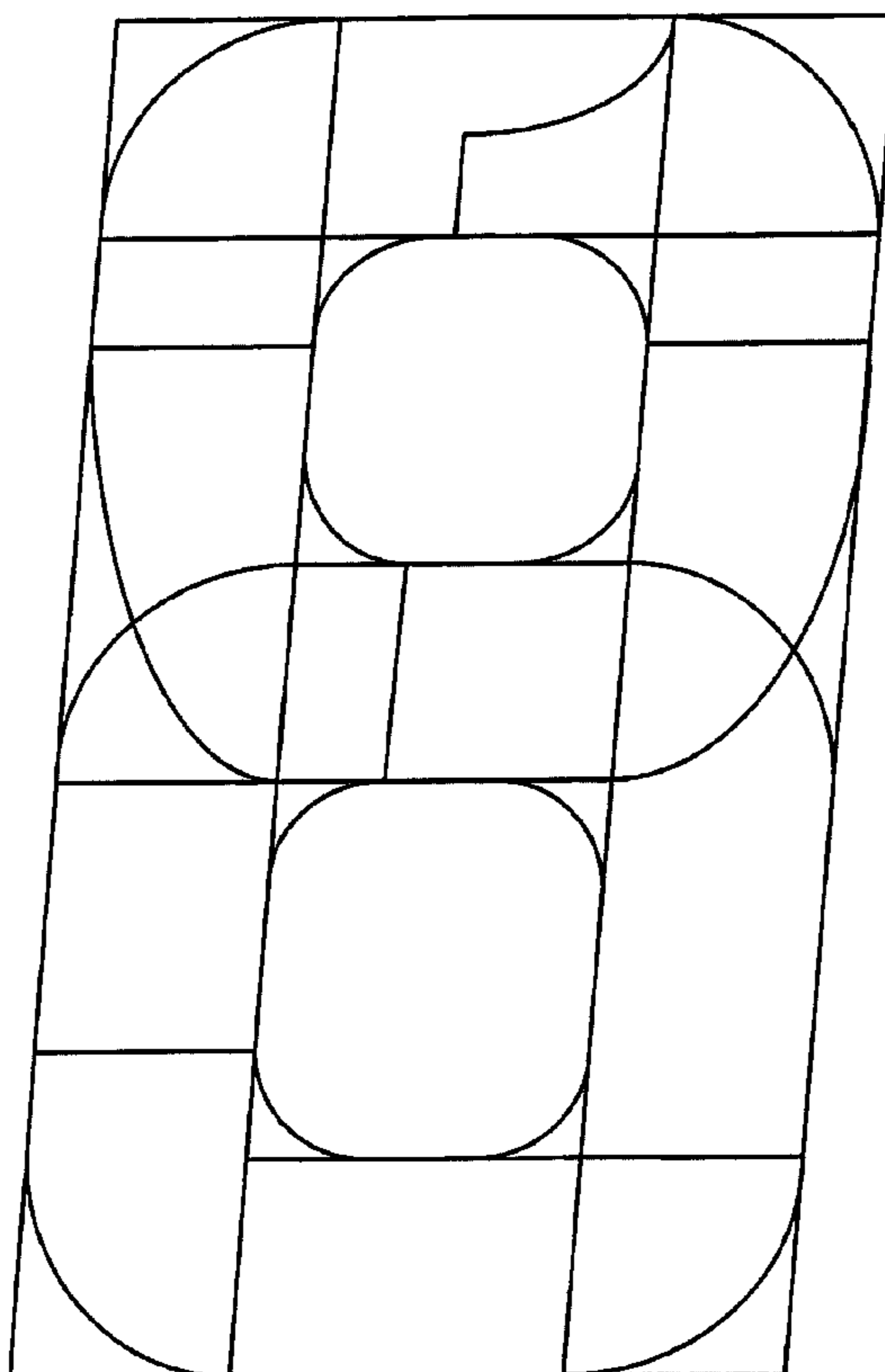
The ornamental design for a multi segment display, as shown and described.

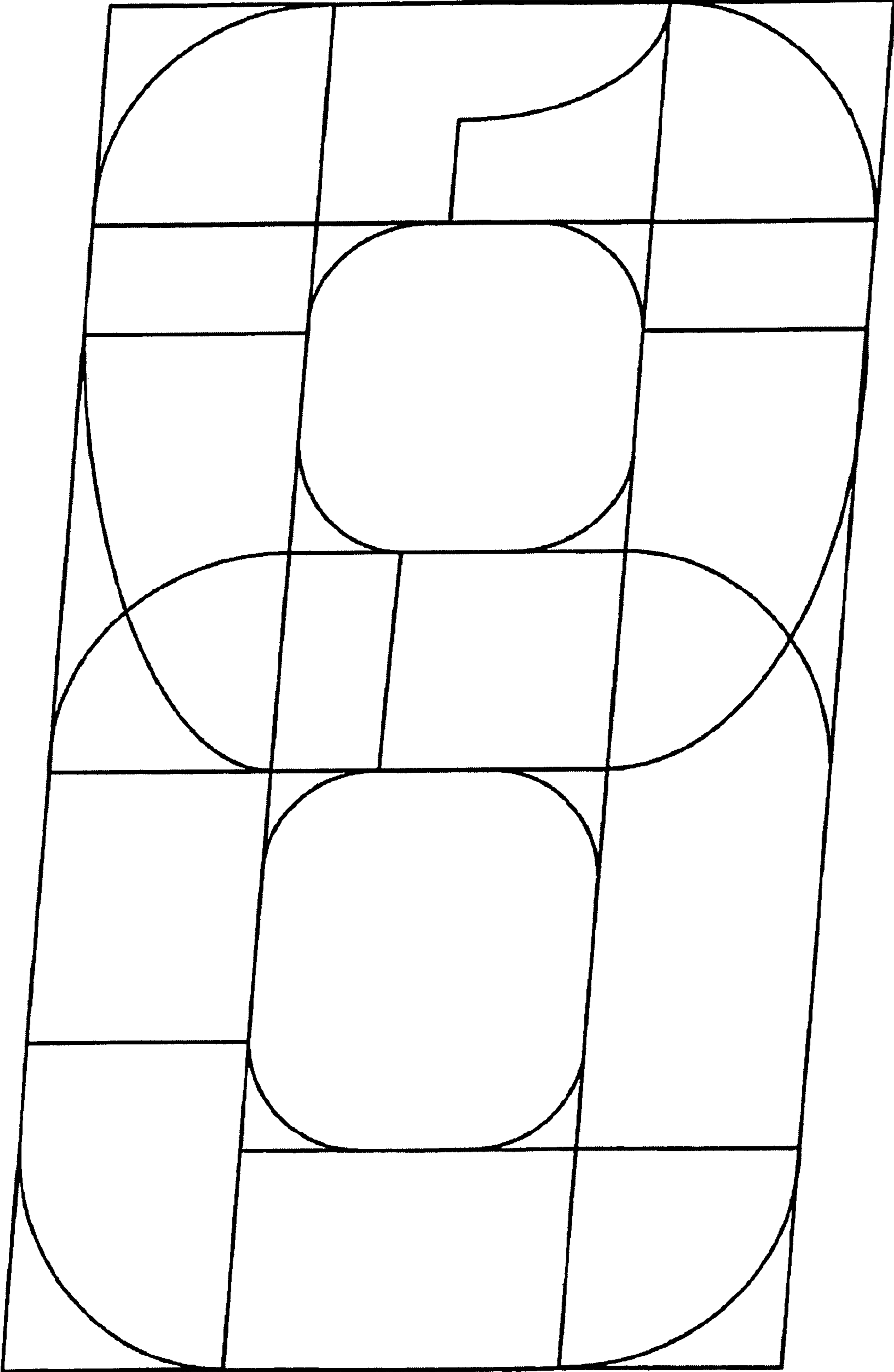
**DESCRIPTION**

FIG. 1 is a face view of a multi segment display showing my new design; and,

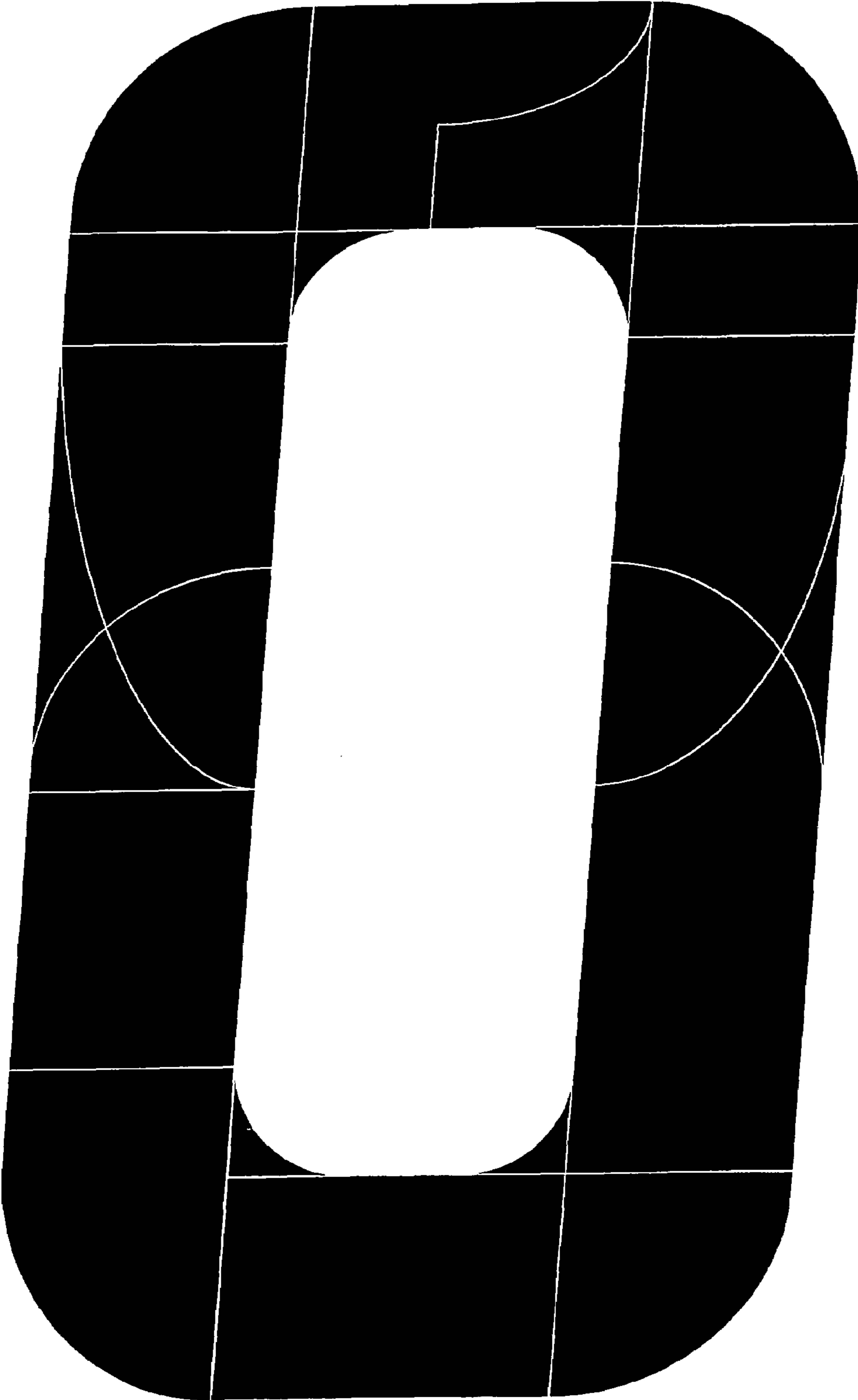
FIGS. 2-11 are face views of individual characters formed from the multi segment display shown with reverse contrast relative to FIG. 1.

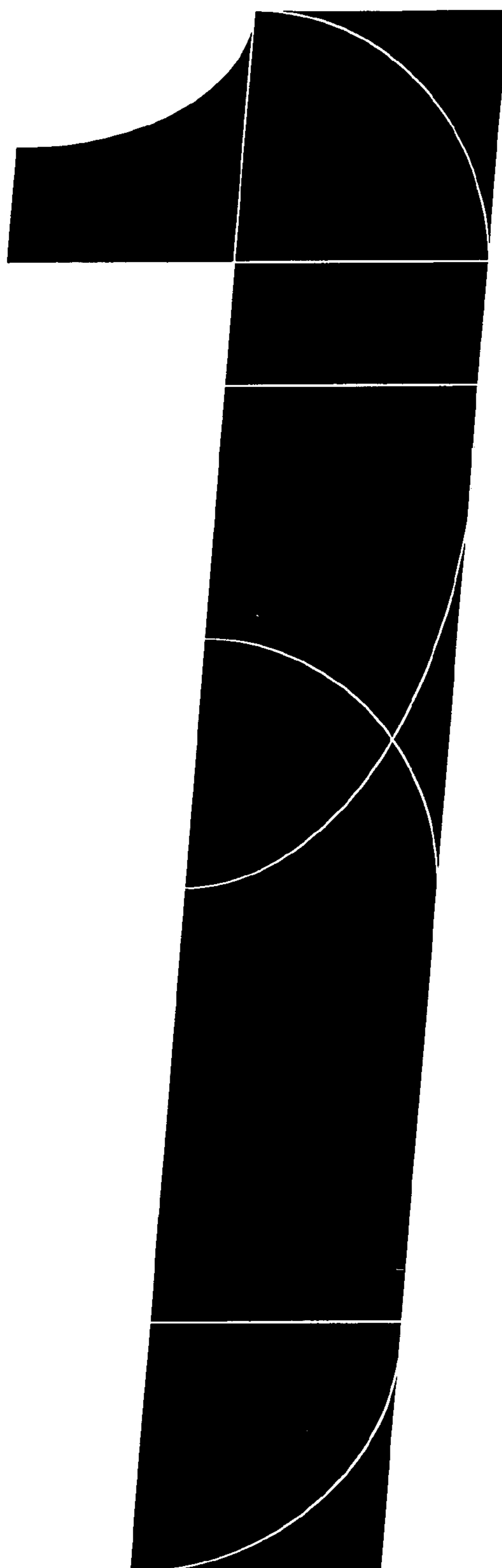




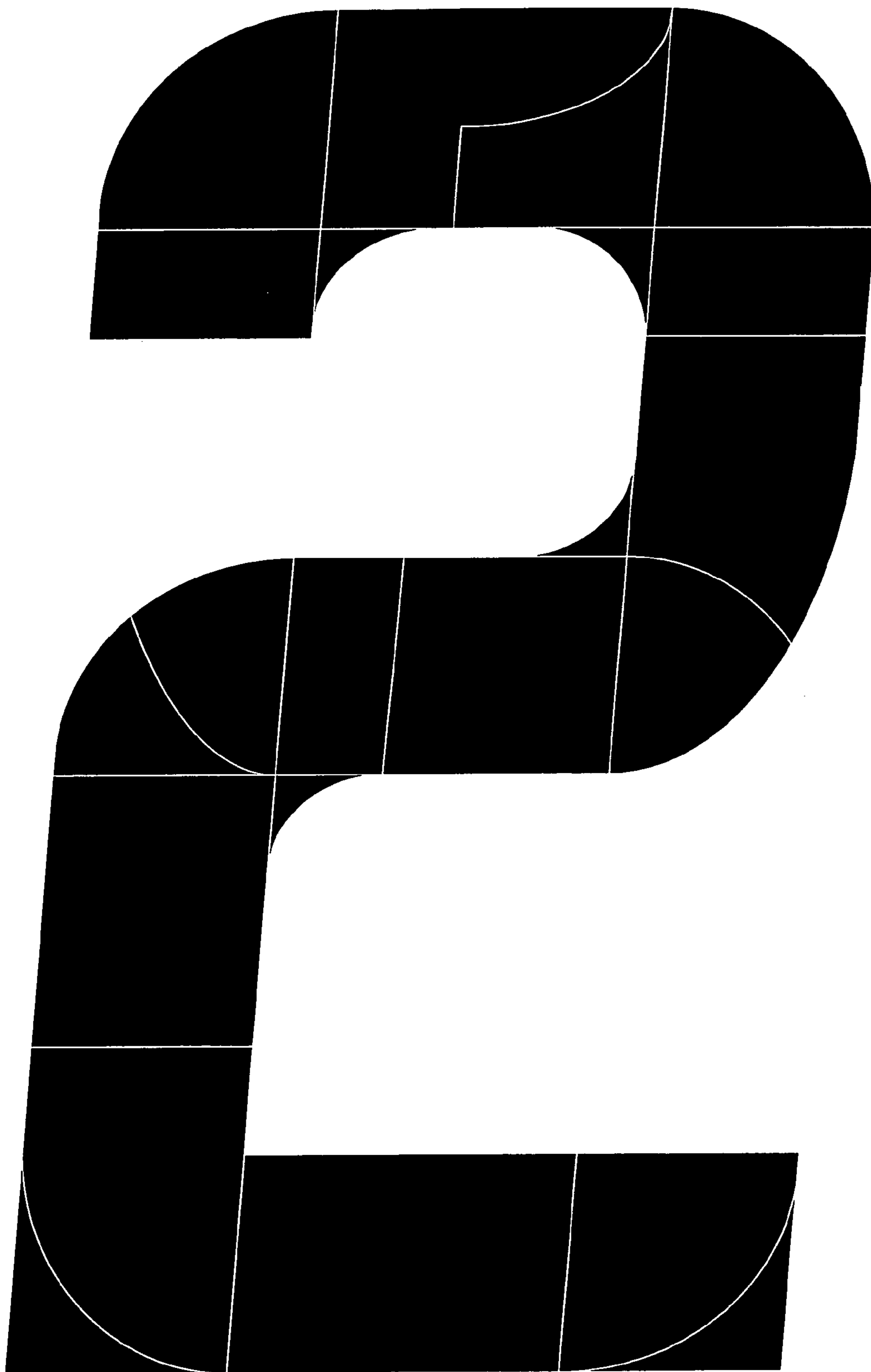

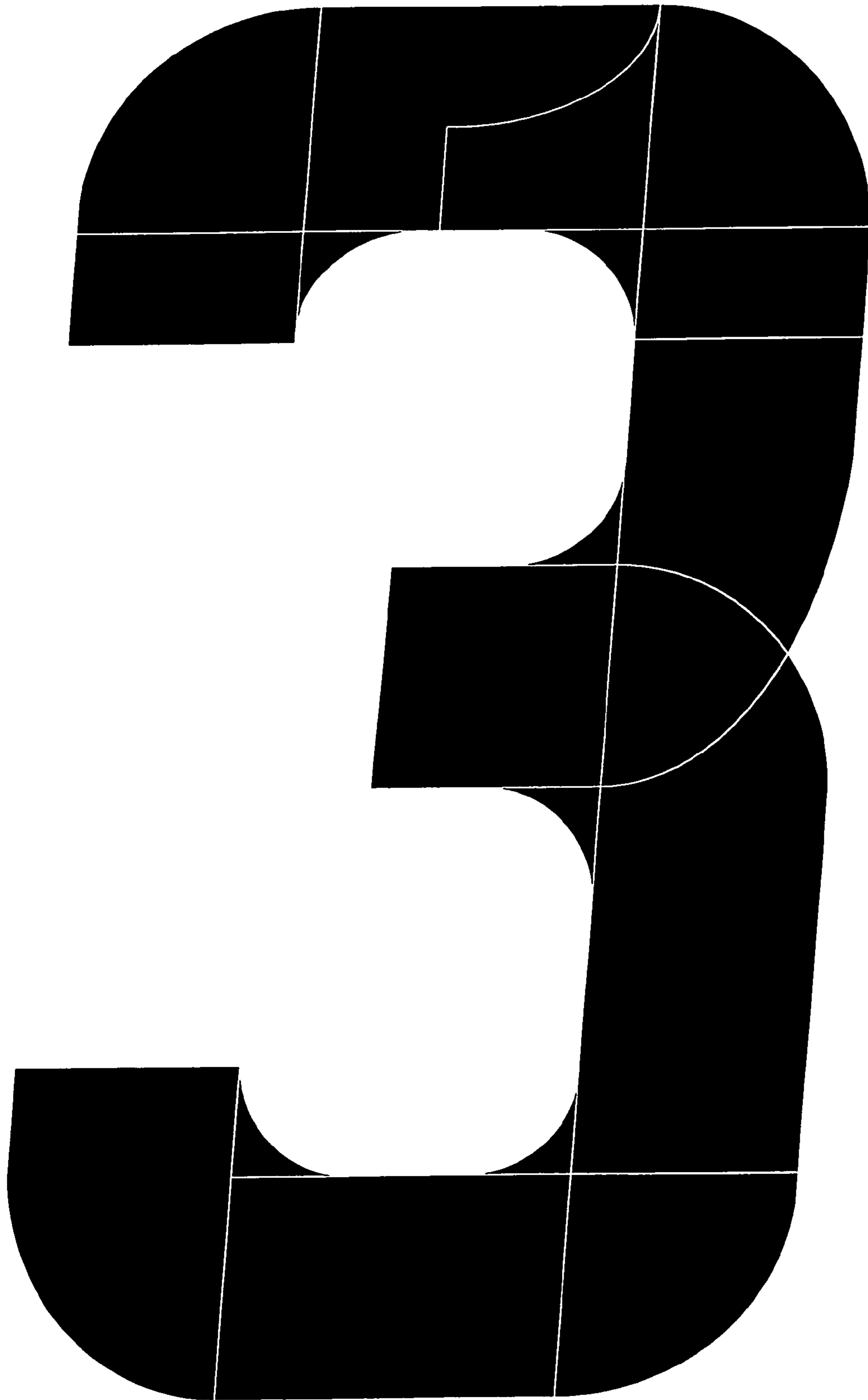

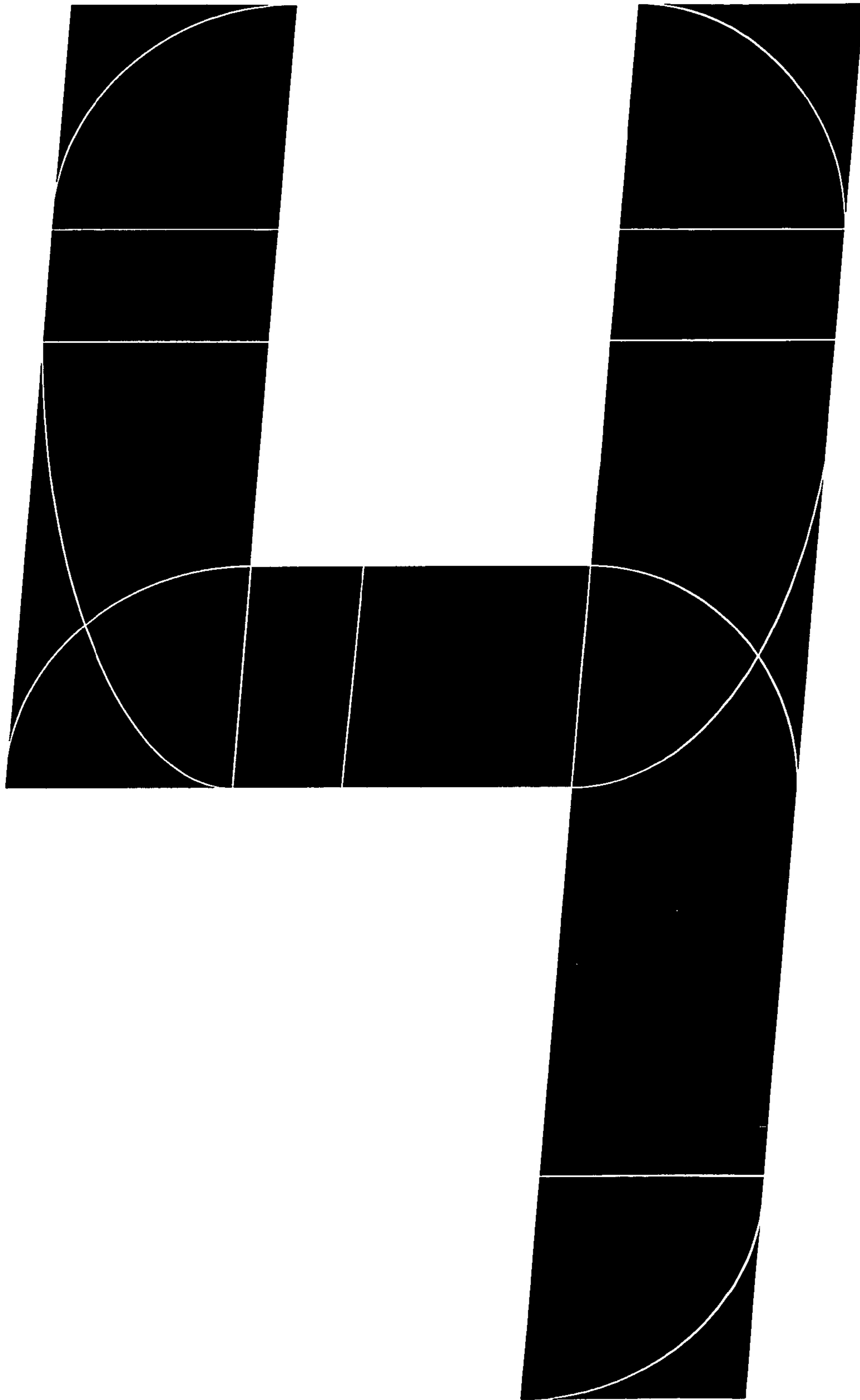

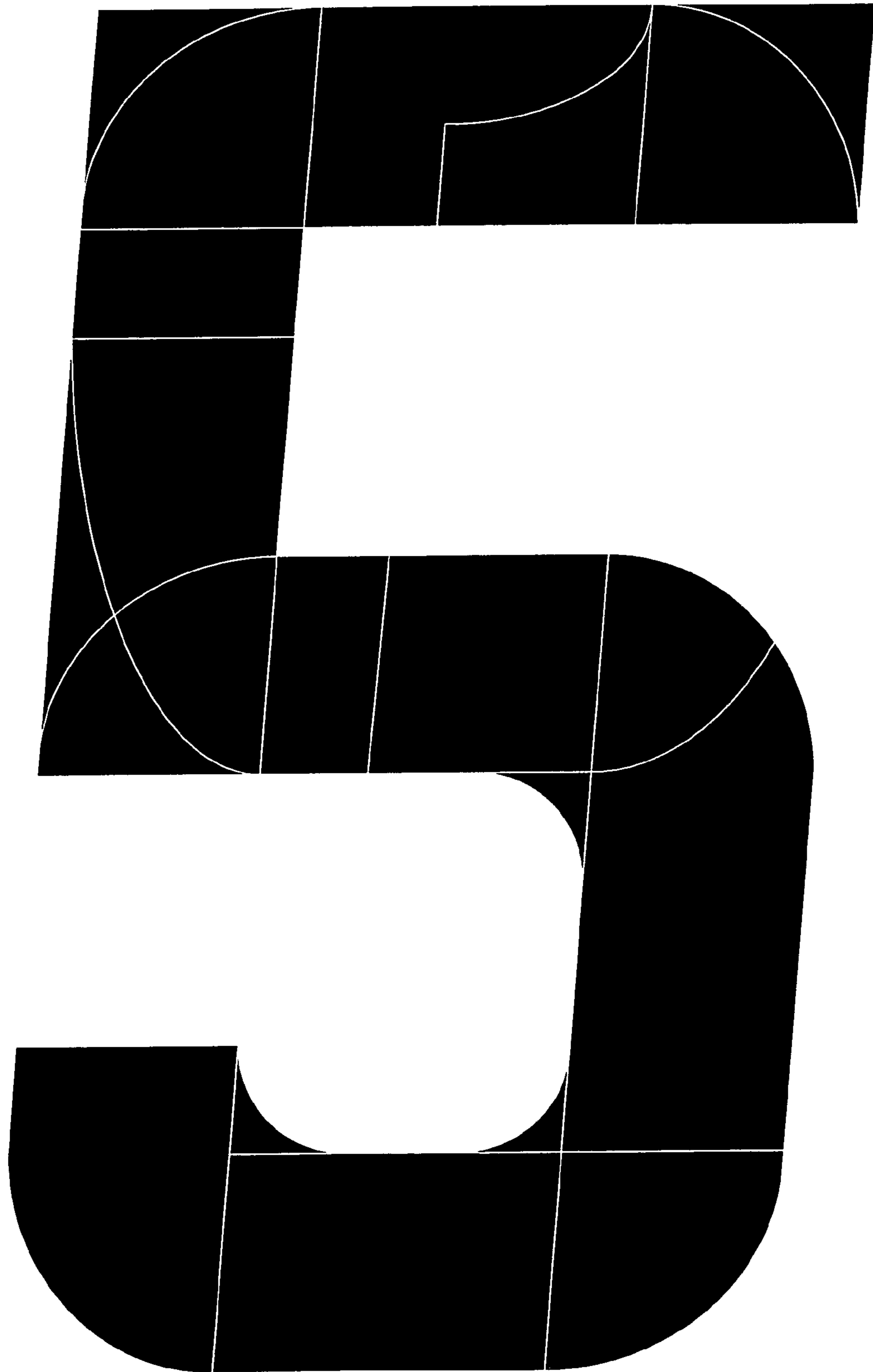

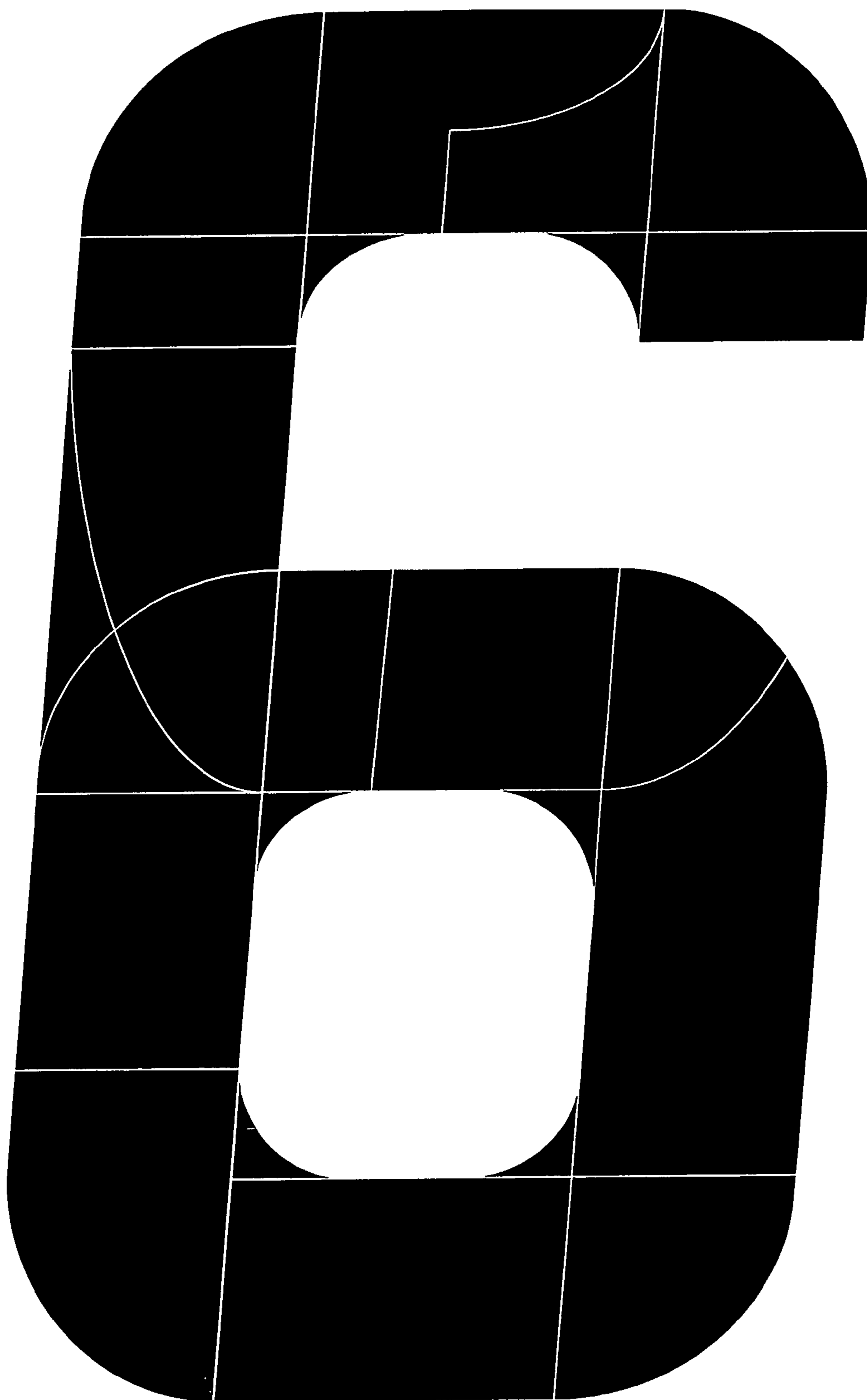

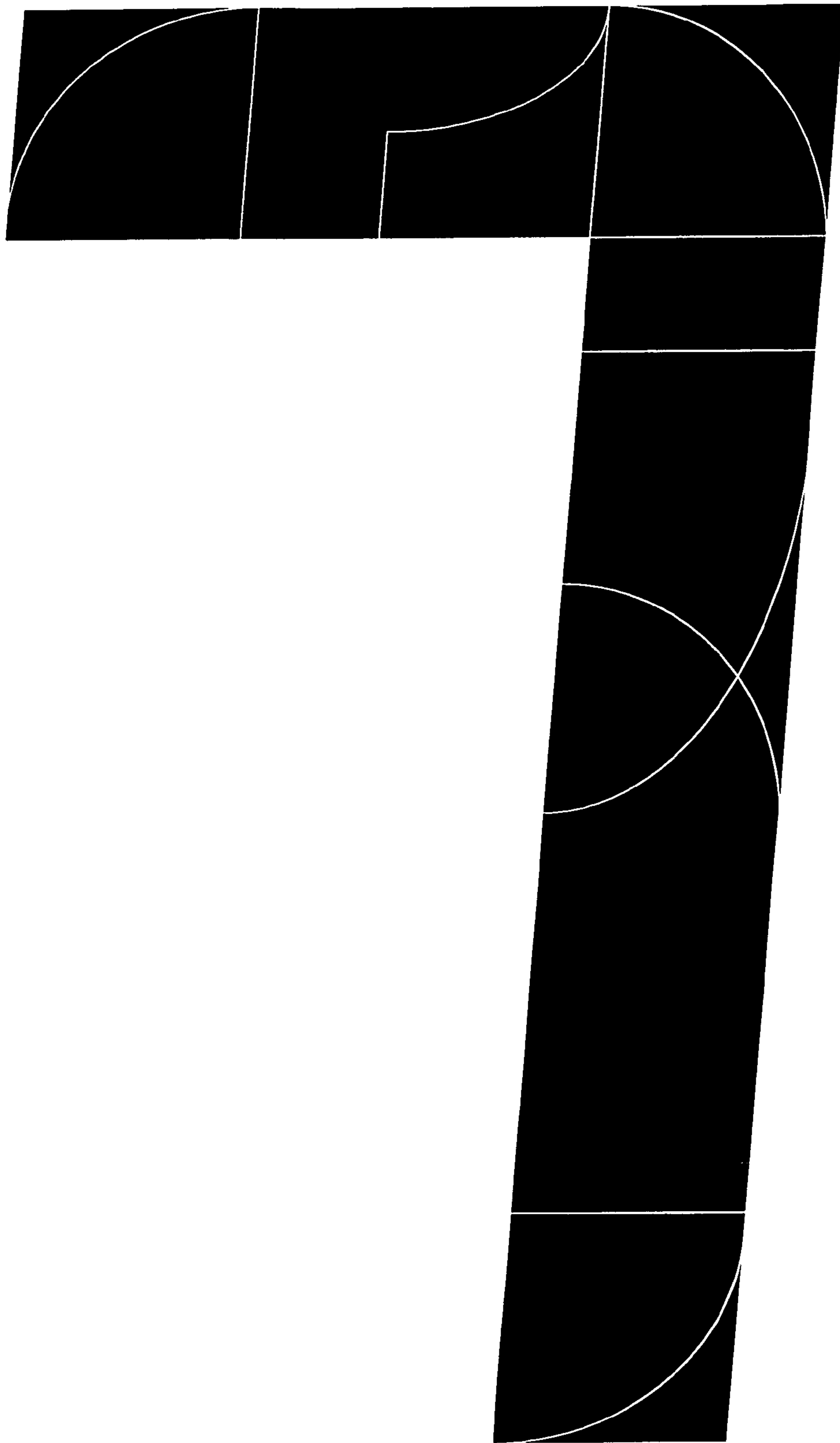

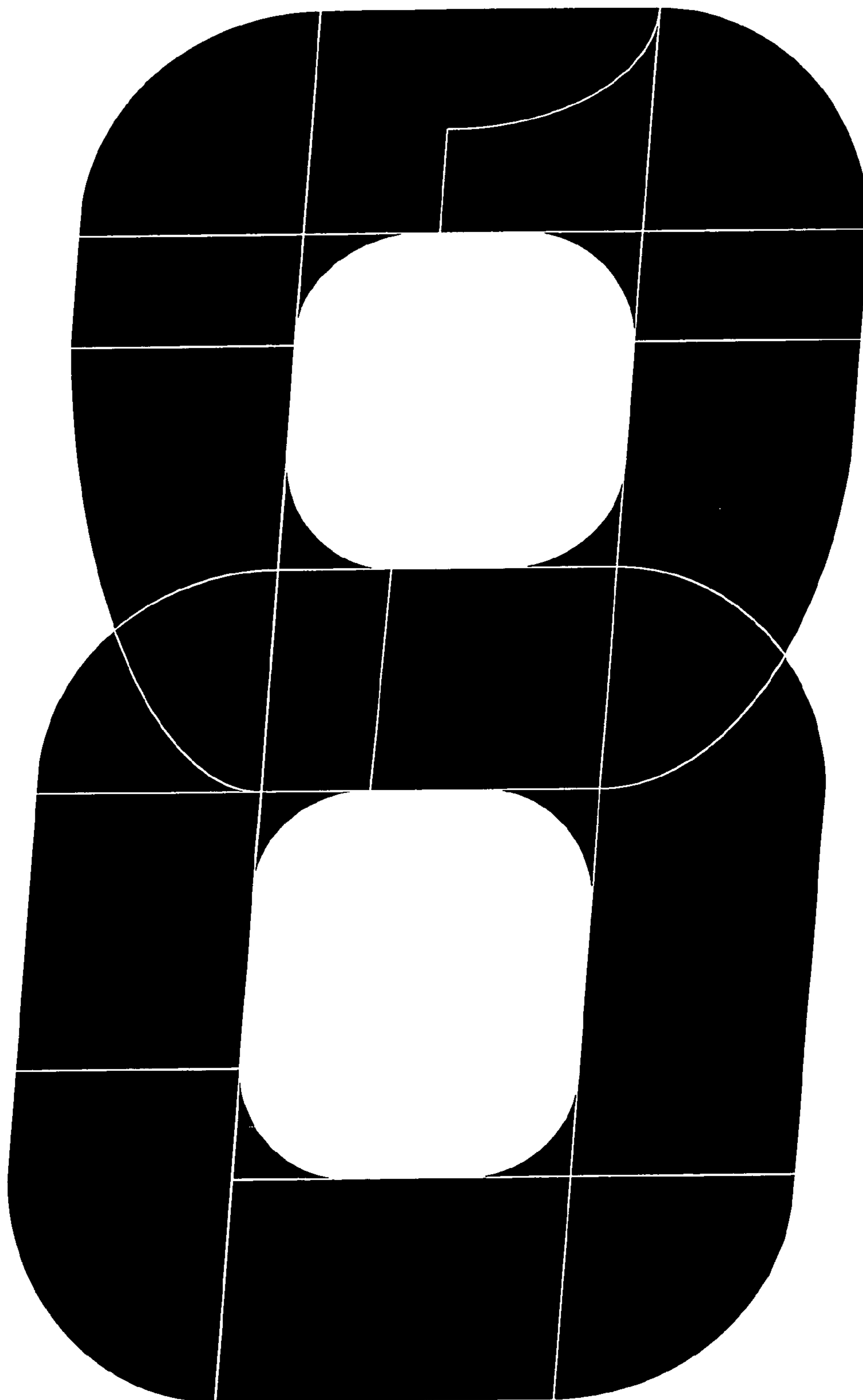




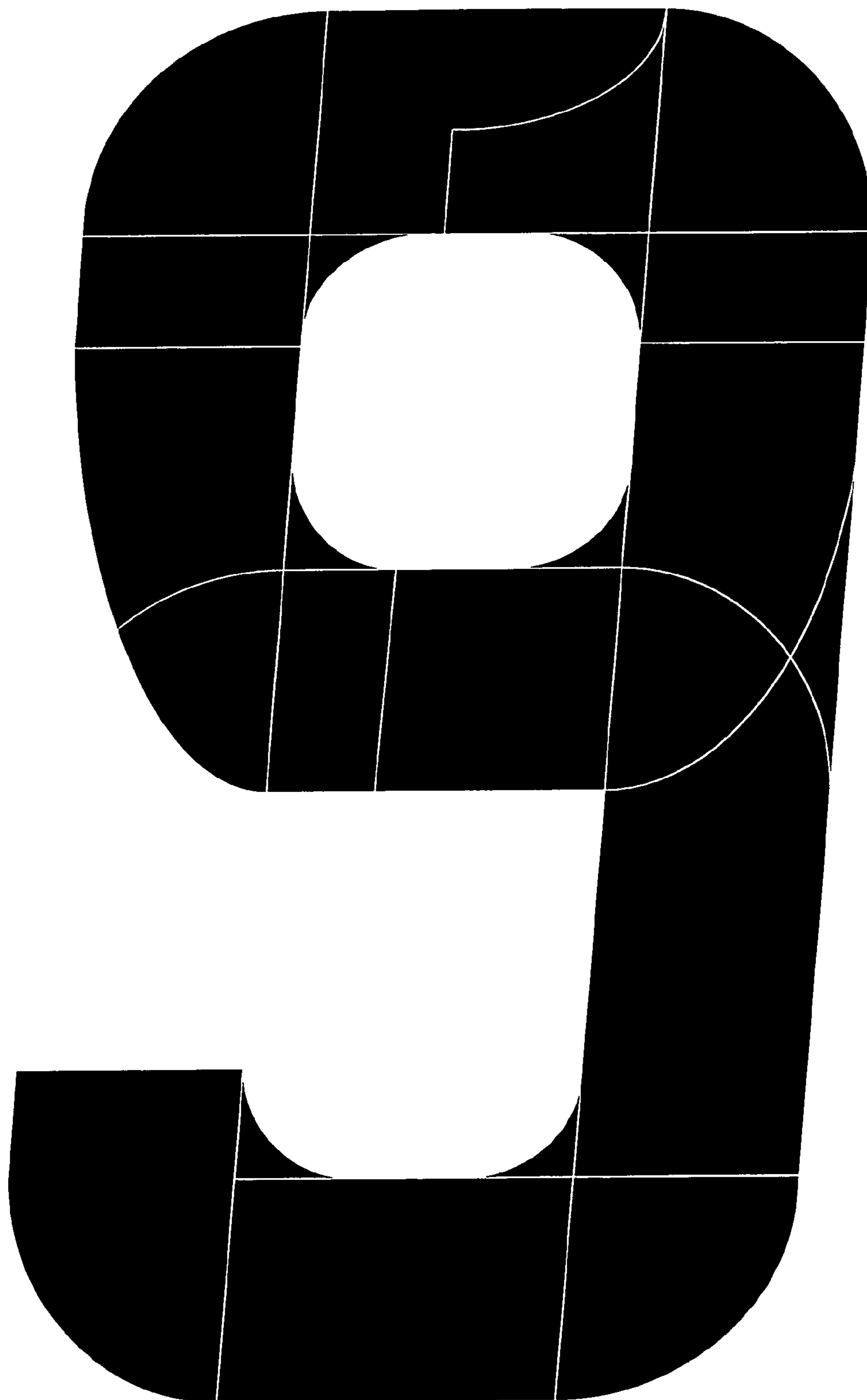
