(57) **CLAIM**

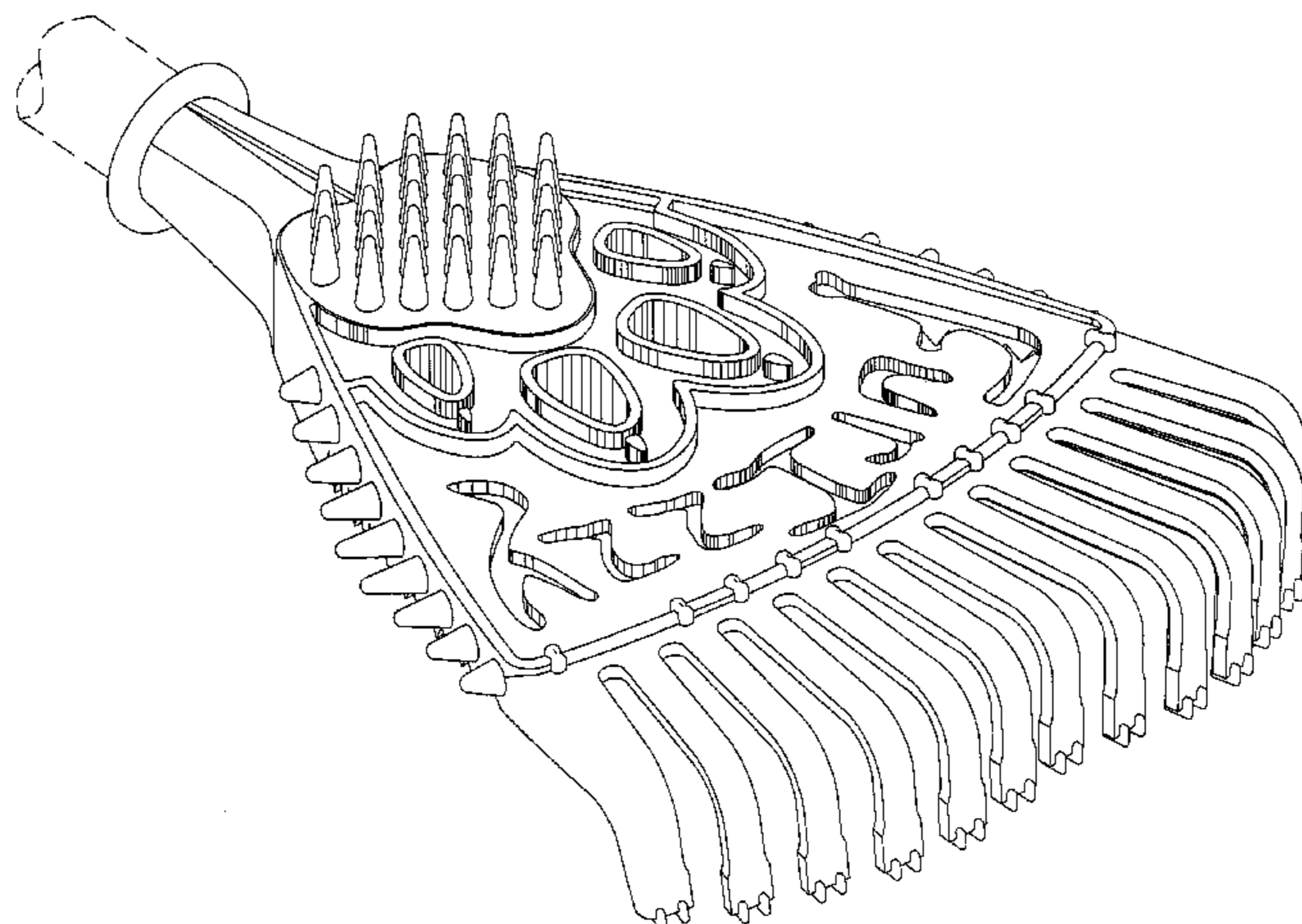
The ornamental design for a massage and grooming device for animals, as shown and described.

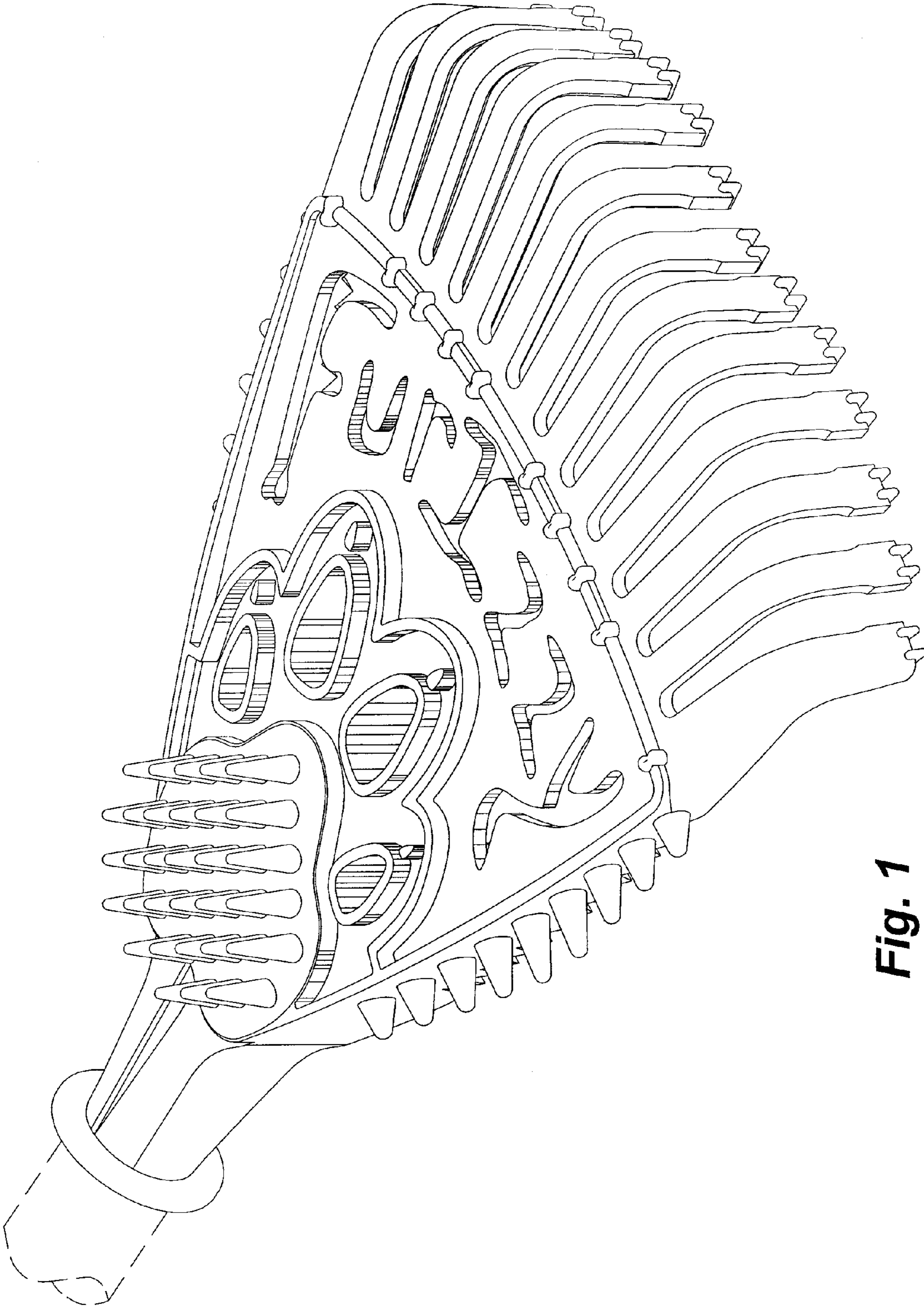

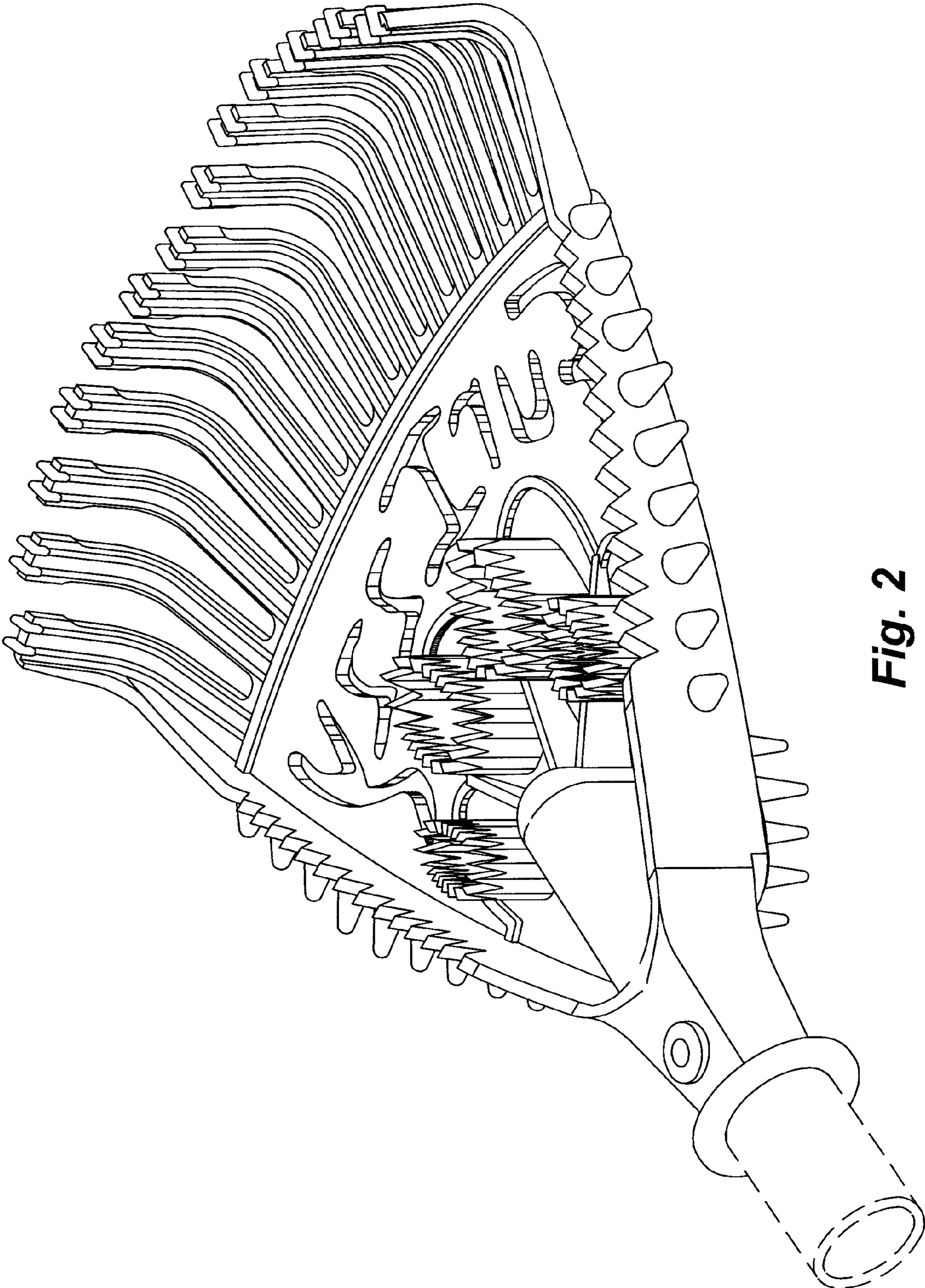

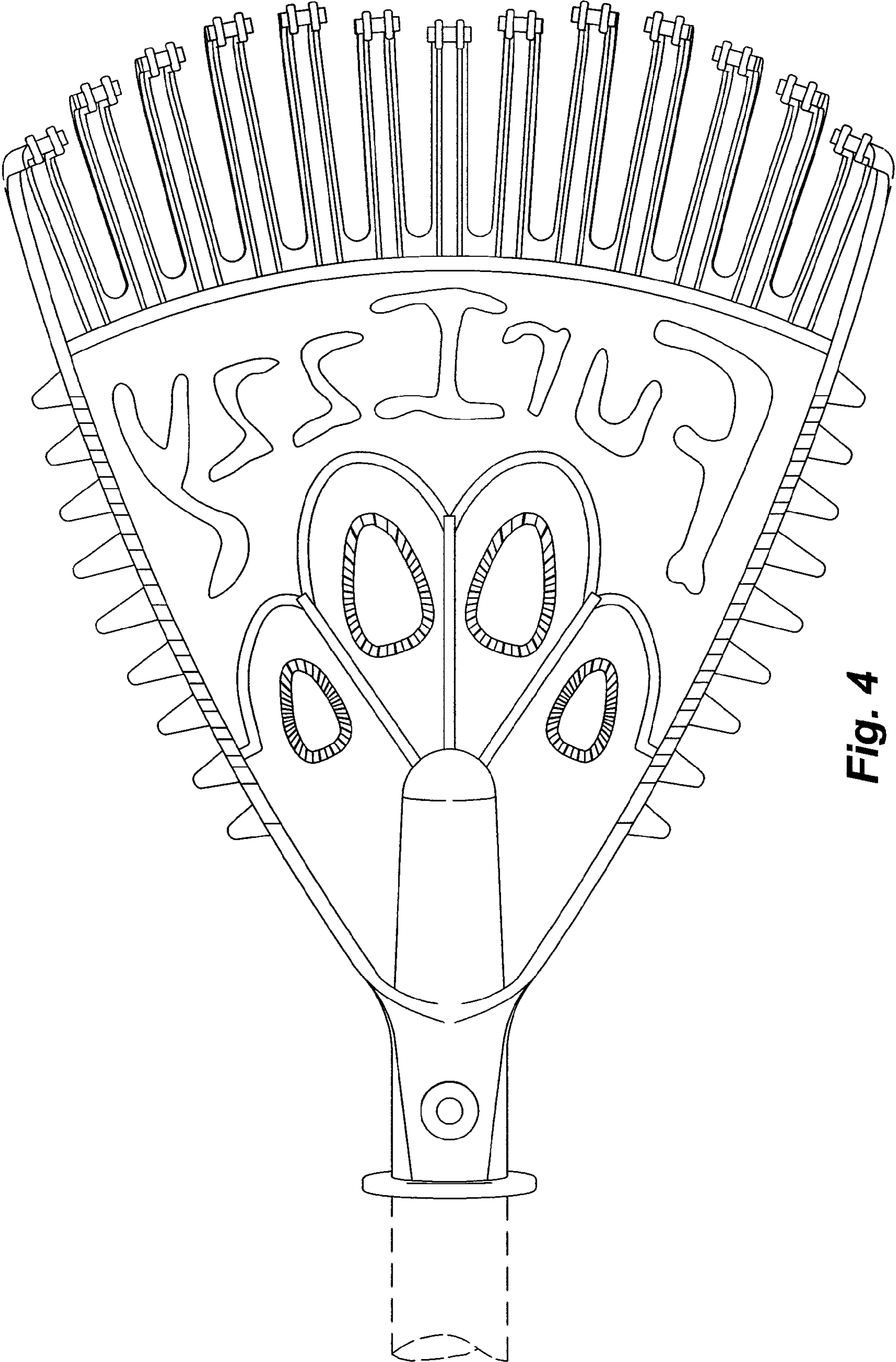

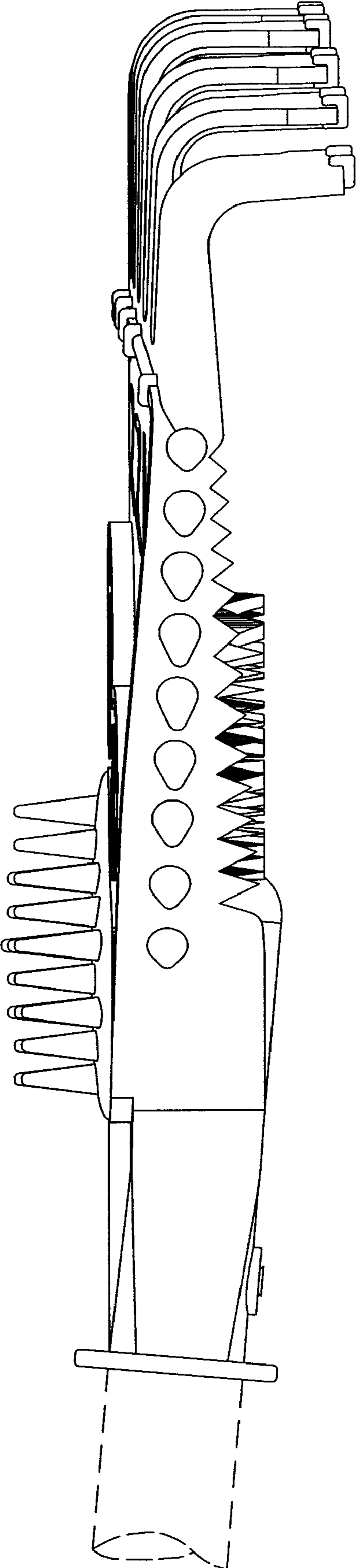

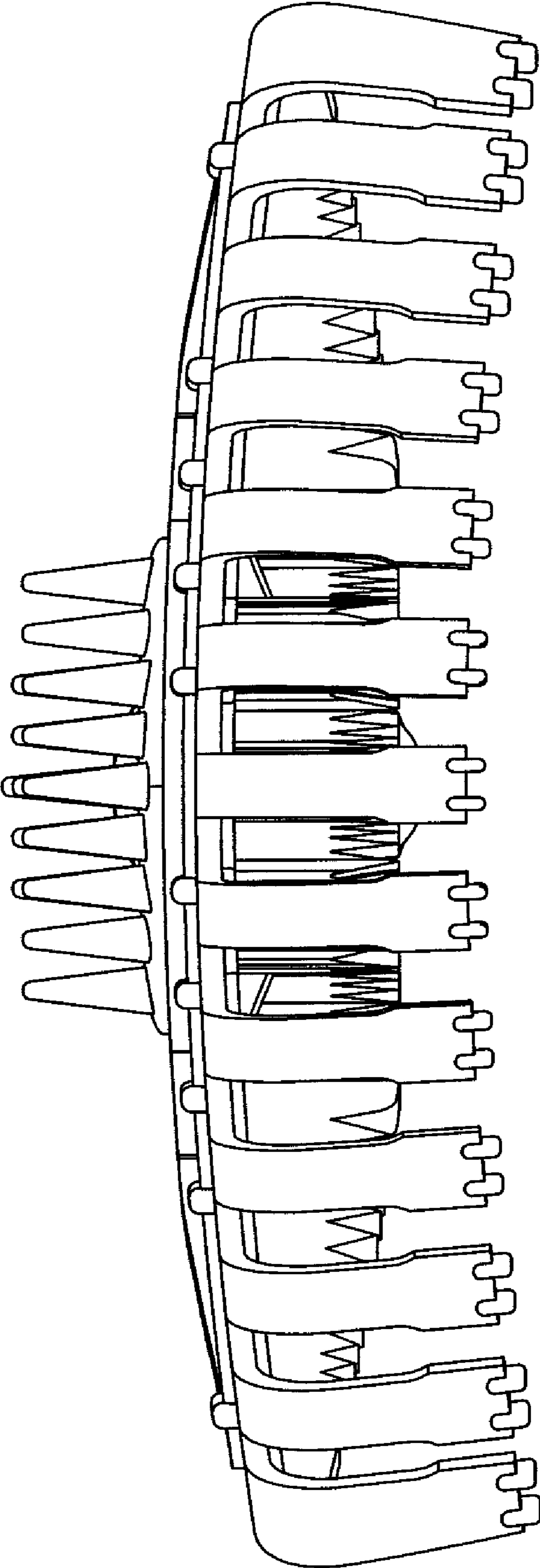
