**DESCRIPTION**

FIG. 1 is a perspective view of a handle.

FIG. 2 is another perspective view of the handle.

FIG. 3 is a front view of the handle, the rear being identical thereto.

FIG. 4 is a right side view of the handle, the left side being identical thereto.

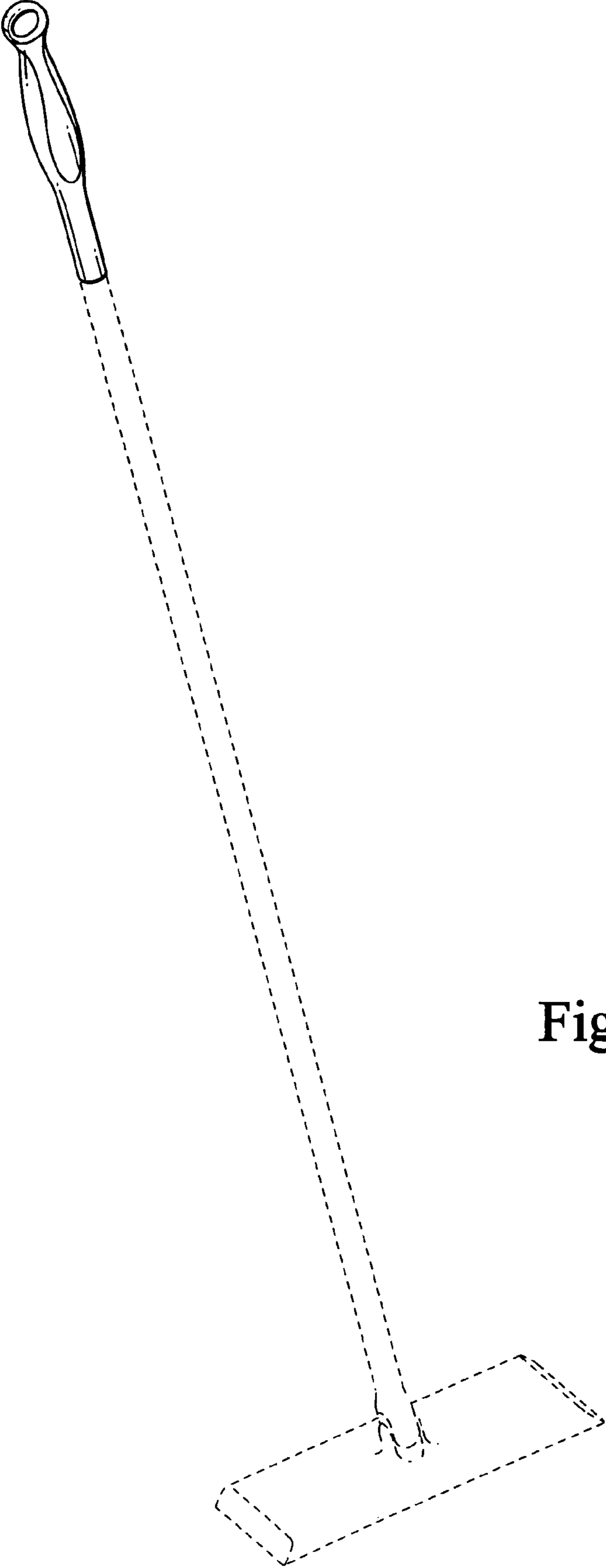

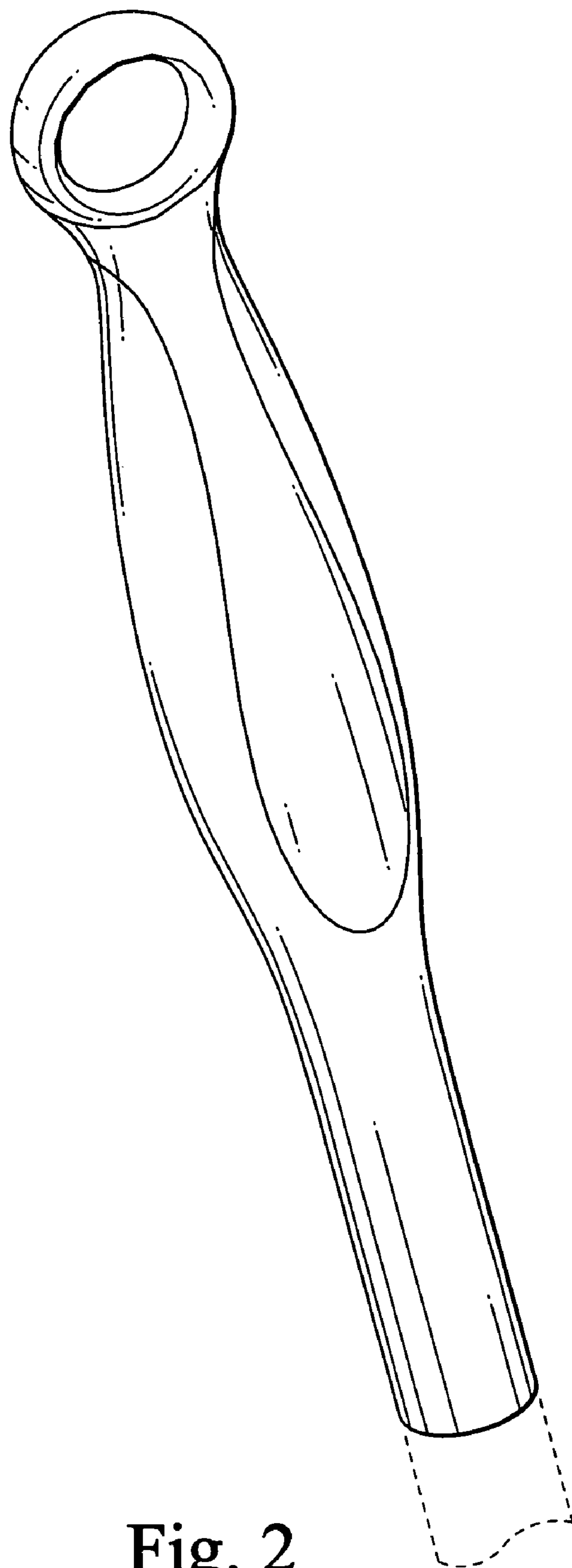

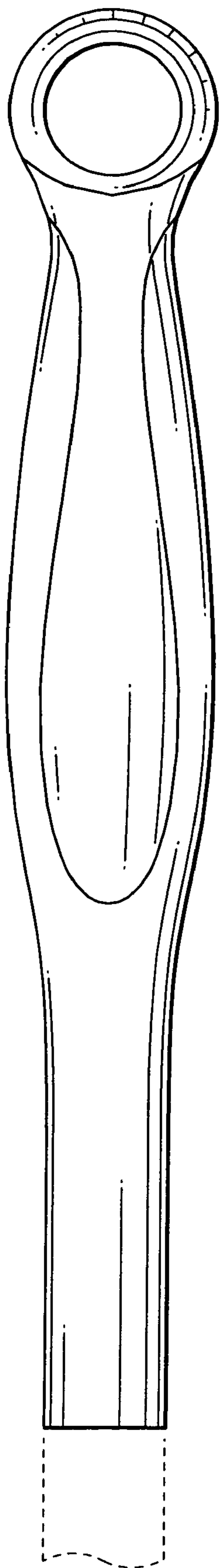

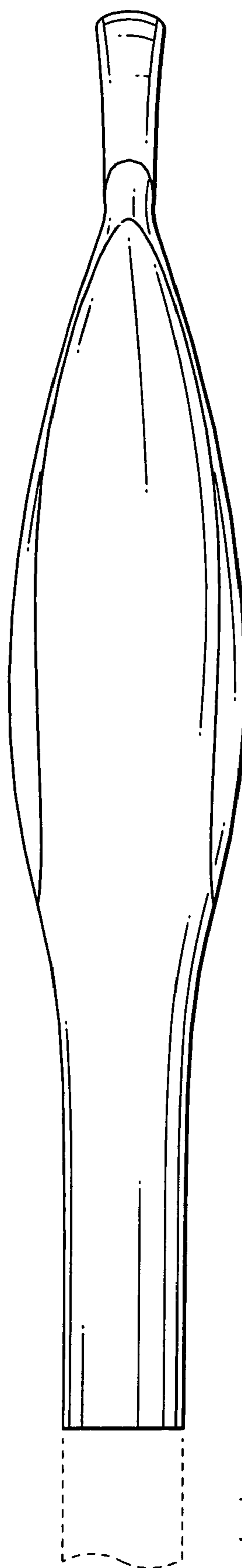

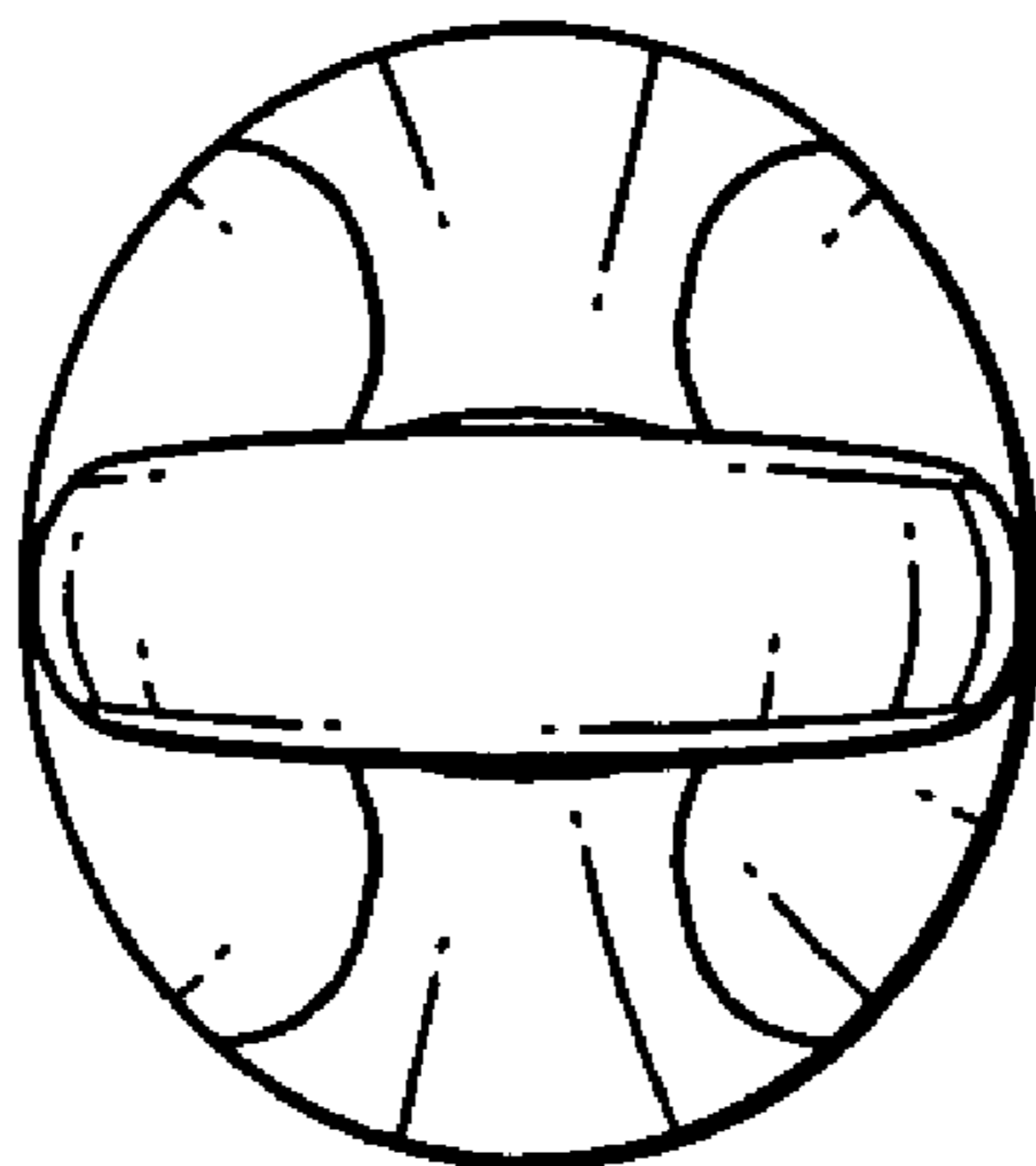

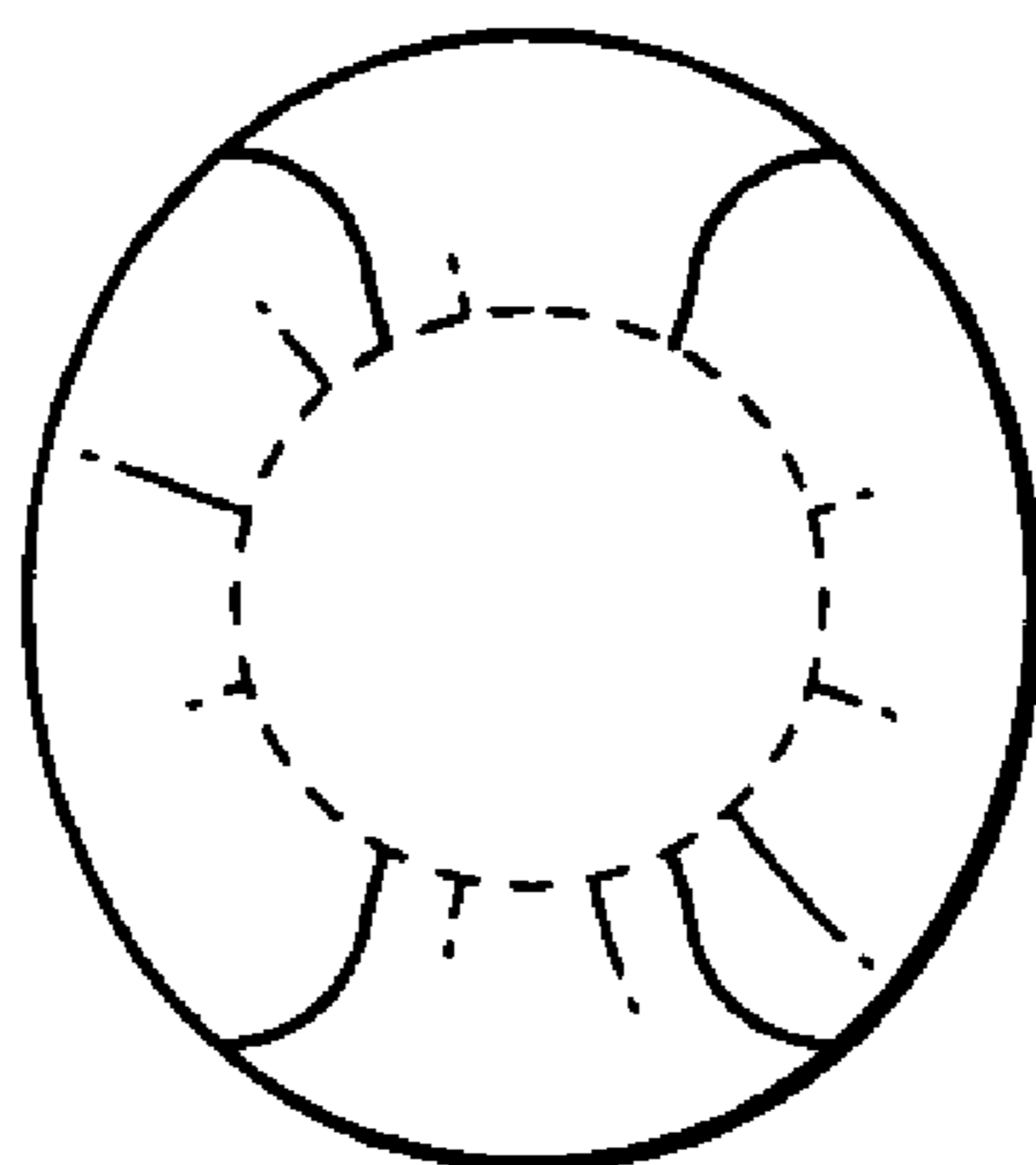
