FIG. 28 is a top view thereof.

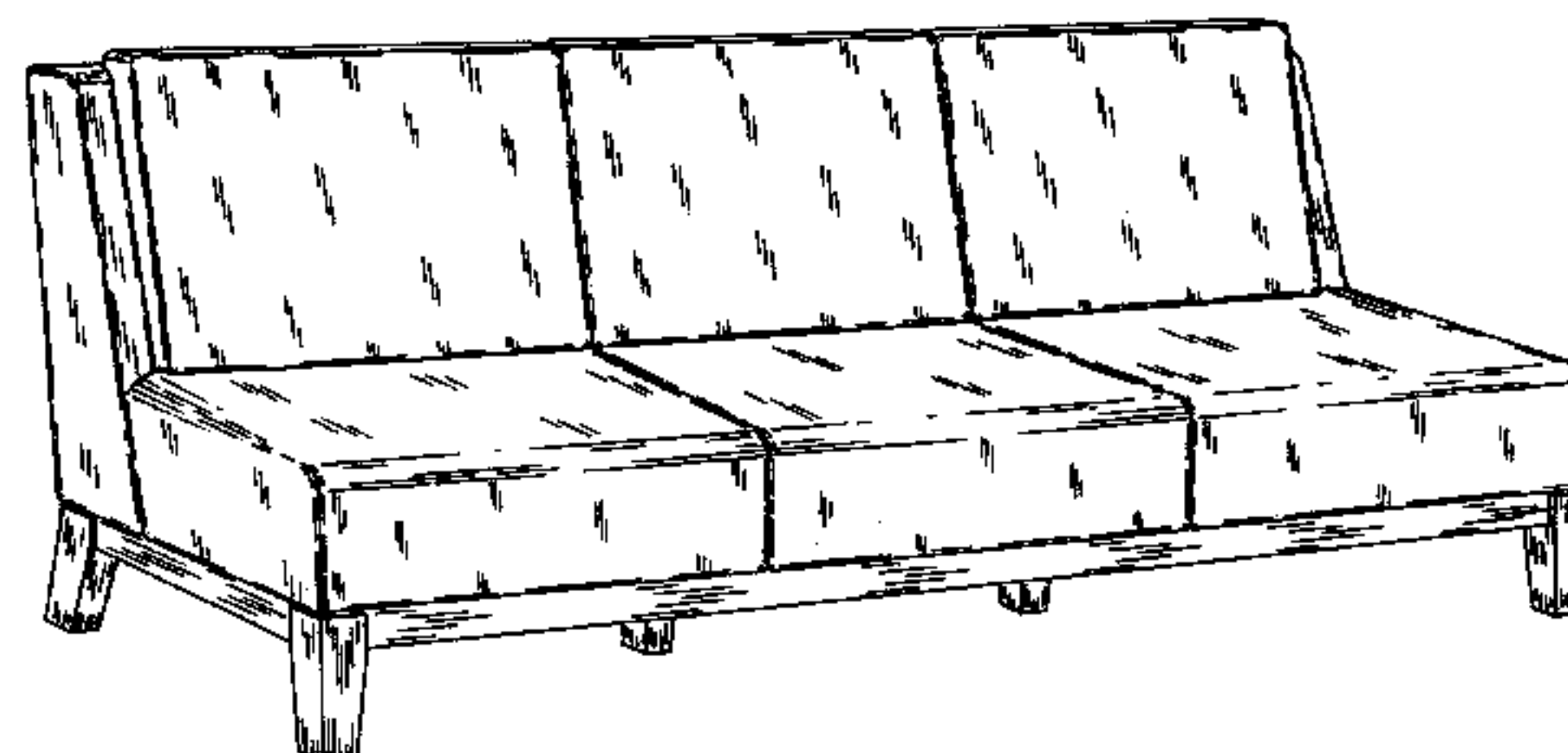
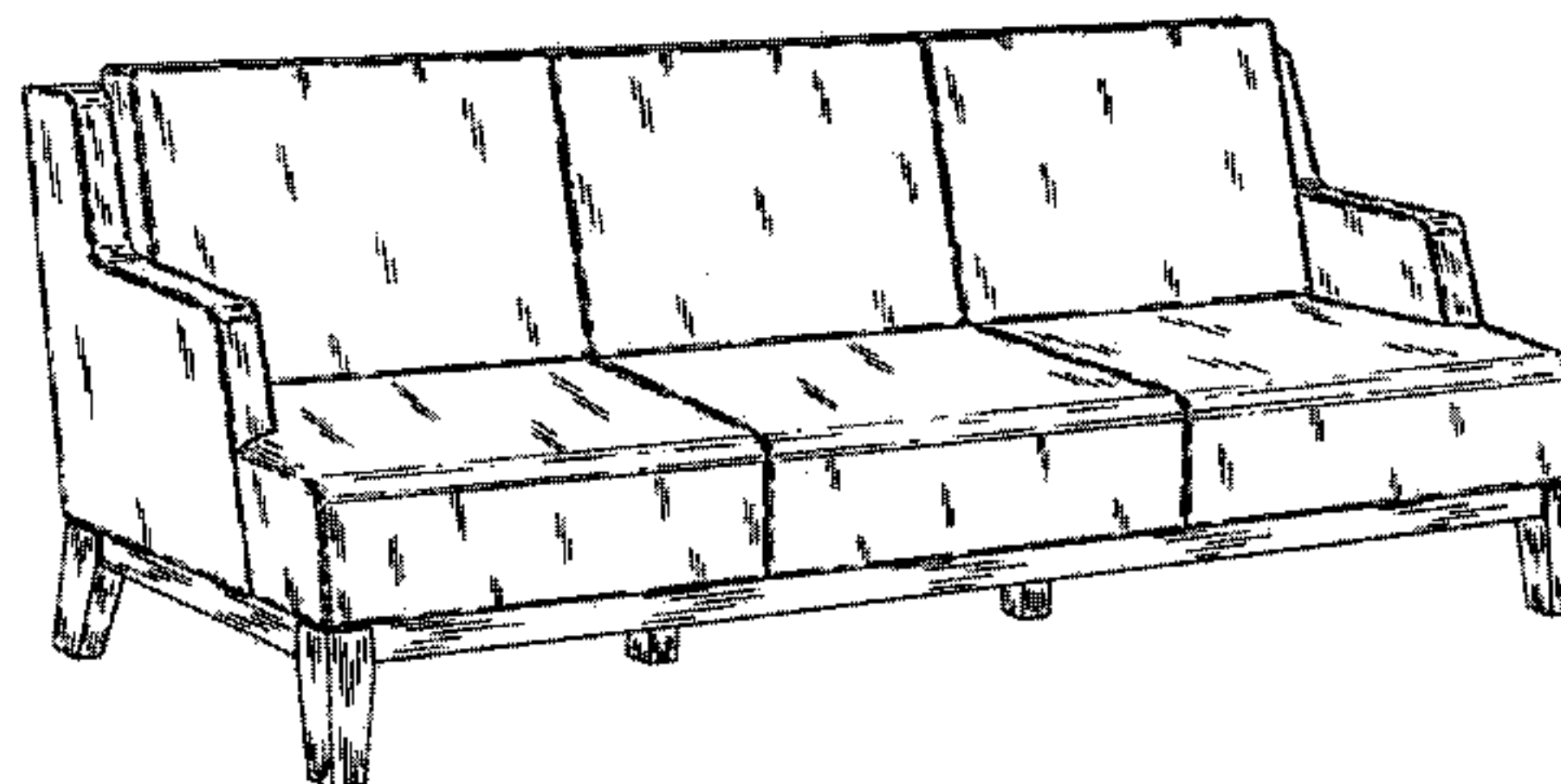

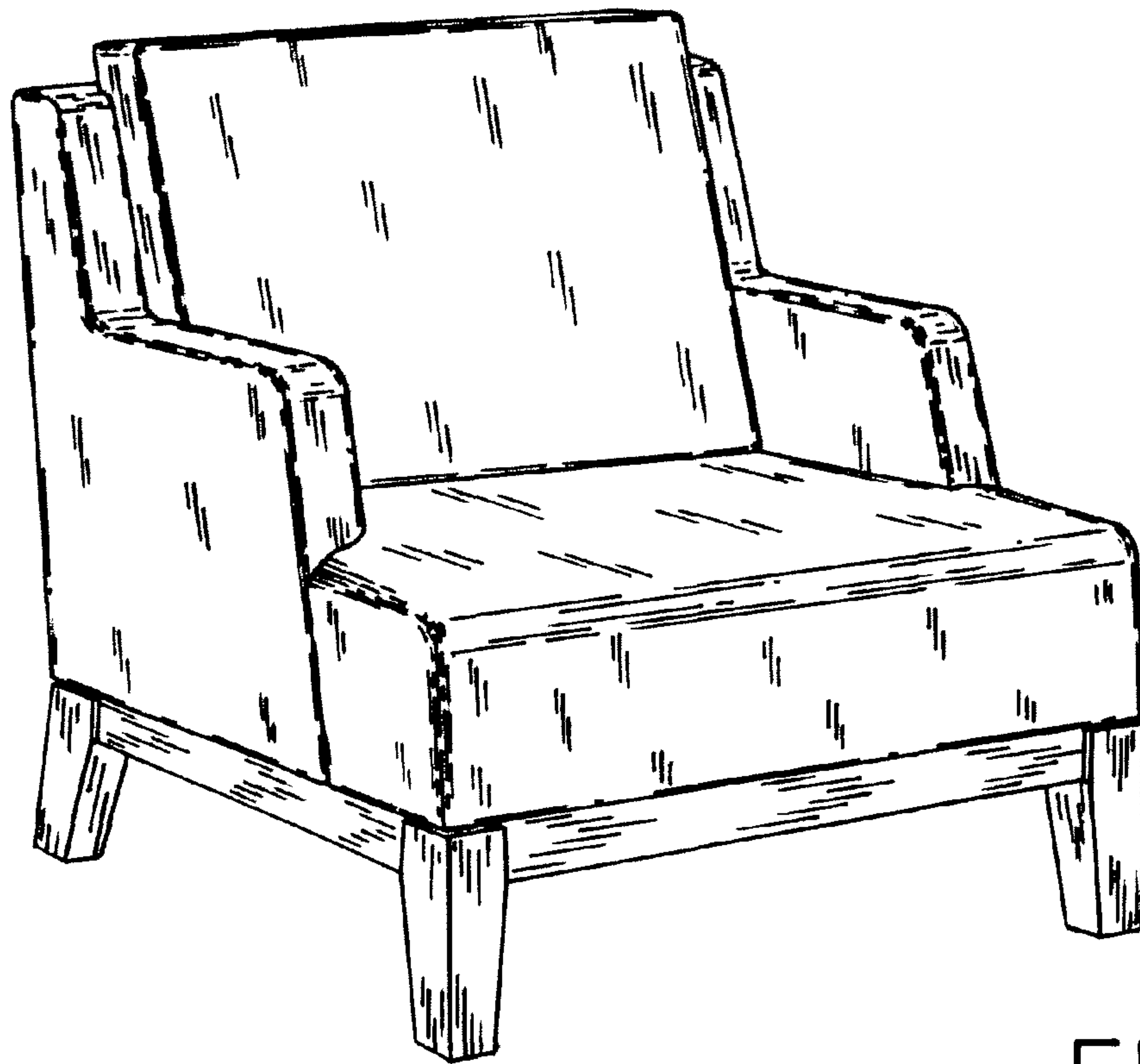

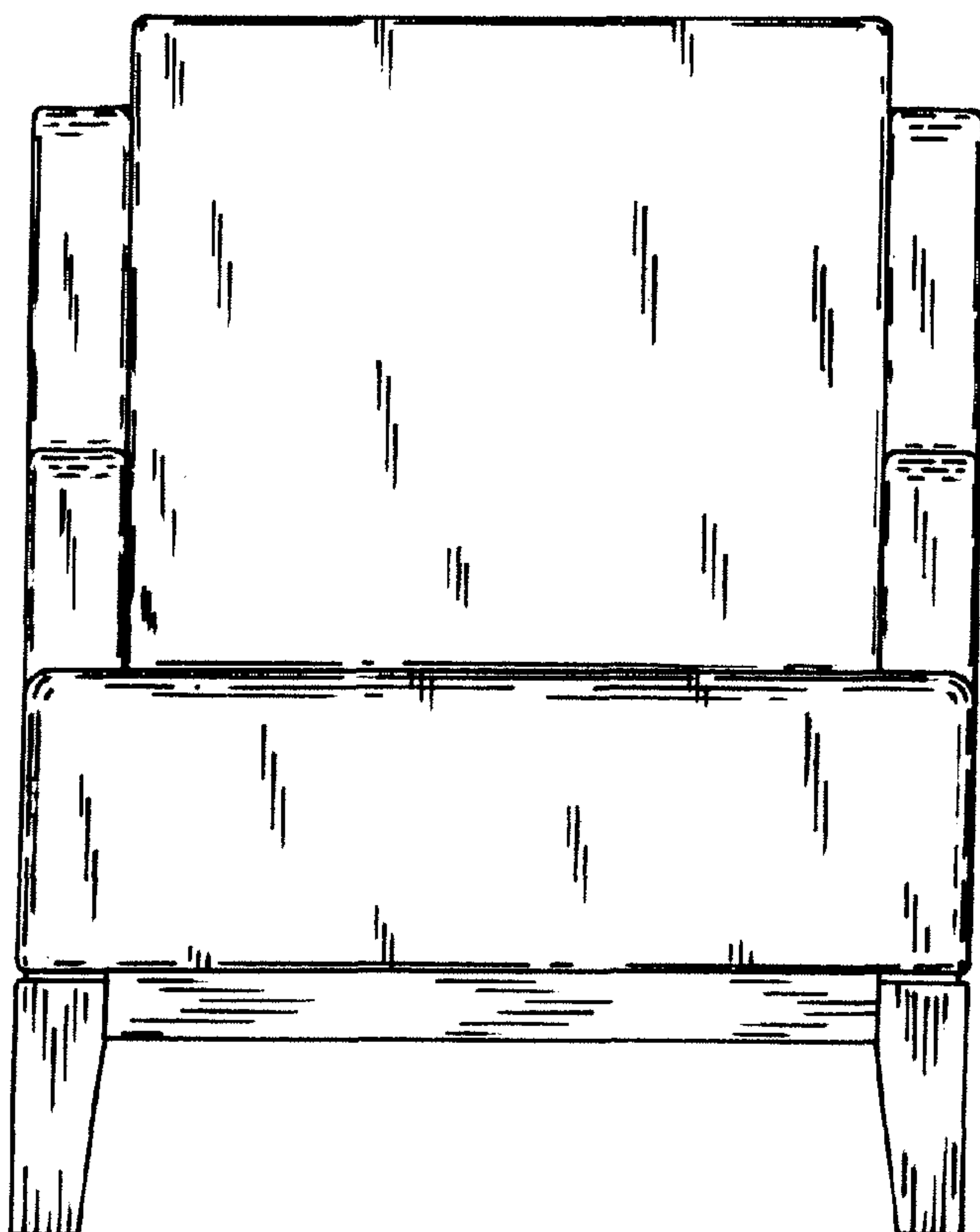

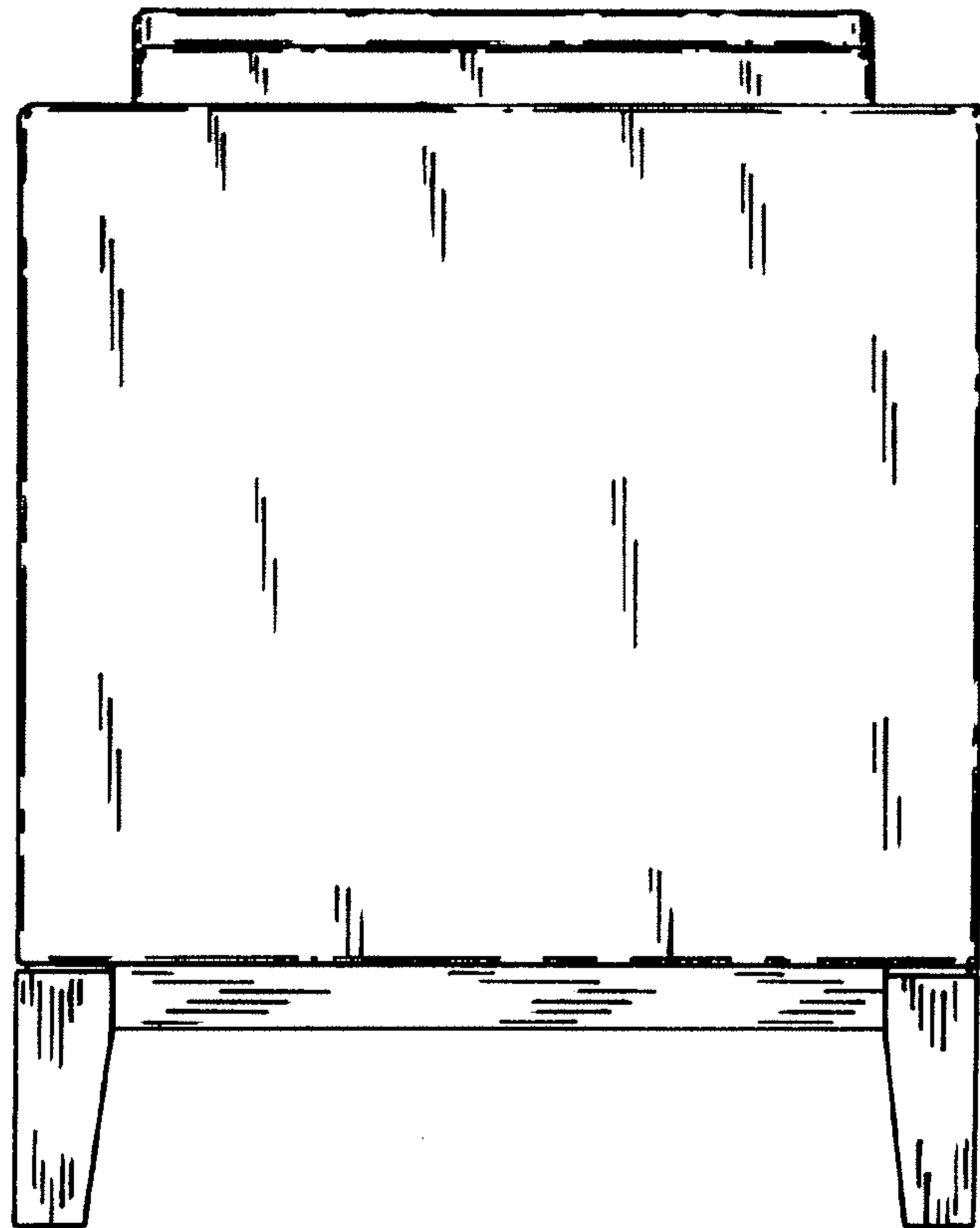

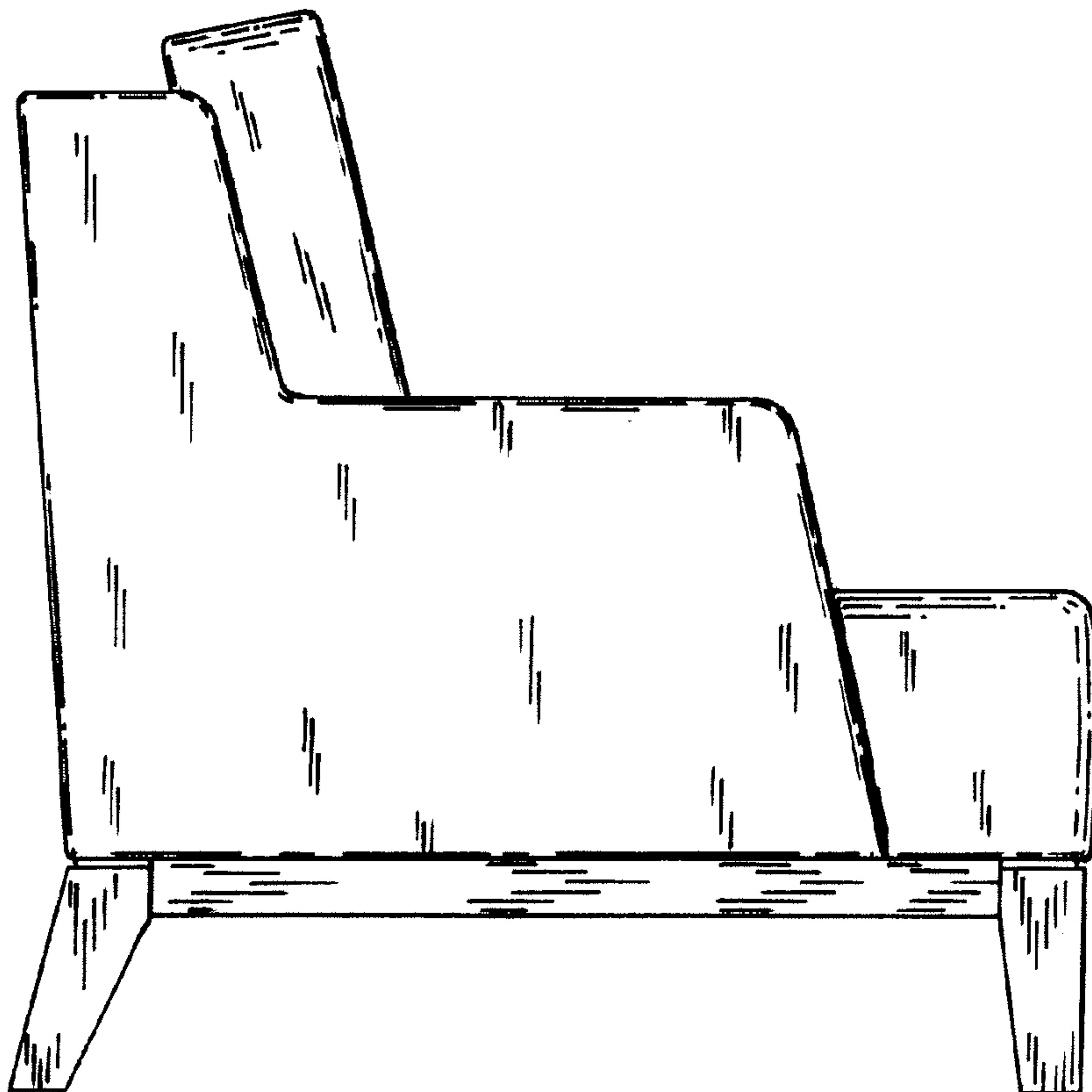

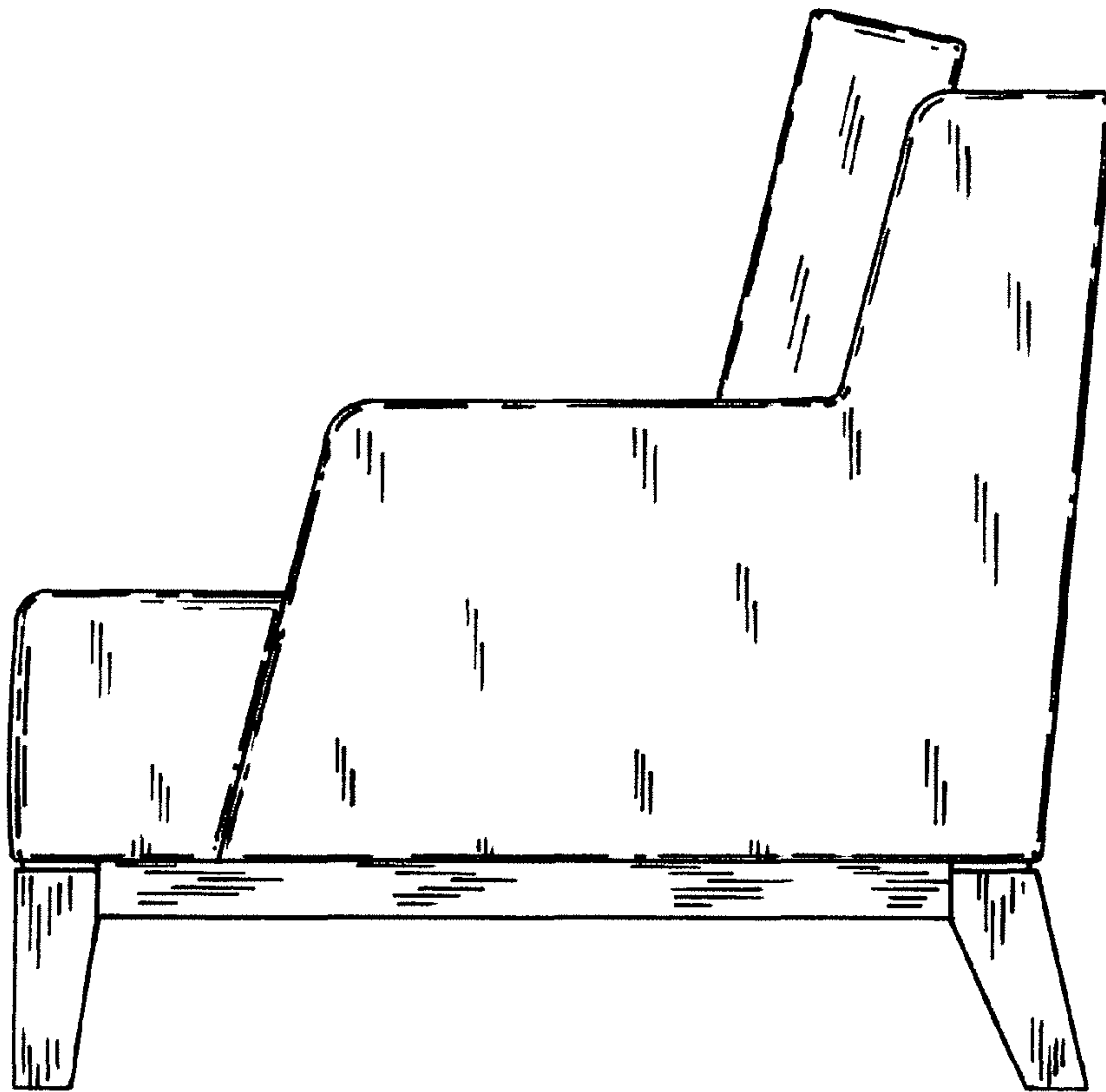

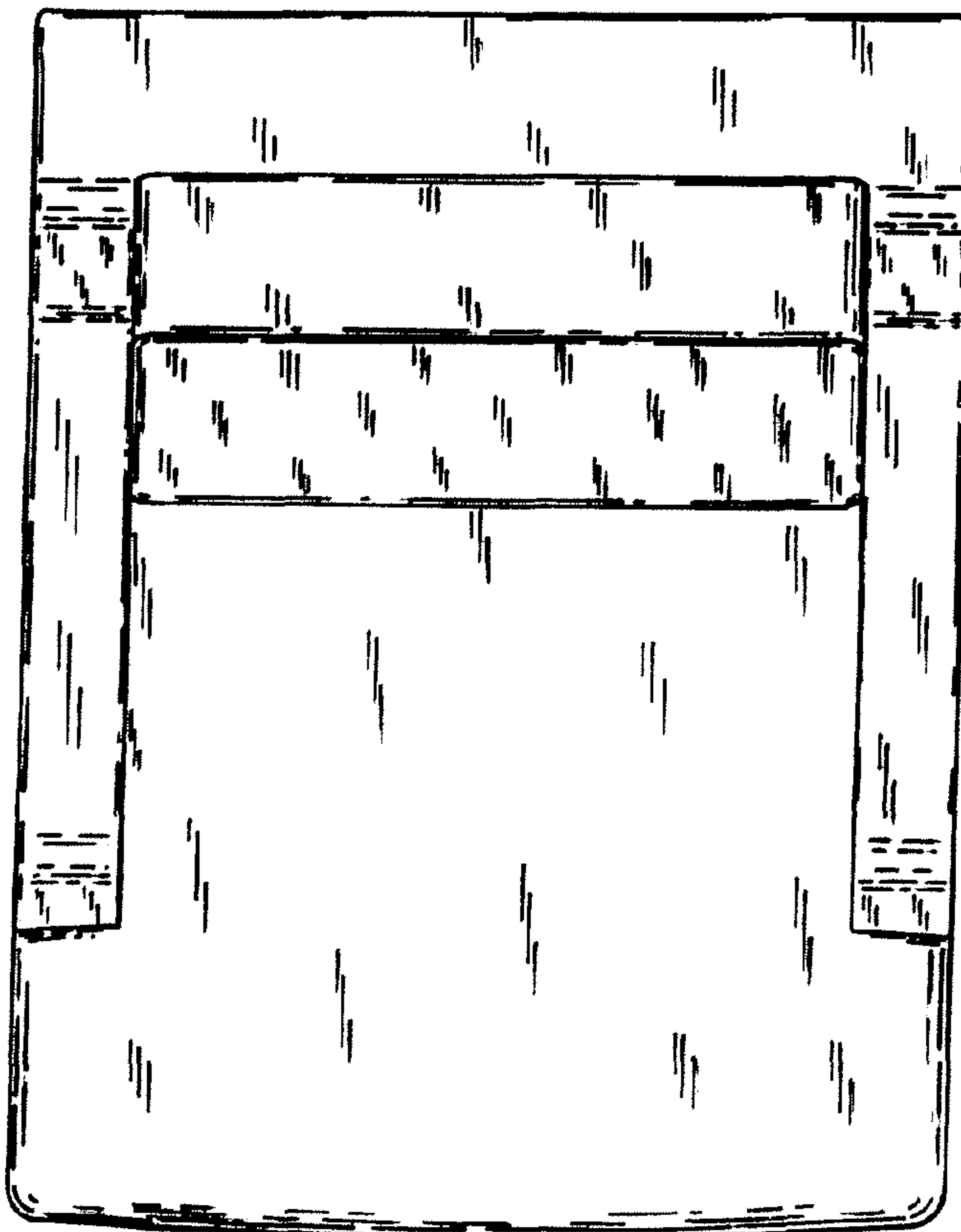

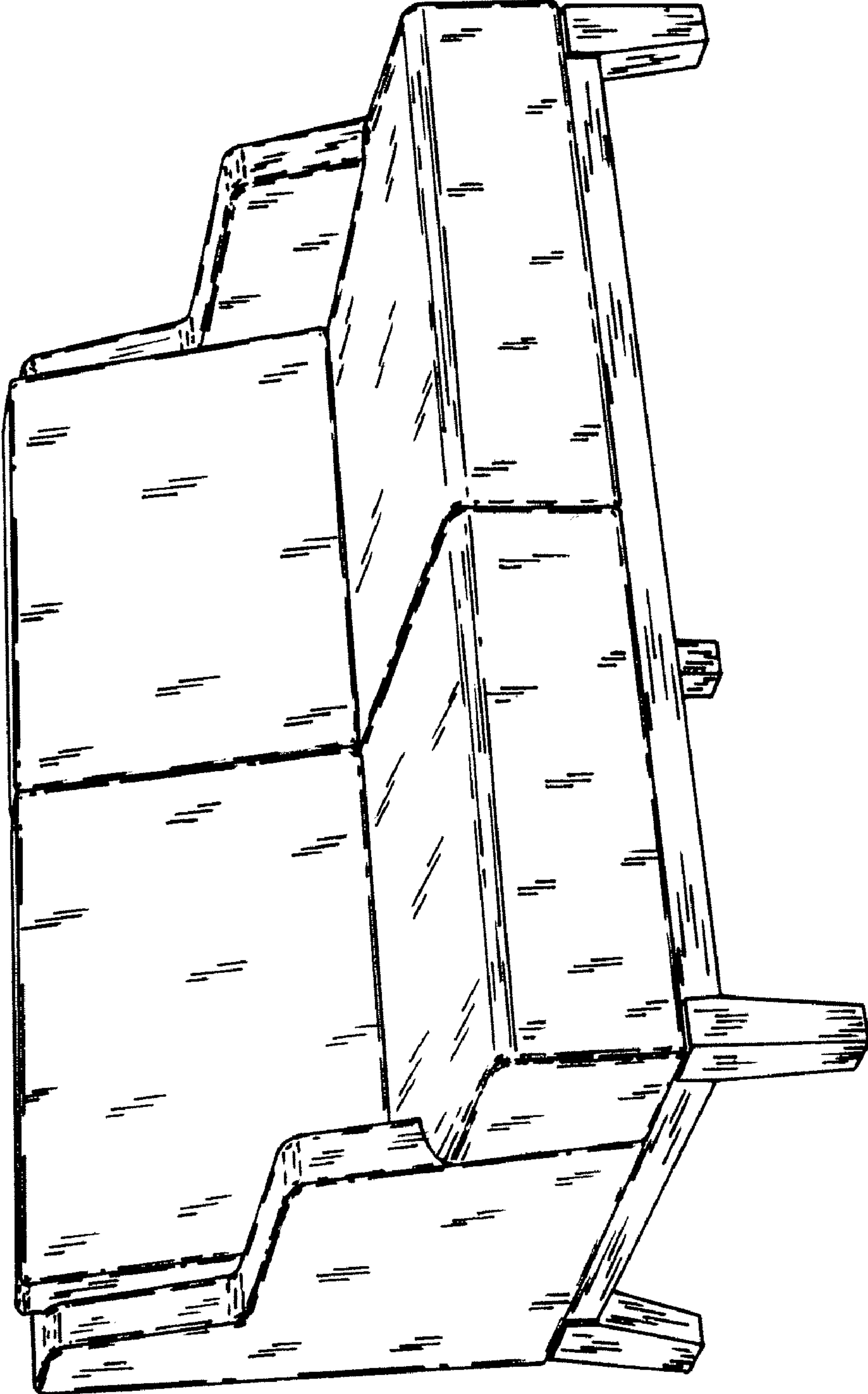

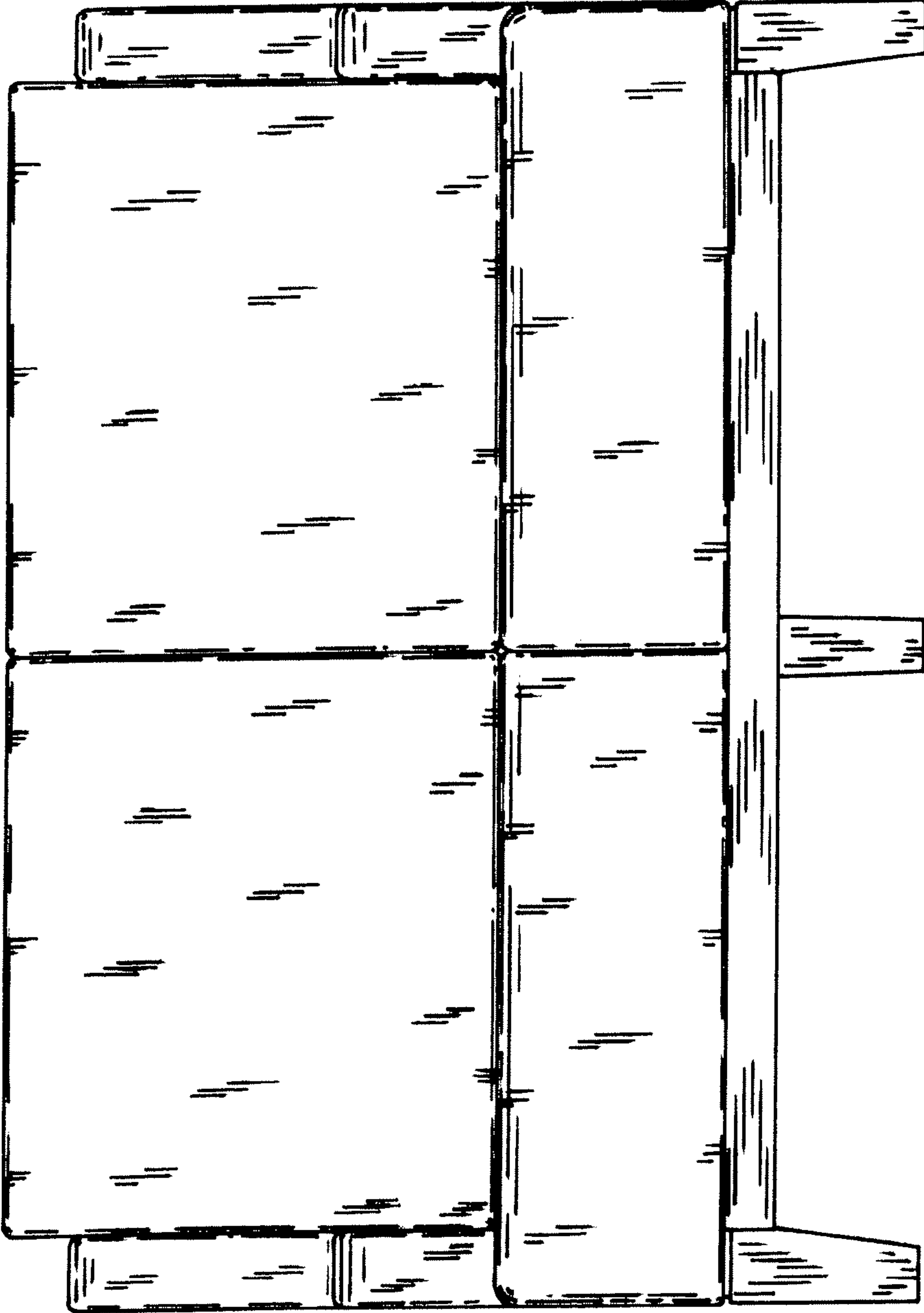

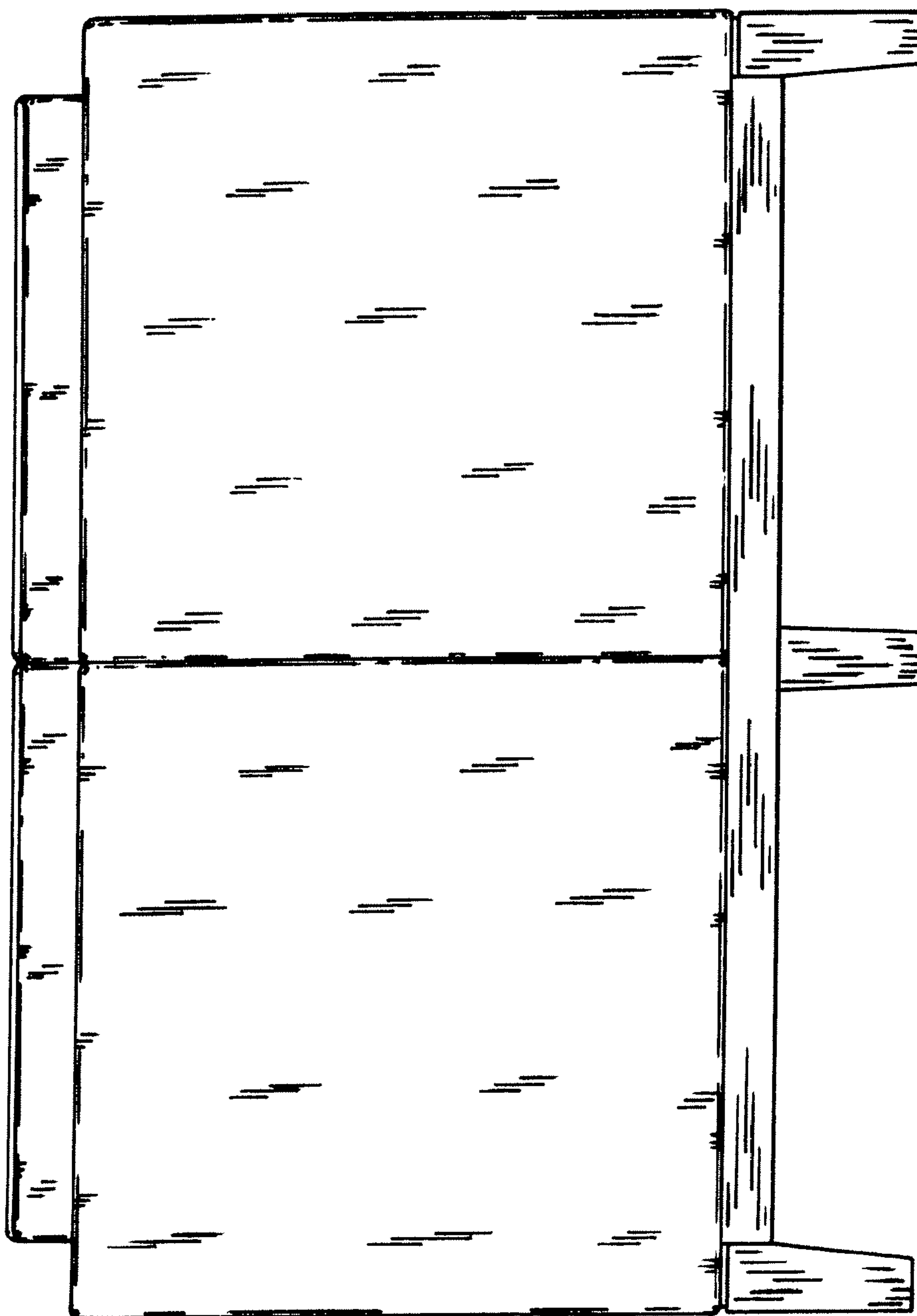

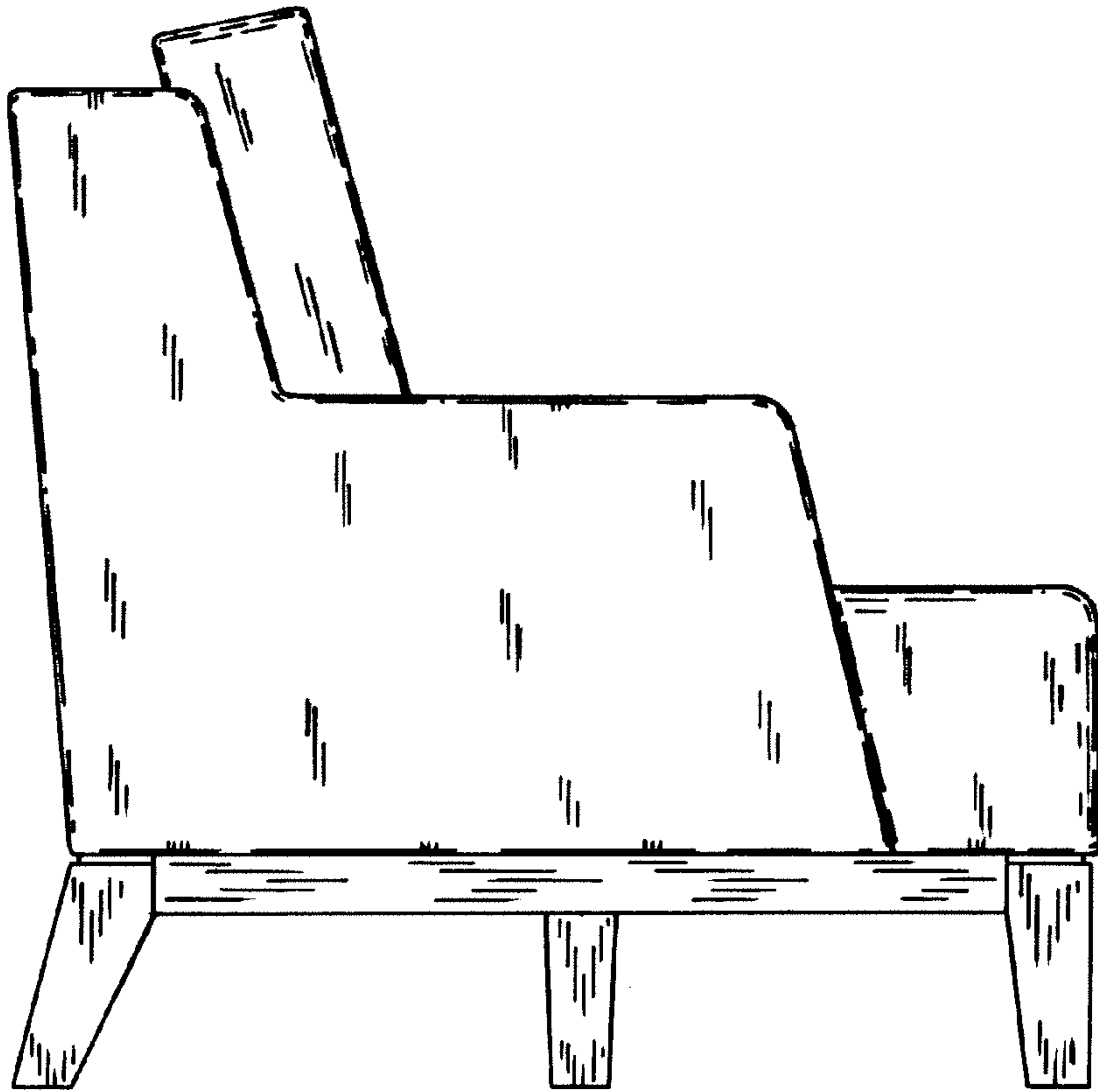

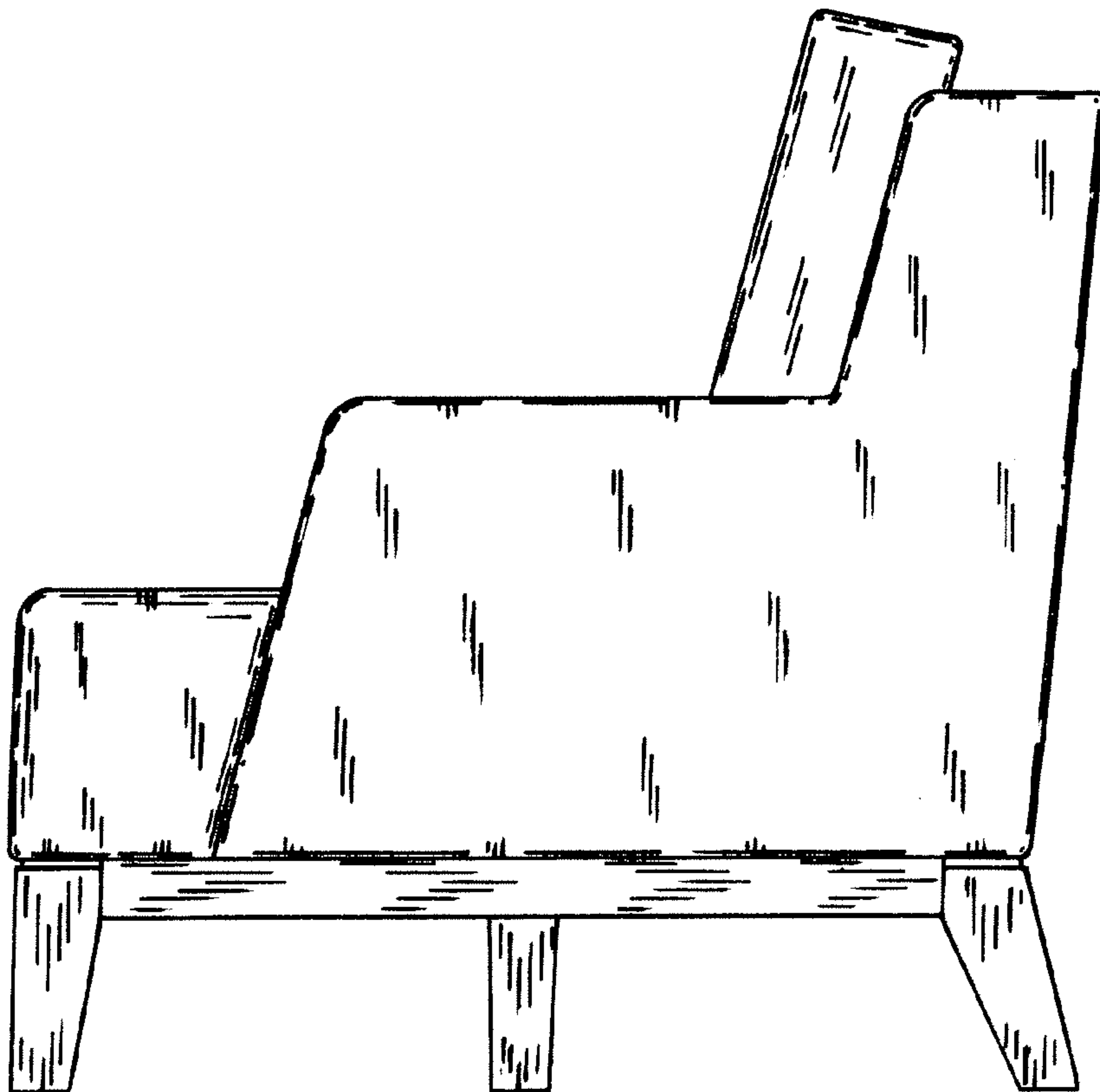

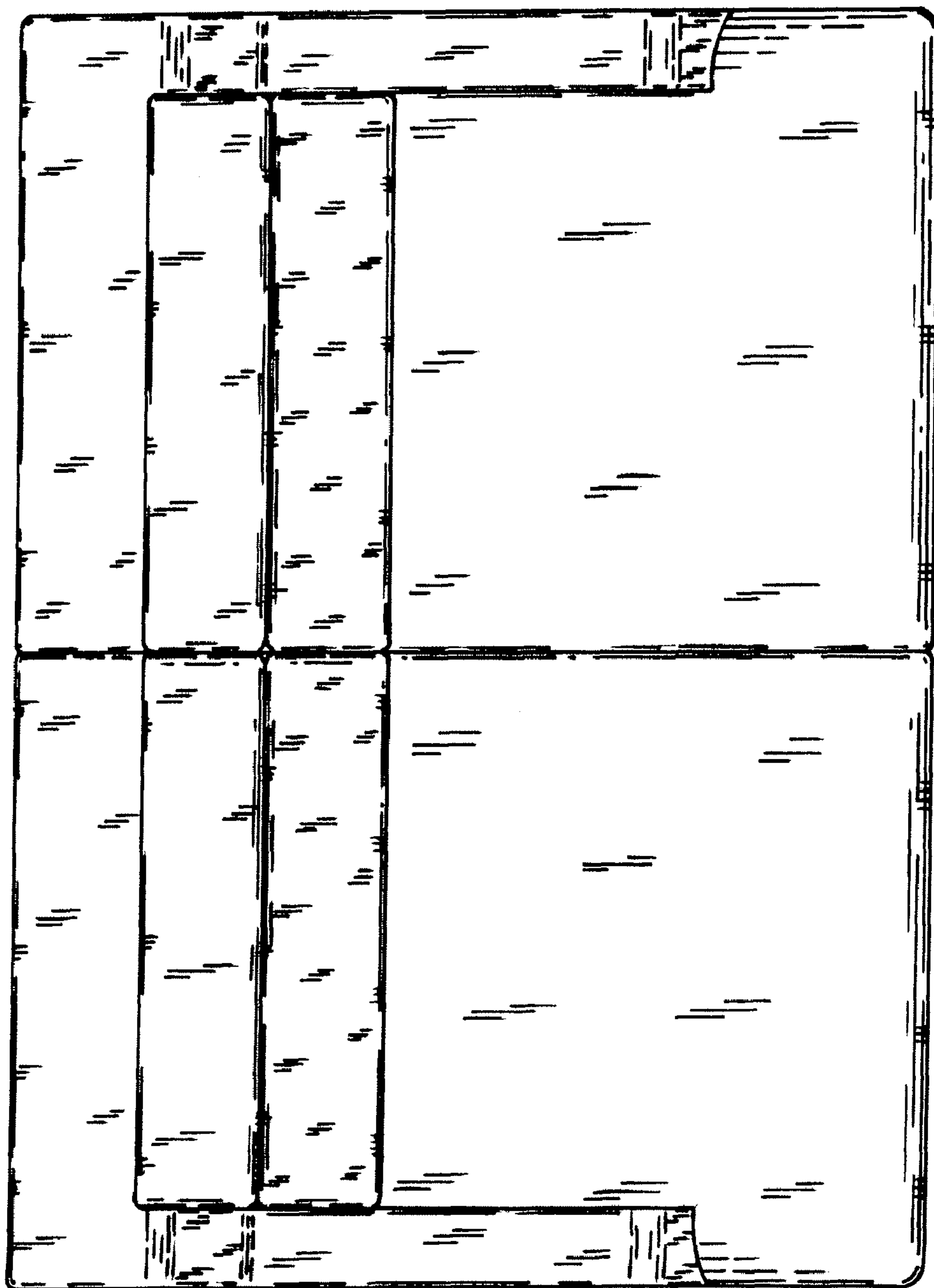

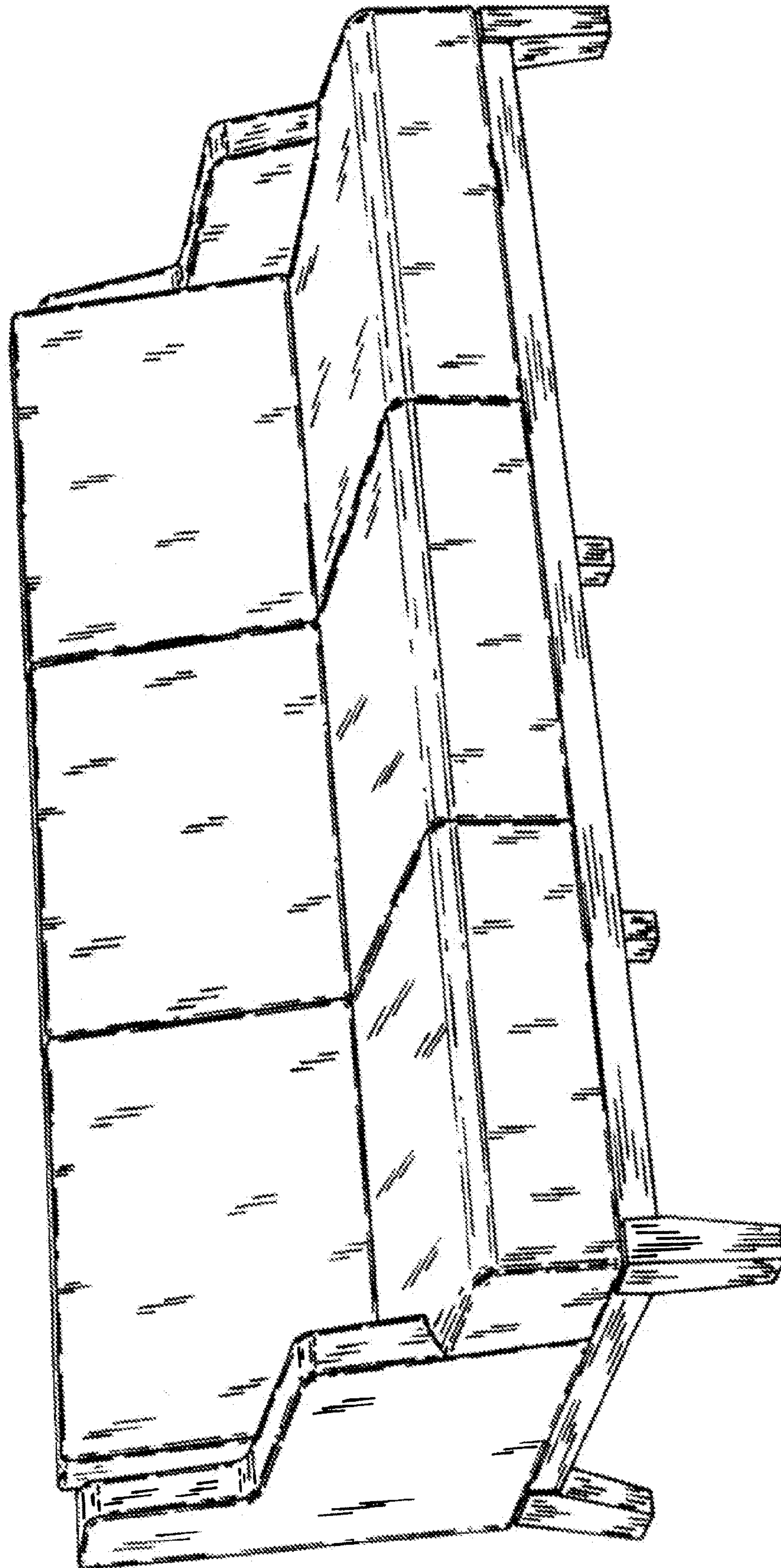

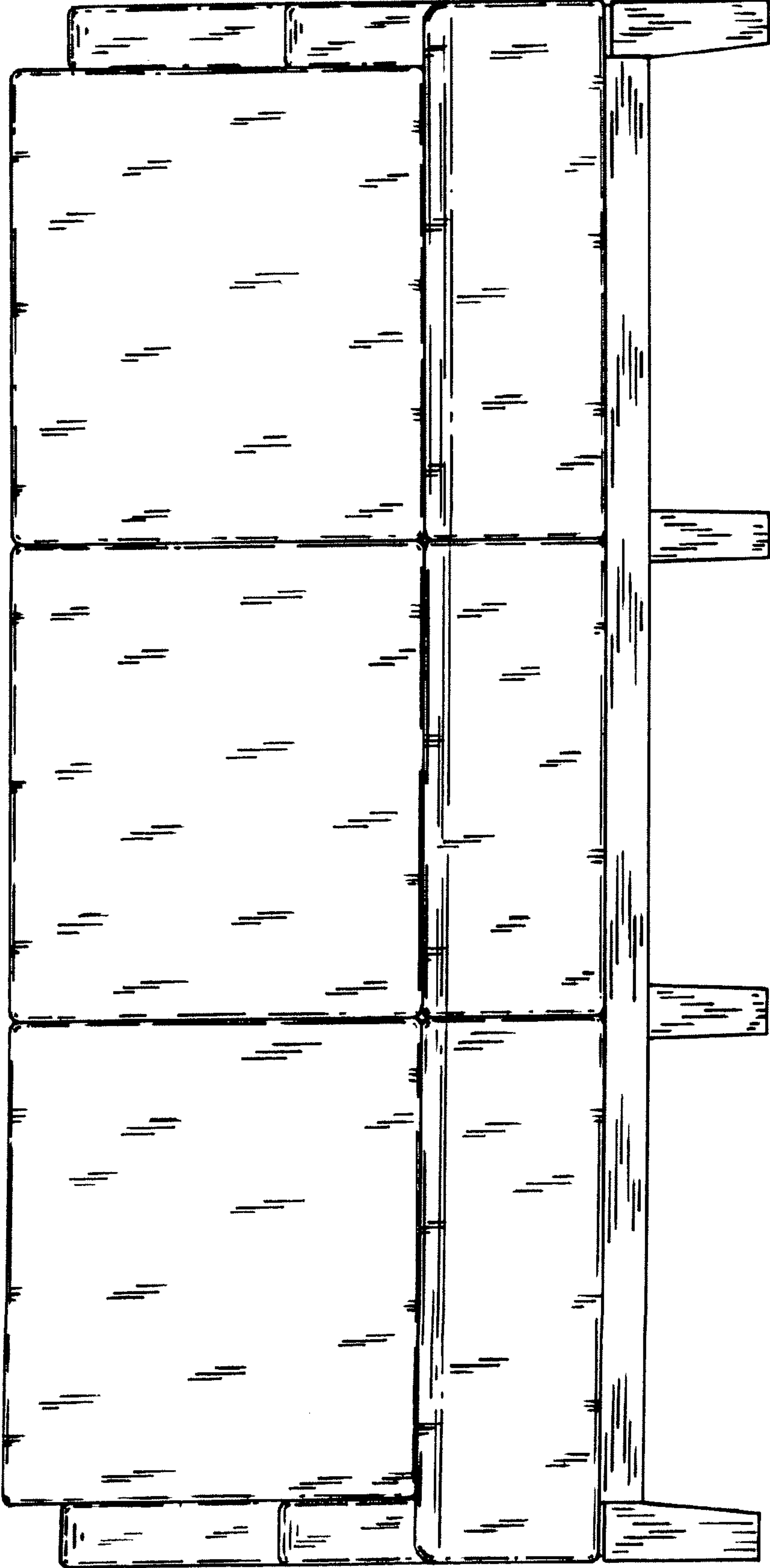

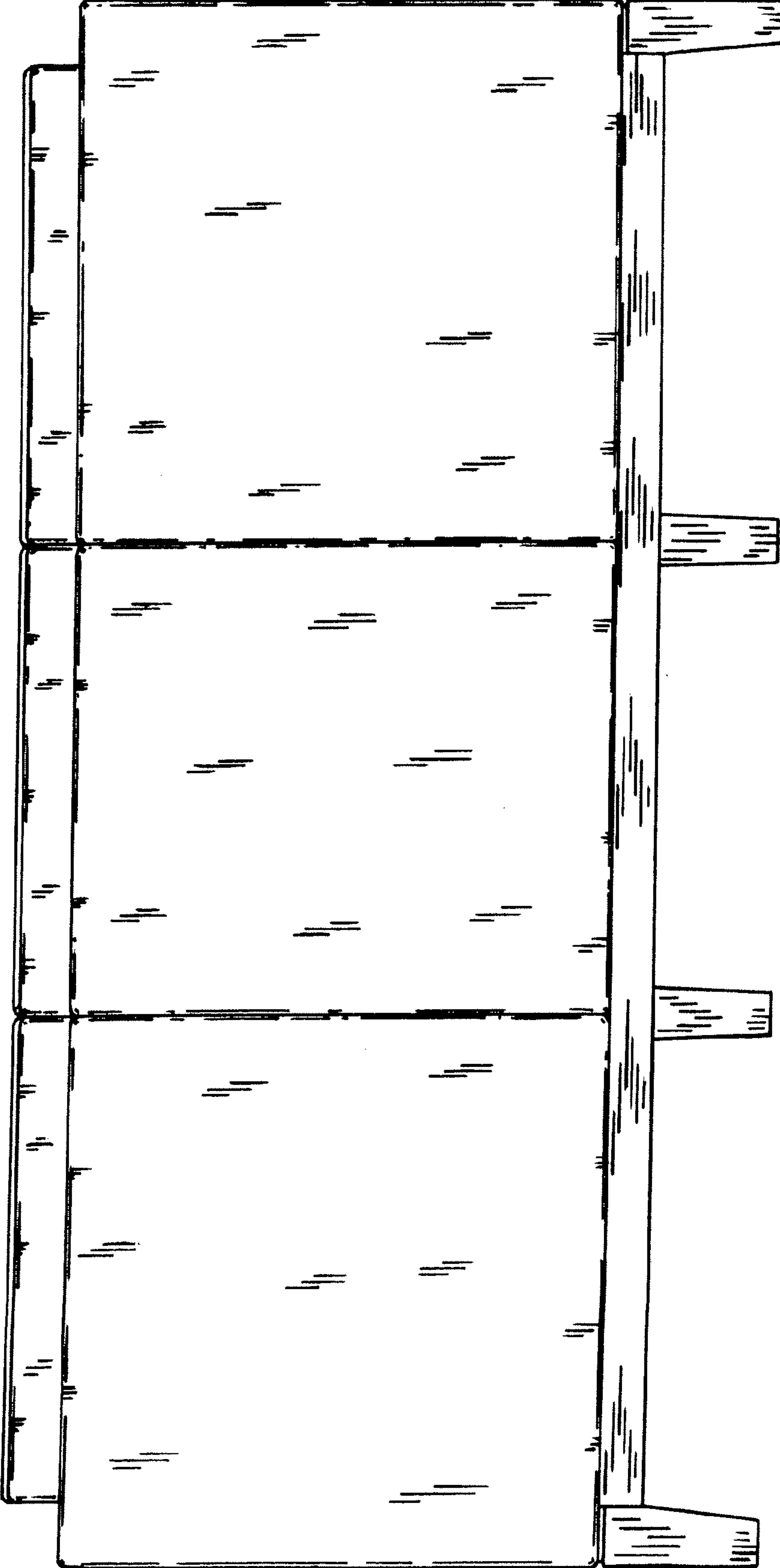

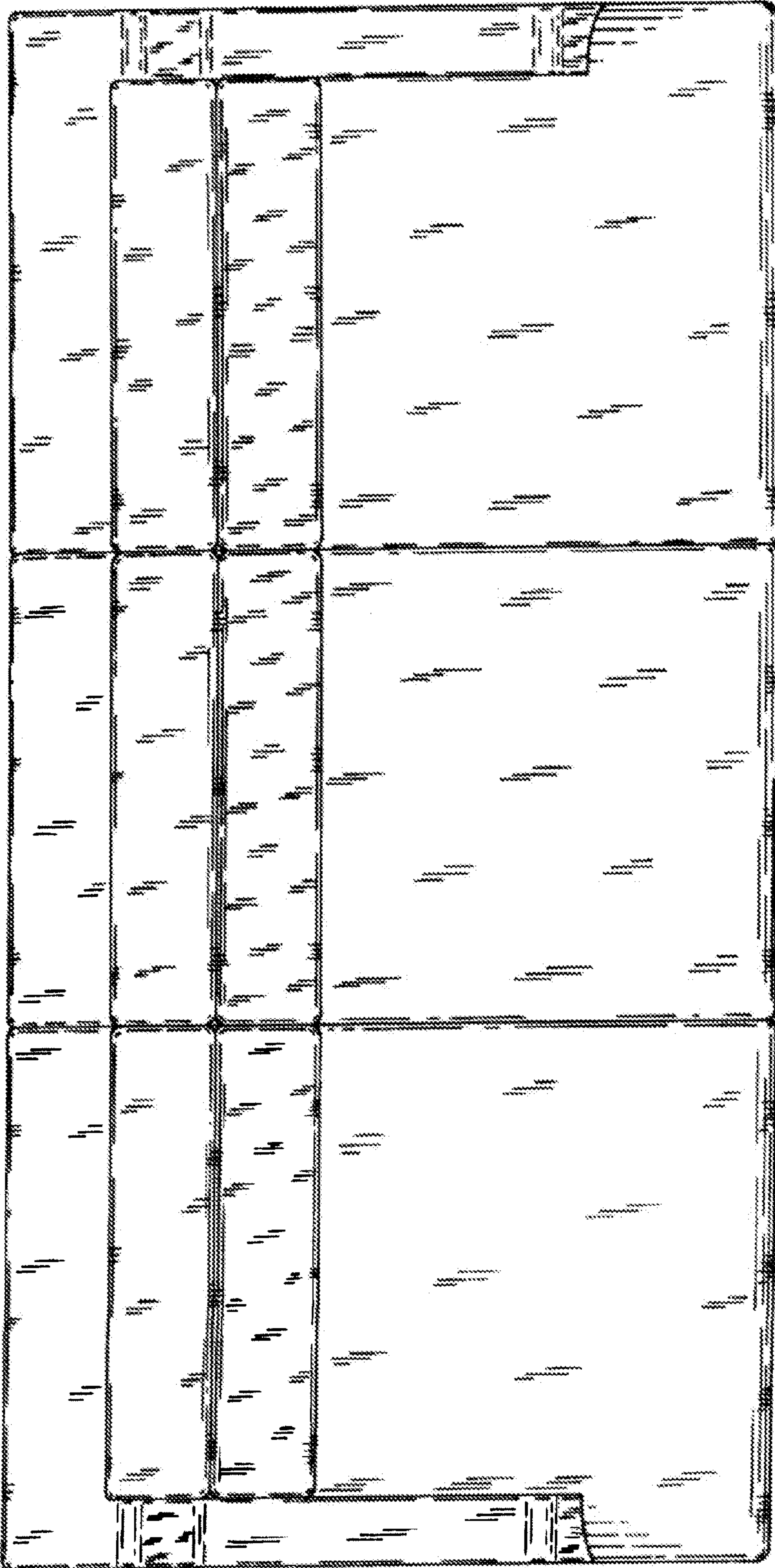

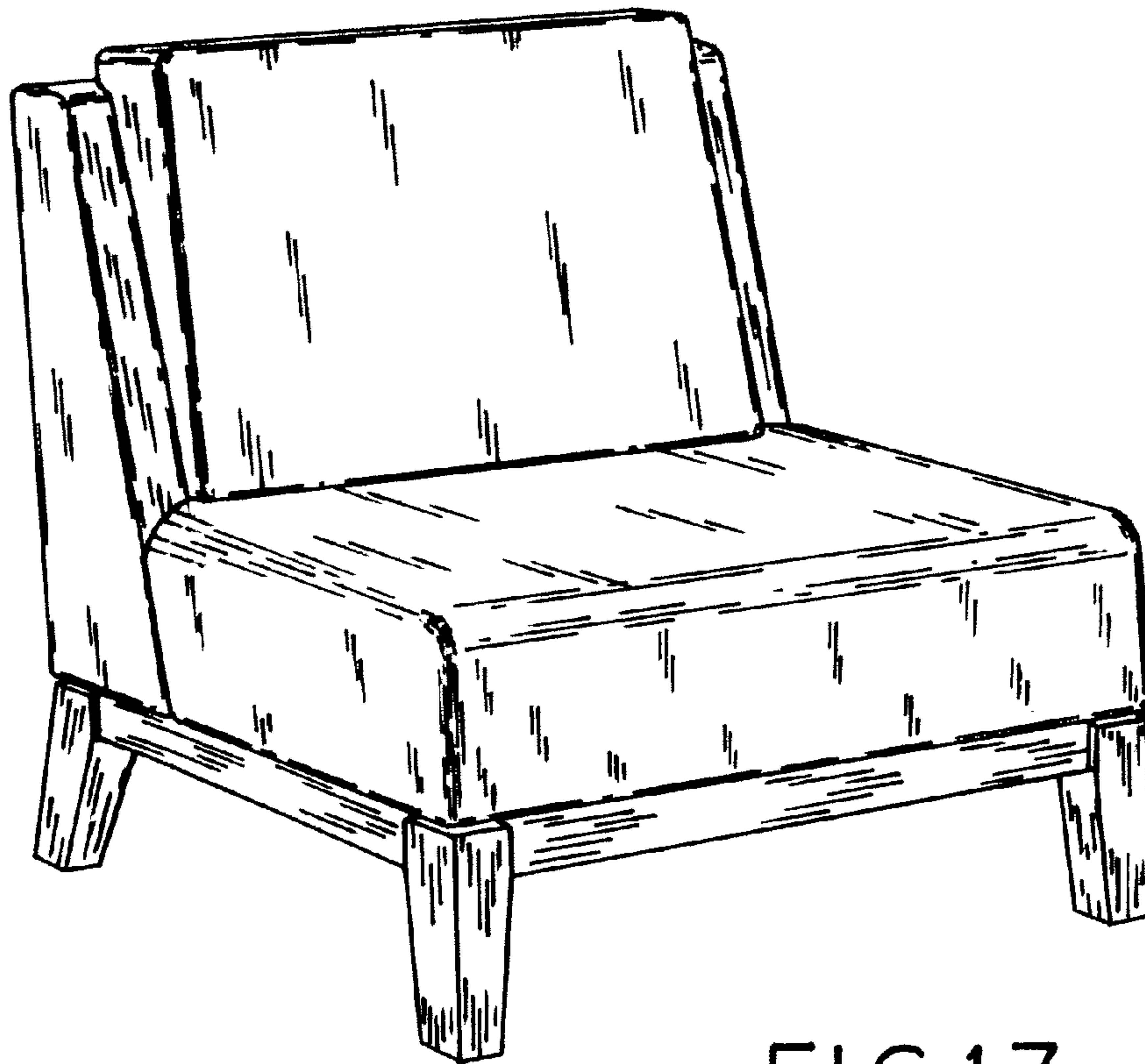

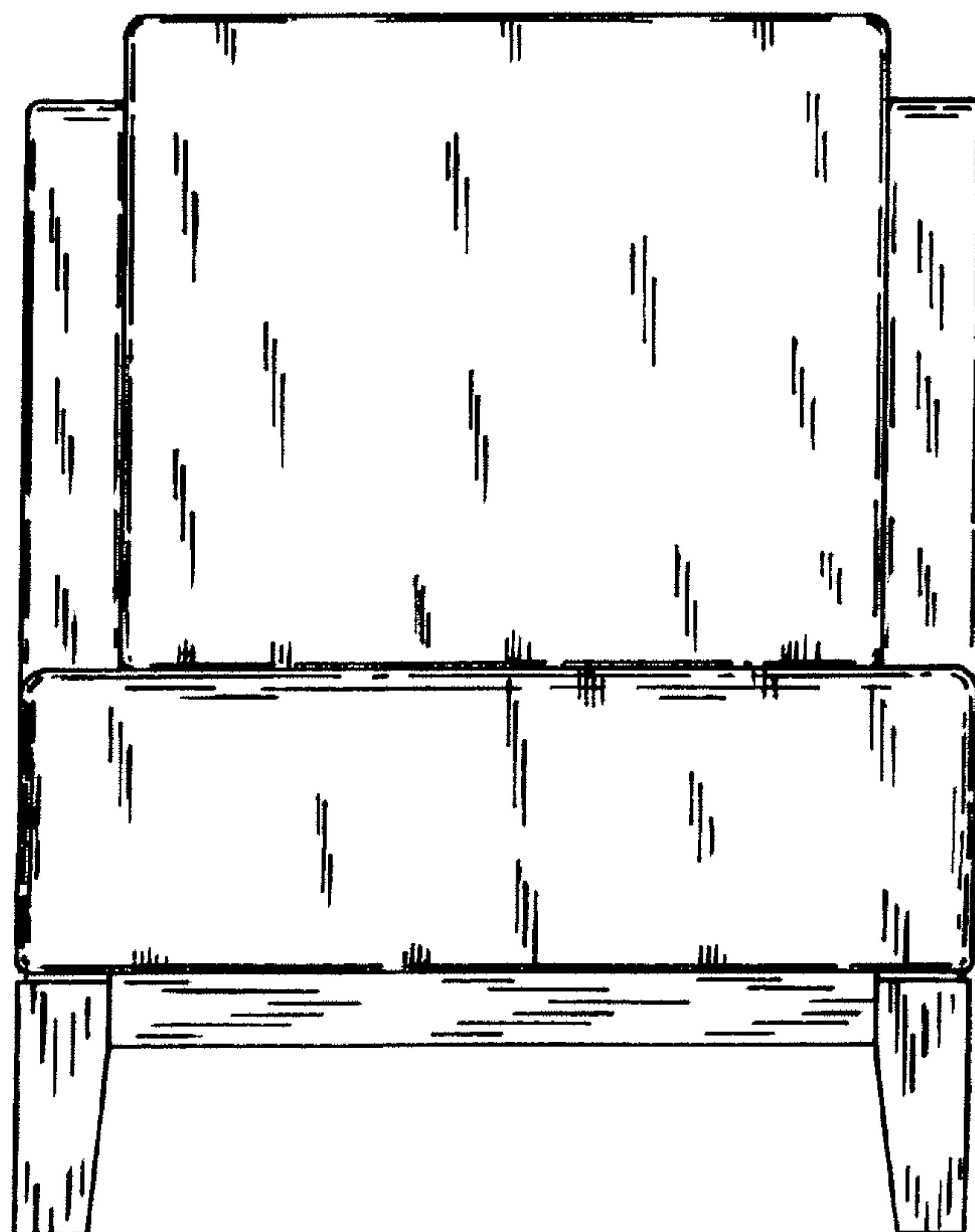

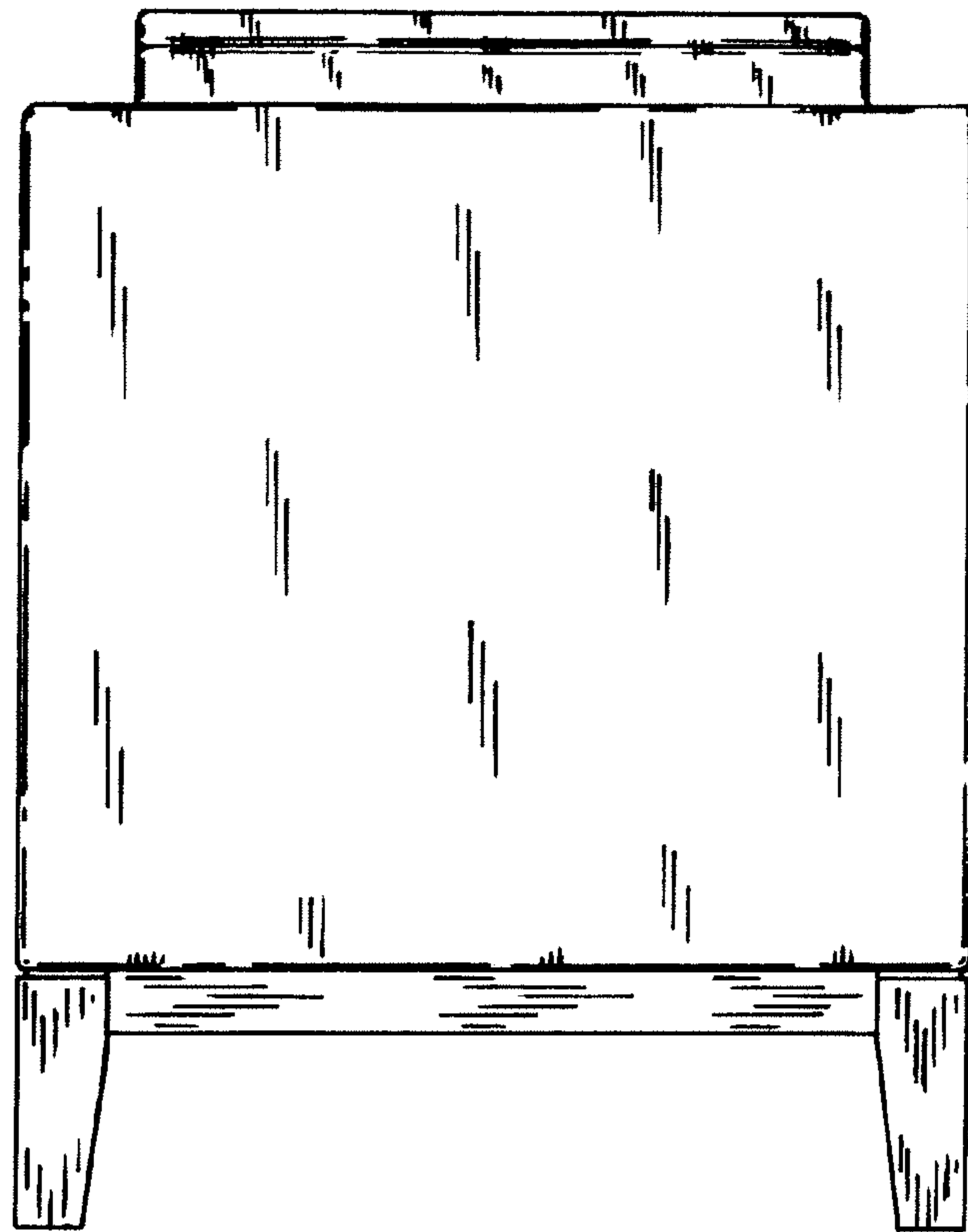

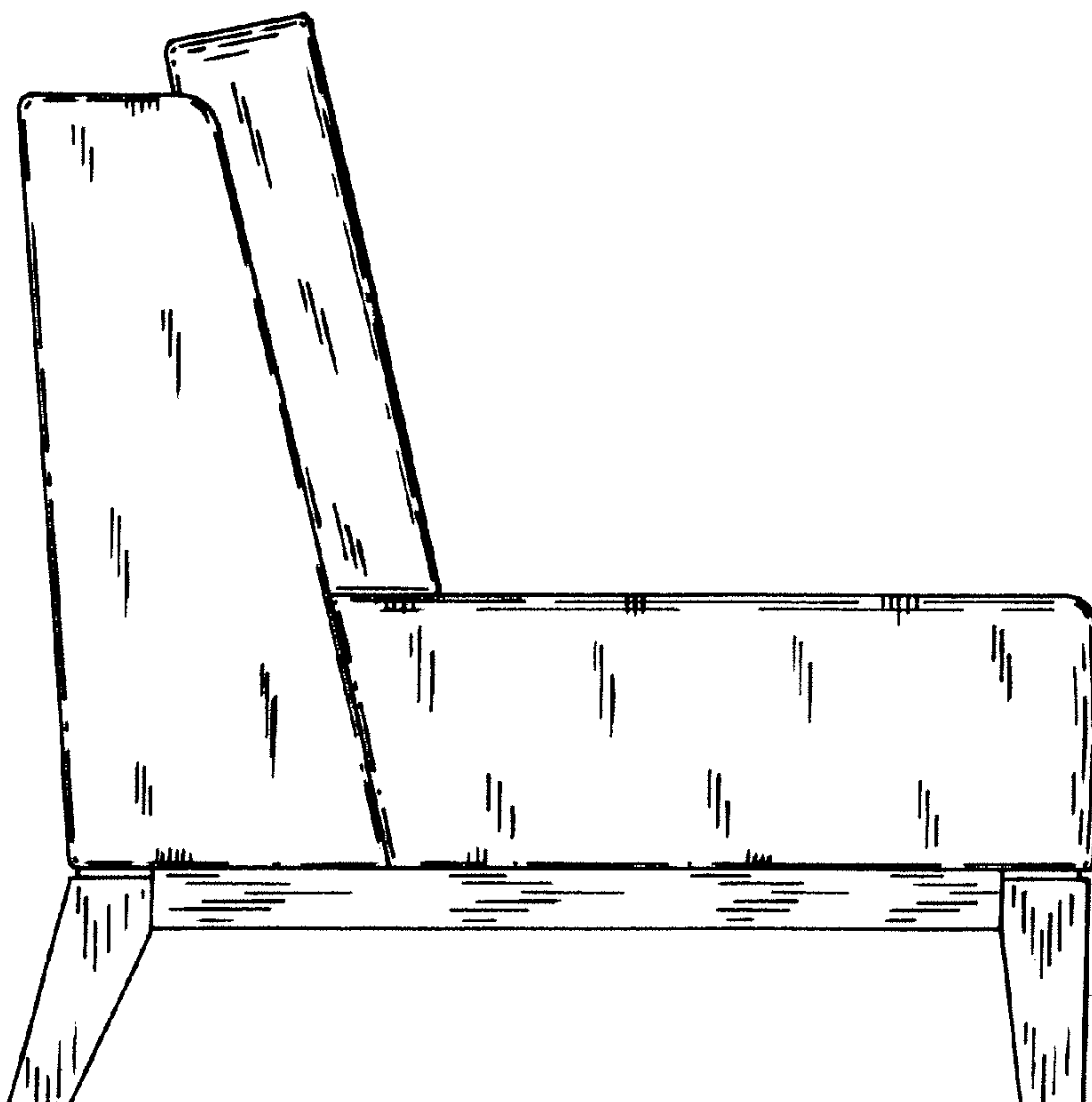

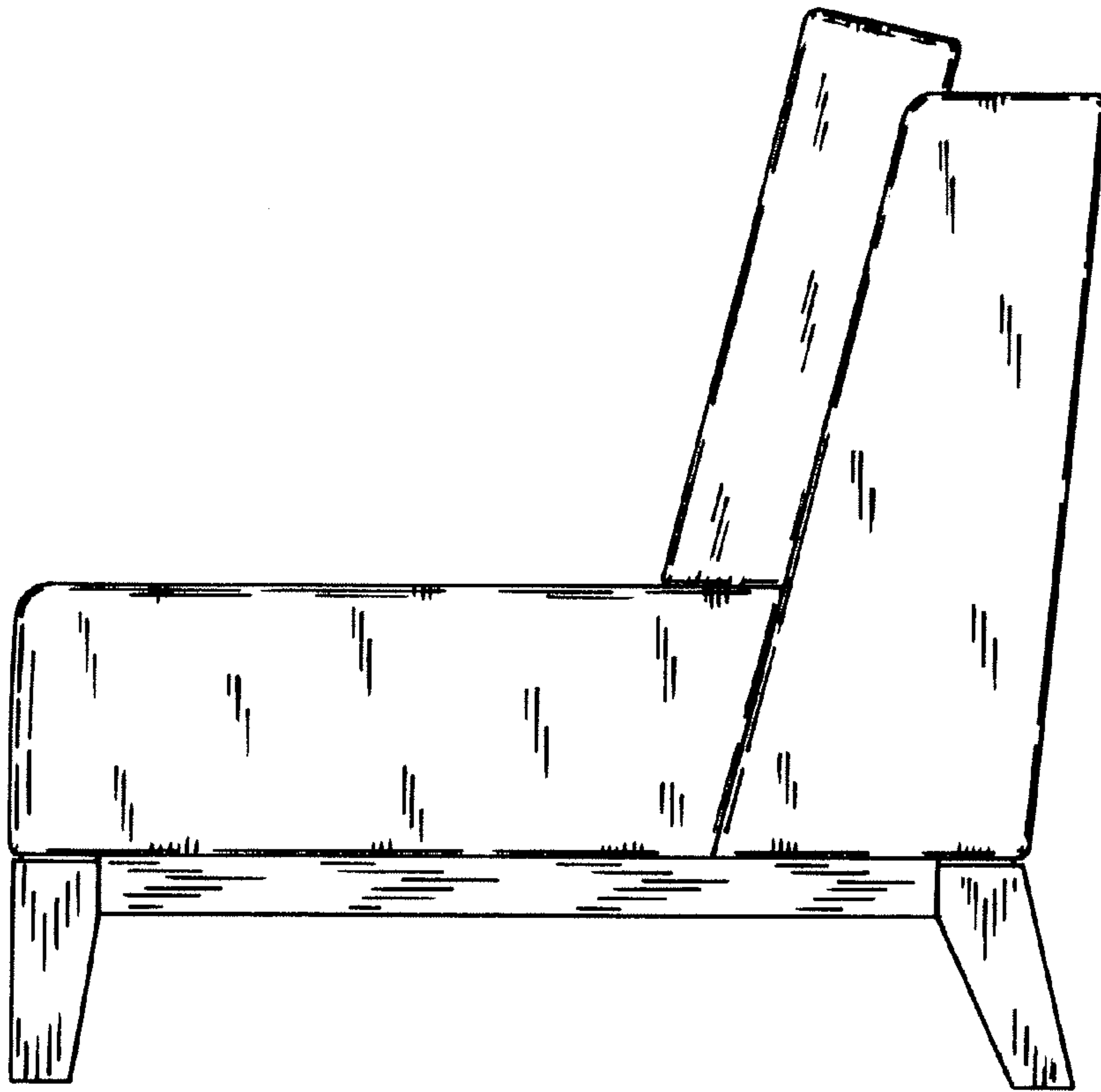

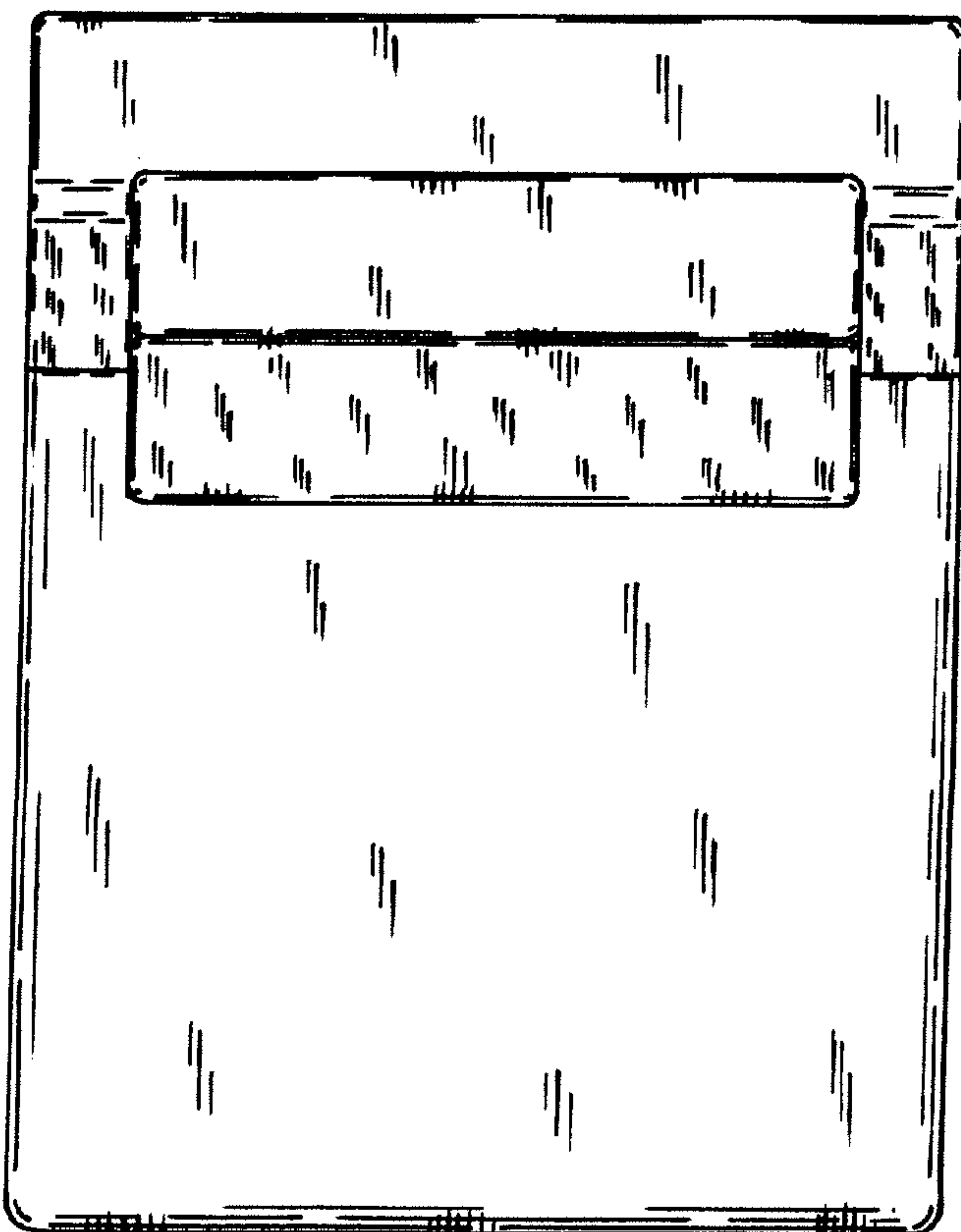

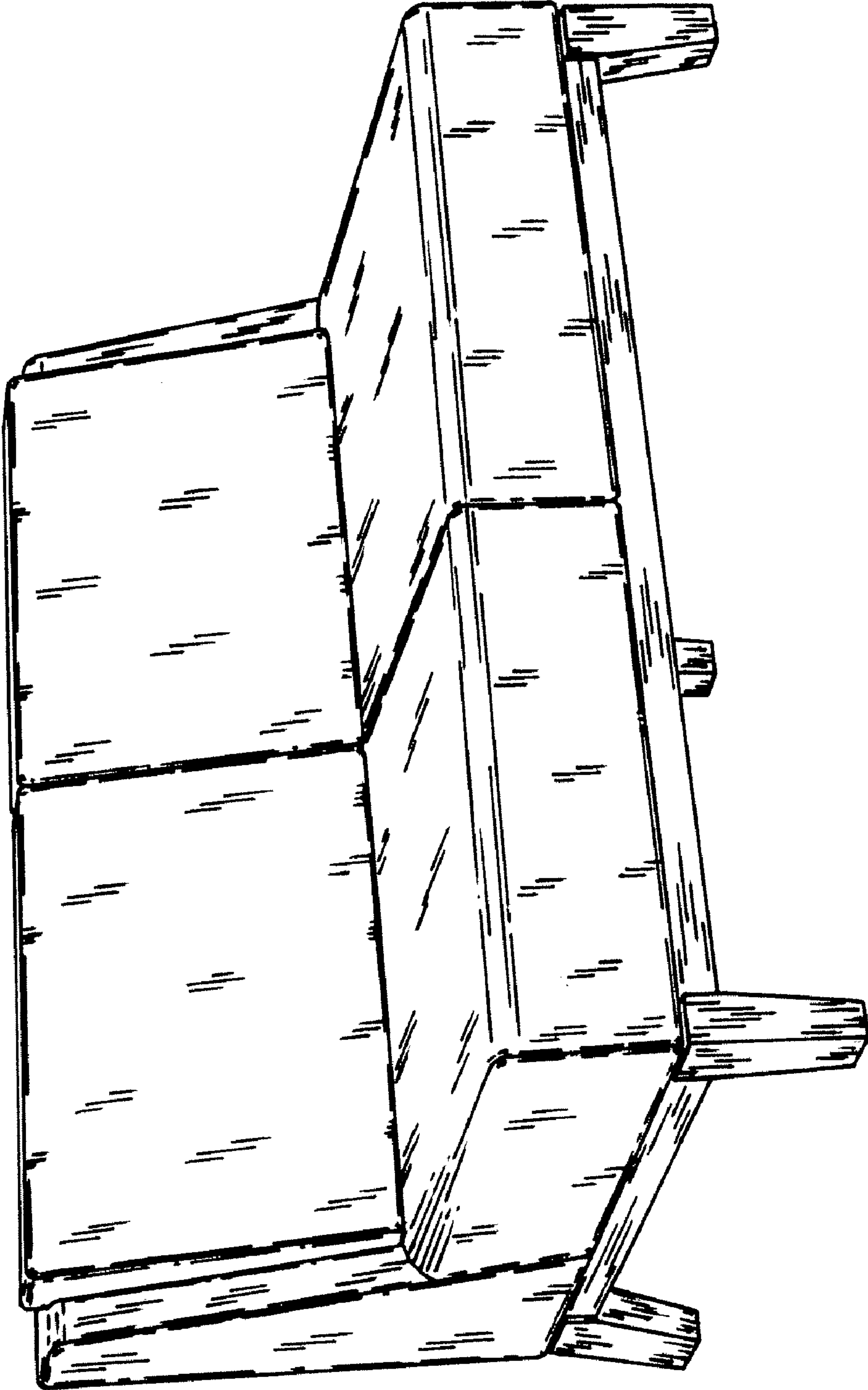

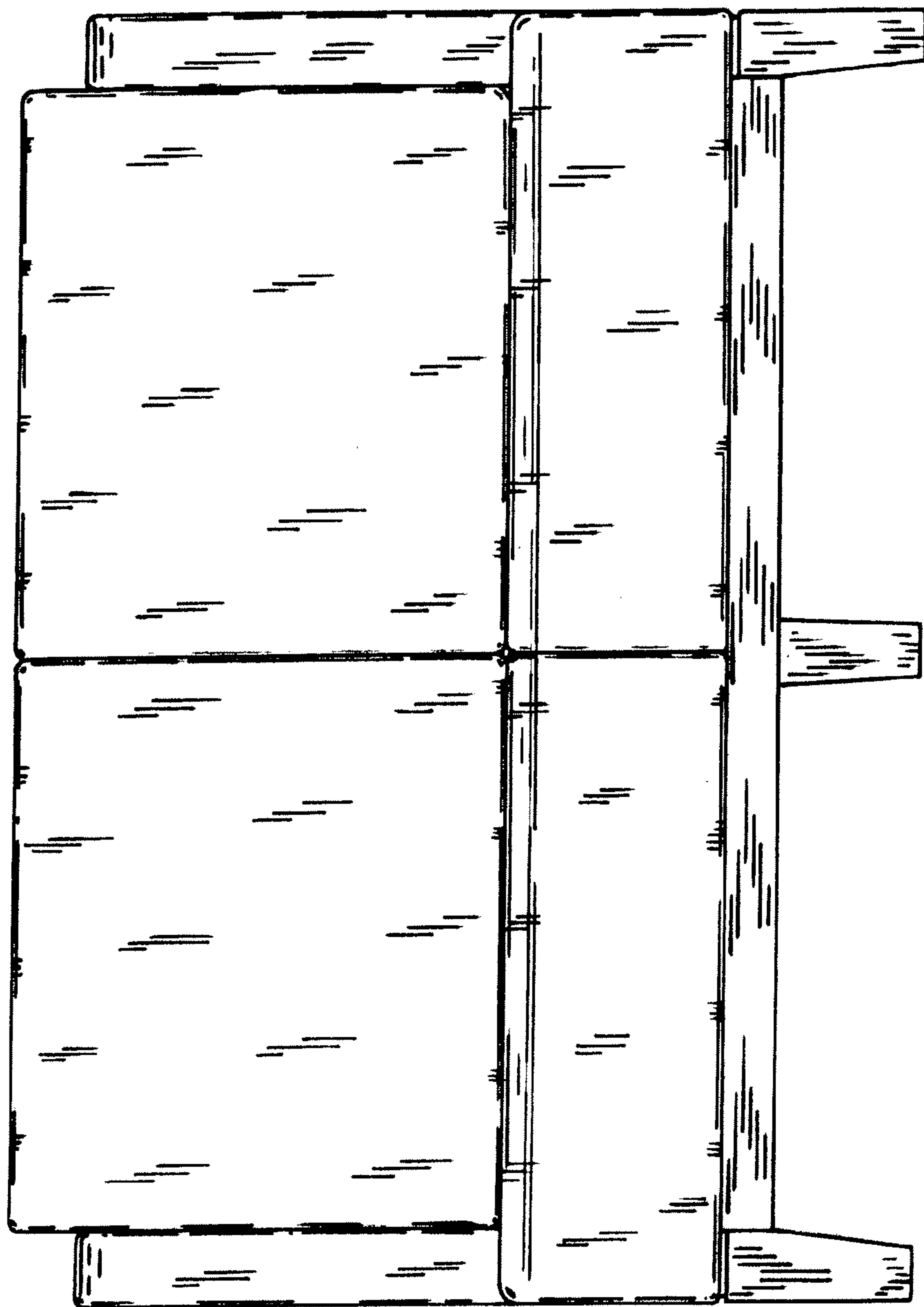

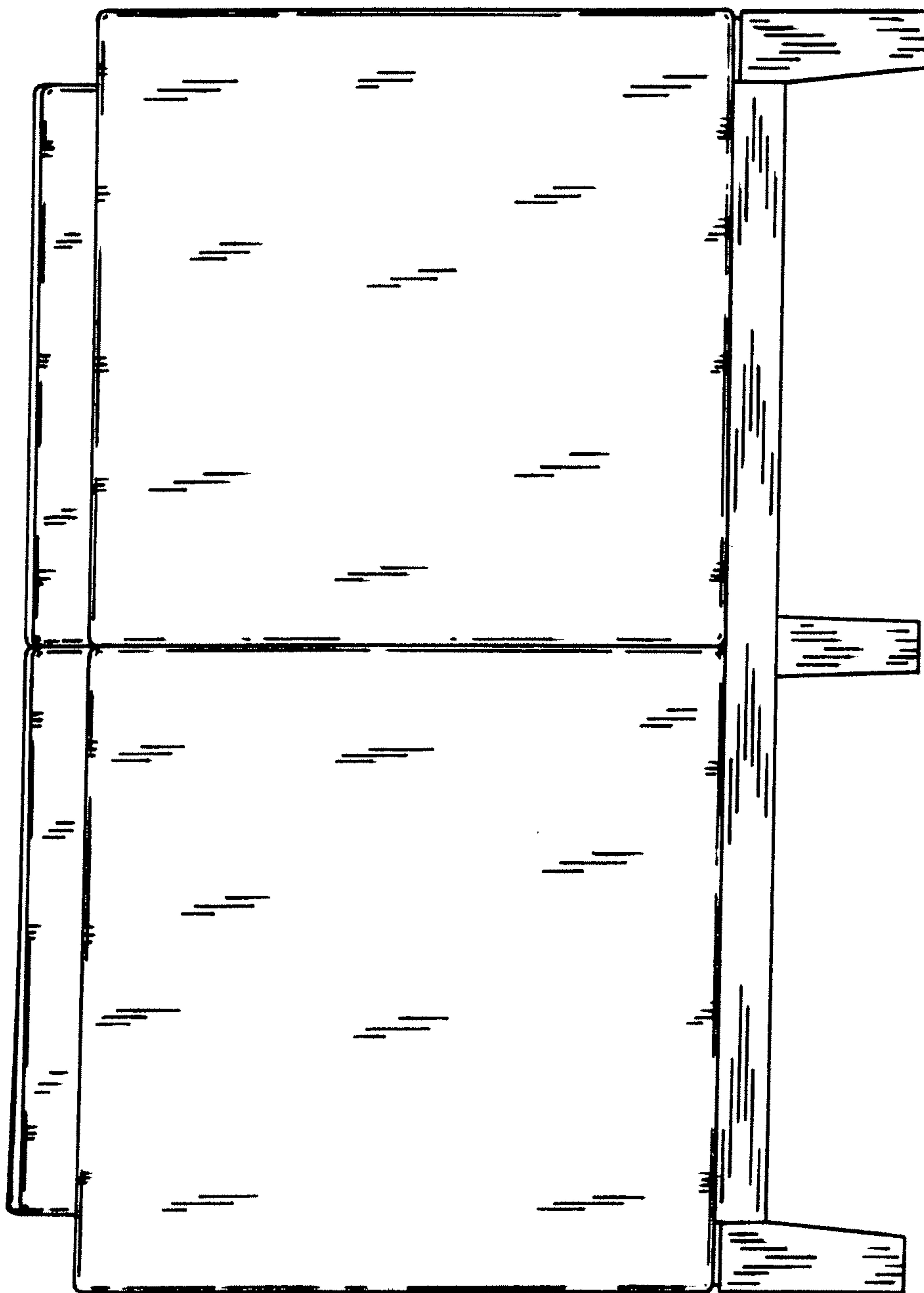

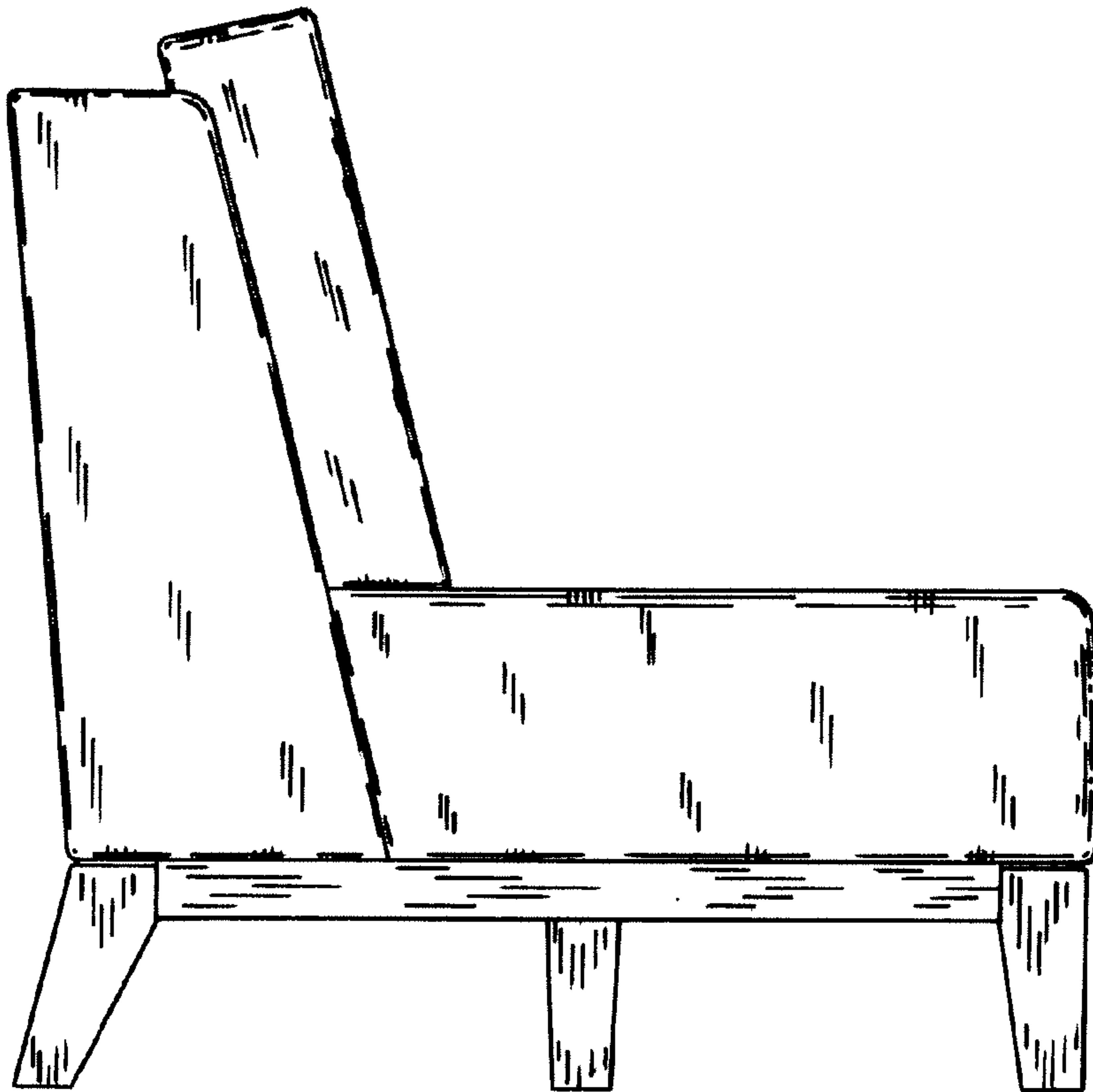

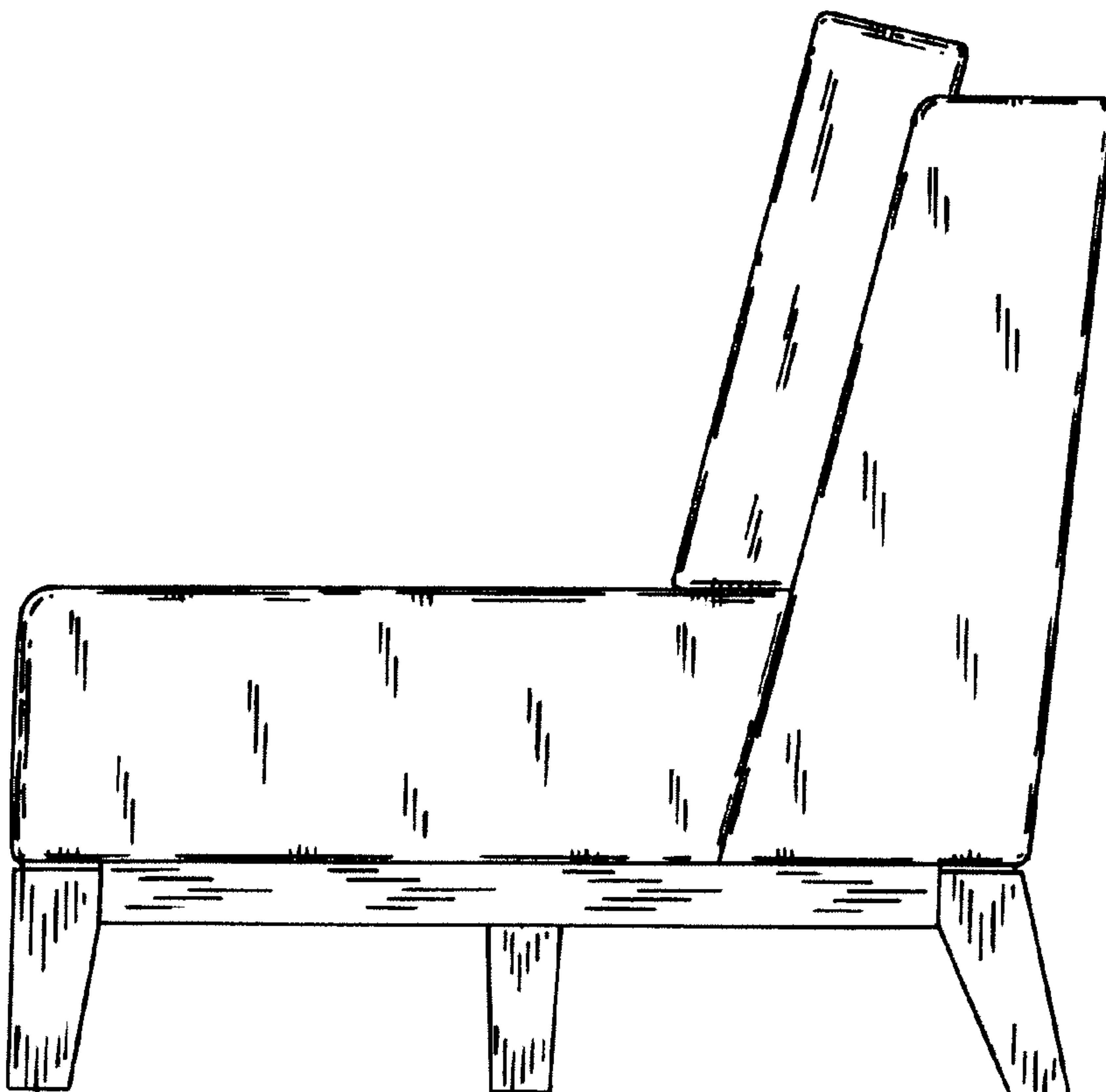

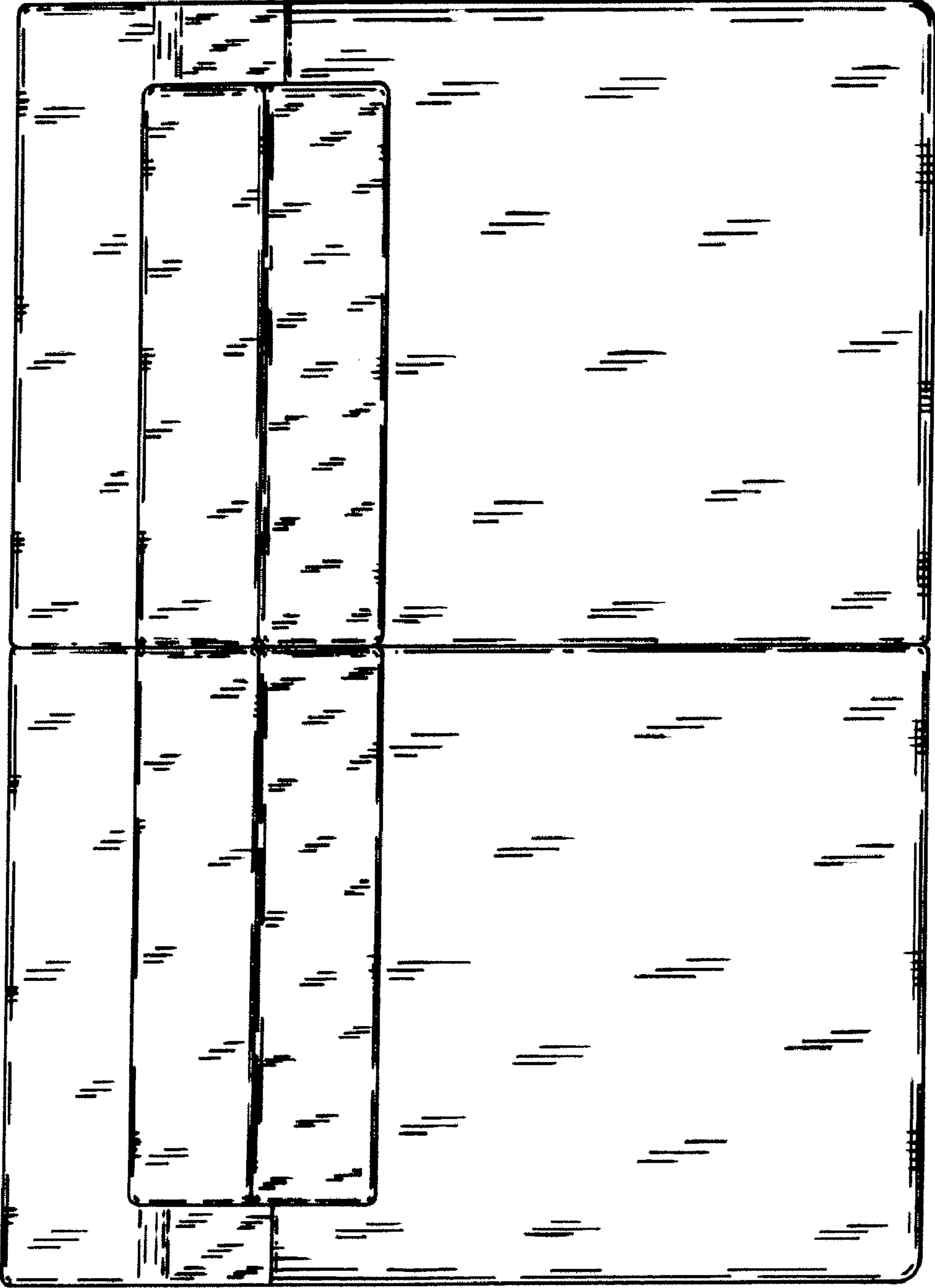

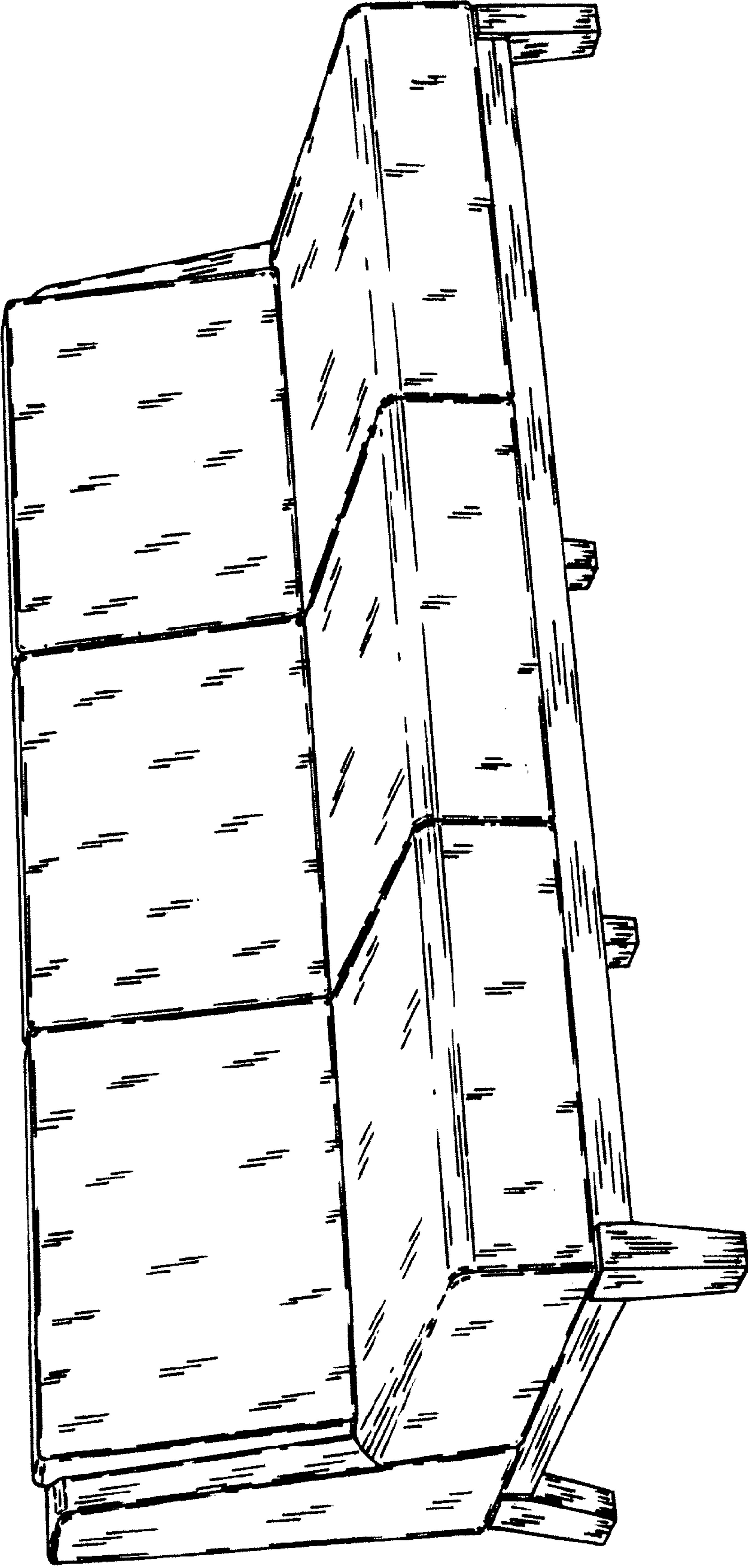

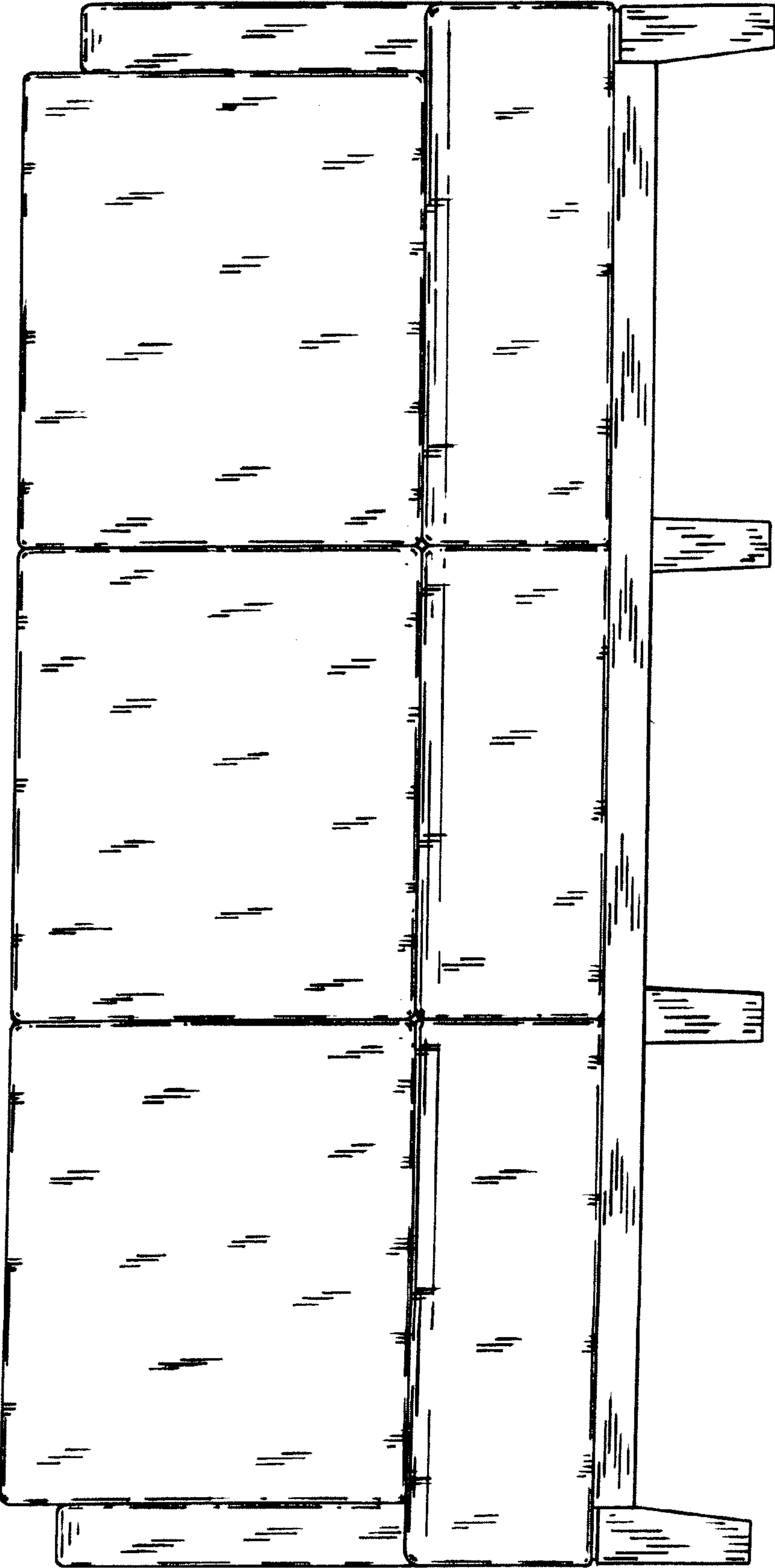

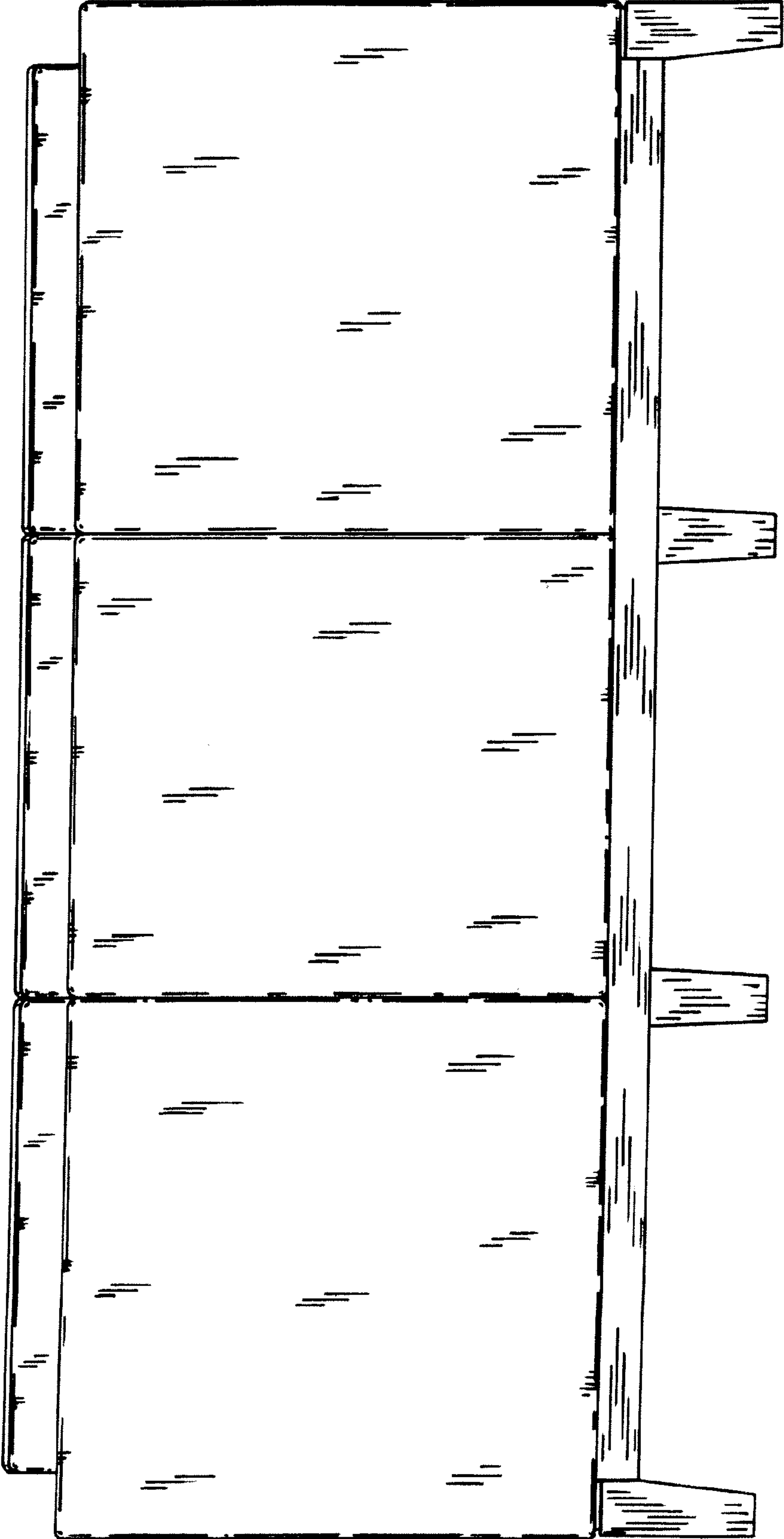

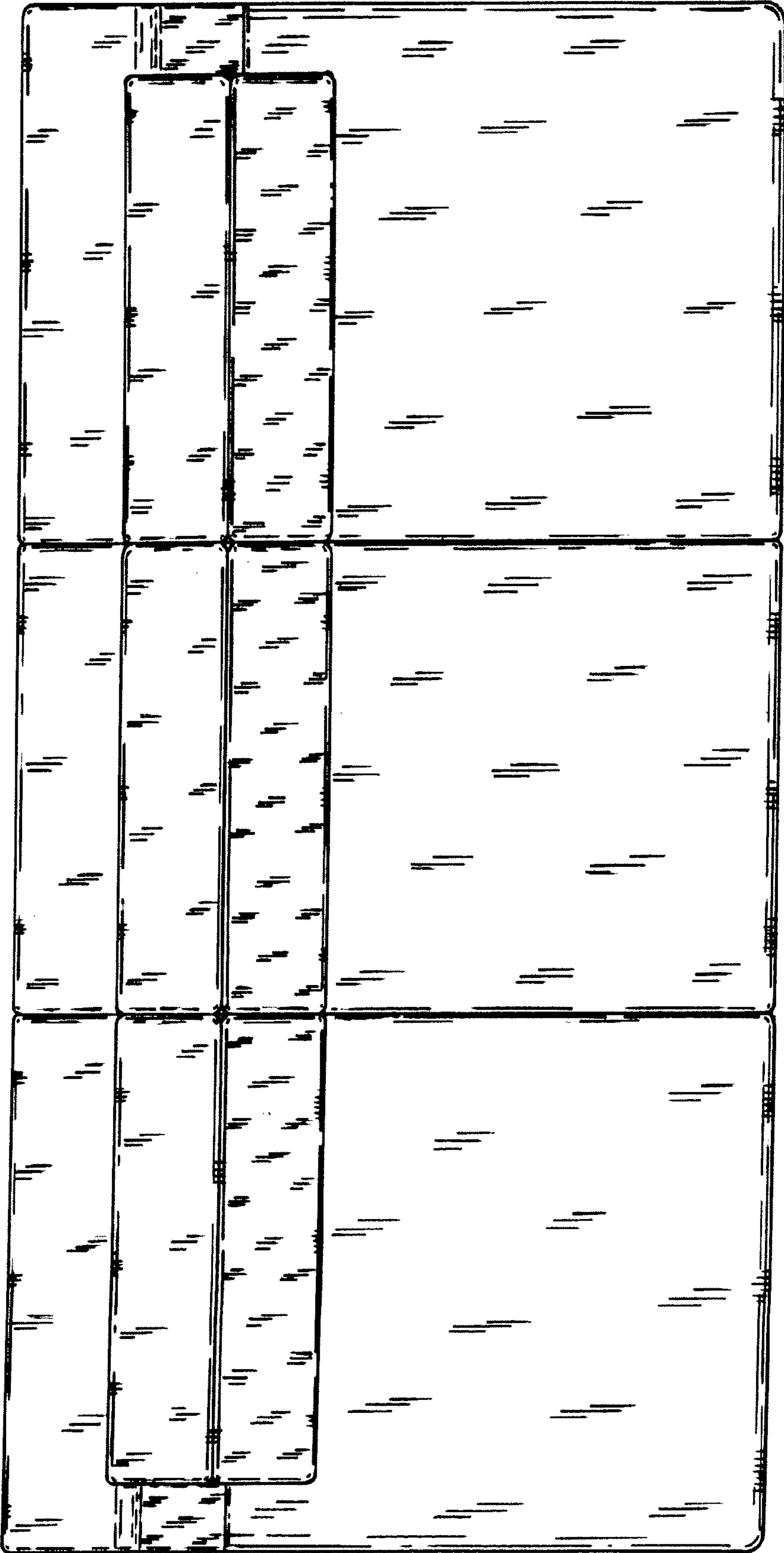
