The ornamental design for a film dispensing cassette for garbage, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a film-dispensing cassette in accordance with an embodiment of the present design;

FIG. 2 is a bottom perspective view of the film-dispensing cassette of FIG. 1;

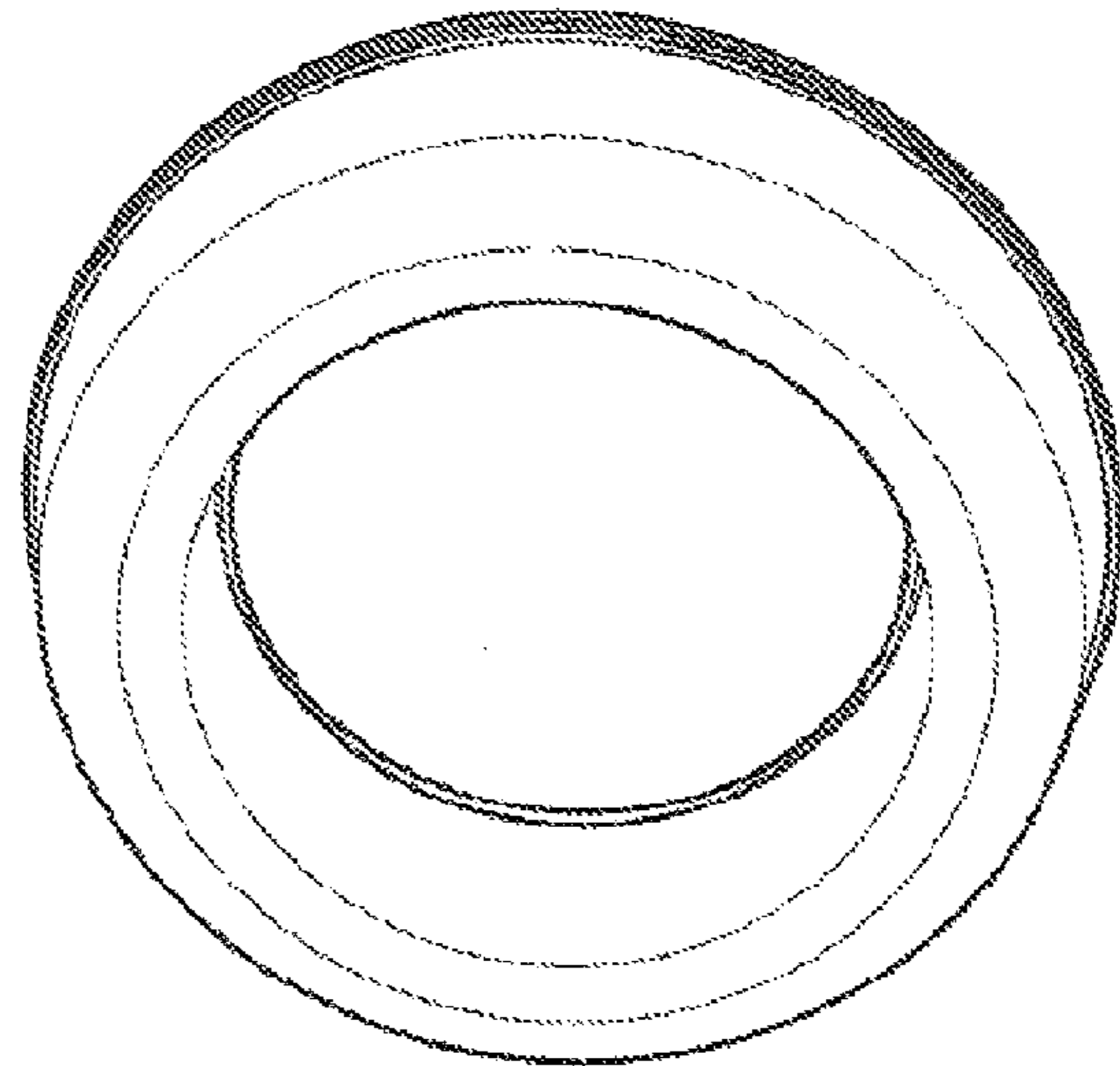
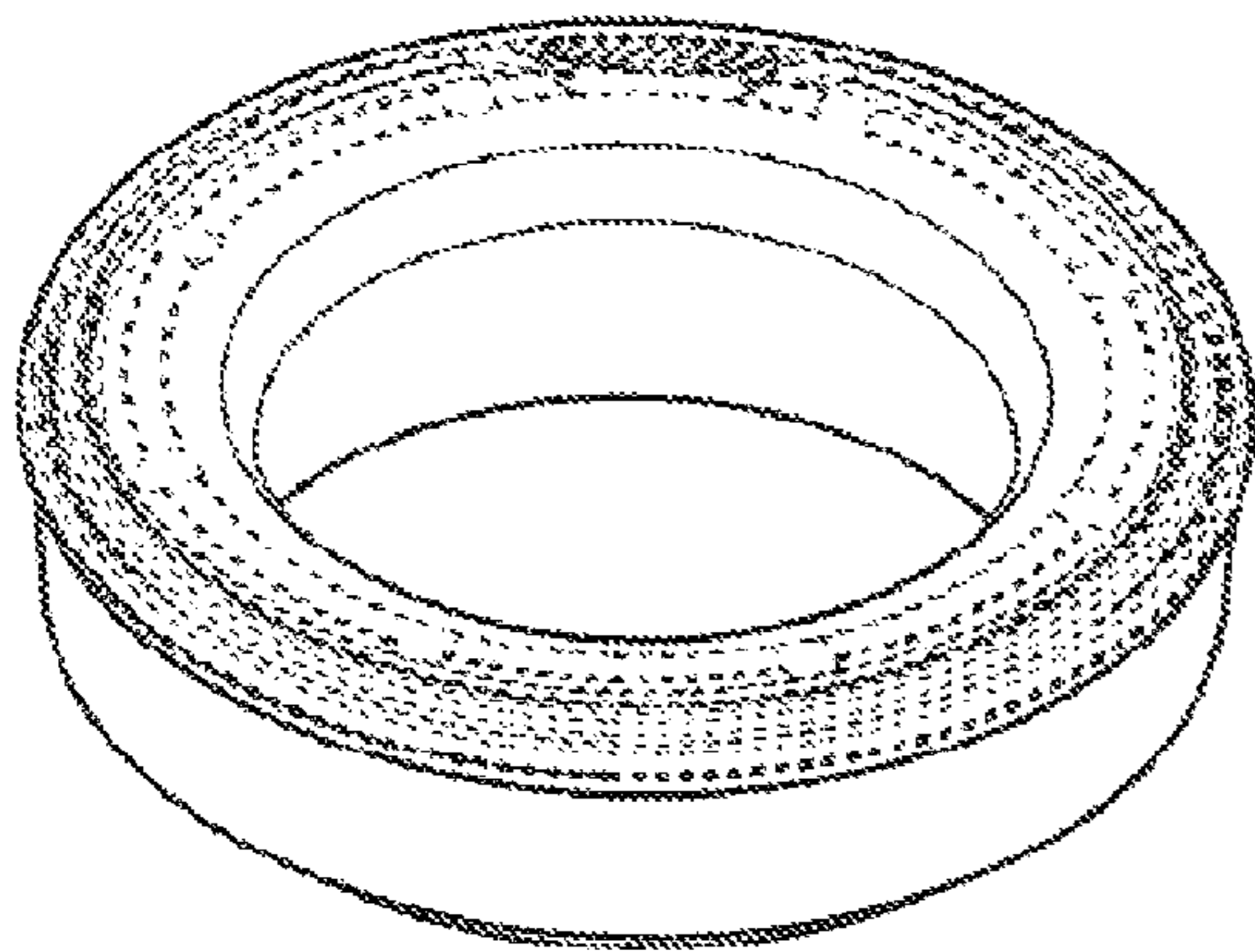
FIG. 3 is a top plan view of the film-dispensing cassette of FIG. 1;

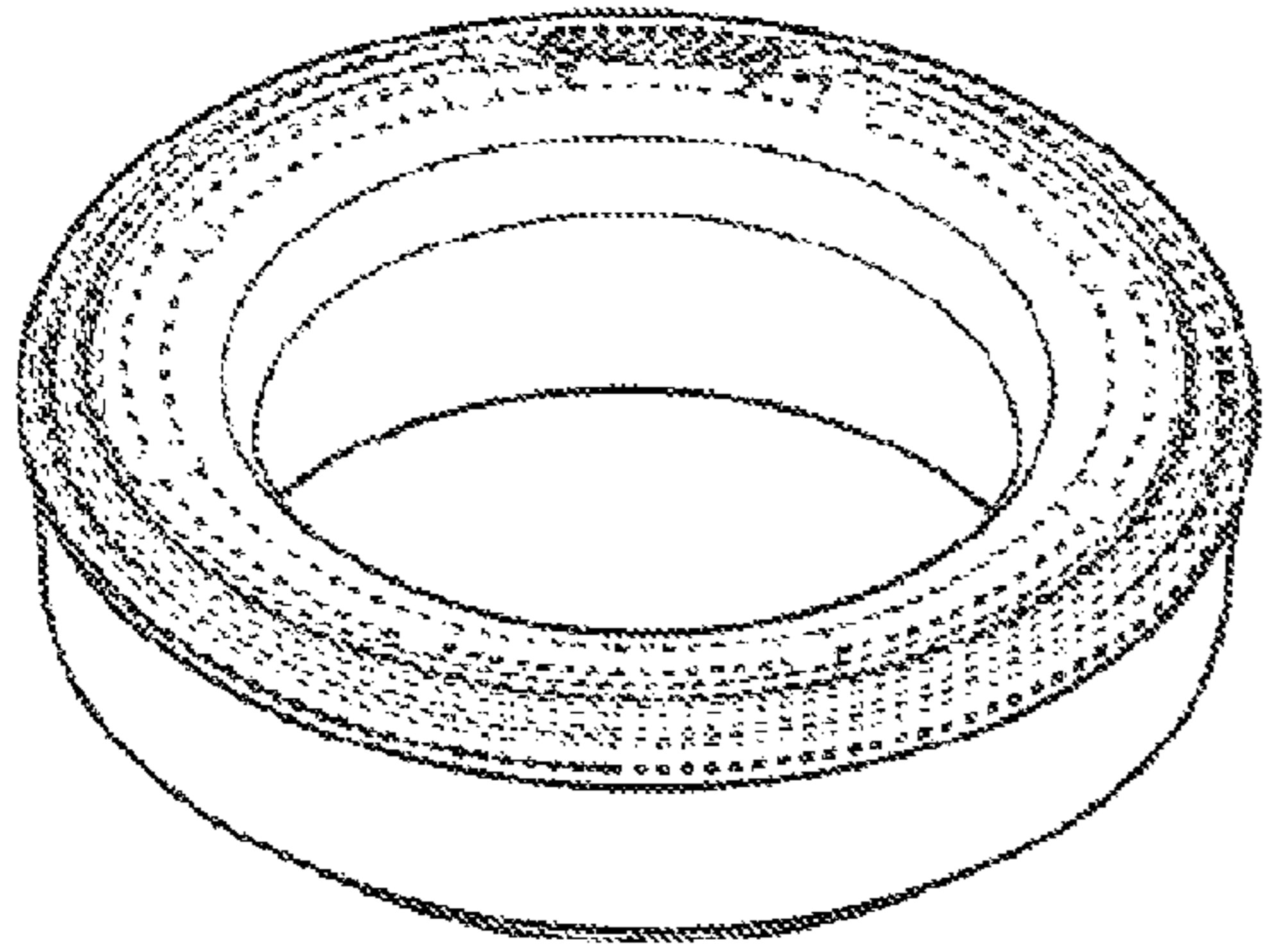

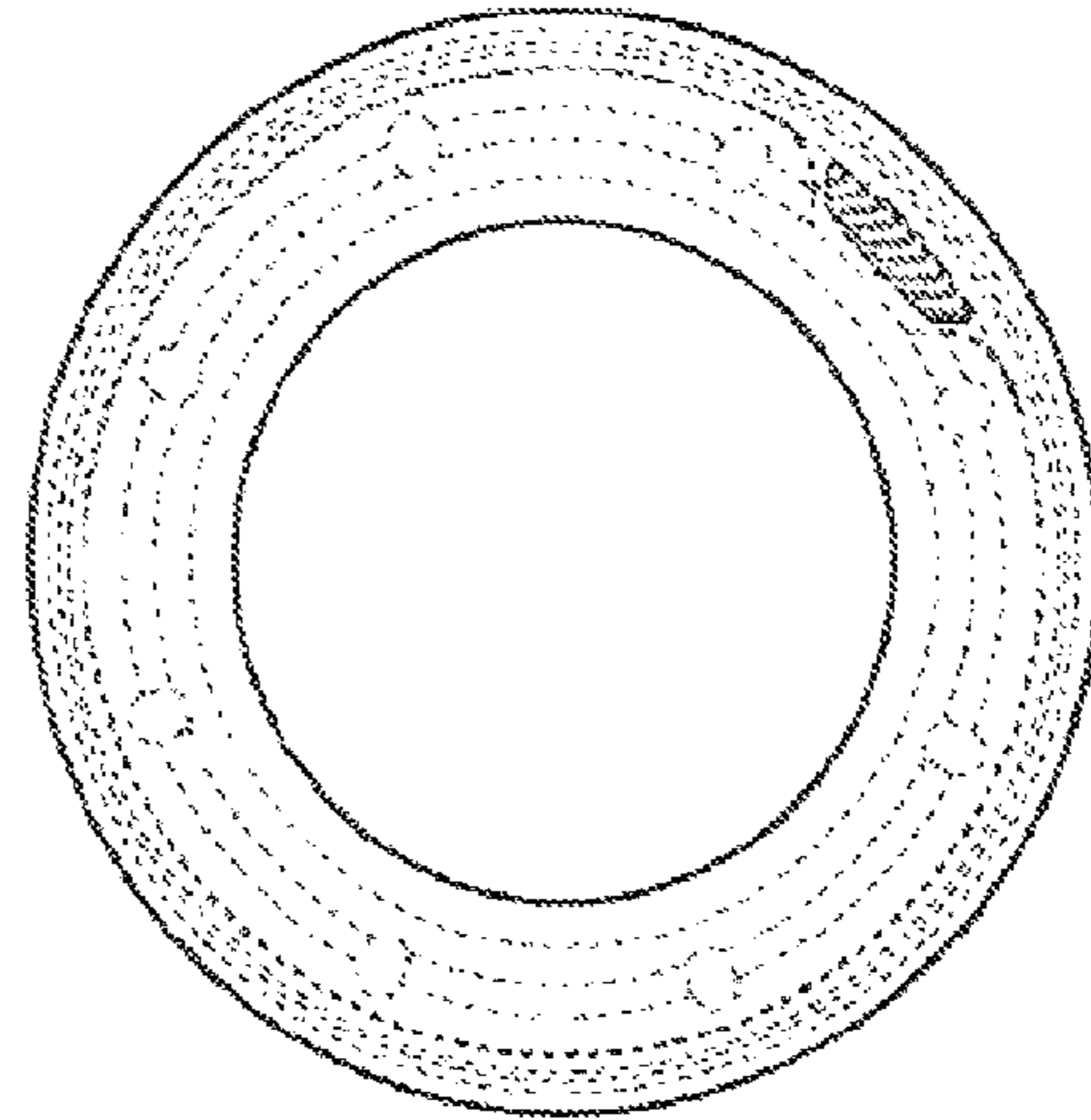

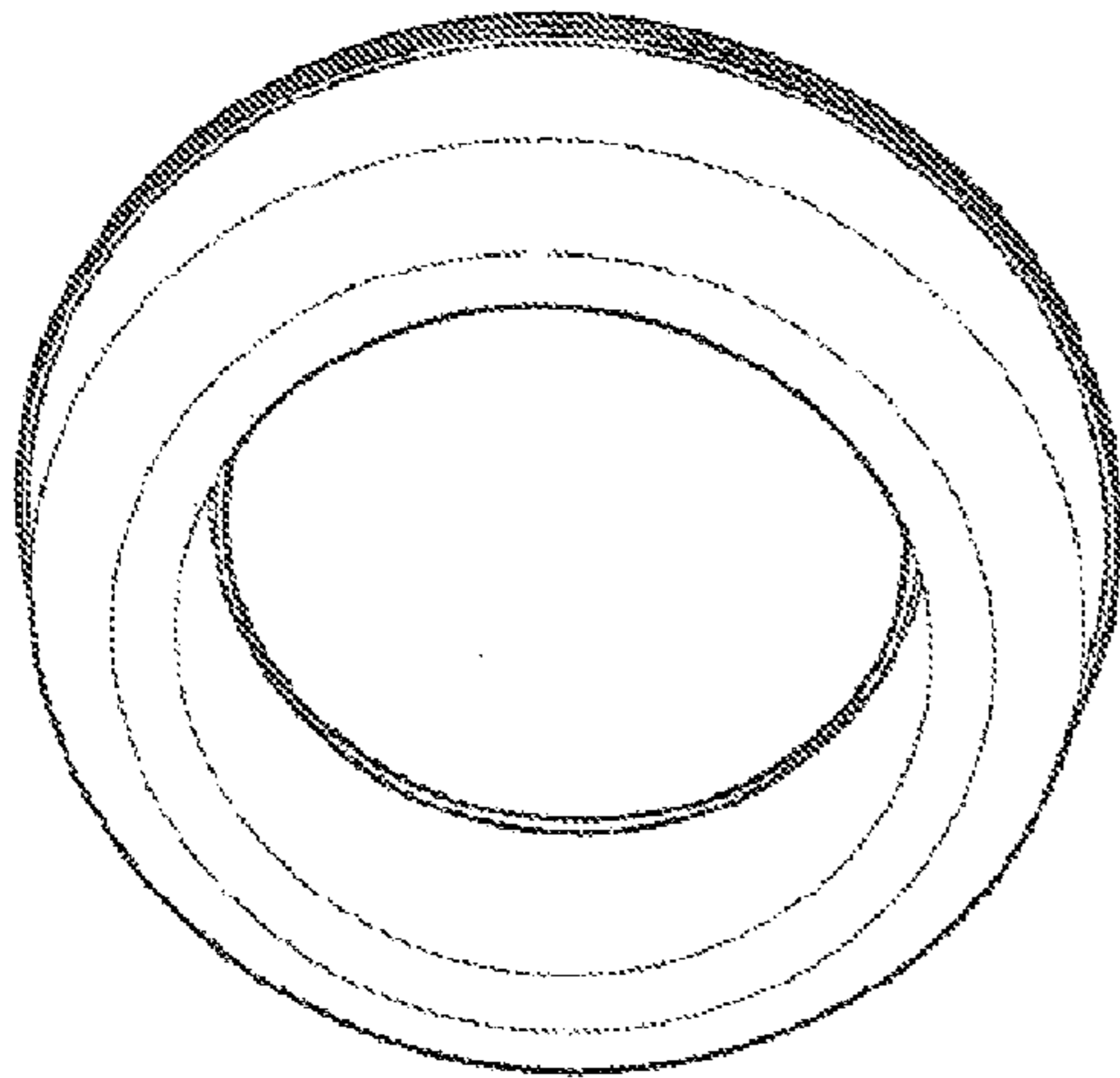

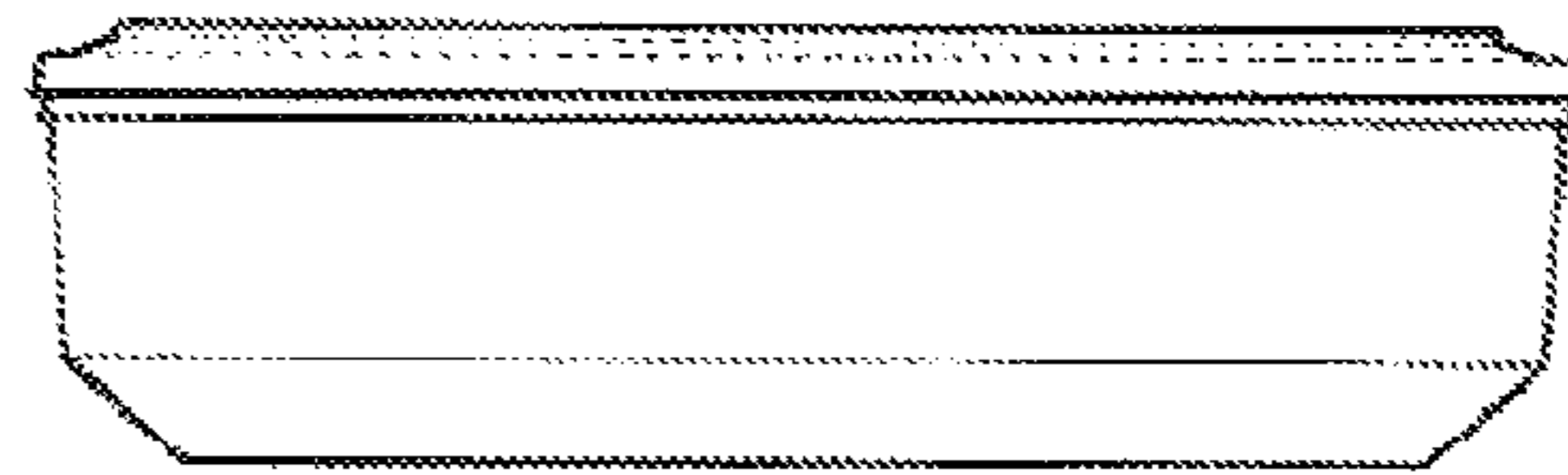

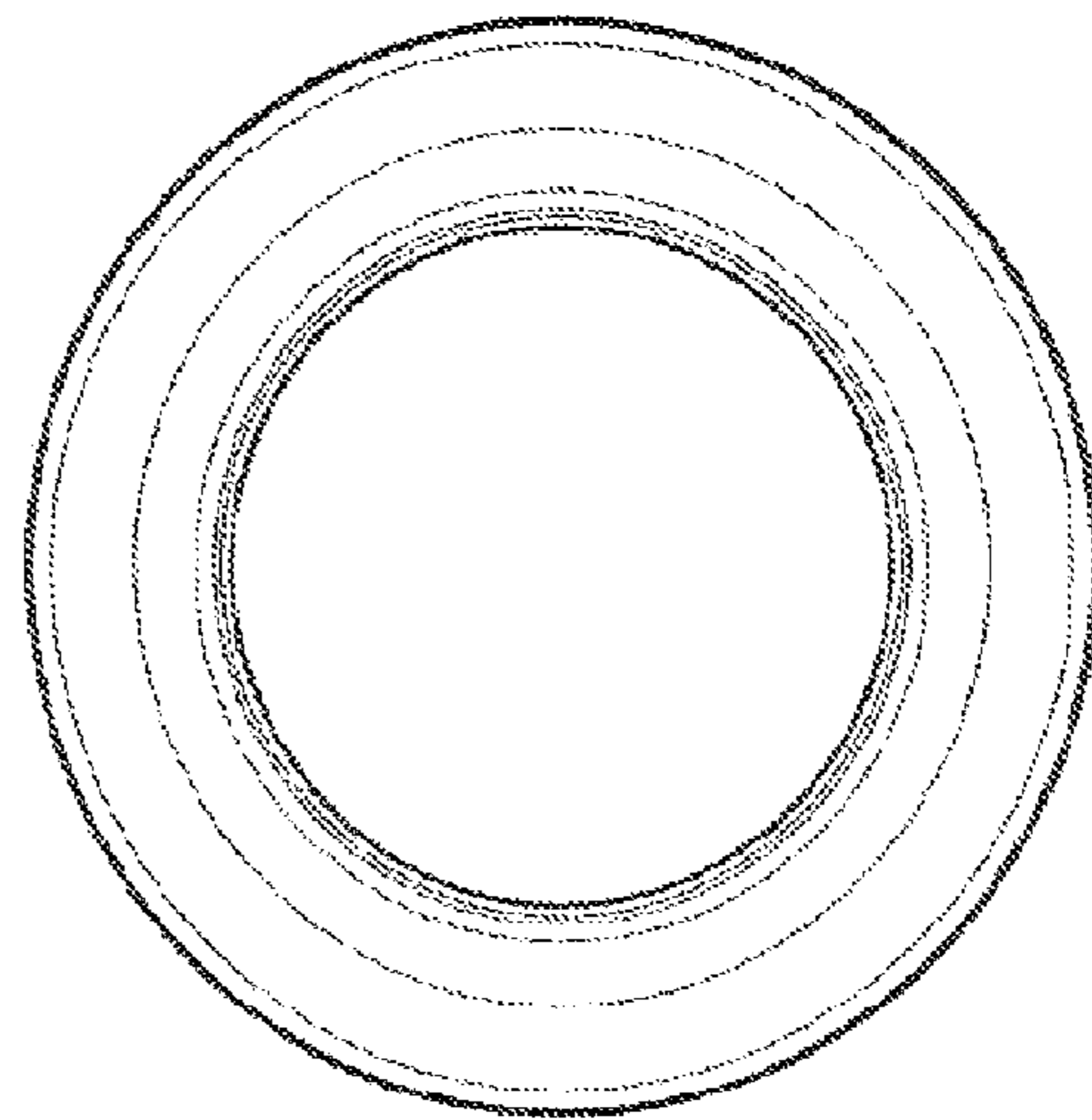
