(57) **CLAIM**

The ornamental design for a wall cabinet, as shown and described.

**DESCRIPTION**

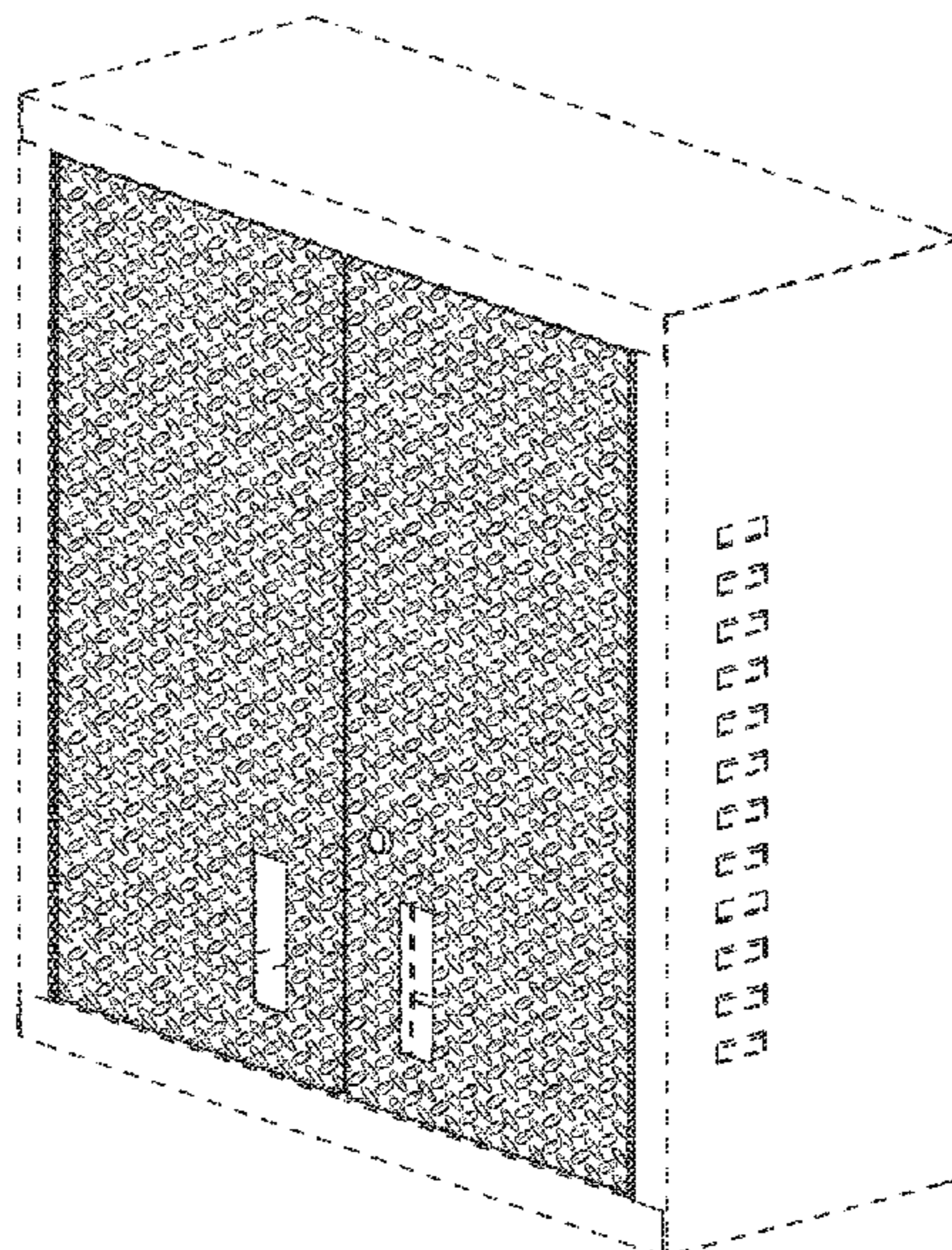
FIG. 1 is a right front perspective view of a wall cabinet showing our new design;

FIG. 2 is an enlarged fragmentary front elevation view of FIG. 3; and,

FIG. 3 is a front elevation view of the wall cabinet of FIG. 1. The ornamental design is not visible in a rear view, top plan view or bottom views. Those portions of wall cabinet in broken lines are understood to form no part of the claimed design.

The characteristic feature of the ornamental design resides in the use of a pattern on the wall cabinet doors. One embodiment of a pattern according to the ornamental design is shown in FIGS. 1–3.

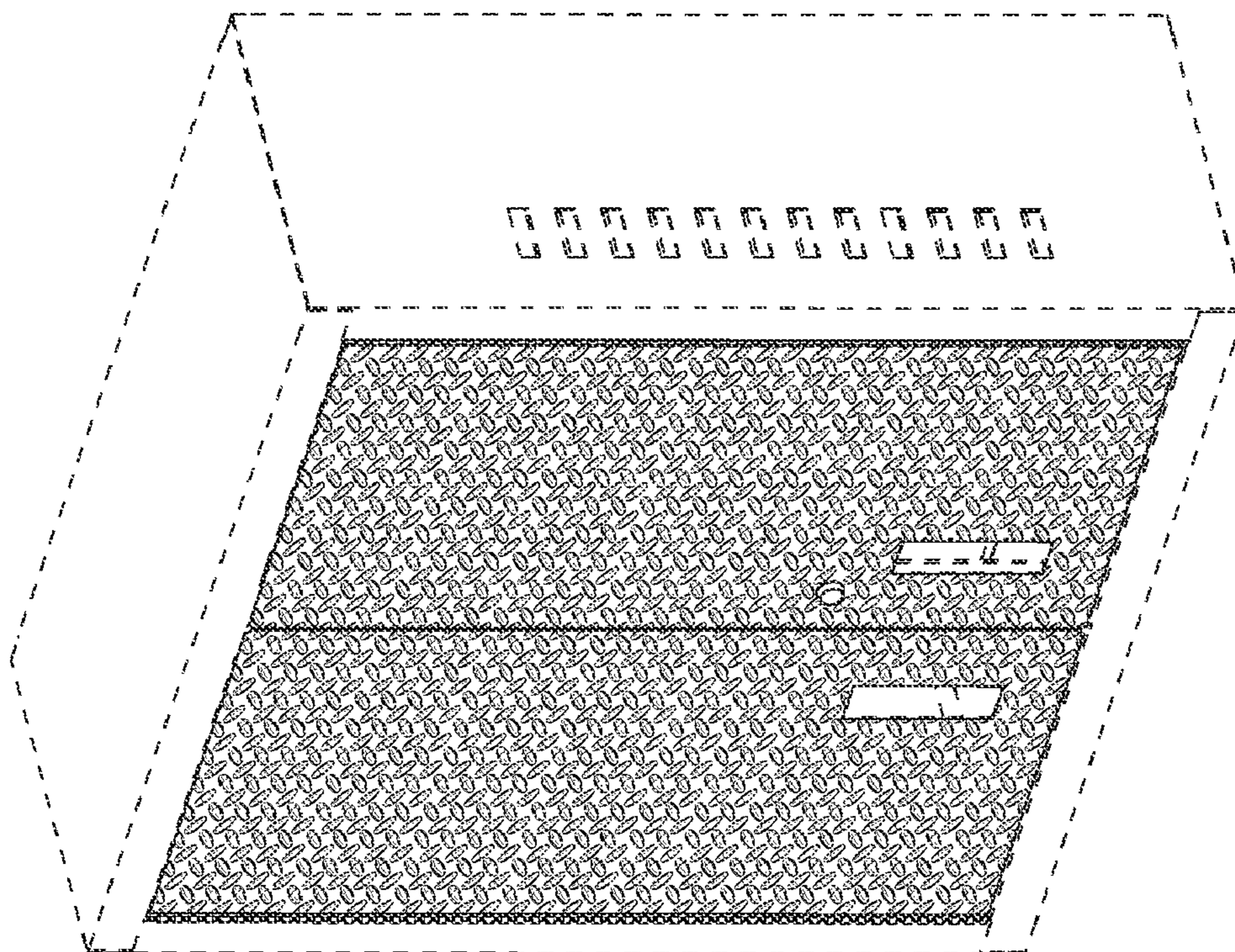

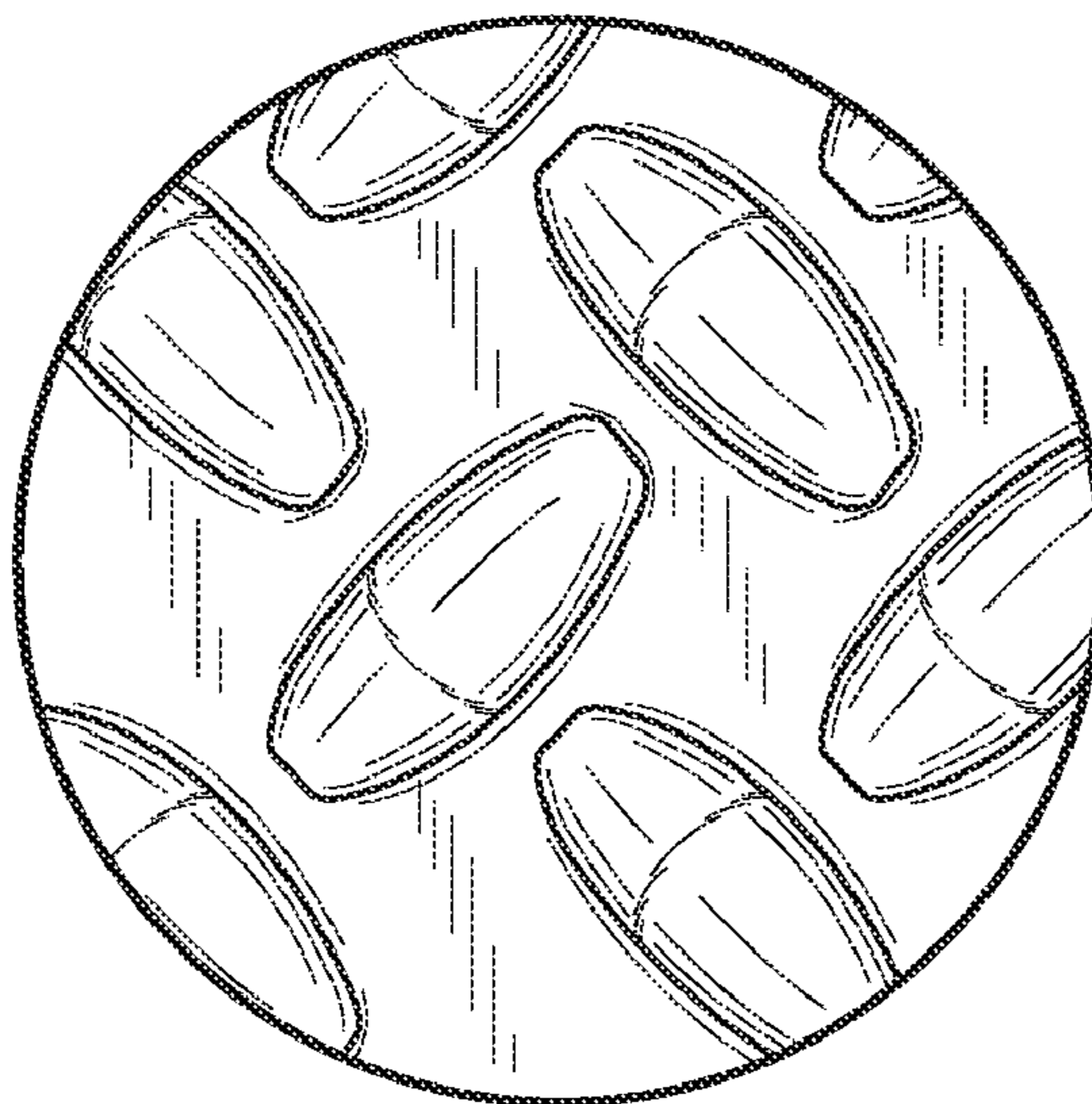
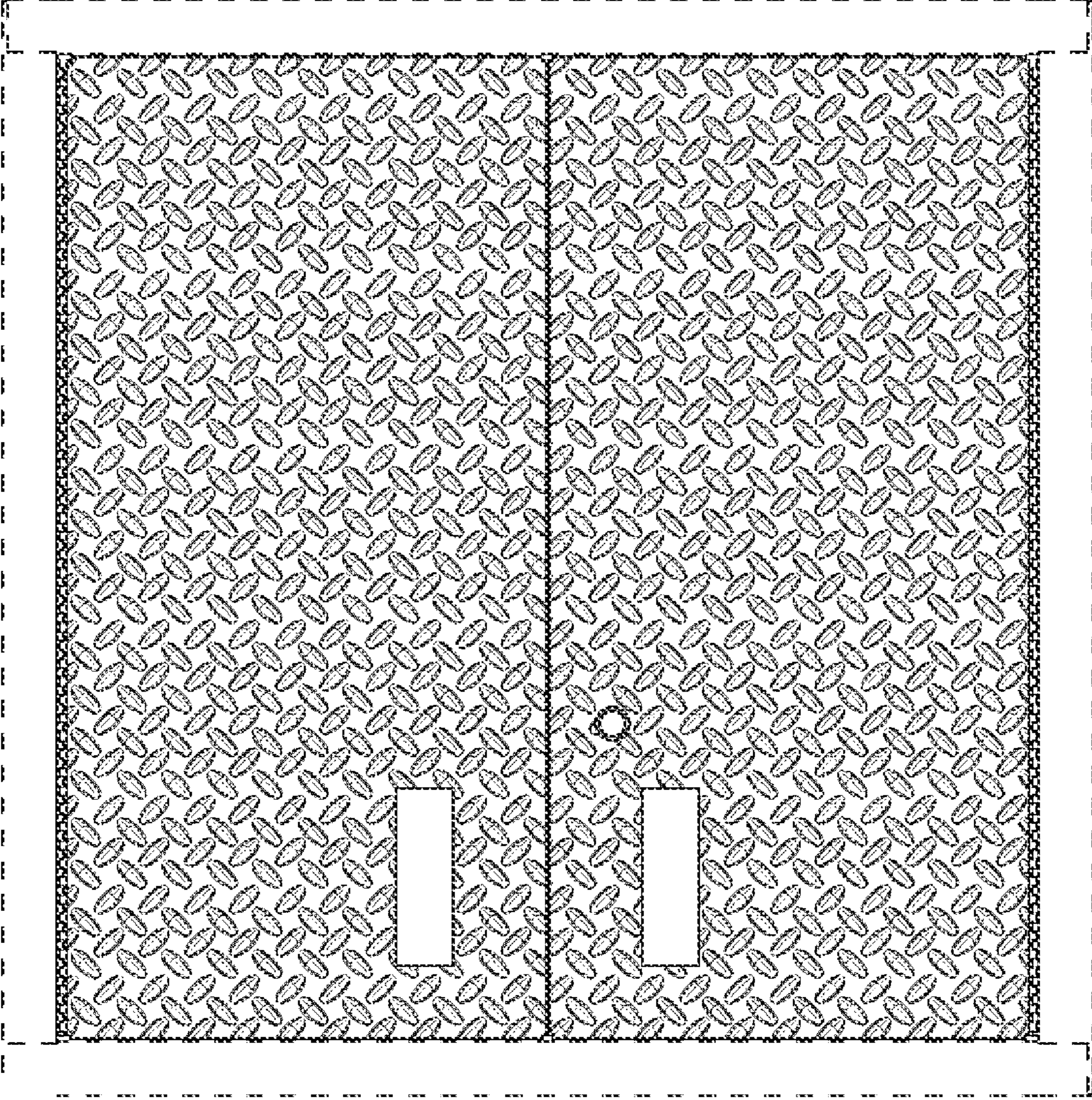
