FIG. 1 is a top right perspective view of a cookware handle according to the present invention.

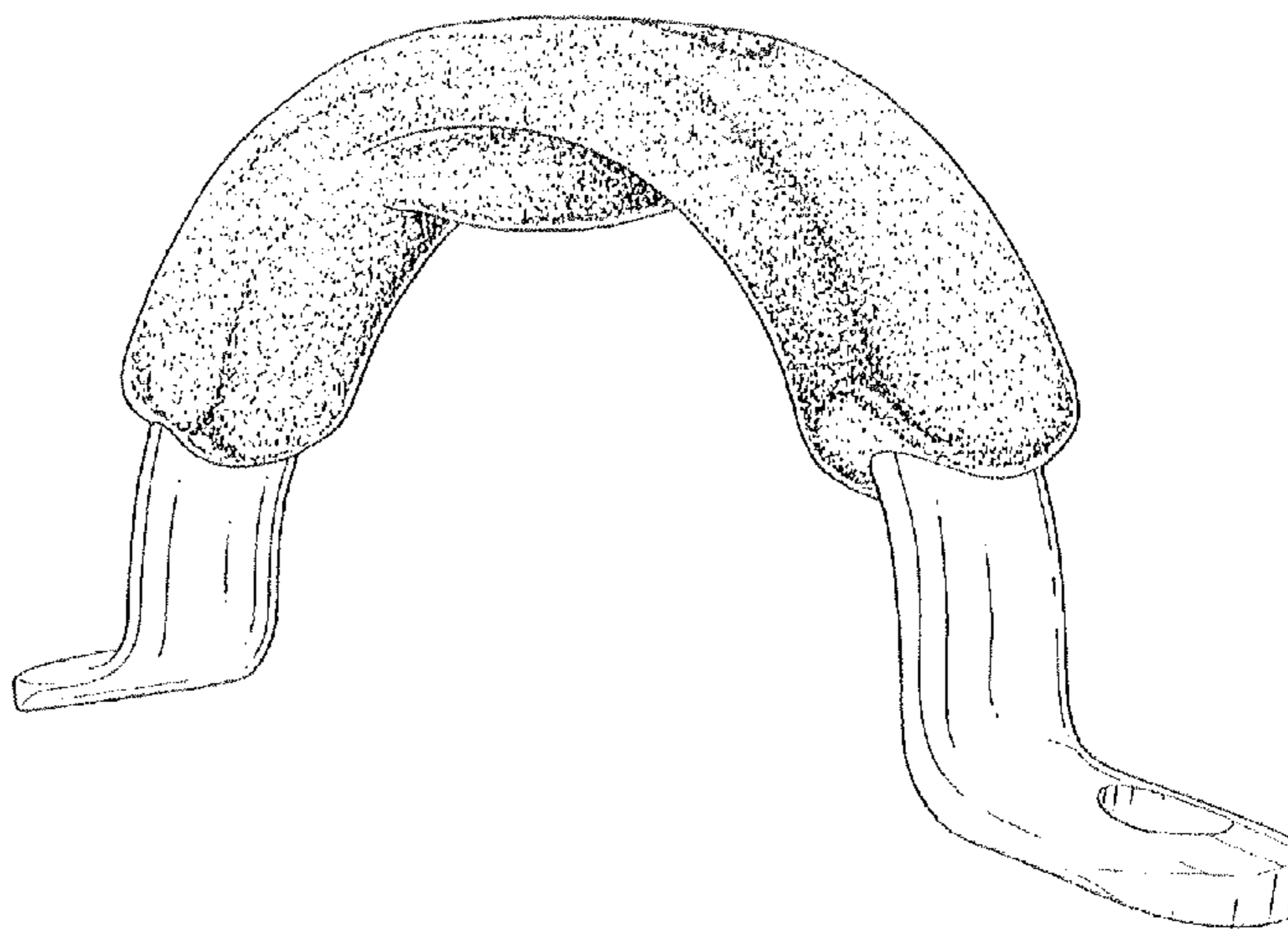
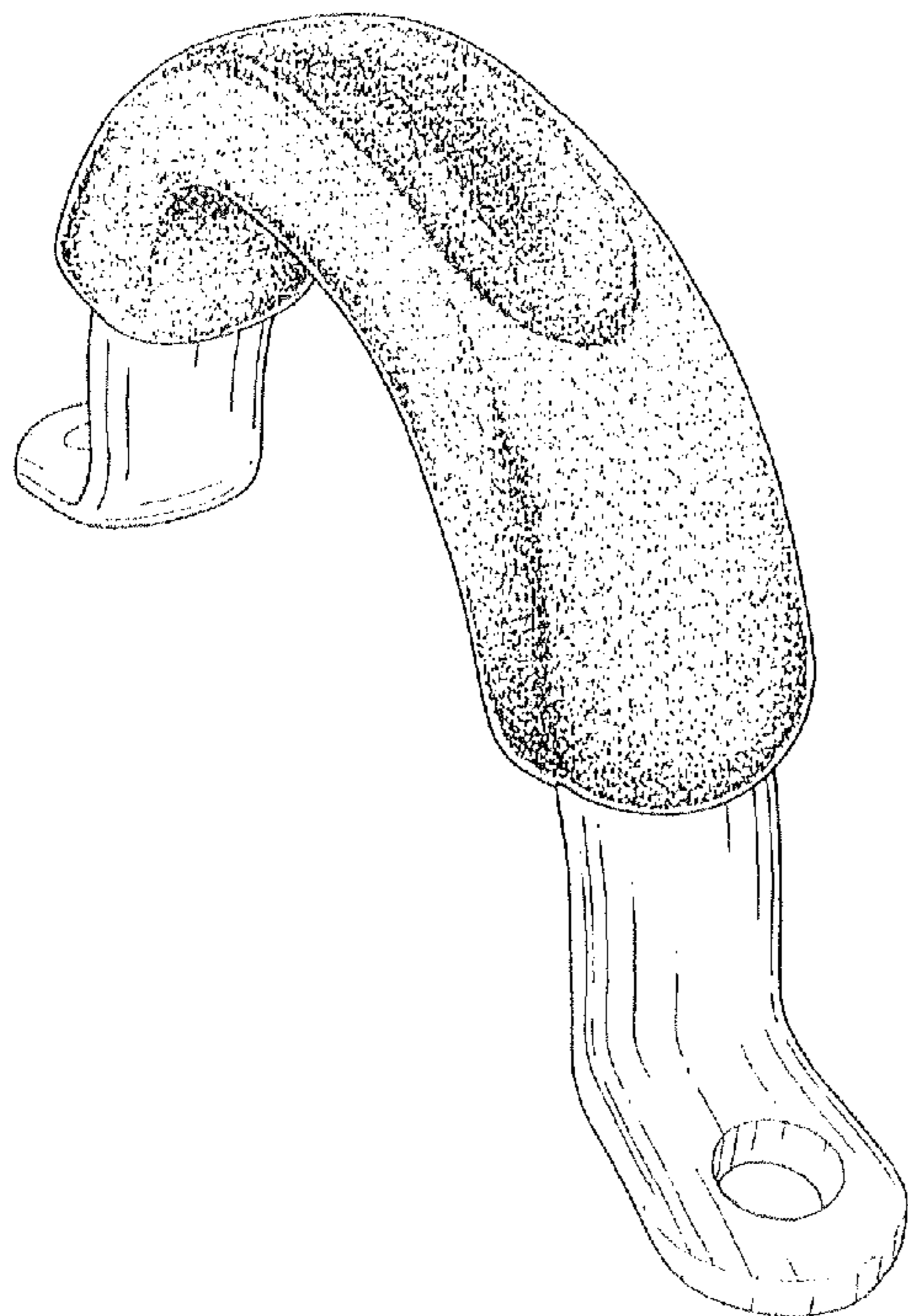
FIG. 2 is a top front perspective view of the cookware handle of FIG. 1.

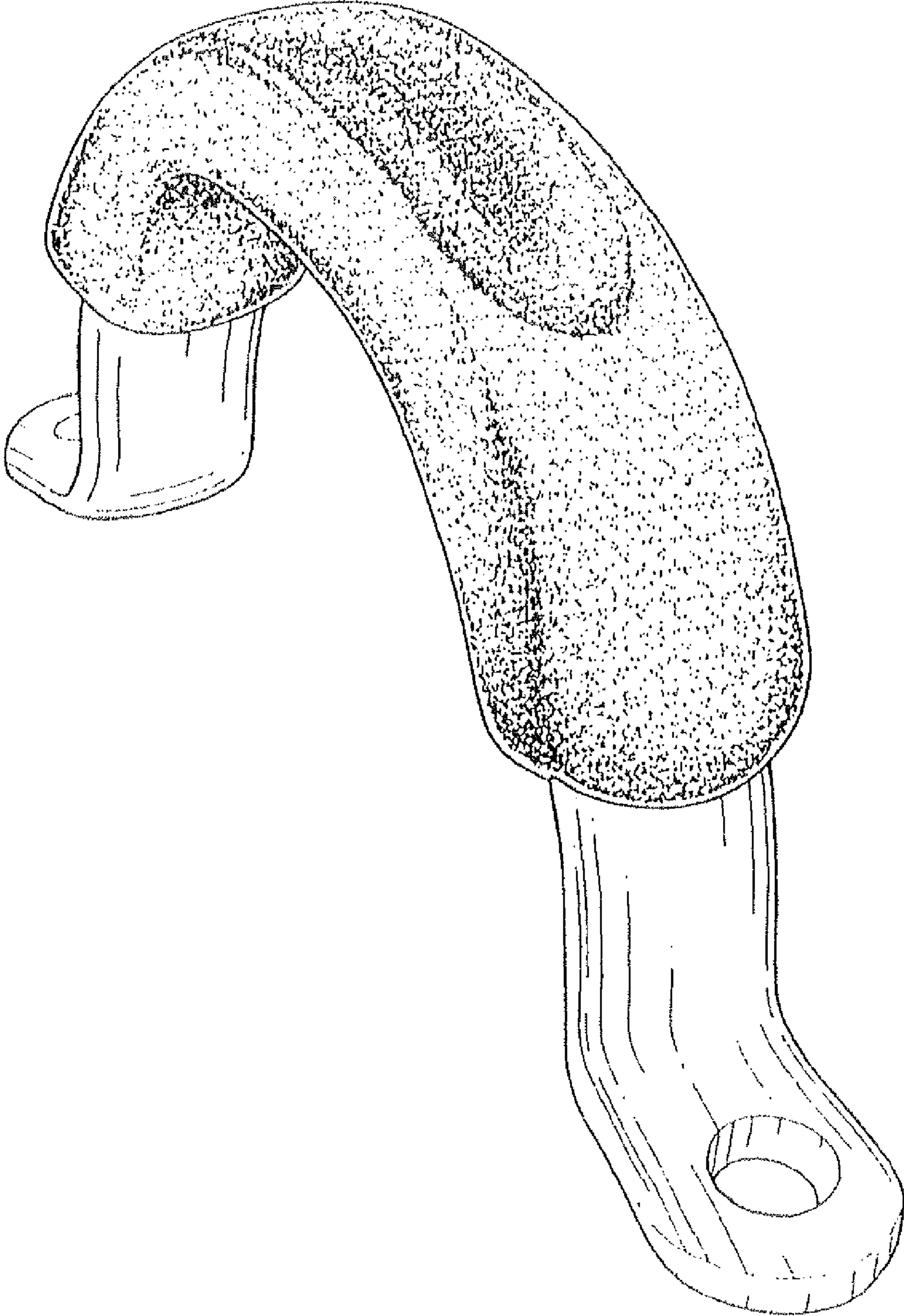

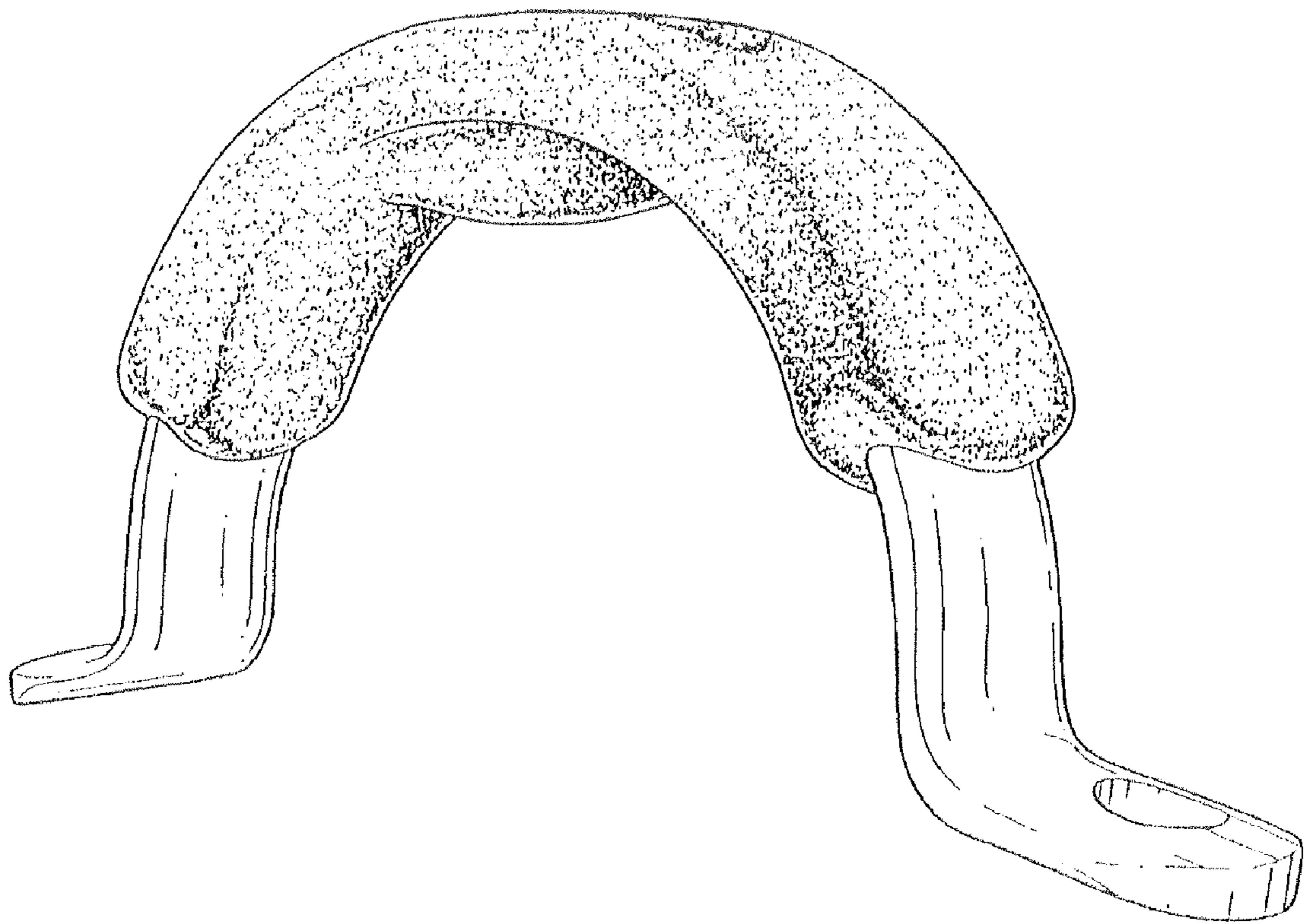

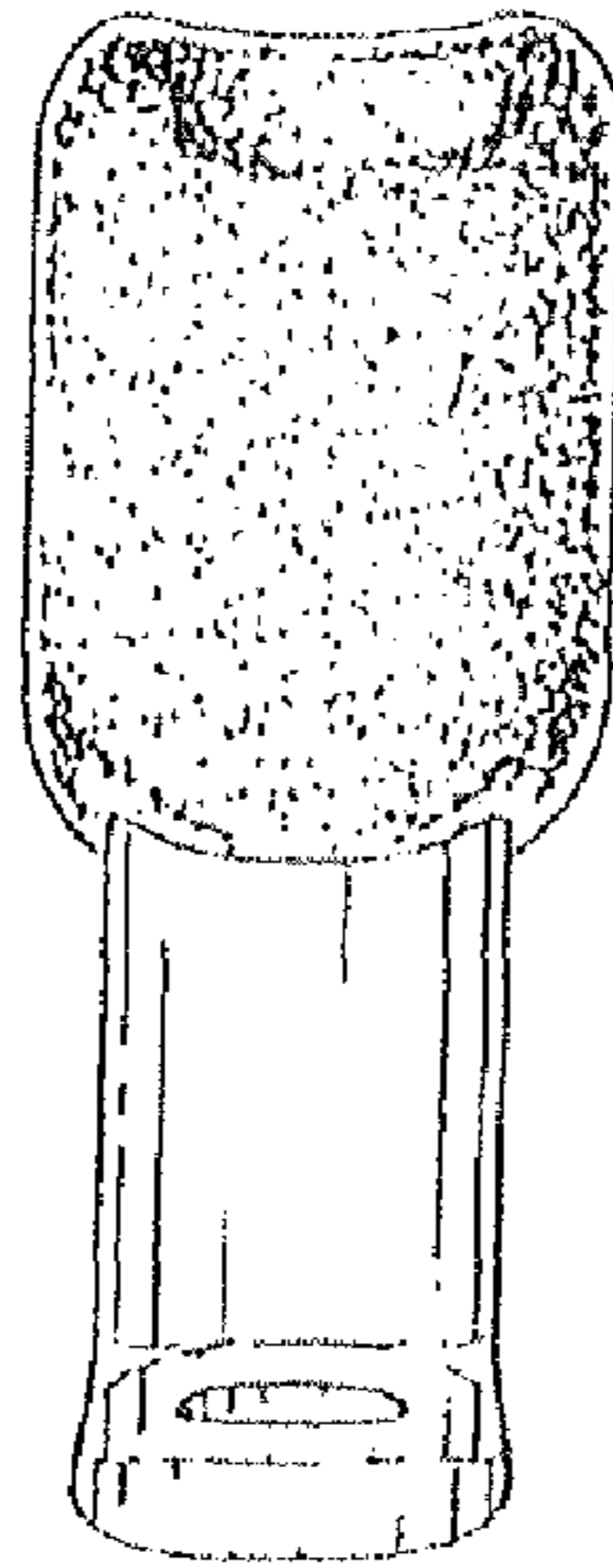

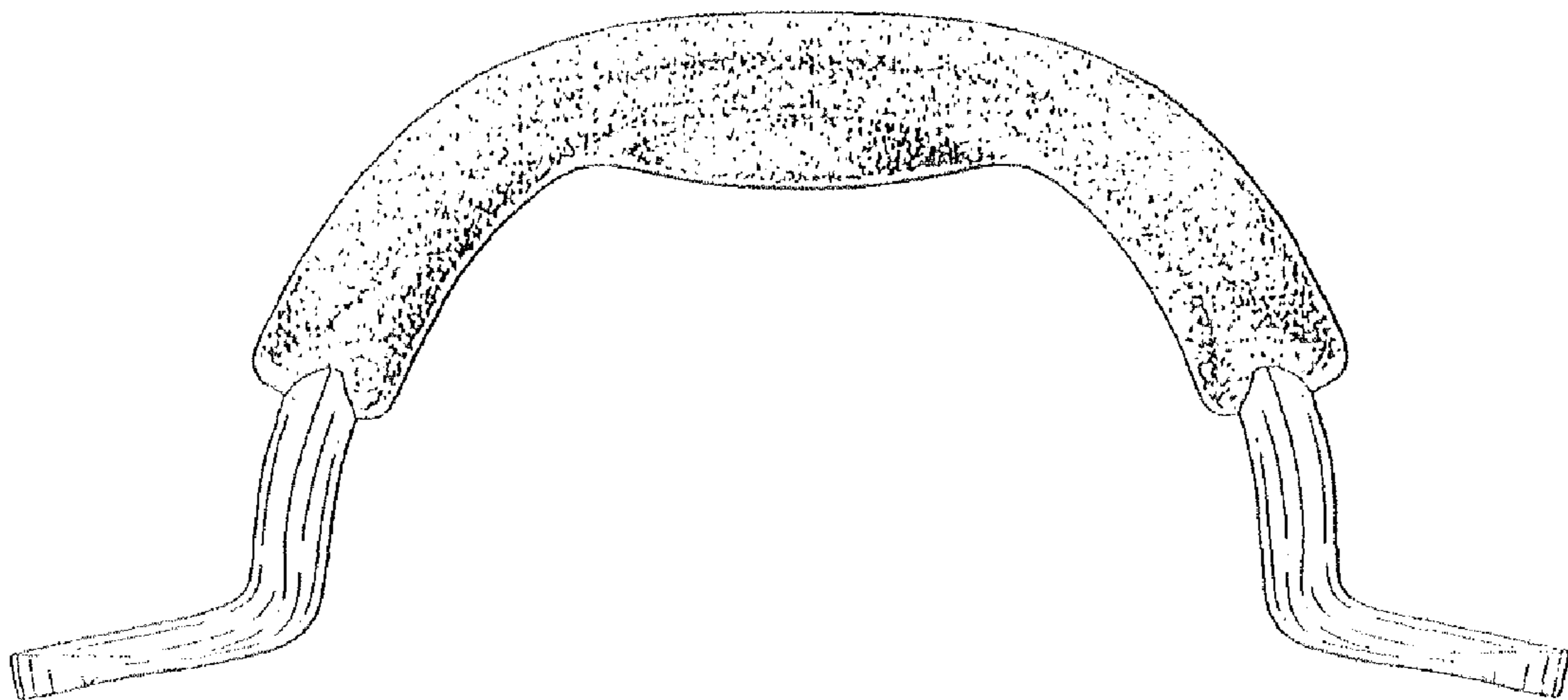

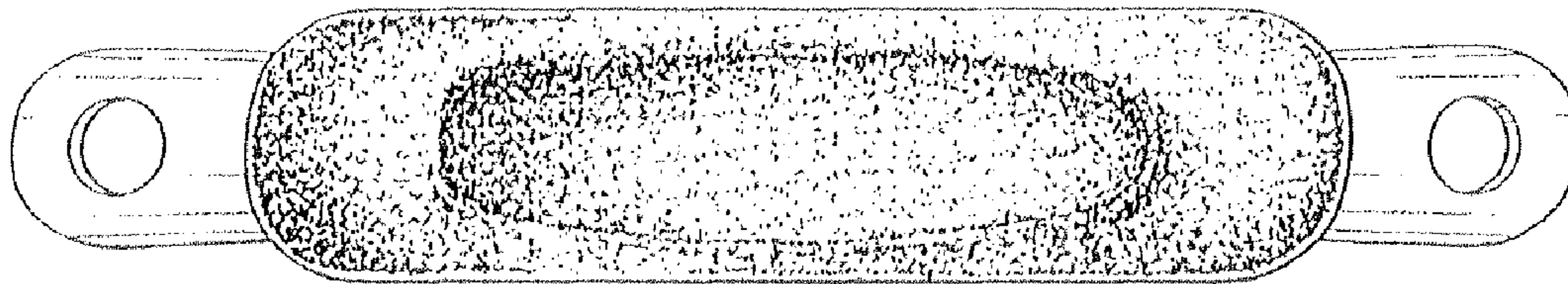

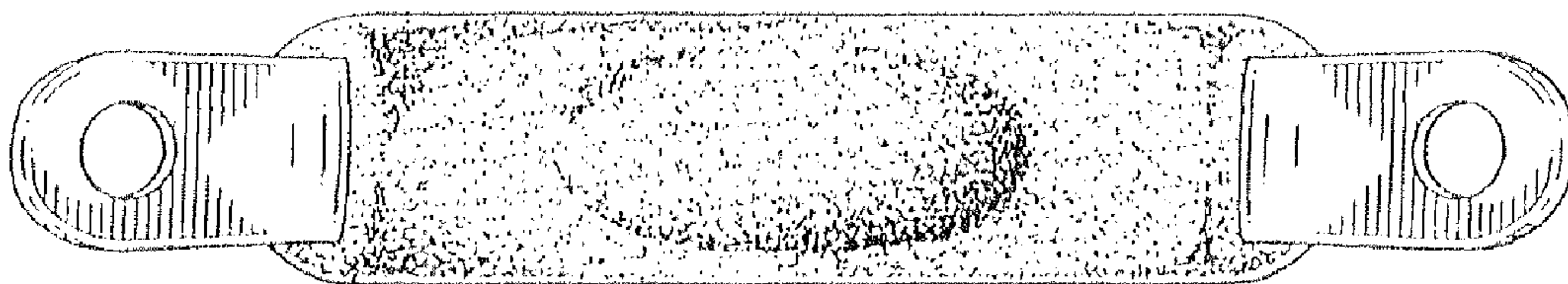
