(57) **CLAIM**

The ornamental design for a handle-grip accessory for motorcycle passenger, as shown and described.

DESCRIPTION

FIG. 1 is perspective front view of the handle-grip accessory for motorcycle passenger of the present invention.

FIG. 2 is a perspective rear view of the handle-grip accessory for motorcycle passenger of the present invention.

FIG. 3 is a front perspective view of the handle-grip accessory for motorcycle passenger of the present invention.

FIG. 4 is a right side view of the handle-grip accessory for motorcycle passenger of the present invention.

FIG. 5 is a left side view of the handle-grip accessory for motorcycle passenger of the present invention.

FIG. 6 is a top perspective view of the handle-grip accessory for motorcycle passenger of the present invention.

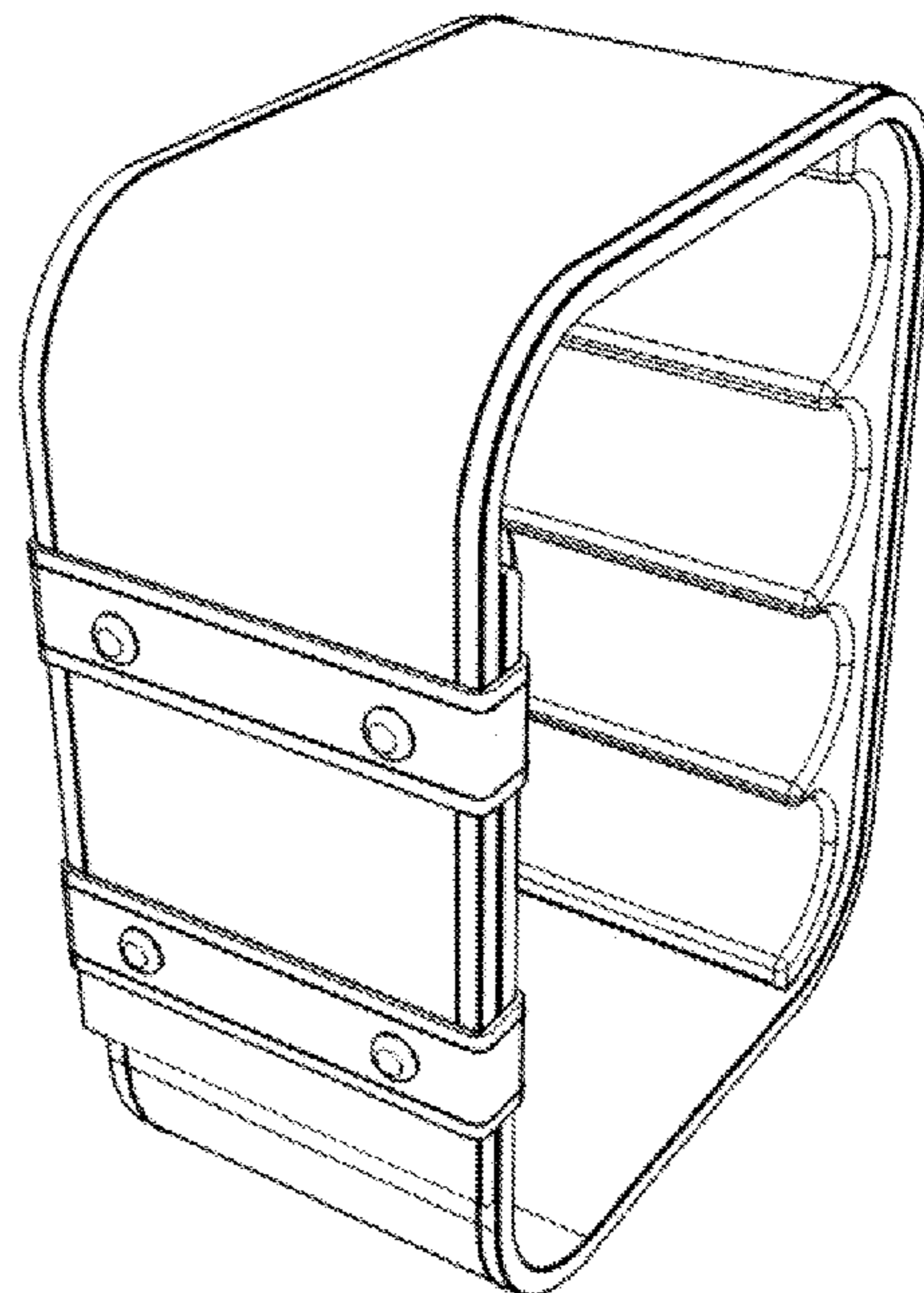
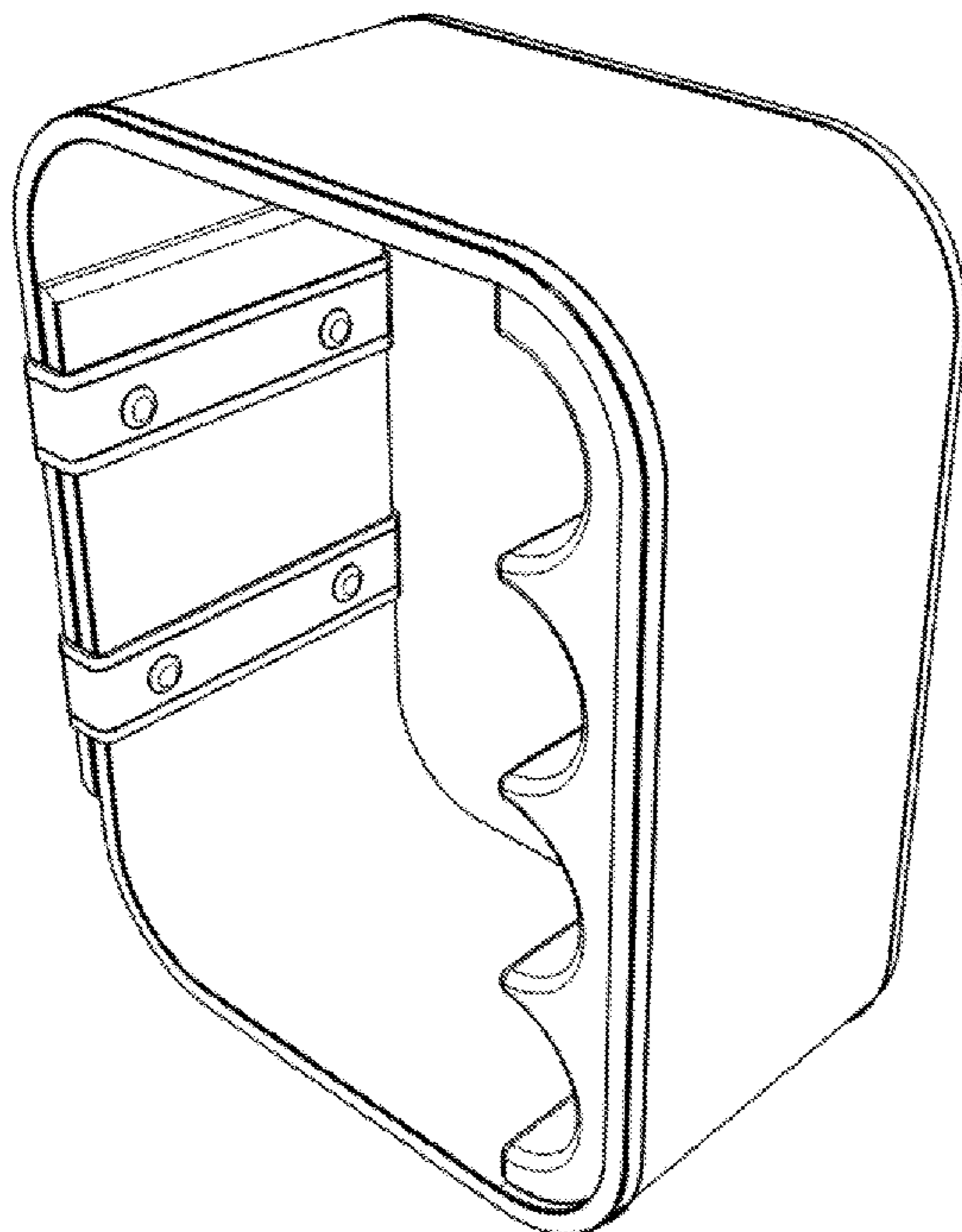

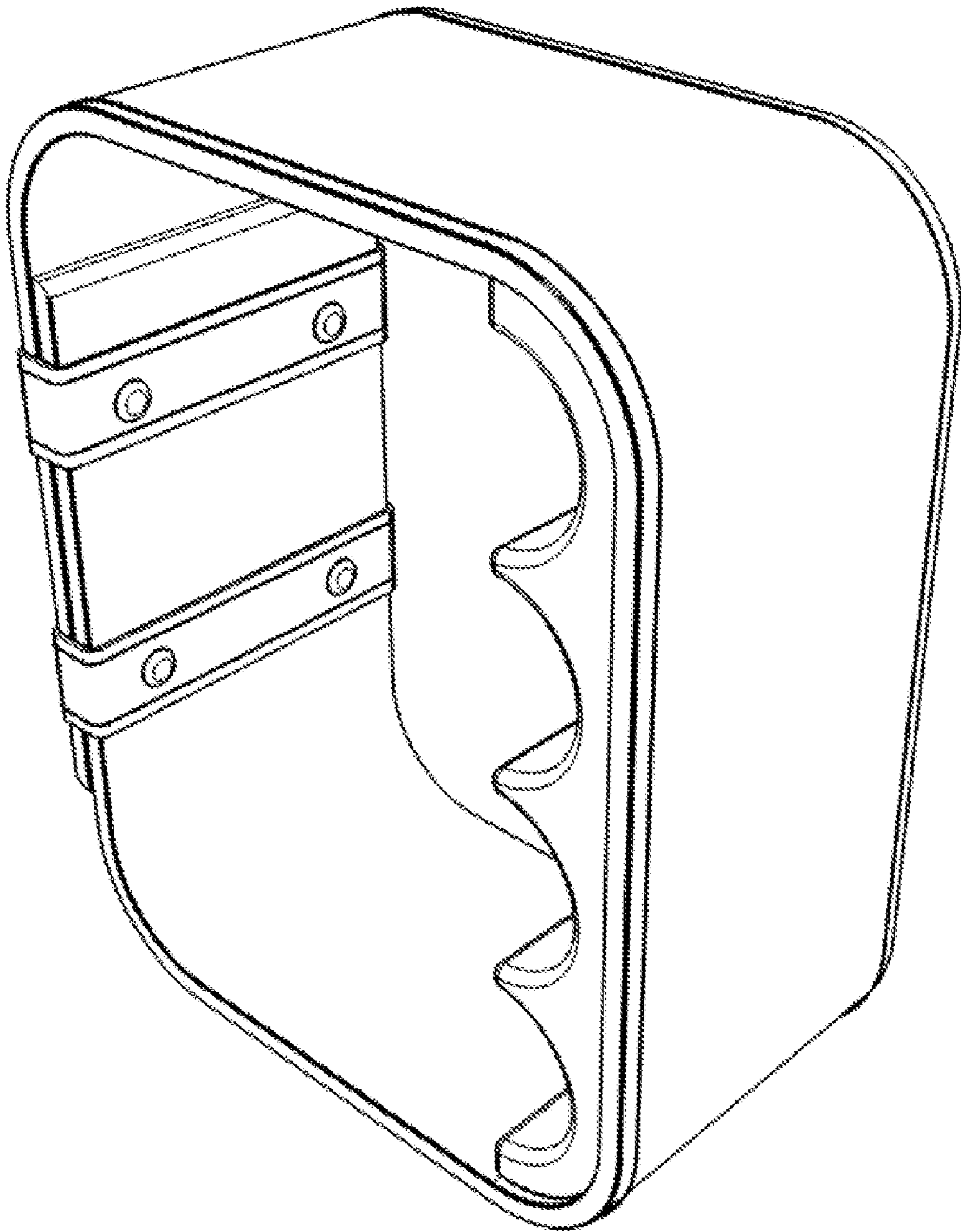

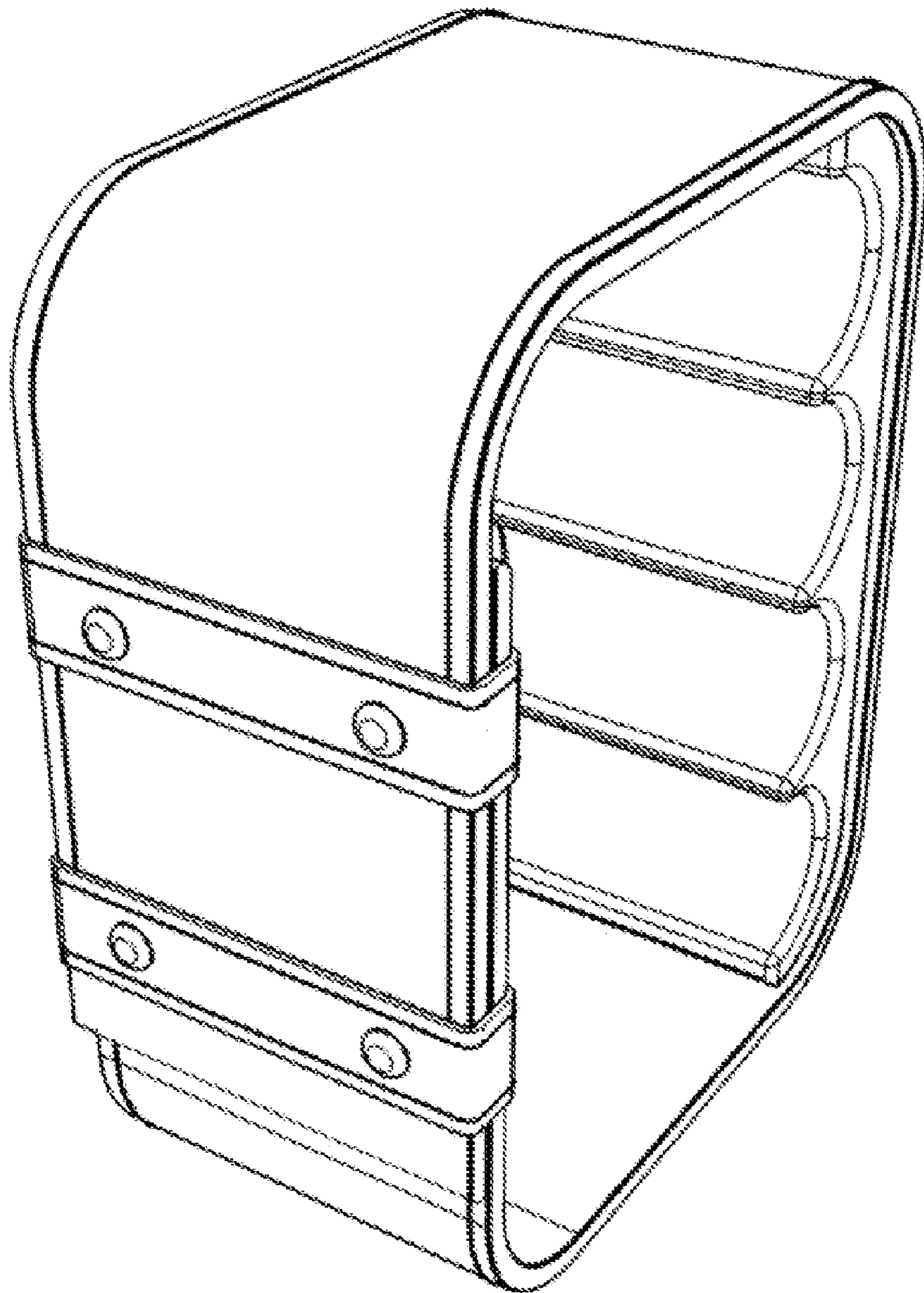

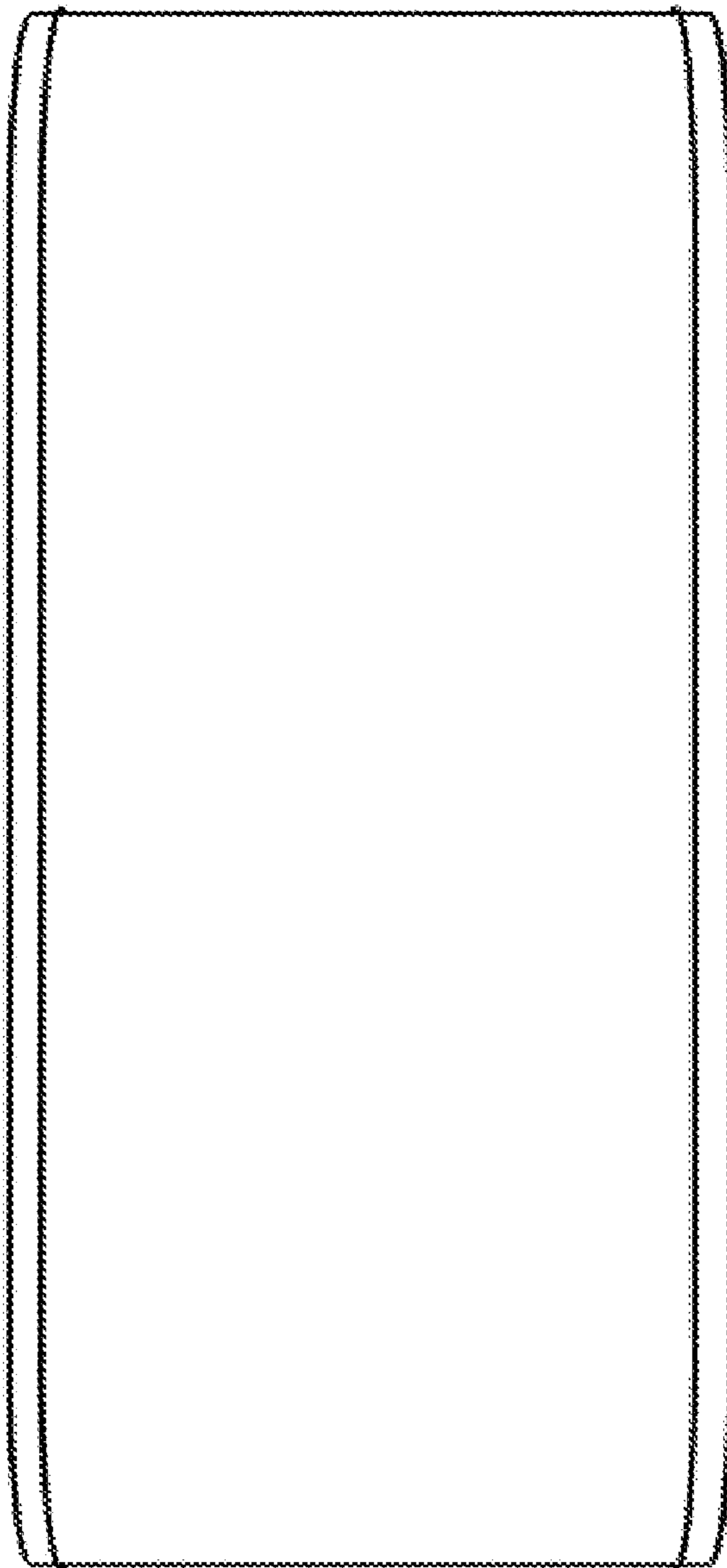

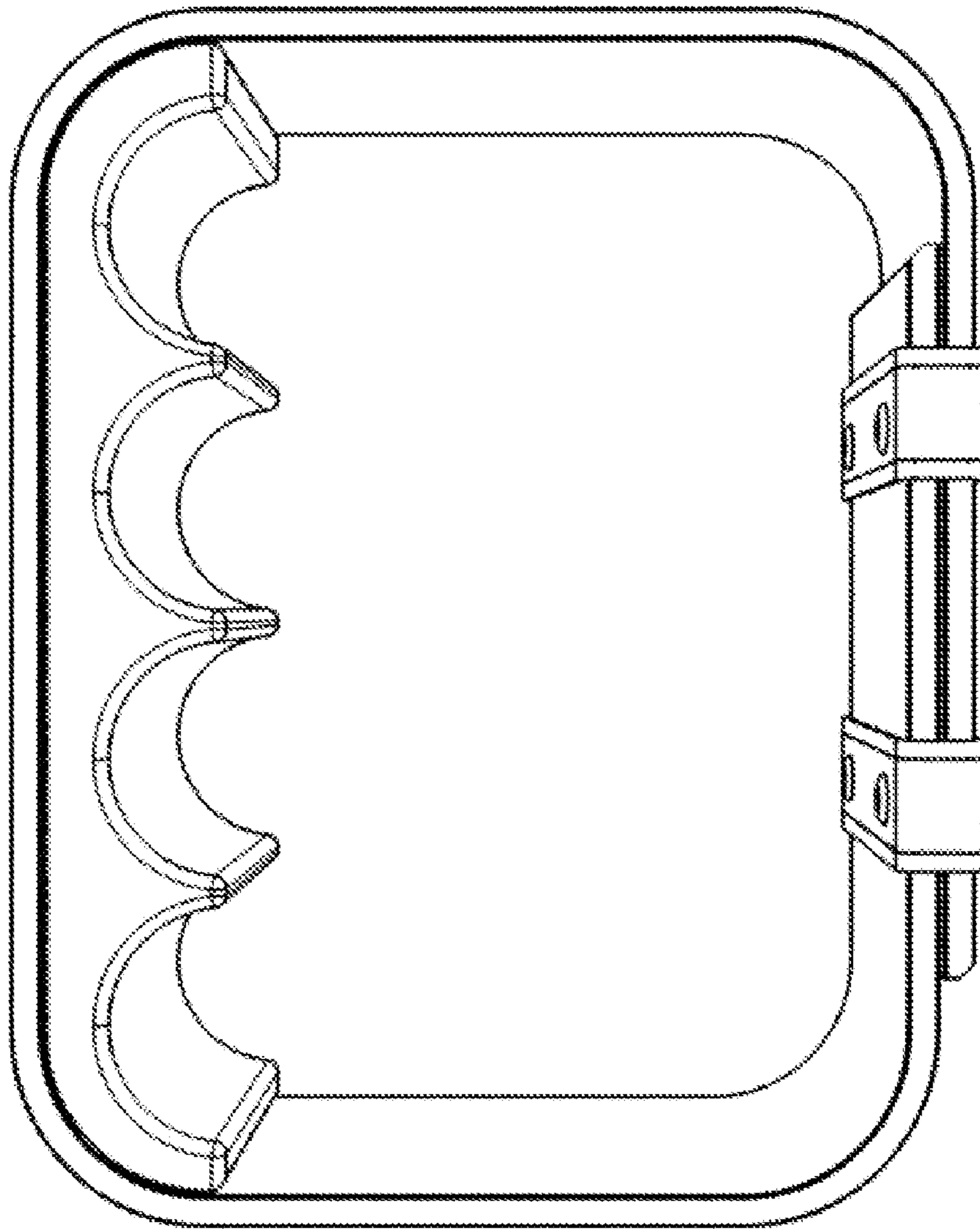

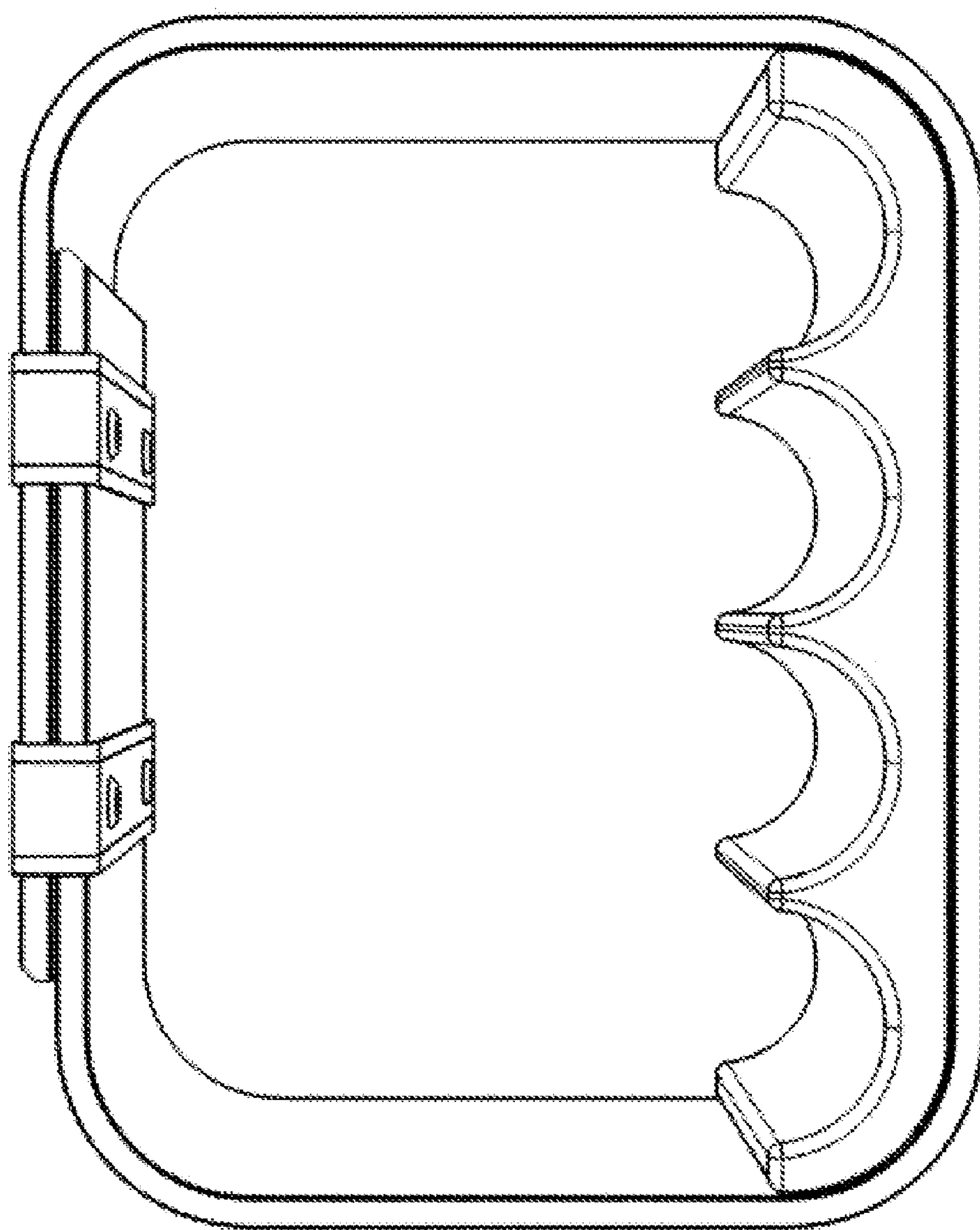

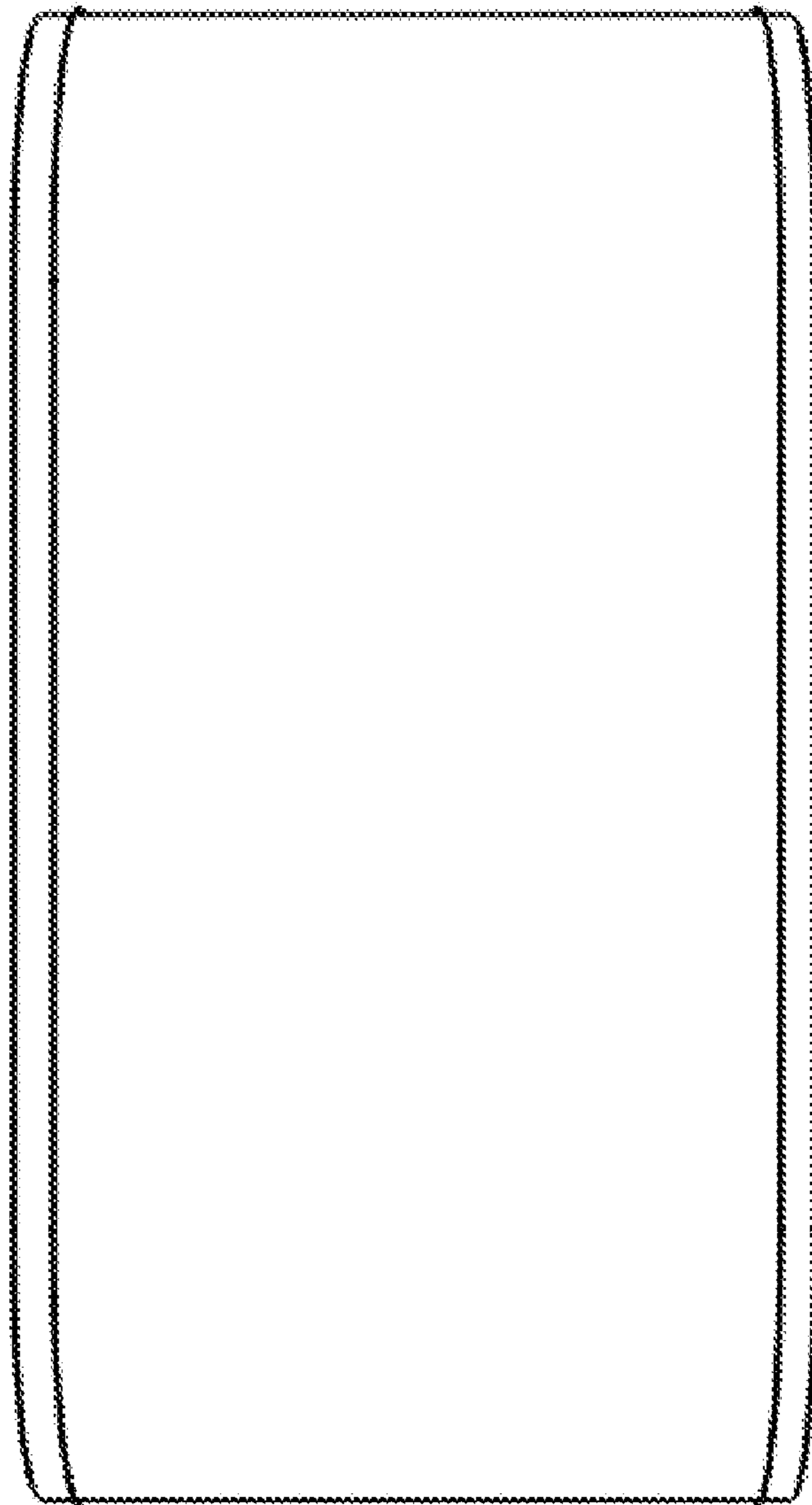

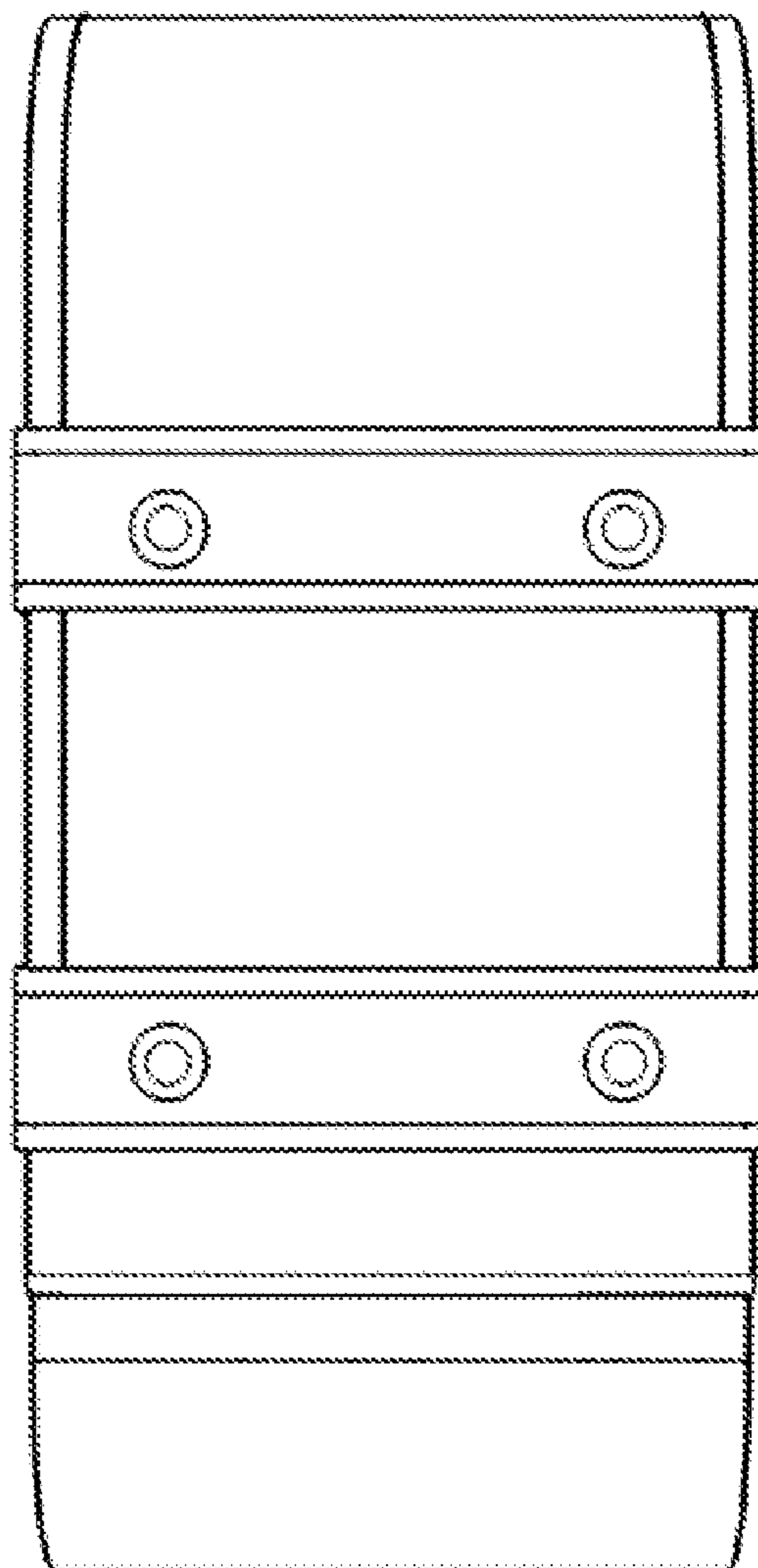
