(57) **CLAIM**

The ornamental design for an acoustic isolator clip, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the present acoustic isolator clip shown positioned over a resilient channel used in the mounting of wallboard or other construction panels to ceilings;

FIG. 2 is a top view of same;

FIG. 3 is a front end view of same, the front and rear end views being mirror images of each other;

FIG. 4 is a side view of the present isolator clip, both side views being identical;

FIG. 5 is a bottom view of same;

FIG. 6 is a top perspective view of an alternate embodiment of the acoustic isolator clip of FIG. 1 shown positioned over a resilient channel used in the mounting of wallboard or other construction panels to ceilings;

FIG. 7 is a top view of same;

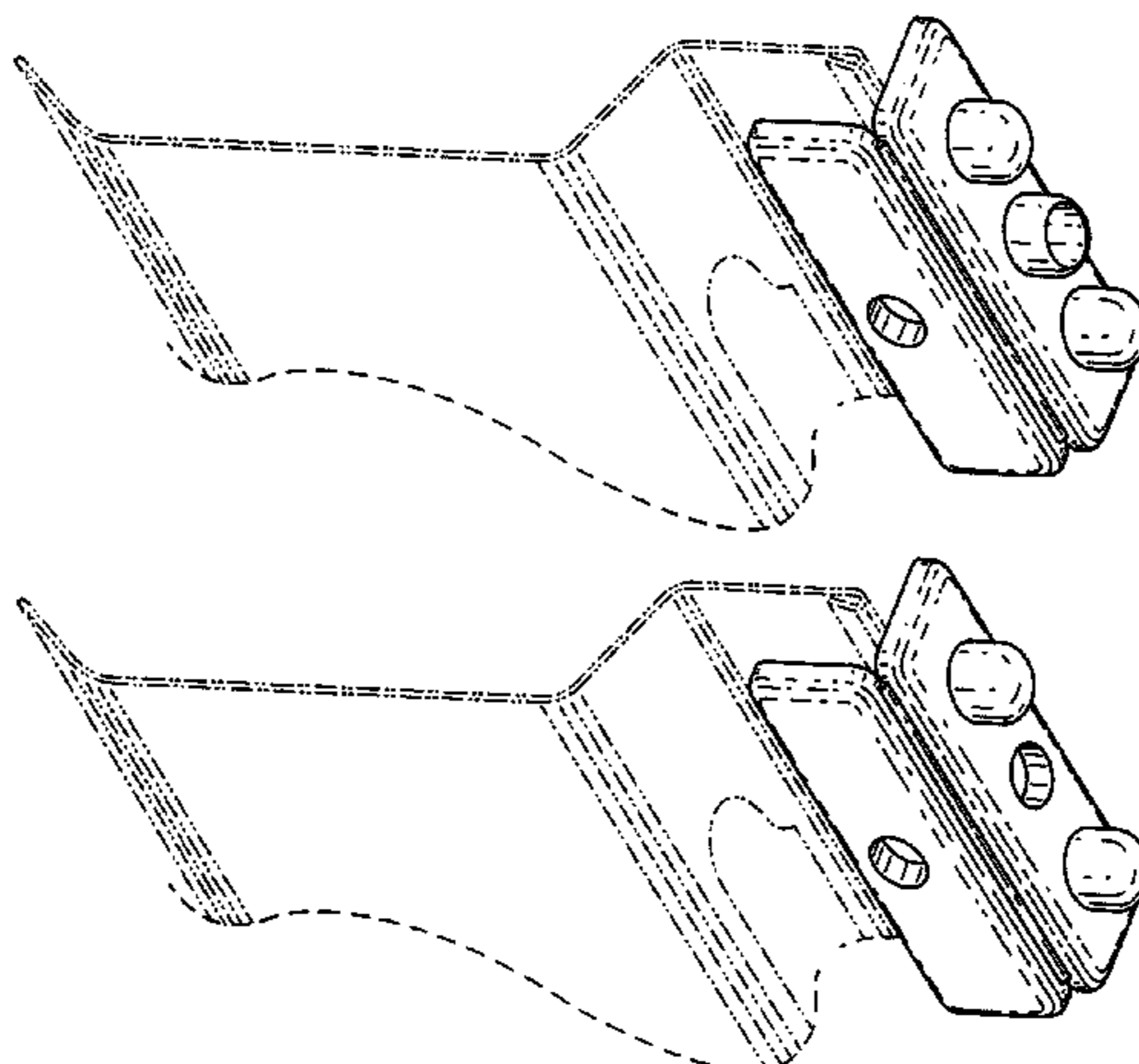
FIG. 8 is a front end view of the acoustic isolator clip of FIG. 6, the rear end being mirror images of each other;

FIG. 9 is a side view of the acoustic isolator clip of FIG. 6, both side views being identical; and,

FIG. 10 is a bottom view of same.

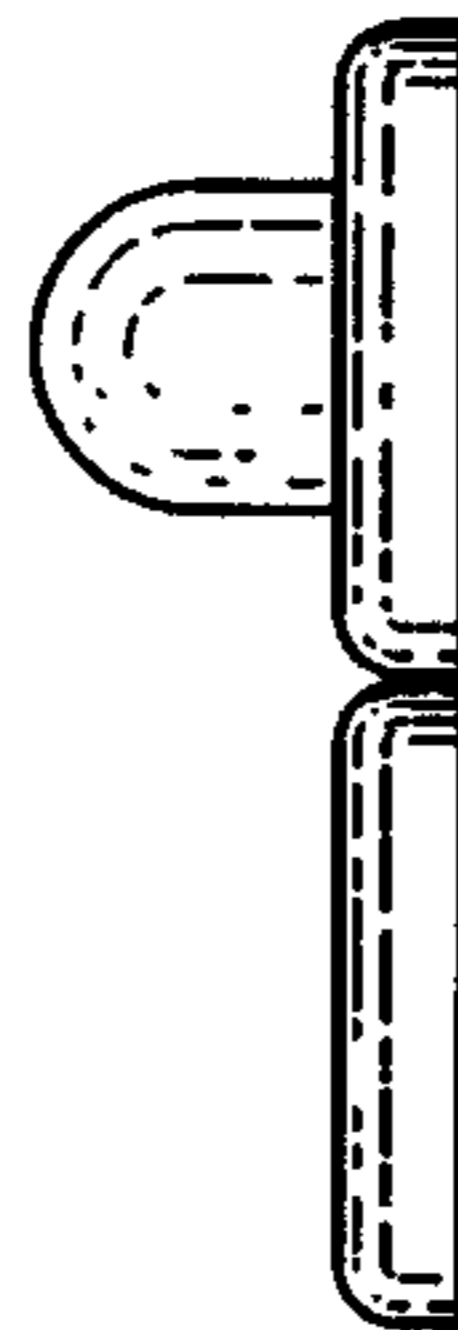
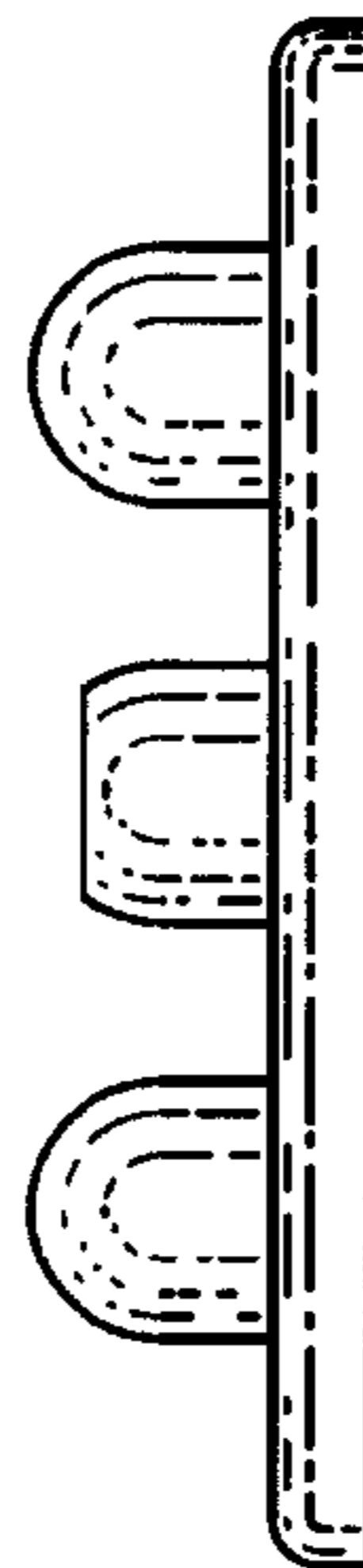
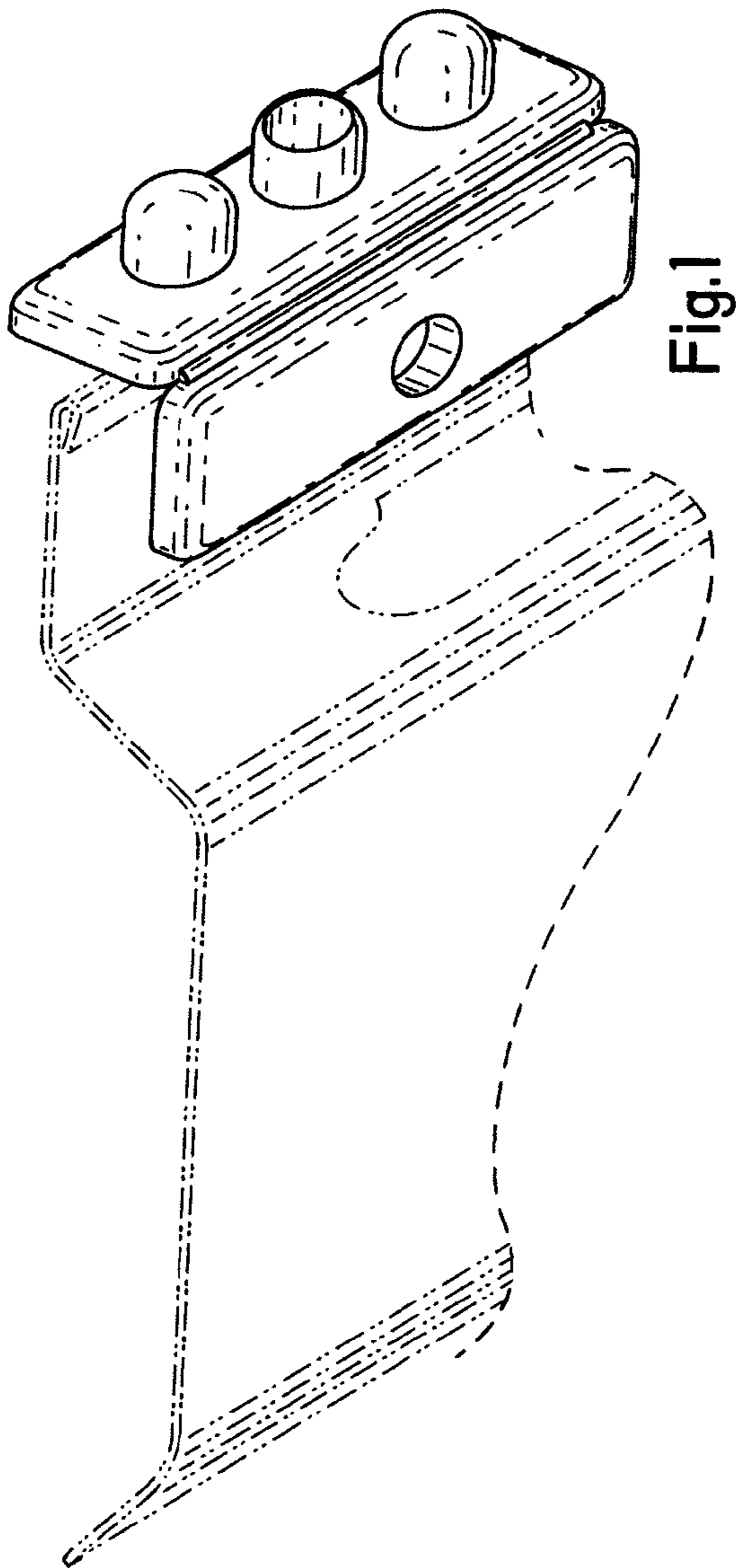
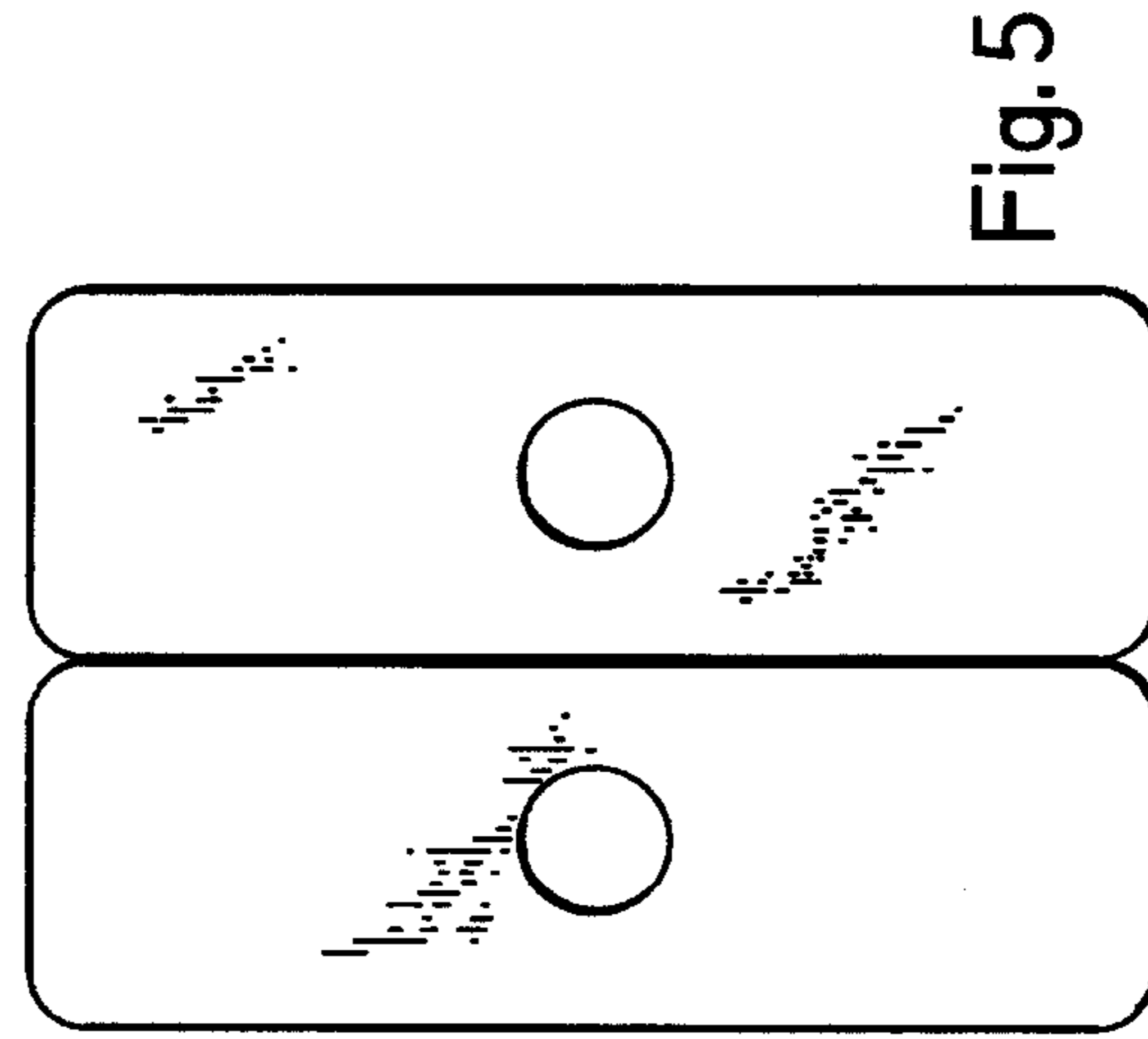
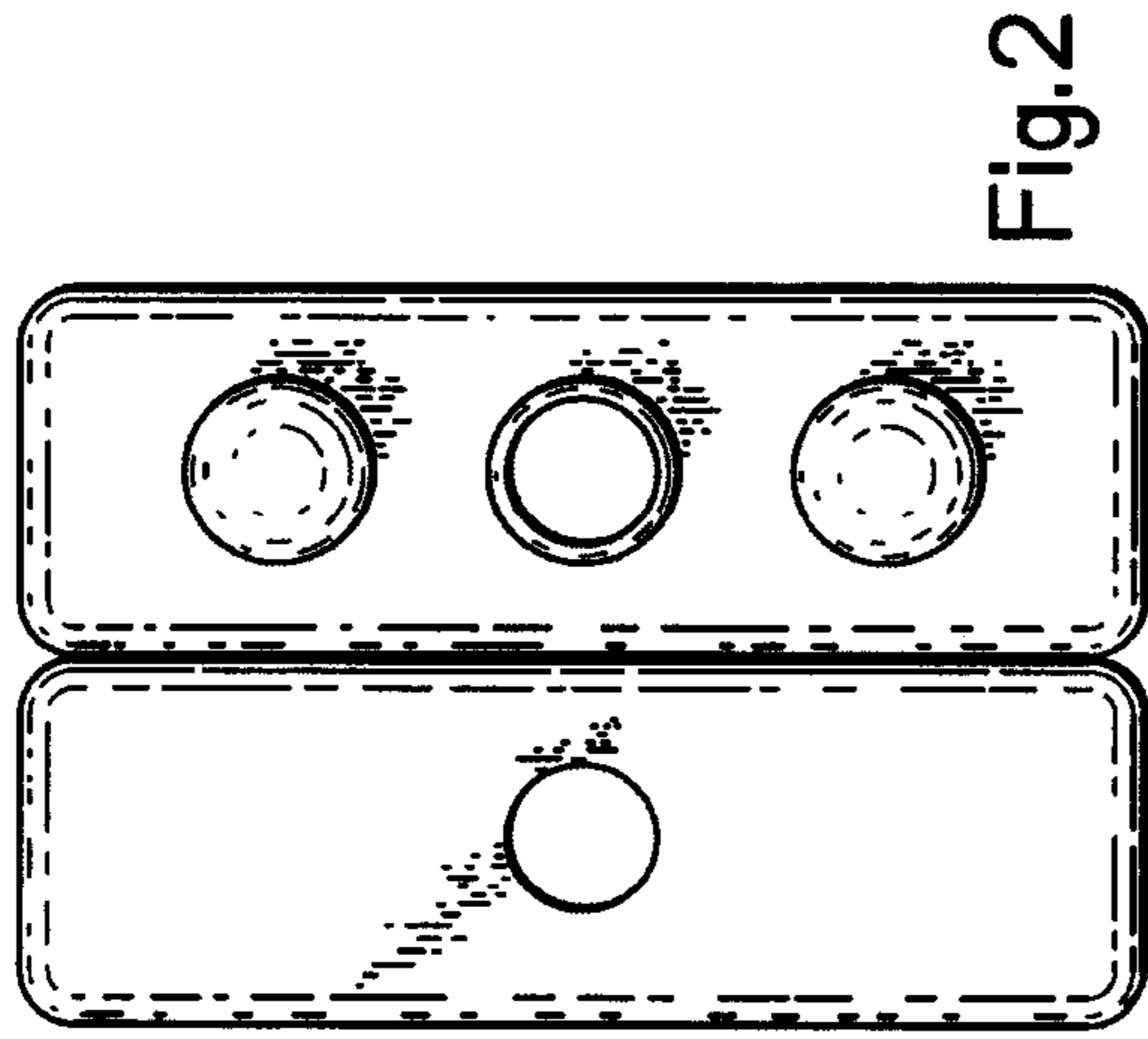

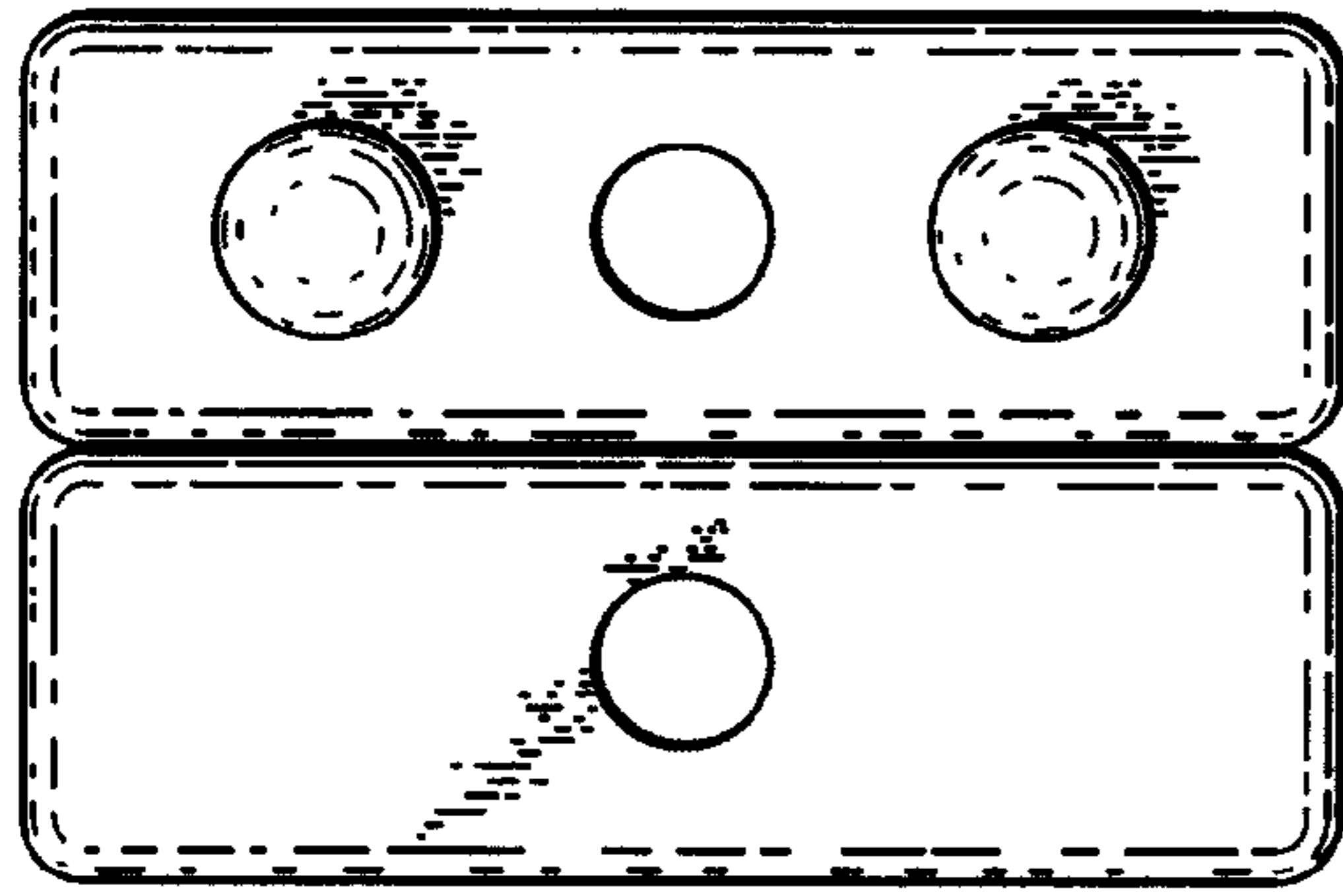

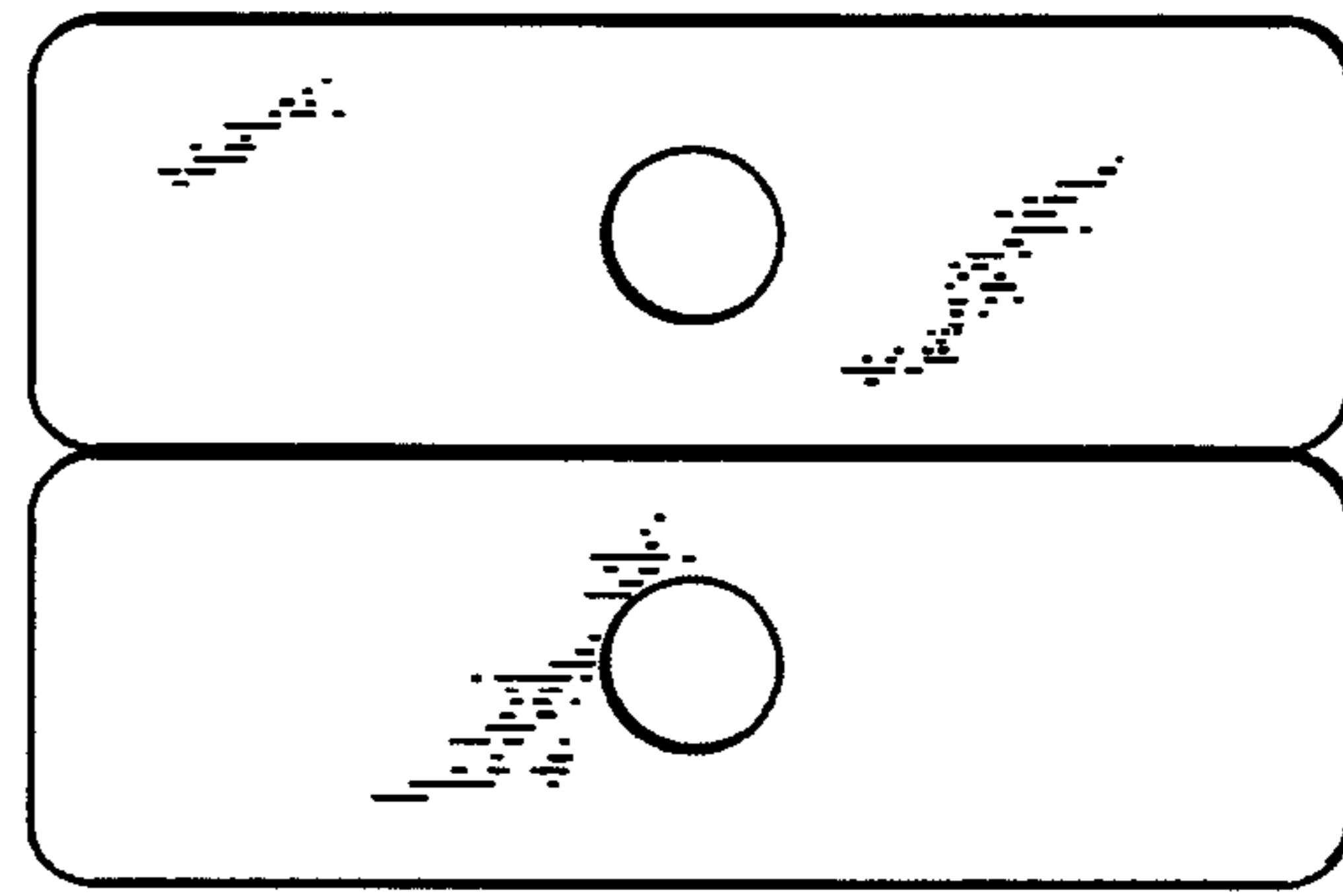

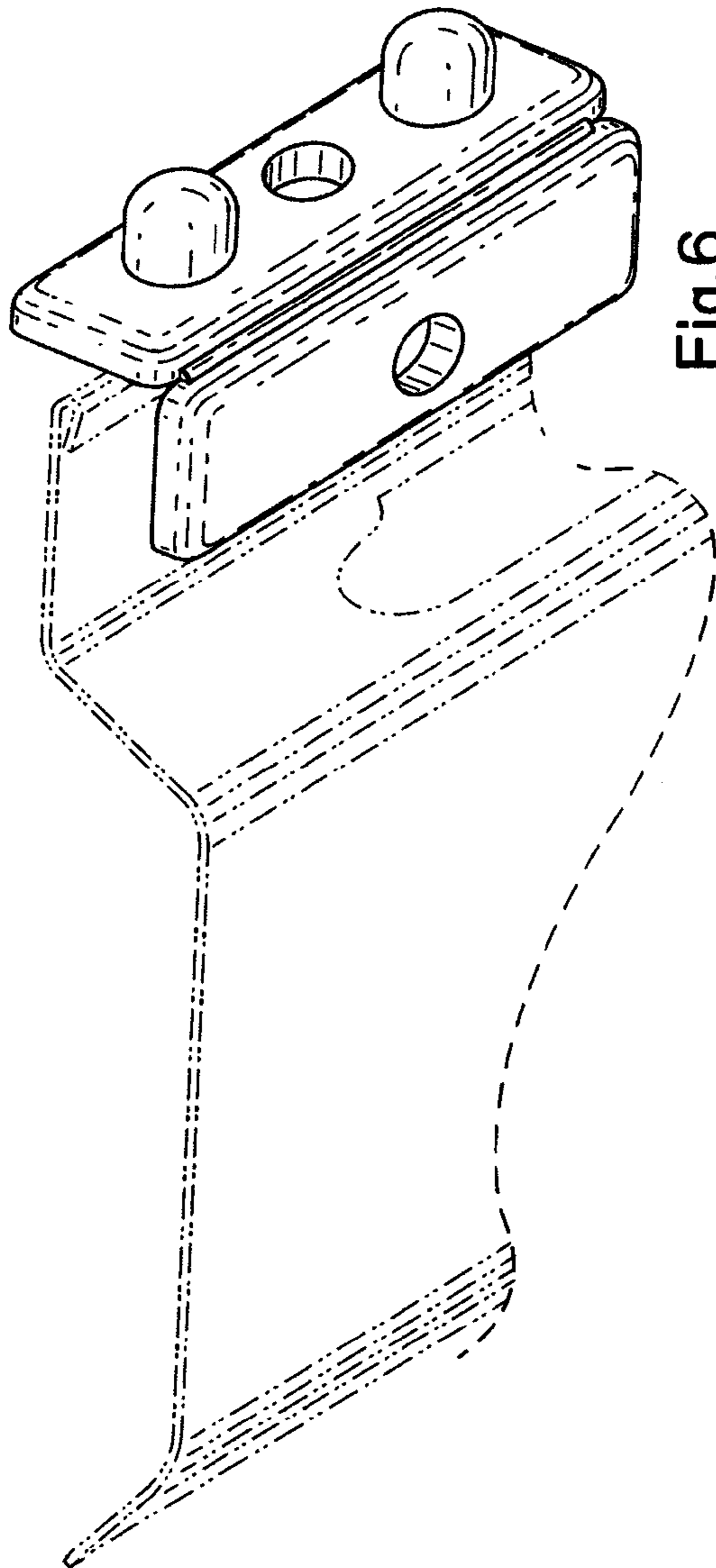

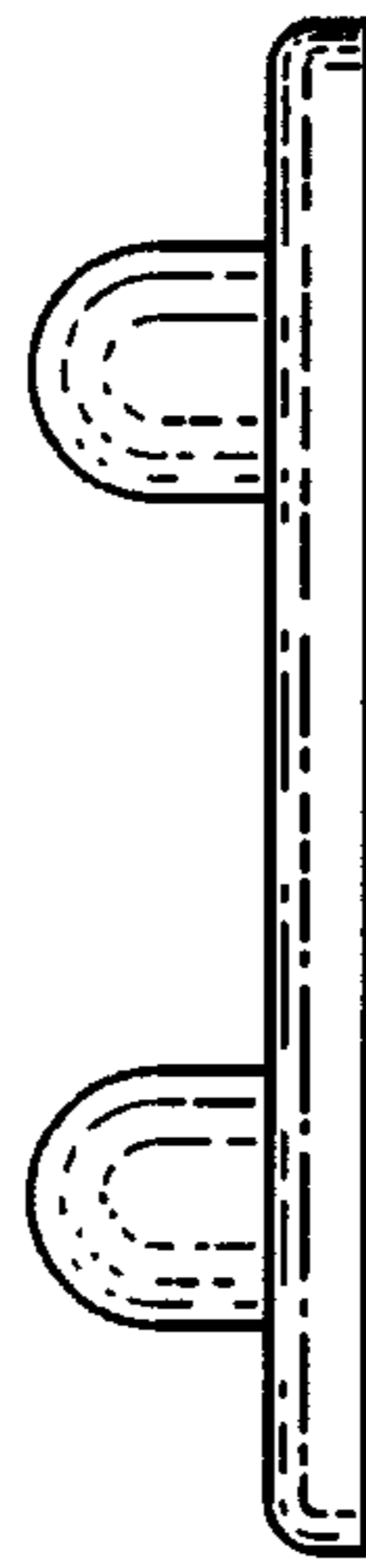

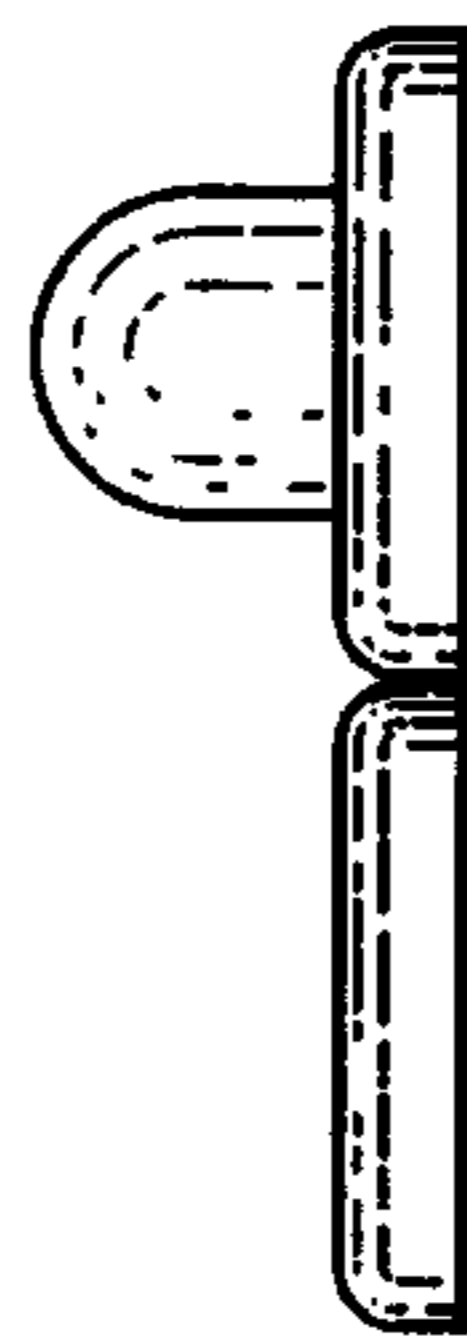
