DESCRIPTION

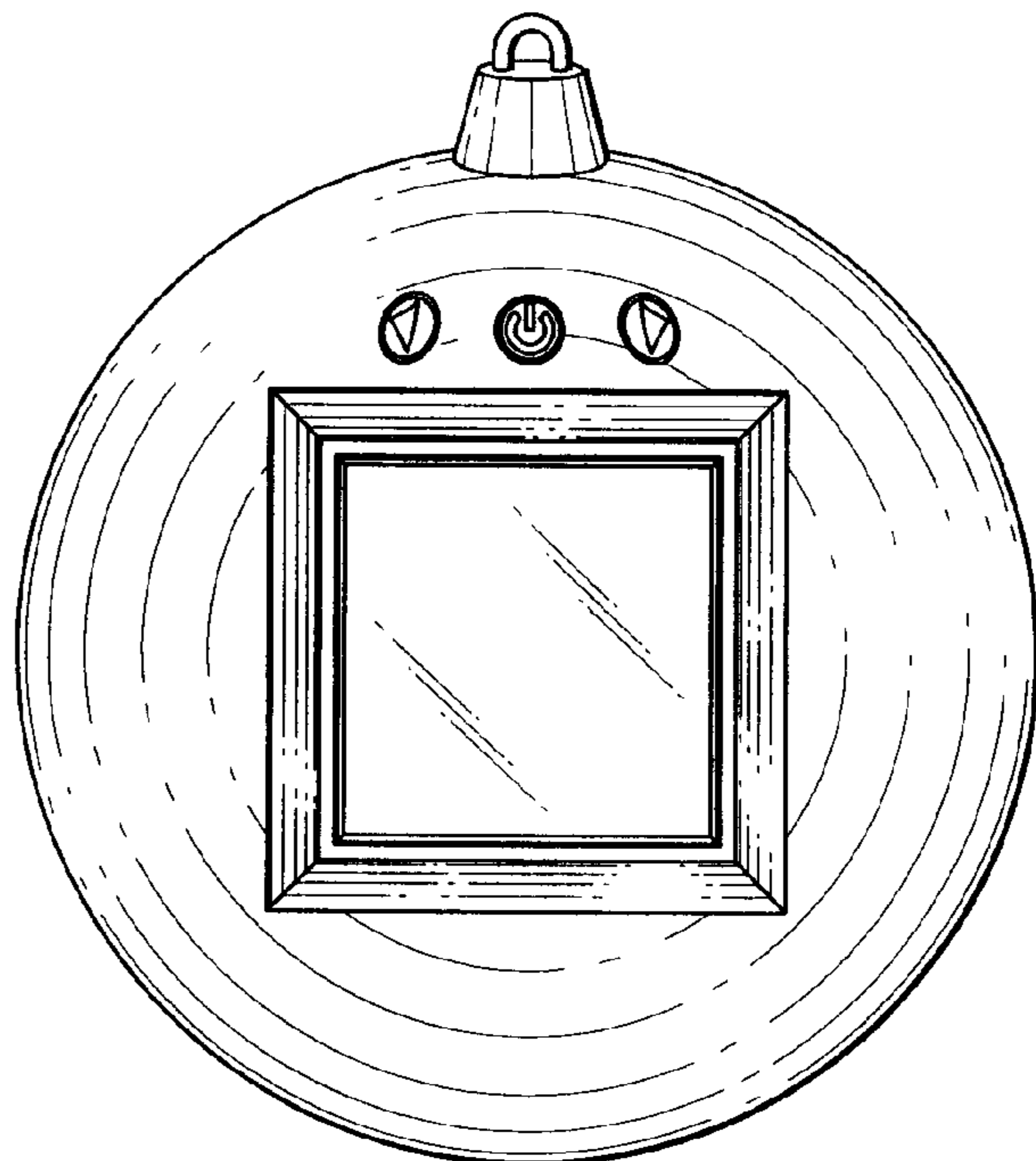
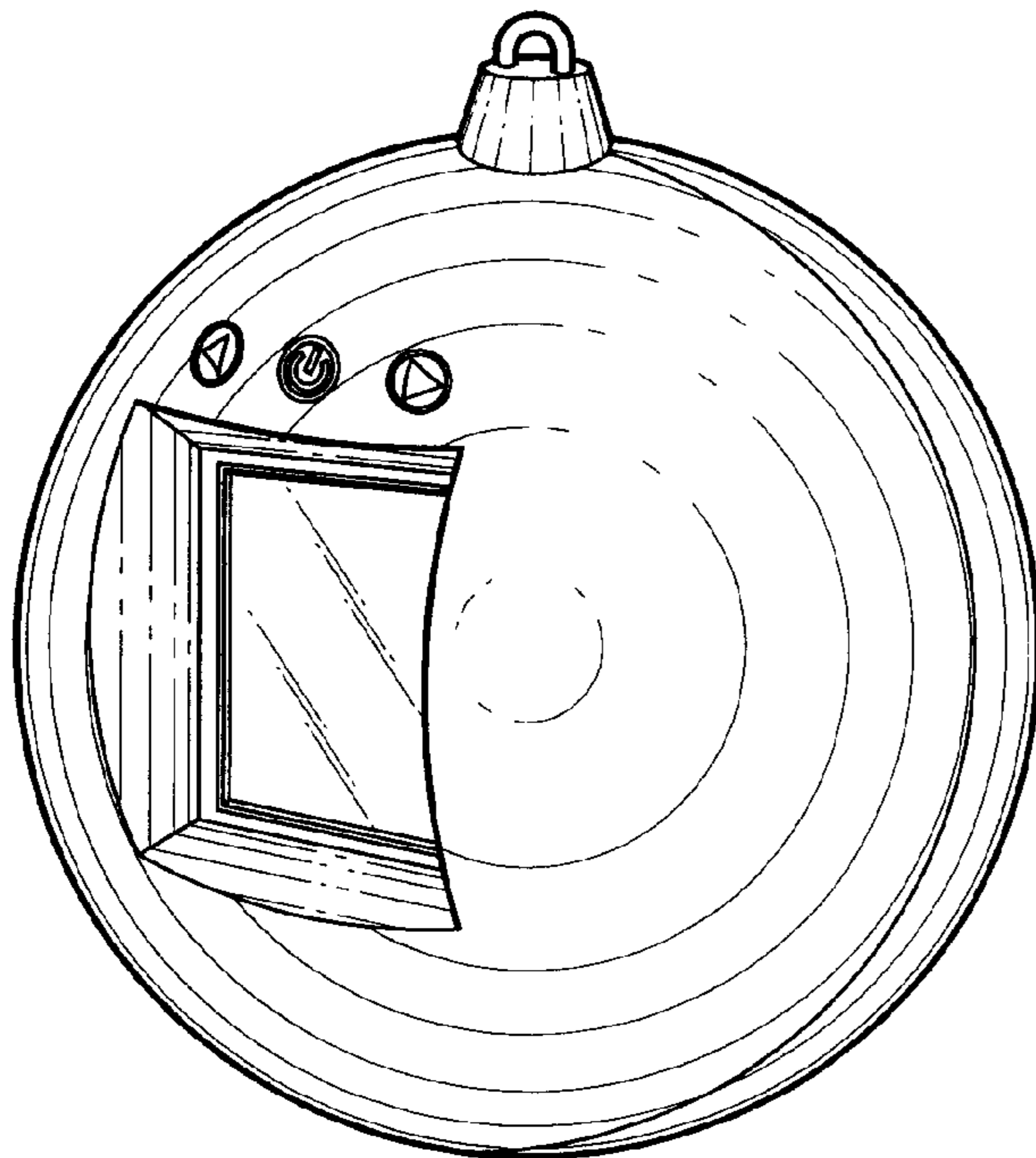
FIG. 1 is a front perspective view of an ornament showing my new design;

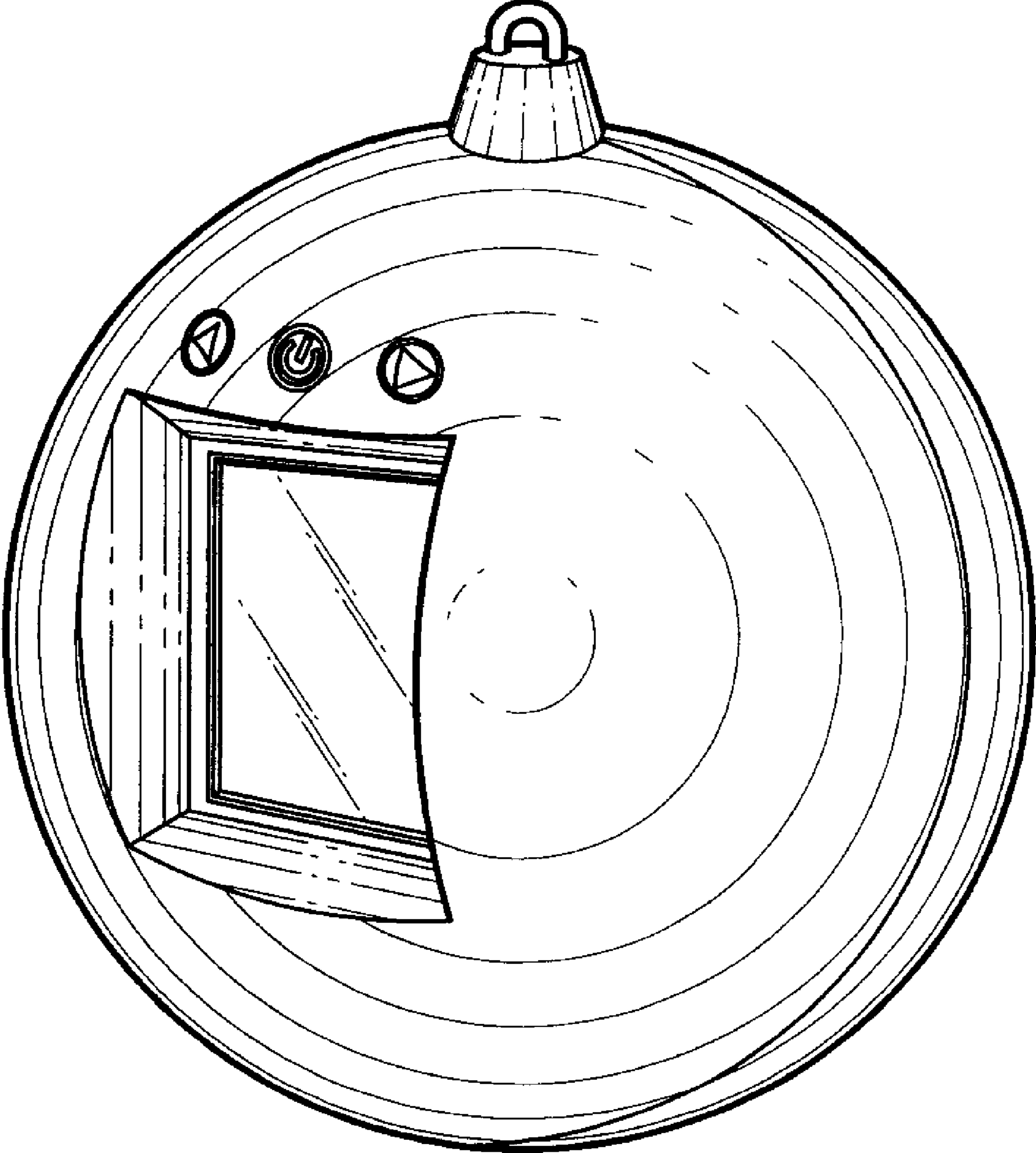

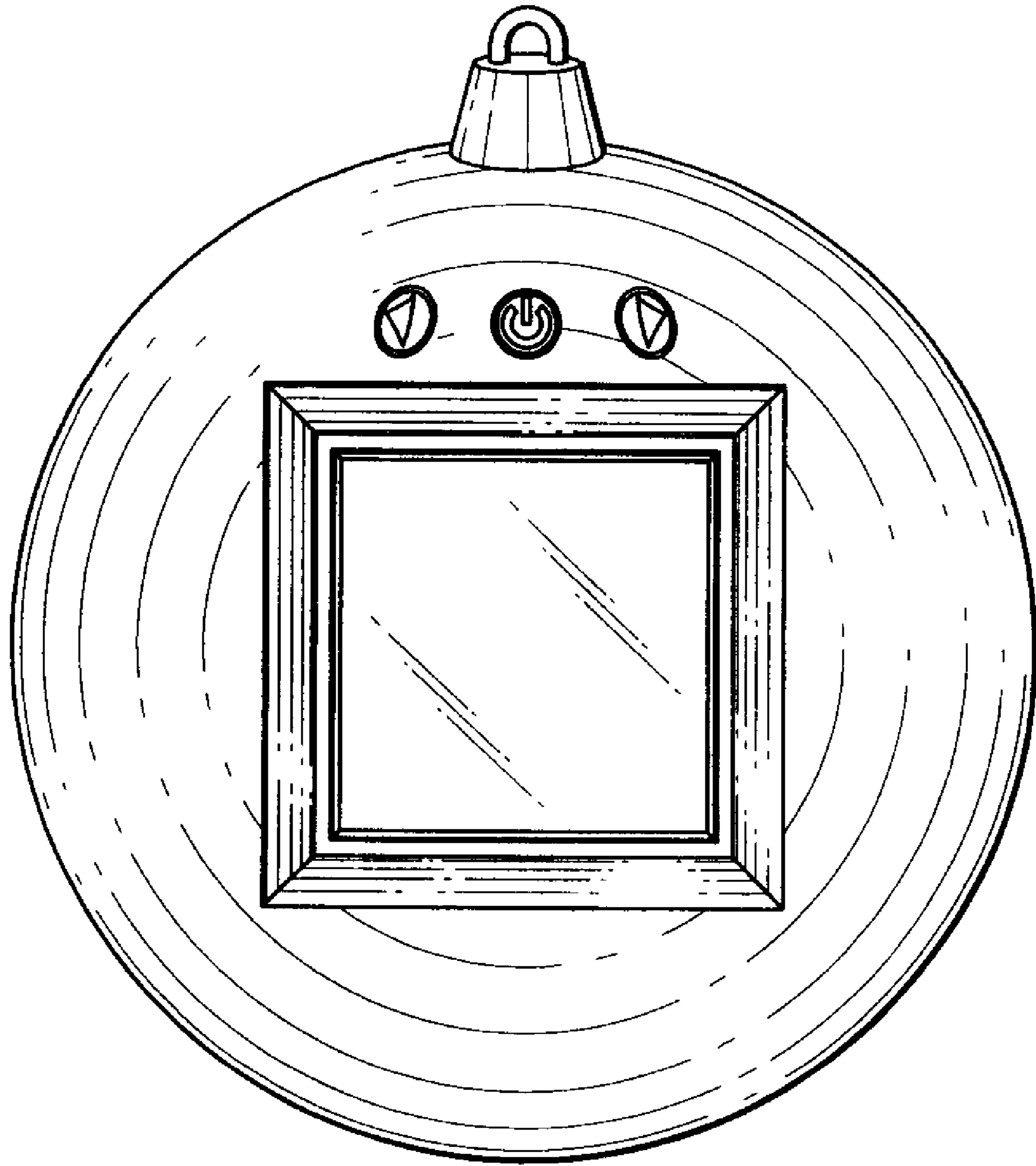

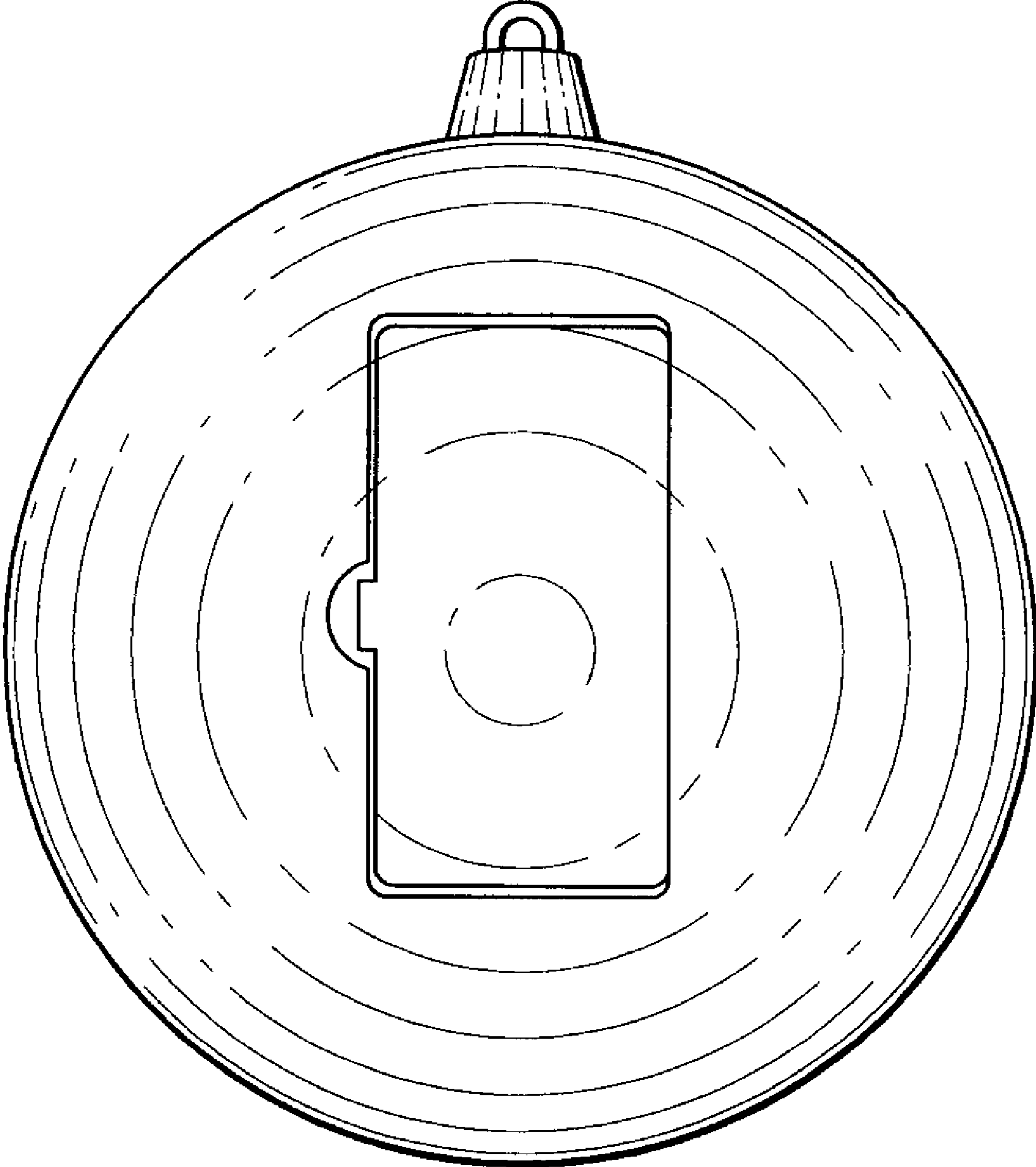

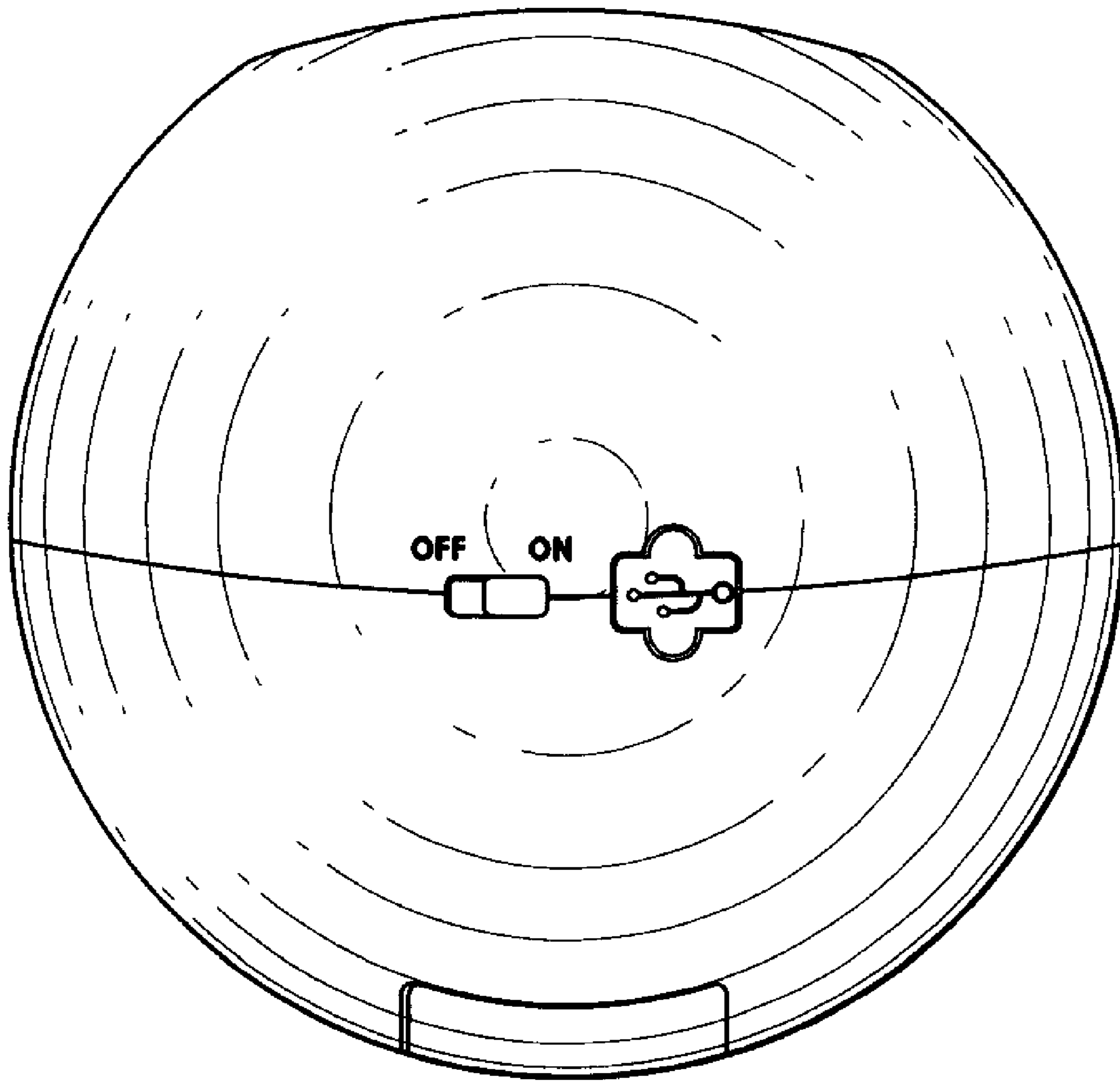
