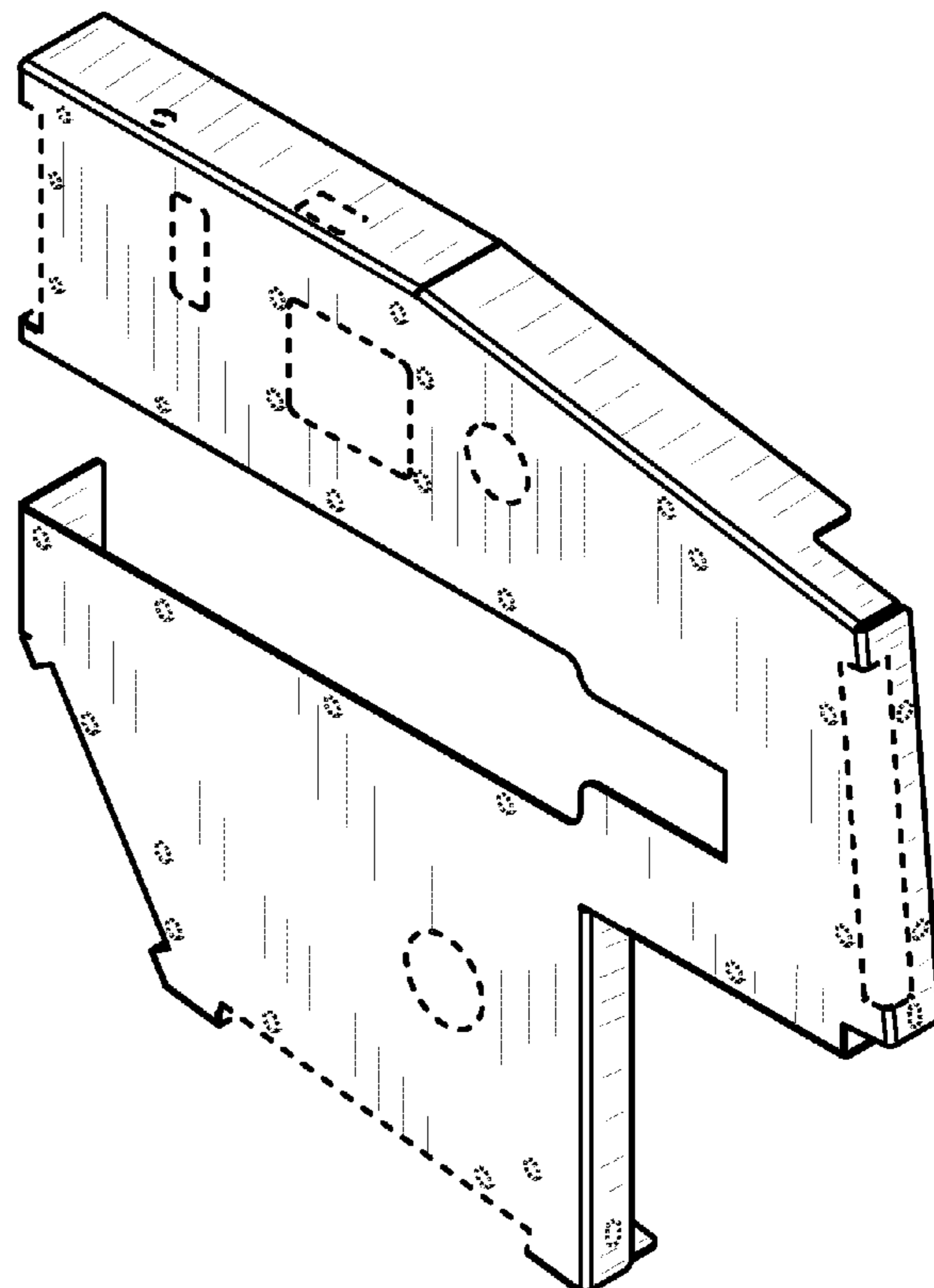
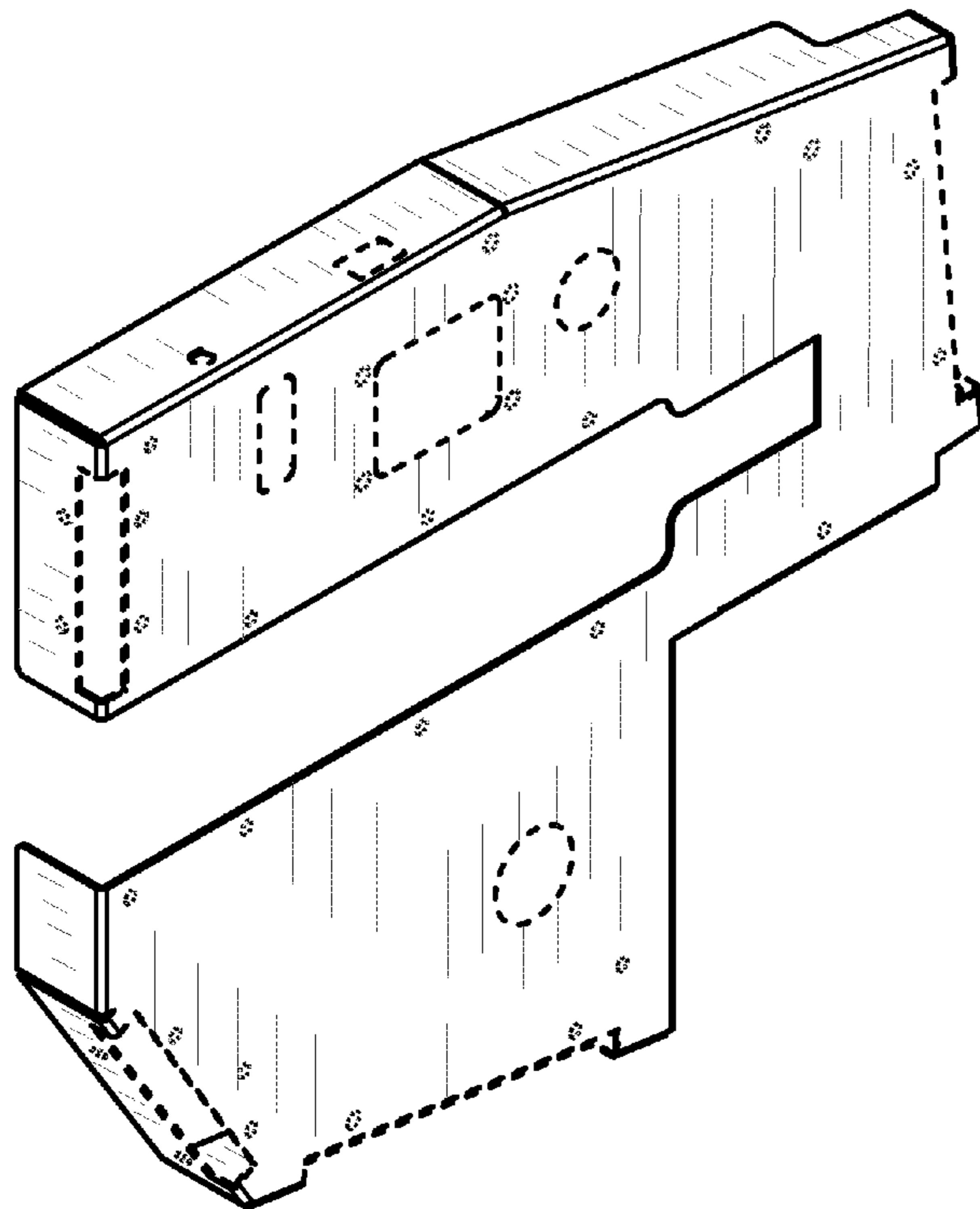
We claim the ornamental design for a vehicle door cover, as shown and described.

**DESCRIPTION**

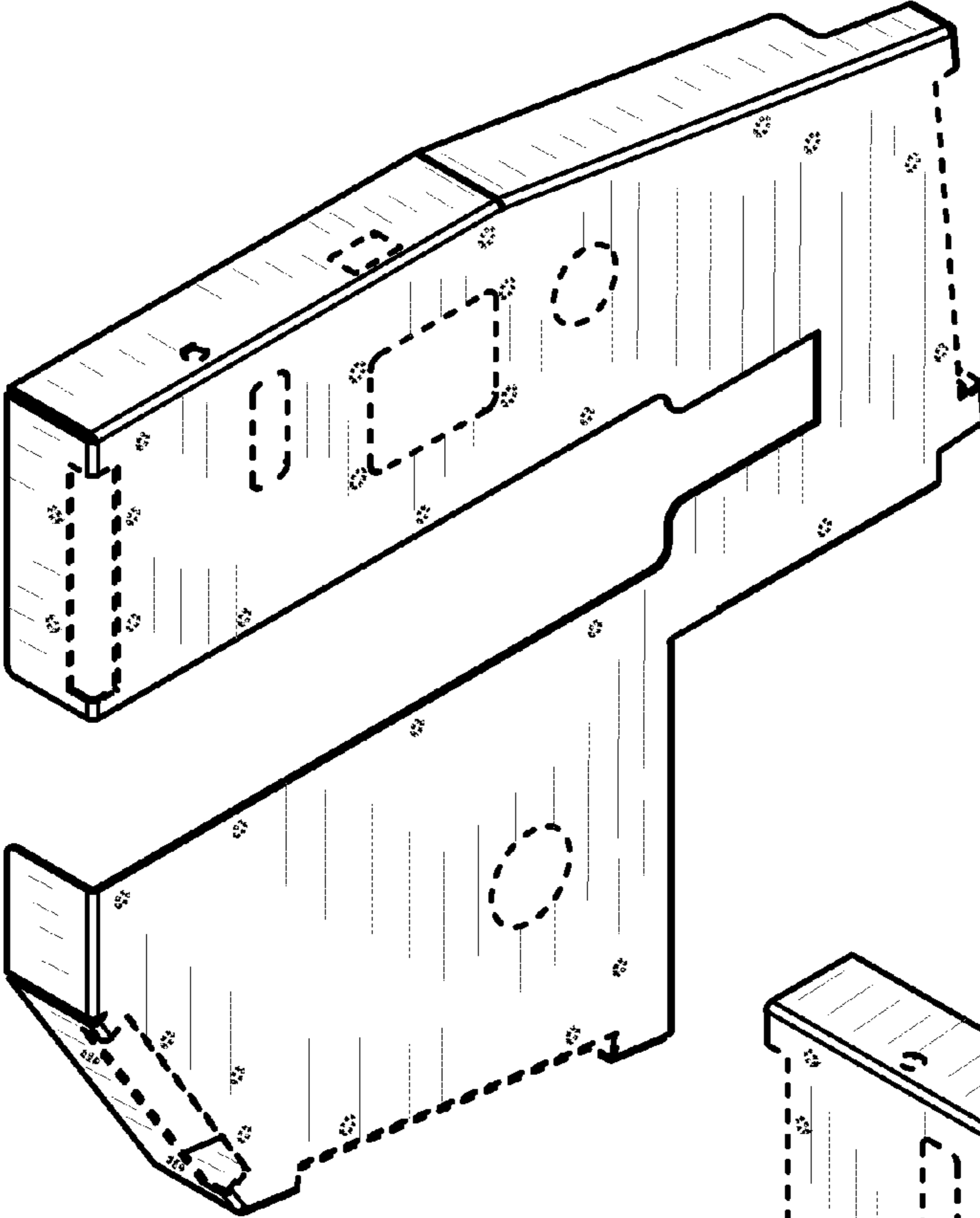

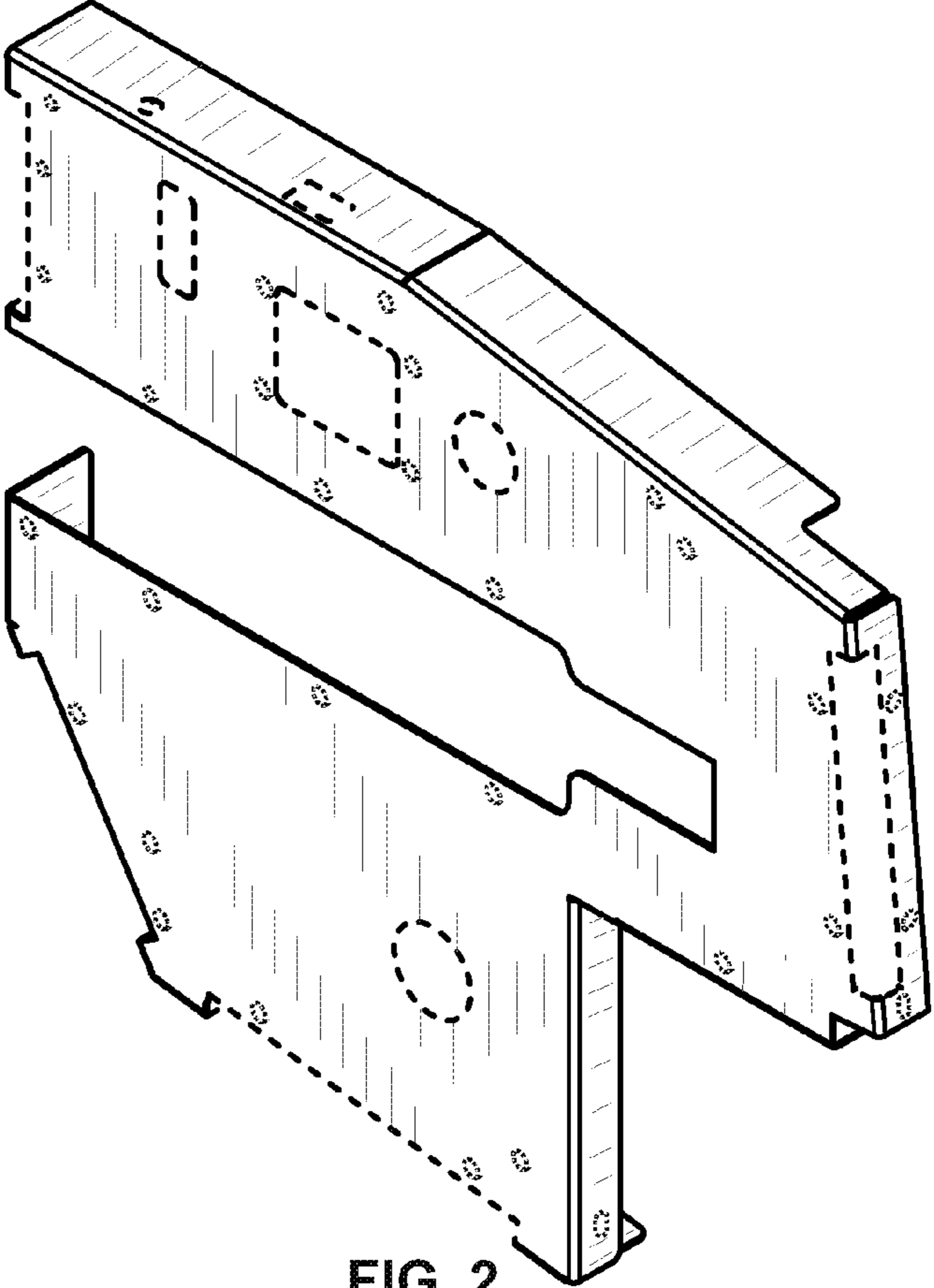

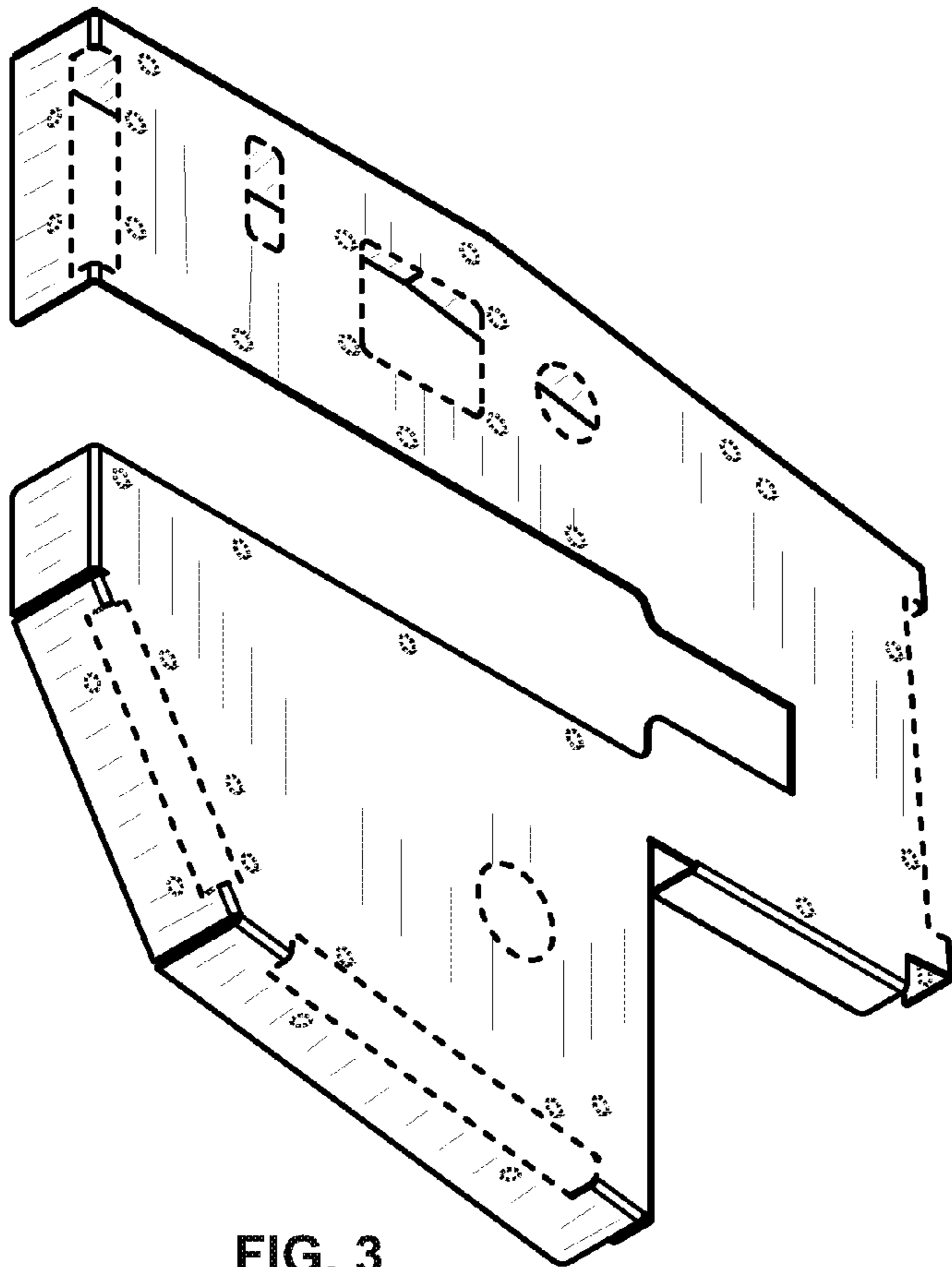

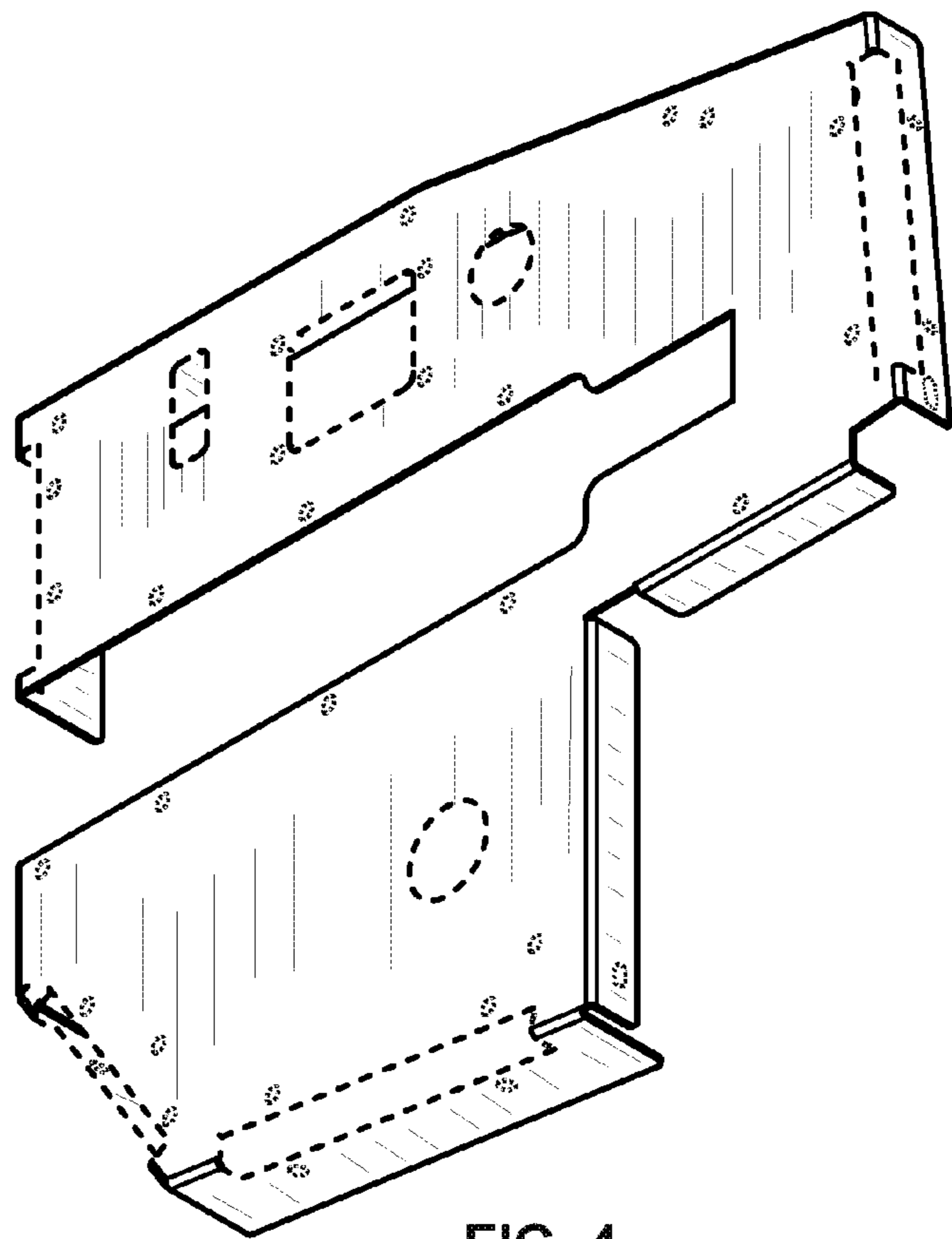

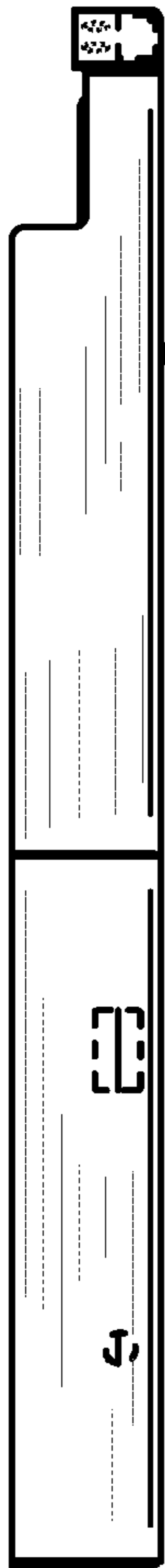

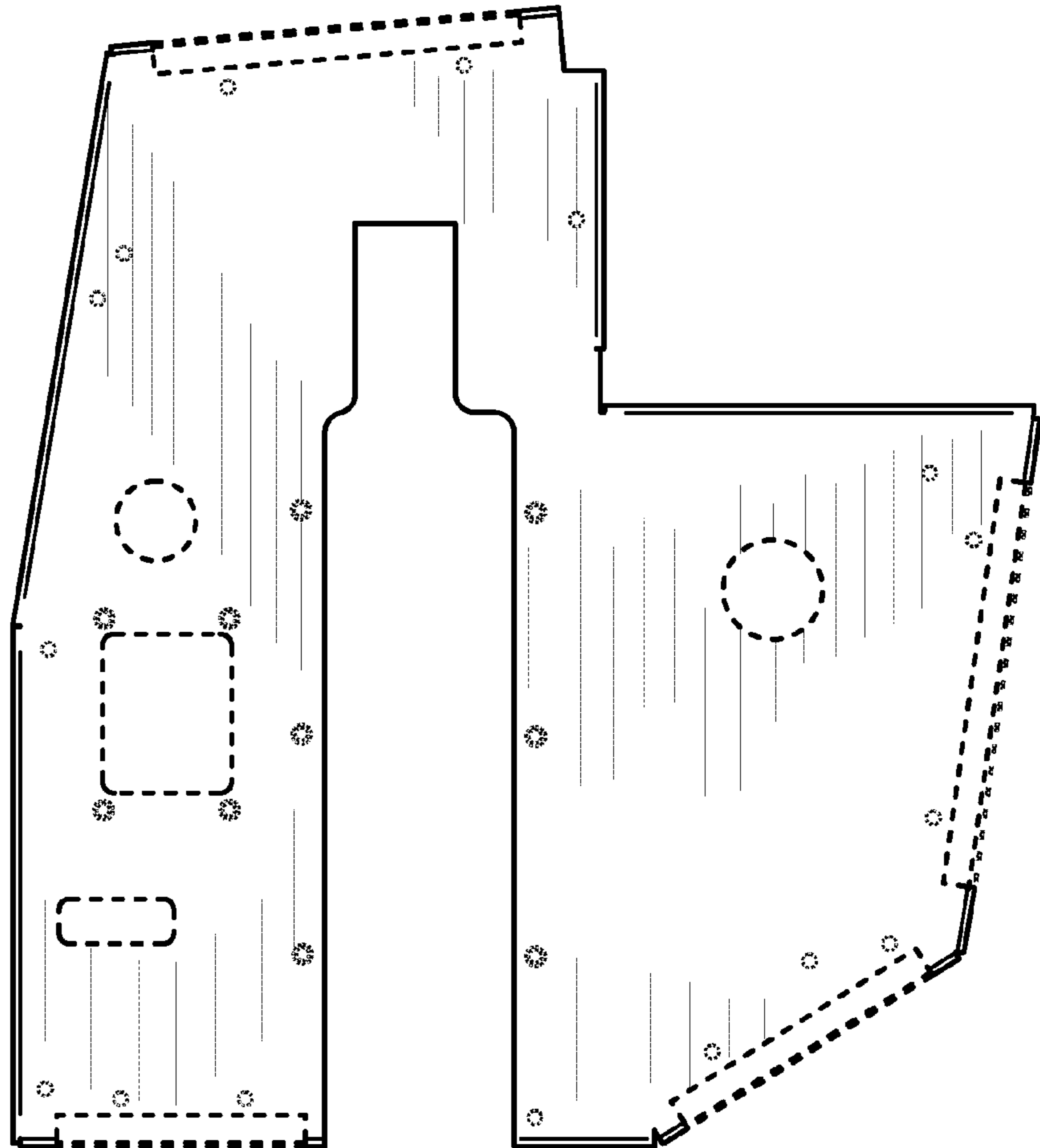

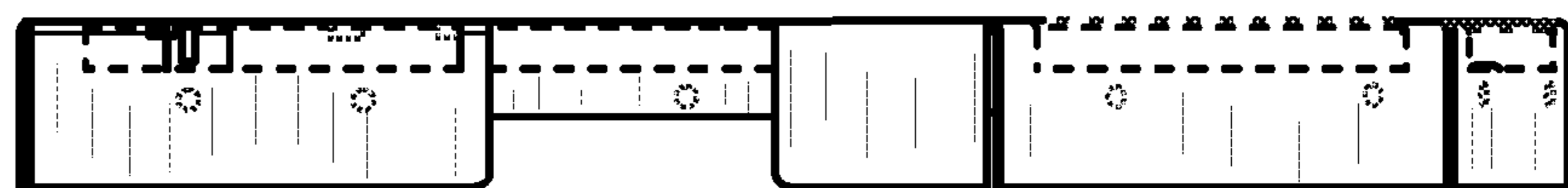

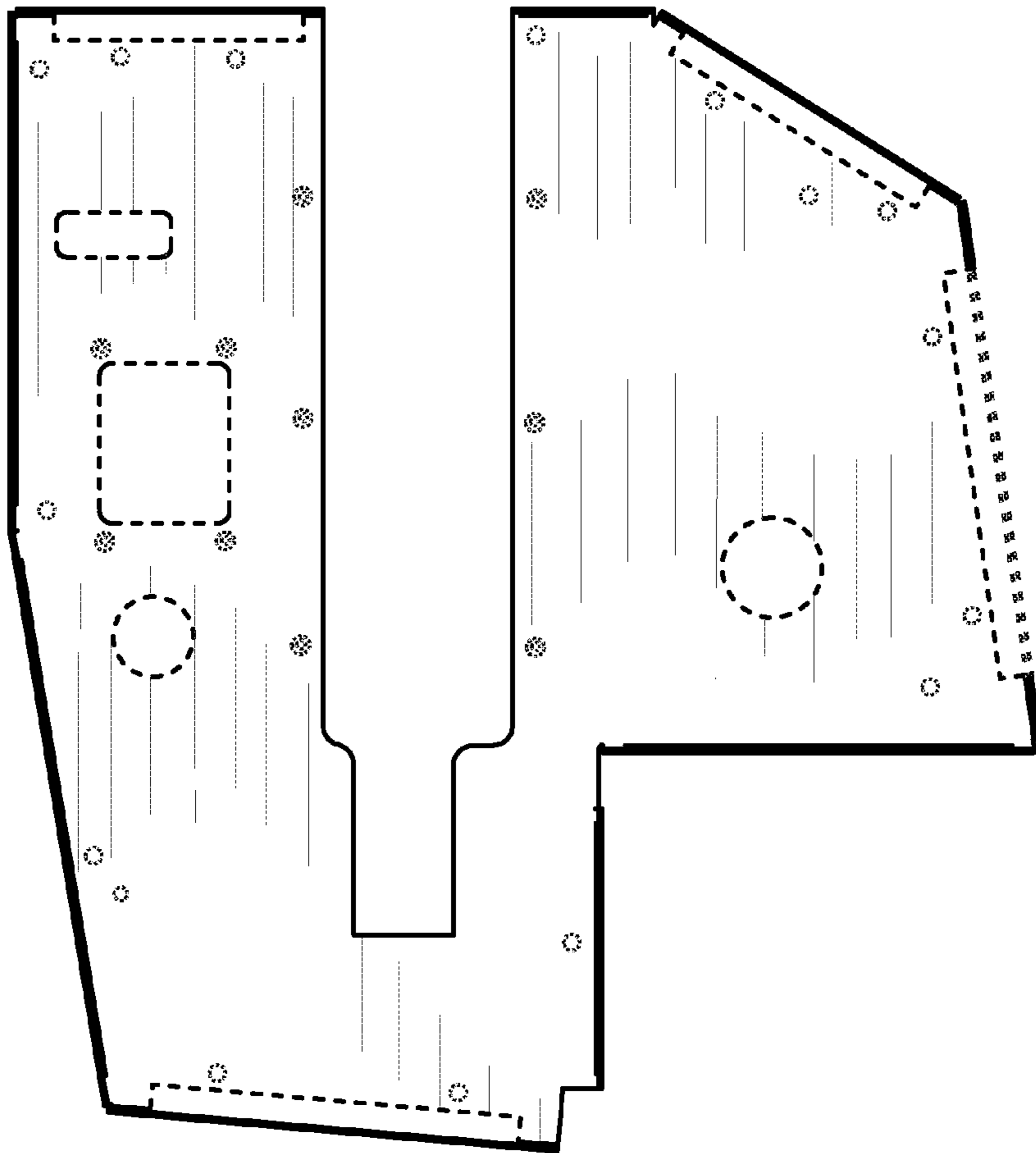

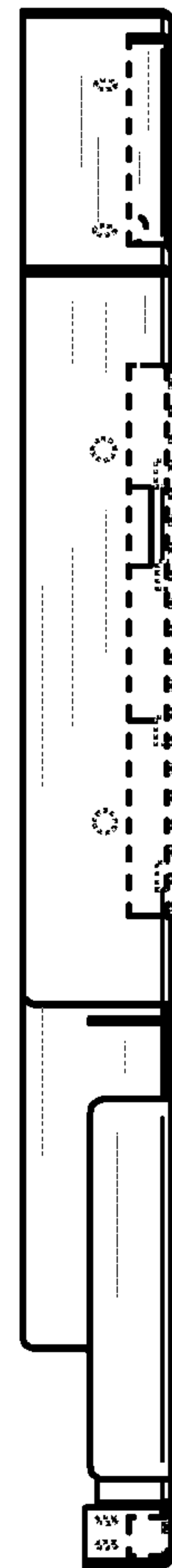

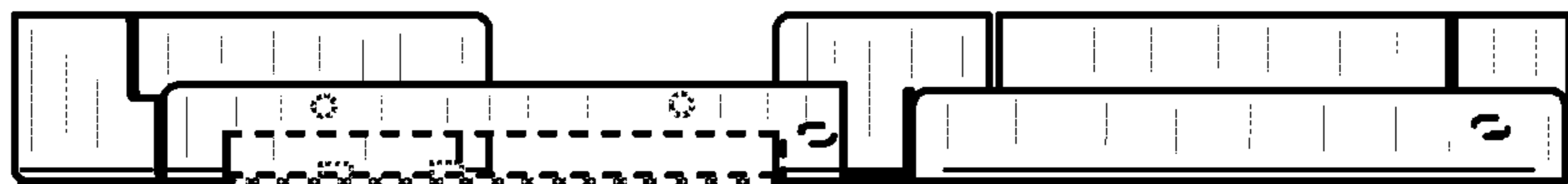
