(57) **CLAIM**

The ornamental design for a bag for a motorcycle windshield,  
as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a bag for a motorcycle  
windshield;

FIG. 2 is a back elevational view thereof, wherein the short  
broken lines represent stitching which forms part of the  
claimed design, while the longer broken lines represent envi-  
ronmental features that from no part of the claimed design;

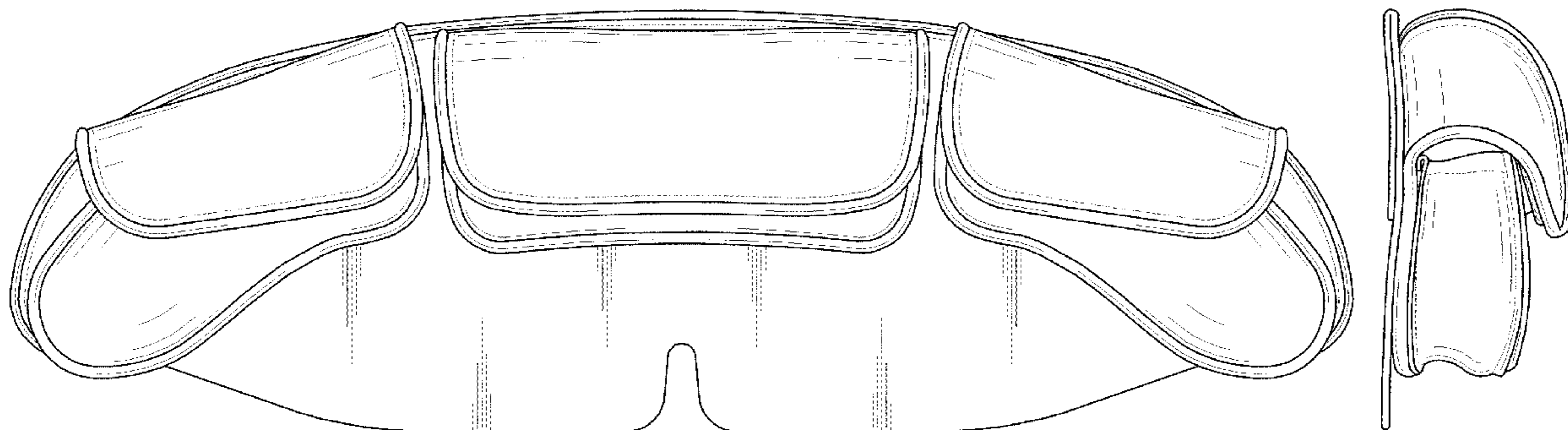
FIG. 3 is a top plan view thereof;

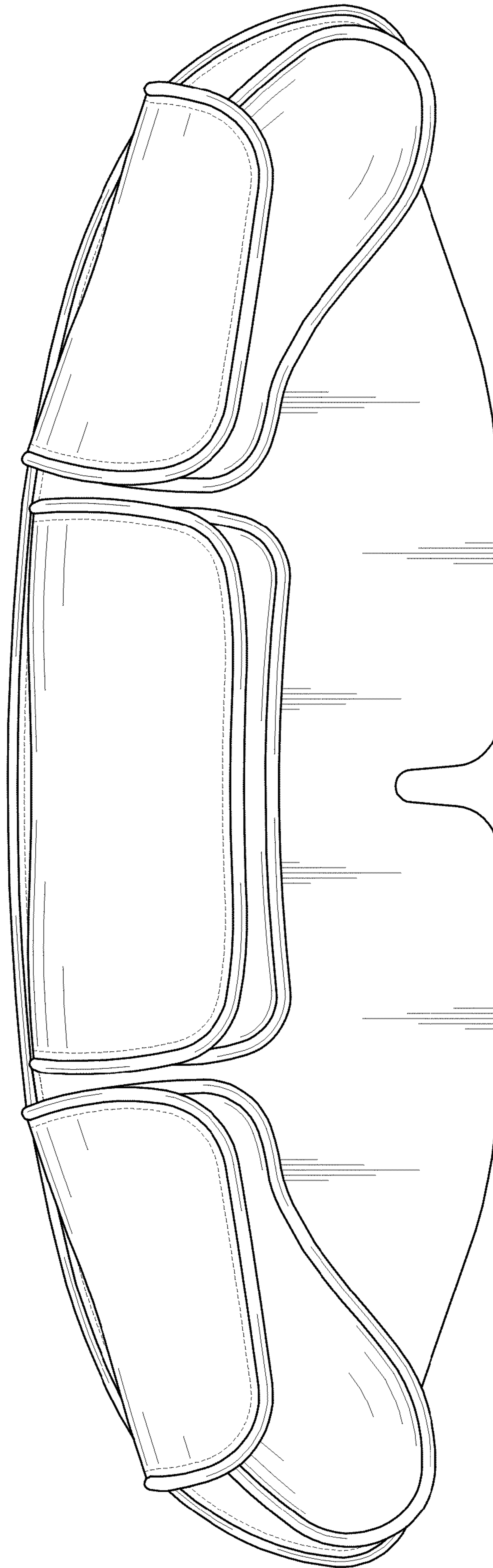
FIG. 4 is a bottom perspective view thereof, wherein the  
circular broken lines represent holes used for fastening the  
design to a motorcycle windshield and form no part of the  
claimed design, and the short broken lines represent stitching

FIG. 6 is a right side elevational view thereof.

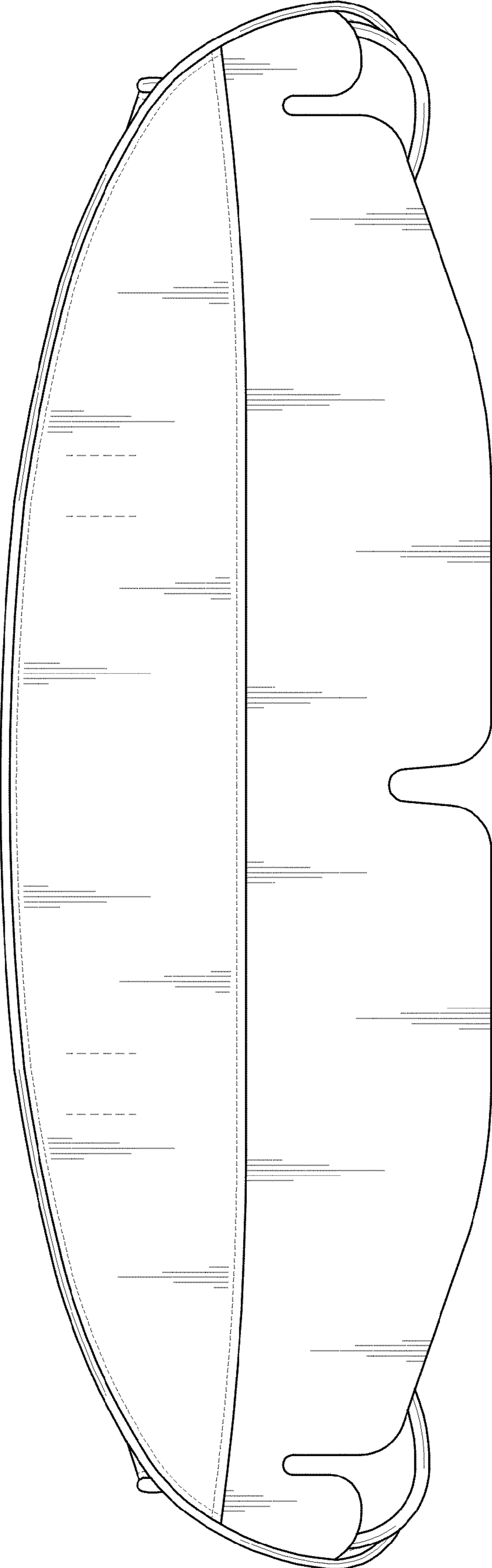

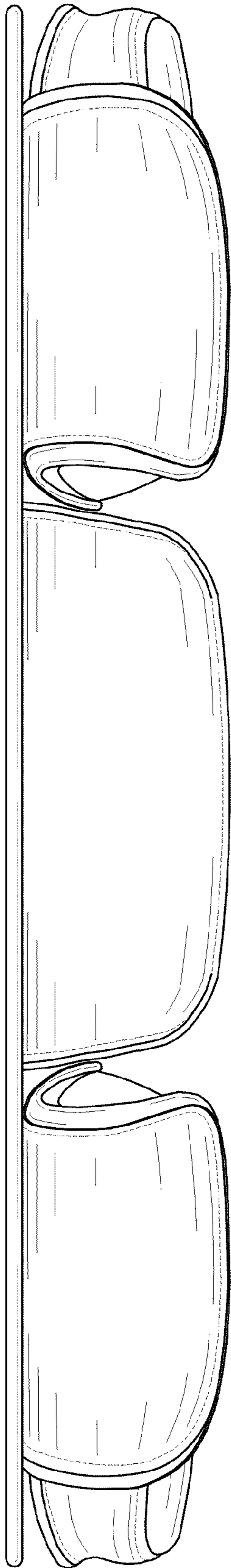

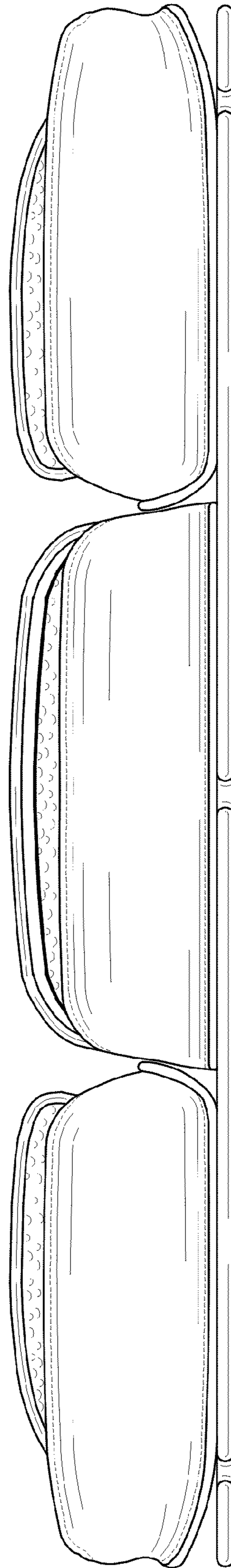
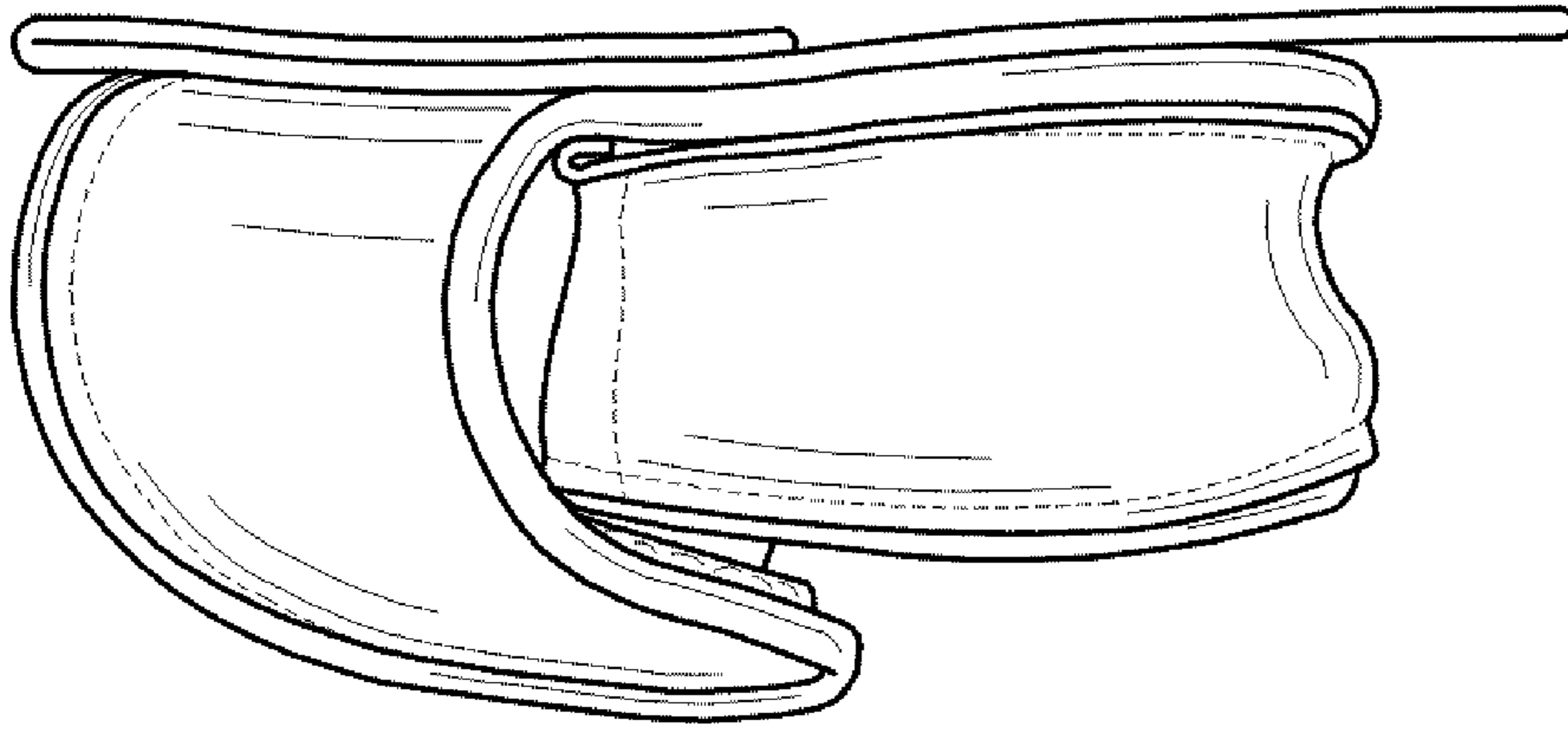
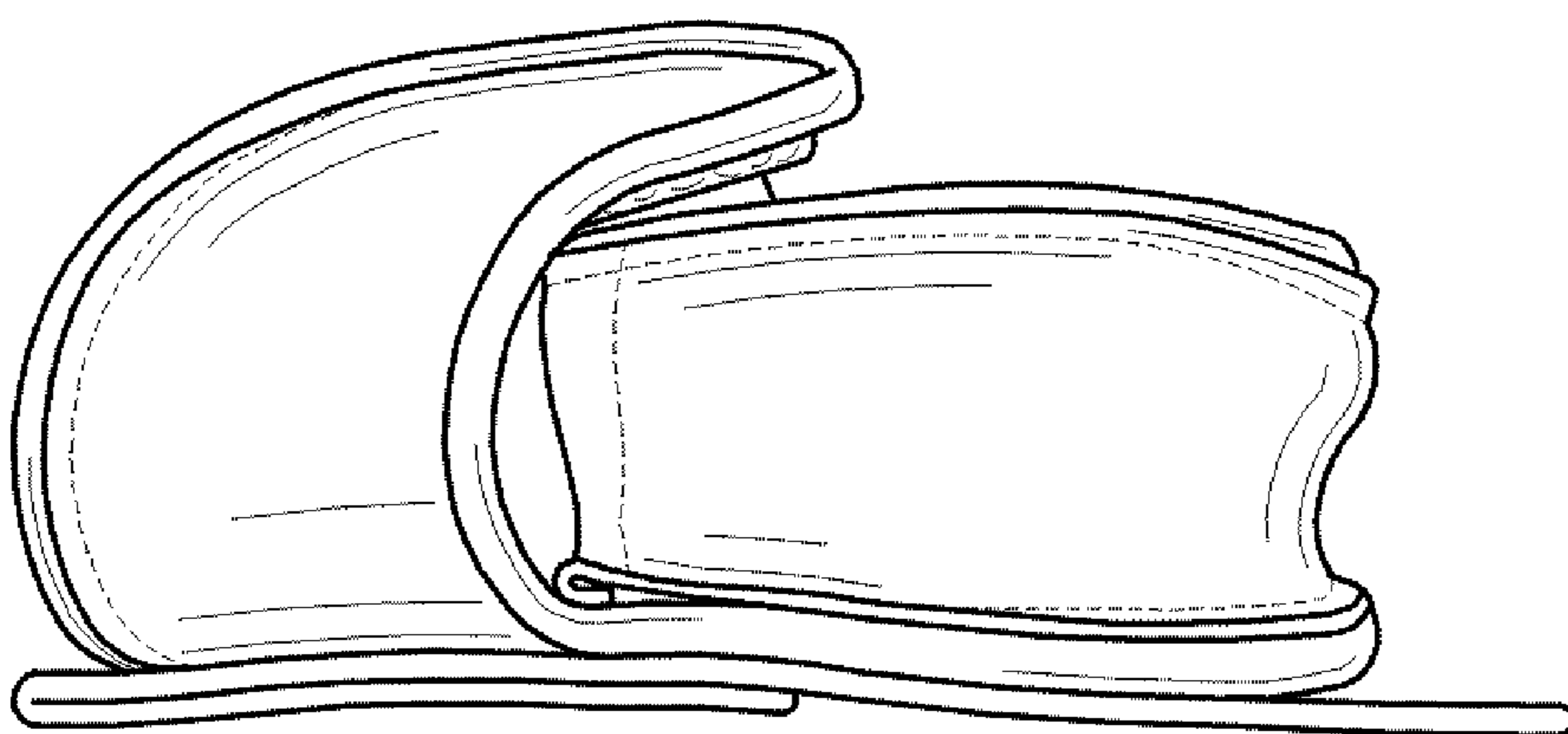
