(57) **CLAIM**

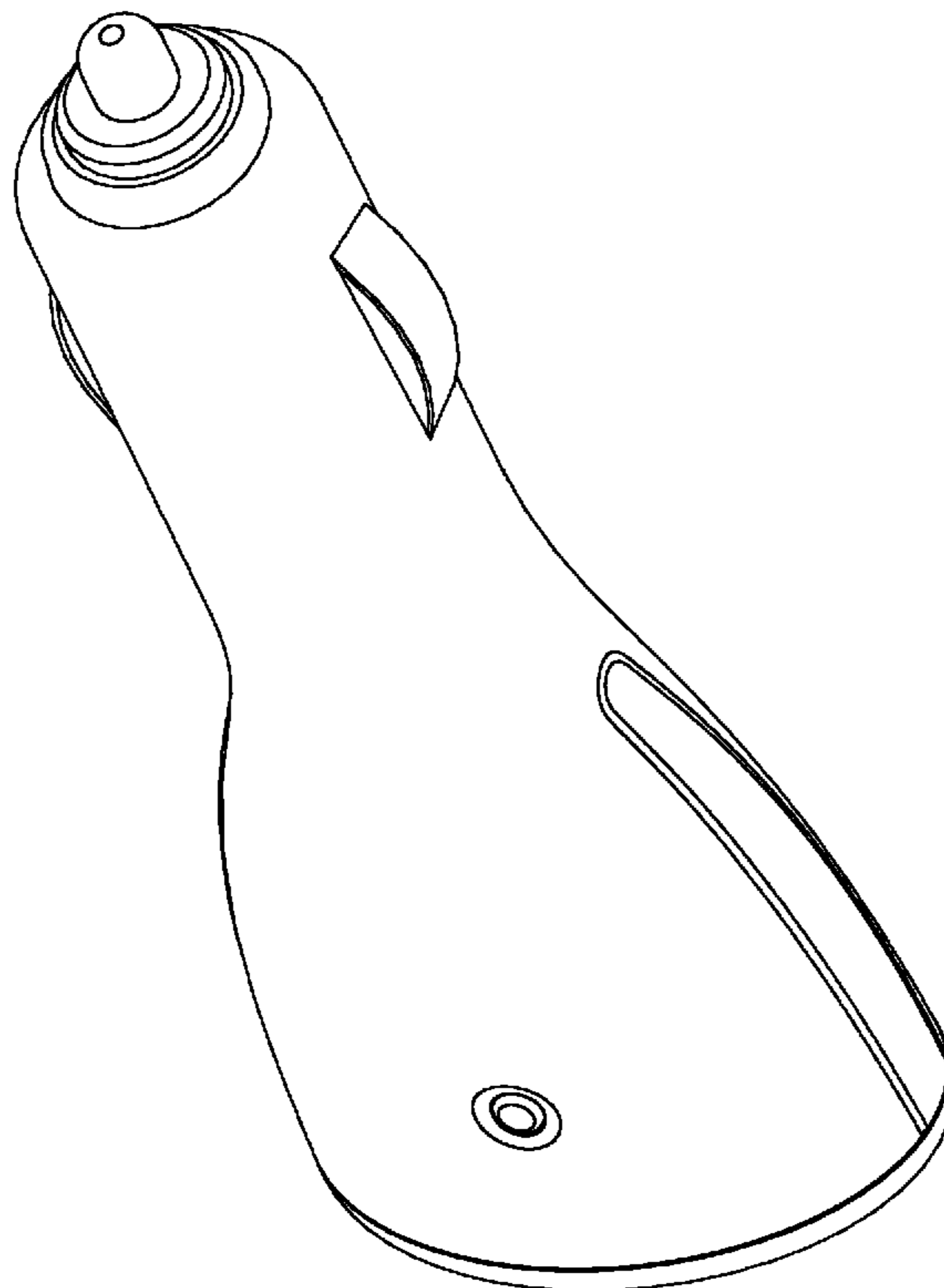
The ornamental design for a car charger, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the design for a car charger;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a left side view thereof, the right side view being identical;
 FIG. 5 is a top plan view thereof; and,
 FIG. 6 is a bottom view thereof.

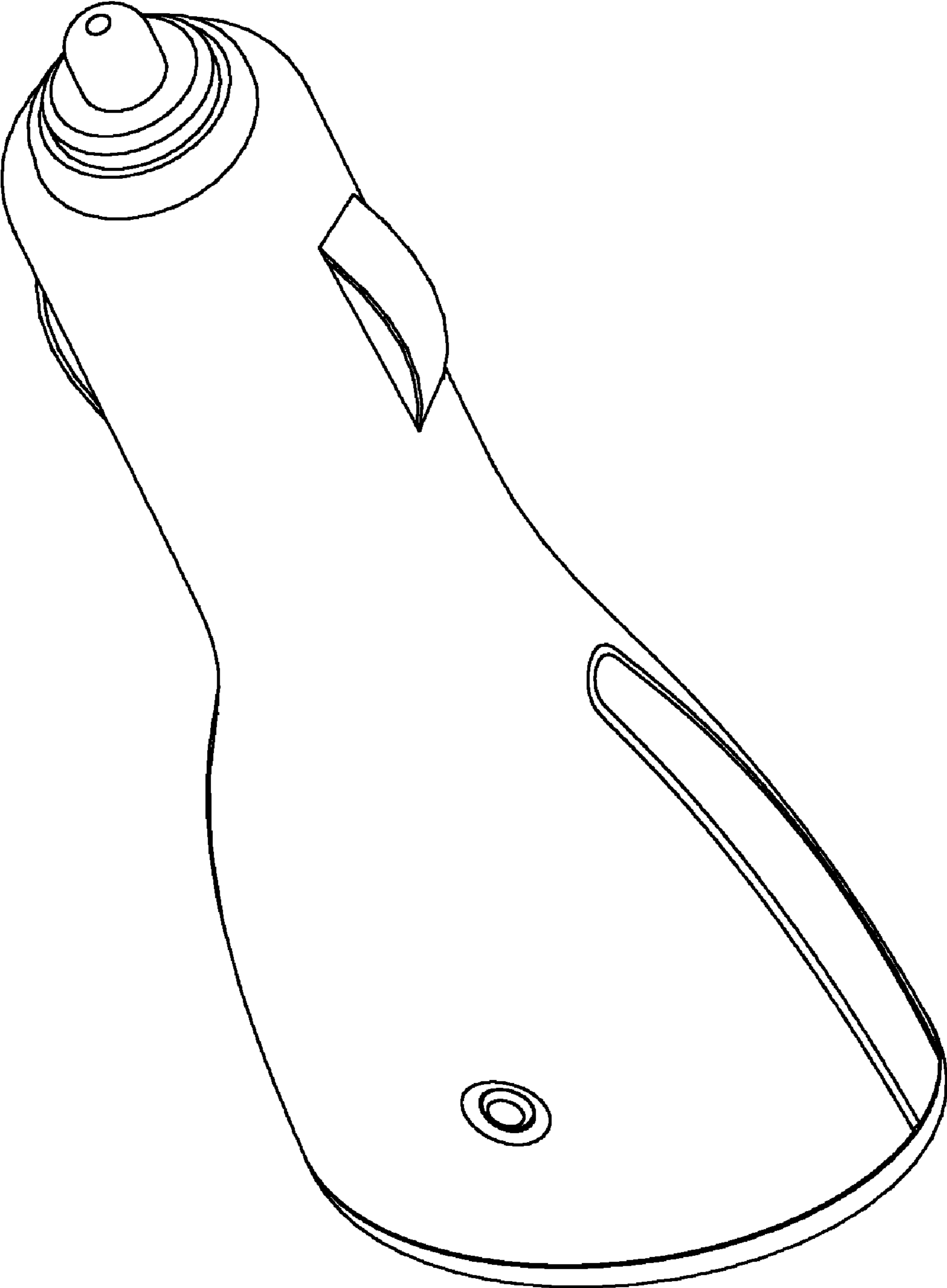

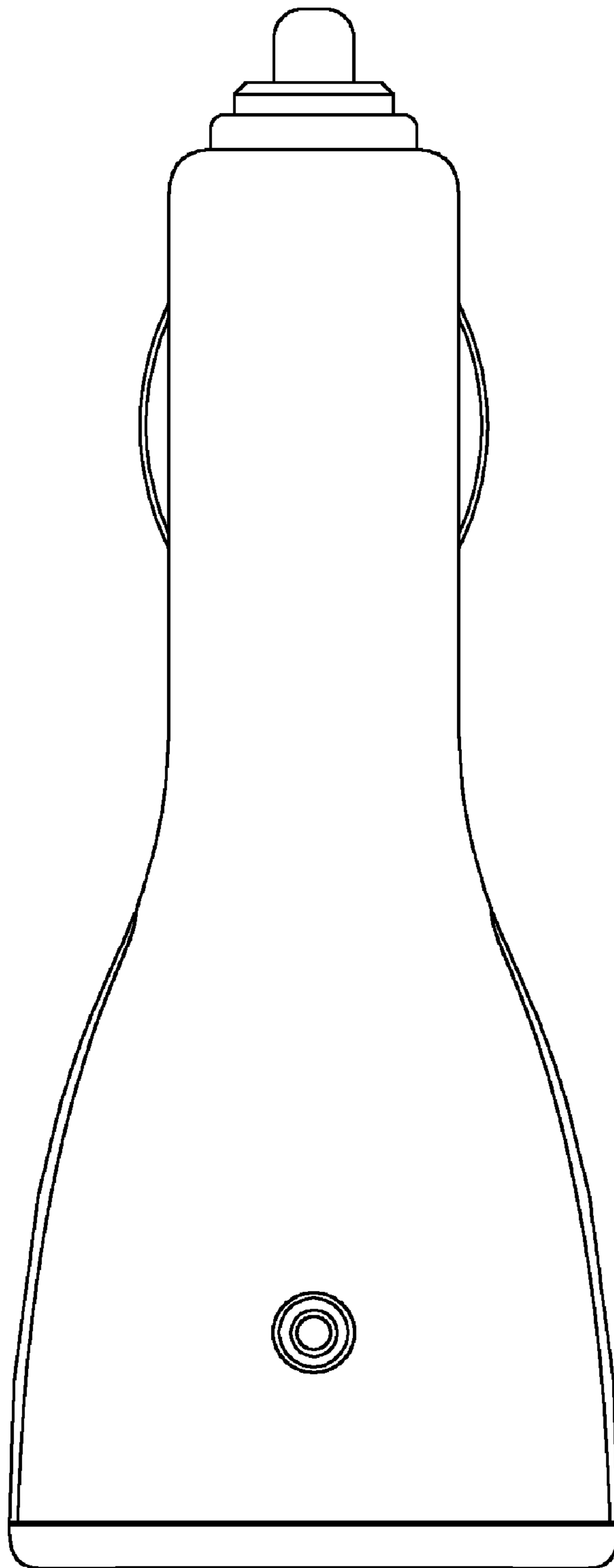

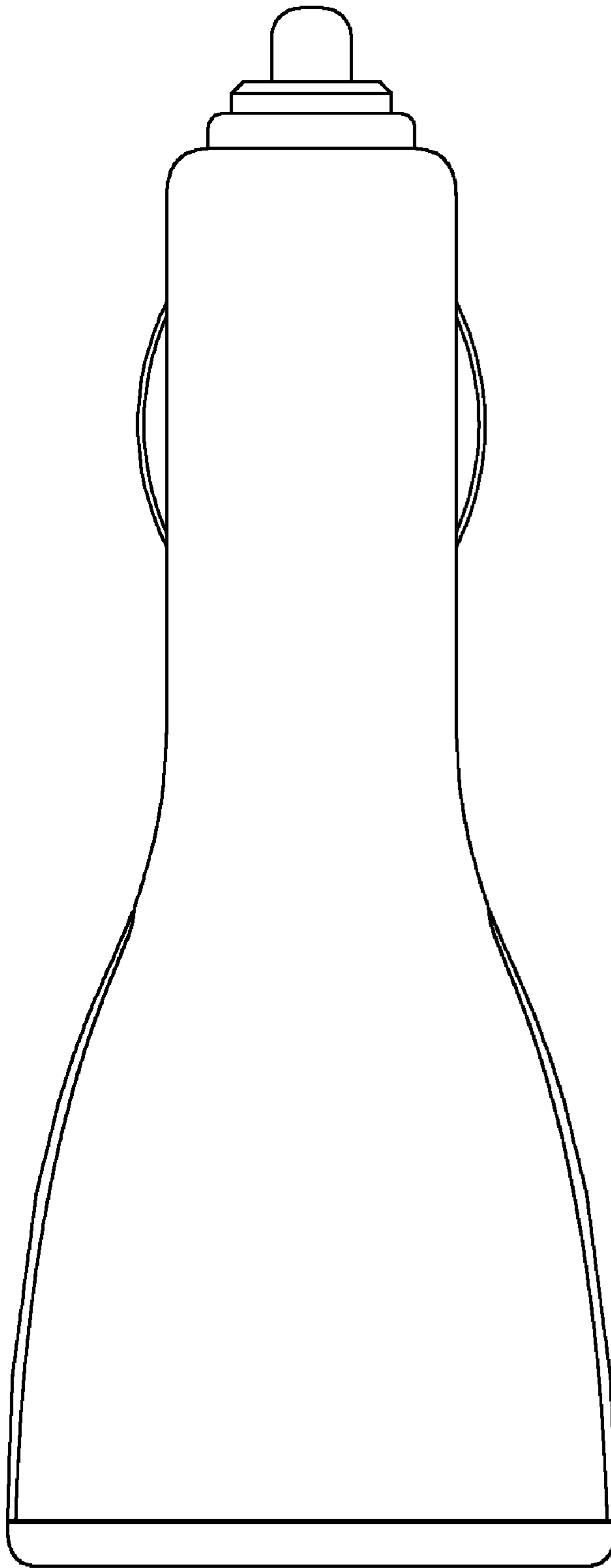

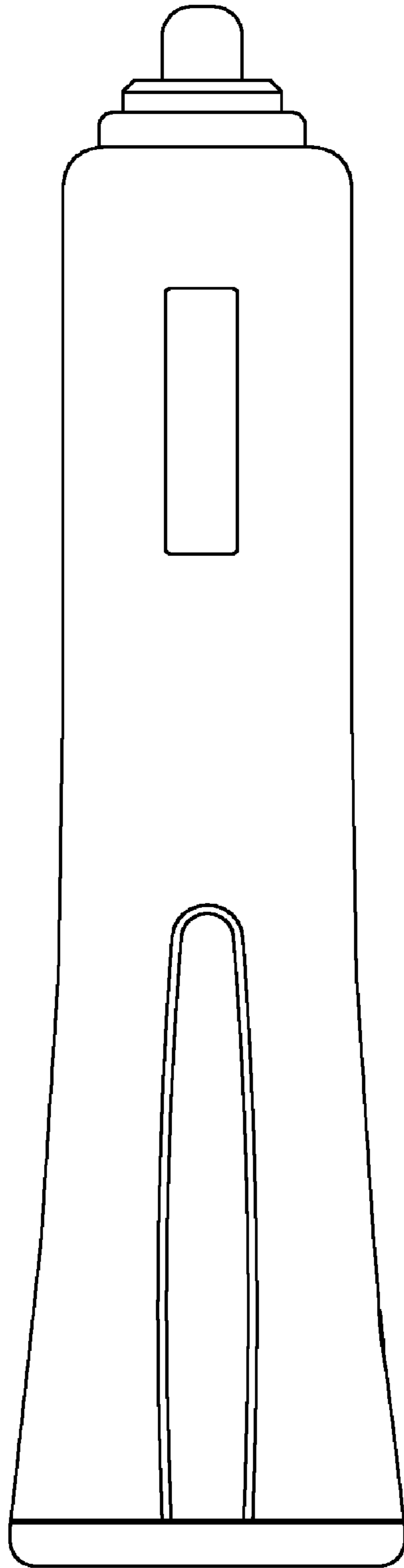

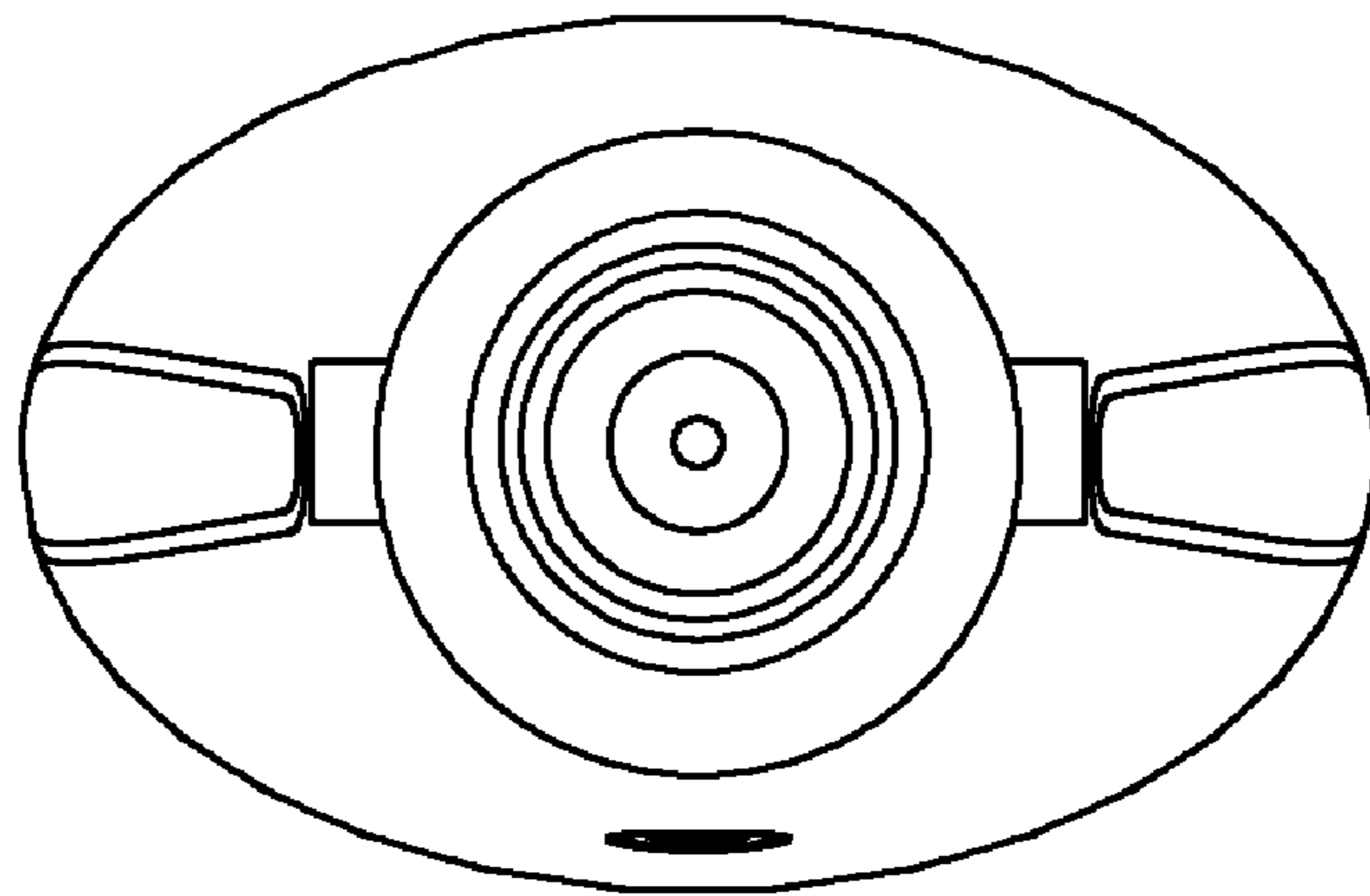

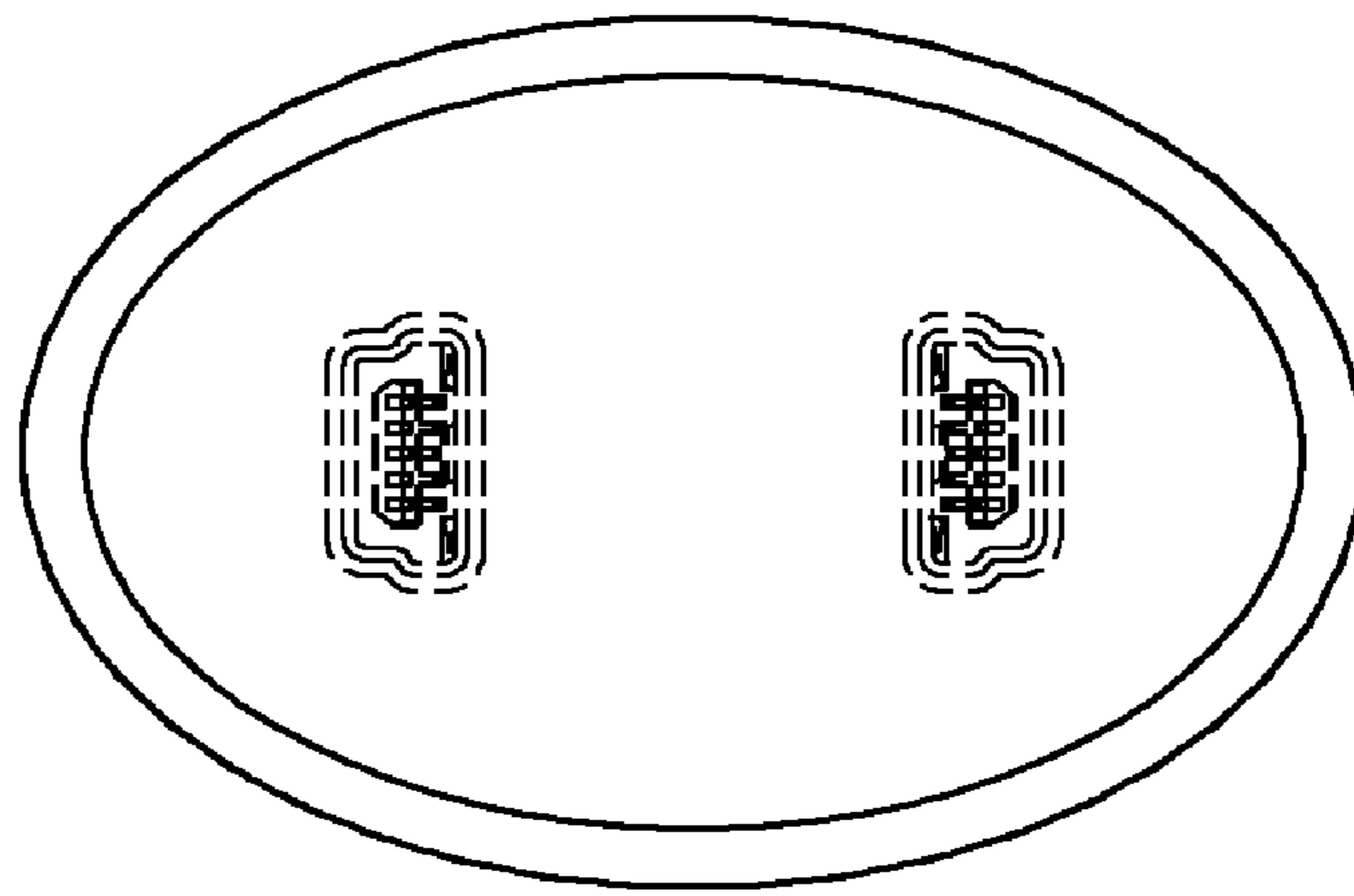
